Republican Jay McMahon Running for Attorney General

Jay McMahon, a Cape Cod Republican has announced that he is running for Attorney General this fall. McMahon ran for this seat four years ago against Maura Healey and was unsuccessful. In 2020 when I met him, he was running for State Senate against incumbent Senator Susan Moran. He lost 56 to 44 percent.

In his campaign this year, he has a strong antidrug platform, opposes COVID vax mandates for first responders and has been criticizing "wokeness" of state political leaders, including Healey.

Two Candidates to Date For Suffolk District Attorneu

The race for Suffolk County District Attorney so far has drawn two candidates, Boston City Councilor (District 5) Ricardo Arroyo from Hyde Park and acting D.A. Kevin Hayden of Dorchester who was appointed by Gov. Baker to fill out now U.S. Attorney Rachael Rollins' remaining term in this office.

Arroyo has promised to continue all the reforms started by Rolins and said he would build "a justice system that protects the safety and dignity of all people." Hayden the interim D.A. who grew up in Roslindale announced in front of the Boys and Girls Club in Dorchester pledged a commitment to public safety, criminal legal system reform, and accountability to all the communities that make up Suffolk County.

BOSTON'S COVID-19

State of Emergency Declaration to End April 1st

Bisola Ojikutu, Commissioner of Public Health and Executive Director of the Boston Public Health Commission, recently announced Boston's COVID-19 Public Health Emergency Decaration will end on April 1, 2022. The announcement follows a vote by the Boston Board of Health during their Wednesday meeting following the recommendation of Dr. Ojikutu. The Emergency Declaration has been in place since March 15, 2020.

"Today's announcement is a testament to how Boston came together in a historically challenging time to lift up public health and community," said Mayor Michelle Wu. "As we transition to this next phase of living with COVID, we will focus on providing the testing, resources, and planning to keep our communities safe and prepared."

"While the City of Boston is no longer in a state of emergency, we must continue to protect our most vulnerable residents and prepare for the future," said Dr. Bisola Ojikutu. "Now is the time for us to use all of the lessons learned from the pandemic, strengthen community partnerships, develop stronger public health infrastructure, and ensure an equitable recovery for all."

Dr. Ojikutu's recommendation to rescind the order is based on the City's consistently improving core COVID-19 metrics, including community positivity, daily adult COVID-19 hospitalizations, and occupied ICU beds. As of March 7th, the community positivity rate

Mayor Michelle Wu and Dr. is 2.2%, down from a peak of 32% in early January. Daily adult hospitalizations have also steadily declined and are now down to 94 after peaking at 769 in mid-January. The percentage of occupied ICU beds has been consistently below the Commission's 95% threshold of concern over the last few weeks.

During their meeting, Boston Public Health Commission officials provided a recommended framework for Boston Public Schools to use in determining when to lift the school masking requirement. Dr. Sarimer Sánchez, from BPHC's Infectious Diseases Bureau, advised reviewing the school masking policy when the number of positive COVID-19 tests per day in Boston falls below 10 cases per day per 100,000 residents, while considering other COVID-19 metrics. BPHC is also encouraging development of "mask friendly" policies for students and staff, and increasing access to vaccines in school communities. The current COVID-19 daily case incidence is approximately 13 cases per 100,000 residents in Boston. The final decision on revising the school mask policy will be made by Boston Public Schools.


The consistently improving metrics also mean the City of Boston and the Boston Public Health Commission can shift their focus to longer-term planning and preparedness efforts, developing a roadmap to handle future surges and pandemics, while continuing to support ongoing efforts to increase access to vaccinations and testing.

The Boston Public Health Commission declared a state of emergency at the beginning of the COVID-19 pandemic, a decision made in consultation with infectious disease and public health emergency preparedness experts at the Commission as well as the City and other emergency preparedness, public health, and healthcare experts. The Declaration was instrumental in Boston establishing an incident command structure and deploying staff and resources to perform crisis response and healthcare coordination functions throughout the pandemic.

"Based on the data, it is clear to the Board that the emergency declaration is no longer necessary," said Manny Lopes, Chair of the Boston Board of Health. "I am proud to have worked with Mayor Wu and Dr. Ojikutu, who led with science and made the hard but necessary decisions that kept our city safe and on the path to a much brighter future. The Board looks forward to our continued partnership with the City as we monitor the pandemic and help guide the city toward recovery."

Despite lower case numbers, BPHC cautions residents that COVID-19 is still transmissible, and can result in severe illness and hospitalization, especially for the city's most vulnerable residents. The Commission recommends residents protect themselves and those around them by getting vaccinated, boosted, and wearing masks indoors if they are at high risk for severe illness or if they will





Keeping this in mind while examining the remains of Roman houses makes the pieces fall into place like the parts of a jigsaw puzzle. The geography of old Rome favored high density and large concentrations of people in urban areas, a natural progression from a City State. The open portion above was called the compluvium and any rain which fell through was collected in a sunken floor tank called the impluvium. Overnight guests were permitted to occupy a small bed chamber called a cubicule, but before retiring they might be invited to view a prized art collection in the picture gallery, which was called the pinacotheca. Small talk and interesting conversations alike were reserved for a sitting room called the exedrae. Libraries were always elegantly furnished and were called bibliotheca. The bath was always taken in the balineum and food was prepared in the culina. They prayed to their family gods in a chapel, which they called the sacraium. Extra all-purpose rooms were called dieta and a sunny spot or sunroom was known as the solarium. Dark and dingy rooms for the family slaves were called *cellae*, and any rooms in the upper story were known as cenacula. That often used, but seldom mentioned, little room where they did their daily "dooties" was called the latrina.

The rear of the domus usually contained a beautiful flower garden with statues and pools. The statues were in numbers to suit the family budget or at least to try to keep up with the Joneses. The walls of many interior rooms were painted with scenes showing the owner's favorite hobbies, such as a beautiful landscape, horses, boats, dogs, or women (I think I'd better get off this subject in a hurry). The dining room was the largest room in the house and the best paintings were usually placed here. Nine persons were the recognized number for a Roman feast; therefore by tradition, the proper dining room, or triclinium, always had three couches, which were large enough to accommodate three gluttons each.

Guests invited to a Roman dinner usually arrived at three o'clock in the afternoon. They might have walked, but were usually carried in a litter by their slaves. Wine and food were served in great quantities. At the beginning of the meal, the servants placed the food on the tables. Later, when the guests were too full to reach, the food was handed to them.

Still later, when the guests became immobile, the food was placed in their mouths by the servants or their own slaves. Their manners didn't seem to be very formal. A notice placed on the triclinium wall in a Pompeian house still remains today and reads:

- 1. Guests will please refrain from casting improper glances at the serving women.
- 2. Do not make passes at the wives of the other guests.
- 3. You must take your shoes off, and you must let the servants wash your feet.
- 4. Use the napkins which are provided. Do not wipe your hands on the furniture or the clothing of the other guests.
- 5. If you can't follow these simple rules ... please go home!

Sunshine **Protection Act**

Having just, once again, gone through the disruptive semiannual changing of the clocks, I urge passage of the **Sunshine** Protection Act, introduced in the Senate, a year ago, by Marco Rubio (Republican,

Background: Daylight Saving Time (DST) was enacted in the United States in 1916 in an effort to conserve fuel during World War I. Originally mandated for six months, in 2005, Congress extended DST to begin the second Sunday in March and end the first Sunday in November. As a result, the United States now enjoys EIGHT months of DST, and only four months of standard time (November-March). The United States has also gone through periods where we have had year-round DST, including in 1942-1945 and 1974-1975.

Senator Rubio's Sunshine Protection Act would eliminate the changing of clocks to standard time for those four months. In sum, if enacted, we would not "fall back" in November and would enjoy a full year of DST, instead of only eight months.

This bill does not:

- Alter or change time zones.
- Change the amount of hours of sunlight.
- Mandate those who do not currently observe DST to do so (American Samoa, most of Arizona, Guam, Hawaii, Northern Mariana Islands, Puerto Rico, and the Virgin Islands).

Potential effects of making Daylight Saving Time permanent:

- 1. Reduces car crashes and car accidents involving pedestrians: better aligning daylight hours to drivers' standard work hours increases visibility, according to the American Journal of Public Health and the Journal of Safety Research. Also reduces the number of vehicle collisions with wildlife by 8 to 11 percent by shifting normal traffic patterns to an hour off from nocturnal wildlife's behavior.
- 2. Reduces risk for cardiac issues, stroke, and seasonal depression.
- 3. Reduces the number of robberies by 27 percent, according to a 2015 Brookings Institution because of additional daylight in the evenings.
- 4. Benefits the economy, according to a study by JP Morgan Chase, which found that there is a drop in economic activity of 2.2 percent — 4.9 percent when clocks move back.
- 5. Reduces childhood obesity and increases physical fitness, according to studies published by the International Journal Behavioral Nutrition and Physical Activity and the Journal of Physical Activity and Health, children see an increase in physical activity during DST. The Journal of Environmental Psychology found that DST increased pedestrian activity

by 62% and cyclists activity by 38% because of additional daylight.

- 6. Benefits the agricultural economy, which is disproportionately disrupted by biannual changes in time by upsetting the synergy between farmers' schedules and their supply chain partners.
- 7. Reduces energy usage, a 2008 study by the U.S. Department of Energy found that during the 4 weeks the U.S. extended daylight savings from the 2005 law, there were savings of about 0.5 percent in electricity per day. Later studies have also shown that the energy savings are minimal but a small savings does

The bill has bi-partisan support, including Ed Markey (D-Mass.), James Lankford (R-Okla.), Roy Blunt (R-Mo.), Sheldon Whitehouse (D-R.I.), Ron Wyden (D-Ore.), Cindy Hyde-Smith (R-Miss.), and Rick Scott (R-Fla.)

After this was written, news accounts reported that, on March 15, 2022, the United States Senate voted unanimously for the Rubio bill to put us on yearround Daylight Savings Time. Assuming that the House and the President concur, the change will happen in 2023.

"Peace, Human Rights and Justice in a United Ireland," -

Official Resolution of Boston City Council President Ed Flynn (Part I)

As we approach St. Patrick's Day, it is good to remember that "St. Patrick was the first and possibly the only saint in recorded history to emphatically and totally condemn slavery.' Fitting indeed as Patrick himself was brought to Ireland and enslaved until finally escaping and later returned to Ireland as a missionary. It was this missionary zeal that was responsible for the proselylization of its people, ultimately making an impact in the spreading of the Christian religion as well as Irish culture. One cannot discount the myriad of priests and religious who consequentially brought the message of the Gospel far from the European continent; and certainly the Irish culture is not lost with the many renowned works which have found its place in the canon of world literature by illustrious writers such as Stoker, Shaw, Joyce, Yeats, and numerous others.

The universal reach of those from Ireland not only extended to all lands, but many came to the United States due to economic necessity and in doing so, assimilated, and have become an influential part of the culture.

"It has been said that America's ethnic diversity is our national treasure. People from every nation and all faiths built up the United States, always striving for a more perfect union." This quote is attributed to Father Sean McManus and is descriptive of the diversity that has made up the cultural and ethnic fabric of America. However, Father McManus who has worked tirelessly in pursuit of the unification of his Irish homeland, has not abated in his desire to bring peace and equality to a land that has seen its share of partition and discord far too long.

Father McManus has introduced the "One Ireland Petition" that will hopefully bring a resolution to a long standing impasse: the unification of Ireland – including its whole 32 counties. And appropriately, in this month of March, the month of Patrick, the Resolution be introduced by Councilor Ed Flynn of the Boston City Council.

Flynn, son of former mayor Ray Flynn, and who was elected President of the Council in January, 2022 (as well as serving in the United States Navy 24 years) has been interested in the prospects of a solution to the socio-economic disparity in Ireland as well as improving equity for immigrants here. In respect to the Irish immigrant, Flynn was interviewed for the spring 2022 edition of the Boston Irish Tourism Association's Travel and Culture Magazine and says: "When Irish immigrants arrived in Boston and the United States during the Great Famine in the 1840s, they were not welcomed, and faced struggles and discrimination," and "Because of this painful past, the Irish community understands the important role that government and social services play in supporting our cities and towns across America. The Irish community continues to contribute to our country in sectors such as the military, business, building trades and organized labor, and is a critical advocate for social and economic justice for all."

Ed also indicates why he has been instrumental in the City's acknowledgement of the Irish and Irish-American role in American and local culture: "The City of Boston will once again formally recognize the exceptional contributions and sacrifices of the Irish and Irish-Americans to our city and country. It is important to celebrate these accomplishments and our proud Irish immigrant roots; and to reaffirm our commitment to social and economic justice for all."

"For this St. Patrick's Day [St. Patrick is patron saint of not only Boston but Nigeria and Puerto Rico, an even further testament of Ireland's global influence] the Boston City Council is pleased to endorse the spirit of the Irish National Caucus' Popular Internet Petition that has over 30,000 signers: "Ireland, too, has the right to be One Nation under God, indivisible, with liberty and justice for all." And, Boston, with almost a quarter of its population claiming Irish Justice in a United Ireland" will population overall claiming 20%,) "Who in America could not wish that for Ireland, which has given so much to America

- socially, culturally, politically religiously, educationally, and in every form of service?"

Father Sean McManus, originally from County Fermanagh, Northern Ireland, is a Roman Catholic priest committed to bringing justice and peace to Northern Ireland and who initiated this petition to bring awareness of the significance of having a unified country, with its focus of "Human Rights, Equality, Justice, and Reconciliation for the Island of Ireland (all precious 32 Counties), based on non-violence, non-discrimination, solidarity, and mutual respect." This quote as with others in this article, appear in the literature supporting the petition.

Father McManus further augments "This petition is consistent with the Good Friday Agreement and reflects the spirit of The Beloved Community, as taught by Rev. Martin Luther, King, Jr.; and, "Furthermore, national self-determination is a fundamental American principle and is the right of every Nation."

Father McManus is referring to the political Accord approved by referendum both in Northern Ireland and the Republic on Good Friday, April 10, 1998. The Agreement was enacted on December 2, 1999.

The Agreement not only advances the cause for Ireland's unification but advocates the themes of impartiality and justice; and, on a more local level, these are the principles that former Mayor of Boston and Ambassador to the Vatican Ray Flynn often spoke of while serving as Mayor of Boston from 1984 until 1993 when he was appointed Ambassador to the Holy See by President Bill Clinton and serving in that capacity until 1997.

The former mayor's addressing the issue of justice was not just endemic with the years during the Flynn Administration; indeed, his advocating for inclusive social justice in general extends back decades, as did his calling for the end to the discriminatory practices towards Catholics in Northern Ireland. Peace, Human Rights and ancestry (with the American Actually, Flynn began to call attention to the unfair treatment of Catholics simply due to their religious affiliation as far back as the early 1970s.

L'Anno Bello: A Year in Italian Folklore

The Superb Herbs of Spring

Spring has blossomed before us, green and cool as a bright sprig of spearmint. The longer days fill the early evening hours with resplendent golden sunrays. Robins are now a regular sight, scampering among bushes or taking off in flight from the treetops, their red feathers flashing the joy of spring. Buds become more pronounced, seemingly smiling with anticipation at the secret leaves concealed within. The first crocuses and daffodils wave gaily in the brisk breeze. Spring places me in the mindset of regrowth and renewal, inspired by the nature that blooms and flourishes all around me. In particular, I think of the gardens that are now beginning to take form, the first tender crops sprouting from the damp, dark soil. My father, like many Italians, loved to garden and took great pride in reaping the gifts that the Earth provided. He did not bequeath me a green thumb, but he did instill in me an appreciation for all that grows and all that originates from the natural world. In the springtime, early garden plants often take the form of delicate herbs. I love cooking with herbs, as their pungent aroma wafts through my kitchen and their sharp taste provides a kick to the recipe. However, I discovered that herbs all come with their own unique folklore and superstitions. In honor of the spring and the rebirth of vegetation, let us dive into the traditional lore of some of our favorite herbs.

• Basil: Basil, or basilico, is one of the best-known herbs of Italian cooking. It forms the crux of pesto, that delectable sauce hailing from the region of Genoa, typically made with crushed pesto, pine nuts and

symbolizes love, and in olden days a girl looking for a romantic partner announced her intentions by placing a pot of basil on her windowsill! However, this fragrant herb also holds a sinister side. People in the Middle Ages thought it gave birth to scorpions. Some scholars speculate that the word "basil" shares the same root as "basilisk," a spooky legendary creature that had the body of a snake and the head of a rooster and could kill its prey with just a glance!

- Lavender: I always thought of lavender as a pretty flower that bloomed in spring and summer, but it is actually used as a culinary herb as well! Honey made from bees that sip on lavender nectar is prized in the Mediterranean world. Lavender also forms the basis of many herbal teas. People use dried lavender buds to flavor breads, scones and chocolate, while candied lavender flowers make sweet cake decorations. In Italy, lavender is called *lavan*dula. It was so prized in ancient Rome that it cost as much as a farmer's monthly wages! Its name derives from the Latin word lavare, or wash, because lavender was used to perfume laundry and baths.
- Parsley: Parsley is known as prezzemolo in Italian. This beloved herb adds color and flavor to Italian pastas, stews and casseroles. It frequently appears as a garnish, a custom which has roots in superstition. Ancient cooks believed that parsley was an antidote to poison, and though we now know that is false, the credence lives on in the form of decorative parsley! In ancient Rome, on the other hand, parsley was often planted on graves. This custom inspired a bevy of olive oil. In Italy, basil further sinister parsley lore, such as

the superstitions stating that only evil people can grow parsley well, or that giving away or replanting parsley serves as an omen of death.

- Rosemary: When I think of rosemary, I think of my mother flavoring chicken or fish with this woodsy, piney herb. It is also delicious baked into biscuits and breads like focaccia. As William Shakespeare noted in Hamlet, rosemary symbolizes remembrance. It was once scattered atop caskets to ensure that funeral mourners would always remember the dead. The herb known as rosmarino in Italian also formed part of medieval brides' wedding bouquets, and as such became a token of love. Folklore also attributes rosemary with the power to repel the evil eye and frighten away malicious spirits.
- Sage: I am in love with the classic Italian combination of savory pumpkin and sage, or salvia. You might say that whoever thought of this delectable flavor profile was wise indeed, and you would be right! The herb sage is associated with wisdom, which is why we call intelligent people sages. Supposedly, bringing a pot of flowering sage indoors invites bad luck, so people would make sure to pick sage before it bloomed. A girl who picks sage on St. Mark's Day (April 25th) or Midsummer (June 24th) will dream of her future spouse, while eating sage in May promoted longevity.
- Thyme: Thyme, or timo in Italian, is a popular herb with which to season soups, stews and pastas. It also tastes wonderful mixed with lemon. This little herb carried a load of significance in the ancient world. The ancient Greeks burned thyme in their temples, believing that its aroma would imbue people with courage. In ancient Rome, it was used to purify rooms. By the Middle Ages, thyme had become synonymous with preventing nightmares and, when given as a gift, inspiring courage in knights. Like many other herbs, thyme was associated with the supernatural and as such was strewn onto coffins to assure a safe passage to the otherworld.

And there you have it — six well-known herbs and their associated folklore. I hope that the traditions and customs attached to these herbs will inspire you to use them in your cooking and, furthermore, to learn about the way people in times past related to the gifts produced by the Earth. After all, spring is about honoring the rebirth of nature, and delicious herbed goods provide us with a delectable way to do so!



From Seed to Bouquet — Grow Your Own Flowers for Cutting

You don't need a lot of space or a big budget to grow and enjoy garden-fresh bouquets. Just fill a few vacant spaces, add an extra row in garden beds, or fill a container with easy care flowers started from

You'll jump-start the season and enjoy earlier blooms by starting some of the seeds indoors to transfer into the garden after the danger of frost have passed. If you're not in a hurry, want to stretch your budget and extend your garden's bloom time, sow some seeds directly in the garden. Just follow the directions on the seed packet.

Annual flowers like these are known for season long bloom and a long vase life. You'll need to plant annuals each year, but you may decide the continuous bloom is well worth the effort. Supplementing them with perennial flowers and bulbs means you need to plant fewer annuals each year for a season filled with colorful garden-fresh bouquets.

Here are a few easy-care annual flowers that you can start from seed indoors or directly in the garden. These beauties will brighten those sunny spots in the landscape and bouquets in your home.

Start zinnia seeds indoors four weeks before the last spring frost or sow them directly in the garden. Either way, you'll have flowers about eight weeks after planting the seeds. Grow taller varieties like Benary's Giant for long stems, Queeny Lime Orange or Zowie! Yellow Flame for eye-catching color or Profusion and Zahara for small daisy-like flowers on compact mildew resistant plants in your low maintenance cut flower garden.



Zowie! Yellow Flame is a semi-tall zinnia with a unique bicolor pattern of blooms with scarlet-rose center and yellow petal edges.

Like zinnias, cosmos make a great cut flower and both are heat and drought tolerant in the garden. Start cosmos seeds indoors four to six weeks before the last spring frost or directly in the garden. The fine foliage adds texture to the garden and the white, pink, lavender blooms light up the midsummer through fall garden. Plant tall varieties en mass to eliminate the need for staking. Or grow shorter varieties like Sonata and Cosmic. Once you plant cosmos in the garden, you may be rewarded with volunteer seedlings in subsequent years.

Marigolds have long been favorites in the garden, but they also make great cut flowers. Like zinnias, you can start them indoors or directly in the garden and have flowers in about eight weeks. Include a variety of single, double, large, and small flowers to create a marigold only arrangement or mix with other flowers. The Gem

series of marigolds have lacy leaves with a citrusy scent and small single flowers all summer long. Not only are these 12" tall plants great in arrangements, but the flowers are also edible and attract beneficial insects to your garden.

Include calendula, another edible flower, in your garden and arrangements. Plant seeds directly in the garden in fall through spring when growing in the Deep South, Gulf, and Pacific Coast areas. Those in other regions can plant seeds directly in the garden after the danger of heavy frost has passed. Also known as pot marigolds, these plants thrive in cooler temperatures. If plants fade as temperatures rise, cut them back, continue to water as needed and watch for new flowers when the weather cools. These will reseed readily so watch for welcome seedlings the following year.

Sunflowers make dramatic statements in the garden and in the flower vase. The 2022 All-America Selections winner, Concert Bell grows 10 to 12 flowers on each stem. You'll have a ready-made bouquet with each stem removed. Suncredible® Yellow sunflower produces four-inch flowers on two to three feet tall plants. The plants continue to bloom throughout the season even if you don't remove the faded

Keep the flowers coming to enjoy in the garden and arrangements with regular picking. The more you pick, the more flowers you'll have. Share extras with friends, neighbors, or senior centers. Studies at Rutgers University found cut flowers immediately increased happiness and had a long-term positive impact on the recipient's mood.

Saint Arnulf of Soissons

Arnulf "Arnold" was born in the town of Brabant, near Brussels around the year 1040. He trained to become a soldier since his youth and later served under Henry I of France for a few years. Then he settled at the Benedictine St. Medard's Abbey at Soissons in France, where he served as a hermit for the first three years. He then was honored with the title of abbot of the monastery.

He then became a priest and in 1080, bishop of Soissons, another honor that he sought

When his see was taken over by another bishop he moved to found the abbey of St. Peter in Oudenburg in Flanders. While there he took to brewing enthusiastically and is said to

have realized he could clarify his beer further by passing it through woven baskets, an idea he had while making "skeps" (straw or wicker beehive) for the monastery's apiary. Generally not as strong as most modern brews, beer at the time was as essential to daily life as water and often much better for your health. It wasn't known at the time but pathogens in the water were killed during the brewing process therefore making the beer safe to consume.

Oudenburg in the 11th century was located very close to salt marshes, which weren't reclaimed until 1173. Home to all manner of viruses and pathogens and disease carrying insects, nasty bouts of plague and sickness must have been a common occurrence.


During one particularly virulent outbreak Arnold is said to have encouraged the local populace to steer clear of water altogether and only drink beer, which had the happy effect of saving a great many of them. Sadly, something in the water must have got him eventually, as he died at the age of only 47 in 1087. He was canonized in 1121. Arnulf of Soissons is perhaps the foremost patron saint of brewers and hop-pickers. The Feast Day of Saint Arnulf of Soissons is August 14th.

A Nostalgic Remembrance



First of all, to all my Irish brethren, Erin Go Bragh and a happy St. Patrick's Day to ya.

A few days ago, Loretta and I were driving on Atlantic Avenue and were stopped by a traffic patrolman due to a parade crossing in front of us. As they approached, I could hear the strains of "Wild Colonial Boy" being played on multiple bagpipes with drums for rhythmic background. When the band crossed in front of my 1966 Thunderbird, I saw that they were all dressed in Irish costumes and all participants, except the musicians, were waving to the onlookers. By the way, the Atlantic Ave. I mention is not the one in Boston. It is Delray Beach, Florida. I didn't know there were any Irish in these parts, but I guess I was wrong.

We Italians have a saint's day that is as important to us as St. Patrick is to the Irish, but not as publicized. It is St. Joseph's Day. March 19th is the day the foster father of Jesus Christ is honored in parts of the Christian world. His day is celebrated by the Anglican (Episcopal) and the Lutheran Churches as well as in the Roman Catholic Church. It is a patronal feast day in Poland and Canada and for people named Joseph or Josephine. In Italy as well as Spain and Portugal, it is Father's Day.

Seeing the date falls during Lent, which began on March 2nd this year, meatless dishes are served, following ancient customs. In Sicily, St. Joseph has become a patron saint. During the Middle Ages, Sicilians prayed to St. Joseph to stop a severe drought that had affected all of the island's crops. The people promised that, if Sicily was spared, they would prepare a feast in his name. Their prayers were answered and the fava bean crop that resulted saved the Sicilian population.

In Sicilian communities, it is traditional to wear red clothing

The first time I met the man (I've forgotten his last name, but Babbononno referred to him as Sammy), was when, I was a teenager, my grandfather asked me to bring him to Raymond's to buy an Easter suit. We headed for Maverick Station, worked our way to Milk Street Station, and wound up at the back end of the Old State House. Within five minutes, we were on Washington Street heading toward Raymond's. Once inside, the men's department was just to the right on the first floor. As soon as we entered, we were surrounded by salesmen trying to get our attention. Most had foreign accents, but all were well

Babbononno would wave them off yelling, "I talka ta Sammy, justa Sammy." Just as quickly as the group of salesmen arrived, they left, all except one, who yelled back, "Mine friend, Mike." He and Babbononno hugged as if they were long lost relatives and the conversation regarding a new suit would begin with me just observing the situation.

They would reminisce about having coffee in the North End when they were young men and then ask about each other's family. When the pleasantries were over, the subject of a new suit would take both men on a search for something that pleased my grandfather.

I must comment at this point ... Babbononno was four feeteleven inches tall, but in good shape for a man his age. A doctor would comment on his good health many years later and ask my grandfather what he attributed his longevity to. At this point in his life, when Babbononno was in his '90s, he said, "Good wine, good cognac and good cigars. When the doctor asked about food, my grandfather answered, "Oh yah, anche a cibo italiano." (Italian food, too.)

Sammy and Babbononno would find a conservative suit that fit the frame of a short men and my grandfather would refuse alterations stating that only Billy the Tailor from White Street in East Boston would make them. To Babbononno this man had magic fingers. I think he was right. Anyway, within a few days, my grandfather was ready for Easter Sunday.

Crescia al Formaggio or Italian Easter cheese bread is an intensely flavored bread that is typically found in Italy from mid March through April during the Pasqua season. This bread has the appearance of a panettone and the name "crescia" derived from the fact that the dough "grows" both in the leavening phase as well as in the oven. Italian Easter cheese bread can be served as a replacement for bread or on an antipasto board with cold cuts, cheeses and olives. It has been said that the Crescia al Formaggio has medieval origins. It was apparently the hands of the nuns of the monastery of Santa Maria Maddalena, in Ancona that created this delicacy as a dedication to the great Saint Mary Magdalene.

Antipasto is a staple that has always accompanied all of my family's holiday dinners. My mother made hers in a large platter with Italian cold cuts, cheeses, olives and stuffed peppers. She would then have an antipasto board with breads and crackers, along with bite sized slices of meats, cheeses, and flavored oil for dipping. This first course was so delicious that most times we would all be full before the second course was even served! If you want to bring some old world Italian tradition to your Easter table this year, the Crescia al Formaggio is the perfect way to do so!

ITALIAN EASTER CHEESE BREAD Crescia al Formaggio



- ½ cup whole milk
- 2 1/4 teaspoons or 1 packet yeast
- 1 teaspoon honey
- 5 large eggs
- 3 tablespoons olive oil
- 3 cups and 2 tablespoons 00 flour (all-purpose can be *substituted)*
- 1 cup grated parmesan cheese
- ½ cup grated pecorino cheese ½ to 1 teaspoon freshly ground
- 1 to 2 tablespoons butter,

black pepper

In a small saucepan over low heat, add milk and warm to just about 110° (don't overheat). Remove pan from heat and add yeast and honey, let sit to proof about 5 minutes.

In a large bowl, beat the eggs, add the olive oil, cooled milk mixture, and beat together well.

In a medium bowl, mix the flour, cheeses, and black pepper together and then gradually, about a ¼ cup at a time add this to the wet mixture and using your hands, mix it all together well.

Turn the sticky dough onto a floured dough board and knead until smooth. Make dough into a ball and place either in a paper or metal panettone mold or a greased 6 to 8 inch round metal pan with high sides.

Cover the mold or pan with plastic wrap and place in a warm dark spot to rise until double in size (about 3 to 4 hours).

When dough has risen, brush top with softened butter and bake on the lowest shelf in a preheated oven at 350° for 45 minutes. Check the crescia and if the top is dark, lower the temperature to 330° for the last 10 or so minutes. You can also tent the top with aluminum foil to avoid burning. Always check to see if cooked with a long toothpick and if comes out dry take the crescia out of the oven and let it cool on a wire rack.





Rest in Peace Ron Stander

Trained in Boston for His Shot at the Heavyweight Title Against Frazier

Ron Stander is best remembered for the courage he showed when he challenged Joe Frazier for the heavyweight title in 1972. The fight was stopped after the fourth round with Stander suffering multiple facial lacerations; however, he was never off his feet and had rocked Frazier in the first round.

Stander, who was known as The Council Bluffs Butcher after one of two places he called home; Council Bluffs, Iowa. He also lived not far away in Omaha, Nebraska where the fight with Frazier took place.

Tom Lovgren was a boxing promoter in Omaha and

I got to know Ron Stander while he was in Boston during that time. At first he was a bit scary and intimidating. His quietness could be taken as brooding, but in reality he was a very nice guy; very easy going.

The ring at the New Garden Gym was quite small, so the sparring sessions turned into

he arranged for the fight spirited affairs. Joe Young to take place there. He was also an enthusiastic supporter of Stander who believed his local hero had a real chance at upsetting Frazier. Tom decided to bring Ron to Boston to train under the guidance of local fight guy Johnny Dunn. Mighty Joe Young a talented heavyweight from Brooklyn, NY was brought in as a sparring partner.

Young was managed by Frank Gioseffi who had been a heavyweight boxer himself in the 1950s. Frank fought on the undercard of the Marciano/ Moore fight. Gioseffi later changed his name to Frank Gio and became a successful actor playing in movies and television. He was in Moonstruck, Once Upon a Tme in America, King of New York, and Analyze That among many others.

Frank wasn't able to make it to Boston with his fighter so I was asked to handle Joe for the training sessions. That was quite an exciting assignment for a teenage kid; working in the camp for a boxer training to fight for the heavyweight championship.

was no soft touch and the two of them went at it pretty hard. In an early session Young caught Ron with a left hook that cracked his nose. Not wanting to postpone the bout and risk losing their title chance altogether, Stander and Lovgren opted to use a full face headgear for the rest of the sparring sessions. This protected his nose but limited Stander's vision while boxing.

After the workouts Dunn and Stander would head downstairs to the Ninety-Nine Club for dinner and pitchers of beer. While a hard worker in the gym, Stander wouldn't give up his beer.

Tom Lovgren told me he was convinced Stander had a great shot at winning against Frazier based on the time Ron kayoed Earnie Shavers. It was early in both men's careers with Shavers having a record of 12 wins and 1 loss with 12 knockouts, and Stander being undefeated in 9 fights with 7 knockouts.

Shavers gave Stander a real going over in the first two rounds but Ron withstood the

battering. Lovgren told me Ron actually broke his arm during the exchanges. Stander came on in the next two rounds and put Earnie down for the count in round four. Lovgren figured Stander could have a similar performance against Frazier. He even put his money where his mouth was by betting \$10,000 on Stander at ten to one odds.

The fight took place on May 25, 1972 in at the Civic Auditorium in Omaha. As expected, Ron came out swinging. In the first round he caught Joe with a right hand that shook the champion. Stander held his own and many gave him that round. The crowd was

Frazier went to work in the second round and by the third was starting to bust Stander up. By the end of the fourth round the referee intervened and put an end to the fight. Ron ended up with 32 stitches in his face, but he never went down and was swinging until the very end.

For his efforts, Stander's purse was \$100,000 of which he took home about \$40,000, the biggest payday of his career. Lovgren lost his bet but not his respect for Stander. He was proud of his fighter as were the fans at the Civic Center who turned out to cheer him on. Ron Stander had nothing to be ashamed of.

Ron Stander passed away on March 8th from complications

HOOPS and HOCKEY in the HUB

Looking down on the ice from our elevated seat in the press box at the TD Garden, it seemed a bit sad to us as we viewed another once-a-year game taking place.

In the notes distributed to media members prior to a game, it is stated how many appearances a team makes in the Garden each year. In the case of all Western Conference teams, that notation usually states that a given club "is making its only appearance of the year."

This night it was the Arizona Coyotes that were visiting. That meant former Bruins forward Phil Kessel would once more be in action on Garden ice, bringing to mind former times when he excelled in numerous home games for the Black and Gold.

Although the Coyotes were near the bottom of the NHL standings when they came to Causeway Street, they had won their last four games in a row. Extending their recent good fortune would not be the case as the Bruins prevailed 3-2 in the final minute of regulation.

But it was Kessel that drew our attention and brought back memories since he began his NHL career with the Bruins, was traded to Toronto and later went on to win two Stanley Cup championships with Pittsburgh before moving on to Arizona.

If there is one defining characteristic of Kessel it is his durability. As he came over the boards for his first shift of the night, he was resuming his quest to move up the ladder into second place among all NHL players in history for consecutive regular season games played.

And on this particular night, he was coming ever closer to Doug Jarvis, who had a long career in the NHL and later served as an assistant coach for the B's from 2010-2016. Jarvis is second on the list behind leader Keith Yandle who currently plays for Philadelphia.

As of press time, Kessel had played in 960 consecutive games, a streak that began back on November 3, 2009 — after he was traded to Toronto.

Jarvis played in 964 consecutive games in a career that stretched from the 1975-1976 season to a couple of games during the 1987-88 campaign. But here is what is what is most remarkable about Jarvis: He never missed a regular season game in his entire NHL career. Not even Kessel or Yandle can say that because early on both did.

If all goes well for Kessel over the next couple of weeks, he will surpass Jarvis on the list in late March and move into second place. Then it will literally become a contest between the two active players to see who will conclude his respective career as the leader. It will be a race between two players with Boston ties: Kessel was more visible here since he was once was with the B's. Yandle was born in Boston, grew up in Milton, and has played in the NHL for 16 years. Yandle surpassed Jarvis back on January 25 to move into first place.

Among other active players Brent Burns (San Jose), currently eleventh of the list, is the closest, having played in 656 games as of mid-March. Patrick Marleau (now also with San Jose) saw his streak of 910 conclude in the spring of 2021.

Just thinking about what Kessel, Jarvis, Yandle and yes, Marleau have accomplished simply boggles the mind. All those games, all those seasons, not one injury that kept them out, not once were they scratched from the roster. Remember that hockey is a very physical game that is played in an enclosure with players being checked into the boards on a regular basis. There is no scampering out of bounds to avoid being hit.

Either Kessel's or Yandle's streak could end with any game, but assuming this twoplayer race continues it could be Kessel who ultimately wins out. Although Yandle has about a 20-game "lead" on Kessel (it fluctuates from night to night), he is a year younger than Yandle. Thus, if age eventually comes to matter, Kessel may have a small edge.

Earlier this March a blessed event "threatened" to end Kessel's streak. The Coyotes were in Detroit when he learned that the birth of his first child was imminent. He skated one shift to keep the streak alive, then went to the airport where the franchise had chartered a plane so he could return to Phoenix. Two nights later, he was back in the lineup in Toronto to continue his streak.

That 30-second shift in Detroit was a departure from normal. He is averaging a total of nearly 17 minutes of ice time per game this season. He was a bit under that at the Garden the night we saw him, going on the ice for 20 shifts with a collective time on ice of 15:22.

Philip Joseph Kessel, Jr. was born in Madison, Wisconsin and grew up in the suburb of Verona.

He credits one of the coaches he worked under as a teenager - Bob Suter (a member of the 1980 Miracle on Ice Olympic team) — for helping him become the player he is today.

He played one year for the University of Minnesota. His last game for the Gophers was a loss to Holy Cross in the NCAA Regionals, a Crusader victory that remains one of the most significant in that school's history.

The Bruins selected Kessel in the first round (fifth overall) of the 2006 NHL Draft, ahead of both Milan Lucic and Brad Marchand.

Early in his career, Kessel faced his toughest opponent. But he beat cancer and was awarded the Masterton Trophy for his perseverance. He became a productive player, making significant contributions, including 36 goals in his third season. His cumulative totals with the B's: 66 goals and 60 assists for 126 points across 222 games.

He was traded to Toronto in 2009 and moved on to Pittsburgh in 2015 where he won those two consecutive Stanley Cups (2016 and 2017) with former Bruins head coach Mike Sullivan at the helm of the Pens. He joined the Coyotes in 2019. Will he become the all-time "iron man" of the NHL? Let's just say he is up to the challenge.
