Santorum Takes Louisiana by Storm

Former U.S. Senator Rick Santorum won the Louisiana Republican presidential primary, beating the acknowledged front-runner Mitt Romney nearly two to one at the polls. Santorum had 49 percent, Romney had 26 percent and lagging in third place was Newt Gingrich at 17 percent.

Santorum, already campaigning in Wisconsin as the votes were being counted, told supporters in Green Bay Packers Country: "We're still here. We're still fighting.

We still believe, as this race really shows." Romney still leads in the all important delegate count and even with a 49 percent share of the vote, Santorum picked up only eight new delegates and doesn't appear to change the overall dynamics of this Republican version of the WEE Smackdown. It is still the Big Unit versus Santini.

However, another loss in southern states for Romney continues to underscore a pattern in this drawn out race. Santorum has a working Southern Strategy. To date he has won Tennessee, Mississippi, Alabama and now Louisiana. While Gingrich has won both South Carolina and Georgia. Romney appears to have no strategy below the Mason-Dixon

The next primaries will be Wisconsin, Maryland and Washington, DC on April 3.

Mayor Menino Promotes The Boston Model for Success

Announces Plans for Public Innovation Center and Encourages National Agenda to Replicate Boston's Example of Partnership, Not Partisanship

Recently, during his annual address to the Boston Municipal Research Bureau, Mayor Thomas M. Menino highlighted how Boston has successfully created jobs, education, and innovation will break ground in three during a stalled economy. Mayor Menino outlined *The* Boston Model, calling on the nation's leaders in Washington to learn from Boston's successes by focusing on partnership, rather than partisanship.

"With spring officially here, there is no doubt that Boston is a rising sun. And I believe our progress shows that Boston has a lot to offer the nation," Mayor Menino said. "Politicians in this country are now so focused on ideology, and not on the things that improve people's

Mayor Menino also announced that the City has

finalized a partnership agreement with Tim Rowe and the Seaport Square development team to operate the new Boston Public Innovation Center. The Center Science and Healthcare weeks and will serve as a nology to Improve People's trepreneurs to meet and exchange ideas, to convene programs and events, and support of the innovation economy. The center will be a one story, 12,000 square foot facility, including a 3,000 square foot restaurant, and 9,000 square feet of meeting and event space.

Mayor Menino outlined five steps that the federal government should take to replicate Boston's success.

- One: Create a National College Completion Effort
- Two: put One Million High-School Teens to Work Over the Summer

- Three: Launch a National Workforce Housing Program for Middle Income Households
- Four: Invest in Basic Life
- Five: Use Green Tech-

"The most vital thing to replicate would be our cooperation and partnership," Mayor Menino said. "Together, we have showed The Boston Model is about partnership; not partisanship."

Results of "The Boston Model" Include:

- \$3 billion dollars of development currently under construction in Boston.
- 100 companies and 3 thousand jobs have set up in our waterfront Innovation District since January

What Do Poll Numbers Mean in the Real World?

Recently, WTKK 96.9 conservative radio talker Jay Severin referenced a recent poll indicating 32 percent of Americans agreeing with Obama's thinking and 68 percent disagreeing. 

GETTING CLIPPED IN OLD ROME

A barber may be defined as a person who engages in the occupation of cutting and dressing the hair, and shaving or trimming beards. The name barber is derived from the Latin "barba", meaning beard. The occupation goes back in antiquity to at least 600 B.C. The Old Testament mentions Ezekiel, who used a razor to cut off his hair and scatter it to the winds. It was not the cutting of the hair, but the use of a razor that indicated a form of barbering that possibly existed.

Our barbers of today are often referred to as tonsorial artists. The Latin words "tonsor" or "tonsoris" refer to barber or shearer. "Tonstrix" is a female barber or hairdresser and "tonstrina" is the barber shop. Barbering was first practiced in Rome about 300 to 250 B.C. The Roman tonsor cut and dressed the hair, trimmed beards, cut fingernails, and tweezed unwanted hair that wasn't cut or was in places that couldn't be cut.

The real Roman dandy actually entrusted the trimming of the beard and style

of the hair to his tonsor. There was a period in Roman history when the barber was almost a tyrant. The hair was cut and styled his way or not at all. The wealthy families were able to afford the services of a tonsor as part of their household staff and were attended once or twice in the course of a day. The majority, who were not able to afford the luxury of a private barber, were forced to patronize one of the many tonstrina in the city.

There were also those barbers for the poorer classes, who placed their barber chairs or stools out on the sidewalk each morning and did their clipping in the open. From its very beginning the tonstrina became a club, information center, gossip shop, and a rendezvous for a job interviews by employers. The popularity of the barber shop was a barometer of their income, and most barbers became very wealthy.

The usual tonstrina had benches for the waiting customers and mirrors on the walls. The victim of the mocenter of the shop. His clothing was protected by one of many kinds of coverings, like a towel or "sudarium", or a front cover "involucrum" made of linen or fine cotton. His majesty, the tonsor, would perform the actual grooming or shaving while one or two of his assistants would stand around and pass the various "tools of the trade".

National attitudes toward hairdressing were much the same as today. There were those who preferred to mass their hair artistically like Nero, or those who never permitted more than a few brief moments to hair grooming like Augustus. Haircuts were performed with iron scissors that never knew a common pivot, and of course, this made steps inevitable and a comb very desirable. Curling and dyeing the hair was also common practice during those times. Thank goodness that the men of today do not indulge themselves in such vanity.

Repugnant to the Constitution and Void



Last Friday, March 23rd, over 50,000 concerned citizens gathered at public rallies in over 100 American cities to Stand Up For Religious Freedom. The Boston rally was well attended, in spite of change of location to the Boston Common less than 48 hours prior to the rally and an erroneous rumor that it was being cancelled entirely.

For me the highlight of the Boston rally was C.J. Doyle, Executive Director of the Catholic Action League of Massachusetts (www.catholicactionleague.org), addressing the substantial arguments against the constitutionality of the Obama Administration's Department of Health and Human Services mandate that religiously affiliated hospitals and other institutions purchase products and services they find morally impermissible.

Mr. Doyle spoke of an earlier state attack on freedom of religion and how the United States Supreme Court ruled, unanimously, that such attacks against Church-related institutions were "repugnant to the Constitution and void."

In 1922 the Ku Klux Klan in the state of Oregon pushed for passage, by popular initiative, of a law to ban private schools and to require all children to attend state schools. When Republican governor Benjamin W. Olcott issued a 1922 executive proclamation condemning the Klan that violent organization put its support behind the election of a new governor, Democrat Walter M. Pierce, who supported the anti-Catholic school ballot initiative.

The Klan celebrated two victories in the November 1922 elections in Oregon, the anti-Catholic bigot, Democrat Pierce; defeated Republican Olcott for governor, and the voters enacted the anti-Catholic school law.

The Society of Sisters of the Holy Names of Jesus and Mary sued to stop enforcement of the law and the case went, in 1925, to the U.S. Supreme Court where the law was held unconstitutional under the due process clause of the Fourteenth Amendment. The court declared:

"The fundamental theory of liberty upon which all governments in this Union repose excludes any general power of the State to standardize its children by forcing them to accept instruction from public teachers only. The child is not the mere creature of the State; those who nurture him and direct his destiny have the right, coupled with the high duty, to recognize and prepare him for additional obligations."

This past week the court heard arguments regarding the unconstitutional Obama health care law. Undoubtedly it, too, will be struck down in whole or in part.

Health Reform Provides More Than 45 Million Women Access to Preventive Health Care Services

Millions More See Lower Prescription Drug Costs, Stand to Gain Health Insurance Coverage

Act, 45.1 million women including 20.4 million women with private health insurance and 24.7 million women with Medicare — can receive recommended preventive services with no cost-sharing, new data released by Department of Health and Human Services Secretary Kathleen Sebelius.

Most women with private insurance do not have to pay for such important preventive health services under health reform; mammograms, cervical cancer baby and well-child visits will be covered at no cost. Beginning in August of this year,

sharing, recommended preventive services, such as well-woman visits, domestic violence screening, and

breastfeeding supplies. An estimated 8.7 million more women who buy coverage in the individual market will gain maternity benefits, beginning 2014, as a result of the health care law's requirement for health insurance plans in that market to cover essential health benefits.

Additionally, the ASPE issue brief notes that more than two million women in Medicare have saved \$1.2 billion on the cost of prescription drugs in the "donut hole" coverage gap. The Affordable Care Act helps seniors and people with disabilities who have Medicare pay less for their prescription drugs in the donut hole, which by 2020, the will be closed.

LBJ WAS AS BIG AS TEXAS

It is an entertaining as well as enlightening book." Normally, if Jimmy Carter is recommending something, I turn in the other direction. However; this book really sounds good.

A book on Johnson pushed by Carter seems weird. No two presidents could have been any different than Carter and Johnson. One was a leader who knew how to lead and the other, well, let's say he wasn't that and leave it there.


to Receive The Order of Saint Michael the Archangel Award

Is the City liable when one child in the school yard pushes another child to the ground and breaks his wrist?

MELISSA INGERSON et al. v. CITY OF WORCESTER Opinion No.: 117908, Docket Number: 09-2307 SUPERIOR COURT OF MASSACHUSETTS, AT WORCESTER November 15, 2011, Decided • November 18, 2011, Filed

On December 9, 2008, the plaintiff Anthony Dejesus (Anthony), a second grader at the Belmont Community School, Worcester, Massachusetts, exited a school bus and proceeded to the area known as the schoolyard to await entry to the building. At least one school employee was always present at the schoolyard to supervise the students. Some ice and snow was present on the schoolyard that morning. While waiting with other students, Dejesus was inadvertently pushed to the ground by another student who, in a game of tag; was

to his right wrist.

Suit was brought against the City of Worcester.

The defendant City of Worcester contends that it is immune from liability as a matter of law and is entitled to summary judgment in its

The trial Judge said:

On the motion record before me, I find that there is nothing upon which an affirmative act of the City of Worcester, causing or contributing to the harm of the plaintiff can be found. The City of Worcester's inaction in failing to maintain and attempting to avoid being supervise its students more tagged "it." As a result, carefully is pleaded and

Dejesus suffered a fracture would be a permissible finding by the fact finder if not for the immunity of §10 (j). Although this somewhat technical distinction between school officials' affirmative acts and failures to act produces a harsh result in this case, it is what the law mandates. Therefore, the City of Worcester's motion for summary judgment must be allowed.

ORDER

The Motion of the City of Worcester for Summary Judgment Is ALLOWED.

This case says that the City is not to be held responsible when one child causes injury to another in the schoolvard.

Boston Food Truck Program Schedule

Favorite Food Trucks Return to City Streets, Adding New Trucks and New Locations Starting April 1st

released the 2012 schedule for the City of Boston Food Truck Program, which officially kicks off on April 1. To launch the new season, the City held a Food Truck Lottery at City Hall, where 23 food truck vendors participated in a random, draft-style selection event to choose from more than 150 vending shifts — roughly 74 lunchtime shifts and 63 breakfast and dinner shifts — at 7 sites across Boston. The City has also added several new food truck sites, including the first 3-truck cluster on city streets, located at Stuart Street and Trinity Place near Copley Square.

"Last year's food truck pilot program was a great success and it's wonderful to see so many new and returning food trucks this year," Mayor Menino said. "My administration has worked extensively across City departments and with food truck operators and residents to

Mayor Thomas M. Menino create a program that continues to give opportunities to small businesses, enliven public spaces, and promote access to fun, interesting, fresh food across the city."

> The Food Truck Lottery event was held on Thursday, March 8th at City Hall and was designed to make the scheduling of new and preferred locations a public and transparent process. Of the 23 food trucks, 15 were part of the City's pilot program with 8 new trucks joining the program this year. Food truck owners gathered and drew names, selecting their preferred locations.

"The live lottery was a great community event that was fair, innovative, and fun — in the true spirit of food trucks!" said Loc Vo, owner of the Momogoose food truck.

In addition to the returning sites at City Hall Plaza, Boston Public Library, Clarendon Street, among others, the City introduced several new sites for food trucks:

Copley Square at Stuart & Trinity Place - while this site existed last year, we've created the City's first 3-truck cluster site on city streets by adding 2 additional truck-vending sites

China Trade Building at Boylston Street - next to the outdoor plaza in front of the China Trade building and across from the Registry of Motor Vehicles.

Financial District - the City's 3rd food truck cluster site (after City Hall & Stuart Street at Trinity Place) is located on the corner of Milk & Kilby. This site can accommodate 2 food trucks.

South End at Tremont Street and Berkeley Streets adjacent to the Benjamin Franklin Institute.

Mayor Menino has been a strong proponent of the food truck movement in Boston. Two years ago, the Mayor launched the Mayor's Food Truck Challenge, inviting local entrepreneurs to present their food truck menus and concepts for a chance to receive permits to operate on City Hall Plaza as well as financial support from the City of Boston. The three winners of the Challenge that operated on City Hall Plaza winners were: Clover Food Lab, Momogoose, and Bon Me.

Are We a God Forsaken People?

on Bremen Street pushing some publishing company. In large writing is written "GOD FORSAKEN" and to its left a simple sentence, "Bad things happen, is there a God?" Growing up Catholic in the '50s and '60s, we were taught at an early age that bad things do happen and that God allows them to happen. Many times these bad things are a tests for us. Life was never meant to be perfect. People suffer and die all the time. Wars happen. Horrible natural disasters tear at the fragility of life. We read of pain every day in newspapers. Most of the time tragedy sells.

Usually when I am reading this particular billboard I am in the midst of a power through Bremen Street Park and the old path that once served as the Narrow Gauge Railroad railbed. I never feel God forsaken when I am out exercising keeping healthy and enjoying the fresh air He gave us.

I wonder how often most of us do feel God forsaken when bad things happen and we are troubled to explain any of them away. Or we go to a wake for a dear friend or relative and remember all the good times you and they had and how they are now a part of your past rather than present. I remember when my brother passed back in 2007 at 56 years old and how angry I was that God let him die. He should have had years more to live, enjoyed life and his family.

I've seen this billboard message in other neighborhoods near busy roads. In this case next to McClellan Highway and Route 1A. Near the airport is an appropriate place since jets fly into the heavens all day long. Closer to heaven than we are down below on the streets of East Boston, but still far removed from everlasting life as we hope to come. God forsaken people have lost all hope and live in constant gloom and doom. Not the best way to live and certainly not a good book to read.

Adding to this reflection was the recent gospel and sermon by Father Wayne over at Sacred Heart a few blocks away from this billboard spreading hopelessness and fear of tomorrow. In the sermon, he said, "Scripture speaks of accepting light and overcoming dark-

I noticed a billboard over in ness. We can live in the East Boston near the YMCA light or wallow in the dark." The light sounds much more positive, doesn't it? In his homily, he talked about the 3,000 subway dwellers that live in the tunnels far below the streets of New York City, a world of constant darkness. Do these dwellers, who almost never surface living in their own dark underground world, ever seek the light? Or do they fear it? Do they live in a world forsaken by God or in a world of "selfforsakenness?" It is easy living in the darkness. You stay put in your life, keep your eyes closed to the beautiful world so nearby. Are these 3,000 lost souls really happy and content as they exist quietly in the cocoon of silence and everlasting darkness? It sounds like they've created their own hell on earth. No fire but only loneliness. That is the world of darkness where life is hopeless and without meaning. Even pain brings meaning to life. It highlights where we stand in our time here for good or bad. When we are gone, will we be remembered or forsaken to a storage facility where we are lost forever as if we never lived?

Thank God that those subway dwellers only number 3,000 but even 3,000 are too many. As an aging baby boomer and Catholic who started life speaking Latin at church, I am not God forsaken, I am thankful for my life with all that my life entails. Yes, I don't like my dark moments but I struggle through them because seeking light is seeking meaning and seeking meaning is to understand life.

I was taught God never abandons us; we are never "God Forsaken." As Easter approaches, we will celebrate new life and the light that shines in the darkness. This is a place that must be sought on both the good days of our life and the bad days too. The billboard asks the question, is there a God? The answer is surely yes. Do bad things happen? The answer is yes, too. However, life is meant to be lived, life is here to be celebrated. It belongs to us for as long as it should be. When our time comes, I have faith that we will not be forsaken. All this means something someday. Otherwise, we would just be wasting our time away.



Saint Rupert of Salzburg

The early life of Saint Rupert is shrouded in the mist of the past, the exact date of Rupert's birth is unknown but according to tradition he was born in the mid seventh century into a Frankish Merovingian family. We know that he was Bishop of Worms, in what is now Germany, and in that capacity he became known for his simplicity, prudence, and his adherence to the Word of God. Rupert has been characterized as being a lover of truth; he was upright in opinion, cautious in counsel, energetic, deeply charitable, and in all his conduct a model of rightness.

Rupert came to the attention of Duke Theodo II of Bavaria who was deeply interested in the Church of Bavaria. Theodo realized that despite the work of early missionaries the people of Bavaria remained only superficially Christian, retaining pagan customs that were woven into their belief. Theodo requested that Rupert should come to Bavaria to revive, confirm, and propagate the spirit of Christianity in his realm. Rupert agreed to Duke Theodo's request and in 696 arrived in the old residential town of Regensburg where he was received with great honor and ceremony.

Rupert was given the territory of the Danube traveling to the Wallersee where he built a church in honor of Saint Peter, which became the foundation of the present market-town of Seekirchen. Rupert requested that Theodo give the territory Juvavum, (modern Salzburg), an old Roman settlement, it was a place of considerable commerce, where Rupert planned to erect a monastery and establish an episcopal see. Theodo granted his request and gave to Rupert and his successors two square miles. The territory encompassed the precipice of the Monchberg cliffs, where once St. Maximus, a disciple of St. Severin, suffered martyrdom with his companions in 476. St. Rupert erected the first church in Salzburg, the Church of St. Peter, as well as a monastery. Upon the lofty cliffs of Nonnberg to the southeast of the town, where the old Roman fortress once dominated the surrounding territory, he established a convent of nuns which, like the monastery of the Mönchberg, he placed under the protection and Rule of St. Benedict. St. Rupert was the first Abbot-Bishop of Salzburg, establishing his foundations after those of the Irish monks.

In addition to Christianizing the people of Salzburg and Bavaria, Rupert built churches and monasteries for their worship. He also was instrumental in developing the salt mines of Salzburg, contributing not only to the spiritual needs of his flock but also their temporal needs.

Saint Rupert passed away at Salzburg on Easter Sunday, March 27, 718, known as the Apostle of Bavaria; his feast day is celebrated on March 27.




Large company Kelley McCormick who reconglomerates continue to try to impose upon the neighbor-

DAPPER TO GET ROSLINDALE SQUARE **SCULPTURE**







Though the lineup of the Blue Grass Boys changed over the years, Monroe always remained devoted to bluegrass in its purest

In 2005 Daniele released Iguana Café. Between 2005 and 2010. Daniele released three more studio albums: Il Mio Nome e Pino Daniele e Vivo Qui, Ricomincio da 30 and Electric Jam. In 2010, Daniele released his 13th studio album, Boogie Boogie Man.

Moron! Jose Romero-Valenzuerla of Las Vegas was pulled over by Oregon cops three times in one hour and charged with driving 105 mph, 98 mph, and 92 mph, respectively. "You would have hoped the message would have gotten across the first time," said a police spokesman.

Trenton, New Jersey's city toilet paper crisis came to an end, as necessity overcame bureaucratic bickering about the price of paper goods for public buildings. After weeks of empty bathroom dispensers in police headquarters, senior centers and other buildings, Trenton was facing state intervention, officials said, an action that could have included closing some buildings for health violations. "I'm embarrassed," said City Council President Kathy McBride, after the incident sparked media attention. "We are the laughingstocks, not only of this nation but of the world." McBride called upon her council colleagues, who have twice rejected a \$42,000 contract for a year's supply of paper products, to act quickly. While the council debate continues, the mayor's office rushed through a \$16,000 emergency order for toilet paper, paper towels and toilet-seat-covers, ending the tale of Trenton's toilet paper woes, which briefly held the title as the most-read story on BBC.com.

"Tide" crime wave: Massachusetts police reported that thieves are targeting Tide laundry detergent, joining a national crime wave that has baffled investigators and forced supermarkets to lock down their supplies. Thieves in Massachusetts, Minnesota, Kentucky and several other states are shoplifting the detergent in bulk quantities and selling it on the black market, at up to half its \$20 retail value. In the Massachusetts towns of Dartmouth, Fairhaven and New Bedford, thieves in search of high-resale items have staged lightning raids on supermarkets, grabbing large jugs of Tide and dashing from the store. "We have been dealing with it periodically for almost two years now," said Detective Robert Levinson of the Dartmouth Police Department. "It's a widespread problem." Levinson said thieves sell the Tide for \$10 in bars and cafes. "The flavor of the day is Tide," said Capt. Steven Vicente of New Bedford's Major Crime Unit. "Before that it was baby formula."

The Supreme Court in Argentina has ruled that women who have an abortion after being raped will no longer be prosecuted. The court confirmed a lower court's decision to allow a 15-year-old, who had been repeatedly raped by her stepfather for years, to terminate her pregnancy. Argentine law had previously been unclear on the point. The law read that abortion was legal only "if the pregnancy stems from a rape or an attack on the modesty of a woman of feeble mind." Some judges interpreted it to mean that abortion was legal only for mentally handicapped women who had been raped. An estimated half a million women have illegal abortions in Argentina each year.

Scornata! A woman who told customs officers she was three months pregnant was discovered to have \$20,000 worth of heroin in her groin and intestines. Authorities said Nigerian Afolake Awoyemi, 42, waddled off a flight at New York's JFK airport with a distended stomach under a "loose-fitting dress." A pat-down revealed a peculiar "bulge" that was not a baby. After she spent time on the airport's specially designed "Drug Loo" toilet, which sanitizes evidence, the bulge turned out to be 25 packets of heroin.

From the gossip rags! The National Enquirer front page showed a weird photo of John Travolta and headlined: Travolta Caught in Prostitution Scandal! Also in the widely read rag was a story about Meryl Streep with a heading, Meryl is a "Nasty' Lady." "We do call her the 'nasty lady' because it fits," said one person who lives near the 62-year-old star. The recluse actress, who has four children with her sculptor husband Don Gummer, has been criticized for not sharing her good fortune locally and making life difficult for her neighbors. "She lives on a very big multimillion-dollar property in the area, but she doesn't give back," said the neighbor. Enough

A New York City police officer shot himself to death last week, marking the fourth suicide committed by an NYPD officer this year and the second in just eight days. Matthew Schindler, 39, was found dead in his car on the side of the Long Island Expressway, he shot himself. A 14-year veteran of the force, Schindler left behind a wife and three children. Upon hearing the news of Schindler's suicide, Bill Genet of the Police Organization Providing Peer Assistance volunteer group said, "Oh, God, not another one." The other police suicides include an officer who shot himself in the head with his service weapon while at the scene of a Queens's car burglary, in front of both his partner and the car's owner. "He got out of his patrol car and he's on the phone with somebody," said a witness. "He puts the gun in his mouth and fires."

ROAST LEG OF LAMB

1 leg of lamb (5 to 6 pounds) 4 cloves of garlic

1 tablespoon thyme or

½ cup chopped mint (optional)¼ cup lemon juiceSalt and pepper

Rub the leg of lamb with half of a garlic clove. Then make several gashes with point of knife into the lamb leg and insert small cut portions of garlic clove into the narrow openings. Rub meat with mint, thyme, or oregano, whichever you plan to use, or some of each. Rub leg of lamb with salt and pepper. Add a little water to the lemon juice and pour gently over lamb. Place lamb fat side up in roasting pan. Place in preheated 325°F oven uncovered. After 30 minutes, baste lamb with juices from the roasting pan and repeat frequently. Lamb should be baked until meat thermometer reads 175 to 180°F. If you are baking without a meat thermometer, allow lamb to bake approximately 30 minutes per pound of lamb. Add more water mixed with a little lemon juice if more liquid is needed for basting.

OPTIONAL: Small white potatoes, carrots and some mushrooms can be added around the leg of lamb after the lamb has baked about an hour. Continue basting vegetables as well as the lamb.

NOTE: I awoke Easter morning to a combination of aromas filling the kitchen. I watched as Mama put the lamb roast into the oven. I saw the chicken soup simmering slowly on the stove next to the tomato sauce Mama had prepared earlier. I always asked to have one of the meatballs as she completed frying them. When did Mama start all this, I wondered.

On the kitchen table, a bowl of hard-boiled eggs greeted my eyes along with a Cannattone (Easter Bread) for Peter and me. As Peter, Papa and I departed for church after breakfast, Nonna and Mama's sister Lena arrived to help make the ravioli. I knew then that the Easter meal would keep us at the table for a long time.



Last week, I was talking about my problem when I started working at the Seville Theater. I had told the manager and assistant manager that I was sixteen years old and they believed me because I looked older than my age. When I started, I was on the bottom of the food chain. I inherited the shifts that no one else wanted. After working for two weeks, Mr. Wall, the assistant manager, asked if I would be interested in doing some maintenance work. As an usher, I would earn the minimum wage, fifty-five cents per hour. Doing maintenance, I would earn \$1.00 an hour, and I agreed. When I told Babbononno, he didn't know what kind of maintenance work I would be doing and gave me a pair of work gloves to use to avoid splinters in my hands. I didn't want to burst his bubble by telling him that I wouldn't be handling any lumber, but that was his point of reference and he was proud of his grandson, so I took the gift and kept my mouth shut.

At the end of the first week of ushering and doing maintenance, I received two pay envelopes, one with my usher's pay and the other for the other work which consisted of helping to repair theater seats, painting the floor of the balcony and running a few errands. When I looked inside the corresponding pay envelope, there were just two dollars waiting for me. I questioned Mr. Wall, the assistant manager and he told me that he didn't think my work was that good and the two dollars was all that it was worth. I wasn't happy and told Dad and Babbononno. Dad was ready to intervene, but I told him that I wanted to handle it. I knew that the head of main-

tenance had the ear of the assistant manager and I mentioned to him what I found in my pay envelope. He just shrugged. I also told him that my father was going to have the family attorney look into the matter and walked away. The next day I was working a shift in my usher's uniform and was called into the office by Mr. Wall. He stared at me for a few seconds without saying anything and then handed me an envelope. I opened it and the rest of the money that was owed to me was there. He then said, "I guess you're not one of those people just off the boat." At that point, I knew exactly where he was coming from. I thanked him for the remainder of what was owed me and began to walk out of the office, and as I did, he smiled saying, "Hey kid, you're not so dumb."

When I arrived home, I told Dad and Babbononno just what happened and they just smiled. Dad said something I didn't get at first, "Justice is sometimes its own reward.

What I also didn't know was that Dad and Mr. Ray, the manager, knew each other from years back. Mr. Ray was well known in society circles and Dad played with bands that catered to the society crowd, hence the relationship. Word had gotten back to Mr. Ray about the pay situation and I think he exercised his authority regarding the scenario.

Well, I labored under the

gun of Mr. Wall from then on. He didn't make it easy for me, but Mr. Ray did. He was what Dad called, "Very Yankee." He sometimes was abrupt, and always formal or semi formal in his approach to me. Years later when I was a young adult, Mr. Ray would tell me to call him, Jim, when we went out to dinner or when he joined me and my musician friends after work at Ken's in Copley Square late at night. However, I could never bring myself to call him anything but, Mr. Ray. Behind his back, some of the longtime ushers referred to him as Papa, but face to face, it

was always, Mr. Ray.

I survived the summer of 1952. That fall, I began my tenure as a student at Boston English High School. Mr. Wall approached me again regarding my working papers, a situation which seemed to slip my mind every time it was brought up. It got to a point where Mr. Wall became exasperated and threatened to fire me if I didn't obtain them. I thought my career as an usher was over because I was only 14 years old by late October, still two years younger than the minimum age to obtain them. Then, one day, I headed for work and all traces of Mr. Wall were gone. I asked Mr. Ray where he was and was told that he was transferred to another theater. I didn't say I was glad, but I was happy about the situation. Then I thought about it, "Sometimes, the enemy you know is better than the enemy you don't know." So, I asked Mr. Ray who was going to take his place and I was told that the company was doing away with the position of assistant manager, and he, Mr. Ray, would be running things by himself.

As time went on, I worked my way up the ladder. I would give Mr. Ray excuses whenever he mentioned working papers and thought I was conning the man. When I turned sixteen and actually obtained them, I discovered that Mr. Ray knew how old I was all along. He just let things slide.

Ushers and candy girls came and went over time. When I was sixteen, Mr. Ray called me and one of the candy girls into the office one evening. He told us in his abrupt way that he had caught both ushers and candy girls stealing from the theater and had fired them. Theresa, the candy girl and I just stared at each other. Mr. Ray then added, "You two were not involved, I discovered," and pointing to each of us added, "You are now head candy girl, and you are now head usher. Go out and hire new crews to work for you, go-go, I'm busy." With that, I became the head usher, a position I would maintain through high school, college and beyond.

I hired a new crew of ushers including a fellow English High student named Henry Giggi. I have lost touch with him over the years, but we were pals back then, and when I made out the schedule. I made sure we worked


the same shifts. Some of the young men I hired didn't last long. Mr. Ray either liked you or took an immediate dislike to you. I never asked him his rationale for those reactions, but for those he didn't like, he would find an excuse to get rid of them and make me do the dirty work of letting them


A few years ago, I received a phone call from a woman who identified herself as a replacement ticket seller. I remembered her and we had a conversation that almost had me in tears. She told me that she and Mr. Ray had become romantically involved. He was an older bachelor whom I looked up to. I saw the refinement in his manner and copied his method of dress, suit, shirt, tie ... fashionable, never flashy, but always dignified. The woman added that I was the son Mr. Ray never had. He presented me with gifts when I graduated from high school and college, but I thought this was something he did with all his employees. She added that he was as proud of me as was my father when I began my college career and just as proud when I graduated. I did reach a point in my young life when something had to go, and I quit working at the Seville ten years after I had started. My time spent in an usher's uniform was some of the most memorable in my life and I will never forget them.



E' proprio necessario che ogni eletto al Parlamento, o ad altre cariche importanti, deve servirsi anche di voli gratuity? Perche' poi un membro del Parlamento deve godere di servizi, scandalosamente rifotti nei costi dei ristoranti della Camera e del Senato? Tanto per dare un esempio, ecco i costi annui delle auto blue. DID YOU KNOW THAT ...?

As we have reported in the past the economic crisis in Italy has affected most of the working class, but none of the members of the Government or the Parliament. As a matter of fact, the race to the privileges has continued undaunted pushing the cost of management, of the Government and of the Parliament, sky high. A Bill has been introduced, God knows if it will be approved, to reduce the salary of the members of both the Parliament and of the Government, as well as some of the privileges. Among these is the use of the "blue car," the life pension, and the full refund to the political parties for "election expenses"! As of now, nobody knows how the cuts will be made, which of the privileges will somehow be reduced, or abolished. The pension the Parliamentarians receive after serving "three years" in the Parliament, if abolished it would save the State hundreds of millions of euro a year. Is it necessary, also, that anyone elected to the parliament, or to other important offices, be entitled to free flights? Why, also, a parliamentarian should enjoy the restaurants' services in the House and the Senate paying scandalously reduced prices? To give an example, here are the annual costs of the cars. Its overall total — as used by Government officials also at the regional level, and by the parliamentarians, is about 90,000. Each of these cars costs annually nearly 13,000 euro, with a minimum cost of 85,000. The total cost of all the cars is about 2.5 billion euro. Furthermore, there is an annual expense for additional 75,000 vehicles used for security and controls, for a total of another 1.2 billion euro.

What is indicated above occurs while the people suffer in a precarious economic situation. Dishonesty Italian style.

Disgraced ex-Mets outfielder Lenny Dykstra was recently sentenced to three years in a California state prison after pleading no contest to grand theft auto and providing a false financial statement. L.A. County Superior Court Judge Cynthia Ulfig sentenced Dykstra after refusing to allow him to withdraw his plea. Said the judge, "He obviously didn't have, the money to get the vehicles ... His conduct was indeed criminal." Dykstra, 49, has had a series of recent legal troubles in his sad downward spiral since ending his baseball career. Prior to this bad news, he had completed a stint at a sober living facility.

Red Sox Connection to Colt

This year the Houston Astros celebrate their 50th anniversary this season, but they started off as the Houston Colt 45s. Pistol Pete was one of those players who deserved better than he got. He always gave his best and just came to the ballpark every game to play as best he could. He always got an "A" for effort. Peter was a quiet guv who hustled in the field on every play and also a great singles hitter too. Mr. Clutch, he was.

Meanwhile, Roman Mejias faded into the sunset and nobody cared that he rode out of Fenway so quickly and quietly too.

THE CAPTAIN IS HON-ORED — Watching the ceremony honoring Bruins captain Zdeno Chara for passing an impressive milestone by playing in his 1,000th game, one has to pause and take stock at what an achievement that really

All those years. All those possibilities of really getting hurt. Hockey is such a physical sport and somehow Chara has come through the fire in essentially one piece. It was very meaningful that among those he paid tribute to when he took the microphone were the trainers and doctors that comprise the medical staff of the Bruins.

For make no mistake about it. Chara is an iron man. He has only missed two games this season and has missed just 14 games in the five plus seasons he has been with the Bruins.

When you first encounter Chara in the Bruins dressing room you might think he chose the wrong sport. Given the fact that he is 6-9, you might think he should be down a couple of doors in the Celtics locker room. But no, he is here, among people of more or less average size, a leader that surely stands out, not only because of his height but because of his

He sits in a corner answering all questions. And because he is The Captain he is caller upon just about every night to do so. Sometimes his contributions are visible as they were the night he was honored as he posted three assists in contributing to a 5-2 victory over Tampa Bay. At other times it might be more subtle, his presence in the locker room, for example, a presence he surely has.

"We really count on him," said B's forward Brad Marchand. "He plays 25-30 minutes a night and he's a leader off the ice. We definitely would not have won it (the Stanley Cup) last year if it wasn't for him. Having a guy like him makes it a lot easier going into the playoffs. He showed why he's such a big asset to our team with those three assists. He just plays all areas of the rink. He seems to know the right time to jump in and create an opportunity."

One of the aspects of Chara's game that is truly amazing is his blazing shot. When he lets it go, you don't want to be in the way. You see, he's won the hardest shot competition three times at the All Star Game. This year, he served as captain of one of the teams and was a plus 7 in the contest. He also broke his record in the hardest shot contest — which takes place the night before the game. The recorded speed of his shot — 108.8 miles per hour. Although that shot was into an empty net one wonders how much an opposing goalie would feel,

regardless of how much padding he was wearing.

And by the way that high plus/minus figure at the All-Star game in no fluke. He's had the NHL's best plus/ minus over the last two seasons. It is a very impressive plus 60. In fact, the night he was honored this defenseman was continuing on somewhat of an offensive roll. Those three assists gave him 4-12-16 total for the last 18 games, a very impressive showing for someone expected to contribute to the defensive side of the ledger. Including the Tampa Bay contest, Chara had scored goals in three of his last five games.

"He's the toughest guy to play against in the league, no question," said the recently acquired Brian Rolston who has spent a number of evenings over the years attempting to cope with the Bruins captain. "If you were to poll the forwards on every team they would say the same thing. Coming in on a nightly basis knowing that you have to face him — it's a tough task."

Chara actually played his 1,000th league game on the road on March 24 in Los Angeles, becoming the 277th player overall and the 91st defenseman to reach that level of durability.

And what does The Captain say. "Well, it's very nice to get that recognition and ceremony," said Chara after the game. "It's very nice to be recognized by the NHL, the Bruins organization, my teammates and everybody that supported me. But when the ceremony is over you have to focus on the game. You've got to be ready because you've got to play. There's no other way to describe it, just be ready and play hard the whole game."
