Turco Wins Democrat Primary To Replace DeLeo

Candidate Jeff Turco, a self-proclaimed "Reagan Democrat" won a four-way Democrat primary on Tuesday, November 2nd. Former Speaker Robert DeLeo recently retired to take a job at Northeastern University,

which opened up his Winthrop-Revere House seat after more than 30 years.

Juan Jaramillo came in second followed by Alicia DelVento, a former State House aide who finished third, and Winthrop School Committee member Valentino Capogreco came in fourth place.

Progressives in this House District reacting to Turco's win have immediately called for the concept of ranked-voting, which was just shot down in the 2020 general election. To them, Turco won because the three so-called liberals or progressives split the vote and handed the more moderate, conservative Democrat the election victory.

Turco will now face Republican Paul Caruccio and Independent Richard Fucillio, Jr., in the March 30th general election.

City of Boston COVID-19 Update

The Mayor said that the City's case metrics leveled off and even ticked upward in the last few days of data. He added that this is not a cause for concern, but it's a good reminder not to take this positive trend for granted.

He urged everyone to remain vigilant and take all necessary precautions to protect themselves and our communities against the virus. That includes wearing a mask with a good fit (whether you wear one mask or two masks, make sure there is a tight fit on the sides of your face); washing your hands frequently, with soap and warm water; continuing to socially distance and avoid gatherings; and getting tested regularly.

Update on COVID-19 testing:

There are currently more than **25** testing sites in the City of Boston. The City continues to support mobile testing sites that are free and open to all, regardless of symptoms.

Mayor announced that mobile sites will continue operations through at least the month of March. They are:

- In Jamaica Plain, at the Anna Cole Community Center in the Mildred Hailey Apartments.
- In Hyde Park, at Boston Renaissance Charter School.
- In **Dorchester**, at the **Strand Theatre**; and **Prince Hall Grand Lodge**.

For information about how to access these sites and others, visit: **Boston.gov** or call **3-1-1**. **Update on vaccine rollout:**

The City continues to work with the State on the **vaccine rollout.**

Right now, adults 65 and older, and adults with two underlying health conditions, are eligible to get the vaccine, as well as everyone eligible in Phase 1.

In Boston, we currently have 17 vaccination sites that are open to all eligible residents. Those include:

- 7 community-based sites: in Hyde Park, East Boston, the South End, Dorchester, Mattapan, Roslindale, and South Boston.
- 8 pharmacies: in neighborhoods including East Boston, Roxbury, Mattapan, and Dorchester.
- And 2 mass vaccination sites: the Reggie Lewis Center in Roxbury and Fenway Park.

The City is focused on providing equitable access to vaccines, especially at the Reggie Lewis Center. Over the weekend, the City held a Black History Month event at the site, to promote vaccine access and health equity. The Mayor thanked the community organizations including the Black Boston COVID-19 Coalition which sponsored the event. He also thanked the City of Boston Black Employee Network for distributing COVID care kits.

This weekend alone, 1,600 people were vaccinated at the Reggie Lewis. Moving forward, the City of Boston will continue to hold 50% of the slots for eligible people of color, working through community health centers and city agencies.

In Boston, over 100 senior affordable housing buildings will be vaccinating residents and staff on-site, and some have already begun. That includes the Boston Housing Authority, which is hosting clinics for residents of public housing who are elderly and disabled. Over the weekend, BHA clinics were held at: Ausonia Apartments in the North End; St. Botolph Apartments in Back Bay/South End; and Monsignor Powers Apartments in South Boston.

This Friday, the City is launching a mobile vaccination pilot clinic at Martin Luther King Towers in Roxbury, and more clinics will be offered at additional developments next week.

The Mayor encouraged seniors and everyone who is eligible to receive the vaccine to get it as soon as they can, sharing the following resources:

- Boston residents 65 and older can call **3-1-1** and get connected to the City's Age Strong Commission for help in multiple languages.
- Veterans 55 or older, enrolled in VA Healthcare, can get vaccinated at any VA health facility in Boston.
- The full schedule for vaccine eligibility is at: *Mass.gov/CovidVaccine*.
- The State has a Vaccine Scheduling Resource available by calling **2-1-1**.

Update on reopening:

The Governor announced last week that the State is moving forward in Reopening: Starting with Phase 3, Step 2; and starting on March 22nd with Phase 4, Step 1.

The Mayor said that in Boston, $\,$

we are also moving forward, but we have some important exceptions to the changes going into effect today. This is consistent with the City's cautious approach throughout the crisis.

In the City of Boston, starting March 1st:

- We **are** moving up to 50% maximum capacity at many indoor businesses including gyms, museums, offices, movie theaters, hotels, and stores. We are moving forward to allow the use of fitting rooms in retail stores.
- We **are** lifting the capacity limit at restaurants; while requiring 6 feet of space between tables, six people maximum per table and 90-minute limits on seating.
- But we are **not** moving forward with live music in restaurants until at least March 22nd.
- We are **not** opening indoor performance venues like concert halls and theaters until at least March 22nd.
- And we are **not** opening higher-contact indoor recreation like roller skating, laser tag, or trampolines until at least March 22nd.
- On those steps, as well as Phase 4, the City of Boston will move forward on March 22nd, if our case data and public health guidance supports it.

The Mayor emphasized that the City of Boston is committed to economic recovery. And at the same time, keeping people safe and continuing to slow the spread must be our first priority. He said that economic recovery *depends* on our public health progress.

The City of Boston's Reopen Boston Fund is still taking applications from businesses with 25 employees or fewer.

St. Patrick's Day warning:

The Mayor said that Boston's annual St. Patrick's Day Parade is cancelled again because of the public health crisis, and he said he is grateful to everyone involved for their cooperation.

He also made it clear that there should be no large gatherings of any kind. Private gatherings remain limited to 10 people indoors and 25 people outside; and there will be no exceptions to the rules on restaurants, bars, and private gatherings.

Last week the Mayor and his team held a meeting with businesses that are traditionally busy on St. Patrick's Day. They

Where Was Biden, Aka Waldo?

The state of Texas recently experienced a historic ice storm and sub-zero temperatures. People were suffering down there and some have died when the state's power grid went down. Recently, San Antonio experienced a day when it was 3 degrees, minus 10 with the chill factor.

According to a White House press release, President Joseph R. Biden, Jr. declared that an emergency exists in the State of Texas and ordered federal assistance to supplement state and local response efforts due to the emergency conditions resulting from a severe winter storm beginning on February 11, 2021, and continuing.

The President's action authorizes the Department of Homeland Security, Federal Emergency Management Agency (FEMA), to coordinate all disaster relief efforts which have the purpose of alleviating the hardship and suffering caused by the emergency on the local population, and to provide appropriate assistance for required emergency measures, authorized under Title V of the Stafford Act, to save lives and to protect property and public health and safety, and to lessen or avert the threat of a catastrophe in all 254 Texas counties.

Specifically, FEMA is authorized to identify, mobilize, and provide at its discretion, equipment and resources necessary to alleviate the impacts of the emergency. Emergency protective measures for mass care and sheltering and direct federal assistance will be provided at 75 percent federal funding.

Biden finally made it down Houston on February 26th where he was met by Gov. Gregg Abbott at the airport and he escorted Biden around showing him various spots like a food pantry among other things.



Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



FLAMEN

During the past weeks, we have been examining some of the ancient customs and beliefs and have noted many striking similarities with Christian procedures and doctrines. We discussed ancient books, manuscripts, the early Egyptian and Greek attitudes toward cosmic gods, the nether worlds, the origin of the basilica, cathedral and the eternal flame. Before we leave the worship of Vesta and the sacred fire, it might be of interest to examine "flama," the Latin word for flame. Flama translates to fire, blaze, or torch. "Flamare" means to set fire, to inflame, or to burn.

During ancient times, the term "flamen" was used to describe "one who kindles the sacrificial fire." The term was also used to identify a special kind of priest in the worship of a special Roman deity. We must bear in mind that this kind of worship occurred in pagan Rome many years before Christianity was practiced. There were fifteen "flamines" (male priests), of which three were high priests and were known as "flamines majores." One high priest was called the "flamen Dialis" or the high priest of Jupiter, their chief Roman god. The second high priest was called "flamen Martialis" or the high priest of Mars, the god of war and father of Romulus and Remus. The third high priest was called "flamen Quirinus," the Savine equivalent of Mars, who was worshipped as the founder of the old Roman capital.

The remaining twelve were known as "flamines minores" or priests who were identified with less important deities like Vulcanus, the god of fire, Flora, the goddess of flowers, Pomona, the goddess of the fruit of trees, and Carmenta, the ancient goddess of prophecy, who protected women in childbirth, to name a few. All of the priests held their office for life and could not be removed except under extraordinary circumstances.

The emblem of their office was a white cone-shaped hat, which was made from the hide of an animal that had previously been sacrificed. The hat also had an olive branch and a woolen thread at the top (a symbol of good health). The flamen were required to wear the hat at all times when they were out of doors. They were exempt from all civic duties and excluded from participating in politics.

The flamen Dialis was superior to all priests, but he was not permitted to spend a night away from home. He was granted a seat in the Senate, the services of a constant attendant, and his family, along with their houses, were all dedicated to Jupiter. He lived in dissoluble marriage, and if his wife died, he resigned his office. For him, every day was a holy day, and he never appeared in public without the insignia of his office. These insignia included his conical hat, a woolen toga that was woven by his wife, a sacrificial knife, and a rod to keep the people away.

When a flamen walked through the city, he was preceded by heralds who directed people to stop their work, as a flamen was not permitted to look upon any labor, or upon any person under arms, or in chains. He was not allowed to touch a horse, corpses, grave, a goat, dog, raw meat, or anything considered to be unclean. His garments were required to be free from knots, but clasps were permitted. If he was ever found guilty of any carelessness in his sacrifices, or if his hat fell from his head, he was forced to resign. His wife was bound by similar rules of conduct and dress, except that her head was covered by a kerchief, and on certain days, she was forbidden to comb her hair.

made it clear to businesses that spacing requirements and time limits will still be in place over St. Patrick's Day weekend. There should be no alcohol without food service. And the City won't allow lines outside restaurants. Enforcement will continue to be in place.

Return of outdoor dining:

The Mayor said that one of the bright spots during the COVID-19 pandemic is how the City and businesses got creative to expand outdoor dining last summer and fall. It brought much-needed vitality back to our streets and small businesses.

Outdoor dining on public property ended in December, and the City is bringing it back for 2021, starting on April 1st, or as soon as the weather permits it

mits it. The City is once again waiving fees, to remove that barrier to apply for the program. We have a centralized online application, so both businesses and residents can follow the process. We have technical support available. And we're doing targeted outreach for under-represented businesses and communities. The City will once again be restricting parking and closing certain streets, to open up dining space. The City will share more details on specific streets in the coming weeks. The Disabilities Commission plays an important role in the review process, and is again working with restaurants to distribute mobility ramps.

The Mayor said that this program was made stronger by community input, so we welcome continued conversation.

The online application has been live since December 10, and the City has already received over 370 applications, with more than 150 approved. Applications moving forward will be reviewed on a rolling basis. You can learn more, or submit an application, at: Boston.gov/2021OutdoorDining

Update on reopening the Boston Public Schools:

On Monday the Boston Public Schools welcomed all students from pre-kindergarten through 3rd grade back to in-person classrooms, if their families opted in. They join the high priority students who have been in school since the fall.

The Mayor said that the City

will continue to bring students safely back into schools, as long as public health data supports it. Grades 4-8 will be eligible for in-person learning on March 15th. And all remaining students will be eligible on March 29th.

The Mayor visited the Martin Luther King K-8 School in Dorchester this morning, to welcome young students back to the building. He said:

"This is the most important thing happening in our city right now. Most students have been out of physical classrooms since March 17th of last year. I want to thank parents, guardians, teachers, school leaders, custodians and food service workers for the tremendous work they have done to keep our students learning. I want to thank bus drivers and transportation staff, for their strong ontime performance this morning. And I want to thank everyone who has worked to prepare our classrooms to the highest safety standards anywhere."

The Mayor said that in addition to all the work on spacing and air quality, we are moving forward with pooled COVID testing for students whose families consent. He stated that this is a good system for preventing the spread of the virus, and as we move forward, we will take every opportunity we can to keep our school communities safe.

Women's History Month:

The Mayor closed with this reflection about Women's History Month.

"In Boston, we believe in empowering women and protecting their rights. That's been a hallmark of my administration and something we're proud of. This month is an opportunity to celebrate everything that women do for our city, especially during this difficult last year. Women in city government and throughout our communities have led many of our most important responses, from healthcare, to food access, to housing support, to education. I want to take a moment to thank them. Women have also taken on a huge burden in the home, reminding us that we have a lot of work to do to achieve a fair economy. We have a range of events planned for Women's History Month, through our Office of Women's Advancement and Executive Director Alex Valdez. You can learn more at Boston.gov/women."

Election Reform Now

Dear Editor:

If we have learned anything from the 2020 elections, it is that too many states have sloppy procedures that might allow fraud. The states must reform those procedures before the next election

The first priority should be to stop the indiscriminate mailing out of ballots. A ballot should only be sent if it is requested by a registered voter, and the system should require that the voter provide reasonable identification. Virginia has a good system. Voters must give their Social Security number, driver's license number, and sign the application in the presence of a witness. That makes fraud much more difficult.

Now that the recent study by Alan Abramowitz has demonstrated that mail out ballots did not increase Joe Biden's share of the vote, even Democrats should be willing to accept tighter security.

Furthermore, ballots should be counted only if they arrive by election day. It may be necessary to allow a few exceptions, such as for the military, but ballots that arrive days or even weeks later should not be included in the count.

In addition, states must use voting systems with paper ballots that can be counted by hand to verify the machine scanning count. This was essential to proving that the Georgia and Michigan counts were valid, yet a few states still lack this fundamental safeguard.

Finally, the states must devise procedures that allow observers for each party to clearly see what is being done in the vote count. This might involve a combination of onsite observers for a general view of what is happening, plus cameras to provide a close-up of the handling of each ballot (and this should be recorded in case of dispute).


East Boston Central Catholic School Carson Scholarship Award

L'Anno Bello: A Year in Italian Folklore Sensing Spring through Herbs

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



Spring has blossomed before us, green and cool as bright sprig of spearmint. The longer days fill the early evening hours with resplendent golden sunrays. Robins are now a regular sight, scampering among bushes or taking off in flight from the treetops, their red feathers flashing the joy of spring. Buds become more pronounced, seemingly smiling with anticipation at the secret leaves concealed within. The first crocuses and daffodils wave gaily in the brisk breeze. Spring places me in the mindset of regrowth and renewal, inspired by the nature that blooms and flourishes all around me. In particular, I think of the gardens that are now beginning to take form, the first tender crops sprouting from the damp, dark soil. My father, like many Italians, loved to garden and took great pride in reaping the gifts that the Earth provided. He did not bequeath me a green thumb, but he did instill in me an appreciation for all that grows and all that originates from the natural world. In the springtime, early garden plants often take the form of delicate herbs. I love cooking with herbs, as their pungent aroma wafts through my kitchen and their sharp taste provides a kick to recipe. However, I discovered that herbs all come with their own unique folklore and superstitions. In honor of the spring and the rebirth of vegetation, let us dive into the traditional lore of some of our favorite herbs.

• Basil: Basil, or basilico, is ne of the best-known herbs of

typically made with crushed pesto, pine nuts and olive oil. In Italy, basil further symbolizes loves, and in olden days a girl looking for a romantic partner announced her intentions by placing a pot of basil on her windowsill! However, this fragrant herb also holds a sinister side. People in the Middle Ages thought it gave birth to scorpions. Some scholars speculate that the word "basil" shares the same root as "basilisk," a spooky legendary creature that had the body of a snake and the head of a rooster and could kill its prey with just a glance!

- Lavender: I always thought of lavender as a pretty flower that blossomed in spring and summer, but it is actually used as a culinary herb as well! Honey made from bees that sip on lavender nectar is prized in the Mediterranean world. Lavender also forms the basis of many herbal teas. People use dried lavender buds to flavor breads, scones and chocolate, while candied lavender flowers make sweet cake decorations. In Italy, lavender is called lavandula. It was so prized in ancient Rome that it cost as much as a farmer's monthly wages! Its name derives from the Latin word lavare, or wash, because it lavender was used to perfume laundry and baths.
- Parsley: Parsley is known as prezzemolo in Italian. This beloved herb adds color and flavor to Italian pastas, stews and casseroles. It frequently appears as a garnish, a custom which has roots in supersti-Italian cooking. It forms the crux tion. Ancient cooks believed of pesto, that delectable sauce that parsley was an antidote hailing from the region of Genoa, to poison, and though we now

know that is false, the credence lives on in the form of decorative parsley! In ancient Rome, on the other hand, parsley was often planted on graves. This custom inspired a bevy of sinister parsley lore, such as the superstitions stating that only evil people can grow parsley well, or that giving away or replanting parsley serves as an omen of death.

- Rosemary: When I think of rosemary, I think of my mother flavoring chicken or fish with this woodsy, piney herb. It is also delicious baked into biscuits and breads like focaccia. As William Shakespeare noted in Hamlet, rosemary symbolizes remembrance. It was once scattered atop caskets to ensure that funeral mourners would always remember the dead. The herb known as rosmarino in Italian also formed part of medieval brides' wedding bouquets, and as such became a token of love. Folklore also attributes rosemary with the power to repel the evil eye and frighten away malicious spirits.
- Sage: I am in love with the classic Italian combination of savory pumpkin and sage, or salvia. You might say that whoever thought of this delectable flavor profile was wise indeed, and you would be right! The herb sage is associated with wisdom, which is why we call intelligent people sages. Supposedly, bringing a pot of flowering sage indoors invites bad luck, so people would make sure to pick sage before it bloomed. A girl who picks sage on St. Mark's Day (April 25th) or Midsummer (June 24th) will dream of her future spouse, while eating sage in May promoted longevity.
- Thyme: Thyme, or timo in Italian, is a popular herb with which to season soups, stews and pastas. It also tastes wonderful mixed with lemon. This little herb carried a load of significance in the ancient world. The ancient Greeks burned thyme in their temples, believing that its aroma would imbue people with courage. In ancient Rome, it was used to purify rooms. By the Middle Ages, thyme had become synonymous with preventing nightmares and, when given as a gift, inspiring courage in knights. Like many other herbs, thyme was associated with the supernatural and as such was strewn onto coffins to assure a safe passage to the otherworld.

And there you have it — six well-known herbs and their associated folklore. I hope that the traditions and customs attached to these herbs will inspire you to use them in your cooking and, furthermore, to learn about the way people in times past related to the gifts produced by the Earth. After all, spring is about honoring the rebirth of nature, and delicious herbed goods provide us with a delectable way to do so!





Rummaging in the bowels of my Dad's cellar I discovered a huge cache of remembrances from my childhood and before. Up on one shelf was yet another box filled with just plain junk on top of what I considered a treasure — my Mom's appointment book from Nana's shop in the year 1950.

Calendars from just 20 and 30 years ago lay on top. But 1950: why did she save that book in particular? More on that question later.

Each column for 1950 ... January through December detailed each client — customers at the time — a name, always with a proper Miss or Mrs. in front.

The services ranged from perms, finger waves, tints, hair cuts to polish on the nails and manicures. There were "cholesterol treatments" that were a popular conditioning service. Placed under a hot dryer with a plastic cap for a half hour or so, would leave hair silky smooth and cure split ends. The cost for a shampoo and wave in 1950 was 75 cents. Similarly priced were the other services.

She also sold a variety of hair pieces, decorative hair combs, jewelry and creams. The glass cabinet to the left of photo was where the goods were on display. There were no answering machines then, so Mom relied on being there to answer the phone, take appointments, and

service the walk-ins. Imagine no answering machine!

Some days were slow, with just one customer. And then some were just packed in and she barely stopped all day, working as late as ten o'clock, then off to the bus for home in South Lawrence.

Among the names she would mention over her next 51 years on earth, many were there in that book. I saw there listed the mothers and aunts of dear friends. One gal tells me how she accompanied her mother to my Mom's shop and would press her face into the window to see just how much longer Mom would be.

Ah, if the book could only talk, what tales it would tell.

Oh and the romance in the Beauty Shop was I'm sure why Mom saved this Appointment Book. It was the time she met my Dad. Lo and behold, there were scribblings of my Dad's writing (her future husband) and his doodled name! All the days he visited and helped her out taking appointments. How exciting this book really was to me! And a year's appointments for her future sisterin-law, Aunt Ann DiZazzo (my Mom finally spelled it correctly three-quarters through the year.) And, of course, her future mother-in-law, my Nana Mrs. Mary DiZazzo!

Designing a Wildlife-Friendly Landscape

We love watching the bunnies hopping across the lawn or ground squirrels scurrying away with a cheek full of seeds. That is, until they dine on our favorite shrub or take just one bite out of each red ripe tomato in the garden. Finding a way to coexist is critical for wildlife struggling to survive and our enjoyment of nature and our landscapes.

As gardeners, we know that digging in the soil and tending a garden is good for our mind, body, and spirit. Researchers discovered the same is true when we take time to observe wildlife. Our need for a relationship with nature is also important to our wellbeing. It helps us feel more content and function more effectively.

But we love our gardens too. Implementing some design and management strategies can help us support and enjoy wildlife, care for our landscapes, and improve our quality of life.

By reducing the amount of edge habitat, where one type of habitat meets another, can allow us to support wildlife while reducing the risk of damage. Create circular or square garden beds that have more interior space and less border space. Long linear beds with more edges and less interior

space allows easier access for animals to dine.

Work with neighbors and your community to create large blocks and corridors of habitat. Providing them spaces, other than your gardens, with needed food and shelter can help you and the wildlife to coexist.

Protect key gardens and plants. Fencing is an option. Make sure your fence is high enough, tight to the ground, and the gates secure.

Repellents are a less obtrusive option. Select a product labeled for the animals and rodents you are trying to manage. For best results, apply repellents before the animals start feeding. Then reapply as recommended on the label. Look for one, like organic, bird — and pollinator-friendly *Plantskydd* (plantskydd.com), that is rain and snow resistant, requiring fewer repeat applications.

Work with nature to maintain a balance in your landscape. Invite hawks, owls, and fox to your backyard. Grow tall grasses and plants that provide cover for foxes. Include trees with good perches or install perch poles to attract and support raptors.

interior space and less border space. Long linear beds with more edges and less interior Make a sketch of your existing

landscape. Identify existing plants and wildlife-friendly habitats. Make note of both the natural habitats and any supplemental food, water, and shelter you provide. Review and note various features in your landscape throughout the year.

Now decide what you want to accomplish in your landscape. What wildlife do you want to attract and have the space to support? Perhaps you want to attract more songbirds to your gardens or animals, like toads, that help manage pests in the garden.

Make sure your landscape provides the habitat features needed to attract and sustain these welcome residents. You will find lots of helpful resources on National Wildlife Federation, Audubon, Natural Resources Conservation Services, Department of Natural Resources, and University Extension websites.

Be patient and wait for a year to evaluate the results of your efforts. Then begin making any needed changes to meet your goals.

Developing a landscape for you to enjoy and one that supports wildlife takes time, but as a gardener this is not only part of the process but an exciting adventure.

Saint Josemaria Escriva

Josemaria Escriva de Balaguer was born in Barbastro, Spain, on January 9, 1902, the second of six children of Jose and Dolores Escriva. His father was a merchant and a partner in a textile company that eventually went bankrupt. The family relocated in 1915 to the city of Logroño, where the father worked as a clerk in a clothing store.

Beginning in 1918, Josemaria sensed that God was asking something of him, although he didn't know exactly what it was. With his father's blessing, Escrivá prepared to become a priest. He was ordained a priest on March 28, 1925.

In 1927, Fr. Josemaria moved to Madrid to study for a graduate degree in law. He was accompanied by his mother, sister, and brother, as his father had died in 1924 and he was now head of the family.

On October 2, 1928, while making a retreat in Madrid, God showed him his specific mission: he was to found Opus Dei, an institution within the Catholic Church dedicated to helping people in all walks of life to follow Christ, to seek holiness in their daily life and grow in love for God and their fellow men and women. In 1930, he started Opus Dei's apostolic work for women.

The Priestly Society of the Holy Cross was founded by Escrivia in 1943, which made it possible for some of Opus Dei's lay faithful to be ordained as priests. The full incorporation of both lay faithful and priests in Opus Dei, which makes a seamless cooperation in the apostolic work possible, is an essential feature of the foundational charism of Opus Dei.

Aware that God meant Opus Dei to be part of the mission of the universal Church, the founder moved to Rome in 1946



so as to be close to the Holy See. By 1950 the Work had received pontifical approvals affirming its main foundational features.


In 1948 Escrivá founded the Collegium Romanum Sanctae Crucis (Roman College of the Holy Cross), Opus Dei's educational center for men, in Rome. In 1953, he founded the Collegium Romanum Sanctae Marie (Roman College of Saint Mary) to serve the women's section (these institutions are now joined into the Pontifical University of the Holy Cross.) Escrivá also established the University of Navarre, in Pamplona, and the University of Piura (in Peru), as secular institutions affiliated with Opus Dei.

During Vatican Council II (1962-1965), Monsignor Escriva worked closely with many of the council fathers, discussing key Council themes such as the universal call to holiness and the importance of laypersons in the mission of the Church.

Escrivia passed away on June 26, 1975, at the age of 73. He was canonized by Pope John Paul II on October 6, 2002. The Feast Day of Saint Josemaria Escriva is celebrated on June 26th.

As of 2018, there were 95,318 members of Opue Dei.







THE BAND - STAGE FRIGHT (Vinyl + 2CD) UMe/Capitol

In the spring of 1971, The Band set off to Europe where they hadn't played since their tumultuous tour with Bob Dylan in 1966, where they were booed every night as the folk rock purists felt betrayed by Dylan who had gone electric, backed by his band The Hawks, who would soon after become known as The Band. Not having played there in five years, The Band — Garth Hudson (keyboards, piano, horn), Levon Helm (drums, vocals, mandolin), Richard Manuel (keyboards, vocals, drums), Rick Danko (bass, vocals, fiddle) and Robbie Robertson (guitar, piano, vocals) — didn't know what to expect, but instead of boos they received a rapturous response at their first concert in Hamburg, Germany and would go on to play for one enthusiastic crowd after another.

Released in both black vinyl, and limited edition, color vinyl version, plus a double-CD version containing 19 tracks of Stage Fright, and Live At The Royal Albert Hall, 1971, an exhilarating 20-song set that captures The Band firing on all cylinders, and delivering thrilling performances of songs from their then-recently released Stage Fright record — alongside their most popular tracks from 'Music From Big Pink' and the self-titled sophomore "Brown Album" such as "The Weight," "King Harvest (Has Surely Come)," "Up On Cripple Creek," "The Night They Drove Old Dixie Down," "Across The Great Divide," "Chest Fever," and inspired covers of Dylan's "I Shall Be Released" and the Stevie Wonder-penned, Four Tops hit, "Loving You Is Sweeter Than Ever."

In addition to Live at the Royal Albert Hall, June 1971, the double-CD features a bevy of unreleased recordings, including alternate versions of "Strawberry Wine" and "Sleeping;" and seven unearthed field recordings, Calgary Hotel Recordings, 1970, features an impromptu late night hotel jam session between Robertson, Danko and Manuel, of several Stage Fright songs recorded while the album was in the mixing stage plus a host of covers.

Whereas the electrifying Live at the Royal Albert Hall concert showcases The Band playing as good as they ever did, The Calgary Hotel Recordings, 1970 offer a glimpse into a different kind of performance, the kind of fun, spur-of-the-moment jam sessions that were bound to happen whenever the guys were together in a hotel room or backstage on tour. Coming off the heels of the band's monumental debut and sophomore records, Stage Fright cemented The Band as one of the most exciting and important musical acts of the '60s and '70s. Fifty years on, lifelong fans and those just discovering The Band can experience the album in a whole new way, sounding better than ever, or for the first

Nanna & Babbononno

A Nostalgic Remembrance



Babbononno used to talk about the unification of Italy, which took place on March 17, 1861. He would not arrive on Earth for another 14 years, but from the way he spoke about one of the great liberators, Giuseppe Garibaldi, you would think he fought with him, side by side. In case March 17th sounds familiar, it is that we Bostonians celebrate Evacuation Day on that date, the day the British fleet sailed out of Boston Harbor during the Revolution, and we celebrate St. Patrick's Day, too. With all of the Irish in and around Boston, and with our local history taking precedent, Italian unification seems to have taken a back seat.

My friend and colleague, Colonel John Silva, gave me a British magazine a while back, with an article about Garibaldi which details his directions in life. Babbononno used to call him the liberator, but not much was ever included in European history text books that we read here in the States, just short passages on Italian unification followed by German unification. Back in 2011, John and I wrote a scholarly work for a couple of colleges on Italian unification, as it was the 150th anniversary that year. In brief, Garibaldi helped free parts of South America from Spanish domination. Southern Brazil, Uruguay and Argentina became independent thanks to Garibaldi.

At about the time our Civil War broke out, Garibaldi and his wife were living with Antonio Meucci in New York. Babbononno used to mention him as the man who invented the telephone, and I used to correct him saying that it was Alexander Graham Bell, not a guy named Meucci. In 2006, the U.S. government would finally give Antonio Meucci the credit he deserved, so I guess Babbononno was right all along.

While Garibaldi was in New York, he was contacted by President Lincoln, who was aware of the man's charisma and military capabilities. In 1861, the north wasn't doing that well fighting the south and the president continuously changed military leaders. He knew how Garibaldi fought the Spanish with his rag-tag armies and his pregnant Brazilian wife on horseback, by his side. Lincoln offered him the position of a two star general (major general) hoping that Garibaldi's involvement might change things. Garibaldi refused stating that he would accept only if he became general of all the American forces and if Lincoln immediately freed

the slaves. Lincoln refused and Garibaldi eventually returned to Italy and became one of the three liberators that unified the land of our ancestors. Lincoln didn't free the slaves until 1863.

According to Babbononno, Antonio Meucci was the inventor of the telephone. Of course, I ignored this as a child. We were taught in school that Bell invented the telephone in the 1875. Meucci had several problems. He was Italian at a point in time when Italians were new to America and not well liked. His English skills were very poor at best and he didn't have money enough to patent and market his invention. When he became ill and needed medicine, his wife sold his equipment and invention to purchase

What medicine he needed and Bell, who had at one point worked with Meucci, bought everything from a second hand store and took the credit for the invention. As I mentioned above, it wasn't until 2006 that Meucci was given credit as the inventor of the telephone. So, after that, I would tell my world history students, "Antonio Meucci invented the telephone and Alexander Graham Bell invented the busy signal!"

Babbononno liked history. At night, when I was a kid, he would tell Mom, Nanna and me about things that happened in American history that sounded fascinating, and they were, coming from a great story teller. I now can only imagine that he did the same thing with my uncles a generation earlier. There were drawbacks to Italian advancement in America due to several things according to Babbononno. He claimed that after Italian unification, southern Italians were still as disenfranchised as they had been when the Italian states were controlled by Spain, France or Austria. After the unification, those who took over were mostly northerners and allied themselves with the local southern clergy. They emphasized education, and to counter this, the locals emphasized the trades. If a man came home with a sore back or calloused hands, he had proven himself. The same emphasis followed Italian immigrants to America after 1880, and as a result, some of the greatest craftsmen and tradesmen made their marks on America. They brought their children (the boys) up to believe that this was the way to go, and combined with the Italian American uncanny abilities for organization, saw their sons become captains of industry, especially in the trades. It

wasn't until my generation came along that education came into play as part of the equation.

To prove this point, a while ago, I sent some information to Dean Saluti. As you may know, he is the president of the Renaissance Lodge of the Sons of Italy in Massachusetts. What you may not know, he is the head of the Culture Commission for the Sons and that info I sent him listed all of the famous Italian Americans whom I have researched, mainly through Wikipedia, the online encyclopedia. We've come a long, long way in the past generation or two, and that includes in industry, politics, law, medicine, education, the sciences, the arts, sports and entertainment. Our people have done it all, and if Babbononno was alive today, he would be just as proud as I am as to their accomplishments and the fact that their names end in vowels.

I remember a conversation with Dad and my uncles, Nick and Paul, and a few of their fellow musicians back when I was a young man. All of them had Anglicized their names so that they sounded more American. Dad became Johnny Christie. Uncle Paul and Uncle Nick's last name went from Contini to Conti. Their Jewish musician friends had done the same thing for the same reasons. You had to make changes and have an Anglo sounding last name to compete, but things have changed. When my son, Michael, decided to become an actor, I mentioned that Dad had become Johnny Christie and I had become Johnny Christy Jr. as musicians and entertainers, and I then asked him if he was going to use either of those Anglicized spellings for his stage name. He then said, "My name is Michael Christoforo, and that is the name I am going to use in everything throughout the rest of my life.

So, considering all of this, when we Bostonians celebrate Evacuation Day and America celebrates St. Patrick's Day on the 17th, pick up your wine glass (or in my case, Scotch on the rocks) and extend a toast to Italian unification, because it was part of the reason so many of our ancestors came to America. In Gallic, the salutation is, "Slanta." In English it might be, "Here, here." But in Italian it will always be, "Salute."

Most Italians are quite accustomed to having a variety of pork in their diets. In Italy, some of the most well-known regional dishes include various cuts of *maiale*. In Rome, there's the renowned *Bucatini all'Amatriciana* and *Carbonara*, both of which use the jowls or cheek of the animal, or *guanciale*. In Lombardy, the famous *Cassouela* which uses the animal's snout, ears and feet. In Abruzzo, the legendary *Ndocca 'ndocca* uses what is considered to be the less valued parts of the *maiale*; the ears, snout, feet, tail, chops, rind, tongue, and blood. Though not a specific dish, due to their popularity, we can't forget to include the *salumi*, or cured meat products. For example, the *coppa di testa* and *soppressata* are both made from the animal's head!

I don't think I ever realized how many dishes my Nonna made that included pork of some kind. She made *porchetta* or stuffed pork roast, pork cutlets, homemade sausage and even pork *spiedini*. She also often used guanciale, pancetta and prosciutto, and this list I am sure could go on and on! The recipe I am sharing today is one that you will often find served in many Italian American restaurants. This one pan dish is easy to make, warm, hearty, and extremely comforting. Served with crusty Italian bread to soak up its delicious juices, "Pork Chops with Vinegar Peppers, and Potatoes" is an absolutely fabulous meal you and your family are sure to love!

PORK CHOPS with VINEGAR PEPPERS and POTATOES

Costolette di Maiale Peperoni e Patate



6 bone-in pork chops (1 to 1 ½ inches thick) 1 to 1 ½ cups Italian bread crumbs (I always use homemade) Olive oil 2 to 3 pounds red potatoes

- 1 (32 ounce) jar of Italian sweet vinegar peppers, reserve the juice
- 1 small jar hot sliced cherry peppers (optional if you prefer spicy) 2 cups chicken stock

Preheat the oven to 375°. Take pork chops and generously brush each with olive oil. Dip pork chops in breadcrumbs and coat well. Place coated pork chops side-by-side (not overlapping) in an oven proof deep roasting pan. Wash and scrub potatoes, cut into good sized pieces, and layer on top of the pork chops. Slice vinegar peppers and place on top of the potatoes. If desired, sprinkle a handful or so of the sliced hot cherry peppers on top.

Take the reserved juice from the vinegar pepper jar and mix it with the chicken stock. Pour the entire amount over the pork chops, potatoes and peppers, making sure the pork chops are completely emerged in the liquid. Cover pan with heavy-duty aluminum foil and cook for 3 1/2 hours. Remove the foil and cook for an additional half hour. Cool before serving.






ALI vs. FRAZIER I

Fifty Years Ago The Fight of the Century Took Place


March 8th marks the fiftieth anniversary of the first match between Joe Frazier and Muhammad Ali and Joe Frazier. The fight took place in Madison Square Garden in New York City and was billed as the Fight of the Century. It certainly lived up to and even exceeded all expectations.



It had the makings of a great fight right from the start. Two undefeated fighters, each with a legitimate claim to the Heavyweight Championship. This had never happened before in the history of boxing and will never happen again. Another factor that played into the anticipation of the fight was the fact that neither contestant was a clear favorite. Nobody could be sure who was going to win.



It is interesting to note that this fight of the century came fifty years after an earlier bout was touted in the same way: Dempsey vs Carpentier. It was also thirty years after the first Joe Louis vs. Billy Conn fight. It is now 100 years since Dempsey flattened Carpentier at Boyle's Thirty Acres in New Jersey in the fight that drew the first million dollar live gate, and it is no 80 years since the night Conn gave Joe Louis all he could handle at Yankee Stadium.



For those of us who were around at the time it happened, The Fight, as it became known, was and still is the biggest boxing event in our lifetimes and even the biggest sporting event. It is rare for anything to live up to such a huge billing. The whole world was watching and awaiting the outcome. It was front page news in the weeks leading up to the opening bell. Predictions were





not confined to just the sport pages. Editorial page writers weighed in with their thoughts on who would win. By the evening of March 8th everyone was buzzed about what was about to occur.



WHEN FOUL SHOOTING **HELPED WILT** — Early March March also brings to mind a marks the 59th anniversary of 70-point game at the TD Garden one of the most enduring feats by Devin Booker of the Phoenix in the history of the National Suns in a 130-120 loss to the Basketball Association.

For it was on March 2, 1962 that Philadelphia's Wilt Chamberlain scored 100 points in a 169-147 victory over the New York Knicks connecting on four of 11 threein Hershey, PA., a record that still stands to this day.

Much has been written about the game and indeed the entire day leading up to it. Wilt, who had stayed the night before in New York City, nearly missed Philadelphia for Hershey.

Hershey was the site of the Warriors preseason camp and the team played an occasional regular season game there as a favor to the community. The game was played near the end of the regular season — there were only five games left before the start of the playoffs — and no New York sportswriters bothered to make the trip. Philadelphia trailed the Celtics by 11 games in the standings. The Knicks were in last place.

A look at the box score along with Chamberlain's career stats give an insight as to how the dominating 7-1 superstar center managed to reach the triple digit summit that night.

For the vast majority of his career Wilt was a poor shooter from the free throw line. While his career average from the line was a poor 51.1 percent, there were several seasons where that dipped into the low to middle .400s. Send Wilt to the line and it was far from certain whether he would connect on those free

But there was a singular exception to this lack of accuracy. It came during that 1961-1962 season when his stats from the 1962 NBA championship. They line increased to .613 percent, the only year in his career that he was above the .500s.

His 100-point night may have been his finest from the line. For on that one evening he made 28 of 32 foul shots, meaning that 28 percent of his point total came from his success at the foul line. point total.

Make no mistake about it. That perfectly proportioned total of 100 points lends an almost mystical atmosphere to the feat. Even he had scored 102 or 103 points, that night in March of 1962 it wouldn't have the almost story book value of that big round 100.

As the decades have rolled by, many star players have taken the floor but none have come close the closest was Kobe Bryant, who scored 81 points in a 122-104 victory over the Toronto Raptors in January, 2006.

Booker became the sixth player in NBA history to score 70 or more points in a single game. No one has hit 70 or more since that night.

In addition to Chamberlain, the morning train that left Bryant and Booker, David Robinson, David Thompson and Elgin Baylor reached or surpassed 70. All except Robinson and Bryant accomplished the feat before the start of the three-point shot era. In addition to his 100-point game, Chamberlain found the range for at least 70 tallies on five additional occasions. > One of the reasons that he was able to score so much is that he often played close to nearly every minute of every game. In the standard 48-minute NBA game, it was not unusual for him to play 46 or 47 minutes — or even more if a game went into overtime.
