

Patriot's Day Events



On Patriot's Day, the National Lancers re-enact the rides of Paul Revere and William Dawes. Check Routes and Times for information on where and when you see watch Revere and Dawes.

The re-enactments begin Sunday night before Patriot's Day with a service at the Old North Church.

Monday morning Revere leaves from the North End, Boston and Dawes leaves from Roxbury, warning the people while on their way to Lexington.

The History of Paul Revere's Ride

Contrary to popular belief, Paul Revere did not set out on the night of April 18th, 1775 to alert the countryside to the impending British march. His specific goal was to ride to Lexington to warn two prominent Colonial leaders, Samuel Adams and John Hancock, that their lives might be in danger. Having departed Boston by boat across the Back Bay, and narrowly averting notice by the H.M.S Somerset anchored there; he procured a strong, quick Yankee horse and rode west toward Lexington.

He avoided British patrols by taking a detour north through the village of Mystic (today's Medford). It was near midnight by the time he arrived in Lexington at the home of minister Jonas Clarke, where Adams and Hancock were staying. After alerting the household, it was decided that the approaching British force, by all accounts a large one,

Stop in the Name of the Shariah Law?

Many Americans polled are now fearful that Shariah Law will creep into our courts as it already has in some European nations. Latest poll numbers show that number now reaching 20 percent. A recent Tampa judge's deferral to the Quran only feeds that fear. Hillsborough County Circuit Judge Richard Nielsen last month ordered the use of Islamic law in a lawsuit down in Tampa, Florida. The lawsuit was over control of a mosque, the Islamic Education Center of Florida, with some \$2 million in state funds at stake in the fight. Muslim leaders, themselves, tried to resolve the dispute using a Muslim arbiter but it went nowhere and resulted in the lawsuit. However, instead of using U.S. law, the Judge's two page ruling reportedly stated the case would proceed under Ecclesiastical Islamic Law, pursuant to the Quran and that the parties involved needed to resolve things amongst themselves.

To me, this sounds like a slippery slope. Next time, will this judge also use Sharia Law to settle probate and family law disputes before his court? What he should have done was dismiss the case or tell the parties to go back and file a new lawsuit based strictly on U.S. contract law



MICHELANGELO

No discussion on the Italian Renaissance would be complete without including one of the greatest geniuses the world has ever produced. Few artists have matched the grandeur of his conceptions or the power of his creations. To know his life is to know the history of Italy's glory.

Michelangelo di Lodovico Buonarroti-Simoni, Florentine, was born in Caprice, Tuscany, in 1475, at the height of the great Italian Renaissance. Today we know him simply as Michelangelo. Chiefly, he was known as a sculptor, and in this art he created some of the greatest masterpieces that this world has ever known. Additionally, he was a painter, and in this art also he created some of the greatest masterpieces that this world has ever known. He was called upon to prepare a defense for his beloved city of Florence when it was under siege, and in this effort he designed one of the most effective defenses known up to that time. As proof that he

was every bit as cultured as he was talented, he also wrote poetry which is still being republished today.

History credits Michelangelo with more than fifty great artistic creations. The most famous appear to be the Pieta' of St. Peter's, the Sistine Chapel ceiling, the Sistine Chapel wall, and the dome of St. Peter's Basilica.

The title Pieta', as we know, is given to any representation in painting or sculpture of the Virgin Mother grieving over the body of Jesus after the Crucifixion. Michelangelo's Pieta' will be discussed in more detail in the next issue of this column.

In 1508 Pope Julius II ordered Michelangelo to paint the ceiling of the Sistine Chapel. This is the work where much of it was done while lying on his back. Here, he chose to present a condensed version of events recorded in the Book of Genesis. He painted 343 colossal figures on 10,000 square feet of ceiling, and at St. Peter's

the age of thirty-three, after four years of agonizing labor, created the most powerful piece of painting in the world. Twenty-four years later he returned to paint the titanic "Last Judgement" on the altar wall of the same chapel. This work shows sinners being condemned to Hell by Christ's furious judgement. It is one of the largest frescoe paintings ever executed, and the most comprehensive in the

Michelangelo was 72 years old when commanded by Pope Julius III to take over the position of Architect for the Basilica of St. Peter, then under construction. He was the eighth of about fourteen men who served in this capacity. Here, he served without compensation "For the love of God only." The design and construction of the central dome is attributed to him and once again he produced one of the greatest masterpieces of art.

What the New Census Numbers Mean for Your Neighborhood

What do the 2010 United States Decennial Census returns mean for Post-Gazette readers? By Post-Gazette readers I mean readers in Boston's North End, where the Italian-American Voice of Massachusetts is published, or in **East Boston**, where the paper maintains a satellite office. Of course, the Post-Gazette has a much wider readership throughout Boston and the Commonwealth, but I look at the two Boston neighborhoods that have historically had large Italian-American populations.

East Boston is Ward One and contains 14 precincts. Although "Eastie" is still sometimes thought of as an Italian neighborhood, the fact is that already by the time of the 2000 census 10 of the 14 precincts were either majority or substantially Hispanic, leaving four precincts, 11 through 14, which make up the Orient Heights neighborhood as majority White, which in this case means largely Italian-American.

In 2000 East Boston, overall, was 50% White and 39% Hispanic, with Asians being 4% and Blacks 3%. By 2010 the overall numbers for Eastie had shifted to 53% Hispanic, 37% White, and the Asian and Black percentages stayed the same. All numbers thus far have been for total population. The census returns are further broken down by race for population aged 18 years and over, and those data tell an even more dramatic story of the changed complexion of East Boston.

The White adult population in 2000 was 54% of the total and in 2010 dropped to 41%. The Hispanic adult population in 2000 was 36% and by 2010 rose to 49%. Or, in census enumeration, there were 19,078 Whites in East Boston in 2000 and 15,051 in 2010, with 13,018 being adults, leaving 2,033 White children in 2010. The Hispanic population in 2000 was 14,990 and 21,419 in 2010, with 15,380 being adults, leaving 6,039 Hispanic children in 2010. In other words, not only did the Hispanic population grow by 43% from 2000 to 2010 while the White population declined by 21%, the Hispanic population is younger, with nearly three times as many Hispanic as White children in East Boston.

In summary, East Boston continues a long tradition of

RADIATION LEVELS IN JAPAN RISING ALONG WITH CRUDE OIL


A rising euro pushed dollar-based crude up \$2.49 to \$112.79/barrel. Rising concerns for Saudi Arabia and other Mideast disruptions. Gold hit a new high up \$14.4/oz on the dollar's fall and U.S. government shutdown fears.

In Japan more than 900,000 homes still had no electricity and increased radiation levels. Workers continued pumping nitrogen into the reactors to prevent build up nitrogen from exploding. As hours ticked down to a midnight shutdown, several GOP Senators called for cutting a deal with the 2012 budget. There was acceptance for a cut from \$38 billion from 2010 spending levels and the 2013 budget. There was general acceptance of a short-term on military only funding bill a possibility if no 2011 deal was reached. A Planned Parenthood funding was possible if no deal was realized. NATO admitted an attack on a convoy saying it didn't know that Gadhafi had tanks as they painted their vehicles pink and didn't help fight near Braga raising pressure on NATO to do more died in Mideast clashes. Bloodshed marked the day of prayer across the Arab world. Hospitals say 42 died in Syria as protests seeking to oust Yemen President Abdullah Saieh were reportedly killed by gunfire as crowds demanded the end of his 22-year rule. The UN found over 100 corpses in a

sign of violence adding to the 800 bodies the Red Cross discovered last week as President-elect Alassens Quattarla viewed the compound and they raised pressure on NATO to do more. Israel strikes Hamas in retaliation for using air strikes by firing six rockets into southern Israel. It targeted terror squads and killed 14 militants and civilians. Hamas fired at least six rockets into southern Israel. The powerful House Oversight Committee is expanding its investigation of possible ethics violations by the Financial Crisis. Inquiring Commission (FCIC) including improper backdoor communications between the panel and trial lawyers suing major banks over subprime investments by one major law firm using the documents employs one of the Commission. The firm Robbins, Geller Rodman could be guilty of conflicts of interest and could make billions of dollars in fees and settlements. The FDIC first report issued in January after a 15 month probe blamed the crisis on greedy bankers and predatory lenders while dismissing the role of housing policy in the mess. Geller colead counsel for three lead mutual funds suing Goldman Sachs to recover losses against Goldman and have six class action suits against Goldman Sachs. A Robbins, Geller partner was calling the shots as lead investigator all along as a congres-

sional investigator said. The FCIC may have conflicts of interest among the pension funds. This may prevent a thorough and even handled investigation between the FDIC and the pension funds and labor unions, which may impede the Commission's ability to conduct an even handled investigation. Goldman Sachs denied any conflicts and defended the integrity of the investigation. They insisted that they abided by the rules. They did not respond to requests for comment on this story. Commissioner Georgian failed to recuse himself from the FDIC's investigation of Goldman Sachs. They never responded to phone calls and emails seeking comment. At a private hangout they discussed updated participants on what the Commission has learned as it reaches its conclusions and action above lessons for fiduciaries. There were 200 in the audience including pension fund activists suing banks probed by the FCIC. The meeting was held at a beach front resort with one of the best golf courses in California. They say that Goldman state pension funds actively suing banks probed by the FCIC.





The Palm Basket

Recently we volunteered to help put into order a backroom at Sacred Heart Church. Things had gathered in it through the years that needed to be sorted, cleaned and made right for use once more. On a shelf behind some dusty cartons was part of an old basket woven out of palms, we remembered it as one of several woven baskets crafted by someone in the North End that decorated Sacred Heart's altar every Palm Sunday. It was decades ago since they were last used, yet, somehow, part of the basket survived.

The discovery of the basket brought back memories of Palm Sundays long ago and the traditions associated with it many of which we continue to practice. The most vivid of these memories was the tradition of exchanging palms as a sign of peace. The moment we arrived home from Palm Sunday Mass, Dad would begin the process of exchanging palms first between he and Mom then among the children who had to exchange palms among themselves. If there was a moment's hesitancy in the process, because of some unsettled dispute, Dad would spot it, it only took a disapproving look from him, to settle the dispute and make the palms flow freely.

The tradition of taking palms to the cemetery to place on the grave of a loved one is still practiced but it seems to have been more widely practiced in the past. Grandma had placed a magnificent statue of the Sacred Heart as a headstone on Grandpa's grave, during Holy Week we would make it out to the cemetery with palms, watering cans and geraniums, we were not only bringing palms to Grandpa, we were going to clean up the grave site and plant it with fresh flowers making it ready for Memorial day. Everything was packed into shopping bags; if we could not get a ride to the cemetery we would make the trip by subway to Forest Hills and then the trek up Walk Hill to Saint Michael's. Grandma would insist that we tie a palm around the wrist of the Sacred Heart, only once did a palm survive the year, remaining on the wrist of the statue till replaced the following year.

We would then replace the palms anchored into the large urns on either side of the statue. Once the grave site was cleaned and replanted came the next ritual, what does one do with old blessed palms; they are a sacramental and should be discarded properly. Grandma worked it all out many years earlier; we would simply bury them just behind the gravestone. Anyone walking through the cemetery would have wondered at what we were doing, we must have looked like grave robbers, but at the time we never gave appearances a thought, it just seemed to be the right thing to do.

It is amazing how the chance discovery of some object from our past can trigger memories, for some reason those associated with Palm Sunday and Easter seem particularly vivid. We all value our memories and cherish them, they seem to grow more precious with time, sometimes they bring a tear to our eyes but often they can be quite amusing as you think to yourself, did we really do that? One last thing, we did not bury the old palm basket behind grandpa's stone, but it would have been fun to revisit that tradition, grandma would have approved.

Here is a case where the Court inferred that if the sole effect of impaired driving is the result of medication and not the drinking of alcohol, you may not be guilty of driving under the influence.

COMMONWEALTH vs. LISE J. BISHOP APPEALS COURT OF MASSACHUSETTS No. 08-P-1735. 2010 Mass. App. December 11, 2009, Argued October 15, 2010, Decided

Raymond Schichilone discovered the defendant, Lise J. Bishop, shortly before midnight at the wheel of her car, stopped in the middle of the road in the town of Yarmouth. The car door was open, blocking the street. She appeared to be very intoxicated; she was arrested and handcuffed with her hands in front of her because she had difficulty standing and needed her hands to steady herself. At the police station, the defendant began what Officer Schichilone described as "outbursts"; one minute she was "calm and cooperative," and the next minute, "uncooperative and yelling." The booking sergeant confirmed the arresting officer's testimony about the defendant's presentation, stating that he believed, based upon her "easily noticeable" odor of alcohol and

Yarmouth police Officer speech that was thick and "almost difficult to understand," the defendant was "very drunk."

> The defendant testified that she remembered having two drinks and dinner with her husband in a restaurant earlier in the evening, and nothing else until she was placed in a cell after being arrested. At the time, she was taking fluoxetine, an anti-depressant prescription medication, on an "as needed" basis to combat the symptoms of a premenstrual disorder. She did not know if she had used alcohol in the past while taking the medication but her doctor had not warned her of any side effects and she had read neither the patient information provided with the medication nor the labels on the bottles until after she was arrested. The defendant was permitted to read the labels

with the warnings, including the side effects, to the jury.

The trial judge clearly informed the jury that the Commonwealth had the burden of proving that alcohol was at least one cause of the defendant's diminished capacity to operate a motor vehicle safely; the judge also told the jurors that the defendant was entitled to an acquittal if her intoxication was involuntary due solely to prescribed medication. These instructions were proper and the defendant was entitled to nothing further on that issue.

This case says that if taking alcohol contributes to your incapacity, then you are guilty. It also says if the incapacity is solely due to medication or if you were not informed by the doctor that the drug can affect your ability to drive, you may not be guilty.

House Republicans have pushed through legislation up on Capitol Hill to end an underachieving Administration program designed to reduce mortgage payments for homeowners facing foreclosure. Most Democrats admit the Home Affordable Modification Program falls short of a University of Maryland its goal but protested the economist has said, "Five vote to end it. Roast Leg of Lamb

1 leg of lamb (5 to 6 pounds) 4 cloves of garlic

½ cup chopped mint (optional) 1/4 cup lemon juice 1 tablespoon thyme or oregano salt and pepper

Rub the leg of lamb with half of a garlic clove. Then make several gashes with point of knife into the lamb leg and insert small cut portions of garlic clove into the narrow openings. Rub meat with mint, thyme, or oregano, whichever you plan to use, or some of each. Rub leg of lamb with salt and pepper. Add a little water to the lemon juice and pour gently over lamb. Place lamb fat side up in roasting pan. Place in preheated 325°F oven uncovered. After 30 minutes, baste lamb with juices from the roasting pan and repeat frequently. Lamb should be baked until meat thermometer reads 175 to 180°F. If you are baking without a meat thermometer, allow lamb to bake approximately 30 minutes per pound of lamb. Add more water mixed with a little lemon juice if more liquid is needed for basting.

OPTIONAL: Small white potatoes, carrots and some mushrooms can be added around the leg of lamb after the lamb has baked about an hour. Continue basting vegetables as well as the lamb.

NOTE: I awoke Easter morning to a combination of aromas filling the kitchen. I watched as Mama put the lamb roast into the oven. I saw the chicken soup simmering slowly on the stove next to the tomato sauce Mama had prepared earlier. I always asked to have one of the meatballs as she completed frying them. When did Mama start all this, I wondered.

On the kitchen table, a bowl of hard-boiled eggs greeted my eyes along with a Cannattone (Easter Bread) for Peter and me. As Peter, Papa and I departed for church after breakfast, Nonna and Mama's sister Lena arrived to help make the ravioli. I knew then that the Easter meal would keep us at the table for a long



being one of the first places for new groups of immigrants, whether the Irish in the 19th century, the Italians in the late 19th and early 20th centuries, and now Hispanic immigrants of the late 20th and early 21st centuries seeking a better life for themselves and their children.

The story of the **North End** — at least as far as what the census data say — is quite different from that of East Boston. East Boston, which had overall 5.5% population growth from 2000 to 2010 and the North End, which had 5.1% growth, both grew at just slightly higher rates than the overall 4.8% for the City. But whereas East Boston saw a large shift of population by ethnic group, the North End, with a 91% White population (was 94% in 2000) remains the whitest of neighborhoods in an otherwise 53% minority city.

Finally, "Thank you" to every Boston resident who responded to the 2010 Census! These data will be important in determining representation in Congress and how tax dollars are directed at local communities.

Nanna & Babbononno

Easter was coming and Mom and Dad had decided that they would host the family get-together. Babbononno was in his nineties by then and living in a nursing home back in East Boston. He had been on his own in an apartment, but by his mid nineties, he couldn't manage and he took up residence at the Columbus Nursing Home on Saratoga Street near Orient Heights.

I always liked to invite close friends to the house at holiday time, but most of my friends would spend Thanksgiving, Christmas or Easter with their own families. The thought was there on my part, anyway. This particular year, I invited a new friend and an old friend. I had become friendly with Dean Saluti, around Labor Day weekend and we had hit it off. Unfortunately, he couldn't make it. He was going to spend Easter with his parents and brothers who all lived in Quincy at that point in time. Sal Meli accepted. Sal and I had grown up together in East Boston, and his parents had recently moved back to Sicily in retirement. Sal accepted my

invitation. I was playing with a band at a Boston nightclub at that point in time and Good Friday and Holy Saturday performances were to phantom audiences. I was playing bass guitar for the Steve Marvin Band and we were at the Point After six nights per week. The club had been the Darburry Room Dartmouth Street Copley Square, but changed hands with Gino Cappelletti, the former Patriots kicker owning it and naming it. Usually, we played whatever we wanted until the dining room of the club closed at 10:00 pm. From that point on, it was top 40 all the way. Sal showed up on Good Friday night with a date. On a break, I joined them and Sal and I planned for Easter Sunday morning. Mom had asked me if I would pick up Babbononno at the nursing home, and I figured that I might as well pick up Sal as well; he didn't live that far nononno suffered from away. By 1:00 am, Jim DeFonzo, Gino's cousin and the club manager came over to the band and told us to pack up. There was no one left in the club. Normally, we yelled, "Last call," at 1:45 and finished at 2:00 am.

I headed to Ken's Delica-

After. It was just around the corner in the middle of Copley Square, and late at night, it was often the hang out for musicians and entertainers. This was Good Friday and the place was almost deserted. I went back to the club and picked up my car and headed to Brookline and another late night hang out, Jack and Marion's. This long-gone delicatessen, like Ken's in Copley Square, was a catch all for a show business crowd looking for something to eat after their evening performances. They were just as deserted as Ken's and I headed home.

The next night, Holy Saturday, was just as slow at the Point After, and we closed at about 1:00 am again. I headed to Kenmore Square to catch up with Dean Saluti. He was in graduate school at the time and working the front bar at Lucifer's, one of the three clubs in the complex called the Kenmore Club. By the time I got there, he was just about wrapping up his end of the operation, as the club was just about as quiet as the Point After had been. We decided to go Chinatown for a late night bite to eat and headed for the Four Seas. The owner, a friend, spotted us and sent over a round of drinks. There was one problem, though. It was after 2:00 am and the bar should have been closed. The waiter brought two extra pots of tea to the table, one with beer for Dean and one with scotch for me, and with a thick Chinese accent he told us, "You have Budweiser tea and you have Johnny Walker tea." That evening we were teetotalers.

It was Easter Sunday morning, and after Mass, I dropped off my folks and headed to East Boston to pick up Sal Meli and Babbononno. The weather couldn't have been any better. It was warm and sunny and I felt good that I had gone to church that morning. Sal was waiting when I got to his house and we headed to Orient Heights to pick up Babbononno.

Like many old folks, Babboanticipation. I had told him I would pick him up at 11:00 am, and he was probably ready and waiting by 7:00 am. I was right. When we went inside to get him, Babbononno was pacing back and forth as if we were an hour late. He, in spite of tessen after I left the Point being in his mid-nineties,

was impeccably dressed: pressed suit, starched collar white shirt, neck tie, pocket handkerchief, spit-shined black shoes, fedora with the brim turned down in front and a top coat in case it was cold outside.

We exited the nursing home and Babbononno looked up and down the street for my car. Not seeing it, he said, "Jenny, wayza da Cadillaca?" I told him that I had traded it in for a Chrysler Imperial and pointed to my new auto. He looked at it and asked, "Dissa new machine, sheeza azza good azza da Cadillaca?" I told him that it was just as good. He quickly added, "Izza gudda da top wadda you pusha down?" When I said that it was a convertible, he responded with, "Denna pusha da toppa down." I did. Before he got in, he asked, "Jenny dissa da seat wadda go up anna down?" I said that the seats were electric and went up and down. He ordered me to put his seat as high as it would go, and I did. He then ordered Sal to get in the back seat, which he did.

Babbononno looked tall sitting in the front of my new convertible with the top down and the right front seat set as high as it would go. He looked at his pocket watch, then at me and said, "Vai, vai." (go, go) He then instructed me to go to Orient Heights Square, right on Bennington Street and head toward the Star of the Sea Church. When we got there, Mass was just getting out and he instructed me to drive as slow as I could. I complied. We passed in front of the church and he spotted some old ladies coming out of Mass. As we passed them, he tipped his hat and called out to them, yelling, "Signore, Buona Pasqua, Buona Pasqua." (Ladies, Happy Easter, Happy Easter) Most of them smiled back saying Buona Pasqua or Happy Easter to Babbononno, and he was happy. We then headed for Belmont and Easter dinner. All the way there, Babbononno sat proudly and tall in the front seat of my new Imperial convertible, which he knew was just as good as the Cadillac I had traded for the new car. I stopped at the lights on the Everett Parkway and again at Wellington Circle, and Babbononno nodded at the drivers and passengers in other cars that were also stopped. I saw Sal's face in my rear view mirror and he was smirking all the way. Once we got to the house in Belmont and helped Babbononno out of the car. Sal commented, "I hope we make it to that age, and if we do, I hope we have it all together like your grandfather. I guess

must have an object other than the capture of two prominent Yankee Whigs. They decided that they must be after the stores of munitions located farther to the west, in Concord. Revere again rose into the saddle. Accompanied this time by another rider, William Dawes, he set off to warn the citizens of Concord.

Paul Revere's Capture in Lincoln

Shortly after departing from the Clarke house, Revere and Dawes met another patriot on the road, Dr. Samuel Prescott. He joined the pair of riders and the three men agreed to stop at every house they passed on the way to Concord and warn the inhabitants of the British advance. Their luck ran out just over the Lexington-Lincoln town line. While the others were warning some families at a small cluster of farms, Revere ran straight into a British ambush. At first, he saw only two soldiers and called to his friends to help him overpower them.

As Dawes and Prescott arrived, the British held the three riders at gunpoint and herded them into a nearby field. Before they could question them however, Prescott suddenly turned his horse and galloped away into the dark woods. Revere turned in the opposite direction and also tried to escape, but was chased down by more British soldiers joining the initial ambush party. While the British focused on Revere, Dawes managed to get away. The understandably irate British soldiers questioned Revere for a short time. He informed them that the entire countryside was being warned of the approaching British force.

The reconnaissance troops took Revere with them as far as Lexington, where it became clear that he had indeed been telling the truth the countryside was beginning to take up arms. Here in Lexington, they released him and rode east, as fast as they could, to warn the main force already on the march from Boston.

Lexington Battle Green

In the murky dawn of April 19th, 1775, a British expeditionary force, on the orders of General Thomas Gage and led by Lieutenant Colonel Francis Smith, ap-The soldiers, numbering between 800 and 900 men in 21 companies, had departed

from Boston the night be-

Their mission: to find and capture Yankee munitions that were stored in Concord. By the time they reached Lexington however, they found themselves faced down by a growing number of local militiamen arrayed on the town Common. Major John Pitcairn's British light infantry was deployed on the Common directly opposite the band of minutemen led by Captain John Parker. "Stand your ground," Parker said to his apprehensive troops. "Don't fire unless fired upon, but if they mean to have a war, let it begin here."

No one knows for sure who fired the first shot of the first battle of the War for Independence. All that is certain is that a heavy toll was extracted from the defiant American militiamen. In the wild, undisciplined firing followed the first mysterious shot and two Lexington men fell dead on the line where they stood. Other militiamen briefly returned fire and then joined their comrades in a confused, smokeshrouded retreat.

The British soldiers continued firing into the fleeing crowds, killing more Americans as they tried to escape back into their homes. Only when Colonel Smith himself arrived on the Common were the soldiers commanded to cease fire and form up. As the families of Lexington nursed their wounded and mourned their dead, the British column continued their march toward Concord.

Lo sapevate che ...

Quello che segue e' solo un esempio (naturalmente ce ne sono altri) di come lo stato italiano spende, o piu' esattamente spreca, milioni di euro per mantenere la burocrazia parlamentare. Stavolta parliamo di 'meta' del parlamento, la Camera Bassa, per vedere quanto costa per tenerla attiva.

Incominciamo con la Camera Dei Deputati-che consiste di 630 eletti-che si riunisce a Palazzo Montecitorio, a Roma. Siccome non c'e' abbastanza spazio per tutti gli impiegati, la Camera spende 54 milioni di euro per affittare i locali necessari. Poi viene la ristorazione, che costa 7½ milioni di euro, e la prevenzione degli incendi che costa 2.8 milioni di euro. Per acquistare nuove tappezzerie, riparare quelle vecchie, comprare arredi, targhe, cartelli, casseforti e armadi blindati la spesa arriva a 1 milione di euro l'anno. Per gli atti parlamentari-dalla stampa allla pubblicazione online- occorrono altri 10 milioni di euro. L'ufficio 'tecnico' di Montecitorio-manutenzione, collaudi, impianti termici, eletttrici ed elettronici- costano altri 17.5 milioni di euro che servono anche per tenere funzionali gli ascenzori.

I corsi di lingua straniera per i parlamentari-dall'inglese al russo- costano ½ milione di euro. C'e' poi un budget di 139 milioni di euro gia' erogati a "Milano 90, s.r.l.", guidata da Sergio Scarpellini, a cui si aggiungono 51 milioni di euro per affitti di immobili annessi a Montecitorio. Il solo Palazzo Marini costa circa 45 milioni di euro l'anno, ed altri 2.6 milioni di euro sono per la ristorazione.

L'analisi dei fornitori della Camera e' difficile da comprendere poiche' sia i proprietari che i soci sono protetti da complesse societa', come nel caso suaccennato di Scarpellini, l'immobiliarista romano che sta construendo un nuovo quartiere residenziale alla periferia della capitale: "La Romanina", ed e'pronto (Scarpellini) a guidare una cordata di imprenditori per la costruzione anche del nuovo stadio della squadra "Roma". Le imprese di Scarpellini fanno parte di societa' finazniarie e di banche. Francamente e' un pasticcio, ed esiste poi nessun controllo!

Did you know that ...

What follows is but a sample (out of many others) of how Parliament's bureaucracy spends or rather wastes, millions of euro to run the lower chamber. (630 elected members) stay "in business" at Palazzo Montecitorio, in Rome. Since there is insufficient space to accommodate thousands of employees, the "Chamber" spends 54 million euro to rent needed space. There is then the "feeding" of the "elected," which costs 7½ million euro; for fire prevention they spend 2.8 million euro; to acquire new tapestries and repair the old ones, to purchase furnishings, plates (for vehicles), stationery, safes and other bullet-proof furniture the cost is another 10 million euro. To prepare Parliamentary Acts (printing and publishing on-line) it costs another 10 million euro. The "technical office" of Montecitorio — for up-keeping, testing and installation of thermal equipment, as well as caring for electrical and electronic devices, the cost is 171/2 million euro, which includes maintenance of the elevators.

Foreign language instruction for the Chamber's members — English and Russian — costs ½ million euro a year. There is also a budget of 139 million euro in the coffers of "Milano 90, s.r.l. (Inc.)" that belongs to Sergio Scarpellini, and another 51 million euro for the rental of real estate adjacent to Montecitorio. The Palazzo Marini itself costs, for rental only, 45 million euro a year, and an additional 2.6 million euro are spent to feed the Chamber's members!

An analysis of the Chamber's suppliers is hard to fathom, for the owners and associates are protected by a network of corporations, as in the case of Scarpellini the Roman Real Estate owner, who is now building a new residential complex on the outskirts of Rome: The Romanina (the little Rome), and is about to lead a building group of developers for the building of a new stadium for the team "ROMA."

Scarpellini's enterprises are part of financial institutes and banks. Frankly, it is a big mess! Nor there is any control whatsoever, by anyone!

Warren Spahn a Lasting **Boston Brave Legend**



Warren Spahn once said, "Hitting is timing. Pitching is upsetting timing." And that he did to the turn of 363 career wins, tops among all left-handed pitchers in baseball history. Spahn fought in World War II and then stood tall for all with the Braves both in Boston where he started and Milwaukee where he finished. He was one of the greatest control pitchers of all times and had the career to showcase that pitching ability. In 1957 when the Milwaukee Braves beat the NY Yankees in the World Series, he won the Cy Young Award and also placed second three times back to back when there was only one Cy Young Award in all of major league baseball. Spahn was inducted into the Hall of Fame in 1973.

Author Jim Kaplan wrote in his book, "The Greatest Game Ever Played," about the July 2, 1963 matchup between Spahn and Juan Marichal of the San Francisco Giants. We in Boston know Spahn as a Boston Braves player but he spent the best years of his career in Milwaukee after the team left Boston for greener pastures in 1952. If you googled Whitey Ford, Sandy Koufax and Spahn, he would finish a poor third but look at his record, a 22-year career with 363 wins. Spahn was the most successful pitcher of the '50s with 202 wins. He led the NL in wins eight times and complete games, nine times. He had 13 seasons as a 20 game leader which tied him with the great Christy Mathewson and only Cy Young with 15 has more. He threw two no-hitters at ages 39 and 40. In 1963 at age 42, he won 23 games with a 2.60 ERA. Spahn entered the minors in 1940 briefly then injured his shoulder. However, he came back in 1941 to win 19 games. He started out 1942 up in the majors with the Boston Braves where he and his manager Casey Stengel seemed at odds with each other. Casey sent him back down for most of that season bringing him up again at the tail end of the 1942 season. He enlisted in the US Army when that season ended. He fought in both the Battle of the Bulge and at the Rhine

River bridge and won a

Purple Star and a Bronze Star. He returned to the baseball diamond in 1946. Many baseball folks believe, if not for his war service, he might have been a 400 game winner but he often disagreed with that saying, "I matured a lot in those (war) years. If I had not had that maturity, I wouldn't have pitched until I was 45."

Guys like Ed Shallow still remember him for bringing the NL Pennant to Boston in 1948 and got to see him pitch in his prime years during the fifties. I was lucky to see him pitch once back in 1964 during those Jimmy Fund exhibition games at Fenway Park. He was treated like a homeboy because to Boston baseball fans he was a Boston Braves player forever with them. Older fans could remember days when they saw him pitch all the time over on Commonwealth Avenue at Braves field.

Finally, if you're really too young to remember, find and read a copy of "The Greatest Game Ever Played" because it truly was indeed.

Giambi's: Anderson Supplied PEDs

The Colorado Rockies first baseman Jason Giambi and his brother Jeremy have testified that Barry Bond's personal trainer supplied both of them with performanceenhancing drugs. The two of them were the first athletics called to testify at the Bonds' perjury trial in San Francisco. Jason Giambi said he met trainer Greg Anderson after the 2002 season while both were traveling in Japan with the United States All-Star team. When they returned home, Anderson had Giambi's blood reportedly tested and it turned up positive for a steroid that Major League Baseball was planning to test for during the 2003 season. "(He) told me that would trip a Major League Baseball test and I should take something else," said Giambi.

Giambi reportedly paid Anderson about \$10,000 for several shipments of steroids known as "the clear" and "the cream" designed to evade detection starting in late 2002 and through the beginning of the 2003 season. Syringes and a calendar detailing when he should take the substances were in the first shipment, said Giambi. Jeremy Giambi testified similarly His five year career ended in 2003. For a short time, he was a member of the Boston Red Sox.

Former San Francisco Giants trainer Stan Conte testified that Bonds added significant muscle mass before the 2000 season and noticed acne on the slugger's back, which prosecutors allege is a side effect of steroid use.

Red Sox Pick Up Another Catcher

The Red Sox have picked 25-year-old McKenry for right hander Daniel Turpen who was 2-1 with a 4.91 ERA for Double A Portland Seadogs last season. McKenry hit .265 with 10 home runs and 49 RBIs for Triple A Colorado Springs last season. He is considered a solid defensive catcher with a good throwing arm. The addition of him to the Red Sox means good accident insurance in case either Jarrod Saltalamacchia or Jason Varitek get injured.

He stood 6' 1", 189 lbs. and was dubbed the "Manassa Mauler!" amassing a record of 60-7-8-6 ND, 49 KO's fighting, among others, Boston Bearcat, Gunboat Smith, Jim Flynn, Fred Fulton, Battling Levinsky, Jess Willard, George Carpentier, Tommy Gibbons, Luis Firpo, Gene Tunney, Jack Sharkey, Bearcat Wright. He was elected to the World Boxing Hall of Fame in 1954.

Boxing legend **Gil Clancy** passed into that Golden Ring in Heaven refereed by God at the age of 88. Gil Clancy was named Manager of the Year twice, in 1978 and 1981.
