### Democratic Inaction on Beacon Hill

May Leave Many Voters with No Choice on the November Ballot

Entrenched Democrat leaders on Beacon Hill appear to have ignored an electioneering factor they somehow never saw coming during the state's response to the COVID-19 pandemic the crucial person-to-person gathering of ballot signatures. The so-called 'robust mail-in balloting' program passed by the Democrat-controlled legislature only addresses the upcoming special elections and not upstart campaigns preparing for the September primaries and November final election.

"The signature-gathering process involves thousands of social interactions between candidates and voters, yet Democratic leadership clearly ignored this during the bill-making process," said Massachusetts Republican Party Chairman Jim Lyons. Grassroots candidates who lack an incumbent's unlimited deep pockets will be unable to get on the ballot, and that means votes will be left with fewer choices on the ballot.

Are you a conservative Republican hoping for a candidate to take out an incumbent Democrat? Well, it won't happen if that candidate cannot get on the ballot due to a signature requirement that doesn't not reflect the reality of "social distancing." Are you a progressive

who would like to see a more liberal challenger to a centrist incumbent? That is equally unlikely, if the next Alexandria Ocasio-Cortez can't get on the ballot because of a system that even in the best of years is rigged for the incumbent. That's why we even saw the Massachusetts Teenage Republicans and the Massachusetts High School Democrats — two opposing groups made up of young people typically on the front lines of signature-gathering efforts — join together to urge the Legislature to act on this problem, only to see Democratic leadership ignore it. Their inaction guarantees well-heeled incumbents will receive a free pass.

Massachusetts GOP Chairman Lyons said: "Incumbents already have established lists of voters who have signed nomination papers for them in the past, not to mention existing campaign accounts that can easily pay for mailings and whatnot. Challengers don't have that luxury, and in a legislature dominated by one party, it's pretty easy to see why the Democrats are refusing to address this potentially dangerous situation."

Republican U.S. Senate candidate Kevin O'Connor, whose 86-year-old father has been hospitalized as a result of the virus,

must gather 10,000 signatures by the Massachusetts Secretary of State's May 5<sup>th</sup> deadline to ensure his place on the ballot.

"We want the Legislature to bring the law into alignment with the social distancing requirement," O'Connor said in a recent interview.

Meanwhile, candidates for state office only have until April 28, to collect the required number of signatures. New York state has already acted to lower the threshold for signatures in its elections.

While candidates from both parties remain in limbo as a result of Beacon Hill's apparent unwillingness to address signature-collection thresholds amid the COVID-19 pandemic, GOP Chairman Lyons has been busy trying to find simpler solutions that don't require legislative approval.

Last week, Lyons announced that after reaching out to Secretary of State William Galvin, the office has agreed to allow individuals to print from home printer-friendly 8.5-inch by 11-inch copies of nomination forms. (To satisfy state law, individuals must print the forms double-sided, however.) "I'm grateful that Secretary Galvin agreed to work with us on this," said Lyons.

# Stirpe Nostra

### **POSEIDON**



Poseidon was the Greek god of all flowing waters. He lived in the sea and rode over the waves in a chariot drawn by brazen-hoofed horses. Giant waves smoothed out as he approached, while sea monsters recognized him and frolicked around his chariot. He generally yoked the horses to the chariot without the help from others, but occasionally he was assisted by the Nereid Amphitrite (a sea nymph) who was his wife. Most of the time was spent in the sea, however, when the gods assembled at Olympus he appeared there in person.

This god is credited with building the walls around Troy for King Laomedon, the founder of that city. A period of labor for wages was ordered because of Poseidon's participation in a conspiracy against Zeus. Later the king refused to pay the wages that were promised, and in consequence, a sea monster was sent by the sea god to rav-

age the land, and to devour the king's daughter. Hercules just happened to be passing through the area and saved the beautiful princess by killing the monster.

Poseidon continued to bear a relentless hatred for the Trojans and sided with the Greeks later, in their war against Troy. At times, he stood off and witnessed the fighting as a spectator from the high ground at Thrace, and at other times, he appeared as a mortal to encourage the Greeks while Zeus was helping the Trojans.

As the ruler of the sea, Poseidon had the power to cause clouds to appear and storms to form, or he could have granted a safe voyage to help those who were in troubled waters. At one time, he argued with the goddess Athena over which of them should offer a name for the capitol of Attica (Athens). The gods decided that the honor be reserved for whichever of the two bestowed

upon mankind the most useful gift. It was at this time that Poseidon created the horse, while Athena created the olive tree, and of course, we all know that Athena won.

Poseidon is credited with teaching men the art of handling horses by the bridle and also for being the originator of horseracing. This is why he is sometimes represented on horseback. The symbol of his power is the trident (a spear with three points). This is the instrument that he used when he created or subdued storms, shattered rocks, or even shook the earth.

This sea god was worshipped all over Greece and Southern Italy. Sacrifices to him generally consisted of bulls, wild boars, and rams, while horse races and chariot races were often held in his honor. For more than twenty-five hundred years, he has been easily recognized in any artistic representation by his accompanying dolphin, horse, or trident.



## BERNARD J. "BEN" DOHERTY

July 17, 1936 - April 11, 2020

Bernard Joseph Doherty, former stockbroker, Massachusetts Boxing Commissioner and Irish-American of legendary toughness and charisma, died April 11th, 2020 at the age of 83.

He leaves behind his son, Greg Doherty, of Kensington, California; his daughter, Kate Quigley of Marblehead, Mass; five grandchildren; his brothers Tony and John and their families; and a number of nieces and nephews whom he loved, along with their children. His son Glen, a former Navy SEAL, preceded him in death in 2012.

Ben was the third child of five born in Boston, Massachusetts to Anthony and Margaret Doherty of Donegal, Ireland. The family kept a large chicken farm in Billerica that taught Ben a strong work ethic at an early age. As the first from his family to attend college, at UMass Amherst, Ben became a great believer in the opportunities provided by education. This would guide his extensive service on the UMass Board of Trustees, as the director of the UMass Business School, and as President of the UMass Building Association. He also gave back to his alma mater Billerica High school by organizing an annual charity boxing fundraiser and was twice invited to be the graduating class' commencement speaker.

Ben was an important member of the boxing community, first as a Silver Mittens, Golden Gloves and All-Army boxing champion and 1960 Olympic trials competitor, then as a fight trainer, Chairman of the Boxer's Fund Board, and, ultimately, Massachusetts Athletic Commissioner. A great proponent of "the sweet science" out of the ring, he had the events, often for good causes. A



flattened nose yet high profile that made him, for many in Massachusetts, the face of boxing.

Above all, he was a fun-loving person. A long-time resident of Winchester, where he had three children with then-wife Barbara, he seemed to live for ski trips to Loon Mountain or out west; water-skiing trips on his small speedboat; attending Celtics games, Red Sox games and boxing matches; and in general just getting out of the house to be among others having fun. He coached innumerable Winchester youth for the decade that his children played. He loved holidays, dressing in costume every Halloween, wearing an all-green suit and leprechaun shoes each St. Patrick's Day, and playing a very jolly Santa at the neighborhood holiday party. A proud Irishman and father, he checked off a major bucket list item when he took all three of his children to Ireland in 2004.

Among his peers, Ben was and a fearless fighter in and known for organizing parties and

successful stockbroker — the top producer for five different firms over thirty-four years who never forgot his roots, he was equally comfortable and welcome among all classes of people. He regularly combined the social and athletic, forging many lasting friendships on tennis courts and the golf links. An unapologetic lover of the spotlight, he gravitated towards microphones and dance floors, where he had abundant skills but was more than willing to play the fool. A photograph in the Boston Herald of him wildly dancing at a wharf party he'd crashed once blew his alibi for missing an afternoon's work.

In his later years, he resettled in the North End of Boston in semi-retirement as a financial consultant. He wrote a financial column for the Italian-American Post-Gazette newspaper for many years, joined the Ancient and Honorable Artillery Company of Boston, explored local restaurants, and kept his faith as a Catholic, rarely missing Sunday mass.

In March of 2020, after a period of declining health, the Covid-19 virus rang the bell that ended the fighter's final round.

He would want the last words about him to be an Irish blessing, so, Ben:

May your left break the devil's jaw And your right hold a bottomless drink, And may you dance with Irish angels in heaven As God gives your mischief a wink.

## L'Anno Bello: A Year in Italian Folklore

Showers and Sunshine: Watching Spring Weather

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is but a memory!



Spring is here, and that means weather as fickle as a teenager's mood. Some days boast record warmth and abundant sunshine, laden with the carefree atmosphere and scent of fresh vegetation reminiscent of midsummer. Other days feature brisk breezes that ruffle the delicate new daffodils and tulips, and cool air that calls for a coat. Of course, spring simply would not be spring without the arrival of brief but soaking rain showers. During these rains, people disappear under umbrellas and colorful rubber boots as they splash their way through the day, jumping in and out of puddles. The aftermath of a spring rain is just as magical: the foliage appears greener, birds commence singing again with renewed gusto, and a rainbow may vividly spread its colors across the sky. Nowadays, knowledge of this weather, from atypically humid Easters to spring rainstorms, is always at our disposal due to meteorological reports on television and apps on our smartphones. However, people in older times needed ingenious ways to determine the weather. After all, in agricultural and maritime societies, weather was often a matter of life and death, as it controlled the success of the harvest or the ability to head to the sea and fish. Italy used to be one such agricultural society, and therefore still contains a multitude of weather superstitions and lore. I remember some of these sayings from my childhood, where they formed an indelible part of my Italian cultural heritage. These pieces of weather folklore are often repeated from generation to generation, even in contemporary times, a testament to their ancient power.

A few years ago, I was having dinner with my best friend at a local Thai restaurant. She looked out the window and gasped, remarking on how amazing the

sky appeared. I turned around to a stunning sight: bright pink clouds streaked across the sky like threads of cotton candy, tinged in gold by the setting sun. I told my friend that the weather tomorrow would probably be nice. How did I know this without checking my phone? Well, I had remembered an Italian saying my grandmother often intoned in a singsong voice: "Rosso di sera, buon tempo si spera/Rosso di mattina, la pioggia s'avicina." Roughly translated, this means: "Red at night, good weather awaits/Red at morning, the rain approaches." My grandmother repeated this dictum so often that I consider it an essential staple of my childhood, right alongside Baby-Sitters Club books and my mother's homemade pancakes. Basically, this proverb explains that a sunset with a reddish tone foretells fine weather the following day, while a red-hued sunrise promises a day of rain. I discovered fairly recently that this maxim has a famous English-language counterpart: "Red sky at night, sailors' delight/Red sky at morning, sailors take warning." Though the red skies proverb dates back thousands of years, it contains some meteorological truth. According to the National Oceanic & Atmospheric Association (NOAA), a red sky at sunset may be caused by the sun illuminating dust particles in the air, indicating a highpressure system that brings good weather. Conversely, the red sky at morning indicates that the high-pressure system is passing, which may be replaced by a rain-inducing low-pressure system. Our ancestors knew what they were talking about!

Encouraged by the memory of this proverb, I grew inspired to search for other nuggets of Italian weather lore. The website of Italy's Osservatorio Meteorlogico, Agrario, Geologico, a meteorological observatory run by Prof. Don Gian Carlo Raffaeli and hailing back to 1865, compiled a number of popular weather sayings from across the country. Not surprisingly, much of the lore concerns rain — after all, it was important to know when it would rain in order to shelter livestock and control the amount of water the crops received, or exercise care during a fishing voyage. "Cielo a pecorelle acqua a cantinelle" means that rain showers will soon arrive when the clouds resemble a sheep's wool. My mother frequently repeated this proverb whenever we saw such clouds, which bear the scientific name altocumuli. Another superstition that foretold rain stated "quando il gatto si lecca il pelo, viene acqua giú dal cielo" rain will fall from the sky when a cat cleans its fur! This was also a favorite dictum of my grandmother's, and I always think of it whenever I see my cat washing herself. Not all Italian weather lore talks about rain, however. According to one maxim, "quando la rana canta, il tempo cambio," a croaking frog is indicative of imminent weather changes. "Stelle troppo scintillante vento forte a te davanti" warns that excessively twinkling stars foretell strong winds. Good weather, on the other hand, can be expected following low fog, as evidenced in the proverb "la nebbia bassa buon tempo lascia." Finally, one of my favorite weather sayings happily declares "arcobaleno porta il sereno" — a rainbow after a storm brings calm weather. It reminds me of the joy and reawakening of nature that occurs in the spring, under the brilliant colors of an afternoon rainbow!

Weather lore, though no longer taken as seriously in our days of Doppler radar, continues to yield influence in the realm of cultural treasures and national characteristics. Some pieces of weather lore contain meteorological truths, while others decidedly do not; however, they all demonstrate the importance of weather to societies that depended on the unpredictable nature of farming or fishing. Moreover, weather lore, like all quaint traditions and superstitions, link us to the rich, unending lineage of our ancestors. I associate weather customs with family memories and parts of my childhood, such as my grandmother singing about red skies or my father playfully remarking that, according to stories from his boyhood, rain falling during sunshine meant that the fox was getting married. So let's cherish all the proverbs about weather that have been passed down from our ancestors, no matter how silly they sound. They are another invaluable part of our heritage and our place in this world, rain or shine!



## Saint Leander of Seville

Leander and his brother Isidore and their siblings, both of whom are saints, belonged to an elite family of Hispano-Roman stock of Carthago Nova (today known as Cartagena). Their father Severianus is believed to have been a dux (governor) of Cartagena, this seems more of a fanciful interpretation since Isidore simply states that he was a citizen. The family moved to Seville around 554.

Leander's own family was heavily influenced by the Arian heresy, but he himself

grew up to be a fervent Christian. He entered a monastery as a young man and spent three years in prayer and study. At the end of that tranquil period he was made a bishop. For the rest of his life he worked strenuously to fight against heresy.

In endeavoring to save his country from the heresy of Arianism, Leander showed himself an orthodox Christian and a far-sighted patriot. Exiled by King Leovigild who subscribed to the Arian heresy, Leander withdrew to Byzantium from 579 to 582. The death of the anti-Christian king helped Leander's cause. He and the new king worked hand in hand to restore orthodoxy and



a renewed sense of morality. Leander succeeded in persuading many Arian bishops to change their loyalties.

In this decisive hour for the future of Spain, Leander did most to ensure the religious unity, the fervent faith, and the broad culture on which was based its later greatness. At the Third Council of Toledo, where Visigothic Spain rejected Arianism, Leander delivered the closing sermon. On his return from this council, Leander convened

an important synod in his metropolitan city of Seville, and never afterwards ceased his efforts to consolidate the work, in which his brother and successor St. Isidore was to follow. Leander received the pallium (a woolen vestment conferred by the Pope on an Archbishop) in August, 599. Isidore wrote of his brother: "This man of suave eloquence and eminent talent shone as brightly by his virtues as by his doctrine. By his faith and zeal the Gothic people have been converted from Arianism to the Catholic faith."

Leander passed away on March 13, 600. The Feast Day of Saint Leander of Seville is March 13th

## **RMV ANNOUNCES**

Additional Licensure Deadline Extensions; Introduces Online CDL Renewal Option

School Bus Certificates, Driving School, Driving Instructor and Inspector Licenses to be Extended for 90 Days

Passenger and Motorcycle Road Tests Cancelled through May 4th

The Massachusetts Registry of Motor Vehicles (RMV) continues to thoroughly review its licensing protocols and credential requirements to identify additional measures that can be implemented to reduce non-essential travel, reduce the need for customers to visit RMV Service Centers, and ensure proper "social-distancing" can take place under Governor Charlie Baker's declaration of a State of Emergency the week of March 9<sup>th</sup>.

The following new changes to service delivery and organizational protocols are now or are about to be in place as follows:

Professional credentials for School Bus Certificates, School Pupil Transport Licenses (7D), Inspector Licenses, Driving Instructor Licenses and Driving School Licenses that have expired or are expiring, between March  $10^{\rm th}$  and April  $30^{\rm th}$ , will be extended for 90 days after the State of Emergency is lifted. These credentials should all be considered "active" as the RMV implements the system changes to reflect that status in the near future.

Commercial Driver's License (CDL) holders are now able to renew their licenses online if they are self-certified in the Non-Excepted Interstate (NI) category for medical certification.

All passenger and motorcycle road tests (Class D and Class M) have been cancelled through Monday, May 4, 2020.

Reminders About Other Previously Announced Changes:

Driver's licenses, ID cards, and Learner's Permits, including Commercial Driver's Licenses & Permits (CDL/CLP), that have expired or are expiring between March 1, 2020, and April 30, 2020, have had a 60-day extension applied to the current expiration date and do not need to be renewed at this time. Customers holding a license or ID marked "Limited-Term" that expired between March 1st and April 30th should visit: www.mass.gov/rmv for more information and to check the validity of their credential. CDL Medical Certificates that expire on or after March 1st until April 30th will be extended until June 30th to prevent license downgrades and elective medical visits, as well as alleviate demand on medical providers.

Due to the current COVID-19 pandemic, the RMV has implemented a strict no walk-in policy at a limited number of Service Centers that remain open to the general public. Service for necessary in-person transactions are available by appointment only. Customers should visit Mass.Gov/RMV to make a reservation at an open Service Center or find information on over 40 transactions that can be conducted online, by phone, or by mail.

Non-Classroom Drivers Education — through a temporary policy, the RMV is allowing driving schools to offer online driver education training and written testing during this emergency period only. The RMV will continuously monitor the current emergency and will keep you informed about the timeframe in which driving schools can offer alternative training.

Effective April 1, 2020, all of the passenger plate registrations that have expired in March or will be expiring in April have been extended for 60 days. Registrations that expired in March have been extended until May 31st, and registrations that expire in April have been extended until June 30th. Registration renewals can continue to be performed online at Mass.Gov/RMV during this time. Customers seeking to do so in-person will not be able to make an appointment and should delay their visit to a Service Center at this time.

The annual motor vehicle safety and emissions inspection stickers that expire on March 31st and April 30th have been extended 60 days and all motorcycles with inspection stickers originally set to expire on May 31st must be inspected by June 30th. The RMV is also extending the time during which newly registered vehicles must be inspected based on the purchase date.

Class D and M Learner's Permits knowledge exams have been suspended through May 4<sup>th</sup>. Commercial Learner's Permit tests are available to be taken at the Milford and Wilmington RMV Service Centers during normal business hours and commercial road tests continue to be conducted by the Massachusetts State Police.

Massachusetts State Police are still conducting road tests for Commercial Driver's Licenses (CDLs), but require anyone taking these road tests to bring and wear a mask or face covering for the entirety of the test.

The National Safety Council (NSC) and the RMV have previously announced the cancellation, through May  $4^{\rm th}$ , of the following Massachusetts in-person classroom driver safety classes: 8-hour Driver Retraining Program, 4-hour Driver Attitudinal Retraining Program and the 4-hour State Courts Against Road Rage (SCARR) Program. The RMV has temporarily approved an alternative way to deliver the statutorily required content in the form of an online course. For a limited time, participation in the online course will fulfill the in-person class requirement. Additional information is available at http://drive.nsc.org and impacted customers can expect to receive specific instructions directly from NSC.



## Designing a Beautiful Garden for You and the Pollinators

You don't need a prairie or large lot to attract and support pollinators. A meadow or informal, formal and even container gardens can bring in bees, butterflies and hummingbirds to help pollinate plants. It's just a matter of selecting the right plants, adjusting your maintenance practices, and skipping the pesticides.

Create your garden by converting a few square feet of lawn, garden bed or front yard into a pollinator-friendly garden. You may want to start by switching out part of an existing garden or container to more pollinator-friendly flowers.

Expand your planting options by converting a portion of your lawn into a pollinator garden. Outline the bed with a hose or rope. Remove the sod, add compost as needed to improve drainage and you'll be ready to plant.

Simplify and dress up your efforts by using an easy-toassemble raised garden kit like the Pollinator Garden Bed (gardeners.com). Its longlasting cedar planks slide into aluminum corners to create a hexagonal bed. Get creative while increasing the garden's size by adding additional sections to create a honeycomb or other interesting design.

Mark the outline of the raised bed you select. Cut the grass short and cover with newspaper. Set your raised bed in place and fill with a quality planting mix. Mulch four to six inches surrounding the raised bed for ease of mowing and to eliminate the need to hand trim.

Once your planting bed is prepared, you're ready to plant. Include single daisy-like blackeyed Susans, coneflowers, and asters that allow visiting insects to rest and warm when sipping on nectar or dining on pollen. Add a few tubular flowers for butterflies and hummingbirds.

They both like bright colors and can be seen visiting salvias, penstemon and nasturtiums. And don't forget the bees that are attracted to bright white, yellow, blue and ultraviolet colors. You'll find them visiting

next. Provide plants with enough space to reach their mature size. Temporarily fill in voids with annuals like salvia, single zinnias and nicotiana that also attract pollinators.

Don't let all the plant and design possibilities overwhelm you into inaction. Gardener's Supply Company has plans for designing gardens to attract bees, butterflies and hummingbirds plus tips on keeping them safe in your garden.

Mulch the soil with leaves annually. It suppresses weeds, conserves moisture, improves the soil and provides homes for many beneficial insects.

Allow healthy plants and grasses to stand for winter. These provide homes for many beneficial

insects and food for birds. Wait as long as possible to clean up your garden in spring. If needed, pile clippings out of the way to allow beneficial insects to escape these winter homes once summer.

### SOLDIERS' HOME CHIEF SAYS STATE KNEW ABOUT THE CRISIS

The suspended head of the Holyoke Soldiers' Home where 32 veterans have now passed away of a coronavirus outbreak is now alleging state officials were made aware of the severity of the crisis earlier than the state claims.

"There has been widespread reports in the media that state officials were kept in the dark about what was happening at the Soldiers' Home during the COVID-19 crisis," the superintendent Bennett Walsh said in a statement released through his lawyer. "These reports are false. Of the 32 deaths at the facility, 28 veterans tested positive for coronavirus. The outbreak spread to 69 home residents and 68 staff members."

Governor Baker in an April 8<sup>th</sup> press conference stated he was not notified of the deaths until March 29<sup>th</sup>. He added, "Since we were notified ... about the situation there, we moved quickly to install a new management team and a command center at the site the following morning."

Walsh claims the state was notified on March 27<sup>th</sup> that 28 veterans exhibiting signs of the virus had been tested. Of the 13 results received, 10 tested positive

Reportedly, there are now two probes looking into what happened, one appointed by the Governor and the other being run by the Feds. This is why no one anywhere in the media should be jumping to conclusions until all the facts assembled.

## Nanna & Babbononno

A Nostalgic Remembrance



I remember a conversation with Babbononno when he was in his 90s. He had been living with my folks in Belmont and hated every minute of it. Back in East Boston, he could buy a couple of stogies, and a copy of this newspaper, but neither was available in Belmont. There was no Central Square where he could meet with other Italians, no store front social clubs like the ones he frequented in both Eastie and the North End. If he wanted to speak Italian, there was only my mother at home most of the day. When I asked him about his friends, his answer was, "Sono tutti morti." (They are all dead) As I said, he was in his 90s, and I think his mid-90s, was when he moved back to East Boston.

Well, I'm getting to feel the same way. Thank God, I haven't lost all my friends. Most are aging but are still with us. I'm getting to feel the same way because I am stranded in Florida and I "wanna go home." I have yet to see my new grandson, Nathan, other than on Facetime. Son Michael returned from Hollywood a couple of weeks ago and has quarantined himself before he goes near his brother, John, or his family. John is working from home, as is most everyone who commutes to downtown Boston. Fortunately, he can perform his duties on computer.

Loretta and I are staying home and can't really do anything. The only places open are gas stations, drug stores, supermarkets, and dollar stores that sell food. Thinking of gas stations, I saw one with a price of \$1.65 9/10s for regular. That's pretty good, but I don't know the prices back home. My bocce team has disbanded for the duration. My cigar crowd has disbanded for the duration. My card game has disbanded for the duration and if we want to eat out, we can't. Last night we were in the mood for real downhome southern ribs. I went to a soul food restaurant and had to order from my car window yelling through a microphone. When I reached a takeout window, my order was ready. I felt like I was at McDonald's, not Troy's Barbecue. But, it's the same everywhere down here. When I spoke to Dean Saluti and John Silva, they told me it's the same back home ... no gatherings ... just take out or curb service.

I think that the most important aspect of the problem for us thus far is that, if we wanted to come home, we can't. As a result, I think we will hang around until sometime in June, and then see what the climate is regarding the coronavirus is like then. I could make a prediction, but I've been wrong so far. Therefore, I'll keep my mouth shut.

The one thing I'm attending is physical therapy. The location is still open and I am in the gym one day a week and the pool two days a week. As a result of the scare, I am one of the few people still active at the therapy

center. Due to their efforts, I am now walking without the assistance of a cane. I keep one in the car just in case, but so far, I haven't needed it. I feel bad for my wife, John Silva and Dean Saluti. All three are still teaching at Cambridge College and everything is now on line. When you can't face students in a classroom, it's a whole different ballgame. Dean is actually teaching at several colleges and it is the same thing ... courses on line.

Other than writing my next book, Nanna and Babbononno, I am arranging music. I bought an electric piano and use it for putting music together for the trio I am part of here in Florida. It consists of piano, guitar and bass guitar (me). I have a book with about 1,000 songs from the turn of the 20th century to the 1950s and am arranging medleys of two to three tunes that are familiar to everyone over 50. I have even thrown in a couple of arrangements from the tunes made popular by Duke Ellington, Count Basie, Glenn Miller, and Benny Goodman. I hope we get to try them out before I come home.

Son Michael is home, as I mentioned already. He insists that we stay here until it's safe to travel. Optimistically, I think we're (stuck) here until sometime in June. When I get back, the first place I am going to visit (for dinner) is La Summa's, on Fleet Street in the North End. Barbara Summa makes the dishes I like just the way Nanna used to make them and I can hardly wait. The second place I want to hit is my favorite Chinese restaurant, and that is in Arlington Heights. They try hard down here, but Chinese food in Florida leaves a lot to be desired. Actually, being a purist when it comes to Chinese food, the only places that have the best restaurants are Boston, New York, and San Francisco ... that's it.

After I have my fill of Italian and Chinese food, I want to drive my antique cars. I have three of them and they are just collecting dust until I get home. Bill Strachman of Allston Custom Garage has put my everyday car in perfect working order, and I can't wait to get behind the wheel to test it out. We keep a 10-year-old Chrysler convertible down here, but I miss my antique toys, an old Lincoln with suicide doors, a Thunderbird, and a Mercedes Benz 450 SL, with a big engine. I was thinking of shipping one or more down to Florida, but I don't have a garage, and without one, I may have a rust bucket on my hands in short order. Those old cars are all metal and the tropical climate and old metal don't get along.

Don't get me wrong, I'm not complaining. I just wanted to let you know what's going on. As a result of not being able to eat out, Loretta has been cooking dinner, something she really hasn't had time to do since the boys were home, and that's a long time ago. As long as she

stays healthy I won't worry, but, in reality, I am worried about this virus. I pray that it doesn't spread and include members of my family. I think most, if not all of you, feel the same way.

I remember stories I heard from Babbononno and Dad about the influenza epidemic that hit the U.S. in 1918. It was called the H1N1virus and killed 50 million worldwide and 675,000 in United States, including my father's younger sister. The virus came to an end and both sides of my family survived except Dad's younger sister as I indicated earlier.

We were going to take a cruise last week with some friends. We had planned to head through the Panama Canal, then back to visit Colombia and the Dutch West Indies island of Aruba. All of that was postponed until next winter. Loretta was refunded the cost of the trip and had a new patio built out back. It's gorgeous and I love sitting out in the sunshine, hopefully staying healthy. If I begin to perspire, Loretta will have to squirt the garden hose on me ... they closed the pool, too. Stay healthy.

Torta della Nonna, or Grandmother's Cake is considered an old-fashioned classic in Italy. With strong connections to Tuscany, this short-crusted lemon custard tart can be found in patisseries and restaurants across the land. Its name may suggest it originated in a Nonna's kitchen, but it did not. Reportedly, it was a Florentine chef



named Guido Samorini who initially created the *Torta della Nonna*. Patrons in his restaurant loved it, and the recipe has since lived on. It's a dessert that's impressive enough to be served in a restaurant, and simple enough to make at home. Its comforting effect makes it feel as though the loving hands of a Nonna created it.

I am sharing my family's recipe for *Torta della Nonna* this week in remembrance of my own Nonna Mary. She was 97 years old when she left us, and if she were still here April 15<sup>th</sup>, would have been her 100<sup>th</sup> birthday. Without her beautiful Sicilian soul, I wouldn't have recipes to share, nor the skills to put them together. My Nonna was an amazing cook and baker, and from a little girl she taught me everything I know. I remember making apple squares with her from apples we picked in the yard, rolling gnocchi on the tines of a fork, and even taking homemade wine and creating wine biscuits. Italian Nonna's are truly gifts that come from above. Even when the day comes that they are no longer with us, they never really leave, their legacy carries on and they live forever in our hearts. *Ricordando mia nonna con amore* ...

### **GRANDMOTHER'S CAKE**

#### Torta della Nonna

#### SHORTCRUST

3 cups '00 or all-purpose flour 14 tablespoons cold butter, cut into pieces 2 eggs, room temperature 2/3 cup sugar Zest of 1 organic lemon

### **CUSTARD**

3 cups whole milk
Peel of 1 organic lemon
3 eggs, and 1 egg yolk, room
temperature
1 ½ cup sugar
1 tablespoon vanilla
¼ cup corn starch
3 tablespoons '00 or allpurpose flour
4 ounces pine nuts
Powdered sugar

To make crust, place flour and butter in food processor, pulse until well combined. Pour mixture onto a dough board, make a well in center and add eggs, sugar, and lemon zest. Mix by hand to form dough, wrap in plastic wrap, and refrigerate for 30 minutes.

To make custard, place milk and lemon peel in a medium sauce-pan, simmer until almost boiling. At the same time, in a large mixing bowl, crack eggs and egg yolk, add sugar, vanilla, and beat well. While beating, sift in corn starch and flour. Remove pan of milk from heat, discard lemon peel. Add a little bit of the hot milk to the egg mixture, while whisking. Place pan of milk back on stove, add entire egg mixture to the pan of milk and whisk while cooking on low to medium heat. Continue whisking for about 10-15 minutes, or until custard thickens. Remove from heat, place custard in heat-proof bowl, cover with plastic wrap, and cool at room temperature.

Grease and flour a 9 1/2 or 10 inch fluted tart mold with removable bottom, set aside. Preheat oven to 325°. Remove dough from refrigerator, cut in half and roll into two circles. Take one circle and press into prepared tart pan. Prick the bottom of the dough with a fork, add the cooled custard. Take the other circle of dough and completely place over top of tart or cut dough into lattice strips (as I prefer to do) and place over top of custard. Sprinkle with pine nuts and bake in preheated oven for about 45-50 minutes (if you notice edges of crust start to darken, cover with foil). Raise heat to 350° and bake an additional 10-15 minutes, or until golden colored, and custard appears set. Cool completely, sprinkle with powdered sugar and serve. Refrigerate leftovers.

There are hundreds of great fights that are well



### HOOPS and HOCKEY in the HUB

One doesn't hear it as much anymore. Perhaps once a year at most.

It has a long legacy but over the course of the most recent decade, few children have heard it very often. It is, of course, the chant, the cheer, the call that once resounded through the Garden on a regular basis — "Beat L.A."

Its origins date back to when the famed Minneapolis Lakers, following the example of baseball's Brooklyn Dodgers, pulled up their Midwestern stakes and moved west, away from the frozen winter land of Minnesota to the warm sunshine of southern California and its principal city, Los Angeles.

And the Lakers top draft pick in the 1960 NBA draft went with them. In a way, maybe it was his destiny. After all, Jerry West had been writing that word all his life. Not only was West his family name, but he had grown up in West Virginia and had played his college ball at West Virginia University. In the 19th century, there was a saying: "Go west, young man, go west and grow up with the country." And in his own time, a century later, that is exactly what Jerome Alan West did.

But West didn't just go in that direction. He also went up. Soar is what he did. Physically, he was 6-3 but when he jumped, his hands went 16 inches above the rim, outstanding for a former college forward, now playing the guard position in the NBA. It was hard to believe that as a youngster, he actually had needed vitamin injections. Teamed with Elgin Baylor, success was on the way for the Lakers — to a point.

Although the two teams first met in the Finals in 1959, it was during his first decade with the team that the rivalry would take hold, put down its roots and grow strong. From 1962 to 1969, the Celtics and the Lakers would meet in the Finals six times and the Celtics would win them all — with three of those memorable series (1962, 1966, and 1969) going the full seven

In their first playoff matchup of the decade (1962), the Celtics and the Lakers would provide a preview. The teams split the first two games at the Garden. L.A. then won Game three in dramatic fashion when West stole the ball from Sam Jones and scored a winning basket at the buzzer.

However, it was Jones who would make the decisive plays that would give the Celtics the championship. For when the Lakers' Frank Selvy missed an eight-foot shot with seconds remaining in Game 7, it was Jones who blocked Baylor's tipin attempt as time expired. And it was Jones who hit several baskets in overtime to give the Green and White the title.

The two teams were back at it again in the 1963 Finals, but West was not himself. While he had averaged 27.6 points, 7.0 rebounds, and 5.6 assists across 55 regular season games, he had missed

the final seven weeks of the regular season with a hamstring injury. The Celtics won in a deciding game 6 by a 112-109 count in the Los Angeles Sports Arena. It was Bob Cousy's final game of his Celtics career — and he went out a champion, throwing the ball high in the air in celebration as time expired.

In the 1965 NBA Finals, the rivalry resumed, but it was a somewhat lopsided affair this time with the C's claiming the crown by winning the series, 4-1. Baylor had suffered a knee injury in the first round of the playoffs. K.C. Jones was assigned to guard West in the first game and kept him down somewhat — to "only" 26 points. West came back with a 43-point performance in Game 2, but the Celtics still came out on top 129-123. West poured in 49 tallies as L.A. won Game 3, but the Celtics put the brakes on any hope of a comeback, winning what proved to be the final two games by wide margins. In the final quarter of Game 5, West went uncommonly cold, missing 14 of 15 shots.

The 1966 Finals became famous for what was stated, not how the games were played. After the Lakers took Game 1, legendary Celtics Coach Red Auerbach announced his intention to retire after the playoffs with star Bill Russell assuming the role of playercoach the following season. The Celtics won the next three games, L.A. captured the following pair to send the series to a seventh game. The C's raced out to a huge lead, held off a late L.A. rally and clinched the championship.

In 1968, the teams alternated victories for the first four games. The turning point was Game 5, which the Celtics won in overtime. The C's then closed out the Lakers in Game 6 124-109 for Bill Russell's first championship as a coach.

The year 1969 would not only close out the decade but also put a lid on the rivalry until the 1980s and the coming of the Larry Bird era. The series was memorable for what L.A. owner Jack Kent Cooke did. With the series tied at 3-3, he placed a notice on every seat in the L.A. Forum advertising a post-game victory celebration in the building.

The Celtics received a copy and the rest is history. Wilt Chamberlain, acquired from Philadelphia in the previous off-season by L.A., was injured early in Game 7 and never reentered the contest, despite his pleading with the coaching staff. The Celtics won 108-106 and there was a celebration — 3,000 miles to the east in Boston.

West would go on to win a championship with the Lakers in 1972, and later coached the team for three years before becoming its general manager. The Celtics won two NBA championships in the 1970s. The rivalry with the Lakers would not resume until the 1980s.
