They Think Gay Marriage Already Won







The Blow Given to Boston Smote on Every Patriotic Heart

"In that day of general affection and brotherhood, the blow given to Boston smote on every patriotic heart from one end of the country to the other. Virginia and the Carolinas, as well as Connecticut and New Hampshire, felt and proclaimed the cause to be their own ... Congress ... expressed its sympathy for the suffering inhabitants of Boston and addresses were received from all quarters, assuring them that the cause was a common one, and should be met by common efforts and common sacrifices."

Obama say on television: "Boston is a tough and resilient town, so are its people. I am supremely confident that Bostonians will pull together, take care of each other and move forward as one proud city and as they do, the American people will be with them every single step of the way."

As I write, we do not know the who or why of the 2013 Boston Marathon Terror Bombing. We know that, as always, the American people will come together. That uncounted multitudes of volunteers will step forward assist the victims and their families. And that the culprits will be found and justice will be done.

HHS Announces New Partnership with Law Enforcement to Help Prevent Sale of EBT Prohibited Items

Partnership Gives Local Law Enforcement New Tools; Enhances Program Integrity and Data Sharing

Massachusetts Health and Human Services Secretary John Polanowicz announced a new partnership with statewide law enforcement associations to increase data sharing, while giving local police the tools they need to ensure that clients and retailers are abiding by the law. The announcement builds on the Department of Transitional Assistance (DTA) 100 day Bridge to Stability action plan announced last month and helps protect benefits for clients who truly need them.

The new partnership includes the Massachusetts Chiefs of Police Association (MCOPA) and the Massachusetts Major City Chiefs Association (MMCC).

"We're giving local law enforcement the data and information they need to ensure that clients and retailers are abiding by the law," said Secretary Polanowicz. "This partnership is an important step forward for DTA, and it will help us protect benefits for those who need them as a bridge to stability during tough times."

Secretary Polanowicz was joined by Chelsea Police Chief and Vice President of the MMCC, Brian Kyes, DTA's 100 day action plan, Everett Police Chief Steven Mazzie, DTA Interim Commissioner Stacey Monahan, and DTA program integrity personnel at the State House Steps today for the announcement.

As part of the 100 day action plan, DTA has launched bi-weekly monitoring of ATM and point of sale withdrawals to identify any purchases made at prohibited establishments. DTA staff members are monitoring where transactions are located and visiting potentially prohibited establishments, such as stores that sell liquor. Under the new agreement, the Department will share this data with local law enforcement so they can investigate and prevent the sale of prohibited items and the use of EBT cards at prohibited establishments.

"The Massachusetts Chiefs of Police Association are pleased to partner with the Department of Transitional Assistance to ensure that clients and retailers are abiding by the law," said Chief Wayne Sampson, executive director of the MCOPA. "Our participation will help provide the DTA with the necessary evidence to take action against those who intentionally violate the law."

DTA is also working in collaboration with MCOPA, MMCC, and other law enforcement in cities and towns throughout Massachusetts on trainings on the EBT restrictions signed into law by Governor Deval Patrick last year. The law prohibits the use of cash assistance at certain locations and for certain items.

The partnership builds off which was launched last month to enhance program integrity, restore public trust in DTA's critical programs, and improve services for clients.

To date, DTA has notified more than 78,000 cash clients and approximately 22,000 individual retail establishments through 38 vendor associations, outlining the prohibited items, establishments and penalties for restricted purchases listed under the law.

DTA is in the process of implementing the blockage of ATM and Point Of Sale transactions for cash assistance clients at prohibited establishments and that is expected to be completed by October 2013.

DTA began charging cash clients a \$5 fee for replacement EBT cards in December 2012. In total, more than \$22,000 has been collected through the end of March 2013 and preliminary research shows a reduction of 28 percent in card replacements during that time. USDA has also granted DTA approval to charge SNAP clients a replacement fee and DTA will be implementing this charge in the coming weeks.

The 100 day plan incorporates established best practices, brings increased oversight and training to the Department, and moves forward with technological enhancements to address issues raised by the offices of the Inspector General, the State Auditor and federal regulators. The plan also takes proactive steps to prevent fraud and abuse, block EBT card usage at prohibited establishments and increase investigation and enforcement of SNAP trafficking.

DTA has also launched statewide Bridge to Stability listening sessions, to gain public input on strengthening client services.

DTA serves one in eight people in the Commonwealth and ensures that the emergency and transitional needs of the individuals and families are met through federal and state-funded benefits, such as Supplemental Nutritional Assistance and cash assistance.

Boston Marathon Explosions

On Monday April 15th, Patriots' Day, two explosions near the finish line of the Boston Marathon which is held annually and brings in people from all over the country, took the lives of three people and left more than 170 injured.

The explosions took place about 10 seconds and 100 yards apart from each other, at 2:50 pm and they were caused by homemade bombs. As reported by CBS, law enforcement is thinking that the bombs were made to look like discarded objects that could have been on the sidewalk or inside garbage cans.

Mike Sienkiewizz from Milton was attending a Mercedes Party at stake house Abe & Louis on 793 Boylston Streetwhen he heard the explosions. He said that he saw mass confusion, "shoes, legs, and limbs." Restaurant staff ushered people through the backdoor and they were told to leave through Newbury :Street. He was concerned that there might have been a third explosion.

During the immediate aftermath a lot of misinformation started to be reported. Fear was palpable throughout the city as people scrambled to call loved ones and try to understand what were no other bombs that to run towards the chaos and rorists win.

needed disarming, as it was initially thought, and that the only two explosives found were those that exploded.

So far, there is no knowledge of who made the bombs or the motives, but Boston and other major cities such as New York and Washington have been taking extra security measures to protect their citizens. Also, countless videos and photos taken on smart phones and other such devices by those in attendance are all valuable evidence that the FBI is examining.

By now, everyone knows the bombs had ball bearings to cause maximum damage. It's all over the news what type of bombs they were, how they were made and speculations about where they were placed. All of this is very important, but I don't want to write more on that. I want to write about kindness and bravery.

In spite of this tragedy, there is something to be said about the way people reacted. Countless videos and photos were taken showing heroic responses to danger. People made tourniquets from their own clothes, runners kept on running to hospitals so that they could give blood, those present helped out any way they could. As President Obama said, "the American people refuse to be terrorized. Because what the world saw vesterday (Monday April 15th) in the aftermath of the explosions were stories of heroism and kindness, and generosity and love ... So if you want to know who we are, what America is, how we respond to evil — that's it. Selflessly. Compassionately. Unafraid."

Humans are good. People stick together and show solidarity. Whoever caused this attack of terrorism, be it a group or one single person is nothing in comparison to the mass amount of caring and goodness that exists in the world and especially in our city of Boston.

In the following days after this tragedy Bostonians have shown courage and strength. Business is being conducted as usual; citizens of this great city refuse to let fear run their lives. In the words of Michael Leiter, and NBC News national security analyst, "you just have to do the best you can to keep people safe and maintain resilience." he said. "It's important we don't alter our lives because that provides the terrorist - domestic, international, whoever it may be - with a huge victory."

When I first frantically I can see it whenever I pick up one of the city's celebrated newspapers and magazines or tune into Chronicle and constantly become amazed at the new innovations and attractions Boston has to offer. I feel this character whenever I hear about how Boston's hospitals groundbreakers in the field of medicine and how its universities educate millions from around the world. American Union regiment, departed to Southern battlefields with courage rippling through their veins. It is here that university students in the 1960s protested against war and pollution and human injustices. With this spirit comes fierce loyalty: something has to be said for a city that never failed to support a scrappy, loveable baseball team which made millions of dreams soar when they won the long-awaited World Championships in 2004 and 2007. I know that this spirit will help us continue to serve as an inspiration to people around the world.

I love Boston because of its

diversity. The North End neighborhood long contributed to my sense of pride as an Italian-American. In this neighborhood, I gulped down Nutella-flavored gelato on hot summer nights and stepped into rickety little shops to buy Christmas panettone with my father. There's also South Boston, with its Irish pubs and where I spent many brisk days walking through the green paths of Castle Island. 

Saint Anselm

Saint Anselm was born Anselmo de Candia Ginevra in the Aosta valley region of Italy in 1033. He was born of noble parentage; his father was Gundulf de Candia, his mother, Ermenberga of Geneva.

Anselm was educated in Normandy. At the age of 27, he became a Benedictine monk at the monastery of Bec, he studied under the renowned Lamfranc. Prior of the monastery, whose abbot was Herluin. Anselm was made Prior in 1063 and Abbot in 1078 upon the death of Herluin. Under his leadership, Bec became one of the foremost seats of learning in Europe. While Abbot, Anselm made a number of visits to England in the interest of his abbey. Having become known and well regarded in England, he succeeded his old friend and teacher Lanfranck as Archbishop of Canterbury on December 4, 1093.



Anselm is often called the father of scholasticism and has been a major influence in Western theology. He is characterized by his spirit of recollection which he was able to maintain even in the most distracting situations, and by the bent of his mind, which was concerned with things transcendent and spiritual.

Anselm resisted the injustices from the rule of King William Rufus, son of William the Conqueror, which in 1720; his feast is celattracted the anger of the ebrated on April 21st.

king and he was exiled from England from 1097-1100. He journeyed to Rome then journeyed to Calabria where he spent time in a monastery; it was there that he composed his work on the Incarnation. It was during this period that he wrote several of his metaphysical works. Anselm did not return to Canterbury until the death of King William in 1100. He once again experienced difficulties with the new king, Henry I who required Anselm to be reinvested by him. Anselm refused and was exiled from 1105-1106. Anselm journeyed to Rome where his authority as Archbishop of Canterbury was upheld by Pope Paschal II. He returned to England in 1106 where he died in 1109.



Simple *TIMES*...

Ruth Harriet Jacobs never met me until Palm Sunday last month as my twin brother and I visited our 93-year-old friend Armando, whom I introduced to you in this column three years ago. You've since learned more about the educator and World War II hero in a previous column. Ruth resides in the assisted living facility in Weston where Armando and his wife live.

I've met many wonderful folks from America's Greatest Generation since visiting Armando after he moved from his Newton home two years ago to the campy atmosphere of wingback chairs, cozy couches stuffed with pillows, delicately decorated plates fill China closets, fresh flowers adorn large shiny oak tables as a few Grandfather clocks sprinkle the sprawling common rooms of the main floor.

Ruth is one such wonderful woman Armando eagerly introduced to me. "Meet my good friend. He's a writer, too." Ruth smiled, asked me my name and then gestured me to move closer so her large specially made eyeglasses could adjust her dimming vision.

Her lifelong penchant for reading books, magazines, newspapers and other publications scattered atop the teakwood tables has Ruth struggling to read small-print with a magnifying glass that she carries in a cloth satchel hanging from her sturdy walker.

"I started my career at 17 as a copy girl in 1943 writing stories about the boys returning to America from Europe," she proudly recalled. "I had just graduated high school and because men, who were the reporters and editors at news-

papers during those days, went off to war, I got hired on the spot at the Boston Herald Traveler." She earned \$28.00 a week and took courses at night at Boston University.

Born in 1924 in Roxbury to a Jewish family, Ruth was the first in her family to attend college. "My maternal grandparents raised my brother and I after my mother died at age 32. I was 10 and my brother was three. I gave my grandmother money to help with costs of raising my brother," she explained.

Her writing interests sprang from being co-editor of her high school yearbook. She then worked for the newspaper one year. "I wrote feature stories and earned more money than seasoned reporters. When I turned eighteen, I began writing feature articles, which paid me by the inch. That meant even more money weekly," Ruth fondly remembered.

Ruth interviewed some of the giants in 20th century history: Winston Churchill, Franklin D. Roosevelt and Eleanor Roosevelt, Dwight D. Eisenhower, John F. Kennedy; Mass. Gov. Maurice J. Tobin, and longtime Boston Mayor James Michael Curley. She also covered presidential conventions and national elections for the daily newspaper.

"I'd meet the boats arriving in Boston Harbor that carried injured and dead soldiers. It was shocking to see these men in terrible situations get carried off on stretchers. I also wrote the obituaries of dead soldiers. The awful part of my job was to go to the homes of deceased soldiers and bring the families bad news. I hated it," she said.

Shortly after marrying in 1949, Ruth left the Boston Herald Traveler because of a problem pregnancy. Her doctor advised her to leave the newspaper. She continued freelance writing from home and wrote children's articles. When her two children began school, Ruth

returned to Boston University and earned an undergraduate degree in three years. Years later, she also earned a doctorate in Gerontology from Brandeis University. Ruth is author of nine books.

Ruth taught at Clark University during the Vietnam War. "A lot of men went to college on the G.I. Bill. I learned from them about Post-Traumatic Stress, which was different from the soldiers I met during World War Two," she recalled. "I wrote a feature story about PTSD with another reporter." After leaving Clark, Ruth taught at Regis College. She also lectured as a senior scholar at Wellesley Centers for Women at Wellesley College.

At age 60, Ruth became a Quaker. "I worked with people in the Peace Movement during the Vietnam War. I hung out with other people in the anti-war demonstrations. Most protesters were Quaker. My children supported my peace activism," she adds. "I never abandoned my Jewish heritage. You don't resign from the people who went through the Holocaust."

She steered the conversation towards the present with an educator's instructive tone. "I hate the thought that as I near the end of my life there's these wars (in Afghanistan and Iraq). Do what you can to work for peace."

Ruth swiftly returned to reminiscing about the vagaries of a copy girl working within a largely male profession who, out of necessity, got assigned to write stories about soldiers. She narrows her large blue eyes, leans forward and impishly reveals: "I was the most kissed woman in the world!" Spontaneous laughter echoed across the quiet large room.

Ruth lay back into her comfy chair staring beyond three French doors leading to an outdoor deck, heartily laughing as though she's still was that 17-year-old copy girl.

for nearly a decade, cocurated the flagship reading series of the New York Citybased louderARTS Project. She appeared on both the second and fifth seasons of HBO's *Def Poetry Jam.* She returned to Chicago in 2009 to co-found Vox Ferus, an organization dedicated to empowering and energizing individuals and communities through the written and spoken word.

A member of seven National Poetry Slam teams representing New York City and Chicago, McConnell is the 2012 National Underground Poetry Individual Competition (NUPIC) Champion. In 2011, she completed her first European tour and debuted her one-woman show, "Vicebox." She is a two-time recipient of the Community Arts Assistance Program grant from the City of Chicago's Office of Tourism and Culture, and received a 2013 grant from the Illinois Arts Council.

The Boston Poetry Slam kicked off in May of 1991, imported directly from slam's birthplace, Chicago, by Michael Brown and Patricia Smith. The slam first started at T.T. the Bear's in Central Square in Cambridge, MA, as an addon to the existing reading

Stone Soup, the longest-running poetry reading in Cambridge. The slam migrated to the Book Cellar in Porter Square later that year and in January of 1992 expanded to a twice-weekly schedule in order to accommodate the burgeoning popularity of the event. When the Cantab Lounge became one of seven hosts for the International Poetry Slam, the Wednesday show settled into its sincepermanent location on October 16, 1992, making the Cantab home to one of the three oldest slams in the world and a fixture of the international poetry scene.

The Boston Poetry Slam ran on Wednesdays and Fridays at the Cantab Lounge from 1992 to 1995, when poetry slam began to take a back seat to the venue's signature open mic. Praised as "the best open mic in the English-speaking world," the now Wednesday-only open began to shine as a mecca for touring performance poets and local readers alike. The historic head-to-head 8x8 series and Champion of Champions slam events were moved to the latest portion of the evening, which added yet another qualification for the many talented poets seeking a prestigious Cantab slam win: the willingness to close the bar on

a Wednesday night. In 2004, Michael Brown stepped down from the position of SlamMaster, turning the post over to 2001 slam team member and then-Champion of Champions Simone Beaubien. The weekly Wednesday show continues to thrive, acting as a hub for the New England performance poetry scene and consistently drawing highquality featured poets and up-and-coming slammers. In recent news, the Boston Poetry Slam served as the Host City Slam for the highly successful 2011 National Poetry Slam and will be honored to host again for the 2013 National Poetry Slam.

Boston has been represented in competition at every National Poetry Slam since 1991 and every Individual World Poetry Slam since 2004, winning team championships in 1992 and 1993 and sending a total of six teams and nine individuals to the Finals stage. Ready for this? Diet drinks tied to depression! Older adults who drink at least four servings a day of artificially sweetened soft drinks boost their chances of getting the blues by 31 percent, says a shocking new study. Those who drink sugar sweetened drinks don't fare much better, increasing their odds of being depressed by 22 percent, according to the research released by the American Academy of Neurology. But seniors who drink coffee slash their risk of depression by 10 percent.

Gee, soup really does fight the flu! Mom was right all along — chicken soup really does help battle flu and colds. In research published in the American Journal of Therapeutics, scientists found carnosine, a compound found in chicken soup, strengthens the immune system in the early stages of the flu. Both homemade and canned varieties work. Previous studies have shown that chicken soup eases congestion and improves the ability of cilia in the nostrils to prevent viruses from entering the body.

For you basketball lovers! Dan Biasone invented basketball's 24-second clock in 1954, an invention that many credit with creating the game we know today. Reminder! Assisting others can safeguard your health and make you live longer, reveals a study published by the American Journal of Public Health. The year-long research shows those who lent a helping hand to others were less likely to die than those who hadn't. "Our conclusion was, helping others reduced mortality specifically by buffering the association between stress and mortality," says study spearhead Dr. Michael J. Poulin, of the University of Buffalo. Good advice!

In a promising advance, scientists have discovered a potential benefit of a molecule in green tea that can prevent changes in the brain associated with Alzheimer's disease. The onset of Alzheimer's is linked to the formation of protein-based amyloid plaques in the brain. But a study conducted by University of Michigan researchers found that the green tea molecule called EGCG, not only prevented formation of this plaque, it also broke down existing ones. "A lot of people are very excited about this molecule," says UM expert Mi Hee Lim. These initial lab findings are encouraging and have paved the way for further research.

Time for a spot of tea.

More healthy advice! Warning! Ordinary table salt could be a key factor behind an increase in autoimmune diseases, including multiple sclerosis. Western diets all have high salt content and that has led to an increase in hypertension and perhaps autoimmune disease as well, notes Dr. David Hafler, chairman of Yale's neurology department. So cut down on using salt!

Wait! More good advice! Exercise and you'll sleep better! Vigorous exercisers are almost twice as likely as non-exercisers to enjoy a good night's sleep almost every night, according to a new poll by the National Sleep Foundation. Lack of sleep affected couch potatoes more than their exercising counterparts. And the risk of sleep apnea, when breathing stops and starts repeatedly during sleep, was twice as high among non-exercisers. "If you are inactive, adding a 10-minute walk every day could improve your likelihood of a good night's sleep," says sleep researcher Max Hirshkowitz. Work your way up to running and swimming for even better results. Buona notte.

LENTIL SOUP

- 2 cups lentils
- 4 cups of water
- 1 medium onion chopped
- 1 1/2 cups chopped carrots (optional)
- 1 1/2 cups diced celery (optional)
- 1 clove garlic (optional)* 2 tablespoons canola oil or
- olive oil 1 cup small shells or elbow
- macaroni

Wash lentils. Combine first five ingredients in a large saucepan. Add chopped carrots and diced celery (optional). Bring to a boil. Cover and reduce heat to prevent boiling over. Stir frequently. Add more liquid as needed. Salt to taste. Oil is added just before lentils are fully cooked. Cooking time about 40 minutes.


*For a different flavor, add one clove of chopped garlic to lentils while cooking.

Follow directions on package to cook pasta of choice. Add lentils to cooked pasta and serve.

Lentil soup freezes well.



Nanna & Babbononno

by John Christoforo



A Nostalgic Remembrance

Babbononno's taste in music ranged from classical to opera. For years, every Saturday, Babbononno would sit by the radio in his bedroom and listen to Deems Taylor broadcasting from the Metropolitan Opera in New York. My grandfather loved Italian opera. To him Italian was the only language opera should be written in. When asked about opera he would comment that German, Spanish, French and English didn't lend themselves to this art form. Then he would add, "Even Mozart had the good sense to write his operas in

When Nanna and Babbononno sold the big house on Eutaw Street in East Boston, they moved into an apartment on Princeton Street, a ten minute walk away. There was an alcove off the living room that my grandfather made into a den. Against a wall centered between a couch and a TV, stood the family's old Victrola. It was the type that was new in the 1920s with a crank handle that wound up an internal spring which allowed the records to spin around. It was probably bought when my mother and uncles were young and left abandoned when record players became electric. At times, when Babbononno wasn't busy, he would play the 12 inch (not the 10 inch) 78 rpm speed records he had purchased decades earlier ... all of them were either classical or opera. His favorites were the operas from the pens of the greatest of Italian composers, Verde, Puccini, Leoncavallo, Monteverdi, Scarlatti, Rossini, Donizetti and Mascagni. Many of his old records featured the voices of Caruso or Gigli and were recorded in Italy. By this point in time, the records were old and scratchy but Babbononno didn't care. He listened to them with love and dedication whenever he could.

As a child, I watched my grandfather operate his record player and when the music from William Tell by Rossini, especially the overture. Once Babbononno caught me playing this composition on his record player and thought I was watching the Lone Ranger on TV, as both the radio and TV series used this as the background music

From my late teen years on, Babbononno and I would have differing opinions on the great Italian tenors. He, of course, was a fan of Caruso. I loved the voice of Lanza. Babbononno used to call him a sellout for going to Hollywood instead of staying with opera. His voice would send shivers up and down my spine especially when I would listen to his rendition of Ave Maria. Maybe Babbononno felt the same way about Caruso.

Even though he played with a band that specialized in Neapolitan pop music, he would always condemn American pop music, especially the music of the swing bands. He was proud of the fact that one of his sons (Uncle Nick) and his son-inlaw (Dad) played with some famous big band leaders, but he claimed the music was junk. He would leave out the music of Glenn Miller when he would condemn the swing style, because the arranger for much of Miller's music and a few of the compositions were penned by Jerry Gray, an East Bostonian whose real last name was Graziano. Once, when I was a kid, I came home from school early and found Babbononno and Nanna sitting in the den listening to a big band playing Jersey Bounce, a pop tune back during WWII. When I peeked in the den, Babbononno's foot was tapping the floor in time with the rhythm. When my grandfather saw me he became flustered and told me that the only reason he was listening was that Uncle Nick was playing clarinet with the band. I found out later that the band was that of Andre Kostelanetz and it was the U.S. Navy Band stationed in Newport, RI during WWII. Uncle Nick was a Petty Officer First Class and in the reed section of the band.

When the mid 1950s came along, I was in my teens and going from junior high school to high school. There was a new type of music that had grown out of rhythm and he wasn't around, I played blues and it was called rock his records. My favorite was and roll. I loved it and would listen to the DJs that played it, especially Symphony Sid (remember him???) and Bill Marlowe who I would become friendly with years later. I bought a record machine that played 45 rpm records and went crazy every Friday when I got paid from the Seville Theater. I would stop by

Central Music on Bennington Street and pick up songs like Rock Around the Clock by Bill Haley and the Comets, Tutti Frutti by Little Richard, Sha-Boom by the Chords and everything that Chuck Berry sang.

Not only did Babbononno hate the music, but I had my go rounds with Dad also. I reminded my father about how his father felt about the Dixieland and swing music that he played, but my father would say that it was a different story and it was real music not the junk the rock and rollers were playing. I think that this was the only time in my life that I was defiant. I loved the new music and learned to dance to it rather well. My friends and I would go to record hops almost every Friday night. I didn't work on Friday nights and we headed to whatever location featured a band or someone spinning records. After I turned 16 and got my driver's license, I would borrow Dad's car, get a date and find whatever station was playing the Platters and hope the music would turn on the girl sitting next to me. Whenever I see the TV re-runs of American Graffitti, I reminisce about those teen years spent listening and dancing to rock and roll, the girls with the poodle skirts and Arnie Woo Woo Ginsberg playing the music we loved.

For me, the music of the day lasted just a few years. Once I became a musician, I concentrated on classical and jazz, but to make money, worked with bands that catered to weddings, parties, Christenings and Bar Mitzvahs. My rock and roll changed when the Beetles invaded America. I didn't care for their musicianship but did like what they wrote. But, by the time they arrived, I was playing mostly jazz or leading a band for the Bob Blasser Show locally or on TV in Providence.

My mother, during my formative years was still buying records. She loved the swing bands and the singers that recorded with them. So, during WWII, I listened to Bing Crosby, Frank Sinatra (and for many years after), Ella Fitzgerald, the Andrew Sisters and Helen O'Connell and Bob Eberly when they were with the Dorseys. There were many others too numerous to mention and Babbononno hated every one of them or so he said. I guess music, like comedy, is generational and I guess we've had our day.



EINSTEIN'S THEORY OF RELATIVITY (E=MC^2): WAS IT AN ITALIAN IDEA? The mathematical equation that ushered in the Atomic Age was a discovery by an Italian dilettante mathematician and made public years before Albert Einstein used it in a developing theory of relativity. Olindo (Olinto) De Pretto, an industrialist from Vicenza published the equation (E=MC^2) in a scientific magazine, ATTE in 1903, as related by the Italian mathematical historian Umberto Bartocci. Einstein used De Pretto's insight in a major paper published in 1905, but De Pretto was never acclaimed, said Professor Bartocci of the University of Perugia. De Pretto had stumbled on the equation, not the theory of relativity while speculating about ether in the life of the universe, stated Professor Bartocci. It was republished in 1904 by the Veneto's Royal Science Institute, but the equation's significance was not understood.

"A Swiss-Italian named Michele Besso alerted Einstein to the equation and in 1905 Einstein published his own work, said Professor Bartocci. It took years for the break through to be grasped. When the 'penny' finally dropped, De Pretto's contribution was never acknowledged, while Einstein went on to become the century's most famous scientist. De Pretto was never recognized. He died in 1921.

De Pretto didn't discover relativity but there is no doubt that he was the first to use the equation that is hugely significant. I also believe, though it is impossible to prove, that Einstein used, and benefited, from De Pretto's research," stated Professor Bartocci who has written a book on the subject. Einstein's theory held that time and motion are relative to the observer; if the speed of light is constant and if all natural laws are the same. A footnote established the equivalence of mass and energy, according to which the energy (E) of a quantity of the matter (M) is equal to the product of the mass and the square of the velocity of light (C), now known as $E=MC^2$.

A mathematics professor at the St. Andrew's University (UK), Edmund Robertson, has stated: "An awful lot of mathematics was done by people who have never been credited. The Arabs, in the Middle Ages, for example. Einstein may have gotten the idea from someone else, but ideas come from all sorts of places." De Pretto, however, deserves a credit if his contribution can be proven. Even so, it should not detract from Einstein."

Yes Larry, I Do Remember Ted Williams!

Recently, one of my "Extra Innings" fans named Larry from East Boston took note that in a recent column of mine, I forgot to list Ted Williams among other notable players I remember seeing at Fenway in my youth. I agreed with Larry that he was among the all-time greatest ballplayers in the history of the game. However, Ted Williams was not among my favorite players like Willie Mays or Mickey Mantle. Once I mentioned Mantle, I felt like I was being accused of being a Yankees fan.

You got to remember that back in the late '50s until 1966, the Red Sox stunk to high heaven. In 1961 while Mantle and Maris were fighting to best Babe Ruth in single season homers, the Red Sox finished 33 games behind the Yankees. Every year back then was like the year before and the year after. I was only 12 years old during Ted's final season. I remember liking to drink Ted's Root Beer by the bottle and eating Cain's Potato Chips with Jimmy Piersall's face on each bag, but my baseball heroes included a young Frank Robinson in Cincinnati, Brooks Robinson at third in Baltimore, Luis

Aparicio stealing bases in Chicago, Sandy Koufax winning games in Los Angeles, Dick Radatz saving games in Boston and Mickey Mantle a switch-hitting home run slugger in Yankee Stadium.

However, I always respected Ted Williams' career and the fact that in his prime he left baseball for five years to fight for his country in both World War II and the Korean War as a Marine fighter pilot. He was a Hall of Famer. He won two AL MVP awards, six batting titles and two Triple Crowns. The year 1942 was among Ted's best seasons in baseball. He finished that year winning the Triple Crown. The previous year, 1941, he hit .406, the first player in 11 years to do so and the last player ever to top the .400 mark. He was among the greatest to play baseball and when he retired, he finished with 521 home runs, 1,839 RBIs and a career .344 batting average.

In 1966 at his induction into Cooperstown, he advocated for the inclusion of retired Negro League players into the Hall of Fame. A few years later, they were added as Williams had desired to see. I also had the pleasure of being at Fenway Park in September 1960 when at his last time at-bat,

Ted Williams whacked home run number 521.

As usual, there were probably less than eight thousand fans in the stands on that historic afternoon. Usually, back then you paid 60 cents for the bleachers and tried to work your way over to the third base line by sneaking by the ushers guarding kids from doing that. There were always more of us than of them.

Larry, Ted Williams was the best ever Red Sox player and one of the greatest players of all time. I didn't have to like him and his attitude with the fans to respect his baseball skills which were unbelievable to friend or foe. However, I still liked Mantle

Carl "The Truth" Williams Passes



Heavyweight boxer Carl "The Truth" Williams, an exceptional boxing talent in the 1980s and '90s and native of Jamaica, Queens, passed away at Westchester Medical Center on Sunday, April 14, due to complications from throat cancer. He was 53. Williams' most notable fight was in 1989 against "Iron" Mike Tyson for the

undisputed heavyweight championship in Atlantic City. A picture pertect lett hook from Tyson toppled Williams in Round 1, giving Tyson his 37th straight victory. Williams won two consecutive Daily News Golden Gloves championships from 1980-81. He turned professional in 1982, winning 16 straight fights before a controversial loss to Larry Holmes in a IBF Heavyweight Title. In 1987, "The Truth" won the USBA Heavyweight Title and followed with three title defenses, including a unanimous decision over Trevor Berbick. Williams retired in 1997 with a career record of 32-10 (KO 21). "I'm just going to remember the man I knew," former world champion Iran Barkley said. "Carl was cool. He was a good guy who was always funny and always laughing." "He was a good friend of mine as well as a lot of other fighters out there," four-time Golden Gloves champion Dennis Milton said. "He wasn't hype. He was a guy that always strived to get better."

Williams is survived by his daughter Carla and his son Daniel.

HOOPS and HOCKEY in the HUB

So it will be a showdown between the two most historic franchises in the NBA. The only two teams in the league that are still playing in their original cities since they began more than half a century ago.

They are the Boston Celtics and the New York Knicks, a pair of dissimilar teams this year in that one (Boston) has struggled during the regular season while the other (New York) has battled its way to near the top of the Eastern Conference.

But while the routes taken may have been very different, both have the same goal as they enter the NBA's Second Season — make it out of the first round and continue on deeper into the playoffs, hopefully to the Conference Finals where nearly everyone feels that the Miami Heat will be the team to beat.

But who really knows. The Celtics finished seventh in the league standings with a slightly over .500 record while the Knicks finished over 10 games behind first place Miami.

And, on paper at least, the Knicks are definitely favored to move on past the Celtics to the second round — at least for those who choose to dwell on the results of the regular season.

For instance, when the Knicks clinched second place with a 90-80 win over the Indiana Pacers, it was the first time that New York had finished that high since the 1993-1994 season —when the Knicks also finished second.

Then there is the matter of New York's victory total, a least 53 with one regular season game remaining as this was being written. That's the most wins by the Knicks since the New Yorkers strung together 57 victories during the 1996-1997 campaign. It's enabled coach Mike Woodson to compile the best record in New York franchise history for a coach over his first 100 games. Woodson was an enviable 68-32 (a .680 winning percentage) over that span. Woodson was also the fastest New York head coach to accumulate 50 wins, taking only 72 games to compile a 50-22 mark.

In addition, there were significant stretches during the year when the Knicks were red hot. They went 12-6 in the month of March, the most wins in that month since 1993-1994 when they went undefeated at 14-0.

The 12 victories in March were part of a 13-game winning streak that lasted from March 18th to April 11th, when the Knicks were beaten by the Chicago Bulls 118-111 out in the Windy City. The 13-game streak was the third longest in franchise history, an amazing stat for a fran-

chise that dates back to the 1940s.

That's another way of saying that the Knicks have been hot this year. And yes, the Celtics have been victims of that. The Knicks won the season series against Boston, 3-1, the first time since 2003-2004 that New York won a regular season series against the Celtics. In the last two of those wins the New Yorkers won by an average of 17 points.

New York is definitely a threat from the outside. With one regular season game remaining, the Knicks had recorded 868 three pointers, putting them first in the league in three pointers made. The 868 threepointers made set an NBA single season record. In addition, the 10.9 triples made per game also led the league. That's amazing, when you think about it. That means that the Knicks averaged nearly 33 points per game just on three-point shooting.

Any discussion of Knicks personnel must start with Carmelo Anthony, the leadsecond at around .650, but ing scorer in the NBA this year at 28.7 points per game. At one span during the season he had a streak of 31 games in which he scored at least 20 tallies per contest, the longest such streak in franchise history. By mid-April he had scored over 20 points in 60 games this season and had been the team's leading scorer for the 54th time.

> The Knicks also have a strong bench, ranking second in the NBA in point production off the bench at 41.1 tallies per game. Over a 10 game stretch in April, J.R. Smith led the way with an 18.1 point average over that span.

> The bench even outscored the entire Sacramento team in a February 2nd victory at Madison Square Garden by pouring in 82 points in a 120-81 victory, the first time in team history that the team's bench had outscored its opponents total points for the game.

> Going into the final game of the regular season, the Knicks cited injuries to a number of players including Anthony, Tyson Chandler, Marcus Camby, Rasheed Wallace, Kenyon Martin and A'mare Stoudemire.

> If Anthony is truly injured, a sore left shoulder was cited, rather than just being rested, it will change the entire series. The goal of every team is to have the maximum number of players in top condition to start the playoffs. This often means resting players for the final few games of the season. So we'll see.

> In any case, it should be a highly charged, emotional series, especially between Kevin Garnett and Anthony. Look for some entertaining basketball next week at the Garden. If you want to see some exciting basketball don't miss it.
