American Icon Barbara Bush Dies

Barbara Bush, former First Lady and First Mother, passed away Tuesday, April 17, 2018, at the age of 92. Bush had battled health problems for much of her later life, including Graves' disease, heart disease, and an ulcer. She finally succumbed to chronic obstructive pulmonary disease COPD) as well as congestive heart failure. Nevertheless, Bush kept an active public schedule, raising money for charity and commenting on the day's affairs until nearly the end.

Only the second woman in American history to have had a husband and a son elected

President (Abigail Adams was the first), Barbara Bush was a force in her own right. Her dedication to keeping order at home earned her the nickname "the enforcer." However, she had a major impact on the world outside as well. When her husband was vice president in the 1980s, Bush adopted literacy as a cause, raising awareness and launching the nonprofit Barbara Bush Foundation for Family Literacy. "I chose lit-



eracy because I honestly believe that if more people could read, write, and comprehend, we would be that much closer to solving so many of the problems that plague our nation and our society," she said.

When Bush spoke at Wellesley College in 1990, some questioned whether she had the credentials to speak to future working women. She disarmed the crowd by suggesting that "somewhere out in this audi-

ence may even be someone who will one day follow my footsteps and preside over the White House as the president's spouse." After a beat, she added, "I wish him well."

Bush is survived by her husband, George H.W.; sons George W., Neil, Marvin, and Jeb; daughter, Dorothy Bush Koch; and 17 grandchildren.

"I always knew Barbara was the most beloved woman in the world and, in fact, I used to tease her that I had a complex about that fact. But the truth is the outpouring of love and friendship being directed at 'The Enforcer' is lifting us all up. We have faith she is

an up. We have faith she is in heaven and we know life will go on — as she would have it. So cross the Bushes off your worry list." — Former President George H. W. Bush

Members of the public are invited to pay their respects Friday, April 20th, as Barbara Bush lies in repose between noon and midnight at St. Martin's Church in Houston, according to the official funeral announcement by the family.

The Notice of Project Change (NPC) for the Parcel 9 Haymar-ket Hotel project, located on a 29,400 square foot parcel along the Rose F. Kennedy Greenway, was approved with a modest increase in the maximum height

of the building, from 65 feet to a maximum of 69 feet, 6 inches, to achieve acceptable floor-to-ceiling heights within the building.


The project consists of a 225-key hotel, containing approximately 9,600 square feet of complementary retail and restaurant uses; a onestory component at the Hanover Street end that will house a restaurant as well as a rooftop deck; and ground floor area off Blackstone Street that will be leased to the Haymarket Pushcart Association to accommodate storage and restrooms for their members. The ground floor of the building will also

include restrooms accessible to the public as well as meeting space that can be made available for community use. The building design includes glass storefronts as well as building materials that provide a contemporary take on the historic setting of the project site between Blackstone Street and the North End neighborhood. The project will reconstruct Blackstone Street from North Street to Hanover Street and include streetscape improvements around all sides of the building, subject to required approvals from the City's Public Improvement Commission.


Stirpe Nostra

THE THREE Rs IN OLD ROME



This Roman abacus, made of bronze and dating from the second century CE, is currently on display at the Bibliothèque Nationale in Paris.

Ludus in Latin means play, game, sport, child's play, diversion, or school. Literarius means reading and writing. Put them both together and ludus literarius comes out to be an elementary school for children in old Rome.

Greek schooling was the forerunner of the Roman system. It should be noted that the Greeks paid great attention to their literary as well as their physical culture. The prohibition of schools was often used as a severe punishment for disloyal allies or provinces. In 550 B.C., there were laws that provided for literary training at public cost for all boys. This attitude toward education was probably the most significant contribution in the development of a civilization of the highest order by these classical Greeks. The young Greek citizen was free, intelligent, and extremely accomplished. He had studied and participated in drama, knew the work of Homer and other great poets by heart, could play one or more musical instruments, sing, and dance. He served at least one term in the army or navy, knew how to build walls and fortifications, and was physically strong and active in games and contests. He was an expert at painting or some craft and was knowledgeable in the work of architects, sculptors and painters; that is, he could discuss their work with intelligence and understanding. Athenian schools were only for boys. Mothers tutored their daughters in the domestic arts of sewing, spinning, etc. The classical Greek was truly a new order of man.

Education in early Rome was not obligatory but was always considered to be of great importance. Many a Roman youth received his early training from his father by learning his father's trade or business. Formal instruction in the *ludus literarius* was available to boys and girls alike and it was lim-

ited to reading, writing, and arithmetic.

There were also schools of the grammataci, which taught language, literature, and philosophy. The teacher was called the magister and his pay was entirely dependent upon the small fees paid to him by the parents of the pupils. The magister was often forced to "moonlight" in order to supplement his income. Any subsidiaries that might have been available seem to have been directed toward higher realms in learning and not elementary education.

The Roman school year began on March 24th. This was the time when the new students brought their entrance fees, called the *minerval*. The balance of the school fees was paid each month. Classes were generally held under the awning or portico of some convenient shop and had to compete with all of the street noises. A screen or cloth drop provided shelter from the hot sun during warm seasons. The classroom furniture consisted of a teacher's chair and some stools for the children; writing tablets made of wax; some calculating boards, call abaci; and a blackboard. The partly open schoolroom, the noise of the teaching (and of the punishment!) was of great annoyance to neighbors and passersby.

One fact was common in all elementary schools — no child was ever spoiled for fear of sparing the rod. The good old-fashioned *schiaffo* (smack!) seems to have been born here.

What Happened?

Throughout most of our history, the United States protected its domestic apparel industry with relatively high import tariffs. Following World War II, the U.S., and our trading partners formed the General Agreement on Tariffs and Trade ("GATT") in 1947. The goal was to increase international trade by reducing tariffs and other barriers to trade. It was believed that more trade would link economies through multi-national commerce so that nations would be more inclined to live cooperatively, creating a more stable world economy.

U.S. apparel tariffs, while still high, were reduced and imports surged. U.S. industry responded by seeking renewed protection. Raising tariffs was off the table due to U.S. commitments under GATT. But the industry had political strength due to the number of workers and the geographic reach. Cotton was grown in many of the Southern states. The Western states produced wool. There were many yarn and fabric mills in the Northeast and Southeast. Garment factories could be found anywhere, including the major cities of the North, such as Boston, Chicago, New York, and Philadelphia. Politicians responded. The U.S. began imposing short-term quotas on imports textiles in the early 1960s. The quota system grew. In 1974, it became the Multifiber Arrangement ("MFA"), which governed the world trade in apparel through 2004. Under the MFA, developed nations could impose quantitative quotas on imports from developing nations on a nation-by-nation basis. The quota system limited imports and, also, assured that no one, or few countries, could totally dominate trade.

Up to 1970, we produced 95% of our apparel. As late as 1988, we produced 74%. Then it changed. In February 1986, the President announced a special program to guarantee access to the U.S. market for Caribbeanproduced apparel assembled from U.S.-made fabric. In 1994, the North American Free Trade Agreement ("NAFTA") went into effect. These programs with our Western Hemisphere partners allowed garments to enter the U.S. duty-free and quota-free, but imposed restrictions on the sourcing of the fabric for the garments that favored fabric production in the U.S. By 2001, of the sixteen million square meters-worth of apparel imported, 39% of it came from

our NAFTA and Caribbean partners.

Meanwhile, China had Normal Trade Relations ("NTR") that had to be renewed annually, which made producers hesitant to depend too much on one, uncertain, source. Additionally, the quota system limited the ability of China to ship all the garments it had the capacity to produce. The result was that although China was the second largest source of apparel imports in 2001, it was, effectively capped at 6% of imports. The rest came from eleven nations, mostly in East or South Asia. However, the major shippers did include one nation (Turkey) not in those

In December 2001, China entered the World Trade Organization ("WTO") and Vietnam got NTR. Quotas expired at the end of 2004. By 2005, the import pattern had changed. Imports had grown to twenty-two million square meters. Our Western Hemisphere partners' share fell to 28%, China's rose to 27%, and Vietnam's, not previously a major shipper, rose to 4%; the remaining shares came from ten East Asian and South Asian countries with the rest of the world not being a major factor any more.

Although the quotas expired at the end of 2004. China's WTO accession agreement provided for re-imposition of quotas for a limited time. The U.S. and China negotiated a bi-lateral restraint that limited China through 2008. By then, Vietnam had entered the WTO (January 2007). So, by 2009, the import picture was quite different. Of the twenty-one million square meters of apparel imported into the U.S., 41% was from China, while our Western Hemisphere partners dropped further to 18%, Vietnam doubled to 8%, and the number of other players dropped from ten to six.

By last year, total imports rose to twenty-seven million square meters. China, at 42%, stayed about the same, while Vietnam surged to 13%. Our Western Hemisphere partners dropped to 16% and the rest of the field further contracted to five.

The reversal from 95% domestically-made apparel to 95% imported was due, entirely, to decisions made in Washington. NAFTA, China in the WTO, Vietnam in the WTO, the end of the MFA quota system, and reduction in U.S. apparel tariffs have all but destroyed our apparel industry.

Lifting Welfare Asset Cap, Good or Bad?

As a working journalist, I try and keep up with the news as much as possible. As a columnist, I have strong opinions but I am always open to divergent views.

Recently, I found myself reading a news story by Christian M. Wade, who covers the Statehouse for The Salem News and its sister newspapers and websites.

According to Wade, the governor is seeking higher limits to qualify for welfare benefits, but advocates for the poor, according to this story, say the state should scrap the caps

The budget plan for the next fiscal year has Baker proposing doubling the state cap on assets to \$5,000 and the governor has also earmarked some \$800,000 in new funding for additional families to quality for benefits under the proposed change.

The budget rolled out by the House of Representatives supports the proposal and is pledging similar reforms. Rep. Jeff Sanchez, D-JP, who chairs the House & Ways Committee, has stated, he supports the doubling of the present asset cap and believes "this is going to help folks."

The state currently spends about \$15 million per month on this program. Should we eliminate the asset cap altogether, should we keep it at \$2,500, or double it to \$5,000?

No one wants to hurt individual families in need, but we should make sure that welfare fraud — which cost the Commonwealth almost \$17 million last year — is also a vital part of any reform.

For me, the bottom line is clear. We should not be making it easier to stay on welfare, we should be incentivizing folks to exit public assistance programs.

We shouldn't make poor people poorer but we do need to deal with MassHealth and SNAP fraud, too. Don't blame the victims blame the cheats

So, should we increase the caps or eliminate them? What do you think?

Moreover, fall offers a bounty of ingredients suitable for baking, from tart apples to juicy pears to sharp, spicy ginger. However, autumn is far from my thoughts as I enjoy the beautiful springtime. An impressive finale to any spring meal, these cakes blend the delectable taste of ful time to use up the last of pineapple along with a sweet

caramelized topping. Of course, on days when you feel that only an all-inclusive plethora of tropical fruits will satiate your desire for summer, try baking up a Hummingbird Cake. This recipe incorporates bananas, pineapples and coconut, finished off with a velvety cream cheese frosting! You could also take a cue from the Italians and snack on kiwifruit whenever you want a taste of the tropics. A perennially popular fruit there, Italy produces more kiwis than any other country!

Strawberries: Strawberries are a harbinger of spring. Whenever I see these ruby-red gems lining the produce shelves of supermarkets, I know that spring has arrived. I love baking with strawberries because of their versatility. My mother once made a strawberry and white chocolate tiramisu for my father's birthday, a summery twist on a classic Italian dessert. Strawberries are also delectable on cakes, pies, cheesecakes and quick-breads. When I went to Italy, I remained impressed at all the innovative uses for strawberries (fragole) in Italian desserts. Italians often drizzle strawberry sauces over baked custards known as panna cotta, or else serve the strawberries in tall, elegant glasses marinated with balsamic vinegar for a savorysweet contrast. As an essential crop of spring, do not be afraid to experiment with strawberries, as they nearly always guarantee a foolproof dessert!

Rhubarb: Rhubarb is my new favorite spring ingredient to bake with. An odd, red stalk that resembles celery, cooked rhubarb tastes like a cross between a strawberry and an apple. Its tartness perfectly blends with sweet desserts. I have found so many rhubarb recipes that I would like to try, ranging from strawberry-rhubarb pies to rhubarb chutneys served over lemon-ricotta pancakes. (My mother and I once made this latter recipe, and we could not get enough!) My favorite rhubarb recipe, however, is one for a moist rhubarb cake with a cinnamon crumb topping that my father-in-law gave me. I prepare this cake for my May Day celebrations now.

Baking in the springtime is a wonderful experience. Using seasonal ingredients connects us to Mother Earth, which is now blossoming with new life. Sweet desserts made with citrus, tropical fruits, strawberries, and rhubarb can serve as lovely finishes to picnics and open-air dinners spent luxuriating in the beautiful spring weather and in the company of nature. Moreover, spring baking offers us the opportunity to engage in the recipes of our Italian ancestors, honoring the food of our heritage and applying our own innovation and creativity to it. This spring, head to the market and pick up the freshest ingredients available ... and from there, happy baking!







WHAT'S HAPPENING TO THE BOSTON HERALD?



Nanna & Babbononno

A Nostalgic Remembrance



One of the chapters of the new book I am now working on is called "Paesani, Compari, and Amici," meaning "Countrymen, Cronies, and "Friends." This is a combined group of associates first established by our immigrant forbearers and continued by their children, grandchildren, and beyond.

Babbononno didn't have too many paesani in the true sense of the word. He came from Foggia, on Italy's east coast, about the same latitude as Rome. Very few people from Foggia came to Boston so Babbononno's paesani were the closest of friends that congregated around him. They became his surrogate family members, including Antonio Ceruolo, Nanna's oldest brother. There were the compari, or in his case, companions that he would assemble as the next tier of friends, people that he and Nanna might invite to their house on holidays or special occasions. In third place were the amici, friends who would visit for coffee and conversation, but without the connections extended to paesani or compari.

Babbononno would talk about friends he had made at the store-front social clubs he frequented to play Italian card games, to read the *Post-Gazette*, or just to have a glass of wine and a cigar with friends nearby. Nanna's circle of friends had three tiers: her sisters were on top; next came cousins and distant relatives; and third were the people she met in the old neighborhood that remained close to her even though she and Babbononno moved away in 1920 (from one side of East Boston to another).

Mom's closest friends were the girls she grew up with in Jefferies Point. Her closest friend, Ada Georgione, married Uncle Nick and would become my Godmother when I was baptized. (Uncle Nick would become my Godfather.) Mom had several other friends, not as close as Ada, but close. Millie and Minnie were names she often used when reminiscing decades later. Her closest friend, though, was her cousin Louise. Louise Ceruolo Pepe was one of the daughters of Zi'Antonio and Zi'Mariuccia, became part of a group of Eutaw Street mothers that got together one night a week for coffee, biscotti, and gossip. When she and Dad moved to Belmont, she would become part of a neighborhood circle of ladies; the difference was that she was

the only Italian. Back in East Boston, they all were Italian.

Dad's neighborhood friends were the kids from Chelsea Street who played football and baseball. There was no concept of "what part of Italy do you come from," as the Italians were American born and there were Irish and Jewish neighborhood kids in the mix as well. Once Dad became a working musician, his social circle was the men he worked with. When he married Mom in the mid-1930s, the wives of the musicians and Mom socialized, but on a more formal basis. The same thing would happen when Dad began to teach in the Boston Public Schools. He would develop friendships, associates, and casual acquaintances. He did become a sort of brother to Mike Barca, a man he met when both were pioneers in the Department of Audio Visual Education, right after WWII. They were both Italian and in the minority and compared notes on the struggles they had working for the city.

There was also a men's group on Eutaw Street that would often get together. In the warm weather, there were backyard cookouts with about eight to ten families that had chosen to socialize. The men sometimes went to baseball games together or out for a pizza without the wives. Santarpio's was always the location for the best pizza in town or an Italian lamb barbecue.

Years later, when my folks moved to the suburbs, Dad and a few of the neighborhood men formed friendships. There were no Italians in the group. Dad was it, but like Dad, they were all Bostonians who made the decision to move out of the city to the suburbs.

I followed suit, forming neighborhood pals at a young age. Most of my close friends were the kids that played baseball. But, even before my formative years, I and the first born son of close friends of Mom and Dad, John Manfredonia, were like brothers. We were born a week apart and remained attached at the hip until high school. John went to East Boston High and I went to English. After graduation, he went into the Army and I went to college. This separa-Nanna's oldest brother and tion widened even more when sister-in-law. Years later, Mom he was discharged from the service and married. He then abided by an unwritten law, "Married men don't hang out with single friends."

> For several years, I had my street corner friends whom I actually distanced myself from when I started college and

joined a new group of young men. I also had friends that worked with or for me at the Seville Theater; but things changed after I graduated college. At the same time, I became more involved with music and show business and associated with musicians, singers and actors, all of whom I networked or worked with. It was more to my advantage to stay close to these people, professionally.

I did have a best friend beginning at about the age of twentyone. Sal Meli and I met playing handball at Shea's Beach in Orient Heights and had a lot in common. We began double dating, nightclubbing, and just hanging out together. He worked his schedule out so that when I had vacation time we were off to other parts of the country or exotic locations somewhere around the world. He was my best man when I married Loretta and became my son John's godfather.

Sal stayed single and we headed in separate directions. He occasionally dropped by with new lady friends, but some of them left a lot to be desired, and so we drifted. Unfortunately, he developed dementia early on and now lives in an assisted living complex in the western suburbs of Boston.

I met Dean Saluti at the end of the summer in 1973. We discovered we had a lot in common and began hanging out together. He was working on a doctorate at Boston University and pushed me in that direction. While at B.U., I met my wife, Loretta, and later worked with Dean doing educational consulting. He introduced me to John Silva and Bill Hurley, and all three became part of my inner circle.

My sons, John and Michael, have followed suit and have maintained friendships they developed in school or sports as youngsters. So you see, paesani, compari, and amici have continued for four generations ... I can honestly say, "Now, that's Italian."

SALMON STEAKS **Broiled or Grilled**

4 salmon steaks

2 medium onions

1/4 cup olive, canola or vegetable oil

2 tablespoons mayonnaise

½ cup lemon juice

1 teaspoon cider vinegar (optional)

2 tablespoons of butter or

margarine


SALMON STEAK: Spread some oil or mayonnaise on the bottom of a broiling pan. Then spread a little oil or mayonnaise over the top and bottom of each salmon steak before placing in the broiling pan. Place in preheated oven about two inches from broiling unit. Turn steaks to broil on both sides slowly. Steaks will turn whitish in color when they are cooked. Depending on size, broiling time will be about fifteen to twenty minutes. Then set broiling pan with steaks aside.

ONIONS: Remove outer skin from onions. Cut onions in half, lengthwise, and then into 1/4-inch slices lengthwise. Set aside in a bowl.

Heat oil in a skillet. Add butter or margarine and onion slices to the skillet. Stir and simmer until onions are about to brown slightly. Remove from burner and add lemon juice. Add vinegar (optional). Stir and return to burner. Simmer slowly a few seconds. Remove from burner.

Spoon onions and liquids from skillet over each salmon steak in the broiling pan. Cover with aluminum foil and return to heated broiler for about a minute. To slightly brown tops, remove cover and broil for a few seconds longer.

Serve each steak topped with onions and liquids from broiling pan. Serve with rice pilaf and vegetable or salad of choice. Serves



Saint Raymond of Penafort

Raymond of Penafort was born in Vilafranca del Penedès, a small town near Barcelona, Catalonia, around 1175. He was descended from a noble family with ties to the House of Aragon. From childhood, he had a love and devotion to the Blessed Mother. He was educated in Barcelona and at the University of Bologna, where he received doctorates in both civil and canon law. From 1195 to 1210, he taught canon law. In 1210, he moved to Bologna, where he remained until 1222.

Raymond was attracted to the Dominican Order by the preaching of Blessed Reginald, prior of the Dominicans of Bologna, and received the habit at the age of 47 in the Dominican Monastery of Barcelona to which he had returned from Italy in 1222.

Raymond was called to Rome by Pope Gregory IX to work for him and to be his confessor. One of the things the Pope asked him to do was to gather



together all the decrees of popes and councils that had been made in the eighty years since the Decretum. The Decretum was a collection of nearly 3,800 texts touching on all areas of church discipline and regulation compiled by the Benedictine monk Gratian about 1140. It soon became the basic text on which the masters of Canon law taught. Raymond compiled five books called the Decretals of Gregory IX. They were looked upon as one of the best organized collections of Church law until the 1917 codification of Canon law. Earlier, Raymond had written for confessors a book of cases called Summa de Casibus Poenitentiae, which discussed doctrines and laws of the Church.

At the age of 60, Raymond was appointed archbishop of Tarragona, the capital of Aragon. He didn't like the honor, got sick, and resigned in two years.

At the age of 63, he was elected to be the head of the Dominican Order, the successor of Saint Dominic. Raymond worked hard, visited all the Dominicans houses on foot, and reorganized their constitution. He stepped down as head of the Dominicans at age 65.

Free of office, he applied himself to Christian ministry, especially working for the conversion of the Moors. He instituted the teaching of Arabic and Hebrew in several houses of the friars. He also founded priories in Murcia and in Tunis and helped establish the Church in the recently conquered island of Mallorca.

Raymond passed away at the age of 100 in Barcelona in 1275 and was canonized by Pope Clement VIII in 1601. The Feast Day of Saint Raymond of

Let's be very careful and remember Eisenhower's warning back nearly sixty years ago.





MAX BAER

The Champ was a Character, Colorful and Very Popular, So Why Has a Movie Never Been Made About Him?

Not many men have been able to lay claim to the Heavyweight Championship of the World. From John L. Sullivan up to Larry Holmes' time as title holder, only twenty-seven have held the undisputed title. Of course, it continued to change hands after Ali, but at that point it had become splintered with different organizations recognizing different champions.

The twenty-seven who held the title were a very unique group. Each has a compelling story and most have very interesting pasts. Given this, it is surprising how few have been the subject of movies. Errol Flynn played James J. Corbett in the 1942 film Gentleman Jim, a highly fictionalized treatment of the

champion's life. While not historically accurate, it is a hugely entertaining moving, made more so by the portrayal of John L. Sullivan by Ward Bond. I believe it was Bond that made the movie so enjoyable, as he truly captured the character of John L.

Speaking of Sullivan, why is it that he has not been given his due by Hollywood? There was one movie made about him, the dreadful The Great John L. (1945) starring Greg McClure. This was so awful, it wouldn't be right to include it on list of heavyweight movie bios. If Hollywood had any sense at all, they would have cast Ward Bond in the role.

Other movies with heavyweight champs as the subject include The Joe Louis Story (1953); The Greatest (1973), where Muhammad Ali played himself in another less than stellar film; Ali (2001) with Will Smith in a decent work; and Cinderella

Man (2005) starring Russell Crowe as James J. Braddock, the best of them all. There have also been truly horrible films made about Jack Dempsey, Rocky Marciano, and Sonny Liston. So much rich material and so few good movies.

After Cinderella Man was released, director Ron Howard was criticized for the way he had Max Baer portrayed in the movie. Baer's character, played by Craig Bierko, came across as a viscous and cruel man, much different than what most people believe about the real Baer. Bierko was excel-

lent in the part, and it is thought Howard took artistic license with the character in order to create drama and tension in the movie. Having two guys who really like each other climb into the ring for the big fight scene just wouldn't have been as interesting.

One of the things that made Cinderella Man such a hit was the fact that Braddock had a very compelling story. Even in his day, he captured the imagination and love of the people struggling through the Great Depression. His story touched so many and still does. It is about a man trying to support his family while all seems lost. It shows his triumph in overcoming the odds through sheer determination and guts as he makes the impossible happen. It is the stuff of a Hollywood movie and it is a true story. It would be hard to top that.

Now, take Max Baer. Many think his life would make for a great movie. Max was an amazing personality. He not only was exciting to watch in the ring, but he was also incredibly popular

out of it. He had a magnetic personality and loved to ham it up for the camera. He was a natural when in public, with a quick wit, good looks, and an infectious smile. He was so good that he even went to Hollywood where he starred in a feature movie, The Prizefighter and the Lady, with Myrna Loy. While a bit green, Baer showed some real talent, even performing a song and dance number.

Baer's exploits in the ring were something as well. He has been rated one of the hardest punchers in heavyweight history with 52 of his 68 wins coming by knockout. His title-winning fight against Primo Carnera was one of the wildest in history. Baer's best night was when he

stopped Max Schmeling in the 10th round in 1933. He came close to killing the former champ in the bout. It was a vicious affair.

Baer did a fighter in the ring. In 1930, Frankie Campbell died after being stopped by Baer. It is also thought that the beating Ernie Schaaf took in his fight with Max was a contributing factor in his death when he succumbed after losing to Primo Carnera six months later.

Baer would lose his title to Jimmy Braddock in 1935 in what would be remembered as one of the greatest upsets in history. Baer was out of shape and had not taken Braddock seriously.

Three months later, Baer would take on the up-and-coming Joe Louis. Max went into the fight with a broken right hand and, after being knocked down for the first time in his career, took the full count on one knee after going down again. When asked why he quit,

Baer said, "People are going to have to pay a lot more than fifty bucks to see me get killed.'

Baer continued to fight until 1941, when he was stopped by Lou Nova. After that, he worked as a referee and had parts in a number of movies, including *The Harder* They Fall, where he played a character loosely based on himself but with the same viciousness that would later be seen in Cinderella Man.

On November 21, 1959, Baer checked into a hotel in Hollywood, CA. Not feeling well, he

called down to the front desk and asked for a doctor. The clerk said, "A house doctor will be right up." Max responded "A house doctor? No dummy, I need a people doctor." Baer died of a heart attack a while later.

So, why no movie about Max Baer? Well, the Max Baer story is really not a compelling one. Max was certainly an exciting character and it must have been tremendous fun to be around him. His fights were always a great draw as they were exciting and the fans never knew what to expect from him. He remained popular all his life. While this makes for a somewhat interesting story, it does not translate into a great movie biography. James Braddock was a much lower key figure, but his was a truly amazing tale that was made for Hollywood.

I doubt there will ever be a movie made about Max Baer, but if you want to be entertained by him, just go to *YouTube* where you can find plenty of footage of The Clown Prince of Boxing. Max was a character.

A player who figured in one of basketball world is mourning the loss. That would be Hal Greer, a Basketball Hall of Fame member, who played for a decade and a half for one franchise — the

So, yes, even though the Celtics were leading and Greer was inbounding in the backcourt, the C's had reason to be concerned. But Greer's toss was deflected by John Havlicek and the rest is history. "Havlicek stole the ball. It's all over!!!" Johnny Most into his microphone as Hondo was mobbed by fans in the old Garden.

The 6'-2" guard later acknowledged that he hadn't put enough speed on the inbounds pass. There would be redemption for Greer just two years later as Philadelphia would go on to capture the 1967 NBA Championship with the West Virginia native averaging 22.1 points per game over the course of that season.

Greer would go on to play several more years with the 76ers before retiring at the end of the 1972-1973 campaign. Over the course of his career, he scored 21,586 points with an average of 19.2 ppg in 1,122 50th anniversary team in 1996. He was 81 at the time of his passing.

"I like what I see," proclaimed screamed Celtics broadcaster then Bruins General Manager Peter Chiarelli, who ultimately decided to place Pastrnak in Providence, not only for development purposes but because he was unsure whether Pastrnak could stand up to the physical aspect of the game with respect to battling much larger players. It almost seemed at the time that one of the reasons Pastrnak was sent to Providence was for his own safety.

That's no longer a concern, of course. The 6'-0" native of the Czech Republic has bulked up to just under 190 pounds and can hold his own in battles on the ice. He led the team in scoring this year and had six points in Game 2 of the Toronto series with a hat trick and three games played. He was inducted assists.
