For the second year, the Commission for Social Justice and the Scholarship Commission, both under the auspices of the Grand Lodge of Massachusetts, are combining their signature events into one day, honoring the most prestigious Italian American leaders and students throughout the jurisdiction of the Grand Lodge. This combined event, known as the Massachusetts Education and Law Awards, will take place on Sunday, May 3, 2015 at the Wyndham Boston Andover in Andover, Massachusetts.

The Commission for Social Justice is pleased and honored to announce the following recipients of this year's awards.

The "Justice Award" recipient is The Honorable Robert B. Calagione. Judge Calagione is an Associate Justice in the Westborough District Court and First Justice of the Milford District Court. He graduated from Georgetown University, and went on to receive his Juris Doctorate at Suffolk University Law School. He served as a private practice attorney for 21 years and as a clerk magistrate for three years before being appointed to the bench in 2001. He was appointed as Associate Justice in the Westborough District Court in 2001, and First Justice of the Milford District Court in 2004, and currently presides in both courts. Judge Calagione is a member of the Education Committee and Case Flow Management Committee of the District Court Department. He also serves as a mentor for new and current judicial members of the District Court. He is known and respected by district attorneys, law enforcement, and private attorneys for his fairness, demeanor, and temperament.

The recipient of the "Law Enforcement Award" is Chief Robert J. Ferullo Jr., Chief

of the Woburn Police Department. He graduated from Northeastern University and Suffolk University Law School, and is a member of the Massachusetts Bar. Chief Ferullo has served in the Woburn Police Department since 1980, rose through the ranks and served as Sergeant, Lieutenant, and was finally promoted to Chief on October 1, 2011. Since becoming Chief, Ferullo has become known across the state for his dedication to the juvenile justice system and substance abuse education and prevention. He is an active participant in the Heroin Education Awareness Taskforce (HEAT) program, which seeks to educate the public about heroin abuse, and works to ensure treatment for addicts, especially given the recent rise in heroin related overdoses. He is also involved with the Clean Start program, which gives second chances to juvenile drug offenders. Chief Ferullo has received many awards, including multiple commendations from the State House, and recognition from the Woburn School Department for his efforts to improve school safety and for his service to the youth of the city of Woburn.

The recipient of the "Public Service Award" is Mayor Joseph A. Curtatone, Mayor of the City of Somerville. Currently serving a historic sixth term as Mayor, Curtatone was first elected in 2003 after serving as an Alderman At Large for eight years. He earned bachelor's degree from Boston College, a Juris Doctorate from New England School of Law, and a Master's Degree in Public Administration from the Harvard Kennedy School. As Mayor, he has implemented a number of programs and reforms that have earned Somerville many regional and national distinctions, such as the

setts" from Boston Globe Magazine, one of the "100 Best Communities for Youth" by America's Promise Alliance, and one of ten "All America City" awards in 2009 from the National Civic League. He has spearheaded reforms for the city's police department, and created Neighborhood Impact Teams to monitor and improve the health, safety, and appearance of the city's business and residential neighborhoods. Delegates from other communities locally and internationally have modeled some of the city's programs, such as the SomerStat program (which harnesses data to evaluate, improve and increase the efficiency of city services), and a comprehensive 311 constituent services program. Under his leadership, the city has also gained national recognition for its "Shape Up Somerville" effort with Tufts University, which aims to reduce instances of childhood obesity. Mayor Curtatone has served as President of the Massachusetts Mayor's Association, a member of the Board of Directors for the National League of Cities, and a member of the Metropolitan Mayors Association.

The Toastmaster for the event is Lieutenant Governor Karyn E. Polito. Lieutenant Governor Polito is a member of Worcester Lodge # 168, and was the recipient of the Commission for Social Justice's Public Service Award in 2011. A former State Representative in the Eleventh Worcester District for 10 years, Polito was the driving force behind many key pieces of legislation, including the establishment of minimum mandatory sentencing for sex offenders, cracking down on drunk drivers, closing school registration loopholes for missing

PHIDIAS AND HIS ATHENIAN SCULPTURES

Ask any Italian-American who the world's greatest sculptor was, and Michelangelo will probably get the vote. The Greeks have their favorite, too. His name is Phidias, and he was born in Attica about 500 B.C. This particular time in Greek history is known as the "Age of Pericles" or "The Golden Age of Greece." Pericles was the statesman who gave out the commissions but it was Phidias who sculptured those splendid statues. In addition to his position as the superintendent of public works for Athens, Phidias directed the construction of the imposing entrance (Propylaea) to the Athenian Acropolis, numerous other works of art, and at least two of the most celebrated statues of Athena that the world has ever known.

The first of these masterpieces, the colossal statue of Athena Parthenos (the virgin goddess), was about thirty feet high, and it was sheathed in ivory and gold. All of the sculptured ornaments of the Parthenon were carved under the supervision of Phidias but the statue was the work of his own hand. This art form was called "Cryselephantine," which means that the statue was formed on plates of ivory, laid upon a core of wood or stone for the flesh parts, while the drapery and ornaments were of solid gold. Phidias. It stood on the



Athena was shown standing, and clothed in a tunic that reached to the ankles. She held a spear in her left hand and a six foot high image of Victory in her right. She wore a metal breast 'plate while her shield was resting on the ground at her feet. All of the gold portions were assembled so that they could easily be removed for safekeeping during times of war. It's easy to understand the reason for this feature when we realize that at today's market price all of the gold was worth about twenty-two million dollars.

The second masterpiece, the bronze statue of Athena Promachos (Athena the Warrior) was also attributed to

Acropolis near the Parthenon and was erected by using the proceeds from the spoils taken at the battle of Marathon. The proportions of this statue were so colossal that the reflection from the tip of the lance and her helmet were visible to sailors as far away as the southern extremity of Attica.

The effort being put forth by Melina, the Greek Minister of Cultures and Science to secure the return of the Elgin marbles has received considerable publicity. Our current discussion concerning Phidias, the Acropolis, and the Parthenon, prompts me to explain that the Elgin marbles are a collection of ancient sculptures that were brought from Greece to England by the Thomas Bruce, Earl of Elgin, in 1812 while he was the British Ambassador to the Ottoman Empire.

It all started with the construction of the Parthenon during the Gold Age of Greece (about 450 B.C.). All of the building's sculptured work is believed to have been done under the direct supervision of Phidias. Like most ancient buildings, the Parthenon had its share of abuse down through the ages. It was used as a Roman temple, a Greek Orthodox Church, and even a Mohammedan Mosque. Greece

Not So Fast!

This week Congress started work on a Trade Promotion Act ("TPA"). Formerly called "fast track," TPA is an Act of Congress that authorizes the President to negotiate and sign a free trade agreement ("FTA") with another country or countries, with the provision that the FTA will be brought to congress for approval by both houses on an up-or-down vote with no amendments. TPA is important because no nation would negotiate with the U.S. if Congress, after the agreement is reached, could amend the agreement. TPA also puts a bill on a "fast track" in that it imposes a relatively compressed time schedule for consideration and vote on the bill.

My progressive friends say that fast track is a way to ram unpopular trade deals through Congress that kill U.S. jobs, grant special favors to nations with poor environmental and labor standards, and reward multinational corporations who, through a system of legalized bribery, have inordinate power in Washington. My TEA Party friends say that fast track is an unwise (possibly unconstitutional) handing over to the Executive of Congresses power to determine trade policy with a tendency to promote dangerous foreign entanglements. Both are, of course.

What is Fast Track or TPA?

Under TPA procedures, a free trade agreement, "FTA," is approved as a Congressional-Executive Agreement, rather than a treaty. This is due to the separation of powers under the U.S. Constitution -

- "[The President] shall have power, by and with the advice and consent of the Senate, to make treaties, provided two-thirds of the Senators present concur." -Article 2, Sec. 2
- "Congress shall have power to lay and collect duties ..." — U.S. Constitution, Article 1, Sec. 8
- "All bills for raising revenue shall originate in the House of Representatives ..." - Article 1, Sec. 7

Therefore, an FTA is not, in the U.S., a treaty. Treaties are negotiated by the President and approved by two-thirds of the Senate with no vote in the House. An FTA adjusts duties, which affects revenue and is therefore (Art. 1, Sec. 7) a "money bill," which must originate in the House.

Under TPA procedures the negotiation is entirely in the hands of the Executive, however, Congress may include negotiations objectives in the TPA bill. But the President must negotiate an agreement that can get a majority vote in each of the houses of Congress, where his party may not have a majority.

TPA is important as a signal to our negotiating partners that Congress has confidence in the President to negotiate an agreement that can be passed by Congress.

TPA is also important as the bill provides a vehicle for Congress to instruct the President, via the negotiation objectives set forth in the TPA bill, as to what he needs to do to get those majorities in the House and Senate.

However, it is not the case, as some have said, that you must have TPA to do an FTA. If you have the votes to pass the FTA you have the votes in the House to bring the FTA up for a vote under a "closed rule," meaning no amendments are allowed. It is commonly stated that Senate does not have the "closed rule," however, that is clearly mis-

CATHERINE DE' MEDICI

(April 3, 1519 — January 5, 1589):

The Matriarch Pulls the Strings

Catherine de' Medici is widely regarded as the most powerful woman in 16th century Europe, but her influence started with her family. In the end, she not only put her three sons (Francis II, Charles IX, and Henry III) on the French throne, but controlled almost all of their actions. Which, under their name, and by extension her own, were some of the greatest atrocities in the history of France.

Perhaps it was precisely because she was denied power for so long that she rose so fiercely after the death of her husband King Henry II in 1559. Her marriage to King Henry was plagued by a lot of the same problems that always affected monarchies. For a while, it seemed as if they would not be able to reproduce and the lack of a son was detrimental to the King. As a result, their marriage (though passionate at first) became loveless and the King turned his attention to his mistresses. One of them, Filippa Duci, gave birth to his daughter Diane de France in 1538.

Still, King Henry had no son, but his proven ability to have children with other women estranged him further from his wife. He limited much of her political power and denied her ownership of the Château of Chenonceau to his other lover Diane de Poitiers.

Meanwhile, Catherine was trying everything she could to give her husband a son and finally did so in 1544 who would become King Francis II. After that, Catherine never again had difficulty giving birth and with the King had another eight children. Love never returned to the marriage, but her legacy would be secure.

The death of King Henry II in 1559 proved to be the turning point in the life of Catherine de' Medici. The quiet woman who accepted her husband's attention to other women rose up with a vengeance, guiding the rule of three of her sons. For the Queen it was a hundred eighty-degree turn, going from virtually no political power allotted to her under her husband's rule to the most powerful woman (one could argue even more powerful than her sons) of the mid-1500s. Perhaps years of enduring quiet humiliation oppression finally erupted in a ruthless outburst of power culminating



in the St. Bartholomew's Day Massacre of August 23, 1572 in which Huguenots were slaughtered in mass throughout Paris.

It didn't begin this way, however. During the reign of her son Francis II, Catherine de' Medici took on a 'live and let live' approach toward the Huguenots, preferring to strike pacts and agreements with Protestant darlings such as Antoine de Bourbon.

By the time her son Charles IX took the throne in 1560, following the death of Francis, the situation had become far more intense and the Huguenots were poised for an uprising. In September of 1567, Huguenot forces attempted to overthrow the 17-year-old King Charles and launched France into a civil war. With this act, Catherine lost any sense of mercy or even reasonability she may have had toward the Huguenots and declared them a threat to the country.

She may have found validation in her declaration on the 21st of August when Admiral Coligny, a celebrated French Protestant nobleman was shot and wounded in the arm by an unknown assailant. Fearing a violent response to the attempt on the Admiral, the response came two days later from King Charles IX. Most historians agree that his mother played a contributing role to what would become known as the St. Bartholomew's Day Massacre. It was an attack of persecution which lasted until September of that year. The goal was to annihilate the Protestants of France by assassinating their most powerful leaders and by the end of the massacre, around 5,000 Protestants had been murdered throughout France.

Throughout France reactions to the massacre were, not surprisingly, divisive, the Catholics seeing it as a necessary step in curb-



ing Protestant aggression, though more moderate Catholics were still hoping for a peaceful religious reform. In other parts of Europe, the reactions were far less approving with only Philip II of Spain applauding the massacre. Holy Roman Emperor Maximillian II, England's Elizabeth I, and Ivan the Terrible were among those to voice disgust at the bloodshed.

What remains a subject of debate is the extent of Catherine de' Medici's, or even King Charles's, involvement in the attack. Many agree that King Charles acted on his own without even consulting his mother in an attempt to nip a Protestant uprising and preserve his rule. Some historians construct it entirely as an inevitable eruption of religious tension in France. Somewhat along this theory is that the Royal Family was forced into launching the massacre due to pressure from the French Catholic

Whatever the truth, and it is likely somewhere in the middle of all of these theories is the question of who was Catherine de'Medici. Was she a quiet woman who stood quietly in a loveless marriage watching a husband she could never please build his legacy around her or a viper waiting in the grass to strike. Did she launch one of the bloodiest massacres in European history to preserve the legacy of her family and her son's throne or was she simply acting on the whim of the populace? What if the attack on Admiral Coligny never took place, would have she still opted for religious tolerance?

Perhaps the best way of understand Catherine de' Medici is in her own words, telling her daughter, "My principal aim is to have the honor of God before my eyes in all things and to preserve my authority, not for myself, but for the conservation of this kingdom and for the good of all your brothers."

Here is Catherine de Medici in the truest form. A woman who fought desperately to give her husband a family ended up ensuring the family legacy almost on her own. To her, her family was her greatest accomplishment and she was determined to preserve its stability by any means necessary.

Baking in the Spring

The other day, as I was Pioneer watching the Woman prepare homemade fruit pizzas on the Food Network, an ad came on for a new show entitled Spring Baking. The commercial began with a voiceover narration asking: "So, what exactly is spring baking?", followed by images of people decorating cupcakes to resemble flowers. The question struck a chord with me because, while I am an avid baker who makes treats all year long. I particularly associate baking with the season of autumn. The cool weather and dusky nights seem appropriate for an evening spent in the honeyed glow of a kitchen, feeling the warmth radiating from the oven. Moreover, fall offers a bounty of ingredients suitable for baking, from tart apples to juicy pears to sharp, spicy ginger. However, autumn is far from my thoughts as I enjoy the beautiful springtime. Everything gets me excited, from the days when the thermometer reaches upwards of seventy degrees to the buds growing bigger and greener on the tips of tree branches. I am also getting excited for the new baking opportunities spring offers. Fresh, seasonal ingredients and inspiration from Italy make for a valuable and fun baking experience during the spring.

1) Citrus: Spring is a wonderful time to use up the last of the citrus fruits left over from winter. Moreover, citrus is a staple in Italian cooking, due to the abundant lemon and orange groves that dot the landscape of southern Italy and the islands. The zest of lemons (limone) and oranges (arancia) flavored the many Italian desserts lining the tables of bridal showers and weddings I remember all my life. From soft-baked, glazed cookies, to the waffle-like biscuits known as pizzelle. I love to use citrus in recipes like creamy lemon bars and orange-scented cakes. For Easter, I made a classic Italian ricotta pie accentuated by both lemon and orange peels. In short, citrus desserts are a great way to bid goodbye to the cold weather foolproof dessert! and welcome in spring!

get warmer and the summer is so near I can practically smell sunscreen and sand, my mind wanders to the flavors of the tropics. I happen to love banana bread, a trait I inherited from my father. Moist, spongy banana breads



are an easy recipe to make and offer a quick, healthy breakfast or snack option. One of my other favorite desserts has to be pineappleupside down cake. An impressive finale to any spring meal, these cakes blend the delectable taste of pineapple along with a sweet caramelized topping. Of course, on days when you feel that only an all-inclusive plethora of tropical fruits will satiate your desire for summer, try baking up a Hummingbird Cake. This recipe incorporates bananas, pineapples and coconut, finished off with a velvety cream cheese frosting! You could also take a cue from the Italians and snack on kiwifruit whenever you want a taste of the tropics. A perennially popular fruit there, Italy produces more kiwis than any other country!

3) Strawberries: Strawberries are a harbinger of spring. Whenever I see these ruby-red gems lining the produce shelves of supermarkets, I know that spring has arrived. I love baking with strawberries because of their versatility. My mother once made a strawberry and white chocolate tiramisu for my father's birthday, a summery twist on a classic Italian dessert. Strawberries are also delectable on cakes, pies, cheesecakes and quick-breads. When I went to Italy, I remained impressed at all the innovative uses for strawberries (fragole) in Italian desserts. Italians often drizzled strawberry sauces over custards known as panna cotta, or else served the strawberries in tall, elegant glasses marinated with balsamic vinegar for a savory-sweet contrast. As an essential crop of spring, do not be afraid to experiment with strawberries, as they nearly always guarantee a

An odd, red celery-looking stalk, cooked rhubarb tastes like a cross between a strawberry and an apple. Its tartness perfectly blends with sweet desserts. I have found so many rhubarb recipes that I

would like to try, ranging from strawberry-rhubarb pies to rhubarb chutneys served over lemon-ricotta pancakes — my mother and I once made this latter recipe, and we could not get enough! My favorite rhubarb recipe, however, is one for a moist rhubarb cake with a cinnamoncrumb topping that my father-in-law gave me. I prepare this cake for my May Day celebrations now.

Baking in the springtime is a wonderful experience. Using seasonal ingredients connects us to Mother Earth, which is now blossoming with new life. Sweet desserts made with citrus, tropical fruits, strawberries and rhubarb can serve as lovely finishes to picnics and open-air dinners spent luxuriating in the beautiful spring weather and in the company of nature. Moreover, spring baking offers us the opportunity to engage in the recipes of our Italian ancestors, honoring the food of our heritage and applying our own innovation and creativity to it. So this spring, head to the market and pick up the freshest ingredients available...and from there, happy baking!

Saint Fidelis of Sigmaringen

Fidelis was born Mark Rey in Sigmaringen, Prussia in 1577. His father, Johannes Rey, was burhgomeister. He pursued his studies at the University of Freiburg in the Breisgau, and in 1604 became tutor to Wilhelm von Stotzingen, with whom he travelled in France and Italy and became his lifelong friend. In 1611, he returned to Freiburg to take his doctorate in canon and civil law. and at once began to practice as an advocate, defending the poor. It was the open

corruption which he found in the law courts that caused him to leave the legal profession and enter Religious life. He was ordained priest the following year, and immediately afterwards was received into the Order of Friars Minor of the Capuchin at Freiburg, taking the name of Fidelis.

From the beginning of his apostolic career, he was untiring in his efforts to convert heretics.

He wrote many pamphlets against Calvinism and Zwinglianism, though he would never put his name to his writings. In 1621, he was appointed to undertake a mission to the Grisons region of Switzerland, with the purpose of bringing that district back to the Catholic Faith.

Throughout the winter, Fidelis worked tirelessly and with such success that the heretic preachers were seriously alarmed and set themselves to inflame the people against him by representing his mission as political rather than religious and that he was preparing the way for an Austrian invasion.

At Easter, he returned to Feldkirch to attend a chapter of the order and settle some affairs of his community. By this time the Congregation for the Propagation of the Faith had been established in Rome, and Fidelis was chosen to lead the Congregation's mission in the Grisons. He had, however, a premonition that he would shortly be martyred, preaching a farewell sermon at Feldkirch, he said as

On retuning to be the re-

gion of the Grisons, he was met everywhere with the cry: "Death to the Capuchins!" On April 24th, at Grusch, he made his confession and afterwards celebrated Mass and preached. Then he set out for Sevis. At Sevis, he entered the church and began to preach, but was interrupted by a sudden riot both in and out side of the church. Several Austrian soldiers, who were guarding the doors of the church, were killed and Fidelis himself was struck. A Calvinist, who was present, offered to lead him to a secure place. Fidelis thanked the man but said his life was in the hands of God. Outside the church, he was surrounded by a crowd led by the heretic preachers who offered to save his life if he would renounce his faith. Fidelis replied: "I came to end heresy, not to embrace it", whereupon he was struck down. He was the first martyr of the Congregation for the Propagation of the Faith. His body was taken to Feldkirch and buried in the church of his order. He was beatified in 1729, and canonized in 1745. His feast is celebrated on April 24th.

That fact led Sales Exec Shawn Seipier to quit his job seven years ago to launch Clean the World, a charity dedicated to collecting and recycling leftover hotel soap for those in need. His company has since partnered with Global Soap, and together the two groups have delivered more than 25 million bars to 99 countries. "One of the most effective ways to prevent many deaths is actually just hand washing with soap," said Global Soap Director Sam Stephens. "We're hoping to make a difference."



AMERICA IS A BEAUIFUL ITALIAN NAME

Parla Come Mangi!





Benvenuti! Let's end our visit to Piemonte with a remarkable dessert savoiardi. The house of Savoy, royal dynasty that ruled the Kingdom of Italy from 1861 till the end of WWII, gets its name from the Savoy region, the Alpine area between France and Italy. Fine cakes and pastries were loved in Casa Savoia (House of Savoy) and the first savoiardi recipe was in fact created by one of their pastry chefs in year 1348. Savoiardi, delicious sponge fingers, are a specialty of Piemonte but are also made in other French regions which were once part of the Savoy region.

SAVOIARDI (Ladyfingers)

3 eggs ½ cups sugar ½ cup all-purpose flour

Pinch of salt 1 Tbsp butter 1/4 cup powdered sugar

Preparation: separate the eggs. In a bowl, beat the yolks with 1/3 cup sugar until frothy. Gradually add 1/3 cup flour, a pinch of salt and mix. In another bowl beat the egg whites until stiff and carefully fold into the egg yolk mixture. Grease a baking sheet with butter and dust with flour. Fill the mixture into a piping-bag with a smooth flat nozzle about ½ inch wide. Pipe fingers about 4 inches long leaving enough room in between. Mix the powdered sugar with the remaining sugar and sprinkle half over the fingers. Wait about 10 minutes, until the sugar has soaked in, then sprinkle on the remaining sugar mixture and let stand for a few more minutes. Bake the fingers until golden yellow in a pre-heated 300°F oven (10-15 minutes). Remove the tray from the oven, carefully transfer the sponge fingers to a wire tray using a spatula and allow to cool. Buon appetito!

Sforna e, aiutandoti con una spatola, trasferisci i savoiardi su una griglia di raffreddamento facendo attenzione a non romperli. Buon appetito!

Nanna & Babbononno

A Nostalgic Remembrance



Mom had told me that Babbononno loved dogs. By the time I came along, the only pet I remember was Tippi the cat, which was Nanna's pet. When my mother and her brothers were young, Babbononno had a dog. I believe it was a German Shepherd, but I'm not sure. The only story I remember about the dog was based on a happening when my mother and her girlfriend, Ada Giorgione, were about 15 or 16. Years later, Ada would marry Uncle Nick, but the marriage would disintegrate during

The girls were in their mid teens and Mom had asked Babbononno if she could go to the movies with Ada. It was a Sunday afternoon, and evidently there was a film showing at the Seville Theater that they desperately wanted to see. Babbononno reluctantly gave his okay, looked at his pocket watch and told Mom what time to be home. She and Ada later headed to the theater which, being a local neighborhood movie house, always had double features, usually a B level film preceded by a cartoon or short subject and followed by the main feature.

Ada and Mom arrived after the first film had begun, settled in and watched the rest of it and then saw the main feature. Seeing that this was a Sunday, the Seville ran its films continuously. Mom and Ada decided to stay and see the part of the first film they had missed. Not returning home at the time Babbononno had given to his daughter, he decided to head to the theater to retrieve her and her girlfriend. First, he attached a leash to the German Shepherd, exited the house at 70 Eutaw Street, walked with the dog to Meridian Street, headed south toward Central Square and entered the outer lobby of the Seville with the dog. In his fractured English, Babbononno told the person collecting tickets that he wanted to pick up his daughter.

The dog must have had an intimidating appearance, as my grandfather was not stopped at the entrance, nor did any usher stop him as he entered the lobby and headed for the orchestra area where he knew the girls would be sitting. Once inside, he waited until his and the dogs vision became adjusted to the dark. He then unhooked the dog from the leash, and in Italian, told the dog to find Angelina, my mother's name in Italian. The dog then wandered through the orchestra seats sniffing out the patrons who began squirming, lifting their legs and yelling about a loose dog. Finally locating the girls, the dog barked for Babbononno, who followed the sounds of his dog and found the two girls sitting together. He yelled at them and they immediately got up to leave with my grandfather. Hitching the dog up to the leash, Ada, my mother, Babbononno and the dog left the theater and headed home. They were reprimanded for not being home on time and tried to explain the circumstance, but Babbononno grounded my mother for a week in spite of Nanna trying to explain to her husband the situation as she understood it.

The dog was long gone by the time I was born, but Nanna had an orange and white cat named Tippi. Tippi was her bilingual pet. She spoke English to the cat as did Mom. Babbononno spoke only Italian to the cat, but the animal seemed to understand everything that was said. He was Nanna's cat, though. I remember, one day, Tippi brought a present home and dropped it at Nanna's feet, a mouse it had just killed. I don't ever remember my grandmother swearing at anything or anyone at any time, except this once. She started swearing and dropping Avellinese F-bombs at the cat loud enough for everyone to come running toward her location to see what was wrong.

I guess I inherited my love for animals, especially dogs from my grandparents. When we lived in East Boston, we didn't have any pets, but when we moved to Belmont, one of the first things I did was accept a puppy from a friend who had bought it, but couldn't keep it due to restrictions at her apartment building. Tammy was my dog while I lived at home, but after I was on my own, it became my father's faithful follower. When he was home, the dog never left his side. When Tammi had to be put down years later, Loretta and I inherited a Keeshond and gave it to my folks to fill the void left by the absence of a pet.

After my kids came along, a woman who taught with Loretta told us that her beagle had had pups. She asked us to take one and the kids picked one out of the litter. He was the cutest little thing with orangish, brown and white coloring like many beagles. The kids decided to name him Beagsley and he quickly became part of the family. Seeing he was now part of an Italian family, he became Beagsley Domenic Christoforo.

The backyard had to be sealed off to allow the dog to wander around without wandering away, so I put in a chain link fence which Beagsley disliked, but it was safer that way. The only problem I remember occurred one Saturday afternoon when I got a call from the dog's vet. I answered the phone and the voice on the other end said, "It's Saturday

afternoon. Do you know where your dog is?" I asked who was calling and when the vet told me who she was, I explained that the dog was in the backyard. She then told me to check, and when I did, I discovered that the dog wasn't there. Somehow, he had gotten out and wandered to a Little League field near the house. He decided to join the game that was in session and someone looked at the medallion hanging from his collar. The vet's name and number were listed on the metal disc and a cell phone call to the vet prompted her to call me.

When I arrived at the field, I discovered that the dog had stationed himself at 2^{nd} base and had actually stopped a couple of grounders. The coach told me that he was better than the kid he had playing 2^{nd} base, but the player covering the base had to be a human, not a dog. I leashed up the dog and took him home much to his chagrin.

Beagsley loved the water. When the kids were young, we had a boat that was moored at the Medford Boat Club and whenever we headed out, Beagsley's feet were firmly planted on the front deck. He was the navigator or lookout and led the way for us.

Those were great times and he grew up with my kids, John and Michael. For some reason, whenever Dean Saluti and Margie Cahn came over, Beagsley loved to jump on their laps and be lovey-dovey. They weren't too happy with this, but never really said anything to keep peace in the family.

When the boys went off to college, Beagsley became my dog and we grew older together. A few years ago, there were too many things wrong with our beagle and we had to put him down. To keep his memory alive, we use his name daily. I have his name immortalized in our email address. In the future, if any of you would like to get in touch, you can email me at beagsley@rcn.com. 

Covington, originally believed that the course of appeals would take at least a year, but his appeal on the grounds that Ali was a Muslim minister and conscientious objector had been refused. Covington's latest maneuver the suit against the draft board contending there is a lack of Negro representation and therefore existing prejudice — is no more than a delaying action. Covington believed he would win in the courts on the question of Ali's minister-objector claim, but this would come only after he reports for induction, which could be in May in Houston. No one was sure he would report. If he failed to do so, he would go to jail and Covington would get him out on bond until the issue was decided.

Whatever the outcome, Ali was a gifted champion. Yet polemics and debate surrounded each of his fights, and the judgments, usually

discrediting, were frequently colored by personal distaste. Even among boxing people, who accept any behavior short of having their wallets lifted, Ali is anathema, and they, like much of the press, couch their prejudices with tiresome criticisms: Ali can't punch, Ali can't take a punch, and, anyway, everyone he fights is just a pug who would be knocked down by a spring wind.

Fight people just refused to accept him, and he seemed to know it when he spoke at boxing's annual testimonial to itself several days before the fight.

Only a few remained on the dais and their heads, attached to broken noses and long cigars, hung down or to the sides, the eyes occasionally rolling at the intense verbal bombast and idiocy strafing the room. The dinner, it was obvious, had quickly become the party scene in Little Caesar, the one where Rico is given a gold watch for his banditry and sparkling handiwork with a chopper. But the star of this show had left, taking with him only the night and leaving behind the one provocative line of the evening: "After I go," said Muhammad Ali, "boxing will go to the graveyard."

Will Swift, despite his hurt, could believe that. When will boxing?

Is Fast Track or TPA Constitutional?

A federal appeals court held in 2001 that the issue of whether the NAFTA should have been approved as a treaty was a non-justiciable political question (Made in the USA Found. v. United States, 242 F.3d 1300 (11th Cir. 2001)). The U.S. Supreme Court denied review in the case. In other words, if you think Congress violates the Constitution by treating FTAs as Congressional-Executive Agreements rather than as treaties, the only remedy is to elect a Congress that won't do that. But that won't happen because the people who object to fast track, progressive and TEA Party members will never work together to elect any one.

As early as 1890, Congress delegated tariff bargaining authority to the President and authorized him to suspend existing duty-free treatment on particular items by proclamation. The Supreme Court subsequently held that the authorizing statute, § 3 of the Tariff Act of 1890, 26 Stat. 612, did not unconstitutionally delegate either legislative or treaty-making authority to the President.





Sullivan lost money to keep his franchise in Boston, never looking to leave the city he loved. For Sullivan it was Boston or bust. Unfortunately for Sullivan, his on field product has secured him an undeserved contemptuous legacy in Boston sports history.



After Muhammad, a Graveyard

The heavyweight champion won an interesting fight against an aging, but surprisingly worthy challenger. Now Ali's clouded future raises the possibility that the ring soon may be deprived of its most colorful figure.

The little sport from the West, 12 years old, wheyfaced, hat on his knee, tie in place, hair slicked down, sat on the wooden bench next to the heavyweight who was now just a truck driver from Arizona. The kid's eves were red, and he would not look at the fighter, who kept glancing out of the corners of his eyes at the son of his manager. Outside, in the dark corridor, a lightweight was howling: "Why do ya bums always fall over for that bum?" Zora Folley was not listening. He was listening to the sound of a dream dying.

"What I tell ya, what I tell ya?" the trainer, Johnny Hart, kept saying. "It was his right hand that ruined us. I warned him about Clay's right. I said double safety. Get out. Move back in a hurry when Clay gets set. Folley didn't do it. It was that simple."

The kid, Will Swift, had had enough. His face turned up at Folley, and his eyes were wet. "It's unfair," he said. "Clay cheats. That was no way for poor Zora to lose. That's not the way a prizefight should go. Clay confused Zora, flapping his hands, dancing and just doing crazy things. Poor Zora. I hate Clay. No, I don't. I know it's wrong. Clay is a great champion."

Folley was silent. Soon he put on his long, gray overcoat. While Muhammad Ali with the Muslim guard prancing in front of him and shouting, "Out the way, get out" - entered the Midtown Motor Inn across from the Garden, Zora Folley departed like an old, humble preacher leaving a gospel tent. He faded into the darkness of Eighth Avenue, a street of no face and no names, where already the scramblers and the ramblers, and the price to get inside, were yowling that one Zora Folley was just another stiff for a bigmouth draft dodger.

Some critics came at you with the same pitch the next day, but the fact is — unless one was looking at Ursula Andress all night — Folley had nothing to apologize for.

Even his "heart," which was quite suspect before the bout, stood up. He made the best fight he could, and it stands as one of the more interesting fights Ali has had. Age (he's 34 and had been in 85 bouts) and caution — his reluctance to vary, even slightly, the style that had given him 40 knockouts — beat Folley. He was also beaten by a patient, disciplined and "scientific" performance, which Ali had promised Folley just because he was such a "civilized, respectable" man.

Still, Folley did accomplish some things. He cut the ring down on Ali. He hit the champion more often than any other opponent with solid right hands and slip jabs. He did not panic when Ali got cute. Faking and feinting, he forced Ali to miss several good punches. On the negative side — besides being knocked out — he obstinately clung to one stratagem; while moving to his right, he kept looking to throw a right-hand counter. It did not take Ali long to learn that he could go in flat-footed and ram home his good right hand, which so many people doubt he possesses.

It is also a popular opinion that Ali just played with Folley the first two rounds, but it is more likely that he was measuring Folley's reactions and the strength of his punches. It wasn't until the third round that Ali began working. His straight left hands — not his jab — kept snapping Folley's head back. These were the punches that started Folley on his way out. At the end of the third round, Ali told his corner that Folley had begun to tire, that his punches had lost some of their life.

In the fourth, Ali, now punching flat-footed, spun Folley around with a left hook and then banged a right hand in back of his ear. Folley went down; he was flat on his stomach, and then suddenly he was up, his nose streaming blood, he was kneeling and looking to his corner for the count. Folley raged back, but he had left too much of himself on the floor. Ali, it appeared, carried Folley in the fifth and sixth rounds, but going into the seventh Herbert Muhammad, Ali's manager, told him to "stop playin'." He did. Two rights, the first of which traveled roughly six inches, gave Ali his 29th straight victory and his ninth successful title defense, and sent Folley back to the anonymity in which he has long labored — and seemed to prefer.

Back on his feet and alert, Folley began looking for his son Junior. The boy was brought into the ring, and

he looked at his father and then he glanced down at his shoes.

"Come over here!" Ali ordered the boy. "Don't be ashamed. I know you are disappointed, but your father put up a good fight. He's a good fighter, a slick, scientific boxer, and if we'd met 10 years ago things might have been different."

Ali, indeed, had been exceptionally decent to Folley, so much so that the fight lacked character. Each of his fights, of course, always seemed to present Ali as a brilliant musician and his opponent as a mere instrument for his will and artistry, but each has always had a distinct current running through it. Ernie Terrell was the self-seeking Uncle Tom. In the European fights, Ali was the noble, misunderstood black prince in exile. Against Cleveland Williams, he was the old, uncomplicated colored boy from Louisville, full of fun and quiet charm. For Folley, who had no desire to engage in blather or even mock animus, Ali was just a fighter. The gate was plainly in danger, until the draft board requested Ali to appear for induction on April 11. That same day he began to create the character dramatization that rescued the box office.

"This may be the last chance," he said, "to see Muhammad Ali in living color, so if you have always been wanting to see me, you'd better come to the Garden." Later he said: "Perhaps in one to three years I will fight again." The "one to three" seemed to indicate he would choose a jail sentence to military service. He would not disclose his decision, but his hints were cleverly camouflaged. "My life, my death, all my sacrifices," said Ali, who had a curious bent toward martyrdom, "are for Allah. I am the tool of Allah and because of my sacrifice it will come out that hundreds of Muslims are in jail rather than fight in the Army. Or even just to go into the service."

It was likely that Ali would not fight in the near future; already, in an effort not to antagonize the government, he canceled his May 27th fight with Oscar Bonavena in Tokyo. His lawyer, Hayden

HOOPS and HOCKEY in the HUB

As the NHL Stanley Cup playoffs proceed without the Bruins, one might think that things have been finalized for the immediate future on Causeway Street. But such is not the case.

In fact, things are more uncertain and up in the air now than when the Bruins played their last home game back on April 4th. For now, the Bruins are without a general manager and they may be without a coach come later in the spring.

When Bruins President Cam Neely and Delaware North Boston Holdings CEO Charlie Jacobs let GM Peter Chiarelli go, they didn't do the same for Head Coach Claude Julien — who has several years remaining on a contract extension.

Rather, they indicated that Chiarelli's successor, whoever he might be, will make that call on who will coach the Bruins for the 2015-2016 season.

"It hasn't fully been made," said Neely during a press conference with reference to whether a decision had been rendered concerning Julien. "We met with Claude, Charlie and I, and we told him that we really believe that once we go through the exhaustive search to find the next general manager that we will leave it up to that GM to decide what he wants to do with our coaching staff. Claude certainly understood that, but that's where we left it."

Right now, that's a non-decision that's not fair to Julien. It might sound a bit odd, but Chiarelli is now actually in a better position than Julien. That's because the decision has been made regarding him and now he's free to become a candidate for other openings as they become available.

We have a strong feeling that he won't be unemployed long, especially when his recent resume includes a Stanley Cup Championship (2011) and a Stanley Cup finalist (2013). Plus, he's able to be available for any GM position that becomes available. He'll have, so to speak, his pick concerning where to apply. The full range of openings will be his to consider.

Not so with Julien. First of all, let us state right here that we hope Coach Julien is back next season. The same recent resume that Chiarelli has on the GM side, Julien has on the coaching side — the Stanley Cup Championship and the Stanley Cup finalist. Those aren't exactly weak reference points.

Julien wants to come back.

During their meeting with him, Neely indicated that he and Jacobs "told him the situation. We asked him (if he wanted to return) and he said 'I signed a contract to coach here. I want to coach here.' So he made that clear. We had planned to meet with him to talk about the answer.

coming season and the past season so that's our next agenda with Claude."

But knowing the B's over the years, one must actively consider the possibility that Julien might no longer be the coach of the B's in a couple of months. If that's the case, Julien could well have fewer opportunities for employment than Chiarelli since a number of the head coaching vacancies will have been filled by then. And that's just not fair to Julien, who took the B's to the championship for the first time since 1972 and nearly repeated two years later.

Ironically, the same situation played out a number of years ago when Chiarelli was hired. The Bruins dismissed GM Mike O'Connell, but kept Head Coach Mike Sullivan aboard. When Chiarelli was finally hired in June (he had been the assistant GM at Ottawa), he fired Sullivan — who had been in the same indecisive no man's land then as Julien is now.

It was getting late in the NHL coaching employment line and Mike saw several opportunities go by the boards while he waited and waited, only to be finally shown the door. Sullivan would become an assistant at Tampa Bay 11 months later.

Jacobs even made reference to the similarity.

"Having been through the process before, when we transitioned from Mike O'Connell to Peter Chiarelli, it (the fate of Sullivan) was part of the interview process. It was a question that was asked of all the candidates. But in all candor, in order to find the best candidate you have to give them the freedom to make those decisions on their own. They have to arrive at their own conclusions — without prejudice from management. That's how you allow them to fulfill their duties to the best of their abilities. So yes, it will be part of the process. We will certainly say: 'We think we have a good coach. We'd like to hear your input on it. The decision is ultimately yours, new GM.' We will be trying to find the best candidate to be our next general manager. And the decision will be his regarding the coach."

Another dynamic may well come into play. Neely described Julien and Chiarelli as being essentially on the same page. "Those two, in my opinion, have a great working relationship and have had one for a number of years." That's not surprising given that Chiarelli hired Julien. He was, after all, Chiarelli's appointment.

But the same won't be true of the next GM. Julien won't be his appointment. He will be a holdover appointed by someone else. Whether that will be enough to impede "a great working relationship" is anybody's guess. Come later this spring, we'll know the answer
