## A PRESIDENT, AT LAST

(And Maybe a Government, Too)

So, Italy finally has a president: not a brand new one. but at least it has one. And after two months of total stalling the, re-election (an unprecedented fact in Italian history) of 88 year-old Giorgio Napolitano to another seven year mandate as Head of State, is a defi nite step ahead for a parliament that since the February 25th vote has not managed to agree on anything at all, and a country which, in the midst of its worst crisis since World War II, is in desperate need of a functioning

executive government. Now, the fact that there is a President does not automatically mean there will soon be a government. Especially considering the fact Napolitano already tried unsuccessfully in this past 56 days to form one.

In fact, due to a byzantine and inefficient electoral sys-

tem, the vote two months ago created a parliament (especially in the Senate) evenly split in three: Silvio Berlusconi's center right party - People of Liberty (PDL), Pierluigi Bersani's center left party - Democratic Party (PD) and Beppe Grillo's anti-establishment

Five Star Movement (M5S); these three political forces were so far from each other (more ideologically, really, than in terms of programs) to the point of aprioristically refusing to govern in coalition with any of the other two.

After consulting with all the forces in the field, as provided by the Constitution, Mr. Napolitano tried anyway to make something happen, by giving Mr. Bersani as the leader of the party that came out of the election with a razor thin yet relative majority, the mandate to form some kind of a government. However, after running his own round of consultations and meetings, the head of PD could not come up with the necessary number of senators (50% +1) needed to grant a confidence vote to a





#### Pray for America



The National Day of Prayer was established as an annual event in 1952 by a joint resolution of the United States Congress and signed into law by President Harry S. Truman. The observance of the National Day of Prayer is founded on the constitutional rights of freedom of speech and freedom of religion and can be celebrated by all Americans.

Millions will answer the call to prayer on May  $2^{nd}$  in observance of the  $62^{nd}$  annual National Day of Prayer. Organized events will be held in thousands of public venues where intercession will be made for America and

its leadership.

This year's theme, "Pray for America," is based on Matthew 12:21 which reminds us that, "In His name the nations will put their hope."

There are nearly 20 events scheduled throughout the Commonwealth, including one to be held at the State House in Boston on Thursday, May 2nd from Noon to 1:00 pm in the Gardner Auditorium.

Days of prayer have been called for since 1775, when the Continental Congress designated a time for prayer in forming a new nation. In 1863, in the midst of the Civil War, Abraham Lincoln called for such a day. Officially, the NDP was established as an annual event by an act of Congress in 1952 and was signed into law by President Truman. Congress and President Reagan amended the law in 1988, designating the first Thursday of May each year as the National Day of Prayer.

## **MassHealth Paid \$9 Million in Unallowable and Excessive Drug Tests**


State Auditor Suzanne M. cally necessary reason. In FY Bump today announced an 2012, MassHealth paid for audit of MassHealth, which found thousands of unallowable and unnecessary drug tests that are costing the Commonwealth millions of dollars annually in Medicaid expenses.

MassHealth, with expenditures of over \$11 billion, provides access to healthcare services for approximately 1.3 million eligible low- and moderate-income individuals annually. MassHealth pays for drug tests as long as the tests are ordered by a physician who is actively treating the member and is being requested for a medimore than 839,000 drug tests costing the program \$18 million. Today's audit report found millions of dollars spent on excessive drug testing and tests that were not being used for diagnosis, treatment, or other medically necessary reasons.

"Medical testing should only be performed when there is medical necessity," said Auditor Bump. "Clearly millions of dollars has been spent on drug tests that have done little to help addicts in recovery but much to increase revenues for testing companies."

Contrary to guidelines set by the federal Substance Abuse and Mental Health Services Administration, the audit found MassHealth members being tested at a high frequency — every day or every other day - for periods sometimes exceeding a year. During a three-year period, 6,282 MassHealth members received more than the recommended eight tests per month, for a total cost of \$24.3 million. The report says MassHealth could have saved approximately \$7.8 million in the same period had it more

#### TERRORIST #2 LAWYERS UP

I refuse to give either of the terrorists names because they can't be real human beings after the act they perpetrated. Their actions were an act of war. The horrible bombings near the finish line of this year's Boston Marathon were committed by radical Islamic jihadists. Three people were killed and 173 others were injured, several in serious condition.

Latest word out of Washington, D.C. is that Terrorist #2 has now lawyered up after being read his Miranda Rights and given legal counsel at our expense. Whatever information provided from him during the first 48 hours in custody will be the last tidbits of information he will be offering.

As I listened and watched a press briefing by Jay Carney, the president's mouthpiece, I wanted to scream at the TV screen. The Obama Administration has now said Terrorist #2 will be put on trial as a civilian in a federal court because as Carney stated, America doesn't try U.S. citizens as enemy combatants. ## L'Anno Bello: A Year in Italian Folklore

The Merry Month of May

When I was younger, I fact that the many ancient Italian-American men and viewed the month of May as a time of transition, the point when I could officially begin counting down to the last day of school. Teachers propped open windows to let warm breezes circulate the classroom, I could walk outside without a jacket, and Memorial Day weekend felt so close I could practically smell the barbecue as soon as I flipped the calendar to May 1st. I work in the education field so May still signifies the winding down of the academic year for me, but now I can also appreciate May as an exciting month in its own right. It is a month of blossoming flowers, trees shining with waxy green leaves, and bumblebees humming around the bushes. I always thought these signs of flourishing spring seemed like magic, but it turns out that May really was considered a month of magic. In Italy and elsewhere, May remained synonymous, since ancient times, with supernatural beings and mystical occurrences. After all, it is easy to picture magic in the air when spring life is blooming all around you. This connection between May and magic inspired the celebrations of the holiday that begins the month, May Day.

The day before May Day, April 30<sup>th</sup>, is called Walpurgis Night in Europe. Its name derives from a mysterious Saint Walpurga, and its traditions stem from old pagan rites honoring the start of the summer season. During this time of transition, witches, fairies and other paranormal entities are said to roam the land, giving Walpurgis Night a connection to Halloween, which falls six months later. In Scandinavia and northern Europe, Walpurgis Night is celebrated with picnics, bonfires and dressing up like witches. In Italy, the eve of May Day calls to mind the conditions in this country.

Romans holidays commemorated the dead in the May perhaps explaining why a popular superstition claims that it is bad luck to get married in May. May Day itself signals the beginning of summer and heralds a whole month devoted to woodland spirits. Some Europeans celebrate May Day by decorating their homes with greenery and dancing around a May Pole festooned with garlands of ribbons and flowers, all acts said to promote fertility in crops. May Day is known as Calendimaggio in Italy and brims with a number of folkloristic traditions. The Calendimaggio of Assisi, a lovely small medieval city, consists of parades of townspeople dancing and singing while dressed in elaborate Renaissance costumes. The Calendimaggio of the town of Nogaredo, located in Italy's northern Trentino region, delves into the supernatural roots of May Day with a witchcraft theme. The May Days of Italy, therefore, keep the magic of a fertile, blossoming season alive

May Day in Italy also comprises of a public holiday: Festa del Lavoro, part of International Workers' Day. As the Italian version of Labor Day, businesses close and many families go on vacation, visiting the beach, enjoying picnics, or touring famous Italian destinations. Others go to parades honoring the successes of the Italian labor movement or even partake in protests against injustices in the workforce. I like to think of this day as a chance to honor the inroads my Italian ancestors made in the area of industrial labor. I am currently taking a course in American labor history, and I was so pleased and surprised to learn how fiercely Italian immigrants fought for safe, equitable work

women organized unions, participated in strikes and rallied communities together in order to provide support to injured workers and their families. We can thank the involvement of Italians and other immigrant groups for reforms such as shorter work days and laws against child labor. Unfortunately, many unjust work conditions still persist in this country and around the world, but the action of Italian-American workers in the United States demonstrates how committed and caring individuals can make a difference in these matters. In the midst of May magic and flowering spring life, this other side of May Day reminds us that we have magic inside us, able to bring love and change to the world.

May, far from the simple transitional month I remember from my childhood, is a time of magic and mystery. It honors the growth of Mother Earth, the start of a warm summer season, the presence of trees and flowers and life-affirming crops. Ancient European holidays like Walpurgis Night and Calendimaggio show us that there is so much mystery in the world, flitting and hiding in balmy spring nights. The Festa di Lavoro, which also falls on May 1st, provides us with a chance to honor our hard-working Italian ancestors and take advantage of the warm weather to band together as a peaceful, forward-thinking community. From witches to workers, flowers to medieval parades, let us enjoy the wonderful magic that surrounds us and move into May with a positive attitude!

#### Is it Public Safety or a Cash Cow?

As a police officer who is soon to retire after more than 27 years on the job, I am a bit hesitant at the idea of license plate reading devices on dashboards of police cruisers. This technology is exploding rapidly and police departments are scanning countless license plates driving past police cruisers for no other reason than by chance. I am concerned about privacy and possible misuses of this technology. As a crime fighting tool, this license recognition technology seems very worthwhile but is it not also a great revenue enhancer for local communities to use rather than raising taxes? Is that a good use of invading our privacy while motoring? I don't often side with the concerns of the American Civil Liberties Union but I am concerned, like the ACLU is, about databases recording the movements of people in the course of an ordinary day. As a baby boomer, I remember too well the required reading in school of books like George Orwell's "1984" as

well as "Brave New World." Sgt. Robert Griffin of the Chelsea Police Department says the State Legislature up on Beacon Hill should "trust law enforcement to do the right thing." Even President Reagan said, "Trust but verify."

If used wisely, license scanners can be an effective public safety tool, but if it's main purpose is to write citations to collect fines, is that a proper use of the technology? I agree with State Rep. Jonathan Hecht who seems to put things into proper perspective, "Technology is rapidly moving ahead in terms of our ability to gather information about people. We need to have a conversation about how to balance legitimate uses ... with protecting people's legitimate expectation of privacy."

Before moving too quickly, we need to assure citizens that we aren't being spied on to build databases. The job of the police is to serve and protect but not necessarily scan and record.

possible cabinet of ministers of his choosing.

At that point the ball was back in Napolitano's camp: yet being in the last semester of his seven-year mandate (the so-called "white semester") the president could not dismiss the chambers of Parliament and send the country to another national election. All he could do was buy some time, and while waiting for the election of the new president scheduled for April 19th, appoint a special committee of ten socalled "wise men" (experts in the main fields of government) to come up with a national interest "to-do-list" for the next government (whatever its political color might be).

Then, finally, came the election of what everyone thought was going to be Napolitano's successor little did we know it was going to be him again! According to the Italian constitution it is up to the parliament to do so: thus, it came as no surprise that an assembly that could not find an agreement on a government that, given the premises, could have lasted a few months could not agree on the name of someone who would hold the country's highest office for the next seven years.

Few names were made, and voted on, from former Prime minister Romano Prodi to long time Labor Union leader Franco Marini, but the first five secret ballots revealed that disagreement ran high even within the single forces - in particular the PD - the leaders of which, as a result, all resigned their position, leaving the party at risk of crumbling into several different factions.

Then, last Friday, came the sixth round of voting, and the only name the left and the right (but not Grillo's movement) seemed to agree on, was that of Giorgio Napolitano, the old veteran of Italian politics, who after being a member of the parliament for over sixty years, had oversaw it as the President for the past seven.

It was a clear landslide: 738 votes out of 997, many more than the 50% needed from the fifth round on (even more than the 66% needed for the first four). Yet it was a just as clear solution of last resort. Also considering the 88 year old president who had already said many times he wanted to retire had to be begged to accept the re-election.

In the end he did, like an old father who, one more time, takes his children out of the trouble they are responsible for. But he made sure to scold, in an intensely emotional acceptance speech, each and every political party for not hav-


vented the current stalemate from ever occurring) during over a year of Monti's technical government. And for not being able, or wanting to, come up with some sort of an agreement over the last two months to give the country in deep economic and social trouble a desperately needed government.

"So far you have been deaf to my callings," he said to the two chambers reunited amid loud cheer and applause (by the same people he actually came short of insulting) "and if I encounter the same deafness, I will make you face the consequences before the country."

The "consequences" (dismissal of the Chambers for new elections or a resignation which will leave the parliament in the same quagmire it comes from) are clear to all and now, thanks to a freshly renewed mandate, Napolitano has the constitutional right to implement them at any given moment.

Hence, the left and the right have no other choice left other than comply: accept - together - whatever name he comes up with for Prime minister, vote - together - the confidence to whatever cabinet he or she will choose to put together, and quickly pass - together - the reforms suggested by





#### WHEELCHAIRS FOR DISABLED DOGS

There are many carts and wheelchairs specially designed to help disabled dogs. Mobility-assistance devices for disabled animals have been around for years. But thanks to improved technology and enhanced design, today's doggie wheelchairs and carts are sturdier, more comfortable and more reliable than ever before, according to County Veterinary Clinic, Okemah, Okla.

#### A QUALITY LIFE

These devices are designed to help an animal live a better quality of life as they're going through major health issues such as recovery from skeletal surgeries, car accidents and other injuries. Some dogs need them permanently, such as older pets that have developed arthritic situations or musculoskeletal illnesses, but there is more of a need for them lately on a temporary

Gina A. Bolger, CVT (Certified Vet Tech) of Pima North the freedom of mobility. Animal Hospital, Scottsdale, Ariz., said that common disabilities requiring carts and wheelchairs include osteoarthritis and neurologic problems. Wheelchairs are also used often during physical rehabilitation of injuries, especially in large breeds of dogs. "Depending on the injury or issue, some pets recommends. may use the device for a



short time or part time throughout the day for recovery, while others may have to use them for life," Bolger said. Every pet recovers differently, but typically 8 to 12 weeks of use of one of these devices is typical.

Bolger said that aside from providing rehabilitative and practical benefits, pet wheelchairs and carts can bring pep and enthusiasm back to your pooch, making them feel more normal while recovering from an illness or traumatic event by providing

#### ROUNDING OUT THE **DETAILS**

Pet carts and wheelchairs come in many different sizes and configurations, some with two wheels and others with four. You can expect to pay from several hundred to a few thousand dollars, based on the type of device your vet

Some vendors and provid-

ers also rent these units out, but most are purchased by the owner because the sizing plays a huge part in the warranties and the pricing. Most mobility-assistance devices are designed to support the rear of the animal, because most injuries and illnesses typically involve the rear legs first, Evans said. Equipped with a rear-support cart or wheelchair, the dog is able to use its front legs to walk and possibly even run if recommended by the veterinarian.

All wheelchairs and carts are custom fitted to the size of the dog. Extra consideration is taken for extra-large dogs to ensure balance and sturdiness. "It's up to the vet to decide which device is right for your dog, depending on the dog's needs and what products and models are available," said Evans, who invented the Evans Mobility Unit, a four-wheeled supportive device ideal for all kinds of handicapped animals, from dogs and cats to small pets to small cows. "But there are more and more of these products entering the marketplace, which is a good thing for consumers," he said.

## **IRA CONTRIBUTION LIMITS RISE FOR 2013**

#### Save a Little More for Retirement

Time to boost your IRA balance. In 2013, you can contribute up to \$5,500 to your Roth or traditional IRA. If you will be 50 or older by the end of 2013, your contribution limit is actually \$6,500 this year thanks to the IRS's "catch-up" provision. The new limits represent a \$500 increase from 2012 levels.1

January is an ideal time to max out your annual IRA contribution. If you are in the habit of making a single annual contribution to your IRA rather than monthly or quarterly contributions, try to make the maximum contribution as early as you can in a year. More of your money should have an opportunity for tax-deferred growth, not less. While you can delay making your 2013 IRA contribution until April 15, 2014, there is no advantage in waiting — you will stunt the compounding potential of those assets, and time is your friend here.2

Do you own multiple IRAs? If you do, remember that your total IRA contributions for 2013 cannot exceed the relevant \$5,500/ \$6,500 contribution limit.<sup>3</sup>

Your IRA contribution may be tax-deductible. Are you a single filer or a head of household? If you contribute to both a workplace retirement plan and a traditional IRA in 2013, you will be able to deduct the full amount of your IRA contribution if your modified adjusted gross income is \$59,000 or less. A partial deduction is available to such filers with MAGI between \$59,001-69,000.4

The 2013 phase-outs are higher for married couples filing jointly. If the spouse making the IRA contribution also participates in a workplace retirement plan, the traditional IRA contribution is fully deductible if the couple's MAGI is \$95,000 or less. A partial deduction is available if the couple's MAGI is between \$95,001-115,000.4

If the spouse making a 2013 IRA contribution doesn't participate in a workplace retirement plan but the other spouse does, the IRA contribution may be wholly deducted if the couple's MAGI is \$178,000 or less. A partial deduction can be had if the couple's MAGI is between \$178,001-188,000. (The formula for calculating reduced IRA contribution amounts is found IRS Publication 590.)5

You cannot contribute to a traditional IRA in the year in which you turn 70½ or in subsequent years. You can contribute to a Roth IRA at any age, assuming your income permits it.1

contributions this year? Single filers and better.

heads of household can make a full Roth IRA contribution for 2013 if their MAGI is less than \$112,000; the phase-out range is from \$112,000-127,000. For joint filers, the MAGI phase-out occurs at \$178,000-188,000 in 2013; couples with MAGI of less than \$178,000 can make a full contribution. (To figure reduced contribution amounts, see Publication 590.) Those who can't contribute to a Roth IRA due to income limits do have the option of converting a traditional IRA to a Roth.7

As a reminder, Roth IRA contributions aren't tax-deductible — that is the price you pay today for the possibility of tax-free IRA withdrawals tomorrow.8

Can you put money in an IRA even if you don't work? There is a provision for that. Generally speaking, you need to have taxable earned income to make a Roth or traditional IRA contribution. The IRS defines taxable earned income as ...

- Wages, salaries and tips.
- Union strike benefits.
- · Long-term disability benefits received before minimum retirement age.
- · Net earnings resulting from selfemployment.

Also, you can't put more in your IRA(s) than you earn in a given year. (For example, if you are 25 and your taxable earned income for 2013 amounts to \$2,592, your IRA contributions for this year can't exceed  $$2,592.)^9$ 

However, a spousal IRA can be created to let a working spouse contribute to a nonworking spouse's retirement savings. That working spouse can make up to the maximum IRA contribution on behalf of the stayat-home spouse (which does not affect the working spouse's ability to contribute to his or her own IRA).

Married couples who file jointly can do this. The IRS rule is that you can contribute the maximum into this IRA for each spouse as long as the working spouse has income equal to both contributions. So if both spouses will be older than 50 at the end of 2013, the working spouse would have to earn taxable income of \$13,000 or more to make two maximum IRA contributions (\$12,000 if only one spouse is age 50 or older at the end of 2013, \$11,000 if both spouses will be younger than 50 at the end of the year).6,9

## Recipes from the Homeland

#### Calamari (Squid) in Tomato Sauce Over Linguine

- 14 ounces crushed tomatoes 1 medium chopped onion
- 1 large chopped garlic clove (optional)
- 1/4 cup olive, canola or vegetable oil
- 1 teaspoon dried basil or two fresh basil leaves
- 2 pounds already cleaned calamari (squid)
- 3 tablespoons white or red
- wine of choice 1 pound of linguine
- grated Romano or Parmesan

Heat oil in skillet, add chopped onion, garlic (optional), and basil. Simmer until onion is opaque. Garlic should not brown. Add crushed tomatoes and stir thoroughly. Cover and simmer sauce until it comes to a slow boil. Lower heat and simmer for about twenty minutes. Stir occasionally to prevent sauce from sticking to the bottom of skillet. If mixture appears to be too thick, add a half-cup of water and

Cut tentacles from calamari if not already separated. Wash and cut each calamari into approximately one-inch widths. Do not cut lengthwise. A small calamari should give about three portions. Wash both thoroughly. Set aside in a bowl.

When sauce has simmered about twenty minutes, add calamari and tentacles. Then stir and cover. Simmer calamari in sauce for about five minutes. Do not overcook. calamari will become tough if cooked too long. Cover and remove skillet from heat until you are ready to cook pasta.

Cook linguine, or pasta of your choice, according to the directions on the package.

While pasta is cooking, return calamari sauce mixture to burner to reheat slowly. Add three tablespoons of red or white wine of choice. Bring to a slow boil. Turn off burner and remove from heat. Place cooked and strained pasta onto a serving platter and top with tomato sauce, calamari, and grated cheese of choice.

OPTIONAL: Adding additional calamari to the sauce will allow some to be served with the pasta and some separately with a fresh green salad. Remaining sauce freezes well. Serves two.

NOTE: In the 1930s, I remember my mother standing at the sink removing the thin layer of outer skin and the inner portions of the squid. She removed the tentacles and placed them in a separate bowl. When I asked if she was throwing the tentacles away she quickly replied. "No! Sono buoni!" (They are good!) Mama was right. I always include them in the sauce.



# Nanna & Babbononno

by John Christoforo



A Nostalgic Remembrance

Like everyone else, I watched the events develop after the two bombs went off at the finish line of this year's Patriots' Day marathon. As the week progressed, two brothers were singled out and law enforcement groups consisted of Boston Police, Watertown Police, Cambridge Police, M.B.T.A. Police, college police units, police from several surrounding suburban towns, the F.B.I., and many other federal agencies that handle terrorism showed up to handle the problem.

As of last Friday, it was all over, one dead and the other wounded and in custody. Even the governor and the president got involved. I was up late that Friday night and began thinking about a gun fight I had witnessed in East Boston when I was a kid. It was around this time of the year in, I think, 1955. It was early afternoon on a Saturday and I was working the kid's matinee at the Seville Theater. Before I left the house, Babbononno asked if I was going to work. When I answered in the affirmative, he said he would walk with me as he was heading to one of the store-front clubs in Central Square to meet up with a few of his paesani to play cards and gossip about the events of the week.

We walked down the Eutaw Street hill to Meridian Street, headed left toward Central Square, and after we passed the intersection of Trenton Streets and Meridian, saw a bunch of police cars a block away near where Lexington and Meridian intersect. As we approached, the police stopped us from passing through the area. Just then a police officer that often worked details at the Seville spotted me and told the cop that stopped us that he knew us and would walk us through the location. It seems that a local hood that they called "The Pig," was held up in a house across the street and wouldn't come out. He was wanted for some crime, I never found out caught up with him and he wouldn't give up. Just as we passed the area where the police were behind cars with guns drawn, the shooting started. Babbononno and I now behind a car with a bunch of other on-lookers stared in amazement. From a second floor window across the street, shots rang out hitting the cars and build-

ings on our side of the street. The police fired back and the gun fight continued as a standoff for what seemed like an eternity. Finally, the police shot a canister of teargas through the second window of the building, and a few minutes later, a coughing voice yelled out, "Don't shoot, don't shoot, I give up, I give up!"

When a rather rotund in-

dividual exited the building, he was tackled by several police-men from Station 7, handcuffed and carried away to an awaiting open wagon called a Paddy-wagon. The term was given to the transport vehicle decades earlier by the police in Boston as an insult to the Irish population, but the name stuck. I couldn't wait any longer and hurried Babbononno along as I had the keys to open the theater. When Mr. Ray, the manager, and Dave Turner, the stage manager arrived, they asked me what all of the commotion was about, and as we readied the theater for the arrival of the kids, I told them the story. Mr. Ray knew who the person was that the police called The Pig. He commented that he was a regular, often attending on Wednesday and Sunday nights with a very thin girl that was known as The Straw. Knick names were alive and well in Italian neighborhoods back then. When the motion picture camera operators arrived, they wanted to know what all the commotion was up the street and I told them. When my ushers arrived I went through the same routine with them. The first picture started at around 1:00 pm, and once all the kids were seated with their popcorn and candy, there was a group of adults that stopped at the ticket booth. I thought it was a bit strange, as on Saturday afternoons when we had kid's matinees, usually there were no adults that came in to the theater. I walked out toward the ticket booth and soon became surrounded by the crowd. They were reportwhat, but the police finally ers from all of the Boston daily news papers and the East Boston Free Press. They were looking for someone called "Johnny the Usher."

> That was one of my knick names back then, along with Johnny Seville and Kid Seville.

The crowd of reporters hit me with dozens of questions as I was spotted and pointed out as someone who saw

the whole thing. I gave my version of what happened and wound up in the newspapers as Johnny Seville. No one questioned how my last name was the same as the name of the Theater. When they had their stories, they left. Dave, the stage manager, relieved me at the door and I went in the theater to help out my ushers.

The main feature was followed by ten cartoons with a couple of encores that were accepted with cheers coming from the kids. Once the matinee was over, my ushers and I picked up the seats to make things easier on the cleaning ladies, and I was ready to head home for an early dinner, as I had to be back for the evening's performance and to help Dave, the stage manager, change the advertising and the marquee. We were a neighborhood theater and changed features twice a week, Wednesday and Sunday, which meant that on Tuesday and Saturday evenings we changed the advertising.

As I readied to walk home, I was stopped by Mr. Ray and Dave Turner. They informed me that I was going to dinner with them to tell them the entire story of what I witnessed that day before I arrived at the theater. I told them that I would have to call my mother, as she would be waiting for me. Mr. Ray said that he had called her and told her I would not be coming home for dinner. We climbed into Mr. Ray's 1950 Buick and headed through the tunnel to downtown Boston and an early dinner at Durgin Park, a famous Boston steak house near Faneuil Hall. I was expected to retell the story of the shoot out and did so, in detail.

When I arrived home after the evening's performance, Mom, Nanna and Babbononno were all up. Babbononno had told them his version of the events of the day and now they wanted to hear what I had to say. Just when I had finished, I heard footsteps coming up the two flights to our top floor apartment. It was Dad coming home from playing with his band. Again, I had to repeat the story. He had picked up a copy of the Evening Record and there was a picture of the shoot out on the front page. Somewhere in the paragraphs was the name Johnny Seville. So, for the umpteenth time that day, I told the story of the shoot out on Meridian Street. I felt like a local hero, except that I didn't do anything except watch the events of the day. I don't know whatever happened to The Pig???

Though early films lacked sound effects and spoken dialogue, they were usually shown with accompaniment by a harried piano player whose tunes suited the action.

By the 1950s there was a noticeable drop in box office receipts. Drive-ins sprang up and TV kept people at home. New filming techniques in the late 1950s and early 1960s contributed to the demise of The Stoneham. These productions required large screens, multi-projectors and advanced sound systems. The Stoneham, like most other small town movie houses could not afford this equipment. For the most part B movies were presented in the 1960s and the number of shows per week declined culminating with the closing of The Stoneham in the late 1960s.

After a quarter century of abandonment and dilapidation The Stoneham has been revived and restored, opening its doors once again in December 2000. The hard work of many months made it as up-to-date for the 21st century as it was for the 20th when it first opened. The marquee replicates the original box style installed in 1930. The rear stage wall still contains the original 1917 screen, a wooden surface painted black and silver.

Today the building is home to Stoneham Theatre, a professionally producing regional theatre, which is the only company founded within the past ten years ranked by the Boston Business Journal among the areas ten most

popular performing arts organization. It is consistently praised by critics and audiences for its superior caliber of production, as a connection to the communities it serves and its comfortable atmosphere. "The ease of fit and the owner's ability, possibly by him or herself, to put the pet in the cart are also big factors to consider," Bolger said.

Contrary to popular belief, Evans said that dogs confined to a cart or wheelchair usually don't try to chew their way out of it unless they experience discomfort.

"The more uncomfortable they feel, the more likely they are to try to get away from it," he said. Normally, the dog should accept the device like a glove within about two or three days. If the dog is chewing on it, check the pressure points. Is the animal resting on the bindings or straps? Have any sores developed? Has the dog been left in one position too long?

Bolger said that all pets confined to a cart or wheelchair should be monitored often to ensure that they don't chew it apart or become dislodged from it.

#### Margaret Thatcher Mental Health Laws Need Changing

As someone finishing up a 40 year career in both direct care and support service for the State Department of Mental Health the recent shooting tragedies has showed the great need to stop blocking out parents whose children suffer from mental illness when their kids hit 18 years old as explained in a recent piece in USA Today, written by Rachel Pruchno, who is director of research at the New Jersey Institute for Successful Aging. She is also the author of a soon to be released memoir, "Surrounded by Madness" which should be "must reading" for our lawmakers up on Capitol Hill who too often can't see the forest for the trees. Her daughter was diagnosed with bipolar disorder at 16 and borderline disorder at 18. For this mother, her daugh-ter's 18th birthday turned her "from valued member of the health care team into its pariah." I agree that too often the health care system is in crisis because families get excluded from being an active part of their adult children's recovery. The parents of Jared Loughner, Amy and Randy, have said they told their son to get help but couldn't

make him do so because of the laws preventing them from taking action. They were turned into helpless bystanders because of the law.

Did vou know that according to the National Institute of Mental Health there are an estimated 114 million Americans suffering from serious mental illness and about half of them lack awareness about their illness and thus compromise their abilities to make informed decisions. Yet at 18 years old they have full control of their healthcare and in many states treatment can't begin until someone exhibits dangerous behavior or commits an act of violence like many recent shooters. The law in effect protects them from help until those individuals kill people and then the law wants to lock them up. We need pro-active not reactive systems in play or these mass shootings and deaths will continue.

Jared Loughner needed help the weeks leading up to the day he killed 16 and injured 19 others at the strip mall in Arizona. His parents reportedly pleaded with him to get help but he ignored their pleas.

I agree with Rachel Pruchno who stated, "Laws should take a more reasoned approach that empower families who know when there are problems and want what is best for all involved. It is time to realign laws with science and compassion."

According to the audit, substance abuse professionals stated some testing occurred because they were pressured by laboratories and sober houses to sign orders requiring frequent testing. These clinicians said that if they did not sign the orders, their patients would be removed from housing or directed to other physicians who would authorize the tests.

The report also identified \$1.3 million in unallowable drug tests conducted at the UMass Memorial Medical Center (UMMMC). These tests were performed for residential monitoring by sober homes, which provide housing for people recovering from substance abuse disorders. UMMMC officials said they were preparing to repay the Commonwealth

Other findings include:

- Three laboratories (Precision Testing Laboratories, Inc.; Lab USA Inc.; and New England Pain Institute) used a deceptive billing practice, known as unbundling, to circumvent price limits and overcharge MassHealth \$4.5 million for four fiscal years.
- MassHealth spent \$7 million on certain tests, such as alcohol urine testing, that are commonly considered medically unnecessary by the substance abuse treatment community.
- MassHealth's claims processing system does not adequately prevent and deny payment for duplicate drug tests. Auditors found 16,441 instances of MassHealth paying for multiple drug tests for the same member on the same day totaling \$313,623.

Auditor Bump has called on MassHealth to recover more than \$6 million from laboratories reviewed in the report and to apply stricter oversight on its payments for drug tests. MassHealth has responded positively to audit findings and has already begun implementing new policies in line with the Auditor's recommendations.

"MassHealth is doing right by implementing better standards, system controls, and monitoring activities to detect and deny excessive drug testing. This will help ensure that the Commonwealth's limited resources are used for effective patient treatments," said Auditor Bump.

The Office of the State Auditor conducts technical and performance assessments of state government's programs, departments, agencies, authorities, contracts, and vendors. With its reports, the OSA issues recommendations to improve accountability, efficiency, and transparency.

## HOOPS and HOCKEY in the HUB

HOW LOW CAN THEY GO? THE FIRST ACT — Well, apparently for the Celtics, all the way down to rock bottom when scoring counted most. You see, when the Celtics lost to the New York Knicks at Madison Square Garden in the first game of their opening best-of-seven playoff series, they set one record and tied another.

The C's only scored eight points in the decisive fourth quarter that saw the Knicks down the C's 85-78. That together with their 17-point third quarter gave the Green a total of 25 points for the second half, their lowest point total in a half during any of their playoff games in history. At least for a short time (see below).

And how many games does that include? Well this unenviable record included all their playoff games to that point — all 592 of them. Not something to be proud of. And just think: the C's were actually leading in this game during the third quarter.

As far as the eight point fourth quarter goes, that "only" tied a team record. And ironically, it goes back to the beginning of the franchise. You see, way back on March 28, 1948, in their very first playoff game in team history, the Celtics also had an eight point fourth quarter during a 79-72 loss to the Chicago Stags.

The Stags only lasted until 1950 but they played a significant back door role in the history of the Celtics. Chicago held the draft rights to a certain player. After the Stags folded, there was a dispersal draft to place the Chicago players with other teams in the league. And that's how one Bob Cousy came to become a member of the Boston Celtics.

Getting back to Game 1, how did the Celtics lose that game? Well, a closer look at the box score reveals that the C's were only five for 20 from three point range. They lost by seven, so if they had made three treys more they would have won the game. They were 27 of 65 from the field, so if they had made a couple of additional baskets and just one additional threepointer they would have tied the score. A bright spot: The Celtics were a perfect 19 for 19 from the free throw line.

Plus, of course, the Celtics failed to contain Knicks star Carmelo Anthony who had 36 points on the night.

HOW LOW CAN THEY GO? THE SECOND ACT — It was more of the same in Game 2 on Tuesday night as

Anthony scored 34 to lead the Knicks to an 87-71 victory over the Green.

Notice that this was the second straight playoff game where the Celtics were held to under 80 points. Not good, not good at all.

But that wasn't the entire story. That record low 25 points in a half by the Celtics set in game one (see above). It didn't last very long. This time around, in game 2, the C's managed to score only 23 points in the second half—fewer than they scored in just the second quarter when they had 28. This time they twice flirted with single digit quarters, scoring just 11 in the third and 12 in the fourth.

The Celtics were just 37 percent from the field (26 of 70) and were a terrible seven of 36 in the second half. They were just five of 19 from three point land.

Just as in game 1 the Celtics led at the half (48-44) but let things get away from them in the third quarter when the Knicks scored 32 points.

It'll be a tall order to climb back from a 2-0 deficit. If the Celtics pull it off, it means they will have to win four of the five remaining games.

To do it, they will have to figure out a way to stop Anthony while dramatically increasing their point production. May Day is May 1st and is a Labor Day in some nations. But it is also known as the international distress signal (Mayday, Mayday, Mayday). That's the call that is probably resounding through the halls of the Garden right now.

Without an improvement on the part of the Celtics, this series will quickly be over. The time of reckoning is definitely at hand. Even if the Celtics manage a victory or two on the parquet, they would still have to go back to New York for game 5. As April becomes May we'll know whether the Celtics are still alive or whether the summer of 2013 has begun for the men in Green. By the time the Kentucky Derby is run on May 4, the 2012-2013 season could well be over for this team.

It's said that April showers bring May flowers but one has the feeling that the baskets raining down on the Celtics spell a finality for this team, a team that at season's start seemed talented enough to finish higher in the regular standings than seventh place and go deeper in the playoffs than simply the first round.

## **New Photography Exhibit Documents**

Lives & Times of Old West End

On April 16<sup>th</sup>, *Life in the West End 1947-1953: the Photography of Jules Aarons* opens at the West End Museum and will run through August 3, 2013 in the Large Exhibition Area. The exhibition will feature 26 prints from photographs taken between 1947 and 1953 and is guest curated by Arlette Kayafas, founder and director of Gallery Kayafas in Boston's South End. The exhibit is free and open to the public. The opening reception takes place from 6:00 to 8:00 pm on Friday, May 10<sup>th</sup> and is free to all.

Jules Aarons is an important figure in documenting the West End of Boston before the ravages of Urban Renewal. His photography bears witness to the vibrant, close-knit old neighborhood — the people, their lives and their relationships. "If there was ever an official photographer of the Old West End it would have been Jules Aarons," says West End Museum Curator of Exhibitions Duane Lucia.

Where city planners saw the West End as a candidate for modernization, Jules Aarons saw something else: "I knew that the dynamics of people whose social relationships involved their neighbors and the streets could be a source of creativity," he wrote. The photographs in the exhibition capture a West End far removed from today's - streets with remarkably few cars; political posters; adults chatting outside doorways; children showing off for the camera or so deep in conversation they don't notice it at all. "The striking thing about these pictures is their humanity," says exhibition guest curator Arlette Kayafas, "Aarons' greatest asset was the compassion he felt for his subjects."

A Bronx native, Aarons (b. 1921 – d. 2008) was born and grew up in the same kind of urban neighborhood, which might explain his affinity for Boston communities like the Old West End and the North End. He first came to the city as a Boston University

graduate student and later earned his doctorate at the University of Paris. Ultimately, he returned to the Boston area, joined the B.U. faculty and became a world-renowned expert in the study of radio-wave propagation. But from his late adolescence through his academic and scientific rise, photography — especially street photography — remained a constant passion. Aarons' photographs of the West End and North End were taken on late afternoons and weekends with a twin lens Rolleiflex camera, and he made his own prints.

Life in the West End 1947-1953: the Photography of Jules Aarons is free and open to the public during regular Museum hours: Tuesday through Friday, 12:00 to 5:00 p.m.; Saturday, 11:00 a.m. to 4:00 p.m. The Large Exhibition Area is a flexible space that hosts three exhibitions per year relating to the history and culture of the West End, and the art it inspires.
