

# House, Senate Pass VALOR Act II

Legislation Strengthens 2012 VALOR Act and Enhances Commitment to Commonwealth's Veterans

Rep. Carlo Basile joined his colleagues in the Legislature to pass the VALOR Act II which builds upon existing legislation to expand opportunities and services for military personnel, veterans and their families.

The legislation provides increased property tax relief and enhances employment, educational and healthcare support services. It creates a home modification program to help injured veterans stay in their homes and function independently, and authorizes the Secretary of Veterans' Services to establish enhanced training and certification for veterans' benefits and services officers.

"This legislation sends a message to our veterans that we appreciate their bravery, sacrifice and service," House Speaker Robert A. DeLeo (D-Winthrop) said.

"Most importantly, it aids in the House, the Senate those who have supported times by providing resources to help them build a bright the nation in aiding veterans and military personnel and I believe this bill furthers that commitment."

"Massachusetts has long led the nation in recognizing and providing for our veterans, and I am proud that this bill will further these efforts." Senate President Therese Murray (D-Plymouth) said. "By working to expand benefits and services for veterans, we remind our men and women in uniform that their sacrifice does not go unnoticed and that the Legislature will continue to support them both abroad and at home."

"Thanks to my colleagues

and on the Committee of America during some of Veterans and Federal the country's most difficult Affairs, today, with the passage of the VALOR Act II, we, as a legislature have future. # Stirpe Nostra

#### JULIUS CAESAR, POST-MORTEM

The will of Julius Caesar named his sisters, his grandsons, and Octavius to inherit three quarters of his estate. He also adopted Octavius into the family and gave him the Caesar name.

A funeral pyre was erected in the Campus Martius and he was cremated while lying on an ivory couch with covers of purple and gold. The robe that he was wearing when slain hung at the head of the couch. Instead of a eulogy at the cremation, Antonius (Marc Anthony) arranged to have someone recite the decree of the senate which voted Caesar all divine and human honors. and also the pledge of the senators to watch over his personal safety. During the cremation some people tore off their robes and threw them onto the fire. Many women threw their jewelry and also the robes of their children.

There was a strong suspicion that Caesar had taken no precautions against conspirators because of his failing health and a desire to bring his suffering to an end. Others theorize that his confidence in the senatorial pledge to watch over his safety caused him to dismiss his armed body guards. He often said that it was in the interest of Rome that he remain alive and that if any harm befell him, the country would be thrown into civil strife far worse than they had ever seen. All persons close to him agreed that the sudden and unexpected death he met was

opposed to one of lingering or suffering.

Caesar died in the fiftysixth year of his life. He was numbered among the gods by formal decree and also in the opinion of the people he served. It is said that for seven days in succession, a comet was seen about an hour before sunset, and this was believed to be his soul which was being taken to heaven. The senate voted that the room in which Caesar was slain be walled up and never used again. They also voted that the Ides of March be called the Day of Patricide (murder of one or both parents) and that the senate would never meet on that day. Most of Caesars conspirators died an unnatural death within the next three years. They died in shipwrecks, in battle, or by suicide with the same dagger used on Julius.

Julius Caesar holds a very unique place in the history of Rome and of the world. During his time, the government at Rome was not adequate to meet the administrative needs of such a great empire. Military power became more important than civil power and great senatorial debates had to give way to violent battles between successful leaders of Roman legions. Caesar was ambitious, desired to become the greatest political leader of his generation, and was successful because of his superior or extraordinary executive ability. He possessed a better knowl-

the kind he preferred, as edge of the needs of Rome than any of his contemporaries. His genius was not merely destructive as some might have said, but was constructive as well.

He was a great statesman; his military accomplishments rank him equal to Alexander the Great, Hannibal, and Napoleon. In the oratory of his day he was second only to Cicero. As a writer he is placed among the world's greatest.

His height, fair complexion, sensitive regard for his appearance and gracious attitude truly marked him as a man of the world. IN AMBITION, ENERGY, AND THE ABILITY TO GET THINGS DONE. HE HAS MADE A GREATER MARK ON HUMAN-ITY THAN ANY OTHER MAN THAT EVER LIVED. Good work cousin Julius, I'm proud of you.


And now the bitter irony of fate. The building in which the Roman Senate met was called the Curia. At that time their curia was destroyed by fire. Pompey built a building for the senate to use while they awaited the completion of a new Curia. The temporary meeting hall was called "Pompey's Senate House." Just four years after completion of Pompey's Senate House, his army was defeated by Caesar and Pompey was murdered on a desolate Egyptian seacoast. Four years after Pompey's death, Caesar himself was murdered in Pompey's Senate House.

and Paris where he resumed his studies and received the degree of Master of Arts. At Bologna he studied Canon Law, in which he acquired a great reputation and later elected Chancellor of the University of Oxford.

His learning and sanctity were so famed that Edmund Rich, Archbishop of Canterbury, and Robert Grosseteste, Bishop of Lincoln, both offered him the post of chancellor of their respective dioceses. Richard accepted the Archbishop's offer and became St. Edmund's intimate friend following him to France. After two years he was ordained by the Bishop and returned to England as a parish priest in Kent.

In 1244, the Bishop of Chichester died; the canons







# L'Anno Bello: A Year in Italian Folklore

A Baker's Guide to Spring

As anyone who remembers my autumn columns can attest, the fall is my favorite time of the year for baking. Something about the crisp air and the enveloping early darkness calls me back to the cozy honeyed glow of the kitchen, where I can spend my evenings basking in the warmth of my oven as I mix ingredients. Furthermore, autumn offers a veritable bounty of products simply made for baking: juicy apples and sharp pears, spicy ginger and creamy pumpkin. However, autumn is far from my mind now as I revel in the joys of spring. My heart swells with happiness as I take in the daffodil stems peeking out of the dirt, the robins singing sweetly from the bushes, the increasingly warm sunshine that falls butter-yellow from the sky. I am excited to welcome in the wonderful ingredients that characterize this season of rebirth and renewal, from fragrant herbs to snappy asparagus stems, tender peas and marinated artichokes. Yet these ingredients which I love so much are also more suited to cooking than baking, leaving an ardent baker like myself in a springtime conundrum. Through a lot of experimentation, however, I devised a baking guide for spring, finding a way to honor the seasonal ingredients in luscious desserts.

Citrus: Early spring is a wonderful time to use up last winter's citrus before they go out of season! I absolutely love desserts made with lemon (limone in Italian) and orange (arancia) because the tartness prevents them from getting too cloyingly sweet. From creamy lemon bars to cakes accented with orange peel, citrus desserts are a wonderful way to bid goodbye to winter and welcome in the warmth of spring. Italian desserts often include citrus peels or

extracts in them, such as the soft glazed cookies frequently seen at weddings to classic *pizzelles*. This Easter, I cannot wait to make my chocolate-ricotta pie with flecks of orange peel in the filling.

Tropical: When weather becomes warm enough to leave home without a coat and the trees become bursts of various hues of green, my baking tastes turn to the tropics. I especially love to bake with banana and pineapple. Banana nut breads are one of my father's favorite desserts, and I love them too because they are easy to prepare and come out so moist and soft. Pineapple upside-down cakes are an impressive finale to any springtime meal. Can't decide what tropical fruit to use? Make a Hummingbird Cake, which uses banana, pineapple and coconut, topped off with a velvety cream cheese frosting! If you want to make something that has both a tropical and an Italian flavor, try using kiwi-this little green fruit has become one of the most popular snacks in Italy, and Italy now produces more kiwifruit than any other country!

Strawberries: When strawberry baked goods start appearing in bakeries and stores, I know spring has arrived. Strawberries are a wonderful addition to shortcakes, frostings and cookies. My mother once made a tiramisu with strawberries and white chocolate, a spring-like twist on the classic Italian dessert. This Easter season, I plan to make Hot Cross Buns that include dried strawberries instead of raisins, modeled after a recipe I once encountered at Panera. Strawberries, known as fragole, are often found in Italian desserts, whether as a sauce dripped over panna cotta or

marinated in balsamic syrup.

Rhubarb: Rhubarb, one of the earliest crops of spring, is now one of my favorite ingredients to bake with. It is certainly a weird-looking food, resembling a red celery stalk, and its flavor is a cross between a strawberry and an apple. However, its tartness perfectly accentuates cakes and other sweets. My father-in-law introduced me to a recipe for a scrumptious rhubarb coffee cake, moist with a cinnamon-crumb topping. I now make it for May Day. My mother and I also once made lemon-ricotta pancakes with a rhubarb sauce smothered on top. Needless to say, it derived rave reviews from my family. Rhubarb is the essential don't-judge-a-book-by-itscover vegetable, strange to look at but delicious to eat.

So there you go — four wonderful ideas for springtime baking. Don't wait for the colder temperatures in order to head back to the kitchen. There are so many delectable ingredients available now, prime for sweet finishes to any spring meal. As we enter spring with hope and joy, I'd like to wish everyone a very happy April ... and happy baking!

#### It Was a Day for Heroes

Last week on Wednesday, March 26<sup>th</sup>, an alarm rung down at the Boylston Street firehouse and the two groups of firefighters from Ladder 15 and Engine 33 headed out to the street toward some sort of fire on nearby Beacon Street.

This firehouse has been quite active over the years. They were the first responders back on June 17, 1972 when an old hotel named the Vendome had a reported fire in progress. Ladder 15 and Engine 33 among other firehouses across the city felt great pain that day as the old building collapsed on a number of firefighters still in the building after the fire was extinguished. They were supposed to be moping up, but things turned quite tragic when nine firefighters got caught in the building's collapse.

In 1994, 22-years later, Fire Lt. Stephen Minihan from Ladder 15 died in a warehouse fire in Charlestown just below the bridge. He was searching for other trapped firefighters when he himself got trapped.

Recently, I was listening to an old folk song about days for heroes. Every day is a day of heroes for those brave men and women who run into burning buildings trying to save anyone trapped inside.

As I was watching the video of that fire last week and saw firefighters working on Michael Kennedy, one of the two firefighters who died that afternoon, I knew things weren't looking good. Hours later reportedly they found the body of Lt. Ed Walsh.

How horrible when you can hear the "May-Day" cries and

are helpless to do anything because of the raging fire blocking any rescue attempt.

March 26<sup>th</sup> started out like any other day at that firehouse. Countless days look the same. Then, something changes when the guys arrive at a fire. An ordinary day in a moment becomes an endless day of horror.

Last Thursday, two days after that fire, I found myself in Dorchester's Meetinghouse Hill and stopped by the firehouse across from the First Church of Dorchester and around the corner from St. Peter's Church. All the guys from Engine 17 and Ladder 7 were sitting down for dinner together as a family because that is what firefighters are to each other. They were having dinner: chicken, sausages, fried peppers, salad and bread. They seemed happy to be alive and sharing the meal together.

I noticed as I was leaving the firehouse, some of the smoke from the frying pan was making its way out to the apparatus? I asked where's the smoke detectors and they pointed the exit door to me all laughing.

The fact they could laugh I thought was a a sign of healing. At that moment they had each other for support and about two tons of donuts donated to them by grateful residents.

I will not forget the sacrifices made over and over again by our heroic fire-fighters who have a job to do and do it well no matter the risks because that is what they do.

They don't refer to themselves as heroes, but we should.

# The Jewelry Box

## Sharing Happiness Since 1977

Within about two minutes of my conversation with Tom Yourawski, the owner of the Jewelry Box in Revere, I felt as if I was talking to an old friend. Tom, or "Uncle Tommy" as he is known by his customers, went into the jewelry business in 1977 after a career as an insurance underwriter. He tells me "I was replaced by a computer, so along with a friend, we started selling jewelry at flea markets. Not long after I opened the Jewelry Box at its first location on Squire Road in Revere. A while later I bought a building at 345 Broadway in Revere where it has been ever since."

"Uncle Tommy" has seen the business change over the years. "The pawn shop reality shows have had an influence on the way people buy and sell. Costume jewelry is now more popular, and I am doing more buving then in the past. The fact that I own the building means I have much lower overhead then the other dealers, so I am able to pass that savings on to my customers both when I am selling to and buying from them. My customers are family to me. I now have the children and grandchildren coming in. It is such a great feeling to get invited to their weddings." At this point I no longer feel like I am talking to a businessman, but more like I am talking to Uncle Tommy, a guy with a very large family that is very dear to

Tom goes out of his way to make sure his customers, (sorry, his family), remains happy. A young man purchasing an engagement ring for the love of his life may be dealing with some anxiety over whether or not his future bride will like it. "I just tell him to buy it, we can exchange it if she isn't happy with it."

Tom Yourawski grew up in the North End of Boston, his mother was Italian, and he served as an altar boy at St. Mary's Church on Stillman Street. 

#### Are You Kidding Me? The '80s Rocked!

all kinds of experts. Music lovers mock the power ballads and the popularity of the likes of Blondie, Van Halen, and Duran Duran. Film critics call it a low point thanks to the rise of sequelettes, cheap horror flicks, and corny romantic fluff. And the fashion? Well, no explanation needed there, and even I won't defend that.

But, holy St. Elmo! What an awesome, unforgettable decade it was. The world may never again see a group of people quite like those who grew up in that varied, multi-faced, bustling decade. The fact that we saw three presidents in ten years attests to how fast the world was moving and changing. Not surprisingly, the generation that came of age during the radical jump from the Carter to Reagan presidency is as hard to define in simple political terms as the decade that precipitated such a change.

A large part of this is because technology was at a crossroad. Computers had taken a huge leap in development from the '70s and were becoming more of a commodity than a new toy for scientists (thanks Apple). More than anything, technology defined the '80s. This leads to my next point: some of the best toys ever came out in the '80s. Sure, many of the classics (Mr. Potato Head, Etch-a-Sketch, and the Slinky) had been around for some time, but the boom in electronics and gadgetry brought us View Master, Simon, Alphie the Robot, and Talking Whiz Kid. Of course,

The '80s get a bad rap from this was all a warm up to the video game boom when Nintendo brought Mario out of the arcades (which had dominated the gaming scene since the late '70s, not to be eclipsed by home consoles like Atari and Commodore 64 thanks to iconic characters like Donkey Kong and Pac-Man) and into the home. By the late '80s, Mario was a fixture in millions of homes across America.

> This fascination with technology translated to film production and some of the best movies of the '80s are remembered for their then groundbreaking special effects which continue to fascinate today in a way that combines nostalgia with a primal love for weirdness. Naturally, the decade was a breeding ground for wonderboy directors like Steven Spielberg, Robert Zemeckis, Joe Dante, and John Landis, while George Lucas continued to expand his Star Wars franchise. Just look at the wonders they created: Raiders of the Lost Ark, E.T., Back to the Future, Gremlins, and An American Werewolf in London.

But the 80s were also a very nostalgic period when the pop-culture of yesteryear was revisited and altered with varying degrees of success. Morphing The Flintstones into The Flintstones Kids and The Munsters into Munsters Today was unforgiveable, but, as sad as the revamping of The Twilight Zone was on TV, I do applaud the feature film reimagining of some of the classic episodes in Twilight Zone: The Movie. Finally, look at what



Jim Henson did with his beloved Muppet creations. Kermit and the gang had been around as early as the late '50s and, mechanically speaking, they changed very little by the time they starred in The Muppet Movie and The Muppet Show. But new developments in cinema allowed a relatively old gimmick to continue to look amazing.

It was computers that saved Disney's animation from its downward spiral following Walt's death in 1966. Computers were first put to use in 1985's The Black Cauldron, but the Disney Renaissance officially started with The Little Mermaid (1989). The movie that opened the door to this renaissance that would bring us hits like Beauty and the Beast, Aladdin, and The Lion King was Who Framed Roger Rabbit, a brilliant and very funny movie combining live actors with a cast of toons, both old and new, which in turn revitalized interest in the golden age of animation.

Best of all, though, this technological flowering brought new ways of exploring the past and the world around us, which is what technology does at its best. A casual glance at some of the best films of the decade Raging Bull, Chariots of Fire, Gandhi, The Killing Fields, Out of Africa, Empire of the Sun, and Platoon, indicates that our global and historical awareness was growing and helped pave way for the dot com years of the '90s. But we had one hell of a decade before that.



elected Richard as their Bishop. King Henry III was furious of his election and refused to give up the property and revenues of the See. He was consecrated by Pope Innocent IV, who supported his claim. For several years, however, Richard became a wanderer in his own diocese. He was entirely dependent on the charity and hospitality of the people and clergy, who defied the King's wishes.

Finally, in 1247, the King relented and Richard was allowed to administer his diocese from his cathedral at Chichester. Richard's personal life was very simple. He was an able administraecclesiastical discipline. The people loved him, not only for his almsgiving, but

for his caring and preaching. In 1250 Richard was named by the Pope as one of the collectors of the subsidy for the crusades. Two years later the king appointed him to preach the crusade. He made strenuous efforts to rouse enthusiasm for the cause in the Dioceses of Chichester and Canterbury. It was while on a journey to Dover, where he was to consecrate a new church dedicated to St. Edmund that he was taken ill. Upon reaching Dover, he went to a hospital called "Maison Dieu," performed the consecration ceremony on April 2nd, but died the next morning. He was canonized by Pope Urban in tor, and firm in maintaining the Franciscan church at Viterbo, 1262. St. Richard's feast is celebrated on April 3<sup>rd</sup>.

# Freeway Says ...

Due to his increasing popularity and several suggestions from readers (and after much negotiating on our part with his huge salary demands), our friend Freeway has consented to try to answer readers' questions concerning him or any of our little four-legged friends. You can email your questions to postgazette@aol.com to the attention of Freeway. Don't forget folks, Freeway is not a vet, so please keep the questions lighthearted! Thanks.

After reading this article I thought I would share it with my readers. Abandoned pets is a major social issue. With millions of homeowners expected to face foreclosures and other personal disasters, untold numbers of dogs, cats and other animals are at risk of being abandoned by their owners. These abandoned pets are sometimes referred to as foreclosure pets. But even if you can't adopt or foster one of these abandoned pets yourself, there are many things you can do to help pets during tough times.

If you know or suspect that a neighbor is preparing to move soon due to a financial hardship, find out if they have made arrangements for their pets. If not, encourage the owner to:

- Ask relatives, friends, neighbors and coworkers if they'd be willing to foster or adopt the animal.
- Choose a property that allows pets, if they're considering an apartment or other rental property.
- Ask a local shelter or pet adoption organization to house their pet for a limited time at no charge while they search for new housing.
- Contact a local animal rescue group and ask if they are able to temporarily foster the animal.

Get in touch with the breeder, if the pet is a purebred dog, the breeder may be willing to take the dog back or find it a new home.

- Talk with local veterinarians and learn if low-cost boarding is offered while they seek a new home.
- Post a free listing for an available pet or search for rescue and adoption resources at Petfinder.com, Adopt A Pet.com, Pets 911 or craiglist.org.
- open-admission animal control shelter as a last resort.

If you suspect any pets left behind after an owner has vacated the property, take the following steps:

• Contact the home's real estate/foreclosure agent or your local police department

or humane society to inform them of the abandoned pet.

- Without breaking into the house, violating any laws or putting yourself at risk, attempt to provide a small amount of food and water to the animal until the proper authorities arrive.
- · Work with local authorities to get the animal placed in a new home — hang up flyers, post online notices of the pet's availability, and spread positive word-of-mouth.
- Careful and prompt action is important once a forsaken pet is discovered.

"Animals who are locked up in an abandoned property will not survive if left for very long. They are not able to get out of their confines to search for food and water. And they risk being exposed to extreme weather conditions and temperatures."

Keep in mind that while they can go without food for many days, a dog or cat can become dehydrated within 24 hours without water and could die in extreme heat or cold within a few days.

Dogs left in homes may attempt to protect their territory when strangers enter the home. "Protective behavior and associated aggression can make it difficult for foreclosure company agents to capture a dog, and animal control officers may be called in to do so. Also, cats may hide when strangers enter the house, reducing their chance of being found.

Lastly, be aware that local laws may prohibit you from your rescue efforts. Pets have virtually no rights because they are considered personal property in most states, and personal property left behind by owners is subject to seizure by the lender repossessing the home. Unfortunately, some laws don't • Turn the pet over to a consider personal property to local humane society or be forfeited until after a set time period, which prevents lenders from removing pets from the property and outsiders from interfering on the animal's behalf.

I know I learned something by this article and I hope my readers did too.



causing "disparate" harm to African Americans, but criminal and credit checks are vital, companies say and even EEOC uses such screening.

The Obama Administration has reportedly threatened employers that run criminal and credit background checks on job applicants, arguing they are racial "barriers" to hiring, but the federal government routinely uses these checks too.

A couple of weeks ago, both the FTC and EEOC told employers that background checks could have a "dis-

parate impact" on African Americans and could open them up to lawsuits.

Back in 2011, the NAACP formally lobbied EEOC to apply "disparate impact" to background checks and to remove any questions about prior felony convictions.

Nine state attorney generals have demanded that EEOC abandon this new policy.

Background checks should always be part of a job application, and to do this is not to racially discriminate against any denied job applicant.

#### ANTOINETTE'S PEANUT BUTTER BISCOTTI

#### DOUGH:

2 ½ cups flour ½ cup sugar

34 cup butter ½ cup chopped walnuts 34 cup water Two 6" x 9" cookie sheets

In a bowl, cut butter into flour with a butter knife. Add sugar and then add water. Stir with fork until it looks like little balls. Do not knead. With your hands, make a ball of the mixture and refrigerate for one-half hour.

After one-half hour, cut dough into four parts. With rolling pin, roll each portion one at a time into a thin rectangular shape. Cover rectangular piece lightly with peanut butter. Then lightly spread jelly of choice over peanut butter. Sprinkle walnuts over jelly. Fold into a long roll beginning at side of rectangular piece of dough (about three inches wide). Place lengthwise (seal side down) in lightly greased cookie sheet. Continue to do same with the remaining portions of dough, placing two rolls in each baking sheet. Brush tops of rolls lightly with milk for a golden color. Bake in a preheated 375°F oven for about 20 to 30 minutes.

For ease of handling, use a spatula to remove from baking sheet and allow to cool on cutting board. Cut diagonally into biscotti. Store cooled Peanut Butter Biscotti in a canister.

NOTE: I am pleased to share this unique recipe with you. A dear friend created it years ago. Antoinette (Marcantonio) Benda, sister of Dr. Joseph Marcantonio, and Rose Sinopoli decided to put together ingredients that she enjoyed with the hopes of making a different cookie. She created these delicate and tasty biscotti.

# Nanna & Babbononno

A Nostalgic Remembrance

Back in the day, we used to head to a department store and purchase an Easter outfit.

Sunday Masses were filled with women wearing dresses, gloves and hats. Men wore suits, shirts and ties. More often than not, they also wore hats. Today, this doesn't happen. People wear casual clothes for almost everything, but back then, we dressed, especially on Easter Sunday.

Mom would bring Nanna to Jordan Marsh and they would shop for their Easter outfits.

Uncle Nick would bring Babbononno to Raymonds, like Jordans, a long-gone Washington Street department store. Dad would bring me to Filene's Basement, and combined, we all would look for Easter outfits.

When I was a kid, Dad had a friend who worked at a men's clothing factory in East Boston called Picarello and Singer. If you were related to someone who worked there, you could purchase the garments at the manufacturer's cost ... a much lower price than you would pay at a retail clothing store. Dad's friend classified Dad as a cousin, so we were in. There was also another place Dad liked to shop at, Filene's Basement.

I did enjoy the hustle and bustle of Filene's Basement. Dad knew someone there, also. His friend would point us in the right direction for the best quality and lowest price for suits, shirts, ties, shoes and hats. When I entered English High School, I headed for Filene's Basement on my own and was befriended by a salesman who was an English High graduate. For the next 15 or 20 years, he waited on me when I was looking for clothes, but I digress.

With Easter being a few weeks off, it was time to head to the stores and plan the Easter outfit. After the purchases were made, we big house on Eutaw Street in was to be cut to my speci-East Boston and model the clothes looking for approval from the rest of the family. Mom and Nanna would mark the dresses where they needed tailoring, and the same would apply to the rest of us. My father and grandfather's new suits would need tailoring as

would my new clothes. Once the approval process was over, we would head to see Billy the Tailor. Billy was a paesano of Babbononno's and one of the best tailors I have ever known. His shop was across from East Boston High School and always smelled of carbon tetrachloride, a cleaning fluid that had a pungent aroma. I used to say that Billy had magic fingers when he would alter a garment that didn't fit right. He was so good, he could make an off the rack cheap suit look like it was custom made just for you. Billy would come at you with a piece of tailor's chalk and mark the suit or dress in many places as you modeled it. With the men, he would ask us if we wanted cuffs or not on our pants, Dad yes, and Babbononno definitely not. Early on I had cuffs on my pants, but later and to this day, no cuffs. Billy would insist on us modeling our clothing after he did the preliminary tailoring. If everything checked out to his satisfaction, he would finish the job. If not, he would make whatever changes he thought were necessary for a perfect fit.

I remember the spring of 1955. I was ready to head to Filene's Basement because Easter was a month or so away and I wanted to buy a new suit. I was working at the Seville Theater and could afford to buy my own clothes which made me, a 15-yearold, a bit on the independent side. Before I headed to town, Dad informed me that one of our neighbors, Danny Gallo, worked in the garment industry and could get us suits cheaper than we could buy them for in Filene's Basement. I said OK and that night, Danny came over with swatches of material for us to choose from. Dad chose a navy blue and I chose a powder blue. Both were tropical blends and could be worn all year round. I wanted the latest style, a one button roll jacket, sort of a latter-day zoot suit from would all head back to the the '40s. The suit which fications, was going to cost me the outrageous price of \$24.00.

called Sumner's, For Men Who Know Style. There I bought a Mr. B collar shirt. A Mr. B collar shirt had two curves in the front going from the button to the end of the collar. When it was buttoned and rolled, it looked like the M on a McDonald's burger sign. Oh by the way, it was named after the '50s jazz singer Billy Eckstein, who used it as a fashion statement. The tailor at Sumner's even added my initials to the shirt without an added charge. I found a navy blue narrow velvet tie and a pair of navy socks to finish off the ensemble, and headed home.

A few days later, the neighbor, Dally Gallo, came over after dinner with two suits, the one Dad ordered and the one I had chosen. We tried them on but both agreed that Billy the Tailor would have to ply his magic to finish them off. We paid Danny and that Saturday, headed to see Billy with our new suits. Of course, Babbononno being a paesano of Billy's had to come along to hang out with his pal. Billy used a piece of tailor's chalk and marked the length of the sleeves, length of the pant legs and the shape of the middle of the jackets. We were set to go, but were told by Billy that the wait would be longer than usual as he had a lot of Easter work to handle within the next few weeks. As long as we could get our suits back before the holiday they were intended for, we would be happy. Billy gave us the date they would be ready and we headed home.

Babbononno called me into his bedroom and handed me a pair of cuff links and a tie stud to use with my new shirt and tie. He said, "Jenny, deeza real golda, eh I no wear dem no moh. You take-a dem eh you looka even bedda with-a new zootza eh my golda." I always liked Babbononno's jewelry. It was always understated but looked expensive. I thanked him and tried on the new shirt and tie and showed him what they looked like with the cuff links and tie stud he had given me. He examined them on me and gave me his approval. I was happy and waited out the time until the suit would be ready.

Mom made Dad buy a new shirt and tie to compliment the new navy blue suit that he was going to wear on Easter Sunday. We headed for Arkin's Men Shop on Bennington Street. Sam Arkin, the owner and Dad were friends from the old days, and together, picked out what Dad wanted. Within a few days, the ladies had their dresses and we our suits back from Billy the Tailor. And, all was well as we waited for Holy Week to arrive.



THE POPE'S POPULARITY ... DIVERSIFIES! Pope Francis continues to attract large crowds everywhere he appears, especially in St. Peter's Square. It was in one of his forays into the Vatican's famous square when he made an interesting and unscheduled stop, while on his Pope-mobile. A young man from the City of Castelvetrano, in the province of Palermo, Nicola Fiasconaro, motioned to offer the Pope a package. The two coins chosen to be eliminated represent 45.8 billion pieces in circulation (nearly 137 per head vis-à-vis the overall population of the community: 350 million in the 27 member States). The decision was prompted by the excessive production cost. Several of the member States had expressed their concern over the cost of producing the coins many found to cumbersome to even carry! The Commission will further consult with the consumer organizations, treasury boards, control banks, and also probe the people's views. Stay tuned!

IMPORTANT DISCOVERY IN AUSTRALIA: A PROTEIN THAT CAUSES ALZHEIMER. A research conducted at the University of Tasmania opens up a new path in the biology of Alzheimer and provides new hope to those who are afflicted with this pathology, who are a large and increasing number in advanced societies nearing old age, and also gives hope toward regeneration of the damaged cells. A research group at the University's biochemical center has discovered that the protein 'Amyloid Precursor Protein' (APP) is the cause of the debilitating pathology, which can also play a role in its cure. This protein degrades in the brain by producing the protein ABETA, the direct cause of the illness. Researchers have also discovered that ABETA also has a positive function. For 25 years the protein has been associated to the illness, but the researchers have demonstrated that it is also important for the growth of the neurons, the brain cells. To block it wouldn't be a positive step. It is possible to use the APP to stimulate the brains to replace the damaged neurons. Certainly it is great news, indeed.



#### Rapid Johnny Rafuse to be Inducted into Ring 4 Hall of Fame

"John never took a back step from any challenge." — Mickey Finn, Ring 4 President

This Sunday Rapid Johnny Rafuse will be inducted into the Ring 4 Boxing Hall of Fame. Fight fans were never disappointed when John stepped into the ring as he was always in shape and never failed to give it his all. Rapid Johnny fought seven recognized champions during his career and came up on the short side of many

close decisions, one of the problems you have when you have to fight in your opponent's hometown.

Over lunch at the Kowloon in Saugus, I had the chance to talk with John, who had been a wrestler in high school, about his career and life. I asked how he got started in the fight game. "I was sitting in a bar drinking and smoking when a guy came in and asked one of my friends if he wanted to come up to the Harbor House in

Lynn to fight. I heard that and said I liked to fight too. I climbed into the ring that night without having had any time in a boxing ring and at the bell, came out as if I were in a street fight. I did okay for the first round but ran out of gas in the second. After that fight, I went to the New Garden Gym where Al Clemente started training me. Two weeks later I was back in the ring and won a decision. I had a total of 16 amateur bouts and then turned pro."

Johnny racked up an impressive record of 12 wins and just two losses when he stepped in against Micky Ward in Ward's hometown of Lowell on August 29, 2008. It was enough of a challenge going up against Ward, but Johnny had to contend with another opponent that night, "I was having a tough time with referee Tommy Collins. He was giving me as hard a time as Ward was." Collins behavior was called "bizarre" by ringside commentator Al Bernstein. Bernstein said he had never seen a referee manhandle a fighter like that before. Johnny managed to keep his cool and least. When I asked him life."

kept to his fight plan despite the referee. Johnny said, "I neutralized Micky's left hook to the body." It was a very exciting fight with Rafuse losing a close decision. This bout proved both boxers were world-class material.

Johnny continued on with his career while learning the hard lessons boxing teaches a fighter. He had a bout in Paris, France for which he received \$7,500.00 only to find out later that the matchmaker who put the fight together received \$28,000.00. "He made out pretty well for just pressing a few buttons. He didn't know that I would find out about it." Johnny tells me very calmly while I was getting angry just hearing the story.

A few months after the Paris fight John was matched with Vinnie Burgese in a bout in Atlantic City with Burgese winning a controversial decision. The two were signed for a rematch

with the winner being promised a bout against Vinny Pazienza to be televised on national TV for a purse of \$35,000.00. This would be a big break for the victor. Johnny went in and kayoed Burgese in the 6<sup>th</sup> round, but a funny thing happened on the road to fame and fortune, Burgese got the fight with Pazienza. Rafuse tells me, "I know I could have beaten Vinny. We had boxed in the gym and I knew how to handle him." Another tough break in a game that is filled with them.

John would go on to challenge NABF Light Welterweight Champion Harold Brazier in Brazier's hometown, but once again came up on the short end of a hometown decision.

Johnny would continue fighting until 1991 ending his career with a decision over Jose Torres in Boston. John hung up the gloves due to an injured elbow.

You'd figure a guy who came so close to crossing over into the big time only to have to deal with the politics of boxing would be bitter, but he isn't in the happy guy, I have a great

what his favorite moment in boxing was he told me it was the victory over Burgese, but he was very quick to say, "That was my favorite time in the ring, but the greatest moment of my life occurred on May 16, 1987. That's when my son John Jr., was born." You can hear the love he has for young John

as he brings up this occasion.

John has always been a tough guy both in and out of the ring, always in shape and never one to back down. He still has an incredible work ethic that has served him well as a union carpenter, a profession he loves.

Both John and his brother Michael tell me they found out where they got their toughness from four years ago when they discovered their 76year-old mother Helen

on the floor of her home. She had fallen and had been lying there for 27 hours with a broken hip and shoulder. Just as Johnny had always stepped back into the ring after a loss, Mrs. Rafuse has recovered and will be in attendance at John's induction ceremony. You can never count a member of the Rafuse clan out.

Ring 4 President Mickey Finn tells me he is honored to have Rapid Johnny Rafuse enter the Hall of Fame. "Even though Johnny was one never to step back from a challenge, he has also been a terrific friend to many people. There will be over 90 of those friends at the sold out Ring 4 Banquet. They couldn't ask for a better pal then Johnny."

John Rafuse may have been deprived of the opportunity to be on top in boxing, but if you measure a man by what he has put into and gotten out of life, John is an undefeated Champion.
