




# **Boston Public Garden** Swan Boats Opening Day 2022

Mayor Michelle Wu and the Boston Parks and Recreation Department are pleased to announce that the popular Boston Swan Boats will open for the 2022 season at the Boston Public Garden lagoon on Saturday, April 16, at 10 a.m.

Launched in 1877 by Irish immigrant and shipbuilder Robert Paget, the Swan Boats continue to be owned and operated by the Paget family. Mr. Paget designed the Swan Boats after attending the opera Lohengrin in New York City. At the end of the opera, the hero crosses a river in a boat drawn by a swan.

2022 marks the 145th season for the Swan Boats. The oldest and smallest boat in the fleet just celebrated its 112th season, while the newest was launched in 1993. The swan on today's boats is made from either copper or fiberglass, depending on the age of the boat, and encloses a paddle mechanism that is used to foot propel the boat through the water.



Fully loaded, each Swan copper just as they were initially Boat weighs three tons and is powered by the driver using a foot-propelled paddle wheel. The Swan Boats are built on oak framed pontoons sheathed in

constructed in 1877. After being stored in a safe place for the winter, the boats are returned to the Public Garden Lagoon each spring.

#### City Council Backs Wu on Protest Limits Ordinance

The Boston City Council has passed Mayor Michelle Wu's proposed ordinance that would ban the kind of early-morning protests that have targeted her and other local officials. The city council approved the measure by a 9-4 vote on March 30th, with perhaps its two most right and two furthest left members voting against the ordinance change. Casting the "No" votes were Frank Baker, Kendra Lara, Julia Mejia, and Erin Murphy. Baker and Murphy are two of the more conservative members on the council and said they opposed the move on free-speech grounds, and Lara and Mejia two of the more progressive councilors, have said they too worried this could limit other protests.

Recently, on March 14th, Boston Police Sgt. Shana Cottone from the Boston First Responders Union stated, "Rights are not negotiable. Our rights to constitutionally demonstrate are not something that should be negotiated or legislated through ordinances."


#### Gentrification Destroying East Boston?

# Stirpe Nostra

#### THE CAESARS TWELVE



During the coming months, this column will present a concise history of our so-called "Twelve Caesars." I believe that readers will find these articles very informative, especially those who have had no formal background in classical studies.

A study of all of the stories, events, and the characters associated with the rise and fall of the Roman Empire would be like reading an entire library, and would probably take a hundred years to fully understand and record its beauties. A capsule explanation divides the history of Classical Rome into three distinct periods: 1. The Regal Period (the legendary kings like Romulus), 753 to 510 B.C.; 2. The Republic (the time of the great Roman Senate, ending with the death of Julius Caesar), 510 to 27 B.C.; 3. The Empire (the period of Roman emperors starting with the great Augustus and ending with the pitiful Romulus Augustulus), 27 B.C. to 365 A.D.

During the period called the "Empire," there were many good emperors like Nerva, Trajan, Hadrian, Antoninous Pius, and Marcus Aurelius. Unfortunately, along with the good, they also had to contend with the bad. There were rulers like Caracalla, who not only built one of the world's largest bathtubs, but was also noted for his brutality; Heliogabalas, who was noted for his debauchery; and Commodus, the son of Marcus Aurelius, who was reported to have been the

most bloodthirsty and unruly emperor that has ever been recorded in all of history. Those of us who are in good health pay a daily tribute to the memory of this character.

Then there was Nero, the archenemy of all Christians, who was one of the cruelest, most depraved, and despotic emperors that ever ruled Rome. Finally, there was a "nut cake" named Caligula, who was just plain off his "Roman rocker." His reign got off to a pretty good start, but the finish just defies description.

The name "Caesar" probably was originally derived from ancient Roman legends. Some say it came directly from the word "caedo," meaning that the first bearer of the name was cut from his mother by "Caesarean operation." Others derive the name from "Caesaries," because the first Caesar was born with a full head of hair. Still others attach the name to "Caesius," as applied to the color of the skin or eyes.

Caesar was the family name of Gaius Julius Caesar, and after his death the title of Caesar was given to all of the Roman emperors from Augustus to Hadrian. References are still being made to these 12 Caesars whose popular names, in chronological order, are: Julius Caesar, Augustus, Tiberius, Caligula, Claudius, Nero, Galba, Otho, Vitellius, Vespasian, Titus, and Domitian.

Boston teens can register for BCYF Snap Shot teen photography program, BCYF SuperTeens pre-employment program for young teens, and BCYF Girls Leadership Corps. Led by a professional photographer, the program includes opportunities to conduct "photo shoots," visits to museums and art galleries, digital photo editing lessons, online personal development workshops led by John Hancock, and opportunities to serve as a "staff photographer" for BCYF.

**BCYF SuperTeens** program teaches teens ages 13 and 14 life readiness and resiliency to help prepare them for their upcoming academic year and future employment. The program focuses on opportunities to enhance communication, collaboration, teamwork, and problem solving. The SuperTeens are mentored by BCYF staff throughout the summer, and they participate in both online workshops and in-person job shadowing activities that highlight employment skills. The SuperTeens also participate in weekly social and recreational activities, including a Learn to Row Crew program on the Charles River, neighborhood beautification projects throughout the city through the painting of murals, as well as visits to some of Boston's museums and historical sites.

Participants earn a paycheck and they will also be provided with opportunities that encourage civic engagement and physical health and wellness.

**BCYF Girls Leadership Corps (GLC)** provides girls ages 11-14 with a variety of workshops and activities. Special pop-up guests will be invited to speak with the girls. Workshop topics will include self-defense with Girls LEAP, leadership skills, empowerment with the YW F.R.Y.E. program, Media Girls, Girl Scouts, and more. The Girls Leadership Corps girls will plan activities that Boston girls will be invited to register for including Girls Day Out, Girls Nights and various workshops and special activities.

### L'Anno Bello: A Year in Italian Folklore

Elation, Emotion and Easter Eggs: Holy Week in Italy

After the damp and bitterly cold early spring fog, in which every raindrop feels like the pinprick of an ice crystal, I look forward to the promise of Easter, the premiere holiday of the season. Signs of Easter sprout around me as surely as the first purple tulips spring from the rich soil. Marshmallow Peeps wink playfully at me as they line shop selves in brilliant hues ranging from robin's egg blue to bright tutu pink. Baskets and wreaths boast eggs dyed with bold solid colors or glittery patinas. At the mall, costumed Easter Bunnies pose for family photos with children in frilly dresses and crooked bow ties. However, as much as the coming Easter fills me with pleasant anticipation, I am reminded that the week preceding the holiday brims with its own unique customs and traditions. The week's very name, Holy Week, reveals its profound importance in the religious year. Italians call Holy Week la Settimana Santa and celebrate its arrival with much fanfare. The Holy Week festivities in Italy emphasize seasonal spring folklore while also paying homage to the intricate and inspiring spirituality of this period. Whether filled with displays of palm leaves or colorful eggs, Holy Week in Italy and around the world heralds the Easter holiday with the reverence, love, and joy it deserves.

Holy Week begins this year on April 10th, which is Palm Sunday. Palm Sunday commemorates Jesus' entrance into Jerusalem, when adoring crowds welcomed Him by waving palm branches in the air. Along with its religious significance, Palm Sunday remains attuned to the seasonal beat eggs with my brother and me. of spring, symbolically falling during the time of the year

when tree branches begin to blossom. My father grew up in the mountainous region of Abruzzo in Italy, where he would spend Palm Sunday, or Domenica delle Palme, collecting the olive branches that grew plentifully in the hills and fields near his home. This was the same country wilderness, laden with ancient orchards and thick forests, about which village elder's whispered stories of sprites hiding under rocks and wolves darting among the trees. My father and his friends would then bring the branches to the local parish, where the priest would bless them. This quaint sylvan ritual embodied all the pleasures of spring, such as communal outdoor excursions and metaphorical links to the themes of rebirth and spiritual awakening. Throughout Holy Week, Italians also give their homes a thorough springcleaning in preparation for Easter and the days of visiting to follow. Holy Week ends with Good Friday, or Venerdí Santo, the solemn remembrance of Jesus' Crucifixion. In Italy, processions of black-robed participants set the somber and pensive atmosphere of the day. Processions that focus on the Virgin Mary are known as the Addolorata, a name indicative of Mary's grief and pain. Therefore, Holy Week begins in triumph but ends in tragedy, encompassing all the emotional spectrum necessary for the joy

For me, Holy Week has always meant Easter preparations, particularly those with an emphasis on the Italian traditions of my ancestors. My parents would reserve a day, usually Holy Saturday, for decorating Eggs have formed an integral part of Easter celebrations

rebirth symbolism: though they appear cold and sterile on the outside, they contain new life inside. I always enjoyed picking the egg dyes, and I would often choose a bright or glittery color to match the cheerful hues of the flowers growing outside my home. Easter eggs form a sweet part of Italian holiday customs as well. During Holy Week, my father would always buy a gigantic chocolate uovo di Pasqua (literally, "Easter egg") from a specialty shop in the North End, wrapped in pastel foil. We would patiently wait until Easter to ceremoniously break the egg open, eagerly anticipating the treats concealed within — usually candy. An Italian superstition decrees that everyone must wear at least one new piece of clothing on Easter, again illustrating the theme of renewal central to the holiday, and as such my mom and I would often shop for a new outfit during Holy Week. When I was a child, this meant a lacy, flowery dress. Though I no longer seek out itchy dresses, I do pick my new clothes with bright colors or a flowered pattern to reflect the spring season. Finally, my mother and I spend much of Holy Week planning our Easter menu. On Holy Saturday, I bake my traditional Italian ricotta pie to be served at the feast the next day. Therefore, I associate Holy Week with the joy and promise of an exciting holiday to come. Its customs have instilled in me an appreciation for the blooming new season of spring, for the spirituality of Easter, and for my Italian heritage as a whole.

Holy Week is a profound and multifaceted period of the year. It revels in the springtime and the resurgence of nature all around us, from the flowers fluttering proudly in the sunlight to the bunnies munching on the fresh green grass. It grants us an opportunity to enjoy the warm spring weather and to find peace and reflection in the spiritual traditions of the pre-Easter season. In Italy, people honor Holy Week by engaging in symbolic rituals like collecting olive branches on Palm Sunday, cleaning their homes, and decorating eggs. No matter which customs we take to heart, we should celebrate them in a way that expresses gratitude toward nature and the cycle of the year. Easter, after all, is the supreme holiday of hope and rebirth, and Holy Week encapsulates that feeling. Holy Week teaches us that if we live in harmony with nature and with respect for the ways of our ancestors, we will find a strength inside us brighter than any spring sun.

I do not support discrimination of natural hair. Never have and never will, but is a law really necessary to stop it? State Rep. Jessica Giannino added, "Hair is part of our identity and culture ... especially women of

People with hair, myself included, like cutting their hair as they wish. I didn't know we had the hair police now patrolling society looking for bad hair

Why do our elected representatives on Capitol Hill and Beacon Hill keep trying to find new ways to divide us from one another? I am a substitute teacher in a nearby public school system and I have seen every hairdo out there on

students regardless of race. Different styles and every color possible.

I didn't know we had the hair police out there patrolling our streets and arresting people for the crime of bad hair. Aren't there more important things out there needing attention? Inflation? Crime? Schools? Gas prices?. Housing? etc.?

I'm sure there are incidents in some schools over student haircuts and styles, but can't this be resolved without the need for a new law or making attacks on hair a hate crime now.

Listen, I have nine, yes, nine nieces or great-nieces who are mixed race and all of them have worn at one time or another all kinds of hairstyles and don't remember any of them ever getting flack over any of their dos. Their hair was their business and remains their business. Not my business and not anyone else's.

I was a police officer for 28 years who loved keeping his good Italian hair a bit long. I was often asked to cut it shorter but never did. I told my supervisors, I do my job and I do it well. Stop looking at my hair. Remember, you don't always need to create a new law to fix something like a hair request.

They can tell you in the service how to cut your hair. I so hated those military crewcuts and felt my head was naked .I don't care if you have braids or dreadlocks like Judge Ketanji Brown Jackson, an Afro like Angela Davis back in the day, or shave your head like U.S. Rep. Ayanna Pressley. Your hair should be your private business, but do we need a law to make it so?

Please don't treat us like babies.



The true story of six-time world champion prizefighter Emile Griffith is told in Boston Lyric Opera's (BLO) new production of Champion: An Opera In Jazz by Grammy Award-winning composer Terence Blanchard (Fire Shut Up in My Bones), with a libretto by Pulitzer Prize winner Michael Cristofer. The contemporary opera is brought to the stage by acclaimed theater director Timothy Douglas and award-winning conductor Kwamé Ryan, and will be presented for three performances on May 18th, 20th and 22nd at the Emerson Cutler Majestic

Champion chronicles Griffith's sweeping life story, from his beginnings in the Virgin Islands to his athletic success in America, through passionate love affairs and a tragedy that changed his life. The story is told as memories from an older Emile with dementia who is on a journey to redeem himself from the fight that left his opponent Benny "Kid" Paret dead.

Champion's story alternates between the story of the physically strong yet gentle Young Emile, who finds success in St. Thomas as a women's hat maker with a raucous social life before being recruited by an American boxing promoter, and an older Emile whose post-boxing life includes a long-time male companion who helps him navigate mental and physical decline, and a search for redemption.

Griffith's rise as a champion athlete ran parallel with his complex personal life; he married a woman, had sexual relationships with men, and openly frequented gay bars in 1960s New York. Whispers about Griffith became public when his opponent Benny "Kid" Paret taunted him in front of the media at a pre-match weigh-in. Enraged, Griffith dominated

Paret in a brutal fight, landing a rapid series of 17 blows that ended the match and put Paret in a coma. Paret died of a brain injury soon after.

"The story of *Champion* is one of a desire to find a sense of belonging," says Acting Stanford Calderwood General & Artistic Director Bradley Vernatter. "The details may be unique to Emile Griffith, but it is the story of many. Terence Blanchard's score is a mix of styles, one that is uniquely American, and reveals the warmth of Emile's story, and the complexities of his life."

## Saint Herman Joseph

Hermann was born in Cologne, the son of Count Lothair of Meer and his wife Hildegund. His sister was Hadewych of Meer. Though of the nobility, the family was not overly wealthy and considered poor. At the age of twelve, he entered the abbey of the Norbertine Canons Regular at Steinfeld. As he was too young to be accepted into the Order, he was sent to study, probably at Mariengaarde at Hallum in Friesland a province of the Netherlands. Upon his return, he made his vows and was given the

habit and the additional name "Joseph." Herman was entrusted with the service of the refectory and later of the sacristy.

After he had been ordained priest, it was remarkable with what reverence and devotion he offered the Holy Sacrifice of the Mass. He was known for his gentle demeanor and affability, his humility, his extraordinary mortifications, but above all, for his affection for the Blessed Mother. He was characterized by his child-like devotion to Mary. Herman experienced visions of Jesus, Mary, and Joseph, and authored a number of mystical writings.

Herman was sometimes sent out to perform pastoral duties and was in frequent demand for the making and repairing of clocks. Late in his life, he had under his charge the spiritual welfare of the Cistercian nuns at Hoven, near Zülpich, whom he served as chaplain. He passed away in 1241, and was buried in their cloister. His body was later transferred to Steinfeld.

His life was one of continuous penance, and he suffered strong temptations and physical illnesses. He was afflicted by incessant headaches that only ceased when he approached the altar to celebrate Mass. Their violence used to increase with the approach of Feast Days.

He had great sympathy for afflicted persons who always found in him a warm welcome and secure refuge.

Herman Joseph was Canonized on August 11, 1958, by Pope Pius XII. The Feast Day of Saint Herman Joseph is May 24th.





A Nostalgic Remembrance



Nanna had passed away from complications of breast cancer just before Christmas in 1958. Babbononno was devastated. He was never really one to show his emotion, he internalized everything. Just as an example, on holidays when I was a kid, my cousins and I would be playing something or other, just waiting to be called to dinner. Babbononno would be sitting in a favorite chair watching us with a stogie in his mouth, a glass of wine on a nearby table and his hands interlocked across his chest. He was taking stock of the children of his children. I didn't pay much attention to this aspect of his being until many years later when the late Sal DiDomenico Sr., and I were talking about grandchildren, and he confessed that he has done exactly that on many occasions.

When Nanna passed away, Babbononno was 83 and in good health, but my mother insisted that he come and live with us. At that point in time, we had a 3<sup>rd</sup> floor 5-room flat at 74 Eutaw Street in East Boston. One of the rooms was separated from the others and stood by itself at the end of the 3rd floor landing. When I was a kid, it was my workshop where I made things out of wood. When I turned 17, it became a music room where I practiced the bass violin. When mom asked Babbononno to come and live with us and he accepted, it became his bedroom.

I was in college at the time, and at the beginning of his stay, things were a bit difficult. Babbononno wanted to be a productive part of the family. The problem was, Dad had to get ready for work each weekday morning, and I had to get ready for my ride to Boston State College. After showering, Dad turned the bathroom over to me to do the same. In the interim, he shaved using his electric razor while looking into a magnified mirror mounted on the wall next to the kitchen sink. If Babbononno was trying to help out by washing the morning dishes or cups, he would be in Dad's way. If he had to use the bathroom and slow one of us down, we were thrown off schedule. Dad's schedule was a bit more flexible than mine. I was part of the East Boston Express, a name given to the three of us who were East Bostonians and rode to Boston State together.

The members of the group were Bob Pesce, a friend who graduated English High with me and was in every one of my classes. The second was Paul Ciccarelli, whose family was famous through their grocery store, The Trenton Corner Market. He usually drove and picked up Pesce first and me second. As a result, I had to be on a strict morning schedule. It took a while, but we began working around each other and things settled down with Babbononno giving way to his son-in-law and his grandson.

When I had to study, my favorite spot was the kitchen table. Dad was usually playing with his or other bands most nights of the week, and Mom would be watching TV. With me studying, she kept the volume down to help my level of concentration stay at its maximum. The problem was Babbononno. He was hard of hearing, but was too vain to admit it. As a result, the radio in his room was usually very loud. If he was watching TV with Mom, he would constantly complain about the low volume. If Mom was out, he would join me in the kitchen and try to carry on a conversation. At times, I had to be really emphatic and tell him that I couldn't talk until I was through studying, and more often than not, it would be in the wee hours of the morning. I felt badly, but if I wasn't prepared, I would have problems. Babbononno finally realized this and left me alone when he saw me at the kitchen table with a pile of books.

One winter's night, Dad drove home from a job in a blinding snowstorm. When he got to the house, there wasn't a parking space to be found. He brought his bass violin up to the 3rd floor and then went hunting for somewhere to park. By about 2:00 a.m., he finally found a parking space about 10 blocks away and walked home in the deep snow. When he came up the stairs to the 3<sup>rd</sup> floor, you could hear him swearing in several languages. After that point in time, he decided he wanted to buy a house in some suburban town. The town he chose was Belmont. Uncle Gino and Aunt Ninna had bought a house there and Dad liked the neighborhood. I loved the idea, but there was a problem, Babbononno didn't want to move. He had his routine and was happy with it. Because he wouldn't go, my mother refused to move.

A similar parking problem occurred one night when Dad came home late, and he was totally frustrated the next morning. He told my mother that he would pay for her and my grandfather to stay in East Boston, but he was moving to somewhere that afforded him better parking conditions, especially at night. When he found a house in Belmont, he brought all of us to see it. Babbononno told him the house was well built, but he wanted to stay in East Boston. My mother agreed with her father. Dad then said that he had put a down payment on the place and he was moving. My mother panicked and told Babbononno that her place was with her husband, and on Good Friday in 1960, we moved to Belmont.

I graduated college that June and told Dad that as soon as I found a day job, I would help out with the mortgage. Right after I received my degree, I decided to begin graduate school to earn a master's degree. That summer, Paul Ciccarelli and I were offered jobs teaching at Tewksbury High School, me drafting and him woodworking.

We were both hired. I stayed at the Seville Theater weeknights, but left weekend nights open for music. Between going to school and three jobs, I didn't pay much attention to Babbononno. He hated living in Belmont. No one sold Il Progresso, and no one sold this paper, the Post-Gazette and no one sold Italian cigars. There was nothing like Central Square or Maverick Square, where he could discuss politics in Italian with a bunch of cronies. He was miserable. My father and uncles made the decision to rent him an apartment back in East Boston where he would feel at home again. They found one near Maverick Square in Eastie, and Babbononno, then in his early '90s, had a bachelor pad all his own!

One day, Mom called him to see if he needed anything and a woman answered with an Irish brogue. She said that her name was Kathleen and she was looking after Michael. When my mother complained to my father, he accused of being jealous that her father had someone to keep him company. I never understood how they communicated.

Kathleen's thick brogue and Babbononno's fractured English might have been in the way but they understood each other until she passed away and my grandfather needed 24/7 attention. At that point he became a resident of what they used to call "an old age home." It's funny, in spite of Kathleen; my widowed grandfather never wore anything except a black necktie for the rest of his life out of respect for Nanna. That was the old Italian way.

GOD BLESS AMERICA



In Sicily, the *Pupa cu L'uova* (Pupi cu l'uova means "dolls with eggs"), *Pupo con L'uovo* or *Cuddura cu L'uova* are small sweet breads or cookies made with a hard-boiled egg on top or inside. They feature a dough shaped cross over the egg and a coating of sugar icing and/or colored sprinkles. These traditional treats of peasant origin have been created for centuries at Easter by the Nonna's as gifts mostly for the children. The "*Cuddura cu L'uova*" are uniquely made in different shapes such as baskets, dolls, horses, doves and hearts, and vary in name, flavor and texture throughout the regions.

I was so intrigued by these amazing delicacies and always wondered why my own Sicilian Nonna never made them. Last year, I had a conversation with my mother's long-distant first cousin, Jean Trasferini. Cousin Jean told me "Your Nonna didn't make them, it was your great-grandmom Catherine Mastroeni that made the "Pupi" for us (her grandchildren) at Easter every year. She used an anise flavored dough made with yeast, and they were more like a sweet bread than a cookie. Her eggs were never dyed, but they were beautiful and so delicious! We called them "goodoodies" from their dialect around Messina. My mom (my Aunt Nancy) tried to make them, but she would say they were never as delicious as Nonna Catherine's." My Cousin Jean and I were going to try and recreate this recipe but Jean became ill and is no longer with us. I have spent weeks sifting through old recipes of my own Nonna's and baking countless versions of these "Pupi". I believe I have finally put together a perfect rendition and I want to dedicate it with much love to my Cousin Jean Trasferini and my great Nonna Catherine Mastroeni. I hope you will join me in making "Nonna Catherine Mastroeni's Pupa Cu L'ova" for your loved ones this year, and help to keep this beautiful Sicilian Easter tradition alive ... Buona Pasqua!

#### NONNA CATHERINE MASTROENI'S PUPA CU L'OVA

#### Cookie Dough:

 ½ cup vegetable shortening
 ¼ cup unsalted butter, softened
 ½ cup granulated sugar
 3 large eggs
 Zest of one organic lemon
 ½ teaspoons lemon juice
 Zest of half an organic orange
 1 teaspoon vanilla extract

Zest of half an organic orange
1 teaspoon vanilla extract
1/4 cup whole milk
2 1/2 to 3 cups all-purpose flour
1 tablespoon baking powder



½ teaspoon salt 8 dyed or un-dyed hard-boiled eggs

#### Icing:

3 to 4 cups confectioners' sugar ½ cup whole milk 1 teaspoon anise, vanilla or lemon extract (optional) Nonpareils or sprinkles for decorating (optional)

#### To Make Cookies:

Preheat oven to 350°. Line 2 baking sheets with parchment paper and set aside.

In a large mixing bowl, cream together butter, shortening and sugar. Add eggs one at a time and beat well after each addition. Add the zest, extracts and milk and mix together well.

In a separate bowl, sift together 2  $\frac{1}{2}$  cups of the flour, baking powder and salt. Gradually add this dry mixture to the wet and mix together well. Add the remaining  $\frac{1}{2}$  cup flour (or more if needed) until a soft dough forms.

Place dough on a lightly floured dough board and knead gently for a few minutes then let dough rest for 10 minutes.

Separate dough into 8 sections, making the 8<sup>th</sup> section a bit larger than the rest (this will be used to make 7 crosses that will be placed on top of the eggs). You will be able to make 7 baskets and use the 8<sup>th</sup> section for the crosses. Take one of the 7 sections of dough and roll it into a 8 to 10-inch log. Take the log and fold it in half, twist/braid the halves together and then connect it into a circle, pinching the ends together. Place this "basket" on the prepared baking sheet and gently place a hard-boiled egg inside, pressing the dough so it adheres to the egg. Repeat until all "baskets with eggs" are made.


Take the remaining section of dough and divide it into 7 sections. Each will be used to make a cross that will go on top of the egg and connect to the basket (see picture).

Bake in preheated oven for about 20 to 25 minutes or until underneath of cookie is golden brown. Remove from oven and cool well before icing.

#### Icing:

In a medium bowl, add confectioners' sugar and gradually add the milk (and extract, if using) until a paste-like consistency is made (as thick or thin as preferred). Mix together well and brush on cooled cookies, decorating with nonpareils or sprinkles, if desired. Let harden and enjoy or refrigerate (hard boiled eggs should never be left unrefrigerated for more than 2 hours) immediately.

#### **Operation Desert Storm**

Two years after the Iran-Iraq war ended in August of 1988, peace negotiations were still in contention. In a heel turn, Saddam Hussein openly accused neighboring Kuwait of appropriating Iraqi oil and pandering to Western interests with low oil prices. Wasting little time, Hussein sent Iraqi troops to the Kuwait border (a country he refused to recognize). Counting on support from surrounding Arab countries, Iraq invaded Kuwait on August 2<sup>nd</sup>.

Far from supporting Hussein's actions, however, the Arab League expressed wide condemnation of the invasion and Saudi Arabia took the step of imploring NATO to step in.

The following day the United Nations called on Iraq to withdraw from Kuwait, but Hussein was undeterred, calling Kuwait Iraq's 19<sup>th</sup> province. On August 8, perhaps foreseeing the inevitable, the United States began sending fighter planes to Saudi Arabia in what would come to be known as Operation Desert Shield. Several other NATO allies also began making their way; the writing was on the wall.

Meanwhile, Iraqi presence in Kuwait increased by 300,000 troops. Still, Hussein seemed troubled by the lack of support from the rest of the Arab world and, when other negotiations were rejected, scrambled to make quick amends with Iran.

On November 29<sup>th</sup>, the United Nations gave Iraq an ultimatum for withdrawal by January 15<sup>th</sup>. Around 540,000 U.S. troops prepared for an attack, but a cross section of the United Nations joined forces in an inspiring display of international cooperation (United Kingdom, Japan, Egypt, France, Germany, and even the Soviets).

On the morning of January 17<sup>th</sup>, the US launched Operation Desert Storm, which began as an aerial attack on Iraq's air force, oil reserves, and communication facilities.

This aerial attack reduced ground battle considerably and, along with, a higher death toll.

he used his pen, he reminded folks that this federal law was a long time coming. We need such a law to protect victims from being hung today as in the past. Vice President Kamala Harris also added that lynching is "not a relic of the past."

#### **Dempsey's Layoff After Firpo Bout**


Didn't Fight Again for Three Years

Recently, I wrote about Jack Dempsey's fight against Luis Firpo and how that match cemented his reputation and turned him into a huge celebrity. However, instead of immediately exploiting the excitement surrounding him by returning to the ring for another big fight, his manager Jack Kearns took him to Hollywood.

In a move that was similar to the one made by Colonel Parker with Elvis Presley when he opted to put the King into movies, the Dempsey team felt it was a safer bet to cash in on his newfound notoriety by having Dempsey appear in movies and on the public appearance circuit rather than risk losing the title, which would kill his ability to make money as a famous athlete.

Things did not go all that well in Tinseltown. While Jack did make good money, his relationship with his manager fell apart. Dempsey married movie star Estelle Taylor and then fired Kearns. Doc responded by filing a number of lawsuits against the champion. The marriage to Taylor was also rocky.

While Dempsey was not known as a big drinker, he did partake in the Hollywood lifestyle of late night partying. It is safe to say he was not living a



**Jack Dempsey** 


during the time Jack was partying out West. Gene was getting sharper and sharper going against solid competition. When

with a flurry of fierce punches in the seventh round. This became known as the Long Count Fight. After Jack dropped Tunney, the referee, following a new rule, refused to begin the count until the champion went to a neutral corner. Ironically, it was Dempsey's people who insisted on having the rule in place. In the heat of the action, Jack reverted to the way he always fought and stood over Tunney. By the time Jack realized what he needed to do, the challenger had been given approximately four additional seconds to clear his head.

To this day, it is argued whether or not those extra seconds enabled Gene to survive. It

ing in condition to defend the heavyweight title.

When fight fans talk about heavyweight champs who have come back after taking off three years the first, and usually the only, name that comes up is that of Muhammad Ali. Indeed, Ali was deprived of over three years of his prime fighting career when he was denied a license to fight for refusing induction into the Army, but Joe Louis was also off for a number of years while he was serving in the Armed Forces. In Dempsey's case, the motivation was financial, while with Louis and Ali it was a sacrifice based on their principles. Dempsey earned money while doing it where it cost Ali and Louis financially.

During the period Dempsev was idle, another heavyweight was staying quite busy. Gene Tunney fought twenty times

life that was conducive to stay- Tunney and Dempsey met in the ring on September 23, 1926, Dempsey had been out of action for just over three years while Gene had been fighting on a regular basis. In fact, Tunney had six fights in 1925 alone. Gene was sharp while Jack was filled with ring rust.

Not to take anything away from Tunney, but Jack was not the same fighter he was when he took out Firpo. The champion was older and fading. In retrospect, it is no surprise Gene took the title from him.

After the loss, Dempsey fought Jack Sharkey. He beat Sharkey but looked terrible until the point where he scored the knockout over the Boston Gob. The victory did earn him a rematch with Tunney.

The second go around was much like the first with one exception. As with the Firpo fight, fireworks occurred when Jack put Gene on the canvas

should also be noted that in the very next round Tunny dropped Dempsey.

There is no doubt Jack Dempsey was one of the greatest fighters of all time, but the fact that he only defended the title six times in seven years leaves the question open to just how well he would have fared if he had been a more active champ. I believe he would have been quite successful had he fought more often. Had Dempsey stayed in shape and fought on a regular basis he very well may have defeated Tunney.

In essence, Jack retired after the Firpo fight when he was at his peak. If he had stayed away from Hollywood and just focused on his career as a boxer, he would have stayed sharp and it is unlikely anyone would have beaten him for some time.

Yes, Jack Dempsey was a great fighter, but we will never know just how great he could have been because of his selfimposed layoff.

CORY CAPTURES A CLASSIC — There he was again, guarding the crease in a regular season NHL game, this time for the New York Islanders.

Yes, that was Cory Schneider, a native of Marblehead and a former Boston College netminder, stopping 27 shots as the Isles prevailed over the New Jersey Devils by a 4-3 count.

You have to go all the way back to pre-Covid-19 days to find the last time Schneider saw the lights of the big-time. That would be on March 6, 2020 when he patrolled the crease for the Devils in a 4-2 victory over the then defending Stanley Cup champion Saint Louis Blues.

The recent outing was the latest chapter in an old NHL story. Always see to it that a player gets some ice time against his former team. After all, he may have more than the final score of the game to settle with his former franchise.

That may well have been true for Schneider, who was initially a first round selection in the 2004 NHL Draft by the Vancouver Canucks. But first Schneider enrolled at Boston College, where he was a standout in both the classroom and on the ice, being named twice to the Hockey East All Academic Team while backstopping the Eagles to a pair of Frozen Four appearances.

After three years at the Heights, he left for the NHL but the Canucks placed him with the minor league Manitoba Moose for the better part of three years (2007-2010). After the lockout year of 2012-2013, Schneider was traded to the Devils in late June of 2013. A year later, in July of 2014, Schneider struck gold in the form of a seven-year, \$42 million contract. That's an average of \$6 million a year (\$500,000 a month).

Unfortunately, things did not go well in the years that followed. Schneider was beset by injuries at various times and the Devils failed to make the playoffs in six out of the seven seasons.

Eventually, Schneider found himself in the minors again, as a goalie for the Bridgeport Islanders of the American Hockey League where he had a 10-10-4-1 record before being called up.

But then the unexpected occurred. Starting New York Islanders goaltender Ilya Sorokin was not ready because of an upper body injury, a reality that would have meant that backup Semyon Varlamov would have to play a third game after just having pulled duty for both ends of back-to-back games.

So the phone rang in Bridgeport and Cory Schneider took the call, made the trip to the Prudential Center in Newark and secured the victory. In a way, it seemed like old times since it occurred in the very same New Jersey arena where Schneider had played those seven seasons for the Devils.

"Real happy for Schneids," Islanders head coach Barry Trotz told the New York Post. "I think for him, he wanted a little bit of redemption, if you will. He has gone through some injuries, rehab. All the stuff that people don't realize can derail your confidence, can derail your career. All that."

For one shining moment Schneider dazzled like he did in days of old. His family was there. There were smiles all around. It seemed like layers of time had been rolled back. But, in fact, time marches on. Whether Corey Schneider, who recently turned 36, can continue to march with it, remains to be seen. But for one wondrous afternoon, it all came together and it was truly something to behold.

OBSERVATIONS ON THE OUSTER OF O'CONNELL — The coach who led his team to victory in the 2022 Beanpot won't be in charge of that squad in the future.

That's because Albie O'Connell, who served four years behind the bench as the head coach of the men's hockey team at Boston University, was shown the door by his alma mater in the closing days of March.

That's too bad since O'Connell was the epitome of all those athletes who have skated under the impressive red and white banners at the university. The Terriers really had two seasons this past year. They started slow at 4-9 but then came alive and put together a 14-1-1 streak that included that Beanpot triumph and a 19-13-3 finish.

Could it have been better? Yes. Was it terrible? No.

Remember, O'Connell had already proven his loyalty to BU as a four-year member of the hockey team and as an assistant coach for a number of years prior to his being named to the leadership position. That should count for something.

In addition, there are other factors to consider. This was not simply the termination of a coach. This was an administrative decision that affects many others.

When Syracuse University head football coach Scott Shafer was dismissed in 2015, he was one of the few individuals to highlight the full ramifications publicly. He noted that his termination did not solely involve him but nearly all of his assistants. Houses would have to be sold, families would have to move and in this particular case, the lives of 27 different children would be disrupted through the loss of face-to-face contact with their friends and the need to enroll in new schools - often in distant communities or other states. This was especially true in the case of Syracuse since it was the only school for hundreds of miles around that played a big-time college football schedule. To our knowledge, it was the only time that the true humanitarian dimensions of such a move had been brought to public awareness.

Although all the possible effects may not be the same in the case of BU since there are a number of Division One hockey programs in Massachusetts, we do wish Albie O'Connell and his assistants well as they and their families search for new positions, plus perhaps new residences and new schools for their children. May their disruptions be minimal as this process plays itself out.
