College and Credit Card Debt

I read somewhere that student college debt now has surpassed credit card debt in this country. Who out there is really surprised by this news? Certainly, I am not surprised. Baker-Polito Administration Extends Non-Essential Business Closures to May 18th, Announces Reopening Advisory Board

The Baker-Polito Administration extended the essential services emergency order to May 18th and launched a Reopening Advisory Board that will produce a plan to the Governor by May 18th. The Administration also announced that the Department of Public Health's Stay At Home Advisory remains in effect and gatherings of 10 or more people remain prohibited until May 18th.

Essential Services Order: Governor Charlie Baker's emergency order requiring that all businesses and organizations that do not provide "COVID-19 Essential Services" close their physical workplaces and facilities to workers, customers and the public will be extended until May 18th. Businesses and organizations not on the list of essential services are encouraged to continue operations through remote means that do not require workers, customers, or the public to enter or appear at the brick-and-mortar premises closed by the order. This order also extends the existing ban on gatherings of more than

10 people until May 18th. Stay at Home Advisory: Governor Charlie Baker announced that the Department of Public Health's stay-at-home advisory will remain in effect. Residents are strongly urged to stay home and avoid unnecessary travel and other unnecessary person to person contact during this time period. Residents who are considered at high risk when exposed to COVID-19 should limit social interactions with other people as much as possible.

Under the guidance, all employees performing non-core functions who are able to work remotely should continue to do so until May 18th.

Reopening Advisory Board: Today, Governor Baker announced the formation of the Reopening Advisory Board, which will be Co-Chaired by Lt. Governor Karyn Polito and Housing and Economic Development Secretary Mike Kennealy. The Board brings public health officials together with leaders from the business community and municipal government from across the Commonwealth. This group is charged with advising the administration on strategies to reopen the economy in phases based on health and safety metrics. frameworks and customer protocols and guidelines, including enforcement mechanisms and coordination with municipal leaders. This report is due on the 18th, but the administration has made clear that public health data and guidance from health care experts will dictate the timeline of the re-opening

The 17-member Advisory Board is composed of three public health officials, including Department of Public Health Commissioner Dr. Monica Bharel, three municipal officials, and eleven leaders from the business community, including MassDOT Secretary and CEO Stephanie Pollack. Members of the Advisory Board bring a range of perspectives to the table, such as an understanding of workplaces and workforces and insights into key areas like financial markets, education, manufacturing and transportation.



Stirpe Nostra

HESTIA

Hestia, sister to the mighty Zeus, was the Greek goddess of the hearth and the symbol of domestic tranquility. She was the founder of the family unit, encouraged the public worship of all gods, and being the abiding goddess of the household, never left Olympus. She was wooed by both Poseidon and Apollo, but took a vow of chastity, and because of this, Zeus honored her as the guardian of every household hearth. She was also remembered at the beginning and at the end of every sacrifice, and at every festive occasion. These feasts began and ended with some kind of liquid toast to Hestia, and by so doing, she was permitted to share in the festivities. In every prayer and solemn oath, her name was uttered before that of any other deity.

Because of Hestia, the hearth became the center of family life, and also a place where fugitives or strangers found hospitality and asylum. As the household hearth formed the center of family life, there was usually a community building (pryteaneum) to keep alive the sacred fire in a hearth which became the center of civic life. This is where the city officials sacrificed to Hestia,

held public discussions, and recognized deserving citizens. It was also the place that hospitality received those who were seeking protection from the state, and even the source from which colonists took fire for the public hearth of their new settlement. Thus, the activities surrounding the hearth of Hestia became their religious center and a way of life for all Hellenic people.

Hestia was considered, along with Zeus, as a guardian of the law of hospitality and of the oath. She was often worshipped with Hermes (Mercury), who we know as the god of herds, commerce, travel, cunning, and as the messenger of the other gods. At times, both Hestia and Hermes were invoked together. She as the goddess of domesticity and tranquility, and he as the god of the restless life on the public streets.

Statues of Hestia usually represented her with a firm but yet gentle expression. Either sitting or standing, but in all instances her attitude was one of calm, and she was always shown fully clothed. The Roman counterpart to Hestia was called Vesta. Her temple housed the sacred fire which was considered to be the source of all Roman life and power.

As the pandemic COVID-19 (Coronavirus) spreads across America — and the World — we see a population splitting apart. People wearing masks. People walking six feet or 20 yards away as we pass by on sidewalks or various venues. People no longer shaking hands or hugging in parking lots or inside restaurants or at post offices. People dying everywhere.

Adjusting to the stark realities of the most difficult time in America since the polio scourge of the 1950s is scary and awkward. It's surreal on many levels. Strolling about the sidewalks of my neighborhood there's few walkers when on a pre-pandemic day numerous folks would pass by, most tossing a wave or saying a cheery hello. Others extending an arm to shake hands or a quick hug. Lately, those niceties that surrounded me my entire life have nearly vanished. Streets, too, are virtually devoid of the formerly voluminous vehicles.

My neck of the woods in Newton is a haven for traffic heading toward several routes and two highways in every geographical direction. The Commuter Rail and Green Line are easy walking distance. But the past three months vehicular traffic has dwindled dramatically. The constant pace of people moving to and from rail systems and bus stops went empty after the MBTA shuttered dozens of bus and rail routes. Solemn reminders that a new order commands our every thought and action.

While conversations with family and friends over the lack of anything close to our daily routine focus on the catchwords "eerie" or "abnormal," I view the lay of the land as something other than all that. The unforeseen moment we're confronting offers intriguing pondering of a simpler time when autos never existed. A sort of time warp of less coming and going now mixes with quiet, cleaner air.

Oh, there's still the constant rumble of trains with reduced schedules. Sirens from fire trucks and police cruisers and ambulances pierce the air. Those loud motorcycles jolt a deep sleep. And the always welcome low whir of the Island Hop flying south to Cape Cod or the Islands keep me tuned to 21st-century realities. It's the stillness of humans no longer talking during a late-night walk past the house or calling greetings across the street or meeting in the neighborhood bakery recently closed that rings hollow.

I am reminded regularly of Dorothy in The Wizard of Oz, pleading: "I want to go back.

I've got to see my Auntie Emm!" Yes, I want to return to some semblance of order. The humdrumness of life — while occasionally disjointed — has its merits. Never, though, have we collectively witnessed human suffering within our society on the massive scale such as today's pandemic.

Suffering and struggling humans around the world, particularly in war-ravaged nations, remain. Hunger is rampant in parched lands. And I continue wondering why the ugliness exists after years of constant chaos, mayhem, disruption, as well as the human toll of a million people moving from their native lands to other countries that cannot allow nor afford all to enter. Their burdens will continue. But why should they have to?

So, yes, I am similar to Dorothy. I yearn to return to humans I cannot see and hug and kiss and sit next to during dinner or a meeting or in church or in a park. I desire to hop the Green Line to avoid fastpaced vehicles whizzing by or backed-up traffic on highways or off-ramps linking to cities in the region. I need to feel whole again amidst familiarity and friendliness and even the rare impertinence of others.

At the same time, I recognize that many humans in harm's way after years of the other evils named hunger and dictator — whose oppressive regimes prevent freedom and self-determination by citizens - are far more nightmarish than ours. Their uncertainty for a brighter future is dim. Their current climate of fear and hunger never

Our future beams brightly despite the pall hanging across the nation. Hope abounds throughout our society. And our present situation is somewhat squelched by food banks, happy volunteers aiding homebound elders, a healthcare system that works despite its imperfections, along with our government's longstanding institutions that provide services, shelter and monetary support.

Life is going. A vaccine that will end the evil virus is within reach of the hands of the most brilliant scientists, researchers, professors, and doctors on the planet. But let us work together towards a better nation and more equitable world that leaves behind the old ways. A routine that clouded a clearer understanding of continuous human suffering way worse than we knew. Suffering and struggle that we relate to in some ways and know now. It cannot be in vain this stark

L'Anno Bello: A Year in Italian Folklore

Magical May, Mysterious May

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.

Looking out my window, I can see that the trees no longer hide their blossoms. Just moments ago, it seems, branches stood bare, with only the tiniest speck of a green bud poking through. Now the vibrant tone of fresh, young leaves fulfills the spring promise made by these delicate early sprouts. Whenever I notice the ever-larger number of trees bursting with frothy green foliage or gossamer purple flowers, I float with excitement over the sheer beauty of nature. From the clouds that scuttle across a sky as a perfectly blue as a robin's egg, to the jewel-toned berries that begin to shine from shop shelves and farmer's markets, the vivacity of spring has encircled the world. With all of this regrowth blooming around us, it is little wonder that the spring calendar is laden with celebrations that call for outdoor festivities, prompting people to enjoy nature. One such seasonal feast, commemorated by our Italian ancestors since ancient times, honors the rejuvenation and fertility of nature that occurs as spring yields to summer. This folkloric festival is known as May Day, and it renders homage to the trees, flowers, and the mystical transformations of nature that characterize spring. More recently, May Day developed into a labor holiday, one which pays tribute to the contributions and sacrifices of workers worldwide. In all of its manifestations, May Day focuses our attention to the magic of nature and the rhythmic bloom of a reawaken-

May Day, as evident by the name, occurs on May 1st every year. The ancient Celts celebrated May Day as a holiday called Beltane. Beltane marked the beginning of summer, the time when livestock were moved to wider pastures for grazing. In the majority of European countries, May Day festivities begin the prior evening on April 30th. This is Walpurgis Night, a feast in honor of a mysterious Saint Walpurga. Since May Day serves as a transitional seasonal milestone, poised on the cusp between spring and summer, people in older times believed that witches, fairies, and sundry other supernatural beings rambled through the Earth during this liminal evening. Contemporary Scandinavians



and Northern Europeans still dress like witches on Walpurgis Night, welcoming May Day with bonfires and picnics. Italians also link the month of May with the paranormal. The ancient Romans dedicated May to the worship of the dead, perhaps prompting the old superstition that it is unlucky to marry in May. Europeans now celebrate the woodland sprites thought to be especially active in May, and indeed, May Day festivities revel in the wonder of the springtime forest. People adorn their homes with greenery and, in a remnant of an old fertility ritual to help crops grow, dance around maypoles festooned with garlands and ribbons. Many Italian cities and towns celebrate May Day, or Calendimaggio, with quaint festivities. The medieval city of Assisi hosts a Renaissance fair where costumed participants enjoy parades, concerts, and balls. The citizens of Nogaredo, a city in the northern region of Trentino, dress up as witches for their Calendimaggio feasts and decorate the town with spooky lights and bonfires. Magic is certainly appropriate for May Day — after all, what greater magic is there than the rebirth of nature in the spring?

In addition to the folkloric nature-based celebrations, May Day also functions as Labor Day in many countries worldwide. In Italy, for example, May 1st is a public holiday known as la Festa del Lavoro, part of International Workers' Day. Italians take this day to commemorate the contribution of workers while also enjoying some rest and leisure. Similar to the ancient nature rites of May Day, families may flock to the beach or mountains, gather for picnics, or visit famous historical sites. Others attend parades that focus on the movement or partake in demonstrations that call for an end to the workplace injustices, which still persist to this day. As part of the Italian-American community, we too can celebrate la Festa del Lavoro by ruminating on the remarkable strides that Italians have made in the United States. At the beginning of the twentieth century, most Italian immigrants arrived in America with little money or formal education, but nevertheless worked hard, often in strenuous and thankless jobs, to provide for their families. Italians became particularly active in the labor struggle that rocked the nation at the turn of the century, quickly forming unions, participating in strikes, and raising the demand for shorter workdays, injured workers' compensation, and an end to child labor. We should thank the Italians and other immigrant groups for the safety regulations and labor law advancements made in the workplace since those long-ago days. However, la Festa del Lavoro also urges us to continue our ancestors' campaigns. Many labor injustices still exist in both the United States and the world at large, including slavery, children forced into dangerous jobs, and unsafe conditions in factories and mines. Just as flowers and leaves bloom with renewed vigor during the spring, so too should our compassion bloom, and we should strive to make the world a better place for our fellow humans. May Day is all about rejoicing

in the beauty of nature, which manifests itself in a plethora of forms. The rejuvenation of Mother Earth reverberates in the rites of May Poles, flower wreaths, and the decoration of homes with greenery and blossoms, a practice the ancient Europeans called "bringing in the May." The mysterious nature of our world, that shivering sense of excitement that accompanies the unknown, echoes through May Day's emphasis on witches, fairies, and woodland pixies. Finally, our human nature, which should always carry kindness and compassion, shines in the way we stand in solidarity with the dignity of others during International Workers' Day. Throughout May Day and the month thereafter, let us aim to incorporate all these aspects of nature into our own souls. Let us make our inner being rise from the depths of winter like spring leaves bursting into the sunlight. Let us open our eyes in wonder as we contemplate the magic present in even the most mundane facets of our everyday lives. Let us dedicate ourselves to the Earth, which we call our home, and to improving the lives of our brothers and sisters who share our planet. By opening ourselves to the magic of May Day, we will foster an eternal spring in our very souls.


Four Women "Quattro Donne" subtitle, A North End Love Story

THE BAKERY

Mom was preparing breakfast the following morning. She was in the kitchen singing. One by one, we made our way to the kitchen and gathered round the kitchen table, all except Pietro. Mom pointed to Pietro's chair and asked Anthony, "Where is he?" Anthony gestured in the direction of the living room. Mom concerned over the events of the night before, decided to see what was going on with him. Cautiously, she walked into the living room to find Pietro sitting by the window, seemingly staring into space. Mom placed her hand on his shoulder, Pietro barely responded.

"What's wrong Pietro? You can tell me," Mom asked softly. There was no response. Mom asked again, this time she stroked his hair. The immediacy of her touch seemed to pierce Pietro's wall of silence and pent up emotions. Turning toward Mom, she could see the pain on his face. "Carmela, please forgive me. I know you were trying to help, but Frank Ricci shamed me, and he did it in front of your friends. I'm an embarrassment to you." Pulling up a chair, Mom sat as close to Pietro as she could. "Pietro, you're a student, Frank Ricci is a fisherman, hardened by the sea. You're a mere boy by comparison, no match for Frank, but you stood up to him and I'm proud of you. The whole family is proud of you. Pietro, I knew

Pietro took his seat at the breakfast table. We had already eaten everything Mom prepared and were waiting for toast. It was then Mom noticed we were out of bread and asked Anthony to run to Giovanni's, our favorite bakery, for a loaf of Scala. Anthony was getting ready to go, when Mom suddenly turned to Pietro and asked if he would go. She wanted him to get out in public as quickly as possible, and Giovanni's was as good a place as any to make an appearance, since the bakery was always busy in the morning.

Giovanni's was famous for its crusty Italian bread. Mornings were always busy at the bakery, when the aroma of bread, still hot from the oven, filled the shop and drifted out to the street. We always wanted to get there while the bread was still steaming, break off an end piece, and eat it on the way home. Nothing is more delicious. Often in winter, Mom would slice bread into several thick pieces, drizzle it with leftover tomato sauce and sprinkle on grated cheese, "instant pizza." Walking into the bakery, you were greeted by lit showcases filled with Italian cookies. The walls, covered with tin sheeting, were banked with shelves displaying loaves of bread in all shapes and sizes: round bustone, baguettes, and miniature loaves, ideal for making an Italian cold cut sandwich. We always bought the Scala loaf, which derives its name from its shape, an oval loaf of bread formed in sections reminiscent of steps in a staircase, hence the name scala (stairs).

MBTA Fare Transformation Program Advances with Approval of Amendment to Public Private Partnership Agreement

New System Projected to Collect \$8 Billion in Fares Over First Ten Years of Operation. Customers Will Begin to See Benefits of Fare Transformation Over the Next Year. New Technology Will Enhance Access to Transit,

Promote Affordability, and Adjust to Future Customer Needs.

The MBTA's Fiscal and Management Control Board approved a contract amendment regarding the Public Private Partnership agreement involving the T and the consortium Cubic | John Liang. This action marks a significant step toward implementing the revised transformative initiative approved by the Fiscal and Management Control Board in December 2019, locking in an achievable and enforceable schedule while procuring new technology that will that will allow the system to adapt to future changes in ridership and to implement new kinds of fare options.

The amended contract totals \$935.4 million, including both the full capital cost of the system and a ten-year stream of operations and maintenance payments. Although this represents an increase of \$212.1 million in project costs compared to the contract approved in 2018, the new fare collection system remains cost-effective and is projected to collect over \$8 billion in fare revenue during its first ten years of operation.

This amendment, which strengthens the original 2018 AFC 2.0 contract, enables the MBTA to achieve all the original goals of the project under a new approach. Based on feedback from customers, advocates, and policy makers, the new approach will result in customer-focused upgrades to the existing and future systems. In addition, this board action reestablishes key milestones, includes new provisions that reduce the T's construction risks, and allows the system to account for future changes within the payment industry.

"Under this program reset, we'll be able to deliver one system that can be used across all modes that meets the needs of our customers today, and has the ability to adapt to future needs," said MBTA General Manager Steve Poftak. "Especially in light of recent changes to daily life caused by COVID-19, it's more important than ever to move toward a dynamic system with contactless options that can withstand major changes to conditions that would otherwise undermine a legacy system of fare collection."

The amended contract is only one part of a comprehensive Fare Transformation initiative that will ensure that customers begin to see improvements in fare collection over the next year, including the ability to obtain CharlieCards more easily and the elimination of the cash/ticket surcharge in 2021, so that CharlieTicket and cash fares will be the same as CharlieCard fares.

Under the phased approach and in the short term, Fare Transformation will result in improvements that include:

- The ability to pay for a trip on all Zone 1A stations on the Fairmount Commuter Rail Line with a CharlieCard;
- Deploying fare vending machines that dispense CharlieCards;
- All-door boarding on MBTA buses and surface stops along the Green Line;
- Integrating ferries and the entire Commuter Rail network into the CharlieCard system.

This amendment also allots more time for both testing and installation of the new system and customer migration. Working with stakeholders, the program reset establishes a more robust, thoughtful net-

work of retail sales outlets and fare vending machines centered on the needs of T customers. In conjunction with that process, the MBTA has committed to a significant increase in the total number of vending machines to ensure adequate access.

"Critical to this project's success is outreach, and the level of engagement we've received indicates just how important the future of MBTA fare collection is to our customers," said Ron Renaud, Chief Transformation Officer. "Thanks to the feedback, we are now on a course to provide improvements to our existing system, and ultimately, deliver a project that is even more focused on the needs of our customers."

While the MBTA's existing fare collection system collected approximately \$671.7 million in FY19, the aging system requires substantial maintenance and upgrades and cannot support the kinds of fare options that customers have requested.

"The investment in new fare collection technology is an investment in the MBTA's future," explained General Manager Poftak. "Fare collection is critical both to funding services and to building a system that provides dynamic capabilities, enhances access to transit, and promotes affordability and can adjust to future customer needs."

The new technology provided by the Public Private Partnership offers reliability of equipment, readily accessible payment technology, and flexibility in fares and programs to further enhance access and equity for the MBTA ridership of the future.

Saint Hilda of Whitby

According to the Venerable monk and Scholar, Bede, Hilda was born in 614, into the Deiran royal household. She was the second daughter of Hereric, nephew of Edwin, King of Deira and his wife, Breguswīþ

She was the founder and abbess of the monastery at Whitby, Kingdom of Northumbria, Britain. She was a Northumbrian princess who converted to Christianity with the rest of the court of her great-uncle, King Edwin of Deira when she was 13. She was raised at Edwin's court in the tradition of Roman Catholicism, but at the age of 33 became an adherent of Celtic Christianity, tutored in the faith by Aidan of the monastery of Lindisfarne, and was abbess at Hartlepool Abbey before founding the monastery at Whitby.

The prestige of Whitby is reflected in the fact that King Oswiu of Northumberland chose Hilda's monastery as the venue for the Synod of Whitby, the first synod of the Church in his kingdom. He invited churchmen from as far away as Wessex to attend the synod. Most of those present, including Hilda, accepted the King's decision to adopt the method of calculating Easter currently used in Rome, establishing Roman practice as the norm in Northumbria.

Hilda was highly educated, her wisdom was so legendary that her counsel was sought by nobility and commoners alike. Hilda was an able admin-



istrator, carefully overseeing the large estate of Whitby while also ministering to the needs of the community. She encouraged the shepherd Caedmon to share the famous hymn which came to him in a vision (Caedmon's Hymn), written in the 7th century. It is the oldest extant poem in Old English, for which she is honored as patron saint of poetry in addition to her honor as patron saint of culture, literacy, and learning. Hilda suffered from a fever for the last seven years of her life, but she continued to work until her death on November 17, 680. Hilda is honored as a saint, her feast day is November 17th.

Nanna & Babbononno

A Nostalgic Remembrance



On the 15th of this month, this column, Nanna and Babbononno, will be 29 years old. I never thought I would achieve the levels of success that have been afforded me as a writer. I didn't start out to be a writer and only tackled the task of writing when it coincided with something I happened to be teaching. As an example, when I taught drafting at Hyde Park High School, it was on a college track, not in a vocational direction. The industrial department director asked me to design an intermediate course for college bound students. I came up with geometric figures, both flat and solid, or three dimensional as the beginning of the course, and designed a course of study that explained the construction of each shape included. A couple of years later, I was recruited by the superintendent's office to head up a program they wanted to put into action. It seemed that the Latino population in Boston was ever increasing and most of the hospital personnel could not speak Spanish. I was asked to write a booklet or book on conversational Spanish slanted toward communications between doctors or nurses and their Spanishspeaking patients. I put the book together, and it was successful for several years, in those courses, using my book and course of study were implemented in at least five Boston hospitals. What I'm saying in a mouthful is that, "Anything I wrote was academic and slated for designated groups, nothing

I was quite busy back in the day, teaching during the day, supervising my Spanish program during the afternoons, and playing music at night. One Monday afternoon, after I left Hyde Park High School, I headed for the Musicians' Union, as Mondays was the unofficial meeting day there. Musicians would gather to converse with bandleaders and contractors, hopefully, to book future work.

more."

The then union president spotted me, came over, and asked to speak with me in his office. My comment to myself was, "What the heck did I do now?" Just after he closed his office door, President Sam Marcus said to me, "Arthur Medoff passed away." My reply was, "I know the name but not the man himself. If he was a personal friend, I then extend my condolences." Sam then added, "Arthur has been writing a column in our union magazine and I need someone to take it over stat." I told Sam that I had written some things for academia, but nothing on a social level where the Medoff column was based. Sam's comment was, "If you can write one thing, you can write another. Want to give it a try; I really need a replacement, now!" That night at dinner, I discussed the challenge with Dad and Babbononno. They both assured me that, having grown up in a family composed of musicians (Babbononno, Dad, Uncle Paul, and Uncle Nick) I had or could get enough information on two generations of entertainers. All I had to do was ask, "Who, how, why, what, when and where?," and then put the information down on paper. After that, I accepted the challenge, and for several years wrote about Boston's music scene and the men and women that made it happen. I don't want to brag, but the column was successful, maybe because I did my homework and I sort of write the way I speak ... whatever ... but it worked.

Early in 1991, Loretta and I were at Dean Saluti and Margie Cahn's home for a dinner party. At that point, I met Pam Donnaruma, my boss, the publisher and editor of this paper. In conversation, she told me that a writer for her family newspaper was leaving and she needed a replacement. I had remembered the Post-Gazette from when it was called La Gazzetta del Massachusetts. Babbononno used to read me the stories from the paper when I was a kid and it was printed in Italian. I hadn't seen the paper since my grandfather had passed away, but I did know that, at that point in time, 1991, it was printed in English.

The next day, I spoke to Dad about accepting the offer. I told him that I didn't think that the people who read the Post-Gazette would be interested in stories about Boston's music scene and the people that made it happen. He then reminded me that I grew up in an Italian, Italian American home, and if I could remember all of the things I experienced from the time I was a child, the Post-Gazette readers might be interested. He then added in, "Talk about those Sunday dinners, the family get-togethers, family weddings, Christenings, and those three-day wakes. Talk about parents, grandparents, aunts, uncles, cousins, the extended family you experienced, the neighborhood you came from, and the people you came in contact with. I can almost guarantee, people will identify with what you have to say."

I called Pam at her office and accepted the writing position after I thought over what Dad

had to say and considered it a challenge. The next thing I had to come up with was a title for a column, and thought that the titles we kids used to identify our grandparents might be a plausible name, *Nanna and Babbononno*. And so, on May 15, 1991, my first story came to be. It was about how Babbononno came to America in 1896 (the year that this paper was founded), and never left.

Since that point in time, I've written stories about both sides of my family, the Christoforo and Contini sides. I wrote stories about Nanna and Babbononno, Grandpa and Grandma Christoforo (their name was originally DeCristoforo or DeCristofaro), I'm not sure. I've written stories about all my uncles and aunts (the only one still with us Uncle Gino's widow, Ninna Contini, who is now 96). I've written stories about traveling the world with Sal Meli, an old neighborhood chum. I've written stories about the escapades I've been involved in working at the Seville Theater, hanging out with Dean Saluti, John Silva, the late Bill Hurley, and many others. I've even included a few things about playing with bands throughout the years. Whatever I did seemed to have worked, and I am proud of the success of this FAMILY column. Come May 15th, writing a story a week totals 18,096! I thank God for those old Boston Yankee schoolteachers who taught me proper English back in the day...it sure helped out.

For quite a while now, people have been pushing me to write a book based on this column. I brought the first few chapters to Florida with me, and considering I'm stuck here for another month or two, have had time to develop about 80 or 90 percent of it. I'm doing the editing right now, and hope to complete it within the next couple of months.

When it is complete, I will get it ready for publication by adding in family pictures, some that go back to the 1890s. So, in three weeks, *Nanna and Babbononno* will be 29 years old. It is a tribute to the generations of my family (if you add in my grandchildren, it is six generations) and I hope to continue my weekly offerings as long as you're out there to read them. Mille gracie ...

When we hear the phrase *La Cucina Povera* it means, "cooking of the poor," and it is also referred to as "peasant cooking." This type of "poor cooking" originated years ago in southern Italy. Times were tough and ingredients were hard to come by. Few ingredients were used to make meals, and food was never wasted or thrown away. In fact, remainders from one meal often became the basis for another. Leftover potatoes turned into a potato and egg *frittata*, and stale bread into breadcrumbs. From *pasta e fagioli* to *biscotti*, many of today's most requested dishes and desserts were actually invented out of necessity by the peasants in Italy years ago who learned to make delicious meals from the simple ingredients they had available.

I was raised on this type of cooking. My Nonna made dishes from whatever she had on hand. When the string beans ripened, she'd make *spaghetti e fagiolini*. If the garden tomatoes were ready to be picked, we'd have fresh sauce or *insalata caprese*, and leftovers would be used to make another day's meal. *La cucina povera* is all about discovering the delicious creativity that can arise from making do with what you have access to. The recipe I'm sharing today is a perfect example of how "leftover" stale Italian bread and a few simple ingredients can be put together to create a delicious "Italian Bread Pudding." Absolutely perfect for either breakfast or dessert!

ITALIAN BREAD PUDDING Budino Di Pane Italiano

Bread Pudding

3 eaas

1 1/4 cups sugar

1/4 cup light brown sugar 1 teaspoon cinnamon

1/4 cup butter, melted and cooled

3 cups whole milk

1-1 ½ loaves stale Italian Bread, cut into cubes 1 cup raisins (optional)

Crema Anglaise

(makes 1 cup)
3 egg yolks
1/3 cup sugar
3/4 cup heavy cream

1/4 cup whole milk 1 teaspoon vanilla

Preheat oven to 350°. Generously grease a 3-quart baking dish with butter, set aside. In a large bowl, beat eggs, sugars, and cinnamon. Continue beating while slowly adding milk and butter. Gently stir in bread cubes and raisins, if desired. Pour mixture into prepared bowl. Let sit for 15 minutes so bread can soak up mixture. Bake for 50-60 minutes, or until set. Let cool completely.

For crema anglaise, in large mixing bowl beat egg yolks and sugar, until fluffy, set aside. In large saucepan, bring cream, milk, and vanilla to scalding. Turn heat to low, slowly pour egg mixture into cream mixture, while stirring constantly. Continue stirring until thickened. Drizzle over bread pudding before serving.







HOOPS and HOCKEY in the HUB

There shouldn't be anyone wondering why city officials in Las Vegas want their community to reopen following the imposition of restrictions in response to the onset of the pandemic. That's because one of the scenarios being strongly considered by the NBA powers that be is to have all 30 teams convene in that city and finish the regular season plus conduct the playoffs using a variety of facilities in the area, including some college arenas.

The city is familiar to virtually all the players, coaches and front office executives since the annual summer rookie league takes place there. Not lost on city officials is the fact that almost all the players and coaches are millionaires with, of course, money to spend in their leisure hours.

What also driving this is television. No franchise in pro sports could afford to pay the players their enormous salaries if the sole sources of income came from ticket sales, concession revenue and in-arena advertising. The plain fact is that pro sports and television are closely linked together in the modern era. Leagues and franchises would not exist without the extensive revenue stream provided by the sale of broadcast rights.

And, as the current situation makes clear, while the technology of television would continue without pro sports, television programming would be vastly different. Millions of viewers across America are learning what those programming differences consist of and they are not happy. The two entities — pro sports and television — are strongly dependent on each other.

The concept that games would actually be played without fans present is a strong indication of how close the relationship between pro sports and television really is. While it certainly is beneficial to have fans present — they enhance the atmosphere of the setting — they no longer are really necessary. What is very essential, however, is to keep the stream of revenue from broadcasting in all its forms — over-the-air, cable and digital — flowing. If that stream of funds ever decreases significantly, the foundation upon which the contemporary professional sports industry relies will crumble.

Leave it to the NFL — one of the best examples of how to get the most out of a broadcast dependent relationship — to do all it could to help fill a media programming void. Rather than postpone its draft, the league held it as scheduled. It employed the technology of computers and the internet, with everyone — including the top draft picks — remaining in their home areas rather than traveling to a central location for the big night.

But the very fact that the NFL held its draft as scheduled meant that it dominated the sports media for weeks prior to the draft.

Who would be selected, what round would they be selected and by which team would they

be selected, were the major themes that carried the hours of sports talk shows — on radio, television and the internet — for

It was, in essence, draft coverage by default. There literally was not anything else to cover in a sports world without baseball, basketball, hockey, golf or tennis.

The NFL Draft this year may have appeared unique in its use of "remote" settings but it really was engaging in what the NBA has been doing for some time now in a modified form.

Every June, the NBA Draft Central is located in New York City. But the powers that be are not there. They are back in the home cities of their respective franchises. Only the top league executives, the projected top draft picks and their family members are in New York — present there for national media coverage purposes.

The entire draft is actually conducted by computers and telephones, leaving the public announcement to be made in New York for the live audience in attendance and, of course, for television.

What the NFL did this year was dispense with the live audience and the gathering of top draft picks centered in one location. Other than that, it functioned as a typical NBA-style draft.

However, the draft we still like the best is the NHL draft. Every year, the coaches and top front office executives from the 31 teams, plus the projected top draft picks and members of their families, arrive at that year's host city.

Everything still has a personto-person feel to it. Executives from different franchises might take a "walk down the hall" for a private conversation and swing a trade. In this day and age, with so much reliance on technology, the traditional way of face-to-face conversation remains the best way. A scenario where one executive might say to another: "John, how about you and I taking a walk down the hall to get a cup of coffee" will never be superior to Skype, Facetime, or Zoom meetings. They all pale in comparison to the real thing.

In a novel we were reading recently, a person from a century ago wakes up in our time and wonders why so many people spend their days "staring into squares of light" rather than conversing with each other. We all might want to pause and consider how our society arrived at that point.

WHAT IS AMERICA COMING TO? — The delivery truck pulled up to a CVS pharmacy in Washington, D.C. recently. The driver began to unload his precious cargo. He did so under the watchful eyes of several armed guards who made sure all remained peaceful as the goods were brought inside. And just what was the commodity that led to the presence of this increased security? It was the delivery of a basic material toilet paper. Armed guards for toilet paper. Did you ever think you'd see the day?
