That Newspaper Photo From Birmingham in 1963

For some reason, I still remember vividly that photo taken in Birmingham, Alabama during a May 3, 1963 civil rights demonstration. It showed a 17-year-old protester getting attacked by a police dog held by a police officer. That photo appeared above the fold of the May 4, 1963 *New York Times*.

Birmingham had been on fire for weeks with daily demonstrations. Starting on May 1st, hundreds of Black kids marched to protest segregation and the city's Police Commissioner Bull Connor, ordered his police force to break things up with dogs and fire hoses.

That vile image made the TV newscasts that evening and on the morning of May 4, 1963, that photo ran nationwide in the nation's newspapers. I saved that photo and still have it today. It is aging and turning yellowish but the image remains as strong as ever regarding the conditions back on my birthday that year when I turned 15 years old. What was my worse thing that happened to me that day? Do I eat the ice cream first or the cake first? Up here in Boston, the TV screen was showing something that seemed to be happening in another country but it was right here in America. As a kid I wondered whatever happened to that 17-year-old boy getting mauled by a police dog.

I hold on to that fading newspaper photo just to remind myself of just how far we have come since then, but also to recognition we still have far to go. The hoses and dogs are gone, but injustice still flourishes for all of us. We are still trying to make America better than it was and we should never forget our past, our present, and our future as a united nation of people who have so much more that brings us together than what divides us up.



Cardinal O'Malley to Celebrate Mass at The St. Leonard's Church At Noon on Sunday, May 26th

Cardinal Sean O'Malley will celebrate Mass at St. Leonard of Port Maurice at noon on Sunday, May 26th. He will also bless new wood-carved statues of St. Francis of Assisi and St. Clare, as well as the newly re-constructed organ, which was part of the original restoration plan for the parish. Following the Mass, all are invited to attend when Cardinal O'Malley blesses the newly renovated St. Leonard's Church Hall and a Meet & Greet Reception.

St. Leonard Church, founded in 1873, is the first church in New England built by the Italian immigrants, which became the center of spiritual activity for the fast-growing Italian immigrant residents of the North End. Yet, as poor as these early immigrants were, they sacrificed a part of what little money they had for the construction of their church building.

When the church opened to the public in 1891, it already had an estimated 20,000 parishioners. With continued growth, construction began of the upper church to accommodate its many parishioners. The upper church construction project, in Romanesque revival architectural style, was dedicated on November 6, 1899.

From its earliest history, the interior of the church was created by the Italian immigrants who were craftsmen as well as parishioners. Spirituality, fraternity, and deep-rooted tradition continue, even to the present day, as the center of life at St. Leonard's Parish.

However, with the passage of time, the old building was in definite need of repair which prompted the present pastor, Fr. Antonio Nardoianni, O.F.M. to embark upon an ambitious and extensive multi-million-dollar renovation project. The restoration project took about a year to complete until the church was officially reopened

with a December 17th Mass celebrated by Cardinal O'Malley. As it turned out the restoration project was well received. The North End remembered more than a century of service by the humble Franciscans with an outpouring of financial support. This became exemplified with a \$1 million dollar gift from the St Joseph's Society of the North End, which met all final restoration costs. Beyond that, however, in an agreement with the pastor and the Archdiocese, the St. Joseph's Society went further and pledged to restore the church hall, which is now completed.

The newly renovated hall, originally St. Anthony's Hall, will now be available for a variety of community needs. Thanks to the special support from the St. Joseph's Society, it will also serve as the new home for many of the religious societies in the North End and can be utilized for special youth and resident activities.

The community is invited to participate in the May 26th Mass to witness Cardinal O'Malley's blessing of the church hall, as the parishioners turn a new page in the history of the parish and look to future ways of serving the people of the community.

LUCRETIUS

During previous issues, we examined the most prominent literati of the Early Age or Age of Greek Influence in Rome. This week, we enter the Golden Age, but must note that it is divided into two periods. The first is called *The Ciceronian Period* and the second is called *The Augustan Period*.

The Ciceronian Period honors Lucretius, the Roman poet who is said to be second only to Vergil. Lucretius is followed by Cicero, statesman, man of letters, orator, master of composition, and the most upright man in all of Roman history. Then came the famous historian named Sallust. The commentaries of Julius Caesar on the Gallic Wars are included as is Varro, the most learned of Roman scholars, and most prolific of all Roman authors.

The full name of today's celebrity is Carus Titus Lucretius, a Roman poet and philosopher who was born about 98 B.C. It is claimed that he was made insane from a love potion. He composed six books of poetry during some sane periods in his madness and finally committed



suicide. His work is entitled *De Rerum Natura (On the Nature of Things)*, an instructive type of poetry containing about 7,500 hexameter lines. It emphasizes the theories of Greek thinkers like Democritus and Epicurus, which deal with the origin of the world and the functions of natural forces. His desire was to free mankind from the fear of the gods and of death, which he believed to be the main cause of human grief.

His first book deals with the fundamental truths and that nothing can come from nothing. Book two deals with atoms and their combinations that produce sensation and feeling. The third book deals with the mind and soul and his attempt to prove that the soul dies at the same time as the body. Book four deals with the

extraordinary theory of sense perception — claiming that matter is continually rising from the surface of all objects. This rising matter strikes our senses and the immediate result is perception. The fifth book treats of the origin of life by spontaneous generation and the

preserva-tion of life in accordance with the law of the survival of the fittest. In his sixth book, he attempts to explain the natural phenomena (thunder, lightning, etc.) and magnetic power.

It is said that in his work, Lucretius succeeded in presenting the main features of the physics and psychology of Epicurus in a clear and concise manner. His *De Rerum Natura* is considered to be one of the finest poems ever written in the Latin language and is also regarded as the greatest didactic (instructional) poem of all literature. Just imagine what he could have done if he had both oars in the water.

The Story of Taps

This Memorial Day we remember and honor the men and women who died to preserve our freedom. Even as we enjoy kicking off summer however we chose this weekend, that is itself a testimony to their sacrifices, for we enjoy the cookouts, trips to the beach, and so forth because they made it possible. We especially honor those who died for our country when we decorate their graves or participant in patriotic parades and ceremonies this weekend.

At those solemn memorial events in our towns and cities, in our churches and synagogues, and in the halls of our veterans or other lodges, a familiar, haunting melody will mark the day —



The familiar bugle call "Taps" is generally believed to be based on a traditional French call to curfew (from Middle English "curfeu," from Old French "cuevrefeu," meaning cover the fire and turn in for the night).

According to the United States Department of Veterans Affairs the version of those 24 melancholy notes that we know from military funerals was crafted during America's Civil War by Union General Daniel Adams Butterfield, heading a brigade camped at Harrison Landing, Va., near Richmond. This music was made the official Army bugle call after the war, but not given the name "taps" until 1874.

Veterans Affair also states that: "The first time taps was played at a military funeral may also have been in Virginia soon after Butterfield composed it. Union Capt. John Tidball, head of an artillery battery, ordered it played for the burial of a cannoneer killed in action. Not wanting to reveal the battery's position in the woods to the enemy nearby, Tidball substituted taps for the traditional three rifle volleys fired over the grave. Taps was played at the funeral of Confederate Gen. Stonewall Jackson 10 months after it was composed. Army infantry regulations by 1891 required taps to be played at military funeral ceremonies."

Taps now is played by the military at burial and memorial services, to accompany the lowering of the flag, and to signal the "lights out" command at day's end.

Italian American Alliance

Opposes Bill to Eliminate Columbus Day in Massachusetts

FIRST READING

On early Monday evening, May 6th, the ALLIANCE was alerted that a First Hearing was being held the next day at 1 p.m. at the State House on a Bill introduced by Rep. Jack Patrick Lewis (of Ashland) that would replace Columbus Day with Indigenous Peoples Day.

With such short notice, the key leaders of Italian organizations scrambled fast. They conferred by phone to discuss appropriate strategy. The short notice created serious difficulties. They all had other appointments that were difficult to break with such short notice. There was even some thought about skipping the Hearing altogether and showing up strong in future Hearings on the Bill. However, it was finally decided that at least one person should attend. Well, since I was teaching a Tuesday morning college class to old soldiers at the New England Veterans Center and Shelter in Boston until noon - I volunteered to attend the Hearing and speak in opposition.

TUESDAY, MAY 7TH

The Hearing was called to order at 1:00 pm and literally hundreds of people assembled in Room 437 at the State House. They were there to support a variety of different bills. It was standing room only.

By 2:30 pm, about a hundred people or so were still there. They represented various Native American groups supporting the Bill to eliminate

Columbus Day and replacing it with Indigenous Peoples Day.

Their testimony went on for hours. One after another, they all said the same thing. They said that when they were young, they had heard wonderful things about Columbus -- but when they grew older they learned what a terrible person he was. It went on and on.

At 4:10, the committee Chairman called my name — "Dr. Francis Mazzaglia."

It was finally my turn.

After identifying myself as the Chairman of the Italian American Alliance, I told the Hearing Officers that I held a great respect for Native Americans and recounted how years ago, while serving as Executive Director of the Greater Brockton Anti-Poverty Agency, Self Help, Inc., that I was inducted into the Algonquin Indian Association by Chief Red Blanket and Medicine Man Little Turtle — I mentioned how they cut my finger and shared blood in the presence of other Indians attending the ceremony – and how I had marched with Indians in Plymouth for several years to protest injustices to the Indian people.

I assured them that Italian Americans were their friends BUT their testimonies all said the same thing. They heard one version of Columbus early in life and a more brutal version of Columbus in later life.

I then asked them if maybejust maybe — the first version was the REAL version rather than the later ramblings of Communist Howard Zinn and the revisionist historians who followed him using links that were clearly labeled "myths, fables, and legends."

I also objected to the charge of genocide. I told them that genocide was the systematic, intentional, and deliberate attempt to murder another group of people. I told them that the clash of microbes may have been a terrible and unintended consequence which caused a plague BUT that it was not the same thing as genocide.

I told them that Columbus never owned a slave and that as governor; he was subject to the decisions of Ferdinand and Isabella of Spain.

Columbus was not a perfect man. None of us are. He was a man of his time.

But it was Columbus who introduced the Old World to the New World.

Where would we be without Columbus?

Eliminate Columbus Day? I raised my hand in a fist, raised my voice, and said: OVER OUR DEAD BODIES!


In concluding my testimony in opposition, I then assured the Hearing Officers that many other good Italian Americans would be present at future hearings on the Bill.

On the way out, I was met by several Native Americans who shook my hand as I left.

I did the best I could.

Hope you approve.

Around this time of year, I feel a sense of energy bubbling up inside me. All of the cabin fever and restless excitement over a new spring evaporates into the warm air, a surge of joy and release as refreshing as an afternoon rain shower. As the temperatures hit ever higher degrees, I can practically smell the summer in the air, the promise of barbecues and ocean waves and ice-cold glasses of lemonade. When class is dismissed at the school where I teach and students run out into the luminous day, their unbridled happiness is contagious as they scamper across the bright green, sun-soaked grass. Indeed, the month of May as a whole calls for outdoor excursions. Traditionally the beginning of summer, May heralds warmer temperatures and an explosion of tender leaves on trees. It is definitely not a month to stay cooped up indoors, but rather one to venture outside and revel in all the delights nature has to offer. In Italy, one of the most beloved traditions is called la passeggiata, or evening stroll. After dinner, Italian families and friends meander through city streets or rural lanes, enjoying the outdoor experience and each other's company. In urban areas, the passeggiata may involve stopping for some delicious, creamy gelato, casual window shopping, or sitting and chatting along the rim of one of Italy's many beautiful fountains. People in the countryside may rest in the shade of trees, pick fruit, or pack a small picnic of sweets and wine. In an age where too many people right after dinner, I love the idea of a tradition that encourages people to step outside and partake in the universal and time-honored pleasures of fresh air, loved ones and the nourishment of food and drink. I fondly remember my evening passeggiate from when I visited Italy several years ago: the walks through bustling city centers, where the late-day sun turned ancient ruins to the color of gold, and the hikes along dirt roads in my dad's home region of Abruzzi, watching the dusky sky darken the mountains. My husband loves to go outside and walk, so often I will try to recreate a passeggiata here at home. As I walk around my neighborhood in this balmy month of May, I pay special attention to the life all around me: jubilant children kicking a soccer ball, robins hopping among blades of grass, the sun peeking through branches laden with delicate pink flowers.

May brims with a number of special holidays that encourage such outdoor excursions. The month begins with May Day, an ancient holiday celebrating the start of summer. It is also a "holiday" honoring flowers and trees, which are their most beautiful now. Mother's Day, which occurred on the 12th of the month, not only allows us to express gratitude for the wonderful things mothers do for us but also prompts us to enjoy their company. On Mother's Day, my family and I often go out for ice cream, an activity all the more special because of its simplicity and its unencumbered focus on loved ones, food, and the warm sun. Soon, it will be Memorial Day, and countless families will fire up the grill and eat summer produce outdoors. Others will flock to the beach or the mounare tempted to watch television tains — any outdoor place will do, as Memorial Day weekend is considered the unofficial start of summer! Later, however, May hosts another summer holiday, Ascension Day, known as la Festa dell'Ascensione in Italian. Falling forty days after Easter, this holiday commemorates Jesus' ascent into Heaven. Italians celebrate it with outdoor excursions and picnics, as typical for the holidays of May. Another moveable feast known as la Pasqua Rossa, or Pentecost, falls fifty days after Easter and honors the descent of the Holy Spirit upon Jesus's disciples. Italian churches often scatter rose petals during the services to symbolize the Holy Spirit, incorporating a lovely outdoor symbol of summer.

This month, be sure to spend an abundant amount of time enjoying nature. The warm days, the sunlight that lasts into the late hours of the evening, the succulent fruits of summer - these are all the pleasures Mother Earth has to offer this time of the year. It is also important to remember that what makes these delights so special is the fact that they are fleeting, since the year is a cycle always in motion, so relish May while you can! Whether you choose to take a passeggiata in the golden hours of dusk, or whether you opt for a picnic on Memorial Day weekend, or whether you simply agree to meet a friend for ice cream or a quick bike ride, strive to appreciate all that nature has to offer. May will come to a close before we know it, but her beautiful experiences are available right now, ready for our fulfillment.

Saint Albert of Trapani

by Bennett Molinari and Richard Molinari

The exact date of Albert's birth is uncertain but it is believed to be around the year 1240. He was the sole child to the nobles Benedetto degli Abati and Giovanna Palizi who lived in Trapani, Sicily. His father served as an admiral in the fleet of Frederick II of Hohensautfen. His parents - who married in 1214 - were childless, and promised that if blessed to have a son, he would be consecrated to Our Lady of Mount Carmel.

In his childhood, his father had thought of arranging a marriage for him but his mother was able to remind her husband to adhere to the vow the couple made that he be consecrated to the Lord.

He received his education from the Carmelites and in 1258 joined the order. Before his ordination in Trapani and his transfer to the order's house at Messina, he served as a mendicant preacher, tending to the needs of the poor. He served from 1280 until 1287 as the provincial for Trapani and as the provincial for Messina from 1287 until 1296 when he was named as the provincial.

In 1301, the city of Messina, Italy was under siege and blockade by Duke Robert of Calabria, Italy. Disease ridden and facing imminent starvation, Albert

and the monastery were asked to pray for intervention. Albert celebrated Mass, offering it as a plea for God's deliverance. As he finished, three ships loaded with grain ran the blockade. The city was saved from starvation, and Robert lifted the siege. Albert was so well remembered for this intervention that a city gate was dedicated in his honor over 300 years later.

Albert passed away on August 7, 1307 at the age of 67. He was Canonized on May 31, 1476 by Pope Sixtus IV. The Feast Day of Saint Albert of Trapani is August 7.



PACIFIC OVERTURES

Is Worthy of a Shogun

Review Pacific Overtures

Music and Lyrics by Stephen Sondheim ~ Book by John Weidman ~ Directed by Spiro Veloudos Lyric Stage, Boston ~ Now through June 16th

Pacific Overtures deals with the opening of Japan to the West and Commodore Perry's excursion there in 1853. The Japanese had isolated themselves from the rest of the world for many years earlier. They had decreed that no foreigners would ever again be allowed to step on their soil. They saw outsiders as barbarians and savages, as people who would destroy their culture and exploit their products. It has a familiar ring to it: Gunboat Diplomacy, isolationism, xenophobia, expansionism, and a fear of change are subjects touched upon.

It was first produced in 1976 at a time when the Vietnam War was very fresh in people's memories, so it would have been natural for people to have focused on American forays into other nations at that time. Given the state of the nation today, where trade wars and isolationism are popular, and a fear of those who are different is in ascendance on both the Left and the Right of the political spectrum, it is very possible audiences will see another message in this very fine work.

I last saw *Pacific Overtures* in 2003 in a lavish production that was incredible. From my count, the original consisted of a cast of 36. The Lyric is working with just 11, with actors taking on multiple roles. Of course, the theatre in Copley Square is also quite small, and the orchestra is much reduced. So how does taking such a huge production and reducing it in size work out? In a word, magnificently!

Director Spiro Veloudos, working with Musical Director Jonathan Goldberg and four additional orchestra members take Sondheim's score and work wonders with it. The music which plays off many Japanese styles includes Haiku, as well as nods to Gilbert and Sullivan. and a multinational flavor that, while showing how different nations can be, also captures the fact that all countries benefit when they cooperate with one another. Unfortunately, historically this cooperation has not always gone smoothly, and that is also brought out clearly here.

The set is simple yet gorgeous. Designed by Janie E. Howland, it has a backdrop made up of four Japanese screen panels with Hiroshige style illustrations on them. They are rotated

very subtly during the play depicting different scenes as the story moves along. The floor gives the appearance of Tanami mats, an item that will serve an important purpose in the negotiations between the Americans and the Japanese. Branches from a cherry blossom tree hang from above. I have read that Someone In A Tree is Stephen Sondheim's favorite song from his own work, and seeing it performed by Brandon Milardo and Karina Wen under the branches is just lovely.

The cast is led by Lisa Yuen as the Reciter and Shogun. From the opening number *The Adventures of Floating in the Middle of the Sea*; Ms Yuen keeps the narrative flowing without forcing it. Her voice is clear and warm.

Carl Hsu and Sam Hamashima play Kayama and Manjiro. Kayama is a low ranking Samurai who ends up as the leading negotiator with the American's, a job he was not exactly thrilled to be appointed to. Manjiro is a fisherman who had lived in the United States after being rescued by American sailors. He has returned to Japan to warn his leaders of the approaching Americans. He is not received well. Kayama and Manjiro form a bond when they find they can help each other through their problems.

In *Poems* the two exchange multiple haiku. It is fast paced and through it we see their friendship grow. I loved how Hsu and Hamashima moved about the stage while performing this number. Choreographer Micheline Wu deserves much credit for the fine work she has done.

The entire cast, playing multiple roles, did not disappoint. Gary Thomas Ng plays the Madam leading her Geisha Girls in *Welcome to Kanagawa*. With twirling umbrellas and flirtatious glances the number was fun and beautiful.

In *Please Hello*, representatives from the United States, France, Holland, Great Britain,

and Russia all besiege Lord Abe (Jeff Song) with trade agreements. The play on Gilbert and Sullivan's *Modern Major General* is delightful along with some French Can-Can, Dutch clog shoe dancing, and the frequent admonition from the Russian representative to "Don't touch the coat!"

Spiro Veloudos has chosen to have the actors wear masks when playing non Japanese parts. The masks are somewhat grotesque and reminiscent of the caricatures of foreigners that have been used over the years in many countries. These caricaturization represent how the Japanese saw outsiders.

It is also interesting that many of the American parts were spoken with Southern accents. It is funny, but I notice that many directors in this area do that when trying to show Americans in a negative light. I wonder if directors in the South have their actors use Boston accents to get the same effect.

Pacific Overtures may very well have Sondheim's best score. It is certainly the one that will continue playing in your head when you leave the theater. I loved every song and will be listening to the sound track often.

One of the beautiful things about theater is it can be fun at the same time it is dealing with serious and difficult subjects. We live in very polarizing times and have for many years. Too often when trying to make a point, a playwright can leave the audience feeling further divided. I found much in *Pacific* Overtures to give us reason to strive to understand each other and find ways to exchange the best we all have to offer. Tearing down walls and barriers to the free exchange of ideas and goods is a positive thing, though it is difficult to accomplish. I think of the words of Frederic Bastiat "If goods aren't allowed to cross borders, armies will."

This is the final production of the Lyric's 2018-2019 season, and they are finishing on a high note (pun intended). Pacific Overtures should top your list of plays to see. You are making a huge mistake if you miss this one. Spiro Veloudos works magic when he brings these large productions down in size for the intimate confines of the Lyric Stage Theater. After attending a number of these scaled down versions, I could argue this is a better way to see them. Well, it certainly is when produced by the Lyric Stage.

PEE-WEE'S BIG ADVENTURE (Vinyl)

The beloved score to the classic 80's film is back after a limited release last year. Pressed on red vinyl the LP includes both the score to Pee-wee's Big Adventure on side A, and is accompanied by a bonus program of Danny Elfman's score to Back to School on side B. This adventure began in 1985, when Tim Burton and Paul Reubens invited Elfman to write the score for their first feature film, Pee-wee's Big Adventure. This is Elfman's first score for film, kicking off his awardwinning career. For Pee-wee's Big Adventure he turned to Oingo Boingo guitarist and arranger Steve Bartek for orchestration assistance. With this iconic score Elfman achieved his goal of emulating the mood of such composers as Nino Rota and Bernard Hermann. Elfman was the lead singer and songwriter for Oingo Boingo (1974-1995) before a career change that has made him a legendary American composer, singer, songwriter, and record producer. Cuts on Side A shine via, "Overture (The Big Race)," the tasty "Breakfast Machine." thumbs up for "Hitchhike," the pretty "Simone's Theme," the scary "Clown Dream," the hectic "The Drive-in," and the mysterious "Finale." Excitement from Back to School has tracks, "Do Not Go Gently," "The Brawl," "Action Medley," the romantic "Love Suite," and finishes up with the rousing "Study Montage."

BILL EVANS – EVANS IN ENGLAND (2-CD)

Resonance Records A new Bill Evans discovery is always cause for excitement. In this case Evans in England is the gem; previously unreleased 1969 recordings have piano master Evans, recorded at Eddie Gomez and Marty Morell at Ronnie Scott's Jazz Club in London. Fans new and old can revel in 18 performances included in the two-CD set. Among those is a pair of Evans' cuts, from his brief stint (1988) trio with Gomez and drummer Jack DeJohnette. Plus 2016's lost studio sides, "Some Other Time," and 2017's Dutch radio recordings "Another Time," which was named 'one of the year's top historical released by Downbeat, JazzTimes, Jazzwise, and the NPR Music Jazz Critics Poll. Playing together for almost seven years, Evans, Gomez, and Morell delivered timeless compositions as "Waltz for Debby," "Turn Out the Stars," "Very Early," and "Re: Person I Knew"; extroverted readings of Miles Davis' "So What" (which Evans originated with the trumpeter sextet on the 1959 classic Kind of Blue) and Thelonious Monk's "'Round Midnight"; and Evans' earliest recordings of "Sugar Plum" and "The Two Lonely People."

ANN SWEETEN – BEFORE TODAY, BEYOND TOMORROW (CD) Orange Band Records

A Nostalgic Remembrance



It was 1961, and I was teaching at Hyde Park High School. In an attempt to earn a master's degree, I began taking graduate courses at my alma mater, Boston State. Since my sophomore year at Boston State (now U-Mass, Boston), I was playing music with any bandleader that called. For the most part, the major portion of the playing I did was with the Ken Reeves Orchestra. The leader, a man who opposed my first job with the unit he was playing with or leading, now requested my services each week. His name was Don Ellis, a tenor sax player who had memorized thousands of songs and could play a dance, wedding, or any kind of a reception without a piece of music in front of him.

During my second summer with the Reeves office, Don Ellis, pianist Hank Gilsdorf, drummer Al Priest and I played weekends at the Chatham Bars Inn in Chatham, MA. Ellis put me in as one of the drivers with the stipulation that I pick him up and drop him off. I lived in East Boston at the time and he in Arlington. Each Friday afternoon, I would be ready to head to the Cape after picking Don up and we would wend our way through the Friday afternoon traffic heading south. Because Don led bands for the Reeves office and Ken Reeves catered to old Boston society, Don used Ellis as a professional name. I didn't know that his real last name was Alessi until I saw his driver's license one day. When I questioned him about it, he admitted he was Italian, "I'm not only Italian, I'm Sicilian. Reeves wants all of his leaders to have Anglo sounding names so, I use Ellis."

Playing for the folks who vacationed at the Chatham Bars Inn was easy. The management put us up, fed us in the main dining room from the guest menu and allowed us to drink on the house. I didn't drink, but a couple of the other musicians made up for it. Although they were never drunk, they played Gershwin or Cole Porter tunes with a glow that only 80 proof could cause. What I also enjoyed was my share of the tips. There was a large brandy snifter located on the piano and Hank the pianist would always we began to play. When someone would approach us with a request, a tip was often given to us, and as we were packing up for the night, Don Ellis would count out the money and divide it four ways. For most of the guests at the resort, money was not a

came to a close and we played our last weekend around Labor Day. When I dropped Don Ellis off, he said he would be calling. This seemed strange, as I usually received my assignments via phone calls from the booker at the Reeves office or via a weekly postcard which listed the jobs, locations and time frames.

Each time I returned home, I had to have a glass of wine with Babbononno who lived the life of a musician vicariously through his grandson. He had long since stopped playing but wanted to remain part of the business through the stories of his sons, Uncle Paul and Uncle Nick, his son-in-law my father, and me.

Later in that Labor Day week, I received a call from Don Ellis asking me if I could drop by his house during the week. When I was able to sit with him over coffee and cake, he told me that he was leaving the Reeves office after decades of leading bands for Ken Reeves. He had made contact with the owner of Carroll's Restaurant in Medford. They were setting up the down stairs area of the restaurant as a function room and Don was going to be their musical director for events booked in that room. Don would be taking pianist Hank Gilsdorf with him but no one else from the Reeves office was interested. He hired drummer Rene Jacques, and if I wanted to join them as the bassist, this would be the nucleus of the band that would play all of the functions held downstairs at Carroll's. On many occasions, the band would include trumpets, trombones and or other sax players. Don had music stands made up for the stage and always had music for the tunes we played but he never needed the music himself. Everything we played was memorized.

I stayed with the band for about a year or so. The only nights that I couldn't work were the nights I was taking my graduate courses. I tried to take courses that were offered in the afternoons or during the evenings of the early part of the week. This allowed me to be able to play about five nights per week and both Saturday and Sunday afternoons. As a result, I was put a couple of dollars in it before making more money as a musician than as a fledgling teacher. Once I finished my courses, I began to think about expanding my horizons musically. As a result, I began making connections in New York hoping to break into the jazz circles there. At the same time, I got hooked problem and we did rather well up with a comedian I had known satisfying their musical requests. at Boston State, Bob Blasser. He Well, that first summer season was doing comedy shows locally

and was also trying to make some headway in New York.

Bob, an ex seminarian, was friendly with Cardinal Cushing and each time a Catholic serviceman was killed in Vietnam from the local area, the Cardinal would put a show together as a fundraiser for the soldier's family. We were the show. I was asked by Bob's music director to join the band last minute and when Bob and I saw each other, it was the renewal of a friendship started back at Boston State. Within a year, the music director and Bob had a falling out and he quit. I was asked to take over and became the music director of the Bob Blasser Show. Later, as we became involved in the New York scene, we became partners in the production end of things.

On my own, I began working with some of the jazz musicians in New York. It didn't hurt that I was Johnny Christy Jr., or that I was Nick Conti's nephew. Both Dad and Uncle Nick had reputations that were held in high esteem both here and in the Big Apple. This opened the doors in New York, but from that point on, I had to prove myself, and hopefully, I did.

With Bob Blasser, playing the shows for Cardinal Cushing, it led to him making inroads for us in New York. We did shows there and as writers and actors, became involved with Candid Camera. Babbononno thought I was crazy, but when I told him what the money was like he backed off. Alan Funt, the head guy for Candid Camera, set us up with writing and performing in a commercial for Alka Seltzer. This led to an interview with Otto Preminger who opened a few doors for us in Hollywood. But, I'm out of space and that's a story for another day.

Swordfish Alla Messinese Swordfish Messina Style in Tomato Sauce

- 1 swordfish steak (about 11/4 pounds)
- 1 medium onion chopped
- 2 celery stalks chopped 3 teaspoons capers in vinegar and water
- 3 fresh ripe tomatoes chopped or 10 ounces crushed tomato
- 2 sprigs bay leaf
- 3 small potatoes cut in auarters
- 1/4 cup olive, canola or
- vegetable oil 1 cup water
- 2 tablespoons white wine

(optional)

Heat oil in a skillet and add chopped onion, chopped celery stalks and simmer until onion is opaque. Add capers, stir, and simmer slowly. Do not brown onion. Add tomato and cover. Cook slowly for about five minutes. Check frequently. A little water can be added to keep mixture from sticking to skillet.

Meanwhile, peel and cut potatoes into quarters. Wash and set aside. Rinse swordfish under running water and dry. Cut swordfish into two-inch portions. It is not necessary to remove outer skin of swordfish. Add potatoes first to skillet; add half a cup of water and cover. Allow cooking for about ten minutes. Then add swordfish pieces to skillet. The swordfish can be placed on top of potatoes if skillet becomes crowded. Spoon some of the tomato sauce over the swordfish. Add only small amounts of water if needed after a few minutes. Cover and simmer slowly for about ten to fifteen minutes or until swordfish is fork tender. Try not to overcook swordfish. Add wine (optional), cover and bring to a slow boil. Then remove from burner.

Serve with fresh Italian bread, vegetable of choice or salad.

Variation: Prepare the swordfish recipe without potatoes. Instead, cook rice or pasta of choice as directed on the package and serve topped with the tomato sauce from the skillet. Serve the swordfish separately with vegetable of choice or salad and Italian bread.

NOTE: Each time I prepare this swordfish meal, I picture my mother-in-law, Mary Sinopoli, at the kitchen stove in our Battery Street apartment. As she carefully prepared the ingredients, she stated, "Swordfish should not be cooked too much as it becomes dry and loses its flavor." I found that to be very true.

GEORGE FOREMAN

Not an All Time Great

Weak Opposition and Fatal Flaw Keeps Him from Elite Status

Big George Foreman is remembered as a powerful man and a devastating puncher. His brutal destruction of Joe Frazier in 1973 is etched in every fight fan's memory. It is mainly off of this performance that Foreman made it onto many people's lists of all time greats. That January night in Jamaica he looked fearsome. In taking Frazier apart so one

sidedly, he took on an almost superhuman status. But on closer examination of his record and boxing technique, the all time great designation doesn't hold up.

Going into the title fight with Frazier, Foreman had an impressive undefeated record of 37 and 0. Only three opponents had gone the distance with him. Yet, even with those impressive numbers, Frazier was made a $3\frac{1}{2}$ -to-1 favorite to retain the title. Frazier was also undefeated at the time and had defeated Muhammad Ali in the Fight of the Century less than two years earlier.

While Foreman's record looks good on paper, when taking a closer look at his opposition, the numbers give a clearer picture of why he was the underdog. Out of those 37 opponents there were very few that could be considered serious competition. In fact, in his last bout before facing Frazier, Foreman fought Terry Sorrell, who at the time had had a total of 19 fights winning only 4. Sorrell would

close out his career with a record of 29 fights with only 6 wins (3 by KO), 22 losses (10 by KO), and 1 draw.

Some might argue this was just a warm-up bout for Foreman before stepping in with the Champ. Well, a warm-up bout usually involves having a warm body for opposition. I'm not sure it was ever verified Sorrell had a pulse when he stepped into the ring.

Three fights earlier **Young dec** Foreman had faced the immortal Clarence Boone. Boone had a record of 30 fights, winning only 3 with 26 losses and 2 draws. Of those 26 losses he had been stopped 14 times. I think the promoters used the same undertaker that provided Terry Sorrell for Foreman.


Go back one more fight and you will see where an opponent was dug up who made Boone and Sorrell look like Louis and Dempsey. On January 29, 1972, Foreman faced the immortal Joe Murphy Gordwin of Houston, Texas. This would be the final fight of Gordwin's career and he would bring his remarkable record of 1 win, 1 draw, and an astounding 15 losses (13 by KO) into the ring with him that night. Forman surely had to be terrified; terrified he might kill Joe Murphy.

Go back a little further in Foreman's career and you will find such immortals as Vic Scott (1 win 2 losses), Bob Hazelton (3 wins, 6 losses), Leo Peterson (3 wins, 4 losses), and Fred Askew (2 wins, 6 losses, 1 draw).

Of course, when a young fighter is being brought along, it is not unusual for him to be given "opponents" to face. But usually those "opponents" are fighters who, while not posing much of a threat, do have beating hearts and the ability to provide some opposition so the prospect will have a chance to learn his trade and improve.

Looking back at the rest of Foreman's opposition in those 37 fights, you will not find a lot of strong opposition. While many are better than those I have just mentioned most aren't too far ahead of the Boones and Sorrells.

Foreman did face a few solid "opponents" during those years. Levi Forte (20 wins, 21 losses 12 by KO, and 2 draws) and Roberto Davila (21 wins, 14losses 3 by KO) both were the type of boxer an up and coming prospect would be expected to face, and both extended Foreman the full ten round limit.

The most notable names on Foreman's record at the time were Boone Kirkman, Gregorio Peralta (twice), and George Chuvalo. His wins over Kirkman and Chuvalo were impressive, he struggled with Peralta.

Kirkman was another up and comer who had faced a series of "opponents" and had not been tested. Foreman simply overpowered him.


Chuvalo was known as incredibly tough. He had never been knocked off his feet, and a number of years earlier had given Muhammad Ali a tough go of it. But with the exception of a very odd win over Jerry Quarry, the Canadian never beat a top rated contender. His slow moving style made him an easy target for Foreman's heavy but wide swings. Big George did look impressive in stopping Chuvalo.

I have written about Foreman's fights with Peralta. Forman won their first fight by decision, and stopped Peralta in their rematch. In both fights, Foreman's flaws were exposed. It was these flaws Ali exploit a few later to regain the crown.

Looking at the accumulated record of Foreman's opposition at the time of the Frazier fight you see that combined they had a total of 289 wins, 376 losses, and 58 draws. if you remove the three fighters who had a pulse from that group, Peralta, Chuvalo, and

Kirkman you end up with a group that had a total of only 100 wins with 355 losses, and 48 draws.

After defeating Frazier, Foreman defended the title twice in impressive fashion knocking out Joe Roman in one round and Ken Norton in two. Roman would have been considered an opponent if he had fought Foreman earlier, and was far from having an impressive record. Norton



After those two defenses Foreman lost the title to Ali who used many of the tactics the over the hill Peralta had employed a few years earlier. After the loss to Ali, Forman still did not score any major wins with the exception of his victory in a slugfest with Ron Lyle, which was a battle of attrition, not skill.

He closed out his career with a loss to the light punching Jimmy Young, who also used technique to neutralize Foreman's power. Without that power Foreman had no boxing skill to fall back on to win a fight.

His major flaw was extending his arms when trying to parry punches. If you watch him in action, it appears he is trying to emulate Jack Johnson's strategy of catching punches with an open glove. Only with Johnson, he would grab the punch just before it was about to land on him. With Foreman, he would reach out and try to stop it just as it was being thrown. As a fight moved along he would begin pawing with both his hands and leave himself open. Ali, Young, Peralta, and Lyle were all able to land on him because of this fatal flaw. Any one off the great and even not so great heavyweights of the past would have spotted this flaw and taken advantage of it.

Foreman certainly had amazing raw power, but that only takes a fighter so far. He did not develop the skills to make him a great fighter. Sure, he would always have a puncher's chance against anyone. But hoping for a lucky punch is not the stuff of greatness. Foreman simply never showed the skills to be considered an all-time great heavyweight champion.

I have not discussed Foreman's second career because it really is not relative to this discussion. Foreman 1.0 was the prime Foreman and the one to look at when judging him as an all time great.

It began with hope, as do many beginnings. A feeling that things would be even better. And what was not to hope for. With Gordon Hayward returning from his year of recuperation, with the addition of Kyrie Irving combined with the exciting young players who had played so magnificently in that inspirational spring of 2018, why shouldn't there be the sensation of expectation throughout Celtics Nation.

But the smooth road became a bumpy one, the season more challenging than had been expected. And there were times when the Celtics played like a collection of individual all-stars rather than an all-star team. So many nights Coach Brad Stevens would state in his postgame press conference that "we still have to find out who we really are."

A statement from Terry Rozier seems to shed light on the matter. In an interview with *masslive.com* a few days after the Celtics were eliminated from the playoffs, he was asked to address "why the on-court product didn't work as well as expected."

His answer gave a brief insight into the situation. "We would have our first five, then our second five. Then when we would go out there, I feel a lot of guys would be mixed up. It wouldn't be the first five or the second five. What we talked about in practice was not what we went through in a game. It was like we're going to keep Kyrie out there and we're going to put other guys out there with him and we're going to figure it out."

Unfortunately, for Celtics Nation, the day when they figured it out really never seemed to arrive. The year that was to be did not extend to its full length. It ended in Milwaukee on a night in early May when those in New England were still looking forward to a spring that had not quite yet arrived. It was somewhat similar to the basketball team that had left the station carrying their hopes and dreams on that bright autumnal day several months ago, but had never arrived at its destination, a train carrying a group of players still trying to figure out who they really were.

AS THE BRUINS MARCH
ON — Unless there is a total collapse, the B's will be playing in their third Stanley Cup Final in this decade.

The first came in 2011, when the B's faced the Vancouver Canucks in a cross continent series that went the full seven

It was the year of Bruins goaltender Tim Thomas who captured the Conn Smythe trophy as the Most Valuable Player in the playoffs. Thomas allowed only eight goals to get past him in the entire seven game series. That is still the lowest number of goals allowed in a seven-game Stanley Cup Final. It also would have been the lowest if the series had gone only six games.

And yet ... despite all that, Vancouver did manage to win three games and force a game 7 on the west coast of Canada, making for a lot of travel.

The Bruins made the long flight to Vancouver for games 1 and 2 plus games 5 and 7. In reality, it seemed like two different series. When the B's played at the Garden, they were

a scoring machine, averaging just under six goals per game. On the road in Vancouver, that averaged tailed off to 1.5 per contest.

But in the historic game 7, the first Stanley Cup Final game 7 in the history of the Boston franchise, both Thomas and veterans Patrice Bergeron and Brad Marchand came up huge.

Thomas made 37 saves on the way to a 4-0 shutout victory while Bergeron and Marchand each tallied two goals. The game was also the last in Mark Recchi's 22-year career. Sadly, while there was euphoria in the Hub, there was destruction in Vancouver as a huge frustration riot broke out following the game with cars set on fire and shops looted in the downtown area.

Unfortunately, for many residents of Vancouver this seemed like a repeat of the riots that had taken place in 1994 after the Canucks lost to the Rangers in the Stanley Cup Final.

What we remember most about the day of the Bruins parade occurred on the train to Boston. It was a Saturday, so the one that stopped at the station on the North Shore was packed since there were fewer trains on the weekend. In fact, after we were allowed to board, we were asked by the conductor to stand in an enclosed area between the cars.

While that was tight, imagine our surprise when we were told by the conductor that the real reason the packed to overflowing train stopped was because it had been discovered that some people who could not get inside were riding on the outside of the train, clinging to an area between the engine and the first car — and had to be ordered off.


The 2013 Stanley Cup Final made history of its own in a way. It was the first one to feature two Original Six teams (Boston and Chicago) since 1979. This had been the season of a lockout, meaning the Stanley Cup Final had a delayed start — not getting under way until June 12th and stretching all the way to June 24th.

It was the spring where Jaromir Jagr became a Bruin for the Cup run, having been acquired on April 2nd from the Dallas Stars. It was the spring where Tuukka Rask was the starting goalie. It was also the spring where the Bruins lifted the spirits of an entire city following the tragic Marathon bombing that had occurred later in April.

The Cup would be won at the Garden — but not by the team that calls it home. The series was tight — it was the first Stanley Cup Final to feature three overtime games — but in the end the Blackhawks, who had finished atop the league standings, snatched victory from defeat in the closing moments of game 6.

That's because the Bruins, fighting to force a game 7, led 2-1 late in the third period before Chicago scored two goals, one to tie the game at 2-2 with 76 seconds left followed by the game winner with just 17 seconds remaining.

So, it been six years since the Bruins participated in the Stanley Cup Final and eight years since they won it. Let's see what happens when either San Jose or St. Louis comes to the Hub this time around.
