



GETTING CLIPPED IN OLD ROME



A barber may be defined as a person who engages in the occupation of cutting and dressing hair, and shaving or trimming beards. The name barber is derived from the Latin "barba," meaning beard. The occupation goes back in antiquity to at least 600 B.C. The Old Testament mentions Ezekiel, who used a razor to cut off his hair and scatter it to the winds. It was not the cutting of the hair, but the use of a razor that indicated a form of barbering that possibly

Our barbers of today are often referred to as tonsorial artists. The Latin words "tonsor" or "tonsoris" refer to barber or shearer. "Tonstrix" is a female barber or hairdresser and "tonstrina" is the barbershop. Barbering was first practiced in Rome about 300 to 250 B.C. The Roman tonsor cut and dressed the hair,

trimmed beards, cut fingernails, and tweezed unwanted hair that wasn't cut or was in places that couldn't be cut.

The real Roman dandy actually entrusted the trimming of the beard and style of the hair to his tonsor. There was a period in Roman history when the barber was almost a tyrant. The hair was cut and styled his way or not at all. The wealthy families were able to afford the services of a tonsor as part of their household staff and were attended once or twice in the course of a day. The majority, who were not able to afford the luxury of a private barber, were forced to patronize one of the many tonstrina in the city.

There were also those barbers for the poorer classes, who placed their barber chairs or stools out on the sidewalk each morning and did their clipping in the open. From its very beginning the tonstrina became a club, information center, gossip shop, and a rendezvous for a job interviews by employers. The popularity of the barbershop was a barometer of their income, and most barbers became very wealthy.

The usual tonstrina had benches for the waiting customers and mirrors on the walls. The victim of the moment sat on a stool in the center of the shop. His clothing was protected by one of many kinds of coverings, like a towel or "sudarium," or a front cover "involucrum" made of linen or fine cotton. His majesty, the tonsor, would perform the actual grooming or shaving while one or two of his assistants would stand around and pass the various "tools of the trade."

National attitudes toward hairdressing were much the same as today. There were those who preferred to mass their hair artistically like Nero, or those who never permitted more than a few brief moments to hair grooming like Augustus. Haircuts were performed with iron scissors that never knew a common pivot and, of course, this made steps inevitable and a comb very desirable. Curling and dyeing the hair was also common practice during those times. Thank goodness that the men of today do not indulge themselves in such vanity.

Korean War to End

The Korean War began on 25 June 1950 when North Korea invaded South Korea. The fighting ended on 27 July 1953, when an armistice was signed. The agreement created the Korean Demilitarized Zone to separate North and South Korea, allowing the return of prisoners. However, no peace treaty has been signed. Now the leaders of the North and South have met and it appears, as President Trump tweeted on April 27th, "KOREAN WAR TO

Tens of thousands of Americans died in the Korean War. In the 1994 version of its annual publication, Service and Casualties in Major Wars and Conflicts, the Pentagon put Korean War battle deaths at 33,652 and "other deaths" meaning deaths in the war zone from illness, accidents, and other non-battle causes at 3,262. That yields a total of 36,914.

We are just a week away from the long Memorial Day Weekend, when we reflect upon and honor the women and men who died in the service of our nation. I'll focus on one, an Italian-American son of Massachusetts.

Corporal Joseph Vittori (August 1, 1929 — September 16, 1951) was a 22-year-old United States Marine who was killed in action during the Korean War. This son of Italian immigrants (Pietro "Peter" Vittori, born in Rome, in 1897, and Dora E Moca, born Raiano, Abruzzo, Italy, in 1907) was born in Beverly and worked on his parent's farm there until he enlisted in the Marines in 1946.

After serving three years in the Marine Corps he returned home, joined the Marine Corps Reserve and worked various jobs around his home town. His unit was called to active duty to participate in the Korean War and after attending some training they were sent to Korea.

He was killed during the Battle of the Punchbowl while defending against an assault on Hill 749 near Songnea-dong, Korea on the night of September 15-16, 1951. He was fatally wounded while fighting off an enemy breakthrough at a gap in his battalion's lines. He was the 19th Marine to earn the nation's highest decoration for heroism in Korea. For his actions he posthumously received the Medal of Honor.

The Medal of Honor was presented to his parents on September 7, 1952. He is buried, along with his parents, at Saint Mary's Cemetery, Beverly.

Saint Mary Euphrasia Pelletier

Saint Mary Euphrasia was born Rose Virginia Pelletier on the island of Noirmoutier, off the coast of France in 1796. Her parents had been exiled by the French Revolutionaries. Her father died when she was ten years old. In 1810, her mother placed Rose Virginia in a boarding school in Tours. Her mother died in 1813. While in Tours. Rose heard of the Convent of the Refuge. This belonged to a religious congregation founded in 1641 by St. John Eudes for the rescue of destitute women and the protection of those in difficulty and danger. It was known as the Institute of Our Lady of Charity of the Refuge, and it had



a house in Tours. Rose entered the Convent in 1814, and some eleven years later, when she was still only twenty-nine, was

appealed to Rome for approval to establish a new religious congregation that would be under one general government. She was given permission to found the congregation of the Sisters of Our Lady of Charity of the Good Shepherd, and on April 3, 1835, she became the first Superior General of the Congregation of the Good Shepherd of Angers. This congregation had the same mission, but was a contemplative order. The Sisters earned their own way with intricate embroidery of priest vestments and production of altar bread. Soon bishops from other cities started requesting that Good Shepherd Sisters establish communities to minister to women and girls in their Diocese. To respond readily to these requests to save souls and expand the apostolate to wherever needed, St. Mary Euphrasia envisioned a governing structure that would allow Good Shepherds to carry on a global ministry. All houses were to be under one general government, the Motherhouse of the Good Shepherd at Angers. Sister Mary Euphrasia passed away on April 24, 1868. She was Canonized on May 2, 1940 by Pope Pius XII. The Feast of Saint Mary Euphrasia Pelletier is celebrated on April 24th.

L'Anno Bello: A Year in Italian Folklore

Of Flowers and Trees: Celebrating the Outdoors in May

Around this time of the year, when delicate spring gently gives way to the heat of summer, I feel the pull of nature calling me. The trees have erupted in full bloom, and whenever I look up through their branches, I see a bright mosaic of lacy green leaves silhouetted against the sunlight. Since the days are now longer, evening falls softly with a dusty glow, reminding me of dinners eaten outdoors watching the sunset. Yes, this is the time of the year when I want to spend as much time out in nature as possible. My husband and I often take walks in a state park near my town, reveling in the shady trees, the burbling waters of the streams, and the miniscule flowers dotting the meadows. Even just walking to my mailbox on a warm and sunny day, watching the birds dart in and out of the bushes, is enough to lift my mood. This desire to return to nature has roots in a deep and universal longing, so much so that many May holidays around the world encourage celebrations in the outdoors.

When I was in Italy with my family years ago, some of my most vivid memories recall places of natural beauty, along with the lovely human interactions they enabled. Our first stop was Milan, and we stayed at a small inn nestled on an old side road. I remember stepping into the hotel's courtvard. which blossomed with wild trees and colorful bunches of flowers. A worn statue of a Roman goddess peeked out from the foliage, making me feel as if I had stepped through a lookingglass into days long past. A friendly group of Japanese girls some oranges they had recently bought, and the experience felt transcendent, a crossroads of culture, nature and history. In

a secluded area of some ancient ruins, where, far removed from the bustle of the busy city, we heard only the sound of the breeze fluttering through trees and chirping birds. Until we started talking to two jovial college-aged brothers from Colorado, I could not shake the sensation that the breeze and the birds were really spirits of antiquity announcing their presence. The latter half of my trip to Italy was spent in my father's hometown of Sulmona in Abruzzi, a bucolic hamlet of rolling hills, braying sheep, and expansive meadows. It felt more like the real Italy than other places that cater exclusively to

The holiday of Pentecost falls on Sunday, May 20th, and Italians will spend this important Christian feast day incorporating rituals from the outdoors. Pentecost is part of the Easter festivities, occurring on the seventh Sunday after Easter, and it celebrates the descent of the Holy Spirit upon the disciples of Jesus. Some Italians refer to this feast as Pasqua Rossa, meaning Red Easter, due to the red vestments clergy wear in honor of the Holy Spirit. Many Italian churches scatter rose petals from the ceiling on this holiday, bringing the ubiquitous flowers of May into the celebration, as a way to commemorate the Holy Spirit descending on the disciples. In England, Pentecost Sunday is known as Whitsunday, and there the festivities heavily take on an outdoor quality. People celebrate with Whitsun Ales at town fairs filled with feasts, folk dancing, parades, and charitable collections to benefit staying at the hotel offered us the village church and poor families. The Easter season contains multiple references to the rebirth and renewal of the Earth and vegetation, which Rome, my family wandered into in religious ceremonies also refers to the renewal of faith and hope. In Italy and other European countries, the Easter festivities do not end on Easter Sunday, but rather move on to encompass other feasts like Ascension Day and Pentecost, reminding us that the beauty of nature and the revitalization of the season continue as spring turns to summer.

May remains one of the most significant months for appreciating nature and all it has to offer. When I was an undergraduate student. I took a wonderful course on Buddhism. One spring day, the professor took us out to the woods to meditate. He explained that by becoming at peace with the outdoor surroundings, we do not separate ourselves from the world but rather reach down into our deeper consciousness and find ways to better our interaction with the world. I also learned this lesson while I was in Italy, and from investigating European holiday customs like those of Pentecost. By taking the time to appreciate the natural world around us, we are forced to look within, and honor our own mind and soul. Perhaps that is the message of the bright spring flowers and the breeze fluttering through the trees after all.

Back when I was a kid in the '50s, Americans knew all about Big Brother and what it meant for our nation. Most of us read George Orwell's book of the same title which was written in the same year I was born, which means that both the book and myself hit the Big Seven 0.

I can't figure out what has happened over the course of my lifetime. Back then with the ending of WWII and the beginning of the Cold War with the Soviets, we appreciated our constitutional republic and especially the Bill of Rights.

I also remember whenever anyone in the government mentioned a national ID card, there was widespread disapproval. Only Nazis and Commies had those. We valued our personal security and we didn't like the idea of giving it up for any reason no matter how good it might sound at first.

We could walk around freely without carrying "papers" on us. The police couldn't just stop us and ask for our identity. We believed, as our founders believed, that we were the government and, as Ben Franklin once warned, "Those who would give up essential liberty to purchase a little temporary safety deserve neither liberty nor safety."

Even when he ran the FBI, J. Edgar Hoover opposed a national ID card. I remember my social security card said "not a form of identification." Americans would have it no other way.

In the '50s and '60s, we all had ID cards of some sort. My dad didn't mind having a Blair's Foodland photo ID to cash his checks when I was growing up near Ruxbury's Dudley Station. When I passed Drivers ED, I applied for my driver's license also with a photo ID card. No problem there.

However, Americans protected their social security cards like the Holy Grail, even though it came with no photo. We knew that our ID number had to be protected.

As the decades of my life went on, I got a draft card, too. It was part of growing up. I have all kinds of cards today, many with photos. However, today too many have forgotten about their own self-protection. I hear so many stories of folks giving up their personal information on the phone too strangers.

They get asked for their social security number and willy-nilly hand it over to a stranger on the other end.

Identity fraud is big today because slowly we have forgotten the lessons of that pre-WWII generation that valued its privacy. My dad only gave up personal information to government agencies and even then he was uncomfortable. Perfect strangers? Never, never, never!

What happened? How did we change? Partly, I think it's because our own government has become far too intrusive. Many assume it can do whatever it wants and we are powerless. Think like that and you

Our lives have become an open book to the world thanks to modern technology and forgetfulness on our part. We are surrounded by surveillance cameras everywhere. I read a story in a local Attleboro newspaper about six years ago. A shopper at the Emerald Square Mall in North Attleboro forgot where she parked her car in the large lot. She spotted a police cruiser, told him her story and he took her directly to her car using a computer to GPS her vehicle. The lady loved the technology, too. She had her car. It bothered me.

I was a police officer at the time and I did not like that news story so much. Should government be able to "help" us like this? In this case, it was helpful but as an American citizen it seemed scary to me. Any technology can become abusive which brings me back to George Orwell's 1984, because it isn't just a novel anymore.

Our founders who broke away from Britain maintained a healthy distrust of all government, even its own in future time. Freedom is a gift to be passed on to future generations, otherwise the American Revolution was a waste of

Think about America as past, present, and future together in real time. Don't forget history. Today we do battle as Democrats, Republicans, liberals and conservatives, and we surrender our oneness as Americans who believe and cherish our liberties on the altar of government.

As Franklin also warned, we have "A republic, if YOU can keep it."





PLEASURE ISLAND

Walking Tour Sunday May 20TH Author Robert McLaughlin Keeps The Memories Alive

If you drive down Rt. 128 through Wakefield you will still see an exit marked Pleasure Island Road. It is one of the last vestiges of a place that in fondly remembered by many of a certain age.

Pleasure Island was a family recreation center inspired by Disneyland and Storytown. It was a huge undertaking encompassing a total of 168 acres of dry land and meadowland. The park was conceived by a man named William Hawkes and the story of how it all came to be is the subject of the book Pleasure Island: 1959-1969 (Images of Modern America) by Robert McLaughlin. It is quite the story and Mr. McLaughlin's passion for preserving the history of the ten years the park survived is evident on every page of his book which is also filed with wonderful archival photographs and excerpts of interviews with Mr. Hawkes as well as many of those who worked at Pleasure Island.

Pleasure Island wasn't an amusement park with thrill rides. It was a theme park with many themes including Western City, Pirate Cove, Monkey Island, and Old Smokey Locomotive Ride among many other things. It also had a whale boat ride where visitors would get to see Moby Dick rise from the depths and see water gush from his blow hole.

In an area of the park was the Show Bowl where many famous entertainers of the day appeared. Among them were Ricky Nelson, Hugh O'Brien, Jimmy Dean, Neil Sedaka, Chuck Connors, The Three Stooges, Fess Parker, and Johnny Crawford. In 1960 the Boston Jazz Festival was held there with appearances by Nina Simone, Dinah Washington, and Duke Ellington. As you can see, there was no lack of first rate talent.

While walking through the park you might confront a pirate who would be quite to draw his sword and pose for a photo or you might happen upon a shootout between cowboys.

Mr. McLaughlin's book brings back memories for those of us who were fortunate enough to have been there and it will be of interest to those who have never experienced such a hands on adventure. The story and interviews are extremely interesting and the photographs are pure gold.

Eventually, Pleasure Island closed, the victim of

many forces including unpredictable weather, the struggle to find backers, and the changing times. It is now an office park with only a few traces of that once magical place still to be found. On Sunday, May 20th from 10:00 am to noon, rain or shine, Mr. McLaughlin will conduct a walking tour of the site and will discuss the history of Pleasure Island while pointing out the places where it all happened. Many former employees of Pleasure Island show up for these walks and also share their memories. I took this tour last year and I can tell you it is a terrific experience.

The location is Audubon Road in Wakefield (Rt.128-Exit42). The tour meets in the first parking lot the left after entering Edgewater Office Park. There is no charge. Mr. McLaughlin will have copies of his book as wells two others he has written for the Images of Modern America series, Magic Mountain and Freedom Land: 1960-1964.

A Nostalgic Remembrance



Two events happened this past week. Tuesday the 15th was the 27th anniversary of this column, a fact that I mentioned last week. The second event would have taken place yesterday, the 17th. It was my mother's birthday. She was born (at home) on May 15. 1909, the only daughter of Mike and Jenny Contini. Yesterday, she would have been 109 if she had lived, a feat that is coming closer to reality these days. Actually, she almost made it to 99, following the genetic tradition of the Contini's.

Babbononno made it to 98, his sons (my uncles) Paul to 95, Nick to 94, and Gino to almost 101. As I said, they had good genes. I hope I inherit the longevity from that side of the family. Mom and her brothers experienced good health both physically and mentally until they were in their nineties and then needed assistance to maintain what is called quality living. Uncle Paul was taken care of by his youngest daughter, my cousin Ellie. She brought her father to Florida for his last few years, and after he passed on, she cared for Uncle Nick, who had moved to Florida

After Dad passed away in 1991 (not long after this column was born), I kept Mom in her house to help her maintain her independence. She adapted to life without my father the love of her life with whom she had spent over 55 years. Not wanting her to feel isolated, Loretta and I decided to take her with us whenever we traveled. Our sons, John and Michael loved the idea and from that point on, we traveled as a family during the month of August and during the February and April school vacations. We stayed home for Christmas due to the extended family being here and because I played a lot of music during the Christmas season, and especially on New Year's Eve.

Mom loved it when we headed to Florida because she could tie up with two of her brothers, Uncles Paul and Nick. We would head to an apartment hotel across from the ocean in Delray Beach, close enough to allow both Paul and Nick to visit every other day. My kids loved the arrangement. They had the best of all worlds, family surrounding them and the warm Atlantic outside the front door and a heated pool out the back door. They lived in their bathing suits while my mother and uncles looked on as they swam. Loretta concentrated on luncheon menus for one and all and those were happy years.

Around 2004 or 2005, it all began to unravel. Uncle Paul passed away as did Aunt Dorothy, Uncle Nick's wife and then Uncle Nick. One morning, I received a call from Mom's cleaning lady who had just arrived at her house and found her bleeding from a cut over one of her eyes. I flew over to Mom's and found the kitchen TV face down on the kitchen table and the knick-knacks that were on the TV table scattered all over the kitchen floor. She evidently had tripped or fallen, grabbed at anything to break her fall and hit the TV. She didn't remember anything, and when I addressed the cut over her eye, she denied she was hurt or had fallen.

Later, after an exam at the emergency room at a local hospital, the attending physician called me aside and told me he examined Mom's entire body and discovered black and blue marks in various stages. He then added, "Your mother has been falling and has not told anyone." The next step was to move her bedroom to the first floor and put in railings to help her get around in every room.

A week or so later, Loretta and I were going shopping and I knew that Mom wanted new slacks. We stopped at her house to check her measurements and discuss color. After the slacks were purchased, we headed back to Mom's to have her try things on. I told her that I would have the pant legs shortened (she was only five feet tall) and return them when they were ready, and all was well.

About 3:00 am, the phone rang. Mom, on the other end, was in a panic. She told us that she had gone shopping for slacks and they closed the store while she was in the dressing room. I asked her which store and she didn't know. I asked where she was making the call from, and she didn't know. I then told her to hang up and I would come and get her. When I heard the phone click out of operation, I knew by the sound that it was her kitchen phone. Loretta and I dressed and were in her kitchen within 15 minutes. Mom was so disoriented that she thought she was in the dressing room of the ladies department at Jordan Marsh, a long gone department store that had been her favorite.

Loretta and I bundled her up and brought her back to our house where she stayed until I could get her into an assisted living complex. We told her it was a vacation resort and she bought it. Unfortunately, her independence had come to an end according to the psycholo-

gist who worked with her once she became a resident at the home.

I thought it best to not say anything when her middle brother, Uncle Nick, passed away, and she never knew. One night, I received a call from the night nurse at the home. She told me that she was Haitian and that some of the superstitions she grew up with were similar to those of the Italian people. She went on to explain that, at night, after the lights were out, my mother would talk to the spirit of my father. It seems that he was calling to her to join him. The nurse then said, "This may be close to the end."

A few days later Mom closed her eyes and that was it, no physical reason for her passing. The doctors claimed it was just old age; she was 99. Was it my father calling from beyond or just old age??? I will never know. What I did know was the wonderful life she had with my father. She joined him on the road with the big bands in the thirties and then settled down in East Boston after I was born, all of us living with Nanna and Babbononno.

She and my father were inseparable for over 55 years and she was the consummate grandmother when my kids came along. I still think of her every day, but I didn't cry at her passing. She had such a wonderful life that I can only talk about the happy times and allow the sad times to slide into the background. The happy days far exceeded the bad ones. And so, in remembrance, "Happy Birthday, Ma," you were loved by one and all.

By the way, I'm working on a new book, called *Nanna and Babbononno*, based on this column. Before I finish, it might be time to purchase my first book, *True Short Stories*.



John Hickok (Parade, Little Women, and Aida on Broadway) plays Broadway producer Robert Whitehead.

Arthur Miller was perhaps the most celebrated American playwright of the 20th century, with masterful plays, Death of a Salesman, All My Sons, A View from the Bridge, and The Crucible, capturing the darker side of the American Dream, the political zeitgeist of the day and, somewhat ironically, the bonds of the American family -- particularly fathers and sons. His life and career was threaded through the culture of the country in the mid-20th century. He divorced his first wife to marry Marilyn Monroe; he was subpoenaed by the House Un-American Activities Committee; he won the Pulitzer Prize and numerous Tony Awards; and he spoke out against the Vietnam War. Miller was seen by many as a moral conscience for the nation.

But despite chronicling the "common man" and the American Family, Miller did not acknowledge his own son. Daniel was not mentioned in Miller's autobiography, Timebends, or in either of his parents' obituaries in The New York Times. Playwright and former Times reporter, Bernard Weinraub became engrossed with the Millers' story after reading a Vanity Fair article about them in 2007. He took a journalist's approach to translating the story for the stage, interviewing social workers and others who knew

and worked with the family. Fall explores the fascinating dichotomy of Miller's life with Morath (the couple also had a daughter, Rebecca) and the divide between their public persona and their private lives.

"Arthur Miller was one of our greatest playwrights. His best dramas dealt with fathers and sons, guilt and betrayal, and essentially, our responsibility towards each other," says Weinraub. "He dealt with the paradoxes and tensions of our lives. What interested me here was the contradiction between the man and the artist. And the impact of his actions on his art."

"Miller wrote many plays about the sins of a father being visited on a son, and as a writer he provided a moral compass for a generation," says DuBois. "Bernie's exploration of this iconic man is a story that remained with me since the first time I read the script a few years ago. I'm proud Boston audiences will be the first to see this show and discover more about a playwright they thought they knew."



the spring of '43. He stayed with the team for almost 11 years. He made his debut on September 6, 1943, against the Yankees in relief. He was 16 years, 8 months, and 5 days old. He recently passed away in San Antonio, TX at 91.

For a short time he was the youngest player in the Majors, but on June 10, 1944, Joe Nuxhall of the Reds made his debut at age 15 years, 316 days.

Scheib's best season was 1948, when he went 14-8 with a 3.94 ERA and 15 complete games. He also batted .298 with two homers. He saved 11 games in 1951 and went 11-7 in 1952. He was sent to the Cardinals in 1954, pitched in three games and retired at 27 years old.



MICKEY WALKER The Toy Bulldog Took On Heavyweights Fought Greb In And Out Of The Ring

When trying to rank the greatest fighters of all time there are many different criteria used. Included in these are boxing ability, punching power, defensive skills, longevity, consistency, the ability to take a punch, and the opposition encountered.

Former Welterweight and Middleweight Champion Mickey Walker would not rank high in the categories of boxing ability and defensives skills, but he more than made up for that in the ability to take a punch, longevity, and the opponents he took on. Not only did he win the welterweight and middleweight titles, he also fought for the light heavyweight championship losing a decision to Tommy Loughran. But not even that was enough for the 5'7" slugger. He also became a contender for the heavyweight championship.



Walker vs Sharkey.

Walker, from Elizabeth, New Jersey, began his professional career in 1919, and in 1921 he held welterweight champion Jack Britton to a draw over 12 rounds. In 1922 he would get another shot at Britton and this time he pulled out a decisive win knocking the champion down 4 times on his way to winning the title.

In 1925, Walker moved up in weight class and took on middleweight champ Harry Greb in a bout that would become the stuff of legend. Well, not the bout in the ring but the one that supposedly took place in the hours after that encounter.

In a 1981 interview with Peter Heller for his book In This Corner, Walker told his side of the story. He concedes Greb won the fight in the ring that night but says he won the rematch that took place outside of a barroom hours later. About Greb, Walker had this to say "He gave me a good shellacking the night we fought. The fight after, on the street, I always take credit for winning that, so I was champion anyhow." He goes on to relate how the two had been drinking

together in the company of their girlfriends. The trouble began when they walked outside and Mickey told Greb "You know Harry, you'd never have licked me if you didn't stick your thumb in my eye." Walker said he didn't mean it as an insult, but Greb certainly took it as one. Harry responded "Why you bum, I could lick you if I had no hands, and I'll show you." As Greb said this he began taking off his jacket. Just as Harry had his coat part way off and with the sleeves down by his elbows Walker fired off his best shot at him. According to Mick-

ey, Greb flew four feet into the air and up against a wall before crashing to the ground. At this point, a huge policeman stepped in and broke things up.

After his evening with Greb, Mickey returned to defending the

Welterweight title but in 1926 he lost it to Pete Latzo. Now he was having difficulty making the weight. He returned to the middleweight division and later that same year he won the title from Tiger Flowers.

It was at this point that Walker got an itch to go after bigger game. Though he had not grown anymore he decided to campaign in the light heavyweight division and took on former champ Mike McTigue whom he kay-

oed in one round. He then won a decision over Paul Berlanbach. Mickey continued defending his middleweight crown while fighting the bigger men and eventually earned a shot at the light heavyweight championship taking on champion Tommy Loughran. On March 28, 1929 he lost a ten round split decision to the smooth boxing Loughran.

After the loss to Loughran, Walker ran off 22 straight victories in the middleweight and light heavyweight divisions. He also did something else; he began fighting heavyweights. He believed he would have better luck against the very big guys because they would be slower and easier to hit. For a time it looked like his reasoning was paying off. He beat the very tough Johnny Risko twice and then took on the fearsome Bearcat Wright. Outweighed by 42 pounds and a half a foot shorter than his opponent, Walker, after being down briefly in the first round, came back to floor Wright and by the tenth and final round had Bearcat hanging on. Mickey won the decision and the opportunity to take on Jack Sharkey in an elimination bout to determine a challenger to champion Max Schmeling.

Walker earned a draw with Sharkey but in reports I have read he took quite a beating on his way to the final bell. It was his toughness more than his ability that caught the eye of the judges.

Mickey continued taking on heavyweights and defeated King Levinsky and Paulino Uzcudun while dropping a decision to Johnny Risko in their third meeting. In 1932 he would be

matched with the now former champion Max Schmeling. A win over Schmeling would put Walker in line for a shot at champion Jack Sharkey.

Schmeling was the one big man Walker should not have stepped up against. Mickey's straight at you style was made to order for the counterpunching German who knocked Walker down late in the first round. Mickey took an awful beating as Max continually landed with his vaunted right hand. Mickey kept attempting to land hooks on Max but was out punched time and again In the8th round Walker, with his eyes swelling shut was dropped two more times. At one point Schmeling pleaded with the referee to stop the fight. When Walker returned to his corner his seconds waved the towel signifying their man had had enough.

In the Schmeling fight Mickey showed incredible courage, but this fight also took a lot out of him. He would continue fighting but was never the same again. He would challenge one more time for the light heavyweight title, losing a decision to Maxie Rosenbloom. He never lost his middleweight title. Instead he gave it up when he set his sights on the heavyweight throne.

Mickey Walker retired from the ring in 1935. His final record is believed to be 131 wins (60 by knock out), 25 losses, 2 draws, and 2 no contests. He opened a restaurant in New York City and took up painting. He earned some renown as an artist and his work was featured in New York and London galleries.

Walker died in 1981 after suffering from Parkinson Syndrome no doubt brought on from his years in the ring. If greatness were judged solely on toughness and heart Mickey Walker would rank very near the top.

HOOPS and HOCKEY in the HUB

Immeasurable. That's what these Boston Celtics are. In an era in sports where many seek to quantify everything, the Celtics have qualities that can't be quantified.

In an era where

many in the front

offices of various pro sports franchises seek to reduce everything to numbers — analytics they call it — the Celtics have proven that they possess characteristics that can't be measured, only ones that can be observed, applauded, appreciated, and enjoyed.

And don't forget another quality that can't be measured — excitement. The kind that can electrify a crowd, light up a fan base, and put a wide smile on an entire region.

This was a team that was written off, a team that wasn't supposed to be much, a team that wasn't supposed to accomplish much. But a funny thing happened along the way. While all the analysts on television and the army of those engaged in analytics were telling us about the dire state of the Celtics, they didn't tell the one group that mattered — the players on the Celtics team.

When Gordon Hayward went down with a season ending injury on the opening night of the regular season, some pronounced the Celtics season as over. When Kyrie Irving had season ending knee surgery in early April, many said the Celtics would be lucky to get by the first round of the playoffs.

Yet, here they are — still playing — and not only playing, but performing well — while 26 other NBA teams are sitting on the sidelines.

The Hawks were supposed to halt them but they didn't. Philadelphia was supposed to pummel them but they couldn't. And oddly that brought the Celtics to a juncture that everyone back in October predicted would occur in May—namely that the Celtics would play the Cavaliers in the Eastern Conference Finals.

Only see, it really was supposed to happen another way. Gordon Hayward and Kyrie Irving would be the ones that would take them there. But when they didn't, others did.

How do you quantify the play of Marcus Smart, who brought an aggressiveness and toughness to the first two games of the series with the Cavaliers? Cleveland Coach Tyrone Lue was looking for an answer.

"He makes winning plays, he makes tough plays," said Lue of Smart. "If it's 50/50 balls, he going to get them. If it's a loose ball or an offensive rebound they need to have, he's going to get it. We've got to find someone who can match his toughness."

"How do you quantify the adjustment in thinking that LeBron James displayed as the series progressed? After the Cavs lost Game 1, James indicated that he was not concerned, that his teams had lost opening

games before. But after the second setback, James was a bit more measured, noting that his team's mission was to "protect home court" and to focus "on what needs to be done to help our ball club be successful."

A n d then there's the fearless play of Terry Rozier, who had 14 points in the third quarter of Game 2. "It's amazing, you know," said teammate Al Horford in the postgame press conference. "It's just like a switch goes off and he goes out there and plays. Terry is fearless. He's always been like that. It's just that now he's getting the opportunity to show it."

And, maybe, just maybe, part of this is that the Celtics don't have a star, they have a team.

"We've just got a tough resilient group of guys," said Celtics Coach Brad Stevens. "It's great in a lot of ways. In a lot of ways you feel comfortable going to several guys with the game on the line and then some. We've gone to Jayson Tatum, we've gone to Marcus Morris, we've gone to Marcus Smart. You feel good about all those guys who can make plays in big moments."

Immeasurable.

At a time and place where many would wish to quantify everything, the Celtics can't be measured. There are no yardsticks, there are no numbers, there are no statistics that can reduce the Celtics to a set of numerals.

It is a team that has gone further than all expected. It is a team that has exceeded all benchmarks, all attempts to measure it, all efforts to reduce it to digits.

It is a team that is immeasurable. It is a team that is, in a way, beyond belief — because in the beginning there were no believers other than the players and coaching staff.

But the zone beyond belief is reality. The reality was that the Celtics were in command of the Eastern Conference Finals as the teams headed west to Cleveland. Whether things would remain that way was, of course, to be determined. But the Celtics were only two wins away from a berth in the NBA Finals.

That, in itself, once would have been unthinkable. That, in itself, was something, a development that no one engaged in analytics could have quantified as the playoffs began.

Yet here they were, inching closer to the brink of the unthinkable. All because of the qualities that this team possessed — a spark, an attitude, a belief, and yes, all the while growing day-by-day in self-assurance. The Celtics are a team that plays with a heart, with a grit and a grind, coupled with an aggressiveness and fearlessness — all the qualities that are a pleasure to behold.

All the qualities that are ... immeasurable.
