Sanders took Oregon by storm as expected, and it was a dead heat in Kentucky as Hillary Clinton won the state by one tenth of one percent with the candidates splitting the delegates. 

votes), followed closely by Marie Simboli (237 votes), who both had more than the 223 votes received by Maria Lanza in the 2015 election. Other candidates elected for a 2-year term on the Neighborhood Council include Gennaro Riccio, Danielle D'Ambrosio, John Pregmon and Brett Roman.

The top six candidates with the most votes are elected for a 2-year term and join the other current six members that have one year left remaining in their term. The other standing members on the 12-person council are Philip Frattaroli, Carmine Guarino, Sean Hennessey, Jorge Mendoza and Ralph Verrocchi. (One seat was vacated by Maria Lanza and will be left open until next year's election.)

A master storyteller, John Christoforo captivates audiences weekly throughout the United States with his column, Nanna & Babbononno, which depicts the trials and tribulations of four generations of his family in the United States. Much of his column focuses on his life growing up in East Boston.

Christoforo's family emigrated from Italy in the 1920s where they first lived on Orleans Street. Later they moved to Eagle Hill where they became one of the first Italian families to live in the area. He attended the Chapman, O'Donnell, and Barnes Schools



in East Boston before attending English High.

Christoforo will take you on a journey back in time to East Boston in the 1940s and 1950s. He will share childhood stories that all ages and backgrounds will enjoy. It is a time of mom and pop stores, the Gem and Seville Theatres, Lombardo's meat market, Gertie's Lunch, Sabo's Men's Store, Fine's Men's Shop, the 5 and

10, Goldenberg's Department Store, Manny's Men's Store, John Sava's Market, Benbrock Pharmacy, and so much more!

At 13, Christoforo lied about his age and went to work at the Seville Theatre where he worked throughout his college years. Christoforo came from a family of musicians and at 18 he continued the family tradition when he became a professional musician. He earned his undergraduate degree from Boston State College (now UMASS Boston) and taught drafting and engineering in the Boston Public Schools for 43 years. He also did a bit of modeling and acting in Hollywood.

In addition to his undergraduate degree, Christoforo earned two masters degrees, and a doctorate degree. He has been married to the same woman for 40 years and has two sons.




Stirpe Nostra

THE SABINES THREE



Numa Pompilius

Numa Pompilius was born in

the Sabine town of Cures. He

enjoyed a great reputation for

justice and piety, and was deep-

ly versed in divine and human

law. His selection to become the

second king of regal Rome came

after the death of Romulus, who

is supposed to have been car-

ried off to the heavens during

a thunder and lightning storm.

Numa built the first temple to

Janus as an index of peace and

Tullus Hostilius war. When the temple was open, this signified that the nation was at war, and when closed it signified peace. Numa was a peaceful and religious king; his subjects spontaneously imitated his character, and all of this in turn promoted a peaceful atmosphere among neighboring nations. He made alliances and treaties with all of these neighboring tribes and then closed

the temple. Romulus ruled for



Ancus Marcius

37 years and Numa Pompilius ruled for 43. Thus, this young nation called Rome was not only strong, but was also well organized in the arts of peace as well.

Tullus Hostilius, the second of the three Sabines, was declared king by the people, and the Senate quickly confirmed their choice. In his early career, he became a participant in what might be termed the ideal war. Roman rustlers were stealing cattle from the neighboring nation of Alba while the Alban rustlers were stealing Roman cattle. Each nation sent envoys to demand restitution from the other. A stalemate developed and both nations prepared for hostilities. During a prewar conference, it was agreed that the Etruscan nation appeared to be waiting for the Romans and the Albans to exhaust themselves and then they, the Etruscans, would rush in to overpower both

Because of this Etruscan threat, it was agreed to take advantage of an extraordinary circumstance. Three brothers from the Alban Army were about evenly matched with three brothers from the Roman Army, and they agreed to engage in combat with the winner deciding the outcome of the war. The Romans eventually won, but not without considerable treachery from Mettius, the Alban leader. After hostilities had ended, Mettius was seized, stretched between two fourhorse chariots, and torn apart as the horses were driven in opposite directions. Such is the brutality that grew side by side with the Roman nation.

Ancus Marcius, the third Sabine King, was the grandson of Numa Pompilius. He proved that he was equal to his predecessor by declaring war on the Latins, defeating them in battle, and returning to Rome with immense spoils. He also brought back many thousands of Latin prisoners and, in keeping with established policy, made them citizens of Rome and then sent them a tax bill. He soon discovered that population growth and crime go hand in hand;

Former Police Sergeant Stephen Borelli announced his candidacy for Governor's Council for the 6th District. He then served as a Sergeant in the MBTA Police and led the training of his fellow officers in criminal investigations during a distinguished 13-year career.

"During my days as a Police Sergeant, I frequently encountered people at the most distraught and fragile moments in their lives," said Borelli. "I still remember each of them and I'm honored to say that I keep in touch with many of them to this day."

Many years after he left the police force, Stephen was instrumental in helping to solve a sexual assault case that he initially responded to in the 1980s. Thanks to his persistence and the exceptional training of his fellow officers, this case showed Mr. Borelli how the dedication of just a small group of public servants can change the lives of those in need.

Mr. Borelli received his law degree in 1997 from the New England School of Law and then entered private practice representing clients in all phases of criminal and civil litigation. In 2006, he was appointed as an Assistant Clerk Magistrate in Somerville District Court where he continues to serve the Commonwealth of Massachusetts. Attorney Borelli holds a B.A. from Suffolk University and is a proud resident of Boston's North End.

About the Governor's Council

The Massachusetts Constitution established the Governor's Council to provide advice and consent to the Governor on the nomination of judges, payments from the State Treasury, and the issuance of pardons and commutations. The Council meets in public session each week and is comprised of eight Councilors elected from across the Commonwealth to serve two-year terms.

The 6th District of the Governor's Council contains portions of Essex, Middlesex and Suffolk Counties and includes 20 cities and towns: Boston*, Cambridge, Chelsea, Everett, Lynn, Lynnfield, Malden, Marblehead, Medford, Melrose, Nahant, Reading, Revere, Saugus, Somerville, Stoneham, Swampscott, Wakefield, Winchester and

For the Love of the Outdoors

Around this time of year, I feel a sense of energy bubbling up inside me. All of the cabin fever and restless excitement over a new spring evaporates into the warm air, a surge of joy and release as refreshing as an afternoon rain shower. As the temperatures hit ever higher degrees, I can practically smell the summer in the air, the promise of barbecues and ocean waves and ice-cold glasses of lemonade. When class is dismissed at the school where I teach and students run out into the luminous day, their unbridled happiness is contagious as they scamper across the bright green, sun-soaked grass. Indeed, the month of May as a whole calls for outdoor excursions. Traditionally the beginning of summer, May heralds warmer temperatures and an explosion of tender leaves on trees. It is definitely not a month to stay cooped up indoors, but rather one to venture outside and revel in all the delights nature has to offer. In Italy, one of the most beloved traditions is called la passeggiata, or evening stroll. After dinner, Italian families and friends meander through city streets or rural lanes, enjoying the outdoor experience and each other's company. In urban areas, the passeggiata may involve stopping for some delicious, creamy gelato, casual window shopping, or sitting and chatting along the rim of one of Italy's many beautiful fountains. People in the countryside may rest in the shade of trees, pick fruit, or pack a small picnic of sweets and wine. In an age where too many people are tempted to watch television right after dinner, I love the idea of a tradition that encourages people to step outside and partake in the universal and time-honored pleasures of fresh air, loved ones and the nourishment of food and drink. I fondly remember my evening passeggiate from when I visited Italy several years ago ... the walks through bustling city centers, where the late-day sun turned ancient ruins to the color of gold, and the hikes along dirt roads in my dad's home region

of Abruzzi, watching the dusky sky darken the mountains. My husband loves to go outside and walk, so often I will try to recreate a passeggiata here at home. As I walk around my neighborhood in this balmy month of May, I pay special attention to the life all around me: jubilant children kicking a soccer ball, robins hopping among blades of grass, the sun peeking through branches laden with delicate pink flowers.

May brims with a number of special holidays that encourage such outdoor excursions. The month begins with May Day, an ancient holiday celebrating the start of summer. It is also a "holiday honoring flowers and trees, which are their most beautiful now. Mother's Day, which occurred on the 8th of the month, not only allows us to express gratitude for the wonderful things mothers do for us but also prompts us to enjoy their company. On Mother's Day, my family and I often go out for ice cream, an activity all the more special because of its simplicity and its unencumbered focus on loved ones, food, and the warm sun. In a week, it will be Memorial Day, and countless families will fire up the grill and eat summer produce outdoors. Others will flock to the beach or the mountains ... any outdoor place will do, as Memorial Day weekend is considered the unofficial start of summer! Earlier, however, May hosted another summer holiday, Ascension Day, known as la Festa dell'Ascensione in Italian. Falling forty days after Easter, this holiday commemorates Jesus' ascent into Heaven. Italians celebrate it with outdoor excursions and picnics, as typical for the holidays of May. Another feast known as la Pasqua Rossa, or Pentecost, falls fifty days after Easter and honors the descent of the Holy Spirit upon Jesus's disciples. Italian churches often scatter rose petals during the services to symbolize the Holy Spirit, incorporating a lovely outdoor symbol of summer.

This month, be sure to spend an abundant amount of time enjoying nature. The warm days, the sunlight that lasts into the late hours of the evening, the succulent fruits of summer ... these are all the pleasures Mother Earth has to offer this time of the year. It is also important to remember that what makes these delights so special is the fact that they are fleeting, since the year is a cycle always in motion, so relish May while you can! Whether you choose to take a passeggiata in the golden hours of dusk, or whether you opt for a picnic on Memorial Day weekend, or whether you simply agree to meet a friend for ice cream or a quick bike ride, strive to appreciate all that nature has to offer. May will come to a close before we know it, but her beautiful experiences are available right now, ready for our fulfillment.

Dogfight

Solid, Touching, Emotional

SpeakEasy Stage Company is closing out their 25th anniversary season with a very strong production of *Dogfight* directed by Paul Daigneault. The New England premiere of the musical is based on the 1991 film and screenplay by Bob Comfort, and with music by Benj Pasek and Justin Paul.

Most of the story takes place on November 21, 1963, and focuses on three young Marines, Eddie Birdlace, Bernstein, and Boland who refer to themselves as the Three Bees. They are to be deployed the following morning to Southeast Asia and are embarking on a game the Marines call Dogfight. It is where each recruit puts up money that is pooled and will be awarded to the man who can bring the ugliest woman to a party they are having. It is demeaning to women, but also serves the purpose of removing any sense of empathy from men who are about to be sent into combat.

Eddie, (Jordan J. Ford) finds waitress Rose Fenny (Alejandra M. Parrilla) at a local dinner and sweet talks her into attending the party with him in the hope he has found his winning date. Rose is caught up in his flattery and is thrilled to go. The others are also finding their mates for the evening.

It would be easy to settle in at this point and see this play as being about women being objectified. It runs much deeper than that. While what the Three Bees and the other soldiers are doing is cruel, it is also juve-

nile and demeaning to them as well. But they are required to give up much of their sense of humanity, considering they will soon be in a very inhumane environment. They are young and, because of their weeks of basic training, feel prepared for anything the world will throw at them. Instead of this being about a group of young men acting like jerks, it has much more serious overtones considering what is about to happen in their lives and in the world.

Rose is no victim. While she is deeply hurt when she finds out what Eddie was up to, she is also touching him deeply with her warmth and confidence. Eddie at first saw an overweight and insecure girl, but fast begins to learn much about himself and life from Rose. He finds it is not so easy to be cruel. As the story unfolds, we are touched on many emotional levels. As one audience member stated after the performance, "I

have learned to always bring a box of tissues to a SpeakEasy production."

The play does have a number of funny and warm moments that will make you smile. Alejandra M. Parrilla as Rose and Jordan J. Ford as Eddie are simply wonderful in the restaurant scene where Rose shows she can match Eddie's tough guy bravura as well as add a very strong wit. Her kindness is also infectious and is breathed in by Eddie. Their touching duet "First Date, Last Night" is beautiful.

The theater is set with the audience sitting on three sides of the stage. This, along with two movable staircases, is extremely effective.

The play moves rapidly to 1967 and the ending is compressed and charged with so much that happens over that time. Has Rose or the war had more of an effect on Eddie? Can we just turn our humanity on and off?

I know I often say this after seeing a SpeakEasy production, but I left the theater with much to think about, and with much to feel.

We are lucky to have such a great company in Boston. I hope you go down to the Calderwood Pavilion and spend a couple of hours being touched by these fine young actors. What's in Your Cosmetics?

Nitric acid is an inorganic acid used as an oxidizer and stabilizer in cosmetics. It is a corrosive liquid that can irritate skin.

Mineral oil is a liquid mixture of hydrocarbons obtained from petroleum. It can increase the response of the skin to ultraviolet rays and can cause sunburn without any allergic effect being involved.

Even petroleum jelly, also a semisolid mixture of hydrocarbons, pollutes our water and destroys marine life. Avoiding them is essential for the health of humans, animals, fish, water, land and air.

Hydrocarbon is a synthetic chemical compound containing only carbon and hydrogen atoms. This large group includes paraffins, olefins, acetylenes, and alicyclic, and of course, petroleum. They are potentially allergenic and phototoxic as described above.

Sodium laurel sulfate is a popular ingredient used as a detergent, emulsifier, and surfactant in over a thousand cosmetic products including shampoos, toothpastes, lotions and creams. It may be labeled "natural," but it's not. And it is produced synthetically and is hardly ever made from coconut oil (even when the label says it is).

In a world with so many artificially produced ingredients, it would be difficult to completely abandon all our fave products. But what we can all do is educate ourselves and eliminate or cut back our everyday bad products and replace them with natural and 100 percent ECCO certified organic ones. Do your research and know what's on the label.

Let's Talk Painted Floors ...

Let's talk painted floors...

There is an infinite amount of possibilities with painted floors. Stenciling, bordering, faux finishing (e.g., have an area rug painted). You can also border or faux finish over an existing wood floor.

Just about any flooring surface that is in good shape can be painted. Wood, concrete, ceramic tile, sheet vinyl, vinyl

This also applies to a commercial space.

Wood floors should be sanded before a primer is applied. Pick up a primer/sealer paint; this will hide the wood grain and any visible defects in the floor. A compatible sealer should be listed on the paint you select.

It is not the paint itself that resists the wear and tear of foot traffic. You have to apply a clear urethane. Once the paint is dried, give it two or three days, then apply three coats of a water-based urethane. Make sure to get a nonyellowing type; it should be on the label.

Urethane is a durable material that creates a very hard surface which will protect the floors. If a surface is not protected with a urethane, it will become very dingy in a short

To maintain a shiny finish, I would suggest applying a coat of urethane every couple of years.

For vinyl and tile floors, make sure to remove any mildew. You can lightly sand to create a rough surface. This will help the paint adhere. Apply a primer/sealer as you would for a wood floor.



Saint Emeric of Hungary

Prince Saint Emeric of Hungary was born in Veszpre'm, Hungary, in the year 1007. He was the only son of King Stephen I, the first Christian King of Hungary, and wife Gisella. Stephen was a Magyar (Hungarian) and Gisella was Bavarian. Emeric was the last child born of their marriage and the only one to survive infancy.

From the age of 15 to 23, Emeric was educated in a strict and ascetic spirit by a Venetian Benedictine monk, Gerard Sagredo, who later became bishop of Csanád. Emeric was intended to be the next monarch of Hungary, and his father worked diligently to prepare him for this task.

Emeric was destined to inherit the traditions of his ancestors, which on his maternal side were those of the German rulers of the Holy Roman Empire, and on his father's, the equestrian nomad tradition of the Magyars. When Emperor Conrad II planned to dis-endow the diocese of Bamberg, he proposed to give Prince Emeric an interest in the spoils, but his father Stephen would not allow this to happen. A written segment of Stephen's parental instructions to his son has been preserved in a text called "The Paternal Ten Commandments". They are listed as follows: 1. Live your religion. 2. Respect the Church. 3. Honor the Bishops. 4. Respect the positions and persons in government. 5. Be patient and make best judgements. 6. Be cordial toward foreigners. 7. Accept good advice. 8. Use the wisdom and experience of your ancestors. 9. Possess the habit of prayer. 10. Perform good deeds.

Emetic married in the year 1022. The identity of his wife is disputed. Stephen wanted



to hand over some of his responsibilities to Emeric, but it is not true that he resigned his crown to him. Emeric's energies and attention centered on the Christian faith. He was strongly attracted to the type of spirituality made popular by the Cluny reform, which started in France. Though prevented from joining a monastery, Prince Emeric, in his private life, followed monastic ways, especially vigils before the altar, prayer and self-discipline. His zeal for the faith was exceptional.

Stephen's plans to have his son succeed him were never fulfilled. On September 2, 1031, at age 24, Emeric was killed by a boar while hunting. It is assumed that this happened in Romania. He was buried in the Székesfehérvár Basilica. Several wondrous healings and conversions happened at his grave. On November 5, 1063, King Ladislaus I unearthed Emeric's bones in a large ceremony, and Emeric was canonized by Pope Gregory VII for his pious life and purity along with his father and Bishop Gerard of Csanád. His feast day is celebrated on November 5th.

The Art Thieves



The Stolen Artworks

The night of March 18th, 1990, started out normal enough for Richard Abath, a security guard at the Isabella Stewart Gardner Museum. St. Patrick's Day parties were dying down around midnight when Abath started doing his rounds in the museum.

At the time, Abath had recently dropped out of the Berklee School of Music and was a hardpartying 23-year-old trying to finance a music career through security work. He was hired as the museum's night guard in 1988 and often arrived to work stoned or drunk. However, it got to be too much, and by March 18th, Abath had already given the museum his two-week notice. If there was anything unusual about his procedure that night, it only appeared so in hindsight to other museum workers. At around 1 am, after switching places with the desk guard, Abath opened and then quickly shut the Palace Road door. Abath would later claim that this was the way he had been taught to make sure the door was truly locked, a point that would become crucial in his defense when he would become involved in the largest art theft in history.

At around 1:24 am, Abath's night would turn from routine to infamous. Unseen by Abath and the other guard on duty, two men emerged from a red Dodge Daytona that had been parked outside the museum entrance since midnight. When they rang the buzzer on the museum door, Abath realized they were Boston Police officers. They claimed they were responding to a disturbance in the area and, since a loud and boozy St. Patrick's Day party was going on in an apartment nearby, this wasn't hard to believe. The museum did have a policy about letting in visitors after hours, a policy that Abath knew.

"I know I wasn't supposed to let strangers into the museum after hours, but no one told me what to do if the police showed up saying they were there to investigate a disturbance," Abath told the *Boston Globe*. "What was I supposed to do?"

Indeed, a few weeks earlier, a panicked pedestrian had approached the entrance after hours pleading to be let in,



claiming someone was trying to hurt him. The guards on duty that night knew not to let him in, offering instead to call the police for him. Once calling the police was mentioned as an option, the strange visitor ran off. In hindsight, this was likely a test of the security system and admission procedure after hours. However, the Isabella Stewart Gardner Museum was lacking in security measures, a fact well known to the guards. The reasons for a defined protocol were obvious, especially since the year before the neighboring Museum of Fine Arts had set precedent by updating its security system with clearly defined guidelines, eliminating gray areas. Among the shortcomings of the Isabella Stewart Gardner's security system was having only one panic button located behind the desk. This would prove detrimental after







consequently he was forced to construct a prison in the heart of Rome, and it was named 'Carcer." It was constructed about 12 feet below ground and lined with stone blocks. The only entrance was through a hole in the ceiling. Prisoners were tightly bound and lowered into the chamber by ropes. Executioners descended by ladders to perform their countless butcheries and slow tortures.

According to a tradition of the Roman Catholic Church, St. Peter and St. Paul were imprisoned here during the later reign of Nero, and the Church also declares that a spring which still exists sprang up miraculously for the baptism of jailers by St. Peter. The structure was therefore named S. Pietro in Carcer. Ancus Marcius died after a reign of 24 years and was in no way inferior to his predecessors in peace or in war.

On this date, May 20, 1994, President Clinton signed a law making it a federal offense to block access to abortion clinics. And also on this date, in the year 1506, Christopher Columbus, Genoese navigator, passed away.

So what's new? Security guards ordered 50 students from a North Carolina middle-school choir visiting the 9/11 memorial in New York to stop singing the national anthem because singing is considered a "public demonstration" and requires a permit. "Some of the students were very upset," said their teacher, Martha Brown, "singing was their way of showing respect."

An alleged robber tried to flee a Washington, D.C., crime scene by climbing over the White House security fence. Secret Service agents quickly grabbed him.

Achtung! President Obama's visit to Germany was a valentine to his ally Chancellor Angela Merkel. The chancellor is facing fierce criticism at home for opening Germany to one million refugees last year, and Obama went out of his way to praise her.

Wedding bells! Former Pennsylvania Senator Harris Wofford will marry a man 50 years his junior, two decades after the death of his wife. "I don't categorize myself based on gender of those I love," Wofford, 90, wrote in a New York Times op-ed. "I had a half-century of marriage with a wonderful woman, and now I am lucky for a second time." A Democrat who served as an advisor to President John F. Kennedy and Martin Luther King, Jr., Wofford was 75 when he met Matthew Charlton, then 25. "We both felt the immediate spark," he says, "and as time went on we realized that our bond had grown into love."

Two days after his death unleashed an international outpouring of grief, Prince was cremated and remembered in a small service for family and friends at Paisley Park, his suburban Minneapolis estate. The final storage of his ashes will remain confidential.

Ready for this! A 10-foot-high statue of Hercules in the French town of Arachon has been fitted with a removable penis to thwart vandals, who've been stealing the mythical hero's member. The towering statue has been castrated numerous times since it was erected in 1948. To protect Hercules' manhood from hoodlums, town officials have now commissioned a removable prosthetic that will be attached to the statue's groin for special ceremonies in the park — and removed right after. "I wouldn't want anyone — not even my worst enemies — to go through what happens to this statue," Mayor Yves Foulon said.

Suzette Charles, born Suzette De Gaetano, was the first Italian-American to win the Miss America title as the second runner-up, replacing Vanessa Williams in the contest.

Maria Teresa Cafarelli de Francisi was the model for "Miss Liberty," which appeared on the one dollar silver coins that circulated in the U.S. during the 1920s and 1930s. The coins are now valued at about \$100 each. (Her husband. Antonio de Francisi, was the coin's engraver. He emigrated from Palermo in 1903 at age 16.)

Reminder: Artist Georgia O'Keefe was of Italian descent. Her mother was Ida Totto and the artist was named for her maternal grandfather, Giorgio Totto, who was born in Italy.

Celeste Lizio, who came to America during the 1930s and opened a restaurant with her husband in Chicago, founded Mama Celeste's Pizza, and a line of frozen Italian foods that she later sold to Ouaker Oats.

Our great musicologist Al Natale, reminds us, the songs "Chattanooga Choo Choo," "Lullaby of Broadway," and "An Affair to Remember" were some of the songs written by Harry Warren, born Salvatore Guaragna. Yes, an Italian-American!

veal and cabbage stew

1 1/2 pounds veal shoulder chop 1 small cabbage

1 medium onion chopped

3 small garlic cloves chopped

2 ripe tomatoes

4 small white potatoes

3 carrots

2 pieces dried bay leaf

4 whole cloves

1/4 cup canola, vegetable or olive oil

1/2 cup minute or regular rice

(optional) Salt

Heat oil slowly in saucepan before adding veal shoulder to sear on

both sides. Remove meat from saucepan and set aside on a platter. Add chopped onion and chopped garlic to saucepan and simmer until onion is opaque. Do not burn garlic. Add chopped fresh tomatoes or ten ounces canned crushed tomato. Stir, cover and simmer for about ten minutes.

Meanwhile, peel potatoes and carrots. If potatoes are large, cut into two-inch portions and set aside. Cut carrots into two-inch portions and set aside separately. Remove spoiled outer leaves of cabbage. Cut cabbage in half. Cover one-half with plastic wrap and store in refrigerator. Cut second half into three portions, wash and set aside.

Add veal to the saucepan. Cover and simmer about five minutes. Add carrots, bay leaf and whole cloves to the saucepan. Stir, cover and simmer slowly about ten minutes. Then add potatoes to the mixture. Place cabbage portions over potatoes and carrots. Spoon the tomato mixture over cabbage. Add a little water if needed. Cover and simmer until meat and vegetables are fork tender. Salt to taste. Remove bay leaf before serving. Serves two.

OPTIONAL: Cook rice of choice according to directions on the package. Serve rice plain or with some tomato mixture over it. Then add a serving of meat and vegetables to the platter.

NOTE: I loved watching Mama create different recipes during the years. Now I encourage others, including my children, to be creative and vary meats and vegetables in recipes. For instance, this meal can be prepared using Italian pork sausages or shoulder pork chops in place of veal shoulder. The meat used in preparing this will determine the flavor of the stew.

The cops told Abath that there was a warrant out for his arrest and to step away from the desk (and, consequently, the only panic button in the building). Abath did so, thinking it was all a big mistake, when one of the officers handcuffed him. According to an interview he gave years later, this was the moment Abath realized the two men he let in were not cops at all, but robbers. For one thing, they had frisked him and, on closer inspection, he noticed one of the officers' moustache was made of wax. His conclusion was confirmed when the second security guard appeared and was also hand-cuffed. At this point, the robbers admitted that they weren't being arrested but the museum was being robbed. The guards were then taken to the museum basement where they were tied to the pipes and their eyes duct-taped while the thieves ransacked the museum.

In all, the burglary took a little over eighty minutes. But by the end of it, thirteen works of art were taken: three works by Rembrandt (including his only known seascape, The Storm on the Sea of Galilee), five by Degas, and works by Vermeer, Manet, and Flinck. Altogether, the works carried a value of \$500 million dollars.

In the twenty-six years since the Isabella Stewart Gardner Museum theft, many theories and leads have emerged, but the thirteen works of art are still missing and the mystery has only deepened. Abath still carries with him the cloud of suspicion which he has tried to dispel for almost three decades.

Who was behind the theft and what was done with the paintings after? Evidence appeared suggesting the thieves were part of a criminal ring operating on the East Coast and rumors emerged that in the early 2000s someone tried to sell a number of the paintings in Philadelphia, but little else has been said about this clue.

Also, it is clear that the thieves knew what they were doing; they turned off cameras and had a working knowledge of the museum. But they were clearly not professional art thieves, given their rough handling of the paintings (they cut the paintings out of the frames, leaving shredding from some on the marble floors) and leaving behind some of the museum's most valuable pieces like a Michelangelo and the museum's most valuable piece, Titian's Rape of Europa.

Because the artwork may have crossed state lines (something the FBI all but confirmed in 2013), the FBI took over the case. However, this may have ultimately hurt the investigation as local authorities were more familiar with Boston's criminal activity at the time.

However, one determined reporter on the case, Stephen Kurkjian, has done some digging of his own and came forward with a story in his book about the case, Master Thieves. He believes the paintings were stolen by Bobby Donati as a bargaining tool to get his mob boss, Vincent Ferrara, out of jail.

Another lead was discovered by the FBI. Robert Gentile, who doesn't rank as high as Ferrara in the criminal hierarchy, was rumored to have a few of the paintings at his home in Connecticut, but nothing was found.

And so the mystery continues and deepens with each passing year. To this day, the empty frames still hang at the Isabella Stewart Gardner Museum in the hopes that one day, somewhere, one of the missing artworks will show up.

Last week I finished the story about Uncle Gus and was asked by several readers if I would continue with the story of that 1972 trip to Italy. With your permission, I will continue with the events of the next couple of months, including the fun and the learning experiences that I had.

When we left Palermo to head to Sal's parents hometown of Canicati, a suburb of Agrigento, which is located on the south coast of Sicily, Uncle Gus finished his story.

About 45 minutes into the drive south, I commented on my thirst and the fact that the temperature must have been around 100 degrees Fahrenheit (38 degrees Celsius). Sal's father mentioned a natural spring located en route and we could get a drink there.

I followed his directions getting off the main road just south of Corleone, (a name that would be made famous later that year when *The Godfather* was released).

I followed a dirt road as directed, and within a mile or so, there it was a natural spring with a pump-handled faucet sticking out of a covered well. There were several boxes of cups lying around for anyone's use. I stopped the car, jumped out first, and headed for the pump handle with a clean cup in my left hand. Just as I reached down to pump the handle to obtain water, something or someone grabbed me from behind. I reacted instinctively, spun around and was ready to confront my assailant. It was a good thing I stopped in my tracks. In front of me was an elderly man about five feet tall, wearing what looked like a state police officer's hat, a red and white neckerchief tied on the side of his neck, and a pair of overalls. He was holding a piece of rope with a small donkey at the other end. The translation of his comment was, "Sir, what the hell are you doing, my donkey was ahead of you.'

When Sal and the two older men heard this as they approached me, all were laughing loudly at my situation. We all waited for the donkey and the little old man to have their fill of the ice-cold water, and then it was our turn. Once Sal's father stopped laughing, he said to me, "You are in Sicily, not Boston. Here they think in rhetoric, not logic."

A half hour later, I saw another face of Sicily. After the well incident was behind us, the older men climbed into the back seat of the FIAT and I continued on my southerly route. I slowed down when I saw two policemen standing on my side of the road, one with a stop sign in his hand. I slowed down. pulled over, and waited for the two men to inspect the outside of the car. When they came over to the driver's side, one of them asked me for my driver's license and "the book." I gave him my license and Sal pulled the rental agreement from the glove compartment. The officer threw both the license and rental form in my face, shouting that I needed an Italian or international license to drive in Italy. He added that he didn't read English and my license was not good enough. I had Sal explain that Italian law stated that any American license was acceptable, and then asked about the book he was looking for. The policeman pointed to the glove compartment and demanded to see the book. At this point, the other officer was ready to pull out his gun. Uncle Gus, who had become quite upset with the two officers, yelled, "That's enough," and he and Sal's father flipped open their wallets and held them out the left rear window for the two men to see. I don't know what they had for IDs, but the two cops snapped to attention and waited for Carmelo and Gus to exit the car, a bit of a project seeing they were wedged into the back seat.

When they were nose to nose with the two policemen, Gus

did the talking, "First of all, this isn't Fascist Italy. Second of all, how dare you treat people in this fashion, throwing credentials in their faces. The driver is the son of an American diplomat on holiday in Sicily visiting family. His American license allows him to drive anywhere in the country, or aren't you aware of our newer laws. Third, what the hell is the book?"

For the next few miles, everyone was silent. I was the first one to say anything, and it was, "Hey, Uncle Gus, you guys must be important, considering the way those cops reacted." He, still upset, shouted back, "Son, we used to be, back in the day."

Sal's mother, Maria, kissed me on both cheeks and stated that dinner would be ready within a few minutes. Then she asked me how the trip was, how my family was, and whether I liked Italy so far. I laughed at the fact that the dinner arrangements were more important than anything else. But, this was Italy and that's the way things were.

After dinner, all of us went for a walk. I enjoyed the people I met who greeted us calling Carmelo and Gus, Captain Meli and General Faldetta. It was a level of respect and a reflection of the old days. Later that night, just as I was falling asleep, I heard Sal's mother on the phone saying, "Yes, I will bring the professor to your house after breakfast." Walk Like a Boxer



Schmeling and Louis weighing in.

There was a time when you could tell a man was a boxer just by seeing him walk. You might be in a restaurant or hanging out on a street corner when a guy would walk by and you could see in his step that he had spent time in the ring. I'm not talking about a fighter who may have taken too many punches and was "walking

on his heels." I'm talking about the light step that most boxers possessed in the days before they were trained to bulk up using weights and musclebuilding. A well-trained and conditioned boxer was always thinking about staying loose and limber. Even years after retiring, you would see that same agile way of moving in a former boxer. (I'm not sure former boxer is an appropriate term as it is something that, once you have done it, stays in your blood all of your life.)

"Stay away from the weights" was a line heard often from the old-time trainers, "They only make you tight and slow." Back in the days when boxing was taught as an art and not a strong man contest, speed, accuracy, and staying loose were emphasized. "Speed beats power," "If you are too tense you will be more susceptible to being knocked out," "Get up on your toes and move," "Stick and move," I can still hear these words echoing

in my head from my days in the various boxing gyms I trained in.

Now, many people may think I am just talking about the stick-and-move boxers, but you will see this in the vast majority of boxers regardless of their style. The ferocious Jack Dempsey moved like a cat stalking his prey. In the Willard fight, he is darting in and out. His body is lean and not muscle-bound. He has a boxer's physique, strong in all the right places without being encumbered by bulging muscles that would only slow him down.

When I was young, I got to meet Dempsey in NYC. To this day, I remember seeing him walking through his restaurant to greet visitors. He was up there in age and suffering from arthritis in his hips, but he still moved as if he were gliding across the floor, ready to move left or right and throw a counterpunch. Jack Dempsey still had it.

Today's boxers are missing out on so much with the focus being on building up muscle. Weight trainers are brought in and muscle is layered on. While a fighter has to be strong, there are different types of strength. So often nowadays. the spectacle that takes place at the weigh in before a match looks more like a pose-off at a body building competition, with the fighters tensing and pumping up their muscles while mugging it up for the cameras. These bulky muscles are not only useless in the ring, but they are actually a hindrance as they make it almost impossible to use proper punching technique. It also results in more arm punches being tossed

than shots that come from the hips with the full force of the body behind them. Of course, fighters are also more susceptible to being knocked out because of how tight they are. It is much more difficult to "roll with the punches" when carrying that kind of muscle. Of course, that is pretty much a moot topic seeing that fighters are no longer taught defensive moves.


I recently watched a brief video of Jake LaMotta training for a fight. It showed him climbing the stairs up to a gym in New York City where he was working out. Now Jake is hardly remembered as a dancing master, but you can see how light he is on his feet as he bounds up the steps. After the workout, he is seen outside walking down the street. If you had no idea who he was, you would still know he was a boxer by the way he was moving along the sidewalk.

Why the difference between those fighters from earlier days and the boxers of today? Well, when you went into a gym in years back, you would see fighters shadow boxing, moving in front of a mirror practicing their form, stretching and shaking out their arms and legs. They were very focused on staying limber. When they would hit the heavy bag they would "work it," which meant boxing it. Instead of just standing in front of the bag, they would circle it and practice footwork as well as punching. In the older gyms, there

was usually space around the bag so the fighters would have room to do this. In many gyms today the bags are lined up close to each other. Now, you often see fighters just standing flatfooted in front of the bag, their feet planted while they are winding up with punches that are telegraphed as if they were being sent by Western Union. It's no wonder that is happening, since most of the time they spend working with a trainer is wasted while going through the silly mitt punching routine that reinforces these bad habits.

A good boxer has to know how to use his entire body. He needs the grace of a ballet dancer combined with the reflexive power of a trip hammer. Most importantly, he has to be taught how to think in the ring, not to just go through mindless motions. Think, stay loose, find rhythm, treat the sport like the art form it once was.

When I was a young boxer, I hated doing road work. Today it is called running. Most of us disliked it back then, but knew it was important, so we did it. As much as I hated it, whenever I saw a clip of Muhammad Ali out on the road, it inspired me to go out and put in a few miles. Why? Because Ali encompassed why it was called "road work. He would be running with a step as light as Bill Rogers, turning while he moved, running backwards and forwards while throwing punches, all the time staying loose. It was beautiful watching him move. I'll bet he never lifted a weight in his entire life, but he had the kind of strength a great fighter possesses.


