On Sunday, May 3, 2015, nearly 300 guests packed the ballroom of the Wyndham Boston Andover to celebrate the second annual Massachusetts Education and Law Awards breakfast.

The Commission for Social Justice honored three longtime public servants for their outstanding dedication and service to their communities. The Justice Award was given to The Honorable Robert B. Calagione, First Justice of the Milford District Court since 2004, and Associate Justice of the Westborough District Court since 2001. The Law Enforcement Award awarded to Woburn Police Chief Robert J. Ferullo Jr., a 35-year veteran of the Woburn Police Department, and Chief since 2011. The Public Service Award was granted to The Honorable Joseph A. Curtatone, Mayor of Somerville since 2003.

Commission for Social Justice Chairman Albert A. DeNapoli, Esq., spoke on the continuing work of the Commission on a state and national level, as there are still many instances of dis-

crimination that affect the Italian-American community. He noted that the presence of the three distinguished recipients of this year's awards is proof of the positive impact Italian Americans have on our communities.

The Scholarship Commission of the Grand Lodge of Massachusetts awarded a total of 31 scholarships to high school seniors pursuing degrees in majors such as engineering, education, journalism, business, and science. The students come from the tops of their classes and are involved in numerous national honor societies, extracurricular activities, and volunteer organizations.

Scholarship Commission Chairman Donna Giuliani touched on the numerous and varied accomplishments of the scholarship recipients, and noted that they are well poised to become leaders in their chosen fields and communities as they progress through the next level of their education. Liaison to the Scholarship Commission and State Trustee Mary Ann Bello

praised each recipient as they were presented with their awards, noting their individual successes and their college institutions of choice. Charitable and Educational Trust Chairman Angelo Rossi was on hand to present the awards, 20 of which are given through the Trust directly.

Massachusetts Lieutenant Governor Karyn Polito, who served as Toastmaster for the event, spoke about the positive effects of her upbringing in an Italian-American home, and the values that were instilled in her that inspired her to commit to a life of public service.

In her remarks, State President Carmelita Bello acknowledged that the two Commissions that are part of the event have long, rich histories of recognizing the talents and accomplishments of Italian-Americans, and of giving back to the community. She noted that over its 101 year history, the Grand Lodge has raised and given over \$7 million to various charitable endeavors,



#### **CUPID AND PSYCHE**

Psyche was a maiden who personified the human soul. Her story was beautifully told back in the second century A.D. by Lucius Apuleius, more commonly known as Apuleius. He was born in Africa, into a wealthy family, and this permitted him to travel to Athens where he spent a considerable amount of time studying the work of Plato. Apuleius also lived in Rome for many years following his classical studies and became actively engaged as an advocate. He returned to Africa fairly early in his career and married a wealthy older woman. After he was charged with using magic to win the rich widow's hand, he replied with much wit in an oration called "Apologia," which has since become quite famous. Subsequently, he traveled throughout Africa delivering lectures and orations. His most famous literary work was "The Golden

# **State Representative Madaro**

**Budget Amendments** Net East Boston \$220,000

He's young, he's handsome, articulate and ambitious. He won his first election at the age of 26 by an impressive margin. I'm describing newly elected State Representative

I had the pleasure of interviewing Madaro recently who was eager to speak of his plans for East Boston. Since being sworn in, Madaro hit the ground running, submitting three budget amendments for East Boston and receiving a whopping \$220,000 dollars.

Twenty-five thousand will go to the State Police to patrol Constitution Beach. One-hundred and twenty thousand will go to Project Bread for low income children to receive healthy nutritious meals and seventy-five thousand is slated for the East Boston Neighborhood Health Center for 24-7 emergency substance abuse counselors.

Madaro is full of ideas for the betterment of East Boston, and intends to work hard towards that goal. His thought for housing is to have more middle-class housing be built, and build up Eastie's economy. He explained "Roseland Project has broken ground, New Street housing rentals will be market price, and with the completion of the waterfront, great things are expected for East Boston. More open space is being planned, Piers Park Phase II will become an active park, and we are moving forward. I expect East Boston to be just as successful as South Boston, Charlestown, and the West End," he added.

Asked of some of his achievements throughout the years, he answered "I wanted to give East Boston High School students the same opportunity given me at Boston Latin to help cultivate the future leadership of this community, so I founded the "Mario Umana Public Service Fellowship." I have also served on several non-profit boards; President of the East Boston Harborside Community Center, Vice President of the YMCA etc.

Madaro's mother, Debra Cave was born in America, while his father, Jacopo was born in Venice, Italy. They met in Venice while she was vacationing there with a friend. They fell in love, got married and resided in East Boston. Madaro learned at a young age his mother's devotion and involvement to the community, which inspired him to follow. It began for him at Boston Latin High School in his junior year when he got his first taste of public service through a "Ward Fellowship," and interned at City Hall for Jim Hunt, Chief of Environmental Services. Madaro furthered his education at Tufts University majoring in Anthropology and Child Development. As a junior at Tufts, Madaro interned in Washington D.C. for U.S. Senator Kirsten Gillibrand from New York. As a senior in College, Madaro was given the opportunity to work with State Representative Carlo Basile as his only legislative aide. Madaro spent four and a half years working with Representative Basile while he finished his undergraduate degree, went back to Tufts and got his Masters in Public Policy and Urban Planning. At that time Madaro went from being Basile's aide to chief of staff.

When asked who was the first person he campaigned for, he said, "Sal LaMattina's re-election campaign." Madaro wanted it known, if it weren't for Carlo Basile's friendship he wouldn't be in the State House today, adding "I am grateful to the voters of East Boston for giving me this opportunity to represent them. I love doing so, and promise to perform to the very best of my ability.'

When asked about his successful campaign, he credited Liana LaMattina, his campaign manager, and knocking on neighborhood doors. He proudly said, "she ran an incredibly strategic campaign. We worked hard and here we are." Since the election Miss LaMattina was appointed his legislative aide. The final question was about his relationship with House Speaker Bob DeLeo; to that he answered, "Great, he is a fellow Boston Latin High School graduate."

Madaro concluded, "The best is yet to come for East

Boston.'

#### Court to Settle State House Fued

Apparently, House Speaker Bob DeLeo found it necessary to turn to the Supreme Judicial Court to decide a battle over taxes between DeLeo and Senate President Stanley Rosenberg. The Speaker moved last week after the Senate passed its version of the new budget due to the Senate's spending plan and a decision to freeze the state income tax rate. DeLeo wants the Court to decide if such an action is constitutional. On this issue DeLeo is right on the mark.

This is not the first time that both the Speaker and Senate President have clashed and probably won't be the last.

When you have two co-equal wings of the Legislative branch of government at odds and the issue can't be settled between them, then the Judiciary branch route is the only route open to end the impasse.

At issue is the requirement that all so-called money bills start in the House, not the Senate. DeLeo is arguing the Senate can't make its own changes in its version of the budget. Rosenberg disagrees and in a move to help pay for the expansion of the state's earned income tax, the Senate moved to permanently freeze the income tax at 5.15 percent.

However, there is a current law on the books passed by the voters in 2000 that would push the income tax rate to drop to 5 percent. DeLeo said the House budget includes no new taxes and, like many others, believes freezing that tax rate is the same as raising

The state's highest court will take up the issue in early June since the state budget must be set by July 1st for the start of the 2016 fiscal year.

Too bad the issue couldn't have been decided within the House, but on the issue itself, Speaker DeLeo had little choice but to let the Court decide if the Senate's action violates the state constitution. DeLeo thinks it does, I think it does and mostly likely the Court will think so too.

Sometimes the obvious is very obvious.

## ,Anna Maria Marchione Pace

Anna Maria Marchione Pace, 76, of Montesilvano, Abbruzzo, Italy passed away April 26, 2015 in Pescara, Italy (Hospedale Civile Di Pescara).

A Memorial Mass will be held at St. Leonard's Church in the North End of Boston on Saturday, May 30, 2015, at 5:00 pm.

Anna Maria was born May 24, 1938, in Pescara, Abruzzo, Italy along the Adriatic Coast.

In 1953, at the age of 14, she immigrated to the United States and settled in the Boston's North End with her father and mother, Tridio and Olga, and sister Elisa.

Anna Maria followed her passion for music and became a prominent Italian radio show host. She promoted Italian culture in the Boston area for many years with countless festivals and galas, with simple beginnings in early '70s of the "Bandiera Gialla" dances at Orsogna Plaza in Everett for young Italians. Eventually as Impresario, Anna Maria was responsible for bringing top Italian stars to Boston and surrounding areas. Anna Maria was also successful as a real estate agent, and in the late '70s she opened the Waterfront Travel Agency on Hanover Street, catering to the needs of the Italian community.

Anna Maria organized many fundraisers, and with the help from her radio audience



raised thousands of dollars to help the poor, the suffering, and victims of earthquakes in Italy. She received praise and thanks from officials of the affected areas, and in 1977 received the Italian Solidarity Star from the president of the Italian Republic Giovanni Leone. The Consul General of Italy in Boston, Di Bruno, was appointed to present Anna Maria with the "Cavaliere" decoration.

The Anna & Tony Pace Radio Show, WLYN-FM, eventually became the biggest Italian radio show in the greater Boston area. With over three decade in

the broadcasting business, Anna Maria had become a household name for Italian immigrants

Anna Maria retired in 1997, and with her husband, Tony, relocated to Montesilvano, Italy to be close to their daughter and family.

Anna Maria is preceded in death by her parents, Tridio and Olga.

Anna Maria is survived by her husband Tony Pace; daughter MaryAnn and son-in-law Franco Olivieri of Montesilvano, Italy; granddaughter Alexia Olivieri; and her sister Elisa Marchione Gennari of Boston.

## Of Course Jeb Bush Would Have Invaded Iraq

The Former Florida Governor Gets Too Much Credit for Being Smarter Than His Brother by Donald Kaul

Jeb Bush must have set some kind of record for political flip-flopping this month.

"Knowing what we know now," he was asked — that Saddam Hussein didn't have any weapons of mass destruction, for example — "would you have authorized the invasion" of Iraq?

"I would've," he said.

Almost immediately, the oatmeal hit the fan. Supporters and critics alike jumped up out of the weeds protesting his embrace of what many consider the greatest foreign policy blunder since Hitler invaded the Soviet Union.

Before nightfall that day, he was backing crab-like away from that position. He had "misinterpreted" the question, he said. In any case, it was futile to take up "hypotheticals" like that.

But back he tracked until it seemed as though the former Florida governor would've been marching in front of the White House, occupied at the time by his own brother, with a "Hell No! I won't go" placard.

The kindest interpretation friendly critics offered was that Jeb Bush was reluctant to take issue with George W., who, after all, ordered the Iraq invasion. It was tilial affection, not foreign policy naiveté that informed his first response.

Are you kidding me?

Of course Jeb Bush would have done the same thing as George W. Bush. There's hardly the thickness of a sheet of paper between them on Middle East policy.

Don't believe me? The man who would like to lead the third Bush administration in three decades named Paul Wolfowitz, the Iraq invasion's architect, to his team of advisers. That's like taking navigation lessons from the captain of the Titanic.

Wolfowitz, you'll remember, is the guy who promised a speedy end to the Iraq War and predicted it would pay for itself with rising oil revenue. That was a trillion dollars - and many thousands of lives — ago. And we're still waiting for our first payment.

I've always thought Jeb got too much credit for being smarter than his brother. That was largely a function of the fact that even though he smoked a lot of pot in high school, he didn't spend his youthful years drunk, unlike George W.

In reality, neither of them has shown

much in the way of smarts. They've gone a long way on family money and friends in high places.

The best of the Bush bunch, to my thinking, is the old man, George H. W. Bush. Not a brilliant intellectual, perhaps, but he was smart enough to know that Iraq's not a place where you want to hang out very long. As bad a guy as Saddam Hussein was, the elder Bush had the sense not to dabble in regime change when he went to war with Iraq.

Perhaps the most astonishing piece of information to come out of this latest Bush flap was a Quinnipiac University poll that showed George W. Bush's favorability rating with likely voters in the Iowa caucus stands at 81 percent.

Eighty-one percent! Chocolate ice cream doesn't have an 81 percent favorability rating among Iowa Republicans.

What can they be thinking of? Certainly they can't be thinking very seriously about the Iraq invasion. Did I mention that it's cost us a trillion dollars and counting?

Perhaps I failed to inform you that our conduct of that war and the other conflicts that seem to have unstoppably flowed from it, with our waterboarding and our drone attacks, have squandered any moral advantage that we claimed over our enemies.

Jeb Bush was the great hope of rational Republicans in the upcoming race. He was the sensible one.

Now we find he hopes to ride his brother's tattered coat tails to victory.

1) Festa della Repubblica (June 2<sup>nd</sup>): In the simplest terms, one can think of la Festa della Repubblica, or "Feast of the Republic," as Italy's independence day, a rough equivalent to our Fourth of July. This feast honors the date in 1946 when, after the turmoil of

World War II, Italians voted on creating a republic rather than a monarchy. Nearly everything — banks, stores, tourist sites, museums — is closed or operates on holiday hours. Instead, Italians celebrate by watching parades and attending outdoor parties or concerts. Expect to see the Italian tricolor flag, with its bright hues of red, white and green, adorning landmarks and waving from people's homes. La Festa della Repubblica appropriately occurs in the summer, when people can take advantage of the lovely weather to go outdoors and show their communal pride in being Italian.

2) Feast of Corpus Christi (June 4th): Corpus Christi, which translates to "Body of Christ," is a religious holiday honoring the Body and Blood of Jesus as present in the Eucharist. Cities across Italy celebrate with processions, such as the one in Rome, which is led by the Pope. However, this holiday is most famous for the infiorate. An infiorata is a festival in which flower petals are used to create marvelous pieces of street art. These gorgeous flower carpets and tapestries boast intricate designs that reflect a lot of skill. The most famous flower festivals occur in the town of Bolsena, north of Rome, and in the towns of Orvieto and Spello in hilly Umbria. What better way is there to celebrate summer than with outdoor displays of brilliantly blooming blossoms?

3) Saint John's Day (June 24th): This is one of my favorite holidays. It commemorates St. John the Baptist, the major religious figure who baptized Jesus, though many traditions originated from the pre-Christian festivities celebrating the summer solstice. In Northern Europe, St. John's Day is known as Midsummer since it falls so close to the summer solstice. People celebrate with rites honoring the sun (the summer solstice) and water (St. John the Baptist): building maypoles, floating garlands of flowers down streams, lighting bonfires. In Italy, this is la Festa di San Giovanni Battista. In the Lake Como region, people float hundreds of delicate lanterns on the lake and later continue the theme of light by enjoying a fireworks display. Florentines celebrate with a medieval tournament, while also holding a procession of rowboats carrying candles drifting serenely along the Arno River. These festivals perfectly capture the magic of the longest night of the year, harnessing the power of the sun and honoring the life-giving qualities of water.

Of course, there are plenty of other ways to enjoy June in Italy. Lots of little festivals, known as sagre, dot the Italian landscape. These small holidays frequently devote their attention to a specific crop, and during the summer that can mean anything from peaches to strawberries to herbs. One of the best aspects of Italian holidays is that they so connect to the rhythms of the Earth, and encourage reflection in the present moment. So no matter how you celebrate, make sure to give thanks for the wonderful month of June and all of the delights it offers!

## Northhampton and Fellows: Life Behind the Signpost

"Welcome to my world of growing up in the 1940s and 1950s. I will keep it light, I will keep it happy, and I will keep it fun. The keeping it fun part is easiest for me, because I have always believed, that's what this whole thing called life should be all about ... having fun!"

Charlie Caizzi, author of "Just So You Know"

As an avid reader and writer, I heard about Charles Caizzi's book about my old neighborhood back when it was home to me and my family in the 1950s and 1960s. The cover shows a photo of the street sign at the intersection of Northampton and Fellows Streets. The sign post looks quite new and I don't remember two (H's) in Northhampton, but we'll let that go.

Over in Roslindale recently, a large group of former St. Philip's parishioners gathered to hear Charlie talk about his book on the old hood and to share memories with all those gathered, myself included.

I did hear about this new book months ago from a writer friend of mine from the South End and was hoping to get a copy of the book, which happened last Saturday morning.

Unlike Boston's West End demise in the late 1950s by the B.R.A. to make room for the New Boston, few outside of its former residents remember Lower Roxbury and St. Philip's Parish, or even knew of its existence. To those who came from there it will always be a great place because our roots were nourished in that collection of streets memorized by heart by all who came from it.

As I listened to the author and folks assembled to talk about the old neighborhood, it seemed very much still to be in the present tense. I travel across Melnea Cass Boulevard often and think of Hunnemon Street, which it replaced. As I look to both the left and right, I have to imagine my old neighborhood because except for a few places like Thorndike Street or the closed Emmanuel House, my neighborhood has become a bunch of beautiful memories. As it should be now I guess. I always knew a neighborhood was more its people than its buildings. For me, the 1950s and 1960s are filled with pleasant memories of days and people gone

The very idea that in 2015, you could get a large crowd together to talk about yesterday and put yesterday's lessons to use today, says something about the strength and values we took from that piece of real estate.

Lower Roxbury died like the

New York Streets area of the South End, almost without notice unlike the old West End which became a lesson for today's urban planners. The same thing that went wrong in the West End happened in the 1960s to the South End and in the late 1960s and early '70s in Lower Roxbury.

Poor and working people got pushed around to create a better Boston or a newer highway. Displaced people are soon forgotten and institutional memories fade, but it was nice to know that the old hood and Catholic parish still exist if only in our dreams and memories of what once was.

For us who came from there, we will be able to envision things as they were, but for other readers from other places, they can still learn about their neighborhood lives growing up through the memories of Charlie Caizzi and the rest of us who share in his memories.

Folks in my old home have moved everywhere since leaving their past behind, but in reality we hold on to and cherish our past because of the strength we grew up with in a time and place that is very much missed in today's fast and furious world where we move too fast to see the things of value we need in our lives no matter how many birthdays we celebrate and no matter how many losses we have suffered since those younger days.

Many from the neighborhood moved first to South Boston and Dorchester and finally down to Quincy, Weymouth and the South Shore. Others to Roslindale and West Roxbury or in my case to either Somerville or East Boston. But all of us carry Lower Roxbury and St. Philip's Parish in our hearts and souls and will forever.

Finally, Charlie is right about humor, without which, we could all be driven to Mattapan, as in you know where. Thanks, Charlie, for the memories you share with readers of this book. We need them to keep our sanity in these crazy times we live in today.

With a strong anchor in life, we will survive and hopefully laugh much along the way.

## Saint Dunstan

Saint Dunstan, patron of armorers, goldsmiths, locksmiths, and jewelers, is a saint who is very close to the two of us because of our long careers in the jewelry business and membership in the ancient Guild of the Worshipful Company of Goldsmiths in London.

Saint Dunstan, Archbishop and confessor, was born at Boltonsborough, near Glastonbury, England, in the early tenth century. His father, Heorstan, was a West Saxon noble, Cynethryth, his mother, lived a saintly life. Dunstan was committed, in his youth, to the care of the Irish monks of Glastonbury Abbey. He was a very bright student who enthusiastically absorbed his studies and had great skill as a craftsman. Indeed, throughout his life he was noted for his devotion to learning and for his mastery of many metal crafts. With his parent's consent he was tonsured, received minor orders and served in the ancient church of St. Mary. While still a youth, he was sent to the court of King Athelstan. He became a Benedictine monk about 934 and was ordained by his uncle, St. Alphege, Bishop of Winchester, about 939.

After living as a hermit at Glastonbury, Dunstan was recalled to the royal court by King Edmund, who appointed him abbot of Glastonbury Abbey in 943. Dunstan developed the Abbey into a great center of learning. He became advisor to King Edred his accession to the throne and began a far-reaching reform of all the monasteries in Edred's realm. Dunstan also became deeply involved in secular politics and incurred the enmity of the West Saxony Court for denouncing their immorality and for urging peace with the Danes.

When Edwy succeeded his uncle Edred as king in 955, he became Dunstan's bitter enemy for the Abbot's strong censure of his scandalous lifestyle. Edwy confiscated his property and banished him from his kingdom. Dunstan went to Ghent in Flanders.

Count Arnulf I, received him with honor and lodged him in the Abbey of Mont Blandin. He was soon recalled when a rebellion replaced Edwy with his brother Edgar, who appointed Dunstan Bishop of Worcester and London in 957. When Edwy died in 959, the civil strife ended and the country was reunited under Edgar, who appointed Dunstan Archbishop of Canterbury.

Dunstan was appointed legate by Pope John XII, and with St. Ethelwold and St. Oswald, restored ecclesiastical discipline, rebuilt many of the monasteries destroved by the Danish invaders, replaced many inept priests with monks, and enforced the widespread reforms they put into effect. Dunstan served as Edgar's chief advisor for sixteen years and did not hesitate to reprimand him when he thought it was deserved. When Edgar died, Dunstan helped elect Edward the martyr king and then his half-brother Ethelred, when Edward died soon after his election. Under Ethelred, Dunstan's influence began to wane and he retired from politics to Canterbury to teach at the Cathedral school and died there. Dunstan has been called the reviver of monasticism in England. His feast day is May 19th.

## Fitted With New Protective Vest



Suffolk County Sheriff's Department K9 Shadow recently received a stab- and bullet-resistant vest from Vested Interest in K9s, Inc. (VIK9s), a local charity that offers vests and other assistance to dogs of law enforcement and related agencies.

Suffolk County Sheriff's Department K9 Shadow received his new protective vest, thanks to Vested Interest in K9s, Inc. (VIK9s), a local nonprofit organization.

Back in January, the Sheriff's Department was notified by the organization that K9 officer Shadow was chosen to receive the donation of a stab- and bullet-resistant vest. Following a visit to determine Shadow's exact measurements, the vest arrived, perfectly tailored.

Shadow, a two-yearold German shepherd, is certified as a dualpurpose dog in both patrol and narcotics. In 2013, he attended a Boston Police K9 Academy patrol dog class and in 2014, he took top honors at the completion of a Worcester

Police Department's Narcotics Class. The K9 Unit is also an active support component of the Department's Tactical Response Team (TRT).

Shadow's partner, Sheriff's Department Corporal Robert Connelly, had this to say after putting the vest on him for the first time, "This vest is made with state-of-the art materials that offer great flexibility and make it very practical for use on Shadow. Some of the significant features on this soft ballistic and stab armored vest include extended pads for protection of his torso and dual hooks for assisting in trailing and tracking purposes. It even has a special compartment for placement of a flashlight or a beacon for aid during any instance when we are called upon to assist various other law enforcement agencies outside of the Sheriff's Department."

"I can't thank Vested Interest in K9s enough for supporting dogs nationwide with protection vests," he continued. "This vest will come in handy for Shadow while on duty supporting not only the Sheriff's Department, but the entire community."

For Suffolk County Sheriff Steven W. Tompkins, the issue of safety is paramount with respect to Department officers of both the two- and four-legged variety.

"I am grateful for the work that VIK9s does to ensure the protection of our Department K9s and those of other agencies," said Sheriff Tompkins. 

# The Hartford Stage Brushes Up Kiss Me Kate

with a Beautiful Production that is Pleasing to the Eyes, Ears, and Heart

I last saw a production of the Cole Porter musical "Kiss Me Kate" in 2009 in Boston, and I was very disappointed. I left the theatre thinking that perhaps this wonderful play was too dated to go over today. Well, I was greatly mistaken. In the hands of Artistic Director Darko Tresnjak along with Choreographer Peggy Hickey, "Kate" is alive and well and living on a stage in Hartford.

This is the first musical I have seen at THS and I was impressed. With a sixteen-piece orchestra, yes, a real orchestra led by Kris Kukul, amazing sets and costumes, and a fantastic cast, this production of Porter's take on "The Taming of the Shrew" will have you humming "Wunderbar" as you leave the theatre.

Set in a theatre in Baltimore in the late 1940s, the play revolves around an acting company that is staging Shakespeare's "Taming of the Shrew. The actor's personal problems, which include love, gambling, keeping the production financially solvent, and dealing with the leading actors, being a divorced couple who still carry a torch for each other though they try very hard to hide it, all spill over to their performances of the Bard's work.

The back stage scenes are very realistic with a multi-level rehearsal space and dressing rooms. The center of the stage revolves so we can see the entrances to actors' quarters as well as the interiors.

As beautiful as these back stage settings are, your eyes are in for an amazing treat when the scenes turn to the staging of "The Taming of the Shrew." The colors are vivid and absolutely beautiful. The costumes gorgeously detailed. Watching this performance I felt as if I had tuned in to high definition theatre. I don't think I have ever seen as beautiful a setting in all my years

of going to theatre. Multi-level sections are now being used as buildings where the actors open doors and pop their heads out, particularly Kate who uses her perch from above to pelt suitors: Just the thing for the women who proclaims "I Hate Men."

While my eyes were drinking in this beauty, my ears were filled with the pleasure of hearing the wonderful songs of Cole Porter being performed by singers who knew how to put them over, with choreography that matched perfectly. Of course, it is hard to miss with songs such as "Too Darn Hot," "Another Op'nin, Another Show," "So in Love," and "Brush up Your Shakespeare," but this isn't just a bunch of very good singers belting out a few songs. No, this is a group of actors doing justice to this marvelous play.

Even the statue of Neptune that takes center stage for a good portion of the play gets in on the act in the number, "Tom, Dick, and Harry." I won't go into detail, but what would a Shakespeare inspired play be without a touch of the bawdy?

It is too much of a challenge to name all of the actors in this small amount of space, but I can say without reservation that everyone was top-shelf.

If you want to brush up your Shakespeare, your Porter, and your musical theatre, get down to Hartford for this one. This is a *Kate* worthy of a huge kiss.

## Leventhal Map Center Opens New American Revolution Exhibition

## We Are One: Mapping America's Road from Revolution to Independence

Now through November 29th

The opening Sponsors Reception of the Norman B. Leventhal Map Center at the Boston Public Library's new exhibition, "We Are One: Mapping America's Road from Revolution to Independence," was held in the McKim Exhibition Hall and Courtyard at the BPL in Copley Square on Friday, May 8<sup>th</sup>.

The benefit reception was held in honor of the Map Center's founder and namesake, Norman Leventhal, who recently passed away. The "We Are One" exhibition was originally conceived under Norman Leventhal's leadership as a means to tell Boston's important role in the founding of our nation. Norman loved Boston, education, and maps. This show incorporates all of these.

More than \$1 million was raised for the exhibition, its tour to Colonial Williamsburg and to the New-York Historical Society, and related educational programs, through the Sponsors Reception, generous individuals, foundations, government agencies, and corporations.

Nearly 200 family and friends of Norman Leventhal, Map Center supporters and guests, gathered in the McKim Courtyard for the reception and brief speaking program, with remarks from Mayor Marty Walsh, BPL President Amy Ryan, Alan Leventhal (son of Norman), BPL Board of Trustees Chair Robert Melzer, State Rep. Byron Rushing, and Map Center Executive Director Jan Spitz.

After spending more than two years identifying and selecting maps and artifacts, the Norman B. Leventhal Map Center (Map Center) opened the free exhibition We Are One: Mapping America's Road from Revolution to Independence. We Are One explores the tumultuous events that led thirteen colonies to forge a new nation and commemorates the 250<sup>th</sup> anniversary of American colonial resistance to Britain's 1765 Stamp Act, a pivotal moment in the chain of events that led to the revolution. The exhibition features 60 maps and 40 prints, lected from 20 partner institutions, including the British Library, Library of Congress, and private collectors, telling the story of our nation's founding.

exhibition "This change the way people look at the Revolutionary War." said Jan Spitz, executive director of the Map Center. "Many rare and historically significant materials have never been exhibited before; this will be a whole new experience for students, educators, history buffs, and everyone who is fascinated with our country's roots."

We Are One takes its title from Benjamin Franklin's early design for a note of American currency containing the phrase "We Are One." This presaged the words "E

Pluribus Unum" found on the seal of the United States and on all U.S. coins. Using geographic and cartographic perspectives, the exhibition traces the American story from the strife of the French and Indian War to the creation of a new national government and the founding of Washington, D.C. as its home. Exhibited maps and graphics show America's early status as a British possession: thirteen colonies in a larger trans-Atlantic empire. During and after the French and Indian War, protection of those thirteen colonies exhausted Britain economically and politically and led Parliament to pass unpopular taxes and restrictions on her American colonial subjects. The Stamp Act, the Tea Tax, and limits on colonial trade and industry incited protests and riots in Boston, as contemporaneous portrayals in the exhibition show.

When tensions between Britain and her American colonies erupted into war, cartographers and other witnesses depicted military campaigns, battles, and their settings. At a time when photography was nonexistent and art was romantic and stylized, these maps and drawings provide the most accurate pictorial representations of the North American colonies and bring the long, bloody struggle for independence to life.

We Are One also shows how, in the aftermath of the Revolution. America took stock of her new geography with surveys and maps. Durpaintings, and objects se- ing this period, the Founders struggled to craft a new national government that would confederate thirteen colonies with different economic interests and cultures. European maps reflect their success by recognizing America's triumphant new status of nationhood and her expanding territory.

"Our goal is to bring important maps and artifacts to the public, drawing on the extensive collections of the Leventhal Map Center and selected treasures from other institutions worldwide," said Robert Melzer, chairman of the board of the Map Center. "We are tremendously proud of this exhibition, and we hope that anyone with an interest in the formation of this coun-

As a highly interactive part of the We Are One exhibition, the Map Center will launch their new American Revolution Portal. This Portal hosts digitized maps of the Revolutionary War era from nationally and internationally recognized collections, and its magnification technology allows viewers to investigate the rich world revealed in the details of these historic documents. The exhibition features loans from twenty institutions and collectors; eleven are also partners in the Portal. Reflecting the Portal's magnification technology, We Are One zooms in on history by using maps at different scales.

With support from the Massachusetts Foundation for the Humanities, a three dimensional "Liberty Tree" will be installed in the Northwest Corridor of the Central Library in Copley Square. Printed prompts will invite visitors to join a dis-

Reminder. During World War II, an estimated 1.2 million Americans of Italian descent served in the U.S. military, constituting one of the largest segments of the U.S. combat forces of about 12 million. Yes, we were one of them.

The only enlisted Marine in U.S. history to win the nation's two highest military honors — the Navy Cross and the U.S. Congressional Medal of Honor — was an Italian American, John Basilone, a U.S. Marine sergeant, who died at the Battle of Iwo Jima in World War II.

Bella Culo of Chestnut Hill wants you to know Susan Sarandon, Bruce Springsteen, and Ann Bancroft are Italian Americans.

Incredible! Gun violence now costs Americans an estimated \$229 billion a year, including the expense of imprisoning gun offenders, medical treatment for the roughly 31,000 people killed and 75;000 wounded each year, lost wages, and loss of quality of life among victims and their families, according to an analysis by the Pacific Institute for Research and Evaluation. By the same measures, obesity costs less — \$224 billion a year.

The Pew Research Center reported 50% of blacks and only 39% of whites think that poverty and lack of opportunity contributed "a great deal" to the rioting in Baltimore.

We now have learned air pollution shrinks the brain. Most people know that breathing in air pollution is bad for their lungs, but new research suggests fine particulate matter from cars, trucks, and factories could also have long-term effects on the brain. Over time, exposure to levels of air pollution typically found in urban and suburban areas could actually shrink the brain by 0.32 percent — the equivalent of about one year of aging, the study of 943 healthy older adults found. The findings don't prove that air pollution directly causes brain changes, but researchers theorize it may cause inflammation of brain tissues. Living in smogdense areas was also linked to a 46 percent increase in the risk for "silent strokes," which are associated with cognitive decline and dementia. "Long term exposure to air pollution showed harmful effects on the brain even at low levels," study author Elissa Wilker tells Science'Iimes.com. Nearly 60 percent of Americans live in areas with damaging air pollution, says the American Lung Association.

# Parla Come Mangi! (Speak as You Eat!)

Benvenuti! Babà alla napoletana or babà al rum is known worldwide as one of the signature sweet specialties from Napoli, but probably not many of us know that this inebriating delicacy actually traces its origin to Poland. Legend says that, back in the 18th century, Polish King Stanislaus liked pleasing his palate by dunking little pieces of German Gugelhupf cake in rum before eating them. The court baker then developed a recipe for a cake that was pre-soaked in alcohol and ready to eat when brought to the King's table. The King was delighted to the point that he named such cake after Ali Baba from the "Arabian Nights." When the King lost his throne and went to France, the newborn babà became part of French cuisine until it made its triumphal way to the Kingdom of Naples writing a new page in the local culinary history. The colorful Neapolitan expression: "Si nu'babà" is quite the compliment, considering that it means that someone is as sweet or as good as a babà!

#### Babà Alla Napoletana (Serves 6)

#### FOR THE DOUGH

2 1/3 cakes compressed yeast (if using active dry yeast, follow the maker's instructions) 2/3 cup milk 3 cups all-purpose flour 6 eggs, separated ¾ cup + 1 Tbsp. butter, softened 2 Tbsp sugar Pinch of salt Butter for greasing

#### FOR THE SYRUP

2 ½ cups sugar 4 cups water Grated zest of one lemon 2 ½ Tbsp. rum

**Preparation:** Dissolve the yeast in a little lukewarm milk and gradually incorporate the flour. Transfer in a buttered bowl, cover with plastic wrap and leave to rise in a warm place until it has doubled in volume. Put the egg yolks, softened butter, and sugar into a bowl, and beat using an electric mixer at medium speed until the mixture becomes slightly frothy. Beat the egg whites with the salt until stiff. Gradually incorporate the yeast dough into the egg-yolk mixture. If the dough becomes too stiff, add a few spoonful's of beaten egg whites. Grease a 10 ½ - in. diameter Bundt cake mold (or individual babà molds) with some butter, pour the mixture in and leave to rise once more, until it has doubled in volume. Bake in a pre-heated oven at 350°F for about 40 minutes. To make the syrup, dissolve the sugar in the water over a low heat, and simmer gently for about 10 minutes. Leave to cool slightly and then stir in the lemon rind and rum. Leave the cake to cool, then turn it out on to a plate. Spoon the syrup over the cake, including any juice that collects on the plate. Serve the babà alone or with some zabaglione and decorate it with candied cherries and whipped cream. Buon appetito!

Monta le chiare a neve ferma con la presa di sale. Gradualmente incorpora la pasta lievita alla miscela di tuorli. Se la pasta risulta troppo dura aggiungi qualche cucchiaio di albumi montati. Ungi con del burro uno stampo per ciambellone di circa 25 cm di diametro (o degli stampini da babà), versaci il composto preparato e fai lievitare ancora una volta fino al raddoppio del volume. Cuoci in forno preriscaldato a 180°C per circa 40 minuti. Per preparare lo sciroppo, sciogli lo zucchero in acqua a fiamma bassa e fai sobbollire per circa 10 minuti. Fai raffreddare appena, quindi unisci la buccia grattugiata del limone ed il rum. Fai raffreddare il babà, sformalo su un piatto da portata e versaci lo sciroppo caldo su tutti i lati. Servi da solo o con dello zabaione e decora con delle ciliegie candite e della panna montata. Buon appetito!

# Nanna & Babbononno

A Nostalgic Remembrance



The weather has warmed up and my thoughts have turned toward my warm weather hobby, old cars. I have three that, perhaps, some of you might have seen in the Columbus Day parades in Boston, when I was involved. One is a black 1962 Lincoln Continental that I used as the Post-Gazette staff car, and the other is a 1966 Thunderbird Town Landau, and the third is a 1973 Mercedes Benz 450 SL. More about these cars later. I have been aware of automobiles since I was about nine or ten. Before I went to work at the Seville Theater at age 13, I washed and waxed cars in my neighborhood for two reasons: the money and I loved those old cars, their unique designs and the shiny chrome that they all had.

Dad had been driving since he was 16, but to him, cars were a means of transportation; they got you from point A to point B. Before I was born, my father owned mostly Fords. From the early '30s Dad, a bass violin player by trade, would buy cars that could fit his instrument comfortably. When he and my mother were dating, I believe he owned a 1932 Ford two door sedan. He kept this until around 1939 and then bought a two-yearold Plymouth from the local mailman. This grey twodoor '37 Plymouth was the car I first remember as a child.

My most vivid memories of this car are two-fold, going to Uncle Nick's on Saturday nights and the struggles Babbononno would have every time he climbed in that car. Saturday nights were special. Dad would drive Mom and me to Uncle Nick and Aunt Ada's (his first wife) apartment on Kelton Street in Allston.

From there he would head out to play with whichever band he was working with at the time. Uncle Nick would wait for us to arrive and he and Dad, dressed in their tuxedos with starched collared formal shirts and bow ties would leave together to join their respective bands for the evening.

In those days, Boston's night life came to a close at midnight. By 12:30 or 1:00 am, they would both be back with a dozen bagels and the fixin's that go with them. I, most likely, would have fallen asleep during the Saturday evening radio show, Your Hit Parade. When my father and uncle would come back, Toby, Aunt Ada's dog, would wake me up, knowing I would sneak her part of my bagel and cream cheese when no one was looking. When it was time to leave, Dad, who had brought his bass violin into the Allston apartment, would bring it back to the car and re-position it on its back across the top of the seats (years before head rests) with the neck facing the front windshield and the tail peg almost touching the rear window. I would climb in back with just enough room for my head next to the body of the bass and he and Mom would sit in front.

This old Plymouth had the two options that were available back in the day, a radio and a heater. Both would go on after the car was started and Dad would head through the streets of Allston to Commonwealth Avenue, pass the traffic jam at Cottage Farm Bridge (now B.U. Bridge) due to the lack of traffic lights, and continue to Kenmore Square. From there he would head through Boston to the Sumner Tunnel and back home to East Boston. This Saturday event continued from the time I was in diapers through World War II. Even after Uncle Nick joined the Navy, Dad dropped us off every Saturday night. If Mom and Aunt Ada wanted to see a movie at Allston's Capital Theater, Clara, Ada's younger sister, would baby sit me. After the war, Uncle Nick and Aunt Ada went their separate ways and the Saturday night get togethers stopped.

Dad held onto that 1937 Plymouth until 1949. By then it had seen better days, rust spots had been filled in, rips in the fenders had been welded, rips in the upholstery had been sewed up or covered up and the trunk lid with its broken lock was tied to the rear bumper so it wouldn't open and close at will.

On a given day in 1949, Dad brought me and his bass violin to Reese Chevrolet, a long-gone dealership which was located in Day Square in East Boston. The smell of the interior of the cars in that showroom has stayed with me all these years. To me, it is as sweet as the smell of a dozen roses. Dad tried his bass in a two-door

sedan and it fit with no problem. He actually liked the two-door fastback, but the bass wouldn't fit. This meant that the car was out of the question, and the sedan was the alternative. He wanted all of the bells and whistles offered in 1949, full-sized hub caps, a rug on the floor rather than rubber, seat covers, a marbleized offwhite steering wheel, and of course a radio and heater.

This car lasted until 1954. Dad fell in love with a powder blue and white four-door Bel Air sedan, which was the first of his cars that I ever drove. In 1967, he replaced the Chevy with a medium blue and white Pontiac four-door hardtop. This car had an automatic transmission, Dad's first. The biggest feature was the hi-fi radio with four speakers that filled the car with the quality sound of the

Years later, this gave way to a 1962 Chevy which lasted until Dad spotted a white 1966 Cadillac. Beyond this car, most of the others he owned were non-descript. As long as his bass violin fit, he was happy. I bought my first car in 1958 and paid less attention to Dad's cars. But like my father, I had to buy cars that fit a bass violin, as I followed in his footsteps and became a musician playing the same instrument.

Here it is many years later and I still admire those cars of old. As I said, I own three of them. When Loretta complains about them, I come back with, "I don't like golf, I don't play tennis any more, I don't smoke, I don't drink or take drugs, don't chase stray women, damn it, I need something." So, along with my adopted little brother, Dean Saluti, who has the same hobby, I drive old cars on weekends. The only problem is, well, the price of gas and the mileage those cars get, ouch. Just as an example, the 1962 Lincoln Continental is almost three tons. It has a 430-cubic-inch engine with about 390 horse-power. As a result, with a good tail wind and the car heading down hill in neutral, I get about 8 miles per gallon using high test with a can of octane booster and a can of lead substitute added in to the mix. It ain't cheap to drive this car!

I swap war stories about old cars with Dean Saluti who has a 1965 Jaguar sedan and a 1969 MGB roadster and a few newer cars. He loves the British cars, I love the American. The cars we drive every day look like they were stamped out with the same cookie cutters. They all look alike and I can't tell one from another unless I look at the name or an emblem that identifies them. Those cars of old were great and I still love them. GOD BLESS AMERICA!



# HOOPS and HOCKEY in the HUB

All last year he coached a team with 14 NHL draft picks on the roster. What will he do for an encore? Oh, just move on to an upgrade and coach an actual NHL team next season.

Yes, that is what former University of North Dakota Head Coach Dave Hakstol will do as he takes over the Philadelphia Flyers. He'll be asked to somehow attempt to pull off an NHL version of what he did at UND - atraditional college hockey powerhouse that was a perennial postseason presence and frequent Frozen Four participant.

"Dave brings a wealth of head coaching experience and success to the Philadelphia Flyers organization," stated GM Ron Hextall in a press release. "He's a proven winner and we are pleased to have him become part of the Flyers' family." Or as a fan posted on the Flyers web site: Hextall and Hakstol.

The selection of Hakstol was one far below the radar — an individual with no NHL experience whatsoever neither on the ice as a player or behind the bench as a coach. As such the eternal questions arise: can a successful college coach make it in the pros? Will the players listen to him? Similar questions were raised when Brad Stevens — another college coach that came in below the radar was named the head coach of the Celtics in 2013.

"It's a risk. We know that," admitted Hextall on the team's web site. "I felt comfortable going through the process with Dave, asking him a lot of questions to that effect. He had all the answers that I thought were the right answers. He has handled a lot of high profile players, albeit before they are getting paid. So I have confidence in the way he handles people, the way he respects people. He treats people with respect."

When Boston area fans last got a chance to see Hakstol it was April and his UND squad had once more made it to the Frozen Four this time at the Garden. Hundreds of fans, plus cheerleaders and a band, had made the long trip from Grand Forks to support their team, only to see it not advance to the championship game.

UND would lose the semifinal matchup against Boston University, that in reality would prove to be the feature contest of the weekend. Both were top ranked teams, but BU emerged the victor, denying North Dakota a shot at the national title.

It would be a familiar conclusion of the season for Hakstol, who, in his 11 years behind the bench, guided his team to an incredible 11 straight NCAA postseason berths and seven appearances in the NCAA Frozen Four. Counting two years before he took over, UND has the Stanley Cup.

now appeared in 13 straight NCAA postseason tournaments, the longest streak in Division I Hockey.

During the Hakstol era, the team enjoyed 11 seasons of 20-plus wins and climbed to the 25-win plateau eight times. He walked out the door with an impressive 289-143-43 record. His final team in Grand Forks finished at 29-10-3 as they left for Logan after being beaten by BU. Although he didn't know it then, it proved to be Hakstol's final game as a college coach. He'll be back at the Garden now on a more frequent basis, since he's coaching in the NHL.

Hakstol will be embarking on quite a change, having spent most of his life in smaller communities in Canada and the U.S.

A native of Warburg, Alberta, he was essentially a UND lifer, playing there from 1989 to 1992 and serving as team captain for two years. He eventually earned a degree in Financial Management in 1996.

He also played four years in the minors before starting his coaching career with the Sioux City Musketeers of the United States Hockey League, earning coach of the year honors for the 1997-1998 season.

But soon it was back to his alma mater. He was named an assistant in 2000, then elevated to the head job in 2005 and never looked back. He was a great fit and it proved to be a great ride for the program that became known nationally, despite its somewhat isolated location. It was during the Hakstol era that the Washington Post described North Dakota as the least visited state in the U.S.

A description such as that won't be applicable now that Hakstol has moved to the East Coast — a region swimming in history and swarmed by tourists. But there should be quite a bit of familiarity. Some 46 former UND players played professionally in 2014-2015 with 20 seeing action in the NHL. In addition, some of those 14 draft picks on Hakstol's last UND roster may well make it to the NHL in the years to come. The difference is that he'll be coaching against the vast majority of them. One of the best to come through the program during the Hakstol years: Jonathan Toews, captain of the Blackhawks.

He'll take control of a team that was far from a winner last season. The Flyers posted a 33-31-18 record to finish 12th in the Eastern Conference and 24th in the NHL overall. Hakstol replaces Craig Berube who had spent six years with the Flyers — four as an assistant and two as head coach.

So the Flyers have pinned their hopes on Hakstol. Only time will tell if those hopes translate into contending for
