## Does America Really Support Roe?

It does appear many pro-choice folks are fearful of any backtracking and state that any change in Roe is cruel and extremist and harmful to women.


## Democrats Sailing Into An Impeachment Iceberg

## **GARDEN OF FLAGS**

In Honor of Those Who Gave All



On Wednesday, May 22<sup>nd</sup>, in advance of the Memorial Day weekend, 700 volunteers gathered at the Soldiers and Sailors Monument on Boston Common planting 37,000+ American flags in honor of every heroic Massachusetts service member who paid the ultimate sacrifice in defending our country since the Revolutionary War.

The Garden of flags is a somber tribute to all, who gave it all for our freedom, and of those from around the world.

The breathtaking mark of patriotism to our fallen heroes is the true meaning of Memorial Day. Displaying our gratitude and support to the families and their sacrifices that they made are never to be forgotten.

Since its inception in 2009, by the Massachusetts Military Heroes Fund, The first Flag Garden on Boston Common was



## **CICERO** Part II



One of Cicero's bitter enemies was a rabble rousing demagogue named Clodius (not to be confused with the Emperor Claudius). This man caused the enactment of a law which declared a person guilty of treason if he executed any Roman citizen before that person had been condemned by the people. This of course was aimed at Cicero because of past deeds which were performed in the line of duty; consequently, he went into voluntary exile in Greece. He wandered around that country, full of remorse and self-pity, even to the point where he avoided all public honors

A favorable turn of events took place through the intervention of friends and Cicero was recalled to Rome with great honors. The senate met him at the city gate and he was returned in triumphal fashion.


Five years later, he was placed in control of the government of Cilicia (Armenia) and waged a successful war against plundering mountain tribes. His soldiers conferred upon him the title of imperator for that region. He resigned his command with intentions of returning to Rome

in great triumph, but trouble between Caesar and Pompey put a damper on that idea. His vacillation between the members of the First Triumvirate was not a great period in history and neither was his divorce of Terentia, his wife of 33 years. During their married life, she had become a woman possessed of a violent temper in addition to her extravagance in the management of his private affairs. They had two children; a son and a daughter. He was very fond of his daughter Tullia, but when her death brought joy to Terentia, he quickly divorced her. At the age of 62, he married a very wealthy and very young girl. From that moment, he became known as "Smiling Cicero."

After the death of Julius Caesar the "Second Triumvirate" was formed. This was a coalition between Octavian (later called Augustus), Mark Antony (Marcus Antonius), and a famous general named Lepidus. This Second Triumvirate was sealed by a proscription (publishing the names of persons condemned to death) in which each member permitted the execution of any friend who might be named by either of the other two members. By this method, at least 2,000 of the middle-class (equestrian order) and 300 senators were executed and their property confiscated.

After the assassination of Julius Caesar, it was Cicero who had composed vigorous orations against Mark Antony. It follows then, that it was Mark Antony who submitted the name of Cicero to be added to the list of those to be proscribed.



We spoke about our parents, siblings, neighbors, priests, nuns, teachers, coaches, and other longtime friends. Through hearty laughs, we struggled to find sense of the sudden, tragic loss of dear friends too young to die. We concluded that those piercing experiences unsettled our collective community unlike any other events.

Mark and his wife live with their son and daughter in Connecticut. Their daughter would graduate Lasell College in Newton the next day, so a three-day visit was planned to meet-up with me and Gerald. We knew time together could not last long enough to do justice to the varied accomplishments and catching-up that we three eagerly sought to discuss. So we jumped in without hesitation as though 44 years had not passed. That's definitely a solid connection that the rough journey of life cannot ever penetrate!

Part of our spirited conversations continuously returned to the Old Neighborhood: Our generation of friends - some we also found anew on Facebook. Its many families included the rich lives of our elder neighbors from the WWI generation. We discovered new revelations about them. A predominantly Italian neighborhood, mixed with Irish, Germans and Polish, we shared anecdotes of those colorful characters we are blessed to have learned lessons we still benefit from.

As Mark reminded me and Gerald of the time he moved from the neighborhood with his family while in grammar school in the late 1960s, we asked him where his grandparents originated. We never knew despite our knowing so very much about both our families.

His paternal grandfather

Nicholas Angerosa came to America in 1915 from Armento, a province of Potenza, Italy. He met Philomena Telento in New York City, where they wed. They relocated to Utica, and raised 12 children.

Mark's father Dominick (second oldest of the six boys) served two tours with the U.S. Army in the Pacific Theater during WWII. Wounded three times, he earned the Purple Heart, then returned from combat to marry Patricia Matarrese and had five children. Our fathers shared common ground on that war where they fought on two separate Continents. And through the years, they shared stories of the hellishness WWII exacted on them and their comrades.

Vito Matarrese arrived in America in 1912 from Alberello, Italy. He fought for America in WWI. In 1923, he returned to Italy to wed Angela Doria. They settled in Utica, New York, where they wed and had daughters Mary and Patricia. Mark added: "Grandpa Matarrese's name and his masonry business logo is still seen on the concrete sidewalks of many streets (in Utica) poured decades earlier."

A generational divide spanning two Continents, three nationalities, and large families who grew to know each other for years. Three friends brought together for one glorious afternoon of fond memories that not even gloomy weather dampened our spirits.

Soon after joining his wife and daughter at nearby Lasell, Mark wrote a message and included a photo shot outside my place that he posted on his Facebook page: "Visiting two of my oldest friends. Nearly four hours of non-stop reminiscing. Our laughter and our love has never

# Four Centuries, a Religious Site

Now that we have celebrated the installation of the new organ at Saint Leonard Church this past Sunday it seems appropriate to remember the other Italian Church associated with the Italian community, the name of which is carved on its front, Sacred Heart Italian Church.

Sacred Heart remains the present day manifestation of the many faces of the immigrants that have passed through the historic North End.

Standing on or just yards away from its present site, a house of worship has stood on North Square, America's oldest public square, at the corner of Sun Court and Moon Streets since 1649, the very beginning of the settlement of Boston.

The first of two Congregational churches burned to the ground in 1676; the second in 1770.

In 1829, a group of Boston Methodists formed the Port Society of Boston to provide charitable aid and religious services for the city's sailors. They acquired the vacant Methodist Alley chapel located in the North End, which was the heart of Boston's shipping industry. The Port Society renamed the chapel the Seamen's Bethel, and at the end of the year Edward Thompson Taylor was hired as Mariner's Preacher. The chapel in Methodist Alley proved too small for the growing congregation, and a new church was built at 12 North Square in 1833.

The legendary sailorpreacher, Father Taylor (Rev. Edward T. Taylor 1793-1871), preached here and is thought to have served as inspiration for Father Mapple in Herman Melville's classic, Moby Dick. Melville made frequent visits to the Bethel.

The former Seamen's Bethel was purchased by the Saint Mark Society, a group of Italian



immigrants, in 1884, and was named Sacred Heart by Archbishop Williams in 1888.

In 1888, the church opened and was entrusted to the Scalabrini missionaries who came to America to minister to Italian immigrants.

Thousands of faithful have benefited by the services offered by the Sacred Heart Parish. The majestic classic upper church is used on special occasions. The smaller devotional chapel downstairs is a testament to the piety and devotion which the early immigrants brought from Italy. The chapel is surrounded by shrines, to name a few, St. Anthony, St. Lucy, Our Lady of the Rosary, St. Therese, St. Rita, St. Jude, Poor Souls, St. Rosalie and the Pieta. The Scalabrini Fathers feeling their work was done among the Italian immigrants departed from Sacred Heart Church in 2004. The church is now part of the parish of Saint Leonard of Port Maurice and is ministered to by the Franciscan Fathers.

North Square is currently under renovation, the City of Boston has commissioned four bronze sculptures depicting the historic significance of the Square one of which features the facade of Sacred Heart Church.



# L'Anno Bello: A Year in Italian Folklore

Jumping into June

Ah, June! No other month brings as much joy to the heart of this schoolteacher. June is inextricably linked to summer in my mind. It means eightyplus degree days when I open every window, trying to catch a pleasant ruffle of a breeze. It is days spent walking by the seashore, inhaling the salty scent of the ocean and listening to the plaintive cries of the gulls. June means days of ice cream dripping down cones and strolls in the late-evening sunshine. Finally, June means the last school bell of the year, opening a summer full of possibility and hope. Yes, I truly love June, and so did my ancestors over in Italy. For June in Italy boasts several holidays that revel in the summery nature and outdoorsy aspects of the month. In truth, June can be an overwhelming time to visit Italy, as that is when most of the tourists descend, combining crowds with hot temperatures. However, those who go outside of the well-beaten tourist path will greatly enjoy this beautiful month in Italy, especially because of these traditional and

deeply significant festivities. 1) Pentecost (50 days after Easter; June 9th this year): This important Christian feast occurs on the seventh Sunday after Easter and honors the descent of the Holy Spirit upon Jesus's disciples. It also closes the fifty-deed Easter period in fact, the name "Pentecost" derives from the Greek word for "fifty." For Italians, Easter, or Pasqua, does not end on the Sunday of the holiday, but rather encompasses a fifty-day period peppered with many saints' days and Easter-related festivities. In Italy, Pentecost is often referred to as Pasqua Rossa, or "Red Easter," after the red vestments worn by clergy on this day. Many churches scatter rose petals upon the congregation during services, symbolizing the descent of the Holy Spirit and incorporating a beautiful summertime flower into the celebration. The English, meanwhile, know Pentecost as Whitsunday. They mark the holiday with Whitsun Ales, or outdoor fairs that include folk dancing, decorating with flowers and garlands, and charitable contributions to the local parish and other causes. Europeans know that it is so wonderful to experience

a holiday where spirituality, community and the love of summer seamlessly combine into an unforgettable celebration.

2) Festa della Repubblica (June 2<sup>nd</sup>): In the simplest terms, one can think of la Festa della Repubblica, or "Feast of the Republic," as Italy's Independence Day, a rough equivalent to our Fourth of July. This feast honors the date in 1946 when, after the turmoil of World War II, Italians voted on creating a republic rather than returning to a monarchy. Nearly everything — banks, stores, tourist sites, and museums — are closed or operate on holiday hours. Instead, Italians celebrate by watching parades and attending outdoor parties or concerts. Expect to see the Italian tricolor flag, with its bright hues of red, white and green, adorning landmarks and waving from people's homes. La Festa della Repubblica appropriately occurs in the summer, when people can take advantage of the lovely weather to go outdoors and show their communal pride in being Italian.

3) Festival of San Ranieri (June 16-17th): The feast of St. Rainerius, or San Ranieri as he is known to Italians, encompasses two days of merriment in the Tuscan city of Pisa. The eve of the feast day, Pisa celebrates its patron saint by lighting up the city's buildings with over 70,000 glass-encased candles. These lumini cast a warm, romantic glow against the meandering Arno River. A fireworks display caps off the night's festivities. The next day, people gather to watch a regatta, or boat race. I find it interesting that this quaint and local holiday includes the two biggest hallmarks of solstice celebrations — fire and water — giving Italians cause to honor the sweet delights of midsummer.

4) Saint John's Day (June 24th): This is one of my favorite holidays. It commemorates St. John the Baptist, the major religious figure who baptized Jesus, though many traditions originated from the pre-Christian festivities celebrating the summer solstice. In Northern Europe, St. John's Day is known as Midsummer since it falls so close to the summer solstice. People celebrate with rites honoring the sun (the summer solstice) and water

(St. John the Baptist): building maypoles, floating garlands of flowers down streams, lighting bonfires. In Italy, this is *la Festa* di San Giovanni Battista. In the Lake Como region, people float hundreds of delicate lanterns on the lake and later continue the theme of light by enjoying a fireworks display. Florentines celebrate with a medieval tournament, while also holding a procession of rowboats carrying candles drifting serenely along the Arno River. These festivals perfectly capture the magic of the longest night of the year, harnessing the power of the sun and honoring the life-giving qualities of water.

5) Feast of Saints Peter and Paul (June 29th): Rome celebrates the feast day of two of the most important figures of early Christianity with great fanfare. The commemoration of St. Peter and St. Paul, or San Pietro e San Paolo, includes a special Mass from St. Peter's Basilica in the Vatican (St. Peter was the first Pope). Many businesses in Rome are closed for the day as people admire elaborate flower carpets — a summer symbol outside St. Peter's Square. Like many summer holidays, the day ends with a fireworks display.

Of course, there are plenty of other ways to enjoy June in Italy. Lots of little festivals, known as *sagre*, dot the Italian landscape. These small holidays frequently devote their attention to a specific crop, and during the summer that can mean anything from peaches to strawberries to herbs. One of the best aspects of Italian holidays is that they so connect to the rhythms of the Earth and encourage reflection in the present moment. So, no matter how you celebrate, make sure to give thanks for the wonderful month of June and all the delights it offers!



"Magnificent" is the best word to describe Mass at St. Leonard Port Maurice last Sunday, May 26th, when Cardinal Sean O'Malley celebrated Mass and used the occasion to bless two new breathtaking statues of St. Francis of Assisi and St. Clare, the Foundress of the Poor Clares - the Second Order of St. Francis. The statues were made in Ortisei, in the Tyrol Region of Italy by sculptor Gregor Mussner especially for Fr. Antonio Nardoianni, St. Leonard's pastor.

The Cardinal then blessed the church's new pipe organ and after Mass, he proceeded downstairs to bless the newly restored Church Hall.

It was the St. Joseph's Society that stunned the North End by gifting \$1 million dollars to

complete St. Leonard's Restoration Project. Not satisfied with its own generosity, the St. Joseph's Society then pledged to donate still another \$350,000 to restore the century old church basement with much needed renovations so that it could be modernized and used by the entire community.

St. Leonard Church, founded in 1873, is the first church in New England built by Italian immigrants, which became the center of spiritual activity for the fast-growing Italian immigrant residents of the North End. When the church opened to the public in 1891, it already had an estimated 20,000 parishioners. The upper church construction project, in Romanesque revival architectural style, was dedicated on November 6, 1899.

A Nostalgic Remembrance

Seventy-five years ago this week, the tide was turned against Hitler and the Nazi party he created. I remember listening to Babbononno talk about the happenings in Europe when I was three years old back in 1941. I didn't understand most of what he would discuss with his sons and my father at the dinner table, but I knew the swears he leveled at Hitler and Mussolini. Most were in Italian, but when he swore in English, Nanna would yell at him, saying that he was exposing his grandson to his low-class mouth. A second glass of wine would always mellow him out and dinner would continue without a problem. The conversations continued

at the dinner table for the next two years. No matter who was in attendance, Babbononno spoke his piece and within a sentence or two, you knew where he was coming from. As the war progressed, Uncle Nick joined the Navy and Uncle Gino the Army Air Corps. Dad was recruited by the OSS, the forerunner to today's CIA. The government was housing Italian war prisoners at the closed immigration station in East Boston, and Dad's job was to interrogate them a couple of times a week. Uncle Nick lucked out; he auditioned for the Andre Kostelanetz Orchestra, which was stationed at the Newport Naval Base. He passed the audition and spent World War II serenading the ships that docked in Newport, Rhode Island. The Navy was lucky, Uncle Nick played great sax, but couldn't swim a stroke. Uncle Gino on the other hand, wound up in the 5th Air Force and served in the Pacific. He was in the thick of it.

One night at dinner, I knew how Babbononno felt. He was never one to become emotional, but during dinner that night, he had an extra glass of wine or two. After Nanna and my mother began doing the dishes, my grandfather grabbed me by the wrist and walked me outside the house on Eutaw Street in the Eagle Hill section of East Boston. With the two of us standing in the middle of the street. Babbononno pointed at the flag hanging in the middle window of the first floor bay window. It was a white flag with red trim around the perimeter and two blue stars in the middle, one above the other. As he pointed, a tear came to his eyes, and he softly said, "Guarda mi nipote, quelli sono mi figli che combattani in la Guerra." (Look, my grandson, those are my sons who fight in the war.) After that, we would return to the kitchen and Babbononno's dessert would be another glass of wine.

Periodically, Uncle Nick would return from Newport, but he and Aunt Ada, his first wife and my Godmother, would do nothing but argue. I didn't know why until years later, but it centered on infidelities that were so common during war time. When Uncle Gino came home on furlough, it was a family event. He was in the thick of the battles in the Pacific, as we island-hopped toward Japan. Each time he came home, he had presents for members in the family.

My favorite was an aluminum a customs station at the Paris bracelet someone had made. On the face of it were two palm trees and between them the inscription, New Guinea 1944. I wore it until my left wrist grew out of it, then I found someone who was good with metal and had him convert it to a watch band. I wore it again for the next few years.

One day, Babbononno came home with the Boston Post, the Boston Globe, Il Progresso and La Gazetta, the newspapers he read each day of the week. He yelled for Nanna, my mother and me to look at the headlines of each. It seems that, on that day, the allies invaded France on its west coast and they called it D-Day. It was the invasion of Normandy and it was June 6, 1944. My grandfather was overjoyed that the tide of war had turned in favor of the allies. He knew that Italy had surrendered to the Americans and actually changed sides with the partisans joining in against fascism and the Nazi cause.

It wasn't until a couple of years after the war that I found out what it was like on D-Day. Dad had a couple of friends who were with the U.S. Army and part of the invasion force. The stories they told about the Americans, British, Canadians, Australians, Scots, and partisans from several of the Nazi occupied countries who fought their way onto French soil were mind blowing, to say the least. When I asked, "What about the French soldiers?" The answer always was, "Yeah, where were they?" To get his friends to talk about the Invasion of Normandy, Dad would first have to get a few drinks into them, as they never wanted to talk about what they experienced. It was that bad.

Just recently, I heard a story, but I don't know if it's true or not. It seems that an old-timer, a man around 90, brought his wife to France for a vacation. At

airport, the inspector in a harsh tone told the man to produce his passport. Fumbling through his flight bag, the man finally produced the necessary document to enter the French Republic. The customs inspector with even a harsher tone yelled at the man asking him if he had ever been to France before. When the man answered in the affirmative, the inspector then yelled, "You should know that every time you come to France you must have your passport ready ahead of time." The man smiled sheepishly and said, "The last time I was here, I didn't have to show my passport." The customs officer yelled, "That's impossible. Every time you come to France, you have to present your passport. When were you here last?" The man answered, "It was June the 6th, 1944, D-Day, and when I came ashore at Normandy, there wasn't a Frenchman anywhere to be found."

Dad and my uncles later told me that they had friends who were in that invasion, but never made it back. The survivors never really wanted to talk about the war, they just wanted to forget it and go on with their lives. In my adult years, I've met many ex-servicemen who have bragged about their parts in their wars, WWII, Korea, and Vietnam. The people who bragged about their exploits were usually the ones who did nothing except conjure up good stories about their experiences. The ones who were in the thick of battle never liked to talk about those days. Remembering those experiences just caused pain, anguish, and guilt. The guilt was often due to their surviving the wars and the memory of some of their friends who didn't.

Well, it is 75 years later. The war ended in Europe in 1945, and maybe next year, we will celebrate the 75th anniversary of it coming to an end. Unfortunately, most of the men who made sure that all of Europe wasn't going to have to speak German are no longer with us. Vets from WWII are few in number and fading fast. But, I must thank them for their sacrifices and end by saying GOD **BLESS AMERICA**

# Recipes from the Homeland

## CANNOLI

Six to ten wooden or stainless steel Cannoli rollers will be needed.

#### **CANNOLI SHELLS:**

3 tablespoons shortening 3 tablespoons sugar 1/4 teaspoon salt 3 cups flour

2 teaspoons wine 2 tablespoons water 1 beaten egg Canola oil for frying

## FILLING:

1 2-pound container ricotta 1 cup sugar A pinch of cinnamon

**SHELLS:** Combine first four ingredients thoroughly. Add water, wine, and beaten egg. Knead dough into ball. Separate dough into small pieces (meatball size). Place in a bowl and cover. Roll each piece into a paper-thin round. Take one wooden or metal roller and gently wrap loosely around thin roller. To seal, dampen one edge of dough with a little water. It is best to prepare three or four cannoli before starting to fry.

FRYING: Heat oil in deep fryer or saucepan. Carefully slip the cannoli shell with roller into the deep fryer (or saucepan). With spatula or slotted spoon, turn item in oil to brown on all sides. Use caution while removing hot cannoli from pan and from hot roller. It is best to fry one at the time as they brown quickly. Cool thoroughly before storing in a covered container in a cool place. They remain fresh for two weeks.

FILLING SHELLS: Drain ricotta cheese in a colander. Then place in a bowl. Add sugar and a pinch of cinnamon before mixing thoroughly by hand. Do not whip. With teaspoon, fill shells with ricotta cheese mixture. Sprinkle confectionery sugar over the cannoli shell before serving.

NOTE: It is best to fill the cannoli shells just before serving. Leftover-filled shells should be refrigerated. Filled shells will soften somewhat in the refrigerator







# When the Heavyweight Championship Changes Hands It Hasn't Always Been a Dramatic Event

Throughout the history of boxing a World Heavyweight Championship bout was usually a major event. The allure of two men fighting for the crown extended beyond boxing. It was always front page news, and even non boxing fans had an opinion on it. The night Joe Louis defended the title against Max Schmeling the entire country stopped to watch or listen. It was beyond a major event.

Few other fights were that big, but most had caused excitement leading up to the night the fights took place.

From the time John L. Sullivan lost the title to James J. Corbett in 1892, until the night Evander

Holyfield was defeated by Riddick Bowe 1992, there had been 29 undisputed heavyweight champions. During that period there were others who laid claim to a portion of the title, but it is safe to say there have been only the 29 who can truly claim to have stood alone at the top. During this same time there have been 19 different men who have been President of the United




Johnson vs. Willard

States. It's interesting to note that the champion who held the title for the longest time and the man who served as president for the longest time both did so at the same time. In fact, there is an old joke about how much less complicated it was to be growing up during that time in that you always knew Joe Louis was the champ and FDR was the president.

While there were 29 different men who held the title over that time, the championship changed hands in the ring just 21 times. There were periods when title holders retired and things

had to be sorted out to determine a new champion. The first time this happened was when James J. Jeffries retired in 1905. Marvin Hart would be recognized as the new champion after defeating Jack Root, but he was not universally accepted as most people still saw Jeffries as the champ. The belief was strong that a championship could only be won by defeating the current holder of the crown.



The other times when the title was left vacant were when Gene Tunney, Joe Louis, and Rocky Marciano retired. It was also up for grabs when Muhammad Ali was stripped of the title in 1967. Both Tunney and Marciano remained retired while Louis and Ali both made comebacks and fought to take back the title Louis was unsuccessful at. Ali lost in his first try when he faced Joe Frazier, but he went on to regain the crown

when he defeated George

Foreman.
While 29 different men held the title, there were just 22 times when the reigning champion lost the championship in the ring. Some of these fights were very exciting, but a number of them were not so much so.

The first time was when John L. Sullivan lost the

title to James J. Corbett. While this fight created tremendous interest, Sullivan was out of shape and long past his prime. It was a rather one-sided affair, and most not for the fact Sullivan showed the determination and fortitude to act into the  $21^{\rm st}$  round.

Corbett's loss to Bob Fitzsimmons was quite a bit more dramatic as he was giving Ruby Robert quite the pasting until Fitzsimmons landed his legendary solar plexus blow and kayoed Corbett. It was also the first heavyweight title fight that was filmed.

When Fitz lost the crown to Jim Jeffries it was a one sided fight with Jeffries winning easily. Nothing dramatic there, though Fitz did give Jeffries quite the go of it in a rematch,

The next champion to lose the title in the ring was Jack Johnson he was kayoed by Jess Willard in Havana in 1915. Willard wore Johnson down before delivering the knockout blow. It was not a terribly exciting fight, but it will be remembered for some controversy, as Johnson would later claimed to have thrown the fight.

Perhaps the most memorable of all title changing fights was Willard vs. Dempsey. While it was

one-sided, it showcased a new young champion who displayed unbelievable skill and power. It was the dawn of the Age of Dempsey, perhaps the most exciting era in boxing.

Johnson lost the title to Gene Tunney in 1926, a fight where Johnson had shown his age, and Tunney displayed his brilliant boxing skills. More than a fight filled with excitement, it was

a changing of the guard with the old king being dethroned by the young prince.

After Tunney retried, the title moved to Max Schmeling after he won by foul over Jack Sharkey in an elimination bout. Sharkey would win by a controversial decision in a rematch in a fight that isn't remembered for much excitement. Sharkey would lose to Primo Carnera in a fight that many believe was fixed.

Max Baer's challenge to Carnera produced a memorable fight because of the number of knockdowns that took place over the 11 rounds

> it lasted. Of course, it must be remember that the giant Italian broke his ankle in the first round.

> When Baer lost the title to James J. Braddock, it had to be one of the worst fights in championship history. The two engaged in a spring session in what most certainly was a case of Baer throwing the fight.

The next two times the title changed hands

The next two times the title changed hands in the ring were both quite exciting. Jersey Joe Walcott's devastating one punch knockout of Ezzard Charles will always be remembered. Rocky Marciano did the same to Walcott, but in even more dramatic fashion when he came from behind to flatten the champ in the 13th round.


Johansson beating Patterson, Patterson regaining the title from Ingo, Liston battering Floyd, Clay stopping Liston, and Foreman taking Joe

Frazier apart were all interesting fights, but none contained the pure excitement of the night Ali regained the title from George Foreman in Zaire. That is a fight that will be talked about for as long as people get together to discuss boxing.

While title changing fights have not always been the most exciting, many heavy-

weight title fights have certainly been. Dempsey vs. Firpo, Louis vs. Conn, Louis vs. Schmeling, Ali vs. Frazier (1) are just a few that come to mind.

What made a heavyweight championship bout so exciting was not seeing a champion lose, it was the fact that there was time when the Heavyweight Champion of the World was the largest figure in sports, and also a major figure in popular culture. Hearing the ring announcer saying the words "In this corner, the undisputed Heavyweight Champion of the World ... " really meant something. It was truly an event.

He does know one thing, he did not watch the game. "I'd be lying if I said I watched that game," said the leader of Bruins Nation. "I was five years old I think."

What he does remember is that as a youngster growing up in Canada "we saw a lot of Montreal, Toronto, Boston, and New York." In other words, four of the Original Six teams. Neely said he didn't become fully aware of the Boston hockey tradition until he arrived in the Hub via a trade in 1986.

"It was really the first time I was like wow this is quite an organization. There are really so many great players that have played here and a lot of really good things have happened. I can't count how many times we've all seen Orr score that goal and fly through the air, but just to be a part of this organization is pretty special."

And one other thing about the famous Orr photo. We don't know who had the time to figure out this stat, but someone at NHL headquarters did. When the Bruins and Blues faced off in Game 1 that saw Boston win 4-2, it had been exactly 17,914 days since Orr's immortal moment.

Bruins head coach Bruce Cassidy was in his own moment, so to speak, being peppered by media representatives with many questions about his team and the 2019 Stanley Cup Final. But then came a question a bit more personal, about who helped him along in his journey to this place in time. His answer was telling.

"Obviously my parents. They both passed away but they knew as a kid how much I loved the Bruins and Bobby Orr. That's what turned me into a Bruins fan at a young age. So they would probably be the most proud. And now my immediate family. Obviously my wife and kids know how important it is to me and how much work we have put in together as a unit. So I think that's it in a nutshell. We're all kind of proud to be here."

As the series got underway, Cassidy was asked what he believed was the Bruins biggest advantage over the Blues.

Cassidy indicated it is "experience. I'll go the easy route. I just believe that our guys have been there, that they have won a cup and have lost a cup. That should give us an edge. Some people disagree with that once you're here but I believe it gives us an edge. I think it helped a lot during our preparation, with all the downtime. So hopefully that is an advantage for us."

Nearly everyone believes that St. Louis was one bad hockey team in the first few months of the 2018-2019 regular season, citing the fact that the Blues were dead last in the 31-team league as of January 3<sup>rd</sup>.

But GM Doug Armstrong begs to differ. He said he saw a competitive team that lost after leading games — in other words, a team that found ways to lose, rather than ways to win.

"I thought we had played some really good hockey in October and November," recalled Armstrong. "But the reality was we were finding ways to lose games and not win games. In probably 12 of our first 15 games we were tied or leading in the third period and came out with no points. So it wasn't awful hockey, it just wasn't winning hockey."

On November 19<sup>th</sup>, Armstrong fired head coach Mike Yeo after a 7-9-3 start and elevated assistant Craig Berube to the top position behind the bench on an "interim" basis. That's a designation that still stands beside his name during the Stanley Cup Final despite the fact that he has guided the Blues to the championship round.

It took a bit of time but the team gradually bought into Berube's leadership. Early January signaled the change. As the ball came down in Times Square and the sign illuminating "2019" lit up, the Blues were looking up at everyone else in the NHL. Things were really blue for the Blues in St. Louis.

But all St. Louis did for the rest of the regular season was post a 30-10-5 record, amassing 65 points — the most by an NHL team in the 2019 portion of the schedule. The turnaround included an 11-game win streak from January 23<sup>rd</sup> to February 19<sup>th</sup>, plus a 12-1-1 record for the month of February.

That was good enough to claim the third spot in the Central Division of the Western Conference and a guaranteed berth in the playoffs. The Blues went on to eliminate Winnipeg, Dallas, and San Jose, setting up their showdown with the Bruins for the title.

Berube is the 11<sup>th</sup> head coach in NHL history to reach the Stanley Cup Final after taking over a team during the season.

Both the Bruins and the Blues put together their rosters in the same manner — a combination of draft picks and trades plus free agent signings. Some 37 percent of the Bruins current roster was selected by the team in the annual NHL draft while 21 percent came via trades and 42 percent was acquired through free agent signings.

For the Blues some 52 percent of the roster came through the draft while 35 percent was picked up in trades and only 13 percent was acquired on the free agent market.

Here's some more about that 1970 Stanley Cup Final: B's forward John Bucyk led all players with six goals in the four-game sweep of St. Louis. His total nearly equaled the scoring for the entire St. Louis team during the series. The Blues managed only seven goals. The Bruins found the range for 20. Phil Esposito led all skaters with eight points, scoring two goals and assisting on six others.

Four different Bruins had game winning goals in the series. Bucyk had the deciding goal in Game 1, Ed Westfall scored the winner in Game 2, while John McKenzie notched the GWG in Game 3, followed by Orr's historic tally in Game 4.
