# Gabriela "Gigi" Coletta Wins

# Special Election for District 1 City Council Seat

Gabriela "Gigi" Coletta, 29, a former City Hall employee in the City Council offices, won a special election for District 1 City Council seat this past Tuesday (May 3<sup>rd</sup>) and declared victory shortly after the polls closed at 8:00 p.m.

"We made some ambitious plans together," she told her campaign workers who gathered together awaiting the vote tally. She added, "I'm expecting you to hold me accountable to them. I need you to come into City Hall with me"

Coletta was opposed by Tania Del Rio both of East Boston running to fill the vacancy



when District 1 City Councilor Lydia Edwards was elected in a special state Senate race in January, and who endorsed Coletta, her campaign manager, and her former chief of staff at the City Council.

There was also a third candidate Jorge Mendoza, a North Ender and restaurateur frustrated with policies coming out of Mayor Wu's office. Mendoza launched a late entry sticker campaign.

Once the Boston Elections Department certifies the election results, Coletta will be sworn into office when a date is scheduled for the swearing in ceremony.

# Mayor of Easthampton, MA In the Hot Spot

According to the *Daily Hampshire Gazette*, an audio it has obtained of a student in a classroom talking with the town mayor has raised issues of racist remarks. Mayor Nicole LaChapelle on March 30<sup>th</sup> was invited by the classroom teacher to visit her class to offer her thoughts after students in two groups practiced for the "We the People: The Citizens and the Constitution" national finals competition, which tests students on their understanding of the U.S. Constitution and legal principles.

At one point in the classroom, the mayor interacts with a student heard on the audio saying, "Your cadence is a little, it's ... not white. You don't talk like a white person, right? And that's fine. But what you have to do with your physical presence is say like 'Who \*\*\*\*ing cares."

Now, the mayor's comments have been called both "racist and unacceptable" by the town's school committee members. This incident became news after the student in the classroom told her mother what happened and what the mayor had told her.

There has been much back and forth and at some point the mayor did appear to be apologizing for her classroom remarks and how they were reportedly misinterpreted. Stay tuned for more on this story as it develops.

Sources say he stands accused of the groping charge witnessed by others at a St. Patrick Day celebration on March 11<sup>th</sup>.



# NEW Health CEO Retires After 34 Years in Community Healthcare

James E. Luisi will Step Down June 1st



Luisi began his NEW Health career as a college student in the late 1970s when the health center had one location with 25 employees and a budget of \$400,000. He advanced through senior leadership to the CEO role with the goal of providing the highest quality care to the most vulnerable residents of the North End, Waterfront, Charlestown and surrounding areas. Today, NEW Health has three locations and a staff of 175 with a yearly budget of over \$25 million.

"I have been honored these last 34 years to lead an exceptional group of dedicated professionals who always strive to provide the best care to our patients and communities. While we have faced many challenges over the years, this job has brought me so much joy and satisfaction knowing the difference we have made in people's lives," said Luisi. "As long as we continue to empower people to self-care while contributing to their health and well-being, community health centers will continue to be the model for health care in this country."

NEW Health is the only Massachusetts health center receiving the federal government's top award in quality for the third consecutive year, named a National Quality Leader and Health Center Quality Leader by the Quality Improvement Awards of the Health Resources & Services Administration (HRSA), a federal agency of the U.S. Department of Health and Human Services. As past Board Chair for both the Mass. League of Community Health Centers and the National Association of Community



Health Centers, Luisi's vision has helped shape the direction of the Commonwealth's 52 health centers and the nation's 1500 health centers over the last 20 years.

"One of Jim's greatest accomplishments during his decades of service has been creating needed programs and services for elder residents," said Jason Aluia, NEW Health Board Chair. "He created a home care program in the 1980s, was involved with the creation of a 140-bed nurs-

ing home in the 1990s, and he spearheaded a low-income senior housing project in the 2000s. He continues to find ways to create innovative programs for our seniors."

State Rep. Aaron Michlewitz has known Luisi since childhood when he visited his father, who worked as an obstetrician-gynecologist at NEW Health. "Jim and the health center have always been the cornerstone of the community — not just in health care but in taking care of many social needs of our residents like food insecurity and housing. During the height of the pandemic, NEW Health also provided crucial testing and vaccination. Jim's leadership will be missed by us all," said Rep. Michlewitz.

When asked about his greatest accomplishment during his tenure, Luisi says he is most proud of establishing health centers at Charlestown High School and in the Bunker Hill Housing Development, the largest low-income housing development in New England where residents had previously never had access to dental or vision services. "People living in the development had to go across town to Boston Medical Center because no other providers in the area accepted their insurances. Against all odds and with help from Sister Nancy Citro, a nun from St. Catherine's Church, we were able to convince the Boston Planning and Development Agency to give us a zoning variance to open in the old St. Catherine's School in 2015," said Luisi.

#### **EXITUS JULIUS CAESAR**



The death of Julius Caesar by Cecil Doughty

Rumors spread that Caesar intended to move to Alexandria, taking with him the resources of the state, draining Italy by levies, and leaving his friends in charge of the city. It was also announced at a senate meeting that because the Parthians could only be conquered by a king, Caesar was to be given that title. Splinter groups of conspirators now united into a general conspiracy of at least 60 persons. This conspiracy, which included Brutus and Cassius, was also brought about because of jealousy, personal hatred, and a patriotic desire to return to the constitution of the republic.

Many signs foretold the approaching murder of Caesar. A bronze tablet with Greek inscription was found in an ancient tomb, and interpreted to have predicted Caesar's murder at the hands of his kindred, and then avenged at heavy cost to Italy. Herds of Caesar's horses refused to graze and were said to have shed many tears. The soothsaver Spurinna warned Caesar to beware of danger, which would occur not later than the Ides of March. The day before the murder, a little kingbird flew into the Hall of Pompey with a laurel branch. Other that he was flying in the clouds. her arms.

For these reasons and also because of poor health, Caesar decided to stay home on that fateful day, but was urged by

senate, which had been waiting for him. On the way to the meeting, a note was handed to him revealing the plot and he held it in his hand with other notes, intending to read them after he took his seat. As he entered the Senate House, he laughed at the soothsayer Spurinna, calling him a false prophet and saying that the Ides of March had come without bringing him harm. Spurinna replied, "Yes, they had indeed come, but they have not yet gone."

As he took his seat, the conspirators gathered around him as though to pay their respects. It was Tillius Cimber who took the lead and held Caesar's toga by both shoulders. Caesar cried, "Why, this is violence." Just then, one of the elder conspirators stabbed him below the throat. He tried to rise but was wounded again, and then saw that he was surrounded on all sides by drawn daggers. He dropped to the floor after receiving 23 wounds. He uttered not a word except a groan at the first wound, although some have written that when he saw Marcus Brutus, he said in Greek, "You too, my child." It was reported that of the 23 wounds, the second one in the breast was the only mortal one.

All of the conspirators immediately fled and Caesar lay there lifeless for some time, until three slaves arrived to put him on a litter and carry him home, with one arm hanging down. "Et tu, Brute" or "You too, my child," that is the question.

# 100,000 Mass Seniors Would Access \$400M in Medicare Cost Relief Under Landmark Bill Expanding Eligibility

Passage of House Budget Proposal Expanding Medicare Savings Program Eligibility Would Dramatically Improve Experience of Aging in State

Seniors and advocates statewide are cheering landmark legislation passed by the Massachusetts House which will give nearly 100,000 lowincome seniors a much-needed break on how much they pay for healthcare by expanding the state's Medicare Savings

After nearly ten years of grassroots advocacy from Massachusetts Senior Action Council, the new state budget makes significant progress on addressing the "health care cliff" that thousands of low-income seniors across the state face. Earlier this year, Governor Charlie Baker proposed expanding MSP eligibility to cover an additional 35,000 low-income adults age 65 and older. The House budget passed late Wednesday includes a measure to expand the program even further.

"Far too many of our seniors confront the crushing costs of healthcare and simply cannot afford their care or prescriptions," said Edna Pruce, President of the Massachusetts Senior Action Council. "We've been raising our voices for years. With this budget, we're finally much closer to getting seniors the affordable care they need."

When low-income Massachusetts residents turn 65 and enroll in Medicare they lose access to state and federal health care subsidies, including ConnectorCare. The House's proposal, raising income eligibility from 165 percent of the federal poverty level to 250 percent, could help nearly 100,000 more seniors gain access to the Medicare Savings Program, which covers Medicare

premiums and lowers prescription costs.

While advocates welcomed the good news, they cautioned that raising income eligibility without increasing the Program's low asset limits penalizes lowincome seniors with savings. These low-income seniors made sacrifices to save for retirement only to have these modest savings prevent access to needed

Fifteen states, including Mississippi, Alabama, and New York, have eliminated or significantly raised the asset limit. Advocates say Massachusetts should follow their lead.

"We are on the cusp of dramatically improving the experience of aging in Massachusetts. Now is the time to get this across the goal line to help all our seniors, including those who worked hard for their modest savings," added Pruce.

One MSAC member expressed hope that legislators will finally take action to close the gap this session. "As someone with a fixed income, I'm out of options. I have cut back on everything I can, but even when my family helps, I worry rising healthcare costs will keep me from staying in my own home," said MSAC member Elaine Correia, 85, of New Bedford.

For Correia, who lives on a fixed income, medical expenses have been taking up an increasing percentage of her income. "The quality of my life has diminished. Medicare premiums alone take up 20% of my income, making it hard to afford even basic needs. The Medicare Savings Program will allow me to get the care I need without forcing me to choose between

# **Department of Public Utilities Joins National Campaign** to Raise Awareness of Safe Digging Practices

The Massachusetts Department of Public Utilities (DPU) is joining with other states and utility companies around the country to remind excavators, contractors, and residents to dig safely and call 811 before starting any outdoor digging projects. 811 is the line for "Dig Safe," which is a nonprofit organization that notifies gas, electric, telephone, and cable companies about the intended digging project. At no cost to the excavator, professional locators visit the requested dig site to mark the approximate locations



of underground utility lines with flags, spray paint, or both.

"Utility lines are buried in the ground all around us on both public and private property,

and sometimes these lines are only a few inches below the surface," said Department of Public Utilities Chair Matthew Nelson. "Calling 811 is the best way to ensure a line won't be hit when commencing a new project this year."

State law requires calling 811 at least three days before digging is to start. Accidently striking an underground utility line can result in serious personal injury, property damage, and costly service disruptions for many. Additionally, failure to follow the provisions of the law and regulations can result in fines.

Excavations are the leading cause of damage to underground utility infrastructure. In 2021, there were 925 excavationrelated damages to utility infrastructure in Massachusetts. Every digging project, no matter how large or small, warrants a call to 811. Examples of digging projects that require a call to 811 include installing a mailbox or fence, building a deck, installing a pool, and planting trees and shrubs.

# Honoring Jane Jacobs

Museum Tours Explore Changing Boston Neighborhoods



The West End Museum will join groups in hundreds of cities around the world to lead Jane's Walks on Friday and Saturday, May 6th - 7th. The Museum is adding two additional walks after the first filled quickly. The free walking tours will explore the character of Boston's North and West Ends before the beginning of urban renewal in 1958.

Jane's Walk is an international movement honoring Jane Jacobs (1916-2006), the activist who championed a community-based approach to city planning. She fought against urban renewal projects, like the one in the West End. Her 1961 book, The Death and Life of Great American Cities, introduced groundbreaking citybuilding principles still used today.

"Jane has the reputation of a saint standing against the sins of a failed ideal that decimated hundreds of urban communities in the 20th century," said Sebastian Belfanti, director of The West End Museum.

For this year's Jane Walk, Belfanti will discuss how the neighborhood's four historic sections — Lower End, Upper End, North Slope, and Bulfinch Triangle — developed after urban renewal.

## L'Anno Bello: A Year in Italian Folklore

Italy's Merry Month of May

Italians love their sagre. These are the small, often highly localized feasts, scattered throughout the calendar that honor a particular saint, or food, or pleasures of the season. As May heralds warmer weather and the kind of sunshine that promises summer, more and more people find themselves called to the outdoors, to the company of others and the tantalizing pull of nature. No wonder, then, that May in Italy proves laden with these quaint sagre that provide communities with bountiful reasons to celebrate, sharing in the universal delights of good food and good company. From fried fish to trees, flowers to risotto, the May festivals of Italy encompass the myriad facets of Italian life and herald the summer with joy and purpose. Here is a sampling of these feasts:

• Risotto Festival (First Sunday in May): If you were to visit the town of Sessame in the northern region of Piedmont on this day, expect a feast of creamy rice. Risotto is a popular dish in Northern Italy, a comforting meal of rice cooked in broth until it reaches a rich consistency. I love risotto because it is so versatile - I have had risotto with squash, extra cheese, warm spices, etc. When I visited Italy, I had a rather luxurious risotto in Milan with saffron and truffles delicious! In honor of this festival, it may be a good idea to prepare risotto with seasonal vegetables like peas and asparagus.

· Wedding of the Trees (May 8th): What a charming little festival this is! In the town of Vetralla, located in the central province of Lazio, people decorate two oak trees and offer them bouquets of fresh spring flowers. Later, the citizens plant new trees, and everyone enjoys an outdoor picnic. The Wedding of the Trees, or Sposalizio dell'Albero, recalls holidays like May Day which revel in the rebirth and fertility of nature in the spring. I also love the ecological significance of planting more trees.

• Saint Fortunato Fish Festival (Second Sunday in May): In the fishing village of Camogli, south of the Italian seaport city of Genoa, citizens honor the sixth-century Italian bishop Fortunato di Todi with a seafood banquet. The festival begins the night before with a fireworks display and bonfires. The next day, people feast on fried fish. As summer approaches, I think of days by the beach enjoying a clam bake or seafood platters as the smell of ocean water and the gentle rush of waves overwhelms me. This holiday serves as a wonderful introduction to a season spent by the sea.

• Infiorata di Noto (Third Weekend of May): Flowers rule at this festival in the Sicilian town of Noto. Artists receive allotted portions of the Via Nicolaci Street to create elaborate mosaics made out of flower petals. The result is a burst of bright colors and intricate artwork that bring a sense of joviality and springtime freshness to the city. Other events during the festivals include parades and fairs. On Monday, when the festival is over, children are allowed to run through the mosaics, scattering petals everywhere. This colorful end to the feast reminds us that things sometimes become more beautiful precisely because they do with garlands and ribbons, not last forever — all the more

reason to enjoy spring while it

May in Italy is a fantastic time to revel in the spring weather and take heart from the presence of others. Spring and summer cause the outdoors to beckon at us, and the local Italian sagres enable people with the opportunity to enjoy the pleasures of the season. 



# Saint John Baptist de Rossi

de Rossi was born on February 22, 1698 in Voltaggio in the Diocese of Genoa, as the last of four children to Carlo de' Rossi and Francesca Anfosi who were poor but pious. His initial education was under the care of the two priests Scipio Gaetano and Giuseppe Repetto who noted his potential and brilliance and held him as their favorite student.

When he was 10-years-old, John met with a wealthy, noble couple from Genoa after Mass. They, too, noted his gifts and potential. So, they took him in as a page, after receiving his father's approval. John was taken to Genoa to attend school until 1711.

In 1710, John's father suddenly passed away. His mother pleaded for him to return home,

but John was convinced that the Lord wanted him to finish his education in Genoa.

At the age of sixteen, he entered the clerical state. He was ordained priest on March 8, 1721. Having reached the desired goal, he bound himself by vow to accept no ecclesiastical appointment unless commanded by obedience. He fulfilled the duties of the sacred ministry by devoting himself to the laborers, and teamsters of the Campagna, preaching to them early in the morning, or late in the evening, at the old Forum Romanum (Campo Vaccino), and by visiting, instructing, and assisting the poor at the hospital of St. Galla. In 1731, he established near St. Galla another hospital as a home of refuge for the unfortunates who wander the city by night. In 1735, he became titular canon at St. Mary in Cosmedin. The house

belonging to it, however, he would not use, but employed the rent for good purposes.

For a number of years, John was afraid, on account of his sickness, to enter the confessional, and it was his custom to send to other priests the sinners whom he had brought to repentance by his instructions and sermons. In 1738, a dangerous sickness befell him, and to regain his health he went to Cività Castellana, a day's journey from Rome. The bishop of the place induced him to hear confessions, and after reviewing his moral theology, he received the unusual faculty of hearing confessions in any of the churches of Rome. He showed extraordinary zeal in the exercise of this privilege, and spent many hours every day in hearing the confessions of the illiterate and the poor whom he sought in the hospitals and in their homes. He preached five and six times a day in churches, chapels, convents, hospitals, barracks, and prison cells, so that he became the apostle of the abandoned, a second Philip Neri, a hunter of souls. In 1763, worn out by such labors and continued ill health, his strength began to ebb away, and after several attacks of paralysis, he died at his quarters in Trinità de' Pellegrini.

Canonized on December 8. 1881 by Pope Leo XIII. The Feast of Saint Giovanni Battista de' Rossi is May 23<sup>rd</sup>.

A Nostalgic Remembrance



For three weeks I've been telling the story of Uncle Gus, Sal Meli's maternal uncle, Agostino Faldetta, who was a general in Mussolini's inner circle. He and several other high ranking men in Il Duce's inner circle were against Italy forming an alliance with the Nazis and in 1941, declaring war on the United States. Once these events happened, several of the inner circle began to plot the overthrow of the Fascist government.

As Uncle Gus continued, he spoke about a part of the war I was familiar with, "The first part of the war in Europe took place in North Africa and included Nazi tank corps, Italian and German infantry, and the air corps of both Germany and Italy. We fought all the way to Egypt and then westward again, losing to British general Bernard Montgomery and American general George Patton. In July of 1943, Patton with 90,000 troops invaded Sicily and they were cheered-on by Sicilian civilians. We in Rome then knew where the overall Italian sentiment was.'

"When the allies reached the mainland the fighting continued on the west coast of Italy, Salerno, Anzio, Nettuno. The only time it was side tracked was when Vesuvius erupted in March of 1944. After the allies took Naples and headed toward Rome, Mussolini left the Italian capital under the protection of our Nazi allies and headed north where the Germans maintained their control. He tried to escape to neutral Switzerland but was captured and killed along with his mistress and several of his aides. His body was hung upside down in the center of Milan for all to see. Two or so days later, Hitler committed suicide."

"At the same time, I stayed in Rome along with several military officials and surrendered to the Americans switching sides in the process. We then deposed the king and Italy became a democracy. In May of 1945, the war in Europe was over. World War II was officially over in September of 1945, and a new international organization came into existence, the United Nations. Italy was not allowed to join until 1955, but I was sent to the first meetings as a silent observer when they convened in San Francisco. Once they moved their international headquarters to New York City, and Italy was allowed to join, I became an attaché and stayed in that position until I retired ... end of story."

Listening to the story told by Uncle Gus made me feel as if I was there. (Thank God I wasn't.) After a couple of days in

Palermo, we headed to Sal's parents home in Agrigento in south western Sicily. Sal and I stayed there for about five days and left to see the rest of Sicily and then to head to mainland Italy. After a day at Sal's folk's place, I called home to let the folks know I was still alive. Babbononno answered and I told him the story surrounding Uncle Gus. I next put the two of them on the phone and they conversed for quite a while. I had reversed the charges and knew I was in for a big phone bill when I got home.

After Sal and I left Agrigento, we zigzagged eastward heading to Sicily's east coast. When it was time to hit the mainland, I booked passage on the ferry that crosses the Straights of Messina to Reggio, Calabria and drove my rented FIAT onto the ferry. When we eventually arrived in Naples, I picked up a friend and his wife at the airport and the four of us traveled together for the next two months or so.

Now, someone might ask, "Why did you leave Sal's parents place so soon?" A crazy situation caused my decision. After being there for a couple of days, I overheard Sal's mother on the phone with someone, saying, "I'll bring Sal's friend to your house tomorrow." The next day Sal's mother, Maria, told me that her aunt, the matriarch of the town, wanted to meet me. We headed to what looked like a Gothic mansion, and once inside, were greeted by a maid who told us that "La Signora" was waiting for us. We entered a living room that was as large as a ballroom. On, what looked like a stage sat a small woman dressed in black. We were introduced and she told me to sit next to her ... I did.

She began asking me questions about my life and I told her I was a teacher by day and an entertainer/musician by night. After dozens of questions she asked how old I was. When I said that I was 31, she asked why I wasn't married. I told her that I had been engaged about 10 years earlier, but it didn't work out and I was happy being single. She then said, we'll have to change that. She clapped her hands twice and a side door opened and all of the single girls of the town that were over 18 and still single came parading past me. A couple had better mustaches than I had. The old lady next commanded me to take my pick. I looked at Sal who was laughing hysterically, and yelled, "Get me the Hell out of here!" We left the next day for parts unknown.

Once on the mainland, I headed to Catanzaro, Calabria to visit a friend. We were treated

like royalty by his family but could only stay for a couple of days as I had a time frame to deal with. I had to be at the Naples airport on a certain date to pick up my friends who flew in from Boston. After I intercepted them, we decided to stay in Naples for a few days, and while there, I called home again. I assured my mother I was OK and when Babbononno got on the phone, he warned me about certain neighborhoods that were dangerous. Once I convinced him I would be careful, he gave the phone to my father. Dad asked for a favor. He had little information on where his parents came from. Almost all of Nanna's siblings had come to America early on, but Dad had very few relatives that ever immigrated. All he knew was that his father came from a town called San Sossio de Baronia in the province of Avellino and his mother was from another town in Avellino, but he wasn't sure

When we left Naples, we spent a couple of days in Pompeii viewing the ruins. All the while I was curious about where my father's family came from and headed for Avellino once we left the towns around Vesuvius. I totally struck out. I couldn't find any information on the Christoforo family. Only later did I discover that wasn't the way my last name was spelled. It was originally DeCristoforo or maybe DeCristofaro ... I'm not sure. When Grandpa Christoforo landed in Boston, the immigration agent spelled his name the way it sounded to him, and not being Italian, wrote out what he thought the name should be. Grandpa didn't know the difference as he was illiterate in both English and Italian.

Years later, my son, John, would accidently discover family in Zurich, Switzerland and when I met them, would find information as to who they all were and where they are living now. After the Italian unification, most of the DeCristoforo men left Italy for Latin America: Argentina, Uruguay, Brazil, Venezuela, Cuba and Puerto Rico. Only one came to the United States

In Italy, La Festa della Mamma or Mother's Day is celebrated on the second Sunday of May, just as it is in the United States. La Festa della Mamma is a very special holiday in Italy, yet not as commercialized as it is in this country. It's recognized as more of a day to spend time celebrating and pampering mothers, more than it is about cards and gifts. Italian mothers have always been the heart of the family and nothing means more to them than caring for their own. Because they are the caretaker of the family all year, on their special day the family pampers them. Pampering mother could be treating her to brunch paired with flowers and a handwritten poem, taking her to dinner at her favorite restaurant, or even baking one of her favorite pastries or desserts. What matters most to Italians on La Festa della Mamma is that everyone in the family comes together and celebrates la mamma.

Mother's Day was always a day I spent with my own mother. As a family we would go out to breakfast or lunch together (of course my Nonna came too), and later in the day it was "coffee and pastry" at mom's house. There would always be a variety of desserts to choose from and my mom's favorite were the puff and cream pastries. She especially loved puff pastry filled with fresh whipped cream. In Italy, they refer to these as Cannoncini or "little cannons". In remembrance of my mother, this week I am sharing an easy to make version of Italian Cream Horns and I hope you enjoy them as much as she did. To all of the mothers with us today and for those who have gone but forever remain in our hearts, Buona Festa della Mamma!

# **ITALIAN CREAM HORNS**

Cannoncini



#### **Pastry Horns**

1 sheet (1/2 pound) Puff Pastry, thawed 1 egg beaten with 2 tablespoons milk Confectionary sugar to dust

#### Stabilized Whipped Cream

- 1 teaspoon gelatin (unflavored)
- 4 teaspoons cold water
- 1 cup heavy whipping cream
- 1/4 cup confectionary sugar
- 1 teaspoon vanilla extract
- (5-inch cannoli forms are needed or if you prefer a cone shape, you can cover ice cream cones with foil and use them in place *of the metal forms)*

#### **Shells**

Preheat oven to 350°. Line a baking sheet with parchment paper, set aside. Generously butter cannoli forms. Dust flour board/ counter with confectionary sugar and lay pull pastry out. Dust top of pastry as well and gently roll out to exceed about an inch around all of the borders. Cut dough into 8-10 strips. Carefully remove strip and roll pastry over form, overlapping as you go and pressing gently to ensure dough is adhering to form. Brush with egg wash, dust with powdered sugar, and place on prepared baking sheet. Leave space between each pastry horn to allow room for puffing. Bake for approximately 12-15 minutes, or until puffed and golden brown. Cool and carefully remove from forms, set aside.

#### Whipped Cream

In a small microwave safe bowl or I cup measuring cup, add gelatin and water, mix well. Let this stand for a few minutes until starting to thicken. Then place the bowl or cup in a microwave and cook for about 7-12 seconds, checking every few to be sure it liquefies, set aside.

In a large mixing bowl add cream, confectionary sugar and vanilla, mix well and then beat together until thickened. Once thickened, gradually add the gelatin mixture (if the gelatin hardened, microwave again until liquefied or you will have lumps), while continuing to beat until stiff peaks form. Place finished cream into a piping bag (can use a Ziplock bag) with a star tip attached and pipe cream into each pastry horn. Place cream horns on a platter, dust tops with confectionary sugar and serve immediately (cream can also be refrigerated, and pastry horns placed in an airtight container for later use).

#### Collapse of the Soviet Union

The Soviet Union's losing streak in Afghanistan may have started the dominoes but the true beginning of the end of the Soviet Union was the election of Mikhail Gorbachev in March of 1985. Gorbachev had a long history as a member of the Soviet Communist Party, but from the outset of his election, perhaps because after sixty years it was obvious that communism had failed tremendously in Russia, he sought to reform the nation through what must have seemed radical steps indeed.

For one thing, he granted freedom of expression and all voices were welcome in the media, including those critical of the government. Parties other than the Communist could run in elections and many political prisoners were released. He encouraged the private sector to run businesses and international trade.

Gorbachev's initiatives, however, were slow to produce results. Undoing sixty years of totalitarianism would not be a fast task and, inevitably, the long-suffering populace grew impatient.

If there were positive outcomes to Gorbachev's government immediately visible,

they were happening elsewhere in Eastern Europe. The non-Communist parties of several countries such as Poland, Czechoslovakia, and Romania had overthrown their Communist leaders by the late '80s. By the early '90s, these singular revolutions made their way into the Baltic countries and the USSR soon lost Estonia, Latvia, and Lithuania.

Realizing they were in dire straits, the Communist Party put Gorbachev under house arrest in August of 1991. Indeed, the opposition was advancing quickly to Moscow with the intent of overthrowing the Communist parliament much like it had in surrounding nations. A rallying of supporters by Parliament Chari Boris Yeltsin, however, led to the defeat of the coup in three days.

Seizing an opportunity to shine, Yeltsin granted independence to both Belarus and the Ukraine that December, all but one of the remaining Soviet states followed and by Christmas of 1991, the Soviet Union had collapsed. Gorbachev, as expected, resigned as president saying, "We're now living in a new world. An end has been put to the Cold War and to the arms race, as well as to the mad militarization of the country, which has crippled our economy, public attitudes, and morals.'



#### Jerry Quarry Vs. Jimmy Ellis

A Disappointing Fight
Capped WBA Tournament

Fifty years ago, not long after Muhammad Ali was stripped of his title, the World Boxing Association organized a tournament to find a successor to the heavyweight throne. While the reason for this was based on an injustice, it did cause a sorting out of the contenders. At the time, Ali had pretty much beaten everyone worthy of a shot. There were a number of young fighters with much potential, but none was ready for prime time with the Champ. Among them were Joe Frazier, Oscar Bonavena, Thad Spencer, Leotis Martin, Jerry Quarry, and Jimmy Ellis.

There were also the veterans who felt they still had much to contribute. Among this group were Floyd Patterson, Ernie Terrell, Karl Mildenberger, Henry Cooper, and George Chuvalo. All had been beaten by Ali but would like another chance.

The fighters chosen to compete in the WBA Tournament were a mixture of the old and the new. Those picked to participate were Leotis Martin, Floyd Patterson, Thad Spencer, Karl Mildenberger, Oscar Bonavena, Ernie Terrell, Jimmy Ellis, and Jerry Quarry. Joe Frazier was asked but refused to take part. He said he would be happy to take on the winner.

The first two bouts took place in August 6,1967 in Houston, Texas. These bouts set the tone for what would turn out to be a series of upsets in the tournament as almost every favorite went down to defeat.

On that day young Thad Spencer upset Ernie Terrell by a 12 round decision while Jimmy Ellis defeated Leotis Martin when their fight was stopped in the 9<sup>th</sup> round when Martin was unable to continue due to a cut mouth.

The upsets continued over the following months as Oscar Bonavena beat Karl Mildenberger and Jerry Quarry won a decision over Floyd Patterson.

This led to the semifinals where Jimmy Ellis won a decision over Bonavena and Quarry stopped Thad Spencer. All were exciting fights and proved the young crop of contenders were worthy of competing at the top level.

The final match for the WBA Title was a much-anticipated

fight between Jimmy Ellis and Jerry Quarry set for April 27, 1968. Both had been very impressive in their victories, and a very exciting fight was expected. That expectation was not met.

In what turned out to be a great disappointment. Jerry was a terrific counter puncher, but Jimmy would not fall into any of the traps he laid for him. This led to many times in the bout where Quarry would be waiting for Ellis to lead and Jimmy would not. At one point a frustrated Quarry beckoned for Jimmy to come to him. Jimmy didn't. Ellis made good use of his sneak right hand which kept Jerry off balance.

After fifteen rounds, Ellis was awarded a majority decision with two judges giving him the nod and one ruling it a draw. Though the fight was tedious to watch, Ellis must be given credit for fighting a wise tactical fight. He did not fall prey to any of the traps Quarry set for him. His job was to win the fight not keep the fans happy. He also kept Jerry off balance by using his right hand and left jab, though sparingly. It appeared Quarry just couldn't get started. A boxing purist would have found the fight interesting, but the average fan was yawning.

Mark Kram writing in *Sports Illustrated* found the fight much more interesting than the fans did. I agree with his analysis:

"Ouarry's performance in the ring was less striking. A crowd of 14,000 paid to see him exhibit lifelessness, inexperience, and much ineffectual punching. It watched Ellis, once almost ruined in the middleweight division, create a tactical masterpiece that, though soporific to television viewers and the live crowd, was demanded against the deadly counterpunching of Ouarry. Ellis was intelligent and cruel with his long, slashing right hand. Even more than the right and his ring generalship, his jab was the decisive weapon. His fight belonged to those who appreciate delicate artistry, not

to those who only recognize heavy-handed slaughter."

A month before the Ellis vs. Quarry fight Joe Frazier won a version of the heavyweight title when he kayoed Buster Mathis in New York. With the two now owning a piece of the title it was expected a showdown between them would not be far off. However, that fight would not occur for two years.

Ellis decided to first defend the title against Floyd Patterson. In a fight that took place in Sweden on September 4, 1968, Jimmy won a hotly disputed decision over the former two-time champ. The fight was broadcast live on home television and Ellis's chances of beating Frazier were greatly diminished by his performance. Not only that, but he was cut and his nose was broken in the fight. It would take time for him to heal.

Over the coming months there was such talk of Jimmy having a fight to regain his stature before facing Frazier. The names Henry Cooper and Gregorio Peralta were floated but nothing materialized. Instead, Ellis signed to fight Frazier for a fight to take place on February 16, 1970.

Frazier had stayed active while Ellis was idle, defending his title four times. Joe was the prohibitive favorite. When the fight took place Joe demolished Jimmy and laid claim to being the undisputed heavyweight champion. This would in turn lead to the greatest showdown when Joe and Ali met in the ring a year later.

The tournament was a good thing for boxing in the sense that it gave exposure to a new group of contenders. It was also ironic in that the man who benefited most from it did not participate. Joe Frazier made a smart move in waiting it out and taking on the winner.

It's also interesting to note that while the Quarry vs. Ellis fight was a disappointment, and the Frazier vs. Ellis fight lacked drama because the outcome was pretty much a forgone conclusion, when the fight that truly would settle the question of who was the true Heavyweight Champion took place it turned out to be one of the greatest fights of all time. That was the first Ali/Frazier fight in 1971.

# HOOPS and HOCKEY in the HUB

CHANTS FOR CHARA — Sounds of appreciation and respect emanated from the stands as former Bruins captain Zdeno Chara finished the final game of the regular season with the New York Islanders on April 29<sup>th</sup>.

Whether that game, won by Tampa Bay 6-4 at UBS Arena (the home of the Islanders), will be the last for Chara remains to be seen. If, and we stress the word if, it proves to be the last time we see Chara in competition, let it be known that he left in a memorable way.

Somewhat like Ted Williams, who hit a home run in his final game in September of 1960, Chara scored a goal in his final game — at least the final one for this year.

As the New York Post reported: "The lasting memory of the night, for anyone in attendance, will be Chara's name being chanted from the rafters as every single person on the ice—the Islanders, the Lightning, the referees—shook his hand. As the night wound to a close he would skate alone on the ice, hand to his heart, and give the crowd a salute."

**BRUINS AND CAROLINA HISTORY**—The Bruins and Carolina go way back — to the time when the Carolina franchise was based in Hartford.

During that time, the two teams met twice in the playoffs with the B's eliminating the Whalers on both occasions in the division semifinals. Current Bruins President Cam Neely played a role in both series. In 1990 Neely picked up a goal and an assist in a decisive game seven. One year later Neely led the B's in scoring with five goals in six games as the B's gave the boot to the Whalers once again.

The 1990s closed with Anson Carter scoring a double overtime tally in game five while goaltender Byron Dafoe followed with a shutout win in game six to eliminate the Hurricanes, who had moved to Raleigh in 1997.

Eleven years later in 2009, Carolina's Scott Walker scored an overtime goal in game seven of the conference semifinals to eliminate the Bruins while in 2019 B's goaltender Tuukka Rask picked a great time to record his seventh career playoff shutout (in game seven) as the B's eliminated the Canes in the Eastern Conference final.

Then in 2020, it was bubble time as the two teams met under COVID-19 restrictions with the Bruins emerging as victors in a first-round series that went five games.

BIG WINNERS — AND BIGGER LOSERS — Yes, the Celtics certainly were the biggest winners of the first round of the NBA Playoffs, sweeping the Nets, who had once been hailed as championship contenders, into a summer of oblivion. Plus the series between Boston and Brooklyn drew an average of 4.8 million television viewers, the best stats for an NBA first round series in six years.

But it turns out the setbacks on the court for the Nets may not have been their only losses. It turns out that Joe Tsai, who owns both the Nets and the Barclays Center — where the Nets play their home games — is set to experience some financial losses as well.

How much? Well the *New York Post* reports the red ink may come in barrels that are between \$50 million and \$100 million deep. And that is just for the 2021-2022 season.

Tsai spent heavily on star players — putting together his version of the Big Three in Kevin Durant, Kyrie Irving, and James Harden. They never really meshed in the regular season, playing only 16 games together — between injuries to Durant, Irving not playing because of his unvaccinated status, and Harden demanding a trade at midseason.

But as the playoffs arrived, Durant and Irving were expected to carry the team with several New York writers predicting that the Nets would prevail over the Celtics. That never happened so the Nets sit sidelined while the Celtics continue onward in the playoffs.

**BOSTON AND THE BUCKS PLAYOFF HISTORY** — In addition to their current matchup in the Eastern Conference semifinals, the Celtics and the Bucks have met in the postseason on only two other occasions in the 21st century.

The last time the two teams met in the playoffs was the spring of 2019. The Celtics entered the series following a first round sweep of Indiana. Things were looking up as the C's continued their winning ways in Game 1 against the Bucks, defeating them 112-90—in Milwaukee, no less. Irving, then with Boston, led all scorers with 26 points and 11 assists.

However, the Celtics went on to lose the next four straight games — including both at the Garden — as Milwaukee eliminated Boston, 4-1. Irving led the team in scoring in three of those four losses. Three of the four setbacks came via double-digit deficits, including a 116-91 blowout in game five.

In 2018, the Celtics eliminated the Bucks in a first-round series — with the C's coming up with a convincing 120-106 game seven win. The Celtics then beat Philadelphia but lost to Cleveland in the Eastern Conference Finals.

Additional matchups took place back in the 1980s. Boston faced the Bucks four times in the playoffs during that decade, winning three series and losing one.

In 1983, the C's were swept by the Bucks in the Eastern Conference semifinals while the next year (1984) they knocked off Milwaukee in the conference finals before losing to the Los Angeles Lakers in the NBA Finals

In 1986, the Celtics, coming off a fantastic regular season that saw them lose only one home game, eliminated the Bucks in the conference finals. They then downed the Houston Rockets in six games to win the NBA Championship.

The next year (1987), the Celtics got by the Bucks in a seven-game conference semifinal series, then topped Detroit in the conference finals but lost to the Lakers in the NBA Finals.
