The Massachusetts Interscholastic Athletic Association will honor former Ambassador and Former Mayor Raymond L. Flynn on June 25th, with the Lifetime Humanitarian Award at Gillette Stadium. Also being honored that night, along with Ray Flynn, will be Jerry Remy, Mike Eruzione, Tony Conigliaro, Dick Jauron, Matt Hasselbeck, and Sarah Behn. They are some of the greatest athletes ever to grow up in Massachusetts and to leave their mark on the baseball diamond, the Olympic ice, women's basketball, and the NFL.

Ray Flynn was an All-American basketball player at Providence and was the last person cut by the Celtics in 1965. He then spent his life in support of youth and youth at risk all over the world. It is fitting that Ray Flynn is recognized by his peers not only for his basketball prowess but for those he helped along the way.

A lot of people don't know just how much Ray Flynn has done while he was in office and before he was elected to help others of all races and socioeconomic levels. In 1965, Ray began the first summer league basketball program at M Street Park for those 18 and under. A few years later he took on the mantle of Softball

Commissioner on the other half of M Street Park. He did this while working full time as a Probation Officer. The summer basketball program caught the eye of an NBA ref from Boston named Kenny Hudson and the concept spread throughout the city and was called the BNBL.

A few years later Ray intro-

duced the Ray Flynn Basketball

Tournament and teams from

all over Boston competed. Ray knew the importance of sports in

society and many of those play-

ers in the Ray Flynn Tourney

became lifelong friends.

As an elected official he continued to advocate for boys and girls throughout the city. In 1974, the city was on edge, as the forced busing program was about to be implemented.

In late August there were riots

expected to take place on Carson Beach. Ray ran a program called Southie Day at Marine Park to keep the kids away from Carson Beach and maybe head off the violence that was predicted. It worked. It worked so well in fact that Southie Day became a summer staple for the next twenty years. When Ray was elected Mayor, the city was a powder keg ready to explode. The hottest spot was at a place called Wainwright Park where black and white kids were at each other's throats because there was only one basketball court which they both wanted to use. Ray went over to the park and met with both sides and hammered out a deal and set a celebrity basketball game at the park in which both black and white kids would play together on the same team against celebrities like Dave Cowens, Kevin Stacom, Carl Weathers, who played Apollo Creed in Rocky, and many more celebrities. He also had a state of the art outdoor hockey rink built in the park and, soon, the flame that was about to ignite was put out.

In his second year as Mayor he started the BHA Unity Days where his idea of bringing celebrities together for a game of bas-

Stirpe Nostra

THE JUNE BRIDE



Here's to the flowers that bloom in June ... and to each signorina who'll be wedded quite soon ... select your maids and their colors ... even the church and the room ... but baby, you ain't going nowhere ... without a good looking groom!

Marriage among the ancient Romans was intended to be a complete union for life between a man and a woman. The main objective was, of course, the procreation of children. To marry and beget children, who could keep the sacred family alive, was the religious duty of every Roman, and it was also a religious duty to the state.

A Roman civil marriage was entered into either "cum conventione" (with a contract), or "sine conventione" (without a contract) and the difference was in the legal status of the wife. The law also placed restrictions on those persons who could marry and those who could not.

Generally, persons who had the right to kiss each other could not marry each other, and any union between prohibited marriages was considered to be one of incest. In early times there could be no marriages between senators and freedwomen (former slaves), or between cousins up to the seventh degree. Other types of prohibited marriages were between ascendants and descendants, between a man and an adopted daughter, grandmother, or niece. Brothers and sisters could not marry except if one was adopted.

Marriage formality was a matter of preference. Some were very simple while others were quite formal. Wedding day superstitions were never ignored. I'm sorry to have to say it, but the full month of May and the first half of June were considered to be unlucky, as was February 13th through 21st, March 1st through 15th,

August 24th, October 5th, the first day of any month, and the fifteenth day of any month (the Ides).

During the "sponsalia" or engagement party, in addition to the formal announcement by the parent or guardian, the symbol of betrothal was the gift of presents, and a ring to the girl from her fiancé. The ring was either made of iron (el cheapo) or gold (el sporto), and it was always worn on the third finger of the left hand. It was said that when a human body was dissected as the Egyptians used to do, a delicate nerve was discovered that starts at that finger and travels to the heart. Because of this connection, it was called the heart finger and is consequently considered to be most appropriate for the wedding ring.

City of Boston **Recruits City Residents for EMT Apprenticeship**

The City of Boston has launched and registered a new Emergency Medical Technician (EMT) apprenticeship with the Massachusetts Executive Office of Labor and Workforce Development that provides paid, hands-on learning for new hires with Boston EMS. The apprenticeship will include a six-month EMT-Recruit academy and six-month fieldwork as a Boston EMS EMT. The apprenticeship is part of a larger effort and partnership with the Mayor's Office of Workforce Development (OWD) to help Boston EMS enhance recruitment efforts, attract diverse candidates, and open pathways to good pay, benefits, and career advancement for Boston residents.

"Apprenticeship lays out an ideal career pathway for residents who want to work hard and learn a vocation, but who may not be able to afford a costly degree," said Trinh Nguyen, director of the Mayor's Office of Workforce Development. "In this way, the apprenticeship model plays a key role in the Mayor's vision to expand economic opportunity for city residents. Apprentices with Boston EMS can earn while they learn, gain industry-recognized credentials, and benefit from built-in wage increases that match their skills advancement."

"Training is essential for ensuring the best possible patient care and all hazards response capability," explained Boston EMS Chief of Department, James Hooley. "The apprenticeship formalizes our longstanding investment in the education and mentorship of our new hires."

The EMT apprenticeship has two components:

- 1. Boston EMS Recruit Academy. In the six-month academy, spend three months in the classroom learning, including additional clinical skills, situational awareness, all hazard preparedness, and documentation training, as well as three months in the field providing patient care while being supported by field training officers. Pay is 80% of a full-time EMT's wages.
- 2. Probationary employment period. Apprentices are promoted to the rank of EMT, gaining additional field experience on ambulance shift assignments in their probationary first year of employment with Boston EMS. Pay is approximately \$57,000 per year, plus benefits. These training components, in addition to a pre-apprenticeship EMT course that prepares applicants for certification, count toward the 2,000 hours required for apprenticeship.

City Academy, an OWD-run training initiative that prepares residents for City jobs, is committed to supporting Boston EMS in recruiting residents for the EMT pre-apprenticeship and apprenticeship. City Academy prepares aspiring EMTs for apprenticeship with a bridge course to develop their CPR, first aid, and job readiness skills. The initiative also covers the costs of the prerequisite EMT course, which — at \$750 or more — can otherwise pose a barrier to low- or middle-income residents.

All candidates who successfully complete the Boston EMS EMT hiring process, which includes a written and practical exam, will be enrolled in the EMT apprenticeship.

OWD coordinated the registration of the EMT apprenticeship with the state's Division of Apprenticeship Standards. The new apprenticeship status of the Boston EMS training program makes it eligible for funding sources earmarked for apprenticeship — a cause that enjoys wide bipartisan support. Another benefit of registered apprenticeship is that the state monitors the program for adherence to federal standards. This verification could make it easier for the EMT apprenticeship to establish articulation agreements with local colleges to award academic credit for apprentices' workplace learning.

OWD has facilitated similar agreements through the Greater Boston American Apprenticeship Initiative — a wide-ranging effort among the City of Boston, local colleges, job training programs, and labor unions to expand apprenticeship opportunities for Bostonarea residents. The initiative provides pre-apprenticeship training and apprenticeship placement in Boston's thriving construction and hospitality industries.



"Tony" truly enjoyed life and being with his friends. He loved to cook and eat, and was a true gourmand. Don't Wait in Line — Seize the Moment

Yet it is one essential vital quality for those who seek to change a world that yields most painfully to change." - Robert Francis Kennedy

Growing up in the '50s and '60s, I was filled with dreams, hopes, and fears. I remember the Cold War with the Soviet Union. It wasn't a war like those before, but one of values and many missed opportunities. Often we would let our fears control us both individually and nationally. "Better Red than Dead." FBI Director J. Edgar Hoover and a generational bunker mentality! We thought like our TVs: only in black and white. Anything else might have confused us.

I started getting involved in politics at age 12. Yes, 12. Ward 8 in the South End is the birthplace of James Michael Curley. A crew of eight kids, we were out there campaigning for Jack Kennedy in 1960. Ten years later in 1970, as a young college student, I did a little fielding in Frank Bellotti's run for governor. Then, the quality of candidates varied for a while.

However, in 1968, the nation was rocked by violence. Dr. King and Bobby Kennedy were both assassinated. The Democrats boiled over in Chicago. George Wallace ran as a strong third party candidate.

I was a Bobby Kennedy sup-

porter and was inspired by his actions and words. He was truly a transformative figure in politics unlike any candidate I saw before or since. He was more than a politician. He was an inspiring leader who wanted to make America a better place and all of us better people. Most politicians usually take a safe route; more about them than us.

Bobby Kennedy thought more about our commonality and our desires to do well. We never got to see how that would work because he was gunned down after the California primary in June1968 and when he died, for many his lofty goals were sidetracked. Kennedy was a positive force not looking for his own glory but for the good of all. When he died most of my idealism went with his passing.

Recently, I have been aiding Boston City Councilor Avanna Pressley, who has decided, like Bobby Kennedy, not to wait for the right time or moment but to press ahead even if it means to anger others who see themselves as being usurped by a new bee.

In the District 7 congressional fight, Pressley is taking on an incumbent who is not that much different than her. However, sometimes it isn't just the public policy aspect as much as personality, drive, and vision. I have heard Pressley speak. I recently campaigned with her in Dorchester. Hers is a new voice and new perspective. Her campaign reminds me of Kennedy's when he offered hope for a real political and governmental connection to the struggles of ordinary folk surviving everyday life, creating peaceful communities, bringing people together, making people

think for themselves, empowering themselves. Knowing that they are the government, this is their nation. The elected folk are our voices but we hold the power to change anything. This was Kennedy's whole point in running five decades ago. He was pretty much on policy not that different from Gene McCarthy or Hubert Humphrey. However, Kennedy was trying to create new politics bigger than himself and bigger than any individual. I see Ayanna Pressley as such a candidate today. Every election is important. This year will be no different. The choice is yours. What do you want? What are your hopes? What are your fears? What are your dreams for you and your children? What matters most to you?

I will be voting in September for the candidate who will listen to us and empower us to walk as one. I don't want someone to lead me or follow me but to be with me. I think that person looks very much like Ayanna Pressley and therefore she is my candidate. Let us — you and I together — transform the American landscape.

L'Anno Bello: A Year in Italian Folklore

June: Italy's Lovely Month of Summer

Ah, June! No other month brings as much joy to the heart of this schoolteacher. June is inextricably linked to summer in my mind. It means eightyplus degree days when I open every window, trying to catch a pleasant ruffle of a breeze. It is days spent walking by the seashore, inhaling the salty scent of the ocean and listening to the plaintive cries of the gulls. June means days of ice cream dripping down cones and strolls in the late-evening sunshine. Finally, June means the last school bell of the year, opening up a summer full of possibility and hope. Yes, I truly love June, and so did my ancestors over in Italy. For June in Italy boasts a number of holidays that revel in the summery nature and outdoorsy aspects of the month. In truth, June can be an overwhelming time to visit Italy, as that is when most of the tourists descend, combining crowds with hot temperatures. However, those who go outside of the well-beaten tourist path will greatly enjoy this beautiful month in Italy, especially because of one of these four traditional festivities.

1. Festa della Repubblica (June 2nd): In the simplest terms, one can think of *la Festa* della Repubblica, or "Feast of the Republic," as Italy's independence day, a rough equivalent to our Fourth of July. This feast honors the date in 1946 when, after the turmoil of World War II, Italians voted on creating a republic rather than a monarchy. Nearly everything - banks, stores, tourist sites, museums — is closed or operates on holiday hours. Instead, Italians celebrate by watching parades and attending outdoor parties or concerts. Expect to see the Italian tricolor flag, with its bright hues of red, white and green, adorning landmarks and waving from people's homes. La Festa della Repubblica appropriately occurs in the summer, when people can take advantage of the lovely weather to go outdoors and show their communal pride in being Italian.

2. Festival of San Ranieri (June 16th-17th): The feast of St. Rainerius, or San Ranieri as he is known to Italians, encompasses two days of merriment in the Tuscan city of Pisa. The eve of the feast day, Pisa celebrates its patron saint by lighting up the city's buildings with over 70,000 glass-encased candles. These lumini cast a warm, romantic glow against the meandering Arno River. A fireworks display caps off the night's festivities. The next day, people gather to watch a regatta, or boat race. I find it interesting that this quaint and local holiday includes the two biggest hallmarks of solstice celebrations — fire and water—giving Italians cause to honor the sweet delights of midsummer.

3. Saint John's Day (June **24**th): This is one of my favorite holidays. It commemorates St. John the Baptist, the major religious figure who baptized Jesus, though many traditions originated from the pre-Christian festivities celebrating the summer solstice. In Northern Europe, St. John's Day is known as Midsummer since it falls so close to the summer solstice. People celebrate with rites honoring the sun (the summer solstice) and water (St. John the Baptist): building maypoles, floating garlands of flowers down streams, lighting bonfires. In Italy, this is la Festa di San Giovanni Battista. In the Lake Como region, people float hundreds of delicate lanterns on the lake and later continue the theme of light by enjoying a fireworks display. Florentines celebrate with a medieval tournament, while also holding a procession of rowboats carrying candles drifting serenely along the Arno River. These festivals perfectly capture the magic of the longest night of the year, harnessing the power of the sun and honoring the life-giving qualities of water.

4. Feast of Saints Peter and Paul (June 29th): Rome celebrates the feast day of two of the most important figures of early Christianity with great fanfare. The commemoration of St. Peter and St. Paul, or San Pietro e San Paolo, includes a special Mass from St. Peter's Basilica in the Vatican (St. Peter was the first Pope). Many businesses in Rome are closed for the day as people admire elaborate flower carpets — a summer symbol – outside St. Peter's Square. Like many summer holidays, the day ends with a fireworks display.

Of course, there are plenty of other ways to enjoy June in Italy. Lots of little festivals, known as sagre, dot the Italian landscape. These small holidays frequently devote their attention to a specific crop, and during the summer that can mean anything from peaches to strawberries to herbs. One of the best aspects of Italian holidays is that they so connect to the rhythms of the Earth and encourage reflection in the present moment. So, no matter how you celebrate, make sure to give thanks for the wonderful month of June and all of the delights it offers!

Martyrs of Gorkum

The Martyrs of Gorkum refers to a group of 19 Dutch Catholic clerics and friars put to death with great cruelty by militant Protestant Calvinists. The event took place in Gorkum, Holland on July 9, 1572.

During this period, various forms of Protestantism particularly, Lutheranism and Calvinism - were spreading through a great part of Europe. Holland was under the rule of staunchly Catholic Spain, Emperor Charles V and his son King Philip II instituted a systematic campaign to root out such "heresies." This caused much bitterness and hatred towards Catholics.

The storm of protest that had reached Holland was followed by a struggle between Lutheranism and Calvinism in which the latter was victorious.

It was demanded of each of the nineteen prisoners that each abandon his belief in the Blessed Sacrament and in papal supremacy. All remained firm in their faith. The Martyrs were hanged despite a letter from Prince William of Orange ordering their release and protests from the magistrates of Gorkum. The men were thrown half-naked into the hold of a ship on July 6th, and taken to Brielle to be killed in the presence of a Protestant nobleman, William de la Marck, Lord of Lumey, who was a noted anti-Catholic. Their bodies were mutilated both before and after death and then thrown into a ditch. In time, in order not to lose the remains of these great men, their remains were exhumed and brought to Belgium for protection. After many years, they were recovered, and various relics are conserved in an urn in the Basilica of the Martyrs of Gorkum, in Brielle, Holland.

The Martyrs beatification took place on November 14, 1675, and their canonization on June 29, 1867, by Pope Pius IX. For many years the place of their martyrdom in Brielle has been the scene of numerous pilgrimages and processions. The Feast of the Martyrs of Gorkum takes place on July 9th.

Seventy-five years after its 1943 Broadway debut, Oklahoma! remains one of the most beloved American musicals. Its anniversary is celebrated with an upgraded deluxe edition, and a vinyl release featuring the original show sequence on 13 tracks. The Zappa Family Trust and UMe continue to reissue classic Zappa albums, by pressing and releasing his long-out-of-print records back on vinyl. Next up in the ongoing vinyl initiative is Zappa's enigmatic Burnt Weenu Sandwich, unavailable on vinyl for more than three decades; Zappa last released this on vinyl in 1986, in the rare Old Masters Box Two. The LP, will feature the album's distinctive original cover art by Cal Schenkel and include the original album's black and white poster, which has never been reproduced in any of the album's CD editions. A Nostalgic Remembrance



was teaching at Hyde Park High School. In an attempt to earn a master's degree, I began taking graduate courses at my alma mater, Boston State. Since my sophomore year at Boston State (now UMass, Boston), I was playing music with any bandleader that called. For the most part, most of the playing I did was with the Ken Reeves Orchestra. One of Reeves' leaders was a man who had been opposed to my playing my first job with a Reeves band, a yacht club party that he was leading. This same man now requested my services each week. His name was Don Ellis, a tenor sax player who had memorized thousands of songs and could play a dance, wedding, or any kind of a reception without a piece of music in front of him.

During my second summer with the Reeves Office, Don Ellis, pianist Hank Gilsdorf, drummer Al Priest and I played weekends at the Chatham Bars Inn. Ellis put me in as one of the drivers with the stipulation that I pick him up and drop him off. I was still living in East Boston at that time and he in Arlington. Each Friday afternoon, I would be ready to head to the Cape after picking Don up and we would wend our way through the Friday afternoon traffic heading south. Because Don led bands for the Reeves office and Ken Reeves catered to old Boston society, Don used Ellis as a professional name. I didn't know that his real last name was Alessi until I saw his driver's license one day. When I questioned him about it, he admitted he was Italian, "I'm not only Italian, I'm Sicilian. Reeves wants all of his leaders to have Anglo sounding names so, I use Ellis." (I wonder if Don was related to "THE" Don Alessi?)

Playing for the folks who vacationed at the Chatham Bars Inn was easy. The management put us up, fed us in the main dining room from the guest menu and allowed us to drink on the house. I didn't drink, but a couple of the other musicians made up for it. Although tney were never arunk, tney played Gershwin or Cole Porter tunes with a glow that only 80-proof could cause. What I also enjoyed was my share of the tips. There was a large brandy snifter located on the piano and Hank the pianist would always put a couple of dollars in it before we began to play. When someone would approach us with a request, a tip was often given to us, and as we were packing up for the

It was May of 1961, and I night, Don Ellis would count out the money and divide it four ways. For most of the guests at the resort, money was not a problem and we did rather well satisfying their musical requests.

Well, that first summer season came to a close and we played our last weekend around Labor Day. When I dropped Don Ellis off, he said he would be calling. This seemed strange, as I usually received my assignments via phone calls from the booker at the Reeves office or via a weekly postcard which listed the jobs, locations, and time frames.

Each time I returned home, I had to have a glass of wine with Babbononno who lived the life of a musician vicariously through his grandson. He had long since stopped playing but wanted to remain part of the business through the stories of his sons, Uncle Paul and Uncle Nick, his son-in-law my father, and me.

Later that Labor Day week, I received a call from Don Ellis asking me if I could drop by his house during the week. When I was able to sit with him over coffee and cake, he told me that he was leaving the Reeves office after decades of leading bands for Ken Reeves. He had made contact with the owner of Carroll's Restaurant in Medford. They were setting up the down stairs area of the restaurant as a function room and Don was going to be their musical director for events booked in that room. Don would be taking pianist Hank Gilsdorf with him but no one else from the Reeves office was interested. He hired a drummer from Canada, named Rene Jacques, and if I wanted to join them as the bassist, this would be the nucleus of the band that would play all the functions held downstairs at Carroll's. On many occasions, the band would include trumpets, trombones, and other sax players. Don had music stands made up for the stage and always had music for the tunes we played, but he never needed the music himself. Everything we played was memorized.

I stayed with the band for about a year or so. The only nights I couldn't work were the nights I was taking my graduate courses. I tried to take courses that were offered in the afternoons or during the evenings of the early part of the week. This allowed me to be able to play about five nights per week and Saturday and Sunday afternoons. As a result, I was making more money as a musician than as a fledgling school teacher. Once I finished my courses, I began to think about expanding my horizons as a musician. As a result, I began making connections in New York hoping to break into the jazz circles there. At the same time, I got hooked up with a comedian I had known at Boston State, Bob Blasser. He was doing comedy shows locally and was also trying to make some headway in New York.

Bob, an ex-seminarian, was friendly with Cardinal Cushing and each time a Catholic serviceman from the local area was killed in Vietnam, the Cardinal would put a show together as a fundraiser for the soldier's family. We were the show. I was asked by Bob's music director to join the band at the last minute and when Bob and I saw each other, it was the renewal of a friendship that started back at Boston State. Within a year, the music director and Bob had a falling out and he quit. I was asked to take over the band and became the music director of the Bob Blasser Show. Later, as we became involved in the New York scene, we became partners in the production end of things.

On my own, I began working with some of the jazz musicians in New York. It didn't hurt that I was Johnny Christy Jr., or that I was Nick Conti's nephew. Both Dad and Uncle Nick had reputations that were held in high esteem both here and in the Big Apple. This opened the doors in New York, but from that point on, I had to prove myself with talent, not family recognition and hopefully, I did.

Bob Blasser playing shows for Cardinal Cushing led to him making inroads for us in New York. We did shows there, and as writers and actors, became involved with Candid Camera. Babbononno thought I was crazy, but when I told him what the money was like he backed off. Allen Funt, the producer of Candid Camera, set us up with writing and performing in a commercial for Alka Seltzer. This led to an interview with Otto Preminger, who opened a few doors for us in Hollywood. That really impressed Babbononno, but, I'm out of space and that's a story for another day.

Recipes from the Homeland

ROLLED GREY SOLE FILLET with Rice and Shrimp Stuffing

6 grey sole fillets* 1/4 pound medium shrimp 20-25 Ritz or Hi Ho crackers 2 tablespoons butter or margarine

1 tablespoon mayonnaise 3 tablespoons white wine 1/2 cup water or clam juice 3/4 cup rice of choice

*Fillet of flounder can be used in place of grey sole fillet. Preheat oven to 375°F.

Cook rice according to directions on the package. Set aside.

Peel shrimp and place in a bowl with water and set aside. Crush crackers thoroughly. Add softened butter or margarine and work it into crushed crackers. Set aside.

Drain shrimp. On a cutting board, cut up each shrimp into halfinch portions and set aside.

Line bottom of a baking casserole dish lightly with mayonnaise. Spread cooked rice over bottom of casserole.

Wash out the grey sole fillets and drain. One fillet at a time, spread some cracker stuffing mixture in center portion of fillet. Add shrimp portions over the stuffing. Starting at narrow edge of fillet, roll the fillet carefully toward the wider end to create the stuffed roll. Continue stuffing remaining fillets. Place each rolled fillet, side by side, over rice in baking dish. With butter knife, spread some mayonnaise lightly over each fillet roll. Sprinkle some cracker mixture over them and top each roll with 1/8 teaspoon of butter or margarine.

In a cup, mix three tablespoons of white wine in one-half cup of water or clam juice. Spread mixture over rice and rolled fillets.

Place casserole dish in a preheated 375°F oven to bake for fifteen or twenty minutes. Then remove baking dish from oven. Additional water or clam juice can be added to casserole if needed. Return to oven to bake until tops of fillet brown lightly and rolled fillets are fork tender (approx. five to eight minutes).

Louis kayos Baer in 1942.



I have written in the past that in many of these matchups where the champ was taking on a much larger opponent, not only did the smaller man win, but it was not even close to being his toughest fight.

Since it seems so many of these experts just can't get past believing size is the key factor in deciding the outcome of a heavyweight fight, I thought I would once again come up with an example of why someone like Joe Louis would have had no problem defeating today's crop oversized champs.

Buddy Baer was a contender for the heavyweight title in the early 1940's. He was the brother of former champ Max Baer. At 6'6" and weighing in at around 250 pounds, he was comparable in size to today's heavyweights. Buddy was also a tremendous puncher scoring 49 knockouts in his 53 wins. He lost only seven fights and was stopped just twice. Baer was also lean and agile. He had excellent boxing moves to go along with his great strength.

In 1941, Buddy stopped Tony Galento, a win that put him in position to challenge

heavyweight champ Joe Louis. The fight was set for May 23, 1941, in Washington, DC. Louis weighed in at 201-¾ to Baer's 237 pounds. Buddy, at 6'6", was also 4 inches taller and had a much longer reach. Seeing the two of them step into the ring together gives you a sense of what Louis would have looked like matched up against Klitschkoor Wilder, the one difference being that Buddy Baer was a much better boxer than either Deonty or Vlad.

Boxing experts covering the bout in 1941 were a bit savvier than those around today. They made Joe Louis a ten-toone favorite over Baer despite the difference in weight and height. The experts I hear from today would have had Baer a hundred-to-one favorite based on his size. After all, how could Louis possibly beat someone so much bigger than he was? We all know Wilder and Klitschko would just walk through Louis because of their size and strength. The same would have to hold true for Baer.

A funny thing happened when the bell rang for the start of the fight. Baer came out aggressively and went after Louis. Baer was not prone to the wild swings such as those used by Deonty Wilder. Instead, he used much shorter and better placed punches. He did back Louis up. He even managed to deck Louis with a short and accurate left hook, sending Louis through the ropes. But after that the fight became pretty much a one-sided affair. You see, Louis did something that today's experts aren't terribly familiar with; he used his great boxing skills to turn Baer's size against him. Louis was able to slip inside the big man's arms and hit him with short and powerful punches that hurt him.

Buddy Baer was no quitter and did manage to stay in the fight trying his best to overpower Louis, but by the sixth round he was nearing the end. In that round Louis floored Baer three times with devastating and accurate blows. The final

knock down finished him off. There was some controversy over the ending of the fight as Baer's handlers argued the last knock down had come from a punch that was landed after the bell. Baer was protecting himself at the time it was landed, so if the bell had indeed rung before the punch had landed neither fighter heard it. It made no difference in the outcome of the fight.

It did make a difference in how the fight was ruled. Baer was helped back to his corner and was on his stool when the bell rang for the seventh round. His handlers argued he should be given the win because of a foul. Referee Arthur Donovan did not agree and instead disqualified Baer because his seconds would not leave the ring and allow the fight to continue.

The minor controversy was enough to get Baer a rematch with Louis, and on January 9, 1942, the two met again at Madison Square Garden. This time Baer came in even heavier for the fight, probably figuring the extra weight would work to his advantage. That theory fell apart before the bell could ring ending the first round. Louis was devastating in taking the giant apart, dropping him three times in less final knockdown being for the ten count.

If you can't seem to visualize Joe Louis handling himself against the overgrown champs of today, just look at his matches with Buddy Baer. You will see how the old adage "The bigger they are, the harder they fall" applies.

Joe Louis would have no problem dealing with today's unschooled giants. They would provide target practice for him. To say a Deonty Wilkder would be too big and strong for Louis is simply laughable. Louis would have had a fall deposite him.

have had a field day with him. It should also be noted that when Louis and Baer fought the second time, WWII was underway. To help with the war effort Louis donated his entire purse of \$47,100.94 from the fight to the Navy Relief Fund. Not only was Joe Louis a great champion, he was also a great American.

HOOPS and HOCKEY in the HUB

We are now in the afterglow of a spectacular season, one that would have been virtually impossible to imagine back at the beginning of the regular season.

Yet, here were are, as we cross the threshold into June, reflecting on all that the Boston Celtics accomplished during the 2017-2018 campaign — one that seems nearly as memorable and magical as any of their numerous championship conquests of the past.

Notice that we didn't say aftermath in reference to the Celtics first week of liberty following Game 7 of the Eastern Conference Finals on the Sunday of Memorial Day Weekend.

That connotes to us a slice of negativity — something we refuse to affix to these players and coaches who came within one game of going to the NBA Finals.

Look on the back page of the Tuesday, May 29th, *Boston Herald* and you'll see the delighted image of Celtics President of Basketball Operations Danny Ainge — with a smile as broad and wide and satisfying as the sunny, summer days of June.

It was taken at the Celtics practice facility in Waltham where the C's met as a group for the final time before going their separate ways for the summer.

It's the picture of a person not wallowing in defeat but rather of one reflecting on the accomplishments achieved in the remarkable season just completed.

Those accomplishments include finishing second in the Eastern Conference in the regular season, a position that would earn them home court advantage in each of the three playoff series that they played.

That high finish in the conference and their extended run in the playoffs demolished the thoughts of the naysayers.

The negativity began on opening night when Gordon Hayward went down with a season ending injury. "The Celtics season is over," bellowed former NBA player and current *TNT* television analyst Charles Barkley over the national airwaves that night

Well, nothing could have been further from the truth — as the C's continued to win and win and win. From leading most of the way, to coming from behind, to winning last minute thrillers — the Celtics continued to post victories. Remember that 16-game win streak early in the season?

Although a good deal of the negativity from commentators subsided after that, it gained a new life when Kyrie Irving played what proved to be his last game of the season on March 11th.

If the Celtics were diminished with Hayward out, how could they possibly be a factor in the playoffs with two high profile performers on the sidelines?

We recall that just before the playoffs started, a national commentator stated that the Celtics might, just might, get through the first round but would certainly be vanquished in the second round.

That was spoken by one who obviously had not seen the team in action over numerous nights in the regular season and was relying on analytics to make his prognostication.

As we've said before, numbers are relied upon heavily in sports today. But for all those aspects that can be measured, numerous characteristics cannot — such as heart, desire, intensity, grit, grind, and good old-fashion will to accomplish the task at hand.

Those qualities are what led the Celtics to banish the Bucks and sink the 76ers. Those triumphs led to the matchup that many had predicted back in October — that the Celtics would play Cleveland in the Eastern Conference Finals. Only it was different because the two players that were supposed to lead them there — Hayward and Irving — were not available.

In addition, a subplot that was talked about in October did not take place since both players featured in last summer's big trade were not on the floor to go against their former teams — Irving as a former Cavalier and Isaiah Thomas, who was traded by Boston to Cleveland and later sent to the L.A. Lakers by the Cavs.

When Boston won the first two games of the Eastern Conference Finals someone figured out statistically that only six percent of the teams that fell behind 0-2 in NBA history came back to win a best-of-seven series.

You knew that stat was not applicable to this series in any way whatsoever. The Cavs had two poor shooting nights — and they both came in Boston — in Game 1 and Game 5. But the reason the Celtics lost the series is that they did not win one of the three games in Cleveland. If they had, the series never would have made it to Game 7.

In his postgame press conference a mere half hour after his team had lost to the Cavs in Game 7, Celtics Head Coach Brad Stevens already was upbeat, saying that he was looking forward to training camp and wished that it started in a couple of days.

Sure, there was some sadness following the Game 7 loss to the Cavs. But that one setback was overwhelmed by the accomplishments of this young Celtics team.

The Cavaliers may well be today's team, at least in the Eastern Conference, but the Celtics, with their young (and now playoff experienced) players, are the team of the future — and by that we mean the near future. Let the preparations for the 2018-2019 season begin.
