

I'm not sure if many people today know that there is a Flag Code that lists the rules for the proper respect to be shown to and when displaying the flag of the United States. Judging from the disrespectful way I see the symbol of our great country being treated, particularly on public buildings, it appears people neither know nor care about this code.

For years I have noticed how these rules are no longer followed. When I walk by a post office, a town hall, a public school, or police station, I am struck by the poor condition of the flags on display. The Flag Code states that:

"It is the universal custom to display the flag only from sunrise to sunset on buildings and on stationary flag staffs in the open. However, when a patriotic effect is desired, the flag may be displayed twenty-four hours a day if properly illuminated during the hours of darkness."

In addition it says: "The flag should not be displayed on days when the weather is inclement, except when an all weather flag is displayed."

When I was a kid in school the flag would be raised when we arrived in the morning and lowered at the end of the school day. Two students were assigned to do this. Looking out the window at this process instilled in me the importance of this symbol and brought me to think about the history behind it.

Things have certainly changed. Now when I see a flag displayed at a public building it is most likely torn and tattered. It is left up 24-hours a day and in all kinds of weather. Many



are twisted and tangled, left in deplorable condition. This is bad enough to see anywhere, but when it is on a government building it is particularly egregious.

Americans should look with pride toward our flag. When looking at it we should all pause and remind ourselves of how lucky we are to be living under this symbol of our great and good country. When we see it being mistreated we should feel as hurt as we would if we saw a family member being disrespected.

It has become popular in recent years to scoff at shows of patriotism. In certain circles it is considered cool to openly disrespect symbols like the flag and the National Anthem. This sad and dangerous mentality is taking hold.

No matter our political differences, we should all be able to stand tall and united when observing our flag and our anthem. We can use the time when taking part in reciting the Pledge of Allegiance or singing the National Anthem to look at one another and remember the motto "E Pluribus Unum," "Out of many, one." To remember we are the luckiest people in the history of mankind. We can go back to our arguing after, but let us at least show we can unite on this one thing.

Let us also not stay quiet when we see our flag not being treated properly on government buildings. This neglect is nothing short of disrespect.


# Stirpe Nostra

#### **LUNA DI MIELE**



The two previous issues discussed the premarital traditions and the vows that were taken in ancient Roman marriages. Today we continue with a description of the procession to the new home, the third part of the wedding ceremony. This was the invariable part of all marriages and it usually took place at dusk with lighted torches.

The bride was taken from her mother's arms with simulated force, reminiscent of the Sabine marriages. Torchbearers and flute-players led the procession. Next came the bride, conducted by three boys; two led her by the hand while the third carried a bouquet of hawthorns for good fortune. These boys were followed by still another youth who carried the bride's spindle and distaff, a symbol of her industry and purity. Then the guests came and anyone else who cared to join in the parade. The role of the groom in all of this was to carry a large bag

of nuts and, as the procession moved along, he scattered them to the boys in the crowd. This was a symbol of the end of childhood and also the fruitfulness of marriage and plenty. The entire procession moved toward the groom's house while all of the participants sang vulgar and indecent songs.

The fourth and last part of the ceremony started when the parade reached the groom's house. The first act of the bride was to tie some wool around the doorposts and then to anoint the wool with oil or fat to signify health and plenty. The bride was then lifted over the threshold as a symbol of the ancient marriage by capture. There are those who claim that lifting the bride over the threshold was a precaution against a bad omen in the event that the nervous newlywed stumbled as she entered her new home.

After entering the house she stood quietly as the groom approached her while bearing fire and water to signify that she was properly admitted into the family hearth and its ceremonial rites. The bride also had her little part to play; she brought three coins with her. One coin was given to her husband as a symbol of her dowry, the second was an offering to the household gods, and the third was dropped into the street as an offering to the gods for her safe journey to the new home. Her last act was to stand in the doorway and throw her bouquet of hawthorns out to the waiting guests, who scrambled for it as a lucky possession. At this point, the ceremonies were over and the "rimbrotto" (nagging) begun.

On the day following the wedding there was a second feast called the "repotia." This was for relatives and close friends, and it was when the bride was offered to the family shrine as a "matrone." A matrone or matron was a name applied by the Romans to every honorable married woman. She was highly esteemed, and when walking in the street the way was cleared for her, but she could never appear unaccompanied by either a slave or her husband. No one was permitted to touch her except her husband, her children, or her attendants. She was distinguished by her long white "stola" which, in cold weather, could be covered by a cloak called a "palla." What else can be said except "Figlio maschile e cento anni"?

## L'Anno Bello: A Year in Italian Folklore

Saving the Fruits of Summer

Ah, summer — the time of vivid sunshine, warm breezes, and days spent relaxing at the beach. It is also the time when I crave fresh fruit the most. The early summer crop of June boasts some of the juiciest, most succulent fruit around. What constitutes summer if not a big bite out of a fire-engine red watermelon, its pulp disintegrating into a sweet and refreshing drink? What else can brighten June mornings like a pile of gem-hued strawberries artfully scattered over cereal or pancakes? What about the clinking of ice cubes floating in a glass of peach or cherry juice - doesn't the mere thought of such a drink bring relief on a stiflingly humid day? Yes, summer fruits have always appealed to me, which is why I was both delighted and surprised to find that they contain a wealth of folklore and superstitions woven between their stems and vines. So let us embark on a journey of taste and the sort of lore that has been handed down from our ancestors, originating from the days when agriculture formed the backbone of almost every society.

**1. Cherries:** I love to bake with cherries. Their tartness perfectly accentuates sweet cakes and muffins. On Memorial Day, I even made a fruit crisp with a blend of peaches and cherries, and it was simply sublime. If people loved cherries so much that they wanted to guarantee a good crop of them, a Swiss superstition states that the first cherry of a tree must be eaten by a woman who recently gave birth to her first child hopefully, the woman's fertility would rub off on the tree and ensure a plethora of fruit for the next harvest. Meanwhile, Italian author Andrea Malossini asserts that it is lucky to find a twin cherry, or two cherries sharing a single stem. Another Italian proverb states "Giugno ciliege a pugno," meaning that June has an abundance of cherries!

2. Strawberries: On June 28th, look up at the sky and feast your eyes on this month's luminous full moon. If you do indeed catch a glimpse of the moon, you will see what is called the Full Strawberry Moon. The Algonquin tribes knew June's full moon as such because it coincided with the time that strawberries were ripe for gathering. A quaint legend states that if a person breaks a double strawberry (two strawberries that somehow grew together in one) in half and shared it with another person, the two would be destined to fall in love. There is still some debate about how



strawberries got their name. One version states that the little yellow seeds resembled flecks of straw, while another popular theory declares that the shoots of the plant would often be dispersed around the ground, leading the fruit to develop a name that derives from the Anglo-Saxon word for "strewn." In Italy, strawberries are known as fragole and grow wild. They are enjoyed drizzled over panna cotta or marinated in balsamic syrup.

3. Peaches: Peaches are excellent in juices, in pies and just plain cut up in delectable slices. I know it is summer when I can smell peaches in the air. It was once believed that eating a peach would impart wisdom. They are also thought to bring longevity and keep evil spirits at bay - not bad for a fruit found readily in supermarkets everywhere! In China, the country to which the fruit is native, peaches are closely associated with immortality and divinity. This is because the blossoms of the peach tree appear before the leaves do, an unusual occurrence. As such, the Chinese will often adorn doorways and gates with peach wood to drive away malevolent forces and attract good luck. In Italy, peach, or pesca, is a popular flavor for marmalades, jams and pastries.

**4. Melons**: Yes, watermelons are the quintessential summertime fruit for us in the United States, emblems of relaxation and hot weather. However, among the Romani people of the Balkans, watermelons have a far stranger connotation vampires! According to folklore, a watermelon left alone at night on the full moon has the potential to turn into a vampire, rolling around and scaring townspeople. The full moon also features in an Italian superstition about melons. Andrea Malossini writes that melons will grow fatter and fuller if planted under the full moon in March. Perhaps the hope is that they will grow to resemble the moon! For me, summer always meant my father bringing home and breaking open a fresh cantaloupe from an Italian market, revealing the sunny orange hue within. How I love these summer meloni!

So there you go a sweet bevy of fruit folklore and superstition. Hopefully this adds more curiosity and wonder to your enjoyment of Earth's bounty during the summer months. Enjoy a season of fresh fruit and healthy eating — but please, keep an eye on any melons left out overnight!

There were protest recently at Faneuil Hall put on by the New Democracy Coalition and Cooperative Ministries. As these protesters gathered beneath the statue of Samuel Adams, Kevin Peterson the founder of the New Democracy Coalition, whom I often agree with, thinks the name "Faneuil" insults African Americans to this day. Boston's has had some unfortunate history in its past.

Today's protesters of yesterday's sins need to look back to those 19th century abolitionist leaders who used Faneuil Hall as ground zero in their fight to outlaw slavery across all of America. They clearly saw the symbolism of fighting to free all slaves in the house that Peter Faneuil financed.

Changing the name of Faneuil Hall may make some people feel better but it does nothing for all Americans today, especially African Americans many of whom can trace their families back to slavery. We need to care more about how America works today for everyone. We have grown tremendously in our understanding of those grand words found on old documents that fall onto the ground far too often.

What America needs today is to continue looking forward and leaving the legacy of Peter Faneuil for yesterday's trash pick-up.







# LIZ PHAIR: WHIP SMART + whitechocolatespaceegg + LIZ PHAIR /Black Vinyl Capitol Records +UMe

Whip Smart – Chicago-bred indie-rock singer/songwriter Liz Phair's September 1994 major-label debut, followed on the heels of her galvanizing, indie-released grrrl-power manifesto, June 1993s critically acclaimed Exile in Guyville. Phair and Brad Wood co-produced Whip Smart, built on the patented "Girly-Sound" alterego promise of Exile with the hard-hitting and quite unapologetic "Supernova" (which shot to #6 on the Modern Rock Tracks Chart), the green-eyed percussive sneer of "Jealousy," and the minimalist title track, which repeatedly name checks the chorus of Malcolm McLaren's joyous 1983 new-wave ode to jump-rope gymnastics, "Double Dutch." # Nanna & Babbononno

A Nostalgic Remembrance



Last week, I was talking about working for a living, and in the case of my family, multi-tasking. What I mean is that most of the men had two jobs. Babbononno worked days building furniture and doing hand-rubbed finish work to make his creations shine. At night, he played guitar in an Italian dance band. Occasionally, he played drums in a marching band. Once in a while he would do a bit of constriction for a neighbor or "paesano" who asked for his help.

Babbononno's sons, Uncle Paul, Uncle Nick and Uncle Gino were all trained to be musicians from their early years onward. Uncle Gino played drums and worked days at the Chelsea Navy Yard until WWII was under way. He joined the Army Air Corps and fought in the Pacific. He became a businessman after the war, but left music behind.

Uncle Paul was too old for the military and stayed with his day job in the printing business. At night, he played alto sax and a swinging Dixieland clarinet. Uncle Nick was with the big bands during the '30s. After leaving the Navy once the war was over, he learned watch making at the North Bennet Street Industrial School in the North End. He never really utilized this new trade as he was in demand every night of the week playing tenor sax and clarinet, and then getting into union politics and staying in the front office as vice president of the Musicians' Union for the next 25 years.

Dad, like Uncle Nick, was with the swing bands in the '30s. When he married Mom in 1936, she went on the road with him. When I was born in '38, he left the road and returned to Boston. Listening to the advice of a close friend, he opted for a day job just as the war began. In his case, it was to teach machine shop and math at his old alma mater, East Boston High School. At night, he played with a band at a hotel lounge six nights per week. By the middle of the war, he was also coaching high school football and interrogating Italian war prisoners housed at various Boston locations.

As I said, the men in my family multitasked working both day and night and then came retirement. Babbononno retired at age 65. Nanna used to say to me, "Tuo nonno ando in pensione cosi lui potesse stare casa e farmi impazzire," ("Your grandfather retired just so he could stay at home and drive me crazy.") Poor Babbononno, he didn't know what to do with himself.

When Uncle Paul's printing company moved to Texas, he didn't want to go and found himself retired. He found a job as a starter at a golf club and continued to play music at night until he was too old to do either.

Aunt Dorothy had moved to Florida permanently just before Loretta and I were married. Uncle Nick stayed behind to help us with the wedding plans, and just after we were married, he headed to Florida for good, retiring as the vice president of the Musicians' Union. Not long after he arrived in Florida, he went to work for a society band, joined the Boca Pops and busied himself with the politics of the condo complex he and Aunt Dorothy lived in. This kept

him busy until he was about 90. Dad became involved with the problems of the Boston School Department once court ordered (forced) bussing began. He would come home all nerved up until Mom sat him down and questioned him, "Chris, do you have enough time in?" The answer was, "Yes." "Are you still enjoying what you're doing?" The answer was, "No." Then Mom, with her hands on her hips said, "Then quit. Put you papers in and retire. If you have enough time in, you'll get a good pension, plus you'll have Social Security from the music business once you turn 65."

Dad did just that. But, once he was home days, he drove everyone nuts. He secretly asked me to find something for him to do during the day. I, in turn, spoke to a friend who was one of the deputy commissioners of the State Lottery. The man owed me a big favor and I now had to call it in. When I asked him to put Dad to work, he said, "No," and then added, "I had the same scenario with my own father. String your dad along for let's say, six months. If after that period of time, he still wants a job, I will put him to work." I said OK and told Dad that I had something coming his way, but he was going to have to wait a short while. Dad said OK and the waiting began.

Within a couple of months, Dad was elected to the Board of Directors of the Musicians' Union, and when I asked him if he still wanted a job, he gave me a half dozen excuses as to why he couldn't go to work. His union responsibilities, combined with playing with a band a couple of nights per week were more than enough to keep him busy and happy until his mid 70s, when his health began to fail.

I stayed with the Boston schools for 43 years. Back in 2003, Mayor Menino put a retirement incentive package together for the police, fire, and school department. He wanted to thin out the ranks, and the amount was too good to leave behind, so I retired. But, like some of the men in my family, I had options. I began teaching on a college level a couple of nights per week and played music on weekends. I'm now down to teaching just one course, am pretty much retired from music, and am thinking of calling it quits with college teaching after this coming fall semester. Of course, I won't give up writing this column or books based on growing up

Babbononno, my father and my uncles are no longer with us, but I think I must have learned multitasking from them, first for survival, and then to prosper. I remember a night several years ago, I was babysitting and Loretta was giving a lecture. Sal Meli came over to help me with the kids, and once they were asleep, said to me, "You know, from the time you were thirteen until you were eighteen, you really screwed up." I asked why he thought that, and his reply was, "Within that period of time, you only had one job, the Seville Theater." I thought about it later that night and remembered that, after the age of 18, I worked day and night almost to the present time. Sal was right!

I sometimes wonder what it will be like for my kids. It is a different world out there as compared to when I was a kid, or Babbononno, Dad and my uncles were alive. I wonder if things will change or be the same for my boys???

## Recipes from the Homeland

#### QUICK VEAL OR CHICKEN SPECIAL

- 1 pound cubed veal stew meat or chicken breast
- 1 large ripe tomato
- 1 medium chopped onion
- 2 cloves chopped garlic
- 2 small sprigs bay leaf (optional)
- 1 fresh mint leaf (optional) 1 or 2 \*julienne potatoes
- 1 or 2 \*julienne carrots (optional)
- 3/4 cup frozen or canned green peas
- 2 tablespoons red wine 1 chicken bouillon cube
- 3 tablespoon olive oil
- 1 can sliced mushrooms or

mushrooms of choice

\*(Julienne) cut into thin long strips

Heat oil in skillet and add cut up veal or chicken breast. Stir and simmer to brown lightly. Remove only meat from skillet and set aside. Add cut up onion and garlic to oil in skillet and simmer until onion is opaque. Add cut up tomato. Stir and simmer over medium heat. Cover and continue to simmer for two or three minutes before adding one cup of water and a chicken bouillon to skillet. Stir, cover and continue to simmer mixture slowly for another two minutes. Then add veal or chicken breast to tomato mixture and bring to a slow boil. Add bay leaf and mint (optional) to skillet and stir. Continue to simmer at low heat for ten minutes.

Meanwhile, remove skin from carrots and potatoes and \*cut into thin long strips (julienne). Set aside in water in separate bowls.

When meat has cooked about ten minutes in skillet, add carrots first. Cover and cook for about five minutes. Then add potato and mushroom slices. Stir and cover. Continue to simmer until potatoes and carrots are tender to your liking. Add wine, cover and bring to a slow boil and then remove from burner.

Serves two.



#### Saints Louis Martin & Marie Azelie Guerin

by Bennett Molilnari and Richard Molinari

Saint Louis Martin was born into a military family in Bordeaux, France on August 22. 1823. Although Louis intended



to become a monk, wishing to enter the Augustinian Great St. Bernard Monastery, he was rejected because he was unable to learn Latin. After his rejection, he decided to become a watchmaker and studied his craft in Rennes and in Strasbourg.

Moving to Normandy, he met the highly-skilled lace maker, Azélie-Marie Guerin who also had been disappointed in her attempts to enter religious life. Zelie, as she was affectionately called, Guerin was born on December 23, 1831 in Saint-Denis-sur-Sarthon, France. They fell in love and were married three months later on July 12, 1858, at the Basilica of Notre-Dame in Alencon.

Zélie's business became so successful that, in 1870, Louis sold his watch making business to go into partnership with her. Louis managed the lace-making business that Zélie continued at home while raising their nine children, four of whom died in infancy. She died from breast cancer in 1877.

Louis then moved the family to Lisieux to be near his brother and sister-in-law, who helped with the education of his five surviving girls, none of whom lived beyond the age of thirty. His health began to fail after his 15-year-old daughter Therese entered the Monastery of Mount Carmel at Lisieux in 1888. Louis died in 1894, a few months after being committed to a sanitarium.



#### Marvelous Marvin Hagler's Toughest Fight

The Night He Took on "The Beast"



Things never came easy for Marvelous Marvin Hagler. Joe Frazier once said to him "You've got three things going against you; you're black, you're a southpaw, and you are good". Joe was right. Marvin had to do it the hard way.

Even before he won the title Hagler was taking on the toughest middleweights in the world, and he was doing it for short money. In his fourth fight he took on local rival and outstanding amateur star Dornell Wigfall over whom he won a decision. He would win by a knockout in a re-match.

In his 15<sup>th</sup> fight he beat Olympic Gold Medal winner Sugar Ray Seales. In a rematch in Seales's hometown Marvin would be given a draw in a fight. Marvin won easily. In a third match in Boston, Hagler removed all doubt by destroying Seales in one round.

Marvin would go on to beat the undefeated knockout artist Johnny Baldwin. After that fight promoter J. Russell Peltz invited Hagler down to Philadelphia to try his hand against the best fighters the City of Brotherly Love had to offer. He took on Bobby "Boogaloo" Watts and lost in a highly disputed decision. Next was Willie "The Worm" Monroe who beat Marvin fair and square though Hagler would come back to K.O. Monroe in two rematches.

There were more victories against the likes of the murderous punching Eugene "Cyclone" Hart, Bennie Briscoe, Mike Colbert, Kevin Finnegan, and Doug Demmings. Remember, these fights were all before the Marvelous One had won the title.

In fact, it was until his 55<sup>th</sup> bout that Hagler finally got a shot at the title only to be the victim of a terrible decision when, after clearly winning over fifteen rounds, the judges called his bout against Vito Antoufermo a draw.

Hagler would have to wait a year before getting another title shot, this time against the new champion Alan Minter. Marvin left nothing to chance by destroying Minter in the third round and finally taking possession of the title.

Marvelous Marvin would successfully defend his title 12 times against the best and only Roberto Duran was able to go the distance with him

Out of those defenses, the one most talked about was his war against Tommy Hearns, in which Marvin stopped the Motor City Cobra in the third round of one of the most exciting fights in history.

After that fight Hagler would make one more defense of the title before his showdown with Sugar Ray Leonard in 1987. It is that fight against John "The Beast" Mugabi that has somehow become lost when talk of Marvin's career comes up. That is a shame because it very well may have been his finest hour. It also may give some clues to why Marvin fought the way he did against Leonard.

John Mugabi, an Ugandan fighting out of England, was a natural boxer/puncher. He had incredible power in both hands and was blessed with a chin made out of iron. He had earned a shot at Halger by beating a number of other up and coming middleweights in impressive style, knocking out all 25 of his opponents.

The fight took place on March 10, 1986 outdoors on a cool evening in Las Vegas. While Mugabi did not have anything matching Marvin's experience, he did enter the ring with intense confidence and showed no fear of Hagler.

It was just short of a year after Hagler's war with Herans and from the opening bell looked very much like it would be a repeat of that fight as Mugabi came out throwing bombs. There was one difference though The Beast could also take the best Marvin had to offer and the grueling match went on for 11 rounds. While there were moments when the intensity would ebb just a bit, this was all out war.

I had seen just about all of Hagler's fights going back to his amateur days and had never seen him rocked the way he was against Mugabi. The two traded monstrous punches round after round with Marvin staying ahead but at the same time absorbing some unbelievable blows. You saw two things in this fight that were very rare in a Hagler bout; Marvin's head snapping back from the force of the uppercuts Mugabi was landing, and Hagler being forced to give ground. Also, Marvin's left eye was almost completely closed by the end of the fight. But, as the saying goes, you should have seen the other guy.

While all rounds of the fight were exciting, it was the 6<sup>th</sup> that really stands out. In that round Hagler came out determined to end matters and it appeared he would do just that as he unloaded



with brutal blows to Mugabi's chin. The Beast was rocked, he was forced back, he looked on the verge of crumbling, but then he came back to life and was rocking Halger with bombs of his own. The crowd was on its feet cheering as the round ended. After that it became a battle of attrition.

Marvin was relentless in the fashion of Rocky Marciano. He wore Mugabi down and by the 11<sup>th</sup> round the effects of the punches and exhaustion put Mugabi down for the count. Marvin had dug down and showed what a champion is made of. Hagler survived punches that would have sunk a battle ship yet never was discouraged. Mugabi took monster shots from Hagler and kept coming. This was like the extended version of the Hagler/Herans fight.

Marvin would next fight Ray Leonard who had said he saw something in the Mugabi fight that told him he could beat Marvin. He felt he could outbox him after that night.

Going into the Leonard fight Marvin was coming off two brutal wars; the battle with Hearns and the war with Mugabi. Hagler had no easy touch in between, but then again, nothing ever was easy for Hagler.

I have always thought Marvin made a tactical mistake in the Leonard fight by not pressing Ray early. He allowed Leonard to gain rhythm and confidence in the early rounds. I believe that Hagler, having just had two brutal wars, wanted to show the public he could outbox Leonard and beat him at his own game. I think if he had shown the same intensity he had displayed against Hearns and Mugabi he would have stopped Leonard. I still think Hagler deserved the decision in the fight, but once again, he couldn't catch a break.

I do know one thing. Marvelous Marvin Hagler showed just why he was a great champion the night he stopped John Mugabi. He not only showed his talent, conditioning, punching power, and indestructible chin, he showed that indomitable "will to win" that makes for a very great champion. Marvin ranks high on the list of all-time greats, and he earned that designation the hard way. We will never again see the likes of a Marvelous Marvin Hagler.

### HOOPS and HOCKEY in the HUB

A couple of days after the NBA Finals concluded with the Golden State Warriors wrapping up another championship, we saw a note in a newspaper that stated that there had been only eight 4-0 sweeps in the history of the championship round.

And yes, it had, as we say in the newspaper business, a local angle. That's because the first sweep in the NBA Finals was accomplished by the Celtics, a triumph that began a most impressive streak of eight consecutive NBA titles.

We all remember Banner 17, when the Celtics swarmed all over the Los Angeles Lakers to win the title back in 2008, in a six-game series that culminated with a huge victory celebration at the Garden. But you really have to go back in time to reconnect with the Celtics sweep in 1959.

To begin with there were some commonalities. The Finals that year not only involved the Celtics but also the then Minneapolis Lakers, so in some ways it could be taken at first glance as the genesis of a rivalry.

But that wouldn't quite be accurate. You see, as the Celtics entered the original Boston Garden for Game One of the series, they were riding an 18-game win streak over the Lakers. In fact, in the last regular season meeting in February, the Celtics had really turned on the scoring jets, downing Minneapolis 173-139. By the time the series against the Lakers had concluded the winning streak would stand at 22.

Another aspect was that the series was sort of an anticlimax for the C's. They were coming off a full seven-game series against the Syracuse Nationals in the Eastern Division Finals and it could be argued that it was the better series. In fact, Boston was behind by eight points at the half in Game Seven before coming back to win by a 130-125 score.

Boston had won the regular season Eastern Division title by a 12-game span with a 52-20 mark while Minneapolis was the second seeded team in the weak Western Division. The Lakers didn't even post a winning record in the regular season, going 33-39.

And yes, it was a much shorter season — ending in mid-March, nearly a full month earlier than it does today. In fact, by the time the Celtics had won it all and captured the championship it was only early April, about the time the regular season wraps up today.

Oh, and there was this little detail from the past that definitely would not occur today. In a pro basketball world where there were only eight teams, the Celtics received a first round bye and went straight into the division finals.

That wouldn't happen now because in today's extremely commercialized environment, the teams would want the gate receipts and the league would want the television revenue.

But perhaps the most important aspect of it all was that it was something of a mismatch on the court. The Celtics lineup featured five future Hall of Fame players — Bob Cousy, Bill Russell, Frank Ramsey, Bill Sharman, and Tom Heinsohn. The Lakers were three years removed from the George Mikan era, the NBA's first superstar who had retired in 1956. They had future Hall of Famer Elgin Baylor — but Minneapolis as a team was not as powerful as the Celtics.

Nearly 14,000 fans were in the Garden for the decisive seventh game against Syracuse — a number not equaled for either of the two games with the Lakers on Causeway Street.

Both Russell and Cousy proved to be ironmen in the series. The four games would have 192 total minutes of action (48 per contest) and both Celtics stars would play 186 of them — or about 46.5 minutes per game. That is astounding.

Plus, the Celtics featured balanced scoring. There wasn't one standout player, as LeBron James is today with the Cleveland Cavaliers. There were several.

Game One, played on April 4, 1959, was competitive and perhaps out of character for the Celtics. Baylor poured in 34 points for the Lakers to lead all scorers but the C's still came away with a three-point win, 118-115.

Here's a departure from the present. There wasn't a day off between games. That's right. The two teams were right back at it the next night at the Garden on April 5<sup>th</sup>. This time the Celtics won by 10, posting a 128-108 victory to go up 2-0 in the series.

And a personality from the present showed his talent in the past. That would be current Celtics broadcaster Tom Heinsohn. He had scored 24 points in Game One and proceeded to score another 24 in Game Two. Bill Sharman led the Celtics with 28, while Cousy added 21.

At this point the scene shifted to the Minneapolis Auditorium for what proved to be the final two games. The Celtics won Game Three (123-110) on April 7<sup>th</sup>, as Heinsohn showed the way with 26 points. Cousy added 23 and Sharman scored 20.

Game Four was two nights later, on April 9th. Today, that would be during the last week of the regular season. This one was a tight game. The Lakers actually led by a point in the fourth before Sharman scored a couple of baskets to give Boston the lead for good. Frank Ramsey's layup with 30 seconds left clinched the 118-113 victory.

Baylor led all scorers with 30 while Sharman led Boston with 29, Ramsey had 24 and Heinsohn had 23.

Where was Bill Russell? He was the one who got his teammates the ball, coming away with 118 rebounds over the four games, including more than 30 in three of the four contests. That helped the C's score 487 points on 118 field goals (remember, no three point shot). Boston also scored 111 points from the line. Cousy was
