To Actually Stop Mass Shootings

To stop school massacres like in Uvalde, TX, argues Jim Geraghty at *National Review*, America needs, "reforms that would have prevented the Uvalde shooter" from getting guns. One would be prosecuting serious threats, such as the ones which the Uvalde shooter made prior to his killings. He was also, "a prime candidate for being involuntarily committed" given his erratic, violent behavior (peers called him a "school shooter" even before the shootings). Red-flag laws on gun ownership need to improve, too. Most demand now that "the court system and police seize the firearms of the troubled individual and then ... that's it" "no requirement for subsequent mental health treatment." Such laws need to take "the mentally ill and (treat) them so that they (are) no longer a threat to others."

Joe Biden is still blaming Putin for economic woes as U.S. gas and diesel prices continue to hit new records and high inflation, rising interest rates, and fear of a recession weigh on Democrats ahead of November's midterm elections.

Conservative: Investigate Uvalde Now

Uvalde wasn't an "apparent law enforcement failure." It is the biggest law enforcement scandal since George Floyd, and therefore one of the biggest in U.S. history. says the *Wall Street Journal*'s Peggy Noonan. "Their incompetence on the scene and apparent lies afterward. This aspect has rocked the American people." The 19 cops who "failed to move for almost an hour" as children, "some already shot, some not, were trapped" know "everything that happened." Many "would have had to override a natural impulse toward compassion. Many would be angry now, or full of reproach or a need to explain. Get them now." These police officers need to be interviewed as quickly as possible. We need "a swift and brutal investigation before they "close ranks" and "lawyer up."

MAYOR'S GARDEN CONTEST DEADLINE JULY 13TH



Mayor Michelle Wu has announced the 26th annual Mayor's Garden Contest highlighting the hard work of Boston's urban gardeners. The competition provides the perfect opportunity to recognize the skills of all Boston residents who contribute to the beauty of the city's landscape.

Boston's green thumbs have until 11:59 p.m. on Wednesday, July 13th, to submit their gardens for award contention. The contest recognizes gardeners who have landscaped, planted flowers, trees, shrubs, and, in the process, helped beautify Boston's neighborhoods.

Gardeners or those nominating their favorite gardeners may find printable and online nomination forms at www. boston.gov/mayors-gardencontest. The preferred method of entry is to submit photos

through the online application. Alternatively, contestants may request an application by emailing their name and address to *gardencontest@boston.gov*. Paper applications are also available in English and ten additional languages.

Judges will fan out across the city visiting finalists the week of July 25th. Once the votes are tallied, first place winners will receive the coveted "Golden Trowel" award from Mayor Wu while second and third place winners will be awarded certificates. The traditional awards ceremony is scheduled to take place in the Boston Public Garden on Monday, August 15th.

Gardeners who have won three or more times in the last ten years will be automatically entered into the Hall of Fame. These distinguished Hall-of-Famers are not eligible to enter as contestants but are invited to return as judges.

First place winners are eligible for a drawing for a JetBlue Grand Prize consisting of roundtrip flights for two to any nonstop destination from Boston. Terms, conditions, and blackout dates apply. In addition, Mahoney's Garden Centers will provide gardener's gift bags to the top three winners in each category, as well as gift certificates for the 2022 Hall of Fame winners.

AUGUSTUS' PERSONALITY



In his physical make-up, Augustus was about average size, but very well proportioned. He had yellowish brown hair, bright lively eyes, was considered to be a very handsome and graceful man, but not the least bit particular about the grooming of his hair or beard. He would usually read or write as he sat in the barber's chair while several barbers worked in a hurry. His beard was either clipped or shaved, whichever suited his mood at the time.

His five feet, nine inches in height was not very noticeable unless a taller person was standing next to him. His body was covered with birthmarks and spots. Numerous callous spots were evident as a result of the vigorous use of the strigil. This was a medal or bone instrument used by the Greeks and Romans to scrape the skin after a bath.

He slept a total of about seven hours a night, but awoke three or four times. During sleepless periods, he often sent for readers or storytellers, and would never lie awake in the dark without having someone sit at the side of the bed.

In his personal living habits, Augustus was fairly moderate. He used the same bedroom in summer and in winter. For private activity and freedom from interruption, he used an attic room, which he called "technyphion" or little workshop. He vacationed in towns near Rome, such as Lanuvium, Praeneste, or Tibur, and disliked large country villas. A villa that his granddaughter built was burned to the ground

because it was considered lavish.

He had an extremely calm and mild nature, which at one time even softened the heart of a conspirator who was about to push him off a cliff as they were crossing the Alps. Constant attention was given to his delicate health during middle age, a factor which enabled him to lead a full life up to age 76. He survived all of his illnesses by moderation in every activity. Records indicate that he often used the sauna and took hot salt water or sulphur baths, but never visited a "Salone di Massaggio."

During his lifetime, he was plagued with a number of serious illnesses, including abscesses of the liver, catarrh, and rheumatism. He complained of bladder pains, but was greatly relieved after passing some stones. In his later years, he was also greatly affected by cold or heat. During winter months he wore four tunics, a heavy toga, an undershirt, a woolen chest protector, wraps for his thighs, and a furlined "asago Balterus."

In summer, he slept in an open court near a fountain while fanners worked in relays. He always wore a broadbrimmed hat in the open air, and did all of his traveling at night in a litter.

After becoming too old for horseback riding, his outdoor activity was confined to fishing, playing pass ball (catch), balloon ball, dice, marbles, and nuts.

Last year, President Biden signed into law the Juneteenth National Independence Day **Act**, creating a federal holiday to commemorate Juneteenth. This is the first federal holiday approved since Martin Luther King Jr., Day in 1983. This year, because the holiday falls on Sunday, it will be observed on Monday, June 20th. Government offices will be closed. Retail businesses, for the most part, will be open, just as they stay open for several of the federal holidays. As for non-retail business, the holiday is still too new to know who will and will not observe it.

On June 19, 1865, federal troops arrived in Galveston, Texas to take control of the state and ensure that all enslaved people be freed. This, however, was two and a half years after the Emancipation Proclamation went into effect January, 1863. This day, the oldest known celebration commemorating the end of slavery in the United States, has become a day for African Americans to celebrate not only their freedom, but their history, culture and achievements.

Juneteenth

"On Juneteenth, we recommit ourselves to the work of equity, equality, and justice. And, we celebrate the centuries of struggle, courage, and hope that have brought us to this time of progress and possibility. That work has been led throughout our history by abolitionists and educators, civil rights advocates and lawyers, courageous activists and trade unionists, public officials, and everyday Americans who have helped make real the ideals of our founding documents for all." — A Proclamation on Juneteenth Day of Observance, 2021, President Joseph Biden, June 18, 2021.

The original of the **Emancipation Proclamation** of January 1, 1863, is in the National Archives in Washington, D.C. The final proclamation was first printed in January 1863, as a twopage broadsheet with the printed signatures of Lincoln and Secretary of State William H. Seward. Later, a limited edition of forty-eight copies was printed. They were signed in pen by Lincoln, Seward, and Lincoln's secretary, John G. Nicolay, the copies were donated to raise money for the group that later became the Red Cross. About twenty known copies of the document have survived in public and private hands. Number 32 of this 48-copy edition is at the **Boston** Athenaeum on Beacon Street. I had the great pleasure of viewing it at a January 20, 2009, Athenaeum event to watch the Inauguration of **President** Barack Obama.

Saint Paulinus of Nola

Pontius Meropius Paulinus was born c.352 at Bordeaux, in southwestern France. He was from a noble senatorial family with estates in the Aquitaine province of France, northern Iberia, and southern Italy. Paulinus was educated in Bordeaux, his teacher was the poet Ausonius. At some time during his childhood, he made a visit to the shrine of St. Felix of Nola near Naples where he developed a love for the saint that would affect his later life.

Paulinus became a distinguished lawyer, holding several public offices in the Roman Empire. With his Spanish wife, Therasia, he retired at an early age to a life of cultured leisure, the couple were baptized by the saintly bishop of Bordeaux and moved to Therasia's estate in Spain. After many childless years, they had a son who died a week after birth. This resulted in their beginning a life of great austerity and charity, giving away most of their Spanish property. In time, Paulinus was ordained a priest at Christmas by the bishop of Barcelona.

He and his wife then moved to Nola, near Naples and spent much effort in promoting

devotion to the saint. Paulinus bishop of Nola and guided that gave away most of his remaindiocese for 21 years. ing property — to the consternation of his relatives — and continued his work for the poor. Supporting a host of debtors,

Paulinus' last years were saddened by the invasion of the Huns. Paulinus died at Nola on June 22, 431; among his few writings is the earliest extant Christian wedding song. His liturgical feast is celebrated on June 22nd.





L'Anno Bello: A Year in Italian Folklore

Mystical and Magical Midsummer Nights

What is it about summer nights that make me think of magic, moonbeams, and fireflies and fairies flitting about a darkened forest? Perhaps the answer lies in the velvety hue of the evening sky, offset by the delicate diamond-like stars that peek out from the late sunset. Or perhaps the answer resides in the comforting sound of crickets and cicadas humming their melody from deep within bushes and trees. It could also be that people tend to congregate outside during the warm summer twilight, illuminating the atmosphere with candles and lanterns from barbecues and alfresco dinners. I always find that the most magical of these nights occurs around the summer solstice, the longest day and shortest night of the year. In olden times, the summer solstice was known as midsummer, which can confuse those of us who view the solstice as the beginning of summer rather than the middle. Ancient Europeans used agricultural rather than purely astronomical methods of gauging the seasons, and so the solstice was considered the height of summer rather than its commencement. As Christianity spread across the continent, Midsummer festivities became absorbed into the feast day of St. John the Baptist, creating an indelible mix of traditions. The result is one of my favorite holidays, a festival that embodies the magic and boldness of summer.

Europeans in older times began the summer on May 1st, or May Day, the holiday that marked the time to let livestock out to graze in pastures. Summer ended on Lammas, which fell on August 1st, the

the first fruits of the autumn. As a result, the summer solstice marked the midpoint of the season and as such was called Midsummer. In Europe, Midsummer heralded not only the longest day of the year, but also the period after which the daylight hours would slowly shorten. For this reason, I like viewing the solstice as the middle rather than the beginning of summer as well — it makes little sense to celebrate the start of summer when the sun begins to diminish in the sky! Midsummer customs later attached themselves to June 24th, St. John the Baptist's Day, the feast commemorating the birthday of the important Biblical figure six months before Christmas. In Italy, St. John's Day customs symbolize both the decline of the sun after the solstice and the sense of magic which pervades the evening. All over the Italian countryside, gli fuochi di San Giovanni, or St. John's bonfires, blaze from the hilltops on the eve of the saint's festival. These fires both mimic the power of summer sun while also symbolically imploring the sun to stay longer in the sky. Young Italians may also spend the evening gathering herbs, which are supposedly imbued with mystical properties on this unusual and magical night. According to old superstitions, these herbs work especially well for romantic divination, and people slip them under their pillows to dream of their future spouse.

Across Europe, similar Midsummer and St. John the Baptist's Day traditions utilize the seasonal staples of water, fire and greenery. In Scandinavia, Midsummer is one of the most significant festival of the grain harvest and holidays of the year, on par

Sporting wreaths of flowers on their heads, Scandinavians celebrate this holiday by dancing around Maypoles bedecked with greenery, building bonfires near lakes and rivers, and sitting down to feasts featuring summer ingredients like strawberries and potatoes. Meanwhile, girls in Russia and Eastern Europe float flower garlands down rivers and attempt to foretell the future by interpreting the movement of the garlands. People in Spain and Portugal celebrate the Feast of St. John the Baptist with outdoor carnivals, bonfires, street fairs, and the exchange of potted herbs. Italians, of course, never pass up an opportunity for a festival and party accordingly on St. John the Baptist's Day, especially in cities of Florence and Turin, where he is the patron saint and outdoor fairs and fireworks displays mark the occasion. Out in the countryside, people may enjoy St. John's apples, or le mele di San Giovanni. A favorite of my father, these are small green apples so named because they ripen extremely early, just around the time of the solstice. No matter where one goes in Europe, charming Midsummer revelries emphasize the importance of the summer sun and the blessings of the season. The United States even boasts its own festivals full of outdoor excursions, fireworks and water the Fourth of July, of course! Above all, Midsummer is a

holiday tinged with bittersweet nostalgia. While it honors the height of the sun's power and the carefree days of summer, it also recognizes that the hours of sunlight will slowly start to diminish once this date is past. It is a poignant reminder that nothing lasts forever. Yet, Midsummer is celebrated with iov, not sadness. Its celebrations encourage people to enjoy the longest day of the year by living life in the present moment. Actions speak louder than words and all we get today for crying out loud is endless dribble from Washington, DC. Sound and fury signifying nothing!





After a three-year stay, Dina returned to Massachusetts and worked at the State Library Agency because her main focus has always been to work with people of all ages and backgrounds. She was the professional librarian assisting health and corrections staff to improve their libraries. Dina has visited every prison, house of correction, reform school, as they were called then, public hospital and mental hospital in the state.

The pinnacle of her career was Dina's 40+ year tenure as Director of the Malden Public Library where, coming full circle, she is particularly proud of her work with immigrants, the Vietnamese, Cambodians and later, Haitians.

A Nostalgic Remembrance



It was June of 1969, and I didn't know what I was going to do for the summer. I had been taking time off from my job in the school department whenever I got a call from Hollywood, but there wasn't much going on that summer according to my agent. Dad and mom were heading on the road as Dad was playing for various county fairs throughout the northeast. Babbononno had just moved back to East Boston and had an apartment near Maverick Square. Seeing he was heading toward his mid 90s, we were worried, but we knew he could take care of himself, and my mother's brothers, Uncles Paul, Nick and Gino would be around, just in case.

The phone rang just around this date in 69, and it was George Graham. George Swartz was a band leader who ran an office under the heading of the George Graham Orchestras. I had worked for him in the past and he knew that I taught school and would be available for the summer months. He told me that he had been speaking to the man-ager of the Colony Hotel in Kennebunkport, Maine. (They also have a sister hotel/resort here in Delray Beach, Florida. If I was interested, I could lead a band for him 6 nights a week at the Kennebunkport location. I could live there for the summer and be well paid. I told him I was interested and asked about the circumstances, amount of men in the band, the type of music, and accommodations. The following week, we met with a John Banta, the manager.

Before the meeting, I tied up with George Graham who told me about the Colony Hotels according to his viewpoint, "The clientele is mostly composed of WASPS, white Anglo Saxon Protestants whose ancestries are looked at and scrutinized before they are allowed to stay at either facility." I got the picture ... George was Jewish and I was (am) Italian. He added that I would have to use my Anglicized professional name, Johnny Christy, and the rest of the band would have to do the same. The music stands would read, "The George Graham Orchestra conducted by Johnny Christy." The pianist he hired would change his Jewish sounding name to Clarence Austin, the violinist, another Italian, would become Edward James and the sax player, also Italian, would be called Joseph Andrews. Andrews, in reality, Joe Papandrea passed away recently at 101.

When we all met with Mr. Banta and he heard us play a few tunes, we were hired to play at the Colony in Kennebunkport for the summer, from the last week in June through Labor Day. Just to clarify, we as musicians had all worked together over the years with various orchestras, and we had over 1000 tunes memorized, including the pop tunes of the day, Broadway musical hits, lots of Dixieland favorites and some semi-classical specialty numbers. We auditioned by playing a couple of each at the insistence of Mr. Graham and Mr. Banta.

When we arrived at the Maine resort, I was in charge. Mr. Banta had one of his workers show us our quarters, single rooms in a middle management building. We were told that we could eat off the menu for all three meals and could use the pool, golf course, their private beach and the tennis courts at the hotel's discretion. Mr. Banta next called us to his office for a meeting and our schedule was given to us. We were to play a jazz cocktail hour in the lounge from 4:00-5:00 p.m. Next we were to head to the main dining room and play from 5 to 6, and limit our selections to semiclassical and show tunes. Our dinner hour was from 6 to 7, followed by an hour off, and then a return to the lounge where we would play for dancing until midnight, or later depending on the crowd.

The attire each night was black tuxedo for the sidemen and a formal colored jacket for the leader (me).

We began the summer festivities during the week before July the 4th. What Mr. Banta didn't know was that the band was composed of school teachers and from the date when we started until a couple of days after Labor Day, we were on school vacation.

Most of the summer guests were at the Colony for two weeks and were from old families, rich old families, rich old Yankee families. Some had attitudes, but most were civil to us. At night, when we played in the lounge for dancing, Mr. Banta would schmooze with the clientele wearing a sport jacket with a variety of beer cans on display and a bow tie to match. Most of the men were in resort wear, but all wore ties. The ladies wore dresses and some, long gloves. From the first night in the lounge, customers had many requests, and I'll be damned if there was one we didn't know.

Occasionally, a personality or two would spend time at the Colony. The first one I met was Edward Everett Horton, a character actor who played an Indian on *F Troop*. The second was Soupy Sales, who stayed for a few weeks. He had a son who attended a camp in Maine and wanted to be close by. There were a few other celebrities, but most of the vacationers were people of business and industry.

I kept in touch with my uncles who checked on Babbononno a couple of times a week and when Dad had a week off, I surprised him and Mom with a week at the Colony. The front office reluctantly booked them in to a vacant room. I think that the only reason they allowed my folks to stay was that I was the band leader and things were going well up to that point. I had thought of inviting Babbononno when my folks were there, but I knew he would be lost and embarrassed, so it never happened.

At one point in August of the year, the owner of the Colony Corporation, a Mr. Boughton, asked to speak to me privately. His daughter was to get married on a Sunday and that was our day off. He asked if we could play her wedding reception. It was OK with my band members. He then had Mr. Banta, the manager, tell us about compensation. They had been paying George Graham, by check every week and Graham would pay us. Banta told me that Mr. Boughton would pay us cash for the music at his daughter's wedding, avoiding the middleman, if you get the hint. We played just background music and a special tune for the married couple's first dance, and then "Daddy's Little Girl" when the bride danced with her father. Later, Mr. Banta handed me an envelope with a week's pay for each musician for just that one afternoon. It was well worth not having a Sunday off that week. All the folks I've mentioned are gone except Mr. Boughton's daughter, who now is the CEO of the Colony Resorts (and remembers me from her wedding). I've had cocktails at the Colony in Delray Beach recently. Times have changed for the better.

In Italy, *Macedonia di Frutta* or Fruit salad is a popular summertime after dinner dessert. The guide for making this is simply cutting up fresh seasonal fruit, adding lemon juice, a sprinkling of sugar or sometimes even a splash of rum or limoncello, and allowing it to macerate before serving. In this country fruit salad is often made the same way, however, there are a variety of others that range anywhere from Waldorf to Ambrosia!

In the summertime, when my Nonna made fruit salad, she'd use fresh seasonal fruits such as peaches, plums, melons and berries. She never added sweeteners because she claimed the juices from the ripe fruits provided "more than enough sweetness". On occasion, she made a different type of fruit salad from a recipe that was given to her in this country. She claimed it wasn't from Italy, but because it required *Acini di Pepe* we could call it Italian! Nonna thought this salad tasted like ambrosia, and though it was a bit sweet for her taste, everyone else that tried it always seem to love it. Italian Fruit Salad is a perfect dessert to serve at any summertime gathering in stemmed glass dessert dishes or cups, or even in the shells of melons or pineapples!

ITALIAN FRUIT SALAD Macedonia di Frutta Italiana



- 1 20 ounce can pineapple tidbits, drained (reserve juice)
- 1 10 ounce can crushed pineapple, drained (reserve juice)
- 1 15 ounce can mandarin oranges, drained
- 1 cup of the reserved pineapple juice
- 1/2 cup granulated sugar 1 large egg yolk
- 1/4 teaspoon salt
- 1 Tablespoon cornstarch
- 1/2 cup Acini i di Pepe, cooked and cooled
- 1/2 cup shredded sweetened coconut
- 1 cup mini marshmallows
- 1/2 cup maraschino cherries (optional)
- 1 cup heavy whipping cream
- large egg yolk 1/4 cup confectionary sugar

 In a sauce pan over medium heat, whisk together the pineapple

in a sauce pan over medium heat, whisk together the pineapple juice, sugar, egg yolk, salt, and cornstarch. Cook stirring constantly until mixtures comes to a low boil and thickens slightly. Remove from heat and allow to cool.

In a large bowl, combine the cooled thickened custard to the cooked *Acini di Pepe* and refrigerate for a minimum of 4 hours or preferably overnight.

Add the pineapples, mandarin oranges, coconut, marshmallows, and cherries (if choosen) and mix together well, cover and refrigerate. In a medium bowl, beat the cream and confectioners sugar together until stiff peaks form.

Remove the custard and fruit mixture from the refrigerator and gently fold the fresh whipped cream mixture into the custard and fruit. Serve in glass dessert cups or in the shells of melons or pineapples, enjoy!



Goodbye to Child World

In my youth, there was no shortage of toy stores. Toys "R" Us still dotted maps of the state, malls were still expected to have a KB Toys and no trip to Downtown Boston was complete without a visit to FAO Schwarz. Today, Toys "R" Us survives only in small sections within larger department stores, a planned revival of KB Toys has been up in the air since 2016, and FAO Schwarz hangs on as a store in New York City and a brand.

The one, however, that was a distinctly New England experience, Child World, closed and vanished without a remnant.

In a flurry of options, Child World held its own, especially so in the heart of a child. It was known for its castle like architecture, a tribute to common childhood tropes, promising children entry into a magical kingdom. "My" Child World, however, was too small to have such luxury. Squeezed between two other stores in an old building in Ouincy Center, it nonetheless was, to me, a most enchanting place.

My memories are hazy but charming. The lighting was dimmer being a part of an old building. The top had the newest releases, plush toys and bikes. There was a short staircase to a lower level containing board games and action figures.

Every toy store needs its mascot. Toys "R" Us has Geoffrey the giraffe (and family), FAO Schwaz its teddy bear, KB Toys had a toy solider and Child World had Peter Panda (its original mascot, the Happy Rabbit was before my time).

All good things, however, come to an end. The recession of 1990 hurt the store but the real beginning of the end for Child World was Cole National's decision to restrict the amount of capital it put into stores, frightening many of the leading tov manufacturers (such as Legos) away from supplying inventory to the stores. After a number of buyouts and restructures failed, the chain filed for Chapter 11 bankruptcy in April of 1992.

A last ditch effort to save the chain (at least in the northeast) was a merger with Lionel Corporation, but that toy store was a poor choice as it was also in debt and indeed ended up going out of business a year after Child World. In August of 1992, Child World began liquidating its stores and by the fall of that year, all the stores had

Joe Says Second Amendment **Has Limits**

Joe Biden recently said in a rare prime time speech that the Second Amendment "is not absolute" while discussing the Uvalde mass shooting. "I respect the culture and the tradition and the concerns of lawful gun owners (but) at the same time, the Second Amendment, like all other rights, is not absolute."

Many lawful gun owners and supporters of the Second Amendment begged to differ with his opinion. According to some interviewed, if the Second Amendment is not absolute, is the First Amendment absolute? The Bill of Rights was placed by the framers of the U.S. Constitution to ensure that freedom of speech, the press, to assembly, and to own firearms were rights that were inherent in people and not rights given by the state.

DOJ Fights Gun Payout

Shortly after the Uvalde mass shooting, the Biden White House decided to fight a court-ordered \$30 million verdict for the victims of the 2017 Sutherland Springs shooting by former Airman Devin Kelley.

The U.S. Justice Department is appealing in an attempt not to pay the verdict to the families and victims. A federal judge found that the government was at fault for letting Kelley get a gun because it failed to report that he was dishonorably discharged, which would





HOOPS and HOCKEY in the HUB

But while the quest for precious parking spaces may only last a week, the historic "Battle of Commonwealth Avenue" between Boston College and Boston University will resume in the fall with new head coaches behind the bench at both schools along with a new athletic director (with a hockey background) on board up at BC.

Things started humming earlier this spring. Legendary Boston College men's hockey coach Jerry York announced his retirement. In addition, the college hockey community learned that BU bench boss Albie O'Connell had been dismissed by his alma mater. Finally came the announcement that BC athletic Director Patrick Kraft had resigned to assume the leadership of the athletic department at Penn State.

Three would be moving on. But a recent pair of appointments signaled a continuity behind the bench for both of the storied collegiate programs. In addition, BC welcomed an athletic director at The Heights who already has experience in overseeing the administrative side of collegiate hockey programs.

Up at Boston College continuity on the hockey side was assured since former BC player Greg Brown, a longtime assistant to York, was named the head coach of the Eagles. On the administrative side, Blake James came aboard to take over the helm of the athletic department. Down the road a bit, Jay Pandolfo, who had moved across town from the Bruins to join O'Connell at BU last season as an assistant, was promoted to lead the Terriers.

Brown began his association with BC as a defenseman, being named a first team All American as well as earning back-to-back Hockey East Player of the Year honors in 1989 and 1990. Over the course of his collegiate career, he scored 24 goals and added 96 assists for a total of 120 points in 119 varsity games.

He went on to play for Buffalo, Pittsburgh and Winnipeg in the NHL followed by additional seasons in Europe before joining coach York's staff at The Heights in 2004. He remained with York until 2018. He then became an assistant with the New York Rangers under former BU head coach David Quinn. This past season he was the head coach of Dubuque in the United States Hockey League.

The selection of James is also one that bodes well for BC hockey. James earned his undergraduate degree at the University of Minnesota-Mankato (now Minnesota State). That Institution is one of the Big Five Division One hockey-playing schools in that state. He later served as the athletic director at the University of Maine (a Hockey East school) from 2005-2010. Just prior to coming to BC, he was the AD at the University of Miami.

Like Brown, Pandolfo is also a former player named by his alma mater to serve as the head coach. Before returning to BU last season, he had been an assistant with the Bruins for five seasons.

During his four years at BU, he scored 79 goals and amassed 90 assists (169 points). He also was a member of the 1995 National Championship team.

He went on to play in 899 NHL games with New Jersey, the New York Islanders and the Bruins, scoring 100 goals and adding 126 assists for 226 points.

DID A FOURSOME FIRE COACH CASSIDY? — It seems as if that might be a good question after reading the official transcript of Bruins GM Don Sweeney's press conference on the day following Head Coach Bruce Cassidy's termination.

Although Bruins President Cam Neely had indicated that Cassidy's fate would be determined by Sweeney, that may not have been the case. According to the official transcript, Sweeney referred to his decisions as "recommendations."

He stated that "You know the rhetoric at times you hear about the Bruins organization, the Jacobs family being uninvested owners, absentee owners. It is so far from the truth. They are very present."

Sweeney referenced that as a part of his job he has periodically submitted plans to Neely as well as Bruins Chief Executive Officer Charlie Jacobs and team owner Jeremy Jacobs. He indicated that the three expect "a best-in-class standard."

Regarding Cassidy, he explained "I had spoken to them over a period of time and made my recommendations as to where I was leaning. I took last week (early June) and then ultimately came back over the weekend and made my final recommendation and got their support."

It would seem that Sweeney's decision was not the final step, but a potential move that had to be submitted to three others for approval. Only after obtaining that approval was the final action taken.

BERGY AND BRUCE? — It is always good to read the entire contents of a story or column that you may see in the sports section of a newspaper (either in print or online). You never know what you might find at the very end.

Boston Globe writer Matt Porter closed his Sunday column on June 12th with the following quote from Bruce Cassidy. Speaking of Patrice Bergeron, his former coach said: "I would like to take him with me." The Bruins captain will become a free agent this summer.

Whether he would move seems very doubtful. Bergeron has stated that he wishes to remain a Bruin, whether he chooses to return or retire.

Cassidy just took the job in Las Vegas. Like Cassidy, Bergeron has children so any move would be a disruption in their lives.

But you can never say the word never. Just don't count on a double move happening in this case.
