Italian Ambassador Praises Community Efforts in Boston

Claudio Bisogniero met with community leaders during his 2-day visit **by Nicola Orichuia**

During a recent two-day visit in Boston, Italian Ambassador to the United States, Claudio Bisogniero, met with representatives of the Italian and Italian American communities at the Dante Alighieri Society in Cambridge on June 18. "It is a great pleasure to be here," said Bisogniero, after an introduction by Dante Alighieri Society President Spencer Di Scala and Comites President Maurizio Pasquale.

Bisogniero was called four months ago to replace Giulio Terzi, who was called upon last fall to be Minister of Foreign Affairs for Mario Monti's government. Bisogniero knows the American political and cultural landscape well, having lived and worked in the United States for eight years and having recently served as Vice-Secretary of NATO.

During his visit in Boston, Bisogniero held meetings with community leaders, as well as with Boston Mayor



first part of a detailed account of a sumptuous Roman banquet provided by "Trimalchio," a boastful, pretentious and ignorant recipient of newly acquired wealth. I described the hors d'oeuvres, cooked dormice, hot sausages and European songbirds called "beccaficos."

This week we are told that after eating their fat songbirds rolled in spiced egg yolk, the guests washed their hands with a good grade of unwatered wine. The wine, which was served for drinking came from Falernos Ager, a district in the north of Campania, which produced the "Falernian" wine, one of the finest in ancient Roman times. This particular wine was 100 years old.

The next dish of the evening was a large round plate containing the 12 signs of the Zodiac. At each sign the cook had placed some food appropriate to the symbol. At Leo there was a large African fig, Cancer contained boiled crabs, Gemini contained a giant double mushroom, Taurus had a round of beef, at Aries there was a saddle of mutton, Pisces had red mullet, and over Aquarius there was a plump goose. Lobsters were placed over Capricorn, Sagittarius contained a bulls eye and Libra had a scale with muffins on one side and small cakes on the other.

At the appropriate time a sign from the host brought in waiters who lifted off the Zodiac dish, to reveal a lower section which contained plump fowl, sows' bellies and cooked rabbits made to look like Pegasus, the celebrated winged horse of Zeus. In the next course, each of the four corners of the dish contained a figure of Marsyas, the flute player from mythology.

A sharp sauce poured Salami

Last week I presented the out through the flutes onto cooked fish until they appeared to swim around in the liquid.

> Next came a wild boar with a palm leaf basket hanging from each tusk. The baskets contained dates from Turkey and from Egypt, that were passed out to the diners while bearded huntsmen entered to slash the side of the boar and release a flock of thrushes. Each bird was then caught in a net by the slaves and cooked for a guest. During a stretch period, fresh covers were spread on the couches and off they went again. This time the servants brought in a boiled calf on a huge dish and laid it on the table. A swordsman rushed into the dining room and attacked the calf with swinging saber. He then collected the slices on the point of his sword and served them to the astonished guests. A large roasted pig was next on the menu, and when the belly was opened, it revealed cooked sausages and puddings.

> The soiled tables were then taken away and replaced by clean ones. Powdered talc and colored sawdust were sprinkled about the floor. Then came the sweetmeats, and an assortment of other desserts fashioned from flour, raisins, nuts and pork. All guests then took a hot bath, after which they were led into another dining room where wine flowed in rivers and the serious drinking began.

> It is said that shortly thereafter some of the guests slid off the couches and onto the floor while others called for their litters and quietly went home. The host just sat there in a drunken stupor mumbling something which sounded like ... I ate the whooooole thing.

A FORTNIGHT FOR FREEDOM

official state-sponsored intolerance – is on the rise in America to an extent not seen since the hevday of the Ku Klux Klan in the 1920s or even the period of the "Know Nothings" in the mid-1800s. America's Catholic bishops characterized the Obamacare HHS mandate as unconstitutional. It is unconstitutional.

On Friday, June 8th, several hundred of us gathered on Boston Common to rally against the mandate's unconstitutional interference with the free exercise of religion. We were Catholics, Protestants, Jews, and even a few non-believers who understood that the issue is not the Church's teaching on sexuality, but our Constitutional freedom as Americans to practice religion, or no religion, unimpeded by unjustifiable government intrusion.

The Catholic bishops have called for the 14 days from June 21st to July 4th to be

dedicated as "fortnight for freedom." and have issued the following Q & A to explain what is at issue.

"What do we mean by religious liberty?

"Religious liberty is the first liberty granted to us by God and protected in the First Amendment to our Constitution. It includes more than our ability to go to Mass on Sunday or pray the Rosary at home. It also encompasses our ability to contribute freely to the common good of all Americans.

"What is the First Amendment?

"The First Amendment of the U.S. Bill of Rights states the following: "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

"What does "shall make no law respecting an establishment of religion" mean?

"This phrase, known as the "Establishment Clause, started out as a prohibition on Congress' either establishing a national religion or interfering with the established religions of the states. It has since been interpreted to forbid state establishments of religion, to forbid governmental preference (at any level) of one religion over another, and to forbid direct government funding of religion.

"What does "prohibiting the free exercise thereof mean?

"This phrase, known as the "Free Exercise Clause," generally protects citizens and institutions from government interference with the exercise of their religious beliefs. It sometimes mandates the accommodation of religious practices when such practices conflict with federal, state, or local laws.

Obviously the bishops know the Constitution, which is more than we can say for our "constitutional scholar" President.

THE WALLS CAME **CRUMBLING DOWN**

On Sunday, June 17, 2012, I was over at the Vendome Firefighter Memorial on Commonwealth Avenue with hundreds of others to remember 40 years to the day when nine Boston firefighters died at a five-alarm fire at the abandoned Vendome Hotel at the

corner of Commonwealth Avenue and Dartmouth Street on the afternoon of June 17, 1972. Over 200 firefighters fought this blaze. Most of them had returned to their respective firehouses late in the afternoon leaving several fire companies behind, among them Ladders 13 and 15. The interior wall in the rear alley collapsed at 5:28 pm trapping 25 firefighters inside. Nine of those men died in the rubble.

I still remember that day quite well. I left home for work at the City Spa Cafeteria. When I arrived I heard the news of the fire on TV. Later at work, I remember the news bulletin about the building's collapse. The following day I went over to the Bunker Hill Day parade in a not-so-good mood as did many that year. Among the nine killed in the fire were those who came from Charlestown or served on Engine 32 out of Sullivan Square. It was not a happy Bunker Hill Day in 1972.

That Bunker Hill Day was also Father's Day and that fire had left 8 women widowed and 25 children fatherless. There was a lot of crying going around as almost everyone seemed to know someone connected to the tragedy that horrible June afternoon.

Killed were firefighters: Thomas W. Beckwith 35; Joseph E. Boucher, 27; Charles E. Dolan, 48; John E. Jameson, 52; Richard B. Magee, Sr.; Paul J. Murphy, 36; Joseph P. Saniuk, 48 and fire lieutenants Thomas J. Carroll, 52 and John E. Hanbury, Jr. 46.

I spoke with Father Dan Mahoney from St. Francis de Sales in Charlestown who had been an assistant fire department chaplain 40 years ago. Recently, he spoke with a news reporter about June 17, 1972. Like many of the firefighters on that day, they had left the fire scene before

REMEMBER VIETNAM

and All Those Sacrifices We Must Never Forget

On Saturday, June 16, the City of Quincy held its annual Flag Day celebration and parade. This year the parade was held in honor of all those from Quincy who served in the Vietnam War, those who survived it and those who paid the ultimate sacrifice. Too often, except on certain holidays we tend to take for granted all the freedom others paid dearly for us, our children and the futures of all of us. I remember being 18 years old graduating English High School in Boston and enlisting in the U.S. Air Force. I was lucky to have avoided going over to Vietnam. Others were not that lucky. I have known many from my generation, who did go and served the cause of freedom with distinction. I knew a few who were killed over there. Their ultimate sacrifice ended their lives, their dreams and their hopes. All who survived that war are owed plenty by America and too often only seem to be remembered either on Memorial Day or on Veterans Day.

Mount Wollaston Cemetery isn't that far from Weymouth. A short distance from the Fore River Bridge and Southern Artery. As I walk and reflect on the grave site memories, I see the names of men who died in many of this country's wars. I especially look at those who served in Vietnam. How many young men died while still 20-something? How many came home with invisible wounds that never healed? The Sixties seem so long ago, but for many not long enough. We look around and see people we grew up with no longer with us. We find them in cemetery plots, victims of a war that killed over 58,000 of us in a war that sometimes made very little sense.

This year, America is remembering the 50th anniversary of that war's beginning but in reality it actually began back in 1956 when I was in the 3rd grade at St. Rita's School in the Roxbury neighborhood of Boston. We didn't even know we were in a war there nor could we tell you where Vietnam actually was located. I just found out thanks to the June 14 Globe South that the very first casualty of that war was Richard B. Fitzgibbon, Jr., of Weymouth, was killed on June 8, 1956, when I was just 8 years old. Also, sadly noted, his son Richard III also lost his life in Vietnam, nine years after his father.

Sgt. Richard Fitzgibbon, Jr., grew up in Stoneham and was days away from his 36th birthday when he was killed by another airman in Saigon while he was passing out candy to some village children. He had served in World War II in the U.S. Navy before joining the U.S. Air Force and lived in North Weymouth when he was sent to Vietnam as an advisor.

This year, the United States begins to commemorate the 50th anniversary of the Vietnam War, but as the death of Sgt. Fitzgibbon on June 8, 1956 shows, this year marks the 57th anniversary of that war since U.S. military advisors started landing in Vietnam as of November 1, 1955. At the height of that war in 1968, we had over 500,000 troops fighting in Vietnam and by the time the war ended for good in 1975 more than 58,000 Americans had died and the nation deeply divided over it all. Lance Corp. Richard Fitzgibbon III who graduated from Wevmouth High School in 1962 was killed in combat on September 7, 1965 at age 21 in Quang Tin.

The Weymouth Vietnam Memorial lists both Fitzgibbons as one of only two father and son known to have been killed during the Vietnam War. 
The statue, a gift from Anna D'Amore Sirignano, was shipped from Italy to Boston and remains at St. Leonard Church.

Sister Eileen Harvey Retires

It was 28 years ago, when Sister Eileen first arrived at Saint John School. Sister had become aware of the position of principal that had just opened; she applied for it, and to her delight, was chosen to lead the old neighborhood school. It was an achievement Sister Eileen had earned after many years of hard work as a grade school teacher that prepared her to assume leadership of a school that needed the dynamic leadership that Sister Eileen proved capable of delivering during the years that followed.

Eileen was born in Brighton, her parents, Frank and Violet Harvey had sepaemigrated from rately County Armagh, Ireland, where they knew each other as friends with no plans of marrying. It took a boat ride on the Charles River to ignite the spark that brought them together; they married and settled in a modest apartment in Brighton. Frank went to work for the Hood Rubber Co., where he remained employed 'till his retirement. Violet, with her great love for children, became a Nanny, work she did lovingly for most of her life. In time, the young immigrant couple raised their family, Eileen and her two

brothers Frank and Gerald. It was while attend-Saint Columbkille's School in Elementary Brighton, that Eileen first felt the desire to enter religious life. After several years of discernment, she entered the Novitiate as a Postulant of the Sisters of Saint Joseph in 1954 at the age of 17. Upon completing her Novitiate in 1957, Sister Eileen spent two years teaching at Saint Agatha's school in Milton where she taught third grade. She then went to Our Lady's in Milton where for the next 12 years Sister taught first grade and then to Saint Catherine's in Somerville where she taught first grade for 13

Sister Eileen attended Regis College and in 1993 received her Master's Degree in Administration from Emmanuel College. Her skills as an administrator would serve her well in her years at Saint John where she guided the school from a simple neighborhood school whose students were drawn nearly exclusively from the North End to today's school where two thirds of the students come from other neighborhoods in the city, creating within the school greater ethnic diversity.

Sister Eileen is fond of saying, "You are number one, if you are doing your best," coupled with her gentle but firm leadership and guided by the mission, "Peace Will be Our Way," Saint John's, which is now 116 years old, has become a safe urban haven with high academic standards placing an emphasis on values as part of its curriculum. Sister has embraced new technology

Is it a crime to possess one ounce or less of marijuana? Is it a crime to possess one ounce or less of marijuana with intent to distribute one ounce of marijuana?

> COMMONWEALTH vs. SHAWN M. KEEFNER SJC-11019

> SUPREME JUDICIAL COURT OF MASSACHUSETTS 461 Mass. 507; 961 N.E.2d 1083

November 7, 2011, Argued • February 13, 2012, Decided

The Court said:

Except as specifically provided in [the act], neither the Commonwealth nor any of its political subdivisions or their respective agencies, authorities or instrumentalities may impose any form of penalty, sanction or disqualification on an offender for possessing an ounce or less of marijuana ... Information concerning the offense of possession of one ounce or less of marijuana shall not be deemed 'criminal offender record information' ... and shall not be recorded in the Criminal Offender Record Information

How about the fact you have the one ounce with intent to give it or sell it to someone else?

The Court said:

Here, the crimes of simple possession of marijuana and possession of marijuana with intent to distribute are listed separately in the General Laws, have different elements, and are distinct. The act, insofar as it relates to the simple possession statute, only applies to a small amount (one ounce or less) of marijuana. In contrast, the crime of possession with intent to distribute applies to any amount of marijuana if the intent is to distribute it (as opposed to personal use).

This case says if you possess one ounce of marijuana it's not a crime. But if you possess one ounce of marijuana with the intent to give or sell it to someone else it's a crime.

RASCAL FLATTS Proves 'Changed' is Good!

Country music superstars Rascal Flatts kicked off their 'Changed Tour 2012' this past week, with stops in Hartford, Connecticut and most recently at WKLB's 19^{th} Country Music Festival on Saturday night. Their show at the Comcast Center in Mansfield drew a huge crowd that was truly ready to rock and enjoy a true country hoedown. With a supporting cast that included Little Big Town, the Eli Young Band, and Eden's Edge, the stage was set.

Currently enjoying the success of their latest #1 hit, "Banjo," culled from their eighth album titled 'Changed,' the group stepped up on stage to prove that 'Changed' is good. Proof is in the fact that this group has taken some risks, recently switching record labels (signing with Big Machine Records), and joining a new management company, both major changes after ten years of being on board with their previous associations.

Encompassing a span of close to four hours, country music fans were able to revel in a heavy dose of pleasure that was capped off nicely by Gary LeVox, Joe Don Rooney and Jay DeMarcus. The trio provided all the ingredients for a lengthy "Summer Night" with their seemingly endless list of hit songs. The tone for the evening was set with the opening strains of "Banjo," picking up the pace with "Bob That Head," and drove the crowd wild via "Fast Cars and Freedom." Audience participation was worked into the show, as the group gave the appearance that they were taking requests from the audience and then performing a medley of song favorites.

The night air was filled with charted 'winners' as, "Here Comes Goodbye," the catchy "Mayberry," the sizzling "I Melt," plus "Every Day," "Stand," the questioning "Why Wait," the romantic "Bless The Broken Road," and the fast-paced "Life Is a Highway." Switching emotions, Flatts lowered the decibels with "Feels Like Today," and they were off again with "I Won't Let Go," the supportive crowd helped out with the chorus of one of their favorites, "Summer Nights," and included the audience in the hook-laden "Me and My Gang." Throwing in some of their new songs from their album 'Changed,' with their second single "Come Wake Me Up" ready to climb the charts, it was a potpourri of country gems.

In a night filled with surprises, one of them was the early departure of a good portion of the crowd, with still a good 20 minutes or so left in the show. Whether it was to beat the traffic, or the fact that the volume of the speakers appeared to be set so high, that the sound sometimes became muffled, regardless, it is rare to see a crowd departing any concert early.

Despite the latter, the audience appeared to enjoy Rascal Flatts performance, and the chance to sing along to their hits, plus the high-fives the group frequently shared with their fans in the stage pit area.

Little Big Town warmed up the stage for Rascal Flatts, and provided the excitement needed, with 40+ minutes worth of their tight-harmonies that always satisfy. The group hit home runs with the audience on the strength of the raucous "Little White Church," their current hit "Pontoon," and mixing in past chart-toppers as, "Bring It on Home." "A Little More You," and a countrified version of Lady Gaga's "Born This Way," just the right sound to get the crowd ready to join in for the explosive closer, their #1 hit, "Boondocks."

Rounding out the show's lineup were the Eli Young Band (Republic Nashville) who brought on the applause, delivering their #1 hit "Crazy Girl," and their latest single "Even If It Breaks Your Heart." The night's opening act was Big Machine Records' Edens Edge comprised of lead vocalist Hannah Blaylock, Dean Berner and Cherrill Green. They earned a huge welcome as well, showering the audience with their charted songs, "Amen" and "Too Good To Be True."

For the 19^{th} consecutive year, country radio's WKLB has scored big with their monster Country Music Festival, allowing every fan in the audience to become a 'live' part of the country music scene — at least for a night!

ISN'T GOOD NEWS A GOOD NEWS STORY TOO?

On June 7, I was over at Franklin Field in Dorchester by Talbot and Blue Hill Avenue. It was a big deal. Over 400 kids, parents, families and friends showed up for the 12th Annual Respect Awards being given out to players in the Metro Lacrosse program which keeps children motivated and out of trouble. Several years ago not far from this event, I passed by a murder scene late at night. Cruisers and flashing blue lights were everywhere. The media was eating it all up. This is news. However, when a program or programs that are positive and helps kids grow up healthy and safe, that's not news? Sadly the media was once again AWOL because this was news that was worth repeating on-air.

"PEOPLE DON'T ALWAYS KNOW" WHEN THEY'VE BEEN VICTIMIZED

Bob Sanders, director of the Boston office of the Equal Employment Opportunity Commission is defending his staff tactic of hunting for victims to represent even when no one had filed a complaint. He called this strategy "commission-initiated investigations." He believes, according to a Boston Herald story, that applicants and employees may not even recognized being discriminated by their employer or perspective employer.

Dave Andelman from the Restaurant and Business Alliance called the recent targeting of the Marylou's Coffee chain "outrageous." "Imagine if the framers of the Constitution knew," said Andelman, "that federal agents would show up from Washington to Massachusetts for the supposed crime of hiring pretty girls to pour your tea. The framers would take bayonets to each of their throats."

Sanders, by the way, has led the Boston EEOC office since 1993 which might mean it is time for some new blood with seemingly less aggressive behavior issues at this agency. Dave Tuerck from the Beacon Hill Institute simply said, "The EEOC should butt out." Short and to the point!

AUTOMATED EXTERNAL DEFIBRILLATORS (AED) IN POLICE CRUISERS?

The Boston City Council's Committee on Government Operations recently held a public hearing to deliberate an ordinance by City Councilor Charles Yancey mandating use of AEDs in police cruisers. Yancey says he wants to make sure when police arrive before fire and EMTs that they can be equipped with the tools to save lives. He stated that often police arrive at medical emergency calls first. I would tend to disagree with that statement. Usually Boston Fire is almost always first on the scene.

Council President Stephen J. Murphy co-sponsored this

city legislation and hoped the financial component for this equipment could come from a Homeland Security grant. Yancey tried to get this ordinance passed once before in 2009

I wonder what the Boston Police Department thinks about such an ordinance? How often would police use AEDs and is there really a need to have one in every cruiser? Where does Police Commissioner Ed Davis stand on this issue? Where does the Boston Fire Department stand on this too?

WE SHOULD RECOGNIZE THE FLAG OF SOUTH VIETNAM AS THAT COUNTRY'S OFFICIAL FLAG IN AMERICA

Recently, in Dorchester, City Councilors Charles Yancey and Frank Baker celebrated Vietnamese Heritage and Freedom Day with members of Boston's Vietnamese community. Vietnam in 1954 was divided between North and South after almost 100 years of French rule. In 1975 the South was overrun by the North creating Communist Vietnam. Vietnamese Americans have been lobbying city and state governments across the country to make the former flag of South Vietnam, the flag of Vietnamese Americans and many communities have done so.

Many Vietnamese fled Vietnam after Saigon fell and started coming here in 1975, Dorchester's Fields Corner area has a large and thriving Vietnamese community. In this country today there are nearly two million Vietnamese who call America their home. This community has done quite well in their adopted country and is proud to call themselves Americans today.

RAY FLYNN SAYS NO TO CASINOS

Recently, Ray Flynn joined up with East Boston opponents of a proposed Suffolk Downs casino and said he sees no good reason for East Boston to host a casino. Joining the protest at Maverick MBTA Station, Flynn says he believes there is a better use for the Suffolk Downs site where developers have proposed a \$41 billion casino. Ray's opposition now puts him at odds with current Mayor Tom Menino.

CAPUANO SUPPORTS BUNKER HILL DAY AS A NATIONAL HOLIDAY

U.S. Rep. Michael Capuano told over 300 folks inside Charlestown new K of C Hall at the 27th Annual Bunker Hill Associates pre-parade breakfast on June 10 that he supports the idea of making Boston's Bunker Hill Day a national holiday for the role this battle played in our bid for freedom from British rule. While the American militia lost the day, it was the beginning of a winning fight for freedom. Capuano said he would not file legislation on Capitol Hill until he can ignite a homegrown groundswell of support. It will

now be up to Townies to start this ball rolling.

The result: Car commuters have an elevated risk of heart disease, diabetes and cancer.

ELBOWS WITH ZUCCHINI

in Tomato Sauce

- 2 medium-size zucchini, washed and chopped (not peeled)
- 2 large ripe tomatoes or a four-ounce portion crushed

1/3 cup olive oil 1 chopped medium onion 1 tablespoon capers (optional) Basil and salt 1/2 pound elbow macaroni

In a saucepan, sauté onion and capers in oil until onion is opaque. Add chopped ripened tomatoes or four ounces of crushed tomato. If a heavier sauce is preferred, use a fourounce-can prepared tomato sauce instead. Cover and simmer about seven minutes. Add chopped zucchini and dried or fresh basil. Add water if more liquid is desired. Bring to a boil. Cover and simmer slowly until zucchini is tender.

Cook pasta according to directions on the package. Pour zucchini with sauce over cooked elbows and serve. Serves two.



Nanna & Babbononno

A Nostalgic Remembrance



Last week, I was talking about Dad's career after WWII. His life style changed from his younger days. From what I understand, you could make a living at just playing music before the war. Most of the people he grew to know and work with did not have day jobs prior to 1945. They played music. The music scene changed after that. The big bands that existed before the war, to a great degree, disbanded due to the war with the musicians being drafted and most never reorganized the way they had existed in the '30s. Dad had a close friend, an accordionist named Gordon Seabury who advised him regarding his future. He convinced Dad that, after the war, things were going to be different than they had been and Dad listened. When he opted for a day job, it might have been the best career move he could have made.

When the changes in the music business began to take place after the war, many of the musicians who were just out of uniform found it difficult to make a living. Most went in search of day jobs and settled for whatever they could find. The changes didn't take place all at once, but they did happen. The big band era was coming to an end. The 16 to 18 piece swing bands of Benny Goodman, Artie Shaw, the Dorsey brothers, Duke Ellington, Count Basie ... all survived as smaller units. Many of the second tier bands just disappeared. Small groups — trios, quartets and quintets with singers took their places. The supper clubs diminished in number. Most restaurants, especially Chinese restaurants, most of whom had live shows with bands, stopped their entertainment policies. Ballrooms stayed alive as did the small night clubs, but the days of working six nights a week on a steady basis were gone.

The young people who danced to the big bands were not young anymore. Those just leaving the service tion of musicians in the were settling down, marrying and bringing children tive. I tried the accordion into the world. As a result, going out at night and having a good time became the back burner of life. The new young people wanted their own music, not what was handed down to them from their parent's generation. Beginning in the early 1950s, they found it. At first,

it was called rhythm and blues, and later, rock and roll. New young bands were born, and piloted the new music. Many of the older performers couldn't understand the melodies nor feel the beat and settled for the occasional wedding or other booking that didn't require knowing the new music.

Another phenomenon came in right after the war that accelerated the loss of work as a musician. It was called television. TV hit New York in 1947 and Boston by 1948. By 1949, Dad bought the first of many TVs that we would own and going out for entertainment was not necessary any longer. When this happened all over the country most musicians became weekend warriors and you couldn't support a family on just weekend work. As time progressed, Dad fell into this same category. He did better than most as he was that good and always in demand, but the musicians who didn't have day jobs had it rough.

Babbononno began giving me music lessons when I was in short pants. He taught me a subject called solfeggio. It is the Italian method of the articulation of music that has become the standard around the world. I would sit next to Babbononno, my feet dangling in the air. In front of us would be a music stand with the music facing us and I would have to sing and read the music note for note while Babbononno conducted it with a ruler in his hand. If I read or sang something wrong, I would get hit with the ruler. By the time I was ten years old, I had hands that looked like they belonged to a fighter, but I learned. The best part of my lessons was when Nanna would yell, "Lunch is ready," in Italian.

After a couple of years of solfeggio with Babbononno, it was time to pick an instrument. Babbononno, Dad and my uncles wanted me to be the 3rd consecutive generafamily and I had no alternaand hated it. I tried piano and hated it. I tried clarinet and hated it. I opted for the trumpet and began to take lessons. As a result, when I entered junior high school, I took up the bugle and played for the Drum and Bugle Corps at the Joseph H. Barnes Junior High School

in East Boston and loved it. When I started high school, I joined the English High School band, but working at the Seville Theater and playing baseball were more important. As a result, the trumpet began to collect dust.

By the time I was half way through high school, music was something I danced to, not played. One day, Dad offered to teach me how to play the bass. It was about the only instrument I had not tried. Right from the beginning, I loved it and took the instrument seriously. By the time I was out of high school, I turned professional, first joining some neighborhood kids playing locally and then spreading my wings once I was good enough to play with more professional groups.

I had thought of making a career of playing jazz, the music I grew to love. Fortunately, I went to college, got myself an education and relied on music as a sideline instead of a full time job. Once I was out of college, I began to teach school. The schedules I had teaching in Boston afforded me the opportunity of going home to take a nap and then playing at night in a refreshed state. I discovered the realities of the music business as I became more experienced. I loved jazz, but it didn't pay as well as a wedding reception. Seeing I could do both, I tried my hand at both and held my own. Whenever I would come across something that was difficult to play and I mastered it, I would silently say, "Thank you Dad and Babbononno."

When Dad thought it was time, I joined the musician's union. Uncle Nick was the vice president at that time and Dad was on the board of directors. This fact didn't hurt as far as name recognition was concerned. Doors opened more easily, but I had to prove myself on my instrument regardless of what my name was. I must have done something right, as I always worked. The extra money afforded me nice clothes, the cars I liked, lots of vacations and some good investments along the way. Thanks to music, it never cost my family any money for my education. I paid my way through college. After college, I decided to go after a master's degree and paid for it on my own. I went after a second master's a few years later and then a doctorate, again paying out of my own pocket. Thanks to the guidance from Babbononno and my father, I have been rather lucky in life. The one thing I think I inherited from them is what I call the Italian work ethic. And, considering what I've tried to accomplish over the years, I guess the apple doesn't fall far from the tree. By the way, my two kids have adopted the same work ethic. GOD

getting called back to the scene. Mahoney remembers, "When I got back, it was a pile of rubble. All I could see was smoke and firefighters on top of the rubble moving debris with their bare hands ... Telling a son that his father was gone on the morning of Father's Day - was heartbreaking ... (In all) I've had to inform loved ones of fallen firefighters 68 times. It never gets easier. In fact, it gets harder each time."

I will always and forever remember the image of Ladder 15 in the rear of the building crushed in the pancaked rubble left in the silence of that agonizing day. That weekend 40 years ago was a sunny one, but as the sun rose up on Sunday morning, Father's Day, that year there was an inner gloominess that paled over all. It took 25 years to get this Back Bay Vendome Memorial built honoring those who sacrificed their lives on that long-ago Saturday afternoon. Firefighters had worked at the fire scene until 2:00 am in the pre-dawn hours of Father's Day rescuing 16 men and recovering the bodies of 9 heroes who gave their lives in service to the people of Boston.

Hundreds of folks, families, co-workers, friends and perfect strangers took the time on this June 17th to pay their respects and honor the memory of all those who sacrificed their lives for us that day. We will never forget and will long remember that band of brothers who now live together in eternity.



THE PRIVILEGES OF THE ITALIAN CASTE ...

We have discussed in recent past the scandalous benefits, free services, and free flights the members of the Italian Parliament enjoy. It has come to our attention recently that all the members of the national legislature, more than 945, continue to enjoy, unlike the taxpayers: a very low interest mortgage. Whenever a member of either branch of the Parliament applies for a mortgage, the bank's interest rate (usually the Bank of Italy) is only 3.45%, for the Senators, and 4.55% for the members of the Chamber's Deputies. It's interesting to note that during the Berlusconi's tenure the interest rate charged to the members of the Chamber was even lower: 4.27%. Furthermore, the process to get the mortgage, to a Parliamentarian, cost only 150 euro, as opposed to the rate the bank charges to an outsider a minimum of 600 euro and as much as 2,500 euro. Now if you wonder why Italy's economy is in shambles you need to look only at the shenanigans of the 'professional' politicians who learn fast the ropes of practical politics and become quite groomed in the 'art' of profiteering. For the good of the country things seem to be changing now. In the first 100 days of Monti's administration all 700 so-called experts and consultants of both branches of the Parliament have been fired, with a net saving of over 24 million euro, at least, perhaps even more. Gone are the days when all kinds of 'imbroglio' were tolerated, even encouraged by the former Premier Berlusconi.

THE EXPERIMENTAL ADVANCES IN THE TECHNOLOGY OF TRANSPLANTATIONS ...

It seems that experiments to create organs from stem cells have accelerated of late. The reason may be the lack of organ donors not only in the U.S. but also in other parts of the world. The list of patients waiting for donors has sharply increased particularly during the past two decades. An Italian doctor, Paolo Macchiarini, who works at the Karolinska Institute of Stockholm. Sweden, is an active researcher on human organs, some of which have already been transplanted, experimentally, on humans. The secret of organs grown in labs rests on stem cells, the new frontier of medical science. They multiply to repair an organ and regenerate damaged tissue, on the strength of chemical factors, well calibrated, so that the stem cells can create a certain tissue. One of the most difficult aspects of biological engineering remains the identification of the most appropriate stem cells and the choice of the appropriate method to have them to regrow. Of course, to see an organ grow in a lab takes weeks or months. Several tracheas have been already transplanted on patients, and quite successfully. If the stem cells come from the patients the rejection process will not occur.


The studies on the use of the stem cells are multiplying worldwide. We constantly read about new progress in the application of stem cells, especially in the manufacturing of several organs.

U.S. Ordered to Say If it Seeks to Execute RI Inmate

United States District Court Judge William E. The judge issued the order in the case of Jason Pleau who is accused of killing a gas station manager outside a Woonsocket bank in 2010. Chafee had refused to turn him over until the U.S. Court of Appeals in Boston ruled that Pleau can stand trial in federal court. Chafee and Pleau sought help from the U.S. Supreme Court but were turned down. Rhode Island turned him over to the feds in May. All this foolishness is what happens when voters choose to elect a loopy liberal independent to run Rhode Island.

Deal with Student Loan Issue Quickly

General of Italy in Boston, Giuseppe Pastorelli. "There was a chance to strengthen economic and scientific ties with Italy," said Pastorelli. Who Said There's No "Politics in Boxing?" World Champion Manny Paquiao Defeated by Judges Pug Luncheon June 12, 2012

Manny Pacquiao and Freddie Roach are a great team. What do you think about the decision given in this fight? Promoter Bob Arum I read says, "The decision was a ridiculous decision. You guys all know who won this fight. So let's be honest about the situation. Hopefully we'll revisit it in November ... I hope boxing recovers, because this isn't arguing about a close decision. This is something that's an absurdity. That's ridiculous, and everybody that's involved in boxing should feel ashamed." **Jimbo Curran** says, "It was the biggest robbery, since the Brinks!" Manny Pacquiao has Boston area Trainer Freddie Roach from Massachusetts in his corner. Congressman Manny Pacquiao is an eight division World Champion. Too many times others think they are demonstrating strength when they are actually demonstrating "Weakness!" when they do something ridiculously wrong. Judges voting for Bradley demonstrated "Not doing the right thing!" Champion Manny Paquiao landed 190 power punches as opposed to the 106 landed by Bradley. 190 minus 106 = That's "84!" more power punches. This was a professional fight. Power punches equate to a higher point value in the Professionals than do jabs and non-power punches. As you remember, that in the amateurs jabs and power punching rights or lefts are scored equally. You know? Power right hands thrown by fighter #1 in the amateurs is scored the same as a staggering right hand. Please don't rush me. That means that Bradley would have had to have landed 169 more non-power punches to have won the decision. Rookie Camp will get under way on Friday, September 14 at Ristuccia Arena in Wilmington, the official practice facility of the Bruins. One week later (Friday, September 21) the full training camp including all veterans and the rookies still on the big club's roster — will convene.

They won't get much practice time since the exhibition season begins just four day later on Tuesday, September 25 when the B's take on the Washington Capitals - the team that knocked the Bruins out of the 2012 Stanley Cup playoffs — in the nation's capital.

Want to really get the feel of an NHL regular season schedule? How about a good old back-to-back right at the start? That's what the B's will face as, without a day off. they head right to Buffalo to take on the Sabres the very next night on September 26.

Then there's a three day break — before another back-to-back on the road. This time it will be against Winnipeg. The first game against the Jets will be a neutral site game in Saskatoon, Saskatchewan on Saturday, September 29. That will be followed the next day (Sunday, September 30) with another game against the Jets on their home ice in Winnipeg.

The first action at the Garden will look a lot like the last game played at the Causeway Street facility this past spring. That's because the B's will be taking on the Washington Capitals, the same team that beat them back in April, in the contest that is set for Wednesday, October 3.

Two nights later the B's will face off against the Buffalo Sabres at the Garden on Friday, October 5. Both Garden games will start at 7:00 pm.

The Black and Gold will then travel north to take on their archrivals — the Monvery next night (Saturday, October 6). Yes, that is the third back-to-back scenario of the preseason. What a schedule! We hope everyone isn't already worn out before the regular season starts the middle of the following week.

DEVELOPMENT CAMP — It used to be held sometime after the Fourth of July but the Bruins have announced that this year their annual development camp will be held from June 28 to July 2 in Wilmington.

This camp, open to rookies and prospects, features onice drills, power skating, full practices and some scrimmages, plus additional office workouts. The vast majority of players at the camp will not make the Bruins opening night roster come

ior hockey, while others will play in the minors. A select few might make the B's the franchise announced the training camp roster for a few days before being sent to their final destination.

> A STANLEY CUP FINAL WITH A HOCKEY EAST FLA-VOR — Wherever you go in the hockey world, individuals with Hockey East affiliations seem to make their mark.

> The latest instance of that is the Stanley Cup champion Los Angeles Kings who featured three former Hockey East players, including former UMass-Amherst goalie Jonathan Quick.

> Others who played in Hockey East included former Maine forward Dustin Penner and former Boston College defenseman Ron Scuderi.

> Quick, who was selected as the winner of the Conn Smythe Trophy (Most Valuable Player in the Playoffs), is the third consecutive former college player to be honored with the award. Bruins goalie Tim Thomas, who played for Vermont, won the award in 2011 while Chicago Blackhawks player Jonathan Toews, who formerly saw action between the pipes at North Dakota, was chosen in 2010.

> Quick had a stellar 1.41 goals against average, a .946 save percentage and three shutouts over the span of the 2012 playoffs that saw him post a 16-4-0 mark. Penner had 11 points in 20 playoff games via three goals and eight assists while Scuderi had one assist and a +9 rating.

> Quick had a stellar prep school record at Avon Old Farms in Connecticut, going 53-8-0 over three seasons, including one year where he lost only one game (1.24 goals against average) and another where he lost only two (1.15 goals against average).

Those stand in contrast to treal Canadiens — in their his college days when he last preseason contest the posted a 23-22-6 career record to go with a 2.40 goals against average. After three years in the minors, he joined the Kings and has been with them for the past five seasons.
