Remembering the Vendome Fire & Never Forgetting Our Heroes

Saturday afternoon, June 17, 1972 was when nine firefighters perished when a wall collapsed after a fire at the Hotel Vendome was extinguished. Firefighters had spent three hours fighting the four-alarm blaze, when the floor collapsed trapping nine firefighters. This fire took the lives of more Boston firefighters than any other in Boston history.

A Mass was held at the Cathedral during the following week. Everyone watched in sadness as the funeral procession passed by.

The Bunker Hill Parade was the following morning. People in Charlestown were strong then as

they remain so today. They watched the parade that year with less cheering. The fire had hit Charlestown personally. We all knew many of those firefighters. They weren't just names, they were real people and they were our friends.

After all these years, the memory of the Vendome fire lives on. Today we can cheer at the parade again but there will always be a sense of loss as the photo of the crumbled hotel lives on in the collective memories of all who were alive on Saturday, June 17, 1972.

A memorial was built to honor the nine fire fighters, and was dedicated on June 17, 1997.

Stirpe Nostra

CAUPONA

During the last three issues, we examined the ancient Roman marriage rites and their attitude toward matrimony. This week I'd like to look into their inns. I guess this makes me a peeping Tommasino.

A Roman wayside inn for the reception of travelers was called a "caupona" or "taberna," and these were located along all the great roads in Italy. They were built for speculation by neighboring property owners and either leased to an innkeeper or managed by their own slaves. A "stabulum" (stable) was usually attached to one end of the caupona. Where the traffic was greatest, several of these inns were usually built close together. Some historians say that the increase in the number of travelers made the inns necessary while others claim that more people traveled because the accommodations were available. Persons from nearby provinces flocked to their "Ludi" or national games and this alone required great numbers of suitable facilities in the city as well as on the highways.

In the earlier ages of Rome, there was no provision for the entertainment of travelers and the duty of the innkeeper to provide hospitality was standard practice. This was a characteristic feature of most countries and was of a twofold nature: It was practiced between individuals and also between the provinces. A stranger who appeared with no hostile objective was treated



as a friend in need, under the special protection of the gods and was kindly received. The quality of the accommodations that were provided could never be termed luxurious and the attitudes of the landlords often left much to be desired.

Some innkeepers were accused of gouging the public, adulterating their food and wine and in extreme cases, even murdering their guests and stealing their valuables. The higher classes used these inns as little as possible, however, when other accommodations were not available they sometimes were forced to use them to transact diplomatic business along with the lodging (I'll have to remember that one).

The man who kept a "caupona" was called a "caupo" or "copo" and a female was called a "copa." The name "caupona" generally referred to

an inn where travelers obtained food and lodging, however, the name was often given to shops which served wine and dressed meat. This is in direct contrast to some of the establishments of today which serve wine and undressed meat.

L'Anno Bello: A Year in Italian Folklore

The Magic of Midsummer Nights

What is it about summer nights that make me think of magic, moonbeams, fireflies, and fairies flitting about a darkened forest? Perhaps the answer lies in the velvety hue of the evening sky, offset by the delicate diamond-like stars that peek out from the late sunset. Or perhaps the answer resides in the comforting sound of crickets and cicadas humming their melody from deep within bushes and trees. It could also be that people tend to congregate outside during the warm summer twilight, illuminating the atmosphere with candles and lanterns from barbecues and alfresco dinners. I always find that the most magical of these nights occurs around the summer solstice, the longest day and shortest night of the year. In olden times, the summer solstice was known as midsummer, which can confuse those of us who view the solstice as the beginning of summer rather than the middle. Ancient Europeans used agricultural rather than purely astronomical methods of gauging the seasons, and so the solstice was considered the height of summer rather than its commencement. As Christianity spread across the continent, Midsummer festivities became absorbed into the feast day of St. John the Baptist, creating an indelible mix of traditions. The result is one of my favorite holidays, a festival that embodies the magic and boldness of summer.

Europeans in older times began the summer on May 1st, or May Day, the holiday that marked the time to let livestock out to graze in pastures. Summer ended on Lughnasadh, which fell on August 1st, the festival of the grain harvest and the first fruits of the autumn. As a result, the summer solstice

marked the midpoint of the season and as such was called as Midsummer. In Europe, Midsummer heralded not only the longest day of the year, but also the period after which the daylight hours would slowly shorten. For this reason, I like viewing the solstice as the middle rather than the beginning of summer as well — it makes little sense to celebrate the start of summer when the sun begins to diminish in the sky! Midsummer customs later attached themselves to June 24th, St. John the Baptist's Day, the feast commemorating the birthday of the important Biblical figure six months before Christmas. In Italy, St. John's Day customs symbolize both the decline of the sun after the solstice and the sense of magic which pervades the evening. All over the Italian countryside, *gli fuochi di San Giovanni*, or St. John's bonfires, blaze from the hilltops on the eve of the saint's festival. These fires both mimic the power of summer sun while also symbolically imploring the sun to stay longer in the sky. Young Italians may also spend the evening gathering herbs, which are supposedly imbued with mystical properties on this unusual and magical night. According to old superstitions, these herbs work especially well for romantic divination, and people slip them under their pillows to dream of their future spouse.

Across Europe, similar Midsummer and St. John the Baptist's Day traditions utilize the seasonal staples of water, fire and greenery. In Scandinavia, Midsummer is one of the most significant holidays of the year, on par with Easter and Christmas. Sporting wreaths of flowers on their heads, Scandinavians celebrate this holiday by dancing

around Maypoles bedecked with greenery, building bonfires near lakes and rivers, and sitting down to feasts featuring summer ingredients like strawberries and potatoes. Meanwhile, girls in Russia and Eastern Europe float flower garlands down rivers and attempt to foretell the future by interpreting the movement of the garlands. People in Spain and Portugal celebrate the Feast of St. John the Baptist with outdoor carnivals, bonfires, street fairs, and the exchange of potted herbs. Italians, of course, never pass up an opportunity for a festival and party accordingly on St. John the Baptist's Day, especially in cities of Florence and Turin, where he is the patron saint and outdoor fairs and fireworks displays mark the occasion. Out in the countryside, people may enjoy St. John's apples, or *le mele di San Giovanni*. A favorite of my father, these are small green apples so named because they ripen extremely early, just around the time of the solstice. No matter where one goes in Europe, charming Midsummer revelries emphasize the importance of the summer sun and the blessings of the season. The United States even boasts its own festivals full of outdoor excursions, fireworks and water — the Fourth of July, of course!

Above all, Midsummer is a holiday tinged with bittersweet nostalgia. While it honors the height of the sun's power and the carefree days of summer, it also recognizes that the hours of sunlight will slowly start to diminish once this date is past. It is a poignant reminder that nothing lasts forever. Yet, Midsummer is celebrated with joy, not sadness. Its celebrations encourage people to enjoy the longest day of the year by living life in the present moment. We know that the year is a cycle, and that we should appreciate each season for what it offers. The darkness of autumn and winter reveals celebrations of the Earth's bounty and communal feasts where families gather together in joy and goodwill against the cold. And yes, the sun will be once more reborn in a bright blaze of glory on the winter solstice, immortalized in light-themed holidays like Hanukkah and Christmas and New Year's Eve. This summer solstice, live in the moment and enjoy all that summer has to provide on the longest day of the year — and let's make a vow to carry that sunshine, optimism and wondrous magic within us for the rest of the year.


"The Boston Celtics Select Len Bias of The University of Maryland"

OKLAHOMA!

Is More than Okay!
Through July 7th

It has been seventy-five years since Richard Rodgers and Oscar Hammerstein collaborated on their first play and changed musical theatre forever. *Oklahoma!*, with a bit of refreshing, has held up well and the latest production now playing at The Ogunquit Playhouse gives this great work the respect it deserves.

The play about the growing pains of the soon to be 46th state takes place, with the exception of the final scene, in one day. There are two romantic stories, the one between Curly (Stephen Mark Lukas) and Laurey (Taylor Quick), and Ado Annie (Chessa Metz) and Will (Colby Dezelick), as well as the conflict's that arise as two groups, the cowboys and the farmers, have to learn to live together and share the land. There is also the matter of Judd (Timothy John Smith), the brooding and scary loner, who doesn't fit in.

As the overture plays, beautiful scenes are projected on the curtain that gives us a sense of the vastness of the Oklahoma territory. The opening scene, which was a departure from usual theatrical formula at the time in which the play first hit Broadway, shows Aunt Eller (Susann Fletcher) churning butter while, from off stage Curly begins singing *Oh, What a Beautiful Mornin'*, which is as effective now as it must have been in 1943.

The sets which include a cabin, windmill, cornfield, and a backdrop that seems to go on forever are constant reminders of the vastness of and challenges faced by those building a community on this new land.

The score is still as fresh as the morning dew on the cornfield. Stephen Mark Lukas and Taylor Quick in the leading roles combine the acting chops and voices that their parts demand. It is said that Rodgers and Hammerstein would cast singers who could act rather than the usual model of finding actors who could sing. I'm not sure what formula was used here, but it certainly works.

This production is based on the 1998 London revival, which ironically did not transfer directly to Broadway because Actors Equity demanded only American actors be allowed to play in it. The choreography by Susan Stroman is the same used in that revival, and is led

here with some additions by choreographer Ginger Thatcher who has worked with Stroman. It is important this was handled well as *Oklahoma!* is as much a dance piece as it is a musical, and Ms. Thatcher gets it done darn well.

The dream sequence ballet ending Act I is breathtaking. Ms. Thatcher along with this amazingly talented cast have given audiences a scene that will be talked about for years; atmospheric, emotionally jarring, and just magnificent! At the performance I attended the audience was in awe as they stepped out for intermission.

The play, at moments teeters on the brink of sentimentality but never goes over the edge also has a dark side to it. The character Judd, who comes across as creepy and threatening, and with good reason, never fits in with the others. In all of the pieces I have read about the play I have not read any that show sympathy with him. In this production Timothy John Smith gives us all of the darkness of Judd, but also an undercurrent of how things may have been different if the others had made an effort to understand him. I'm reminded a bit of Captain Queeg in *The Caine Mutiny*. Could a sympathetic ear have made a difference? After all, early in the play it is Curly who shows a dark side when, in jealousy over Judd's escorting Laurey to the box social, he visits Judd and attempts to convince him to commit suicide. While the song is funny it is also quite disturbing, and the Calibanish Judd sees through it; not exactly an invite to join in with the community. Mr. Smith brings more complexity to this character than I have seen before, and he does it very subtly. Quite impressive.

All of the musical numbers are memorable with *People Will Say We're in Love*, *The Farmer and the Cowmen*, *The Surrey with Fringe on Top*, and the finale *Oklahoma!* being particularly outstanding.

Oklahoma! is a wonderful musical but it is more. The story has many levels to it, and it is one that can make us think about the challenges of working together to build and maintain a community. In a way we are all farmers and cowboys who have to work on being friends. It is also a reminder that being able

to get along does not mean not having differences, but, instead, respecting those differences. It also means striving to understand the outsider.

With cornfields that literally reach out to the actors, an unbeatable score, a cast that abounds with talent, lighting and scenery that are beyond impressive, this is a theatre experience not to be missed. Director Fred Hanson has pulled it all together and the Ogunquit Playhouse stage is the perfect theater to witness it in.

Every so often I like to remind my readers that the Ogunquit Playhouse is not summer theatre. It is a full blown theatrical company that rivals Broadway in quality. As is seen in *Oklahoma!*, you get top talent with a production team that knows how to out on a play. And it all takes place in a beautiful and comfortable theater. If you haven't been before, don't hesitate to take a drive up to beautiful Ogunquit, Maine and see for yourself. Richard Rodgers and Oscar Hammerstein would be pleased. You'll leave the theater saying "*Oklahoma!, You're Okay!*"

Saint Clelia Barbieri

Clelia Barbieri was born to Giacinta Nannetti and Giuseppe Barbieri, on February 13, 1847, in a village called "Budrie" of San Giovanni in the vicinity of Bologna, Italy. Her parents were of different origins: Giuseppe Barbieri came from one of the poorest families of "Budrie" while Giacinta from the most important family in town:



Santa Clelia Barbieri

After her much-contested wedding, the wealthy Giacinta accepted the poverty of a laborer's life and moved from a comfortable home to the humble cottage of her father-in-law.

Clelia's father died in 1855, due to a cholera epidemic, so she started to work alongside her mother spinning hemp to support her siblings.

During this time, the family moved into a house near the local parish church. Clelia started to spend her time in deep contemplation during her childhood and despite her poverty, she was raised in a pious household in which religious education was imparted to her. She made her First Communion on June 17, 1858.

Clelia later joined "The Workers of Christian Catechism" as an assistant teacher in 1861, and became such an inspirational leader that the parish priest — Father Gaetano Guido — entrusted her with the teaching and guidance of girls in doctrine. Up until 1864, she rejected marriage offers put forth to her and opted instead

to lead a pious life of service to others. At the age of 21, Clelia founded a separate group known as the "Suore Minime dell'Addolorata." This group began to minister to the poor and the sick in the local area.

Clelia died due to tuberculosis in 1870. Her religious order operates in places such as Tanzania and India and in 2008, there were 296 religious houses in 36 different communities. Being only twenty-three at the time of her passing, Clelia Barbieri is considered the youngest founder of a religious order in the history of the Church.

She was Canonized on April 9, 1989, by Pope John Paul II. The Feast Day of Saint Clelia Barbieri is on July 13th.

Summer Pet Care Tips: Take Great Care of Your Friends?

Nanna & Babbononno

A Nostalgic Remembrance



The evolution of my folk's generation changed dramatically after WWII. Dad had been teaching machine shop at East Boston High School, and was approached one day by someone he knew in administration. It seems that this man, Joe Hennessey, had a friend who was running for school committee. He was from Jamaica Plain and knew no one in East Boston. Mr. Hennessey asked Dad if he would help out in campaign matters, as Dad was perceived to be well connected in Eastie. Dad first wanted to meet Hennessey's friend and a dinner meeting was arranged. Dan McDevett and Dad hit it off right away. He was personable and seemed honest. After dinner, Dad agreed to help in any way he could. As a result of Dad's marketing McDevett topped the ticket in the East Boston school committee race that year.

Not long after McDevett was sworn in, he called Dad and asked him to meet him after school at committee headquarters. It seems that the school department wanted to implement a new concept within the Boston schools. It would be a facility that handled the latest in electronics and science. Dad was interested. The new facility would be called the Department of Audio/Visual Education, and would supply films, projectors, cameras, wire recorders, etc., to all schools ... as well as program science experiments for the junior high schools in the city. Dad was interested. He said yes to joining the new department when he was told that his friend Mr. Joe Hennessey would be the director, he was elated.

Dad transferred from East Boston High School to the new department which opened operations at Girls Latin School, which at that point in time, was housed in one end of Boston Teachers College on Huntington Avenue. On his first day, he met two other men who had been recruited as pioneers for the opening of the department. One was Les Morris and the other was Mike Barca, who would become one of Dad's best friends over the next few years.

Dad, in the beginning would head out to different schools and show films that were requested, or make recordings

on wire (later tape) at the different schools. They also specialized in the use of photography at special school department events. As the department grew, Dad began to take courses at Boston Teachers College and B.U. As a result, he was given the responsibility of designing science experiments and shipping the necessary materials to the junior high schools throughout the city.

The new department became a success, and before you knew it, each school in the city had its own audiovisual equipment and a trained person who could handle the mechanics involved (thanks to Dad). This relieved him, Les and Mike from having to go to the schools each day. As a result, the department began to grow, and the original four men increased to six, then eight, then ten. Specialists in various forms of electronics and communications were added to the roster and the new division grew even faster eventually being called the Campbell Resource Center. Dad would remain with the program until he retired from the school department.

Beginning in the late 1940s, the music scene began to change in Boston. The big band era was coming to an end and most of the restaurants that previously offered entertainment replaced bands, singers, and dancers with cocktail pianists. Both Dad and Uncle Nick gave up playing steady nightclub jobs in favor of working for bandleaders who specialized in playing for dances, weddings, christenings, bar mitzvahs, debutant parties, proms, etc. ... At first, they hooked up with a former sax student of Uncle Nick's, Ray DiGiovanni, from East Boston. DiGiovanni became a professional musician after a couple of years of study with Uncle Nick and put together an orchestra under his new professional name, Ray Digg. They would become a mainstay at the Oceanview Ballroom which was located at the beginning of Revere Beach. As a matter of fact, Kelly's Roast Beef, located half way down the beach, has a picture of the ballroom and Ray's band with Uncle Nick on lead sax and Dad on bass violin playing for dancers. Dad, a couple of years later, would team up with a trumpeter named

Barney Mould. Barney and Dad played many of the Jewish affairs in Boston. Both Dad and Uncle Nick would develop reputations of being able to play club dates (single performances) that included just about any type of music and, for a while, worked just about every night of the week.

Dad would have summers off from the school department. An old musician friend, Chet Nelson, began to book in the music for county fairs that took place in many of the northeastern states. Dad also played tuba and Sousaphone and went on the road with Nelson during July and August playing between sulky races during the afternoons and for the variety shows at night at each fair ground. Seeing that Mom didn't work and school was out for me too, he brought us with him to almost every fair he played at. I even landed a job while we were on the road. A man from South Boston, named Louie, handled the scenery for most of the fairs, and in spite of my age, put me to work setting up staging. I was only eleven or twelve and was making \$35.00 a week as his helper.

When Dad had time off, we were often invited to stay in Maine with Mike Barca and his family. Barca, Dad's closest friend from the Department of Audio and Visual Education, was married to a "down Mainer." As a result, he built a cottage on a lake in Maine and my folks and I grew to love staying for a few days at a time. This inspired Dad to buy a cottage near Mike's, on Lake Maranacook in Winthrop, Maine, and from then on, Mom and I would travel with Dad to the county fairs only in July. During August, we stayed on the lake. Over time, Dad began to back off playing in August and joined us, making our stays in Maine some of the best experiences in my young life. We grew to love the people, the area, and constant get-togethers with the locals and other summer residents. Nanna and Babbononno came with us many times and enjoyed something they never experienced in their younger days, a summer's vacation.


Beginning when I was 13, I started a 10-year stay working at the Seville Theater in East Boston. Mr. Ray, the manager gave me the month of August off each year so I was free and clear of any responsibilities. Having my own spending money allowed me to rent a horse for the month of August from a stable near the beginning of the town. My horse for several summers was a pinto named Fearless Fostdick, after a character in the *Dick Tracy* comics. These summer vacations continued until I was out of college. Things began to change after that. Most of my age group no longer accompanied their parents to Maine and it wasn't the same. I, too, began to go places on my own, but that's a story for another day.

with Daniel A. DiCenso

Shakespeare in Love



Somewhere between Monty Python and Elizabeth is *Shakespeare in Love*, a funny and charmingly odd little tale of an imagined love between an aspiring actress named Viola de Lesseps and an as yet (date: 1593) unknown William Shakespeare.

The multi-award winner is a hodgepodge of history and imagination but done throughout with a love for Shakespeare and his work. There are many familiar faces here including Joseph Fiennes as Shakespeare, Geoffrey Rush as theater impresario Philip Henslowe, Colin Firth as Lord Wessex, and Ben Affleck as a villain version of Ned Alleyn, and Judi Dench as Queen Elizabeth. Primarily though, it was the film that cemented the career of Gwyneth Paltrow and turned her into a trans-Atlantic star.

As Roger Ebert explained, "Is this a movie or an anthology? I didn't care. I was carried along by the wit, the energy, and a surprising sweetness. The movie serves as a reminder that Will Shakespeare was once a young playwright on the make, that theater in all times is as much business as show, and that *Romeo and Juliet* must have been written by a man in intimate communication with his libido. The screenplay is by Marc Norman and Tom Stoppard, whose play *Rosencrantz and Guildenstern Are Dead* approached *Hamlet*

from the points of view of two minor characters."

Shakespeare in Love was the brainchild of freelance screenwriter Marc Norman. He conceived of the premise in the late '80s from the least likely source, his son Zachary who first pitched the idea.

"Zack was at Boston University taking a four-year theater course. He called me from a phone booth one morning, with this idea for a movie about Shakespeare just starting out as a playwright," Norman recalls. "I thought it was a great concept for a movie, but it took me a couple of years before I could find my way into it. One thing about your kid giving you an idea is you don't want to go back to him and say, 'I can't do it.'"

After a few years of working on a screenplay, Norman teamed up with director Edward Zwick to sell the concept to Hollywood. Universal eventually bit in 1991, asking playwright Tom Stoppard to adapt it to the screen.

After the screenplay was completed in 1992, Julia Roberts fell in love with the premise and agreed to star. Production was set to start in England when male lead Daniel Day-Lewis backed out of production. Without a bankable star, Universal shelved the production indefinitely asking for an initial investment of \$4.5 million. The only responder was Miramax boss, the now-disgraced Harvey Weinstein. Zwick, however, had moved

on to other projects and so John Madden took over as director. Madden had a flair for period pieces but Norman and Stoppard took Shakespeare's early years (heavily fantasized here anyway) and brought them to the 20th century.

"From the research, though, I think you could argue that *Romeo and Juliet* was his breakthrough play," Norman said. "Before *Romeo and Juliet*, he wasn't Shakespeare; he was just one of many guys writing in the Elizabethan theater. He's doing a good job, but what he's doing is kind of derivative of other stuff ... not anything strikingly better than anybody else. When Shakespeare began writing *Romeo and Juliet*, he was in development hell ... writing stuff just to pay his bills. Then he fell in love, and what he learned from that love affair, he plugged into that play ... the harder he fell, the more the play changed."

Norman, however, made his modern classic a tribute to the literary legend that has been etched in history.

"These guys really were inventing show business. Everything we think of the entertainment business — the star system, arguments over billing, public relations, rivalries, lawsuits, etc." he said. "I found a contract from 1610, which looked just like one I signed with Disney last year. If you're going to write about Shakespeare, you'd better do it really well. I'm not a genius or a great poet. But what we share is that we're both professional writers, and professional writers are usually stuck for ideas, broke and horny — that became an instant way into the material."

Kody Clemens is getting a head start following in the footsteps of dad Roger Clemens. The University of Texas slugger helped put the Longhorns into the College World Series last week.



Had Memorable Sparring Session with Dempsey Before First Tunney Fight

Philadelphia has been home to many great fighters over the years. It is best known for its sluggers such as Joe Frazier and Bennie Briscoe, but many great ring technicians have also come from the City of Brotherly Love. Light Heavyweight Champion Harold Johnson, Middleweight Champ Joey Giardello, and middleweight contender George Benton to name just a few.

One of the greatest light heavyweight champions of all time as well as one of the greatest ring technicians was from Philadelphia. Tommy Loughran was born in 1902, and began his professional boxing career in 1919. Over the next 18 years he fought 126 times (that's his official record, though it is thought he had a number of bouts beyond that number) taking on the greatest fighters of his day while also capturing the World Light Heavyweight Championship. Out of his 126 fights, he had 90 wins, 26 losses, and 10 draws. He was stopped only three times.

Loughran was a master boxer who knew how to move on his feet while employing an excellent defense. He liked to say, "They have to hit me to hurt me, and they can't hit me."

To judge Loughran's greatness you only have to take a quick look at his record. In July of 1922, he fought Harry Greb for the first of what would be five times. In that bout, he lost a close decision and then, just a month later took on Gene Tunney. The bout against Tunney is recorded as a draw with the newspaper reports being split on the result.

Loughran would go on to fight the likes of Georges Carpentier,

Johnny Wilson, Johnny Risko, Young Stribling, Mickey Walker, Ernie Schaaf, Max Baer, and Jimmy Braddock. He won the vacant Light Heavyweight title with a win over Mike McTigue. Loughran who would eventually give up that title and move up to campaign as a heavyweight.

He got off to a rocky start in his quest for a shot at the Heavyweight Crown when he was kayoed by the "Boston Gob" Jack Sharkey in three rounds. However, he would later avenge the loss to Sharkey by winning a decision over the Boston Gob. That win would lead to a title shot against the giant Primo Carnera.

The Carnera fight was held in Miami, Florida. Loughran weighed in at 186 pounds to Carnera's 270, the biggest weight difference in the history of the undisputed heavyweight championship fights. According to Loughran, the only way he would be allowed to win the fight was if he scored a knock out. The Judges' scorecards were extremely lopsided in Carnera's favor, but many at ringside felt Loughran had outboxed the champion and deserved the decision.

Tommy Loughran's greatest fight may have taken place not in public but in a gym. It was September 11, 1926, just 12 days before Jack Dempsey was to defend his title against Gene Tunney. Dempsey had been inactive for quite some time and was feeling the ring rust. He didn't feel he was getting enough of a workout from his sparring partners and asked his friend Tommy Loughran to come over to Atlantic City where he was training and go a few rounds with him. He offered him \$5,000.00 for the sparring session.

Loughran accepted and in an interview he gave to *Sports Illustrated* in 1979, recalled the workout he had with Dempsey. In that interview, Loughran said "But gee, boy, what I didn't do to him. The year before he had had a nasal job, his nose was all shortened, and they didn't know whether it would stand up under punishment. I let him have it on the nose. Blood squirted in all directions. He stepped back and cussed me out loud, and when he did, I grabbed him and turned him around and put him up against the ropes. Gee, I poured it on him, I gave him such a beating. I hit him in the belly, hit him with uppercuts, hit him with a hook, caught him with another. I had his eyes puffy,

his nose was bleeding, he was spitting out blood. I had him cut under the chin, and I think his ear was bleeding. I don't know whatever held him up. He always came tearing back in, no matter how hard I hit him."

Now, it might be easy to say this was just an old-timer giving an exaggerated account of what happened that day, but there are newspaper reports to back up what he said. Dempsey had slowed down and anyone seeing this sparring session would have known that Tunney had an excellent chance of taking him. Moreover, it had to shake Dempsey's confidence in his ability after such a long layoff.

Dempsey and Loughran remained lifelong friends. When I was a kid, I remember seeing Loughran at Dempsey's restaurant in New York. Loughran became a commodities trader after retiring from boxing. Always a clean liver, he stayed within a few pounds of his fighting weight until he passed away in 1982, at the age of 79.

Tommy Loughran had many incredible fights against some of the best fighters who ever lived, but I think his favorite time in the ring was his go with the great Jack Dempsey.

HOOPS and HOCKEY in the HUB

It is big, bright, and airy, a wonderfully modernistic building that is the perfect complement to a team whose goals is to be the best.

It is the brand new Celtics practice facility that had its grand opening on June 19th, when a couple of hundred guests plus members of the media were invited to step inside and take a peek at the Red Auerbach Center at New Balance World Headquarters.

As if to emphasize a point, everything on this particular day was aimed at a goal that appears to be close but has not yet been achieved — the winning of Banner 18 by the Celtics. Indeed, the scoreboards at each end of the floor featured a tie score of 18-18, while the time remaining was stopped at 18:18.

While Banner 18 may be won in the next year or two, 18:18 will never show up on an NBA scoreboard since each game is divided into four 12-minute quarters. But we digress.

Before we took a tour there was a speaking program with Gov. Charles D. Baker and Mayor Martin J. Walsh topping the list of those that addressed the audience. The program was scheduled for a 10:30 am start, but was delayed because the heads and city and state respectively were somewhat tardy in their joint arrival, not taking their seats until approximately 11:10 am.

It was obvious that Gov. Baker has been a lifelong Celtics fan, from his days growing up in Needham, to his time as a player at Harvard and continuing into adulthood.

Speaking without notes, he cited many of the star players that have graced the parquet over the years, including Hall of Famer and current Celtics broadcaster Tom Heinsohn who was in the audience. He also mentioned legendary Celtics radio play-by-play man Johnny Most as well as the current duo of Cedric Maxwell and Sean Grande that calls the games today.

When the speaking program was over, Gov. Baker decided to try his skill but as fortune would have it his 12-14 foot shot hit the rim and bounced away.

Mayor Walsh, while admitting he did not have as extensive knowledge of basketball as some of those seated before him, extolled the Celtics for their contributions to the city as well as to those involved in the whole Boston Landing development. The Celtics and Bruins practice facilities are now in place on the same street, separated by the New Balance World Headquarters building. Still to come is a world-class track and field complex.

Much has been made about the glassed in nature of the building and the outstanding views to the outside. While all that is true, one must go above the court to a walkway that surrounds it in order to have that experience. The views are

indeed dramatic but not if one are down on the court.

Another aspect that one realizes while being courtside is that this is a dedicated practice facility with not one, but two parquet basketball floors gracing the facility. It is not a venue that will also host high school games, for instance. There's only one small section of bleachers. There may well be clinics or recreational games but no contests that would draw any kind of a sizable audience.

The amenities are indeed comprehensive and spectacular. There is, of course, lots of space dedicated to exercise equipment but there's also a nap room where those in need of few winks can be accommodated. Actually, we thought the video room might also serve that purpose as well. Equipped with a 98-inch screen, the 27 seats are so comfortable we could easily see a few members of the roster dozing off in there as well. That's something Coach Brad Stevens might want to check on from time to time.

One feature that absolutely captivated media members was a so-call float tank — an enclosed chamber that has some 1,100 pounds of salt in it. When everything is set to a person's body temperature and earplugs are in use, sensory deprivation can take place, even more so when the lights are turned off. This experience was not available to those on tour but everyone to a person kept wondering about it.

In addition, there are also three water therapy pools of different dimensions. In the largest, one can "swim in place" for exercise against a current of water.

The locker room area has a significant design. It is circular and built around a large shamrock logo that is in the middle of the gray carpet. And, knowing it is important to look one's best for those TV interviews, there's a barber's chair just a few steps away.

There's also a lounge where players can spend some downtime. In that area there's a billiards table, five television sets, several lounge chairs plus an additional four bar chairs that overlook the court area.

We wish the Celtics offered a meal plan because we'd give serious consideration to signing up. All meals are individually customized by Nick Arcuri, the team's director of nutrition, and are prepared in a full kitchen worthy of the best commercial restaurants. Three meals a day will be available for those that desire them.

There's also a medical examination room, outfitted with some of the latest diagnostic equipment, and spaces for the coaching staff to get together.

They kept the media in mind as well. There's an area for press conferences, a broadcast studio and an expanded space for the media relations staff.

All in all a facility worthy of future NBA champions.
