

Stirpe Nostra

HIND, BOAR AND COW CHIPS



Roman relief (3rd century AD) depicting a sequence of the Labours of Hercules, representing from left to right: the Nemean lion, the Lernaean Hydra, the Erymanthian Boar, the Ceryneian Hind, the Stymphalian birds, the Girdle of Hippolyta, the Augean stables, the Cretan Bull and the Mares of Diomedes

We have covered the circumstances surrounding the birth of Hercules, his early education, physical training, the events which led to the imposition of his famous labors and the first two of those ordeals.

The third labor required Hercules to capture the Ceryneian hind, a golden horned deer with hoofs of brass that roamed the forests of Attica. This beautiful animal had been dedicated to Diana, the goddess of the hunt, and was sacred to her. Consequently, it had to be captured alive and unharmed. Hercules pursued the deer for a full year before running it down. One report states that he caught it in nets while another says that he crept upon it while it slept. Following proof of

capture, the animal was released unharmed.

The fourth labor required of Hercules was to capture the Erymanthian boar, a large beast that ranged over Mount Erymanthus and ravaged the territory all around northwest Arcadia. The animal was tracked into the deep snows of its mountainous territory and brought back alive to the king who became so terrified that he hid from the hero.

The fifth labor of Hercules was a humiliating assignment. He was required to clean the stables of King Augeas in one day. The king owned vast herds of cattle, and the dung from these herds had been deposited so thickly on his land, that it was no longer able to be cultivated. Hercules made a

separate deal with the king, agreeing to clean the stables in return for a payment of one tenth of the cattle.

After the contract was signed, Hercules broke through the walls of the stables and diverted a nearby river, flushing the area with its water. As was suspected, Augeas refused to honor his agreement, claiming that it was the duty of Hercules to perform the work without pay. Threatening revenge, the strong man returned to Tiryns only to find that he was doubly repaid for his cleverness when King Eurystheus, author of these labors, refused to honor this last ordeal on the grounds that it had been undertaken

Large Pool of Plate Classics Up for Grabs

MassDOT Registrar of Motor Vehicles Erin C. Deveney announced that applications for the 2015 Low Number Plate Lottery are now available at the Registry's website and at branch locations throughout the state.

year again for Massachusetts plate aficionados," said Registrar Deveney. "There is a large pool of classic plates, including Z9, up for grabs this year and we encourage everyone to visit our website

In addition to the availability of plate Z9, there are 155 other plates that are part of this year's lottery including: 650, 7X and L91. Annually, approximately 6,000 applications are received.

American Freedom and Equality Continued

The drama of liberty which we celebrated on the Fourth of July continues. Four years after the Declaration of Independence, John Adams, in the Constitution of the Commonwealth of Massachusetts framed this Declaration of the Rights of the Inhabitants:

All men are born free and equal, and have certain natural, essential, and unalienable rights; among which may be reckoned the right of enjoying and defending their lives and liberties; that of acquiring, possessing, and protecting property; in fine, that of seeking and obtaining their safety and happiness.

Those words were invoked three years later by Supreme Judicial Court Chief Justice William Cushing, stating:

[The words of the Constitution] declare that all men are born free and equal; and that every subject is entitled to liberty ... In short slavery is in my judgment as effectively abolished as it can be by the granting of rights and privileges wholly incompatible and repugnant to its existence.

It would take decades, and America's bloodiest war, to bring freedom to all Americans. Lincoln's words in 1863 at Gettysburg mark another scene in the drama.

However, in the political and civic realm, the genius for enlargement of liberties has, in recent decades, severely atrophied. On November 2, 1976, the voters of the Commonwealth foolishly adopted Amendment 106 to the Massachusetts Constitution, which added to the phrase, All people are born free and equal, the following enumeration: Equality under the law shall not be denied or abridged because of sex, race, color, creed or national origin. It's a catalog of protected classes which, far from expanding freedom, suggests that while "all people are born free and equal," the law need only concern itself with persons so far as they are representatives of their sex, race, etc. In sum, it is a denial of individual freedom in favor of group identity.

Under this political theory, which now enjoys support among the elite in our Commonwealth, persons are not equal before the law based on nothing more than shared humanity, but rather as arising out of membership is some particular class. There is no end to the new protected classes that politicians can pander to, to the detriment of the common public good. And no end to the spurious new rights, which are no rights at all but merely political patronage directed at preferred classes who vote for these politicians.

L'Anno Bello: A Year in Italian Folklore

Beware the Dog Days!

Summer brings many pleasures, which is why so many people consider it their favorite season. It means vacations and refreshing dips in the pool, bright sunshine and warm weather, licks of an ice cream cone and golden twilight hours that last long into the night. However, summer also introduces days of great humidity, when the air feels like a thick and damp blanket enveloping the earth, when you sit in front of any fan you can find in hopes of some relief. I actually like humid days, for they remind me that summer is really and truly here and differentiate the season from all others. Nevertheless, too much stifling weather can really wreak havoc! During periods of high humidity, I like to stay in an air-conditioned space and enjoy ice-cold glasses of water or lemonade, basking in summer relaxation. While I, like many others, take the humidity in stride as part of the season, in olden days the hot days of summer were considered downright dangerous. In Italy and other places across Europe and the world, a host of superstitions have attached themselves to the dog days of summer. These fascinating bits of folklore remind us that days spent under a scorching sun have both vexed and intrigued our ancestors for generations.

I was reminded of the dog days this morning when every dog in my neighborhood suddenly got the urge to bark and howl simultaneously. Besides the fact that dogs and other animals feel the summer heat as much as humans do (which is why you should take precautions to keep your pet cool and comfortable during the summer), why the canine association with the hottest days of the year? The term "dog days" derives from the fact that in ancient times, during the summer, the star Sirius rose about the same time as the sun. Since Sirius is the brightest star in the constellation Canis Major, which means "large dog," the Romans represented the star as a canine ter fan can tell you! For the lief that a blast of air to your ancient Egyptians, the rise neck or throat can cause a



sign of relief, since it heralded the flooding of the Nile River and thus the growth of crops and vegetation. The Romans, however, perceived Sirius as a malicious and dangerous star. They believed that its brightness combined with that of the sun, causing the heat to rise in the summer! Many superstitions have since attached themselves to the dog days, or dies caniculares as the Romans caused them. Supposedly, illnesses run rampant and snakes are more likely to bite during the dog days. Thanks to modern science, we know this is not true, but it is easy to see why these days acquired such a nefarious reputation. In modern times, we can turn on the air conditioner or jump in a pool when it is too hot. In ancient times, people had no such luxuries, and indeed spent the summer haying under the hot sun. That must not have been a pleasant experience!

The dog days supposedly last from July 3rd to August 11th. When I visited Italy ten years ago, it was during the height of the dog days, and I received a big culture shock. Here in the United States, I was used to popping inside an air-conditioned store or restaurant when walking outside in the sweltering heat got to be too much. In Italy, air conditioning was practically non-existent. In fact, it was so rare, that whenever a store did have an air conditioner or fan blasting inside, they advertised outside on colorful posters hung from their windows. Perhaps this reluctance to use air conditioning is due to the Italian fear of il colpo - something any Harry Pot- d'aria, or "hit of air": the beof Sirius was viewed as a wide number of maladies. I

also found out that many Italians dislike putting ice in their drinks for fear of indigestion. These cautions, by the way, are not unique to Italy, but prevalent in other European countries as well. Though the lack of air conditioning and ice took some getting used to, I eventually found out that Italians have other great ways of cooling off in the summer. Nearly every time I visited a family member, they had a fresh melone, or melon, waiting on their table. Juicy and refreshing cantaloupes, watermelons, and honeydews form a staple of Italian summer eating, the perfect finale to a muggy day. Italians also enjoy strolling outside in the fresh air during the evening, when the heat of the day has lessened. These walks are called passeggiate, and they provide Italians with the opportunity to chat with family and friends while enjoying a gelato and exploring the city or town. This is a wonderful tradition that America should adopt, especially in the summer, when we could all use some relaxation and time in the

outdoors! I believe that the dog days serve as a wake-up call to relax. The humid, stagnant air and high heat is nature's way of telling us that we can use time to recharge and take it easy. Too often, our busy schedules and hectic modern lives keep us from taking time for ourselves, even in the midst of summer. Whether we set apart a few minutes to enjoy a cool glass of lemonade (with ice, of course!) or take a cue from the Italians and spend summer evenings basking in the fresh air and company of family, these small indulgences will rejuvenate our



Saint Henry

St. Henry was born the son of Henry, Duke of Bavaria, and of Gisella, daughter of Conrad, King of Burgundy, on May 6, 972. He received an excellent education under the care of St. Wolfgang, Bishop of Ratisbon. In 995, St. Henry succeeded his father as Duke of Bavaria and in 1002, upon the death of his cousin Otho III, he was elected emperor. His main focus was on a series of wars against the Polish Duke Boleslaw I, who had already conquered a number of countries. Unlike his predecessor, who had focused upon imperial attention in Italy, Henry spent most of his reign concerned with imperial territory north of the Alps. Henry did, however, lead three expeditions into Italy, twice to suppress secessionist revolts and once to challenge the Byzantine Empire for dominance over southern Italy. On February 14, 1014,

As German king and Holy Roman Emperor, Henry II was a practical man of affairs. He was energetic in consolidating his rule. He crushed rebellions and feuds. On all sides, he had to deal with drawn-out disputes so as to protect his frontiers.

Through donations to the Church and the establishment of new dioceses, Henry strengthened imperial rule across the Empire and increased control over ecclesi-Pope Benedict VIII crowned astical affairs. He stressed

service to the Church and promoted monastic reform. Henry married Cunigunde of Luxembourg, who later became his queen and empress. Henry gave numerous donations to foundations, gave liberally to pious institutions and built the Cathedral of Bamberg. His death occurred at the castle of Grone, near Halberstad, in

For his personal holiness and efforts to support the Church, Pope Blessed Eugene III canonized him in 1146, making Henry II the only German monarch to be a saint. His feast day is July 13th. He is the patron saint of the childless.





Freeway Says ...

Due to his increasing popularity and several suggestions from readers (and after much negotiating on our part with his huge salary demands), our friend Freeway has consented to try to answer readers' questions concerning him or any of our little four-legged friends. You can email your questions to postgazette@aol.com to the attention of Freeway. Don't forget folks, Freeway is not a vet, so please keep the questions light-hearted! Thanks.

Whether you're looking for a pet-sitter to care for your fur-kid during your vacation or on a regular basis, finding the right person can be challenging. Before you start looking, think about the characteristics and skills that are particularly important to you. Here are 10 traits a good pet-sitter should

- 1. Flexibility: Especially when your work schedule is subject to change, it's advantageous to have a pet-sitter who is flexible and can step in on short notice. That way, if you have an important appointment or need to stay late at the office, you can trust your pet will be taken care of.
- 2. Calmness: Any pet parent knows that with animals, things don't always go according to plan. But a petsitter must remain patient when your pet doesn't behave as expected, and stay calm so your pet doesn't feel and react to the anxiety.
- **3. Sensitivity:** A good pet sitter recognizes the needs of your pet and responds to them. The person should realize when your cat does not want to play anymore and give her space. Look for someone who handles your pet affectionately and never uses physical punishment or force, like dragging on your dog's leash during a walk.
- 4. Trustworthy: Since you'll probably be handing your spare keys to your pet sitter, it's very important that you can trust this per-

son. To get an idea of whether a caregiver may be trustworthy, check references from previous employers and run a background check before hiring. Remember, if you get a bad feeling after meeting someone, always trust your gut.

- **5. Experienced:** Especially when your pet is high maintenance or challenging in terms of care, hire a pet sitter who has a lot of experience. If you have a big and dominant German shepherd, your pet sitter should not be new to the pet care field. Instead, find someone who has handled large dogs before, and can provide references or a certificate to show their experience level. Does your pet have a medical condition or need special treatment? Look for a caregiver with a background in this area.
- 6. Consistent: You've probably worked hard to teach your pet the rules of the house. Make sure your sitter knows them, too. If you don't allow your pooch to lie on the sofa or sleep in your bed, your pet sitter should not undo your training by bending the rules. The person you hire must be firm and consistent even if your pet gives him the begging puppy-dog-eyes!
- 7. Reliable: Your pet sitter is there to make your everyday life easier not to cause you additional headache wondering if they'll be late or show up at all. It's important that you can rely on your caregiver and schedule your

plans confidently. Set clear agreements between you and your pet sitter about rules and scheduling. If the sitter is running late (as happens to everyone occasionally), what is the protocol for letting you know?

- 8. Insured: Having a license and insurance shows that this person is professional and serious about his/her business. Insurance protects you and the sitter should something unexpected happen to your pets. It's also a good sign if the pet sitter is willing to set up a contract between the two of you, defining services, pay rate, rules, etc.
- 9. Genuine Love for Animals: Ask interesting questions during your interview to get a feel for the candidate's personality (for example: "What's the funniest or most embarrassing thing you've experienced with an animal?"). A good pet sitter will show a genuine love for pets in their answers to your questions. Ask about pets they've owned or cared for in the past. A person who loves animals will be eager to tell you stories of their own pets. Through these types of discussions you can gauge their love for animals and their level of excitement about this job opportunity.

Also, is the pet sitter taking notes? Does the person ask questions about pet's eating habits, characteristics and dispositions? These are good signs that the





Joseph Barisano became Ray Barron.

Parla Come Mangi! (Speak as You Eat!)

Benvenuti! Our next region is located directly across from Campania on the Adriatic Coast and also borders the Ionian Sea and the Gulf of Taranto to the south. Over 2,500 years ago was part of the Magna Graecia. Today it is considered Italy's "breadbasket" and largest olive oil producer. It's known for its mussel and oyster farms; for wines such as Locorotondo, Primitivo di Manduria and Salice Salentino; for its regional symbol Castel del Monte — the remarkable, well-preserved octagonal fortress built in year 1200 — and for its unique and characteristic white dry stone huts with a conical roof known as trulli. Geographically considered the "heel" of the boot because of its elongated shape and position within the Italian territory, it is the easternmost region in Italy. Its capital city is Bari; other cities are Foggia, Barletta, Taranto, Brindisi and Lecce. It is, indeed, Puglia. Taralli, crostini, friselle, pane di Altamura, and focaccia are among the bread specialties of the region that grows both durum and soft wheat. Puglia is mostly known for its durum wheat crop since it thrives in its dry, hot climate and needs the right balance between mineral content of the soil and moisture in order to become the outstanding grano duro di Puglia that delivers the typical crunchy bread crust and, when milled and transformed into semolino (semolina), is used as the basic ingredient for pasta. Taralli, crispy bread rings, are a delicious snack and a popular aperitif in southern Italy and come in many different varieties — boiled or baked, with fennel seeds, pepper or olive oil. This very traditional recipe features flour, lard, olive oil, yeast and fennel

Taralli

4 cups flour 1 tsp salt and some freshly ground pepper ½ cup lard (substitute with 2/ 3 cup Extra Virgin Olive Oil)

1 packet (1/4 oz) of active dry yeast 1 or 2 tsp fennel seeds Warm water (as much as needed) Olive oil

Preparation: on a work surface combine the flour with a little salt and pepper, then knead together with the lard (or Extra Virgin Olive Oil), fennel seeds and add sufficient water to produce a smooth, elastic dough. Cut off small pieces of dough and shape into rings. Place them on a greased baking sheet (or on a baking sheet lined with parchment paper) drizzle the surface with some olive oil and leave to rest for about one hour. Then bake in a preheated 300°F oven for one hour. Buon appetito!

Taralli

500 g di farina 1 cucchiaino di sale e pepe nero q.b.

125 g di lardo (sosotituisci con 150 ml di olio extra vergine di oliva)

1 bustina da 7 g di lievito di birra in polvere 1 o 2 cucchiaini di semi di finocchio Acqua tiepida q.b. Olio d'oliva q.b.

Preparazione: su una superficie da lavoro combina la farina con sale e pepe q.b. e lavora il tutto impastando con il lardo (oppure con l'olio extraverine di oliva) ed i semi di finocchio aggiungendo abbastanza acqua in modo da formare una pasta liscia ed elastica. Taglia dei piccoli pezzi di pasta e lavorali a formare la caratterisica forma a cerchio dei taralli. Adagiali su una teglia da forno unta (o rivestita da carta forno) e cospargine la superficie con un filo d'olio. Fai riposare per circa 1 ora. Inforna in forno caldo a 150°C per un ora. Buon appetito!

10. Connection to your Pet: You wouldn't hire a babysitter without having her meet your kids first it should be the same with your pet! Set up a meet-and-greet (this can be part of your interview or separate) with the candidate and your pet. It's okay if

you're pet doesn't warm up to the new person immediately, but watch for signs that your pet is very uncomfortable or that the person is handling the pet incorrectly. Nanna & Babbononno

A Nostalgic Remembrance



The 4th of July has always been very important for my Italian family. It was a chance to prove you had become an American. As a matter of fact, I never saw an Italian flag in Nanna and Babbononno's house, only a small American flag aside of Nanna's black metal Statue of Liberty.

July 4th was a day to celebrate and a time for the family to come together, so Babbononno would speak to his brother-in-law, Nanna's oldest brother and my grandfather's best friend, Zi' Antonio Ceruolo. They would plan for a family outing that might include three generations of the extended family.

Knowing where they liked to go, Dad would book a barbecue pit at the picnic area on Mystic Lake. From that point on, family members would be asked if they were interested in a 4^{th} of July get together. Usually, from the first generation, Nanna and Babbononno would be counted in, as well as Zi' Antonio and his wife, Zi' Mariuccia. From the second and third generations we had Dad, Mom, me, Uncle Paul, his wife Aunt Eleanor, and their daughters, Paula and Ellie. On my mother's side, on one occasion, Uncle Gino and Aunt Ninna came along, even though Aunt Ninna was almost ready to deliver twins. From Zi' Antonio's side would be my mother's cousins, Louise Pepe and Marie Beatrice, accompanied by their husbands, Ralph and Al, respectively. Louise's kids were always with them at family get togethers and they were my closest cousins even though they were second cousins. The list included Lulu, Anthony and Ralph, Jr. The Beatrice kids would accompany their parents, Elizabeth and Allen. One year, the list included Dad's sister, my Aunt Mary, accompanied by her husband Jim Dello Russo and their son, Jim, Jr. If Dad could talk him into joining us, Grandpa Christoforo would tag along.

Seeing the celebration was for the 4th, the preparations would begin the week before. All the ladies would begin to prepare the food. The slight difference between a typical American 4th and our 4th would be what we ate. An American 4th might include hotdogs and hamburgers, accompanied by potato salad, corn on the cob, maybe baked beans and watermelon. The main beverage would be beer, and soda for the kids, and that's it.

This was an American holiday, but we were Italian. Nanna, Zi' Mariuccia and the rest of the ladies would distribute the menu that would include the things that were going to be brought but prepared in advance: gravy, gravy meat, meatballs, lasagna, sausages, onions and peppers, stuffed peppers, stuffed artichokes, stuffed mushrooms and whatever else might be found on a Sunday dinner table. Dad and the men would have sausages made up by a local butcher, and when they were ready would include in the order steaks, lamb chops, spare ribs, and of course, hotdogs and hamburgers which only the kids might eat. The bread would be Italian. The only compromise here might be that the loaves would be sliced in advance. Where the Americans might have a jar of pickles, Dad would bring a jar of hot peppers. In case someone wanted sandwiches, a variety of Italian cold cuts and cheeses would be available, or they could be the main part of an antipasto. For dessert, the Americans might bring apple pies. My family brought cannoli and an assortment of other pastries and cookies from Quality Bakery, then located in Day Square in East Boston, or Mike's Pastry in the North End or Royal in Cambridge.

The liquid refreshments included gallons of Zi' Antonio's best homemade red, and maybe a gallon or two of Grandpa Christoforo's summer white wine. A few bottles of hard liquor were available for those who liked highballs. Al Beatrice liked beer and would have a case or two of his favorite. For after dinner, oops, the cookout, a bottle or two of homemade anisette might show up. Several bottles of soda for the kids were always bought. Saraford soda was 15 cents (28 oz). We now had the fixin's for an Italian outing.

Even though Dad had reserved a barbecue pit, he would bring along his Coleman gas stove and a portable barbecue contraption because pre-cooked food had to be heated and the barbecue pit that was reserved was never large enough for all that had to be done. Dad would include several Cuban cigars for after dinner and the first generation would

bring their stogies, and with this, we were ready for a 4th of July cookout.

For entertainment and exercise, we kids brought bats, balls and gloves. The older men brought a set of bocce balls and a couple of decks of cards.

Early on the morning of the 4th, Dad and Babbononno would pack Dad's old Plymouth with everything we were bringing and, with Nanna and Babbononno in the back seat and Mom and me in front, it was off to the Mystic Lake picnic area. Of course, all the kids would have their bathing suits under their outer clothing because the lake had a public beach. We had a problem though. We could swim before eating, but we were prevented from swimming after eating for at least an hour. Our mothers and grandmothers would tell us that if an hour hadn't passed, we could get cramps and drown. It was an old wives' tale, but we kids believed it and waited out the hour by playing tag or hide-and-go-seek.

Someone in the family always prayed to St. Anthony for good weather the night before, and the prayers always seemed to work as we were blessed with cloudless skies year after year. By 10:00 am, everyone who was coming was there and the cooking and eating would begin. If someone had a glass of wine too many, there would be blankets to lie down on. This usually didn't happen as no one really wanted to miss out on anything. By noon, the steaks, chops and sausages were on the grill and the serious eating would begin, not just the picking that preceeded the noon time

By the time the afternoon rolled around, Mom would put a couple of pots of coffee on Dad's Coleman stove, and when they were ready, the pastries would come out and be placed on the picnic table covered with wax paper to keep the flies away. To reset the table, the ladies would interrupt card games, Whist being played by the American born, Briscola, Sette Belle and Scopa being played by the old-timers. We kids just kept asking about the time so we could head back into the lake and splash around again.

This was the essence of a genuine American holiday celebration done Italianstyle, and if there was a problem with anyone, someone would have a bottle of Brioschi to sooth the stomach. They are all gone now, including some from my generation, but they were great days and it was great fun. Last weekend when we celebrated the 4th with friends, Loretta drove home and I remembered everything I added in this week's column.

The New England Patriots organization will induct Willie McGinest (1994-2005) and Houston Antwine (1961-1971) into the team's Hall of Fame on August 5, 2015. The event will begin at 5:00 pm and is free and open to the public.

McGinest and Antwine will join past inductees (Induction years in parenthesis) John Hannah (1991), Nick Buoniconti (1992), Gino Cappelletti (1992), Steve Nelson (1993), Vito "Babe" Parilli (1993), Jim Lee Hunt (1993), Bob Dee (1993), Mike Haynes (1994), Steve Grogan (1995), Andre Tippett (1999), Bruce Armstrong (2001), Stanley Morgan (2007), Ben Coates (2008), Jim Nance (2009), William H. "Billy"

Sullivan, Jr. (2009), Sam Cunningham (2010), Jon Morris (2011), Drew Bledsoe (2011), Troy Brown (2012), Tedy Bruschi (2013), Gil Santos (2013), and Ty Law (2014).

Houston Antwine was a star defender in the American Football League (AFL) being named an All-Star six straight years, from 1963 through 1968, honors which secured his place on the AFL's All-Time team.

Willie McGinest was a fan favorite most notably remembered for coming up with big plays at the most crucial times. His 16 career postseason sacks are an NFL record and he also owns the




