Betty Ford Dies at 93

After Lifetime Promoting Treatment of Substance and Alcohol Abuse



Less than five years after the death of Gerald Ford, his wife and former first lady Betty Ford passed away at the age of 93.

Two separate ceremonies were held to remember her. The first ceremony on Tuesday was held in California, where Ford lived, and eulogies were read by former first lady Rosalynn Carter and journalist Cokie Roberts. Both speakers had been chosen by Ford several years ago.

The speakers focused on Ford's twin passions: politics

and her world famous Betty Ford Center for substance abuse and alcohol treatment. Roberts, a commentator on National Public Radio, said Ford asked her to give a eulogy five years ago and specified it should be about the power of friendship to mend political differences even in these hyper-partisan times.

Ford had asked Roberts to recall the times when her father, Democratic Congressman Hale Boggs, was House majority leader and Republican Gerald R. Ford was House minority leader. They could argue about issues but get together as friends afterward. The two families became close as did the Ford and Carter families, despite Jimmy Carter defeating Ford in the 1976 presidential election. Former president Carter spoke at Ford's funeral in 2007.

Archdiocese to Morph Existing Parishes into Mega-parishes?

Reports have it that for over the last two years, officials from the Archdiocese of Boston have been meeting on a regular basis to strategize plans to decrease the existing 291 parishes down to about 150-160 larger parishes. The North End model appears to be the future of the Archdiocese's plan for mega-parishes. The North End once had four parishes and is now down to one, St. Leonard's Parish with four different worship sites. Eventually, I do see this happening across the Boston Archdiocese and the nation. East Boston has a number of Catholic parishes, perhaps too many for the low number of priests available to staff these churches.

Cardinal Sean O'Malley remains reportedly against having circuit pastors assigned to several parishes at once. It would appear from details coming out that mega-churches are the future parish life for Boston Catholics.

By all appearances, the Archdiocese of Boston has learned from the mistakes of reconfiguration back in 2004. That process led to upheaval and church takeovers by concerned Catholics angered and frustrated with the way the chancery handled matters seven years ago.

Stirpe Nostra

THE PATHETIC GALBA

Following his tour of duty as a governor in Africa, Galba returned to Rome and lived in partial retirement until midway in the reign of Nero. It was said that he was so concerned about being required to leave the country on short notice that he never went away from his villa for any reason without taking about \$50,000 dollars in gold with him in a second carriage. This precaution apparently served him well because one day while visiting in Spain, he accepted the governorship of a province in that country and was required to assume his duties immediately.

During his initial years as a governor in Spain, he maintained his energetic and disciplined characteristics, even to the point of being oversevere. He ordered a moneylender's hands cut off and nailed to the counter of his shop because he was dishonest in business. A man who poisoned a ward and benefactor was ordered to be crucified. When the man claimed immunity from punishment on account of his Roman citizenship, Galba ordered a taller cross, had it painted white, and continued with the crucifixion.

It soon became quite obvious to Galba that any government official who became notorious because

of some high degree of proficiency or talent was sure to attract the attention of Nero, and any jealousy on the part of the emperor would certainly bring an end to the career and possibly the life of that official. Because of this fear, his activities gradually took on a low profile, but the damage had already been done and Galba soon discovered that Nero had secretly ordered his execution. These events happened just about the time that the people were rising up against Nero and before long the emperor was reported to have died.

The assembled multitudes soon saluted Galba as emperor and he accepted, declaring that he was acting as a lieutenant of the Senate and of the people of Rome in order to put an end to the disgraceful tyranny of Nero.

He investigated those who had enriched themselves through association with Nero, but most of them had already squandered their illgotten wealth. Restitution by confiscations once again became the order of the day.

He condemned to death many distinguished men on minor suspicions and without the benefit of a trial. He even revoked any grants that Nero had given and made a bungling attempt to tighten the reigns of the economy. This action caused him to be hated by people of every class, but especially so by the soldiers and the Praetorian Guard. His refusal to give the gifts, as promised, embittered the soldiers throughout the empire.

An uprising soon followed in Rome, but a false report indicated that the trouble was over, the rebels had been killed and the faithful were coming as a group to offer their continued support. This news induced Galba to appear in public where he was quickly abandoned by his followers, then attacked and butchered by the forces of Salvius Otho.

As a Roman emperor and a Caesar, his reign probably ranked with the most pathetic of his 104 counterparts. In person, he was of average height, bald, with a hooked nose. His hands and feet were crippled by rheumatism or gout, he could not wear shoes or hold a scroll and his skin hung from his bones like a sack. He was a heavy eater and lavish in his tastes, often heaping up the remains of his dinner and leaving them for his attendants. Like some of the other Ceasars, he had his share of unnatural sex and in this activity preferred the macho type. He died at the age of 73 and in the seventh month of his reign.

Boston and New England Companies Named to Made in the USA Hall of Fame

The Made in the USA Foundation has announced 22 companies that have earned a place in the **Made in the USA Hall of Fame**. The Foundation held an awards dinner Saturday, July $2^{\rm nd}$ in Santa Monica, California. Among the companies honored were two Boston companies:

Boston Beer Company — Brewmeister Jim Koch comes from a long line of brewers. In the mid-1980s, Jim got his great-great-grandfather's recipe from his father's attic. After only six weeks on the market it won the award for "The Best Beer in America" in the Consumer Preference Poll at the Great American Beer Festival.

New Balance – In 1938, New Balance created its first pair of athletic shoes. Today, New Balance is the largest shoe manufacturer in the United States, making 7 million pairs of athletic shoes a year in six factories in Maine and Massachusetts.

In addition, four other New England companies made it to the Hall of Fame:

Bevin Brothers of Easthampton, Connecticut — The Bevin family has been crafting quality bells for 176 years. Bevin Brothers is the only remaining company manufacturing bells in the United States.

Colt — The Colt 1911, official firearm of the U.S. Army from World War I until the Vietnam era, remains in production, virtually unchanged for 100 years. Colt is based in Connecticut.

Ethan Allen — In 1936, Ethan Allen manufactured its first Early American style furniture in New England. Today, Ethan Allen is the largest U.S. furniture manufacturer in many styles.

Peterboro Basket — The Peterboro Basket Company has thrived in the heart of historic Peterborough, New Hampshire making high-quality baskets since 1854.

Other Made in the USA Hall of Fame companies are: 3M makers of Scotch brand tapes, Annin Flagmakers, Bed Head Pajamas, Chateau Montelena winery, Dilettante Chocolate, Fender Musical Instruments Corporation, H.F. Coors brewery, Harley-Davidson motorcycles, Hart Schaffner & Marx suit-makers, Jack Daniel's Distillery, K'NEX maker of plastic construction toy sets, Milliken & Company textile manufacturer, Nordic Ware kitchenware products, SpaceX rocket-maker, Vitamix maker of high-quality blenders, and Whirlpool Corporation maker of home appliances.

Niobe Regina di Tebe

"Niobe Queen of Tebe" was the centerpiece of the recent Boston Early Music Festival 2011. The play was composed by Agostino Steffani, an Italian composer who lived between the 17^{th} and 18^{th} centuries. His play risked being lost in time, as nobody acted it for many years. The BEMF has the merit of keeping alive such masterpieces due to a meticulous research of sight and sound, inviting modern audiences to rediscover classics from Steffani's period. The result was a full staged Majestic theatre.

The Niobe's character originates from Ancient Greek mythology and Ovidio spoke about the queen in his "Metamorphosis" as well. She ruled over the city of Thebe with her husband Anfione, and she had many children, but committed the sin of pride. For this reason, she triggered the wrath of the gods, who killed all her children. Anfione took his own life in despair and Niobe turned to stone due to her own torment

Agostino Steffani was born in Castelfranco Veneto, and spent abroad most of his life. He was not only a composer, but also an ecclesiastic and a diplomat. He was inspired from the ancient myth when he composed "Niobe Queen of Tebe," which was first performed at the Munich court theatre during the carnival season of 1688. This baroque opera masterpiece has been recovered by BEMF with meticulous attention. Sumptuous costumes, impressive choreographies, rich set designs and many "deus ex machina" effects gave the spectacle a unique baroque atmosphere. Moreover the talent of soprano **Amanda Forsythe** in the title role, and of the countertenor, **Philippe Jaroussky** as King Anfione, carried away a public whose response was a long standing ovation at the end of the performance.

New Food Trucks Set to Serve Up Tasty Treats on Boston's Streets

Healthy Food Initiative Brings Trucks to 15 New Locations

Mayor Thomas M. Menino today announced that food trucks are ready to serve "wicked good food" on Boston's streets tomorrow with 15 new permanent locations in several neighborhoods. The new locations have been approved by the City and the food trucks will rotate between the sites starting July 13. Boston's Food Truck program, unlike in other cities, has designated permanent spots on city streets where food truck vendors can apply to operate. The food trucks will serve a variety of breakfast, lunch and dinner foods from 6:00 AM - 11:00 PM (with a 9:00 PM closing time in some neighborhoods). These new locations are in addition to

the food trucks that already operate on City Hall Plaza and on the Rose Kennedy Greenway.

"I'm excited that we have been able to designate permanent spots on city streets for new food truck vendors," Mayor Menino said. "Food trucks are a fun, fresh way for people to enjoy a variety of food, much of it healthy and locally produced."

The food trucks will be located in the Back Bay, Bay Village, South End, Fenway, Kenmore Square, Boston University, Dorchester, Boston Marine Industrial Park/South Boston Waterfront, and the Charlestown Navy Yard. For a map of the public location go to: www.cityof boston.gov/business/mobile/



CORPORATE PROFITS SEEM STRONG

Analysts are projecting a 14% growth rate led by energy and materials. Over the past six quarters 70% of companies have beaten their estimates. Expectations have been low. Investors have had to grapple with disruption for the tsunami in Japan, a default in Greece, unemployment higher and consumer spending lower. In April and May with the outlook lows, we are vulnerable to an upside surprise in Quarter III. Stocks are selling at 12.6 times P/E average as a normal 15 times and Greece will avoid a nearterm default and earnings will be better. M&A activity helped the market this week. Immuco bolted 30% on news it will be bought by Varcro for \$772 million in cash. The Federal Reserve laid out guidance for banks that have derivative units. Derivatives are used to hedge risks and speculate for profit. Critics say derivatives contributed to the 2008 financial crisis. Energy transfer offered \$85 cash deal for William. Shares of Southern closed at \$42.72/ share suggesting that a higher bid is coming. National Oil Well offered \$85 cash deal and the stock rose 38% to \$85/share.

A group of bondholders will try to opt out of Bank of America's \$8.5 billion settlement agreement. The bank reached a deal with 22 investors to excuse it from the deal by 530 Trust require more disclosures. Bank of America fell .9% to \$11/share on the

ImmunoGen Inc., jumped as the maker of anti-cancer drugs was rated a buy at Jefferies, which said that its TDMs drug could be a standard for breast cancer. DMI is replacing Riches Horecption. Jefferies said that DMI is safer and that a combination of Herptin and a cell billing agent discovered by ImmunoGen was up 2 points in active trades. The U.S. jobs figure didn't help. Netflix has expanded its foot print to include Canada, South America and the Caribbean. The expansion will include 46 countries. It will be available in Spanish, Portuguese and English and will have the fastest growth through 2015 of any company as the rights to films and TV shows are covered up on a country by country basis.

Capital One Financial Corp., seeks to expand in Massachusetts in Boston and Brookline. It has branches in eight other states and is the largest bank and credit card issuer in the U.S. They plan on getting \$600 million in deposits. Capital One last month bought ING's \$9 billion deal to come into New England which has 7 million customers.

Moody's drops rating on Portugal to junk DWA2 to Baaz. The Portuguese government has raised taxes as the economy is expected to contract 2% this year and next. It joins Greece in market credit worries risks.



Burning Topic — New FDA Rules on Labeling Sunscreen

Ciao Bella,

Well. halfway we're through summer and all us sun-worship queens are grateful to the Food and Drug Administration. Last month they released longawaited sunscreen regulations with new labeling indicating reliable info on product protection — ironic how the sun in so many ways can be so healthy and yet so deadly.

The FDA wants to inform and educate the consumer that they are protected against both ultraviolet-B (UVB) and ultraviolet-A (UVA) rays. The labeling now on shelves gives the sun-protection factor on its labels indicating only the level of protection of UVB rays, which mostly causes sunburn. Both UVB and UVA rays are known to cause wrinkles and skin cancer.

The new rules will be out in a year. A sunscreen labeled "broad spectrum" will be required to protect against both sets of rays. And the SPF (Sun Protection Factor) will be the "number" to the degree of protection against the UVB and UVA rays. For those sunscreens that don't offer enough protection, a warning label will be required to carry a mandatory statement that the product hasn't been shown to protect against skin cancer! These rules are a long time coming!

Many sunscreen products on the market bear a label "broad spectrum" that only

protects against UVA rays. Broad Spectrum will have to mean protection from both kinds of rays.

The new FDA ruling is also requiring companies to eliminate terms like "waterproof" and "sweat-proof." In the future these products will need to pass a test for water resistance in order to keep a water claim on label. The FDA in a separate proposal is considering to make SPF 50 the max value since there is not enough data for higher SPF products. They will also be looking into "sunscreen sprays" whether or not it offers as much SPF protection since consumers themselves so lightly.

So sun loungers pay attention to your labels and stay protected from old man sun! Buona giornata and God bless the United States of America!

...... A new exhibit, "Distant Climes: 18th-Century British Views of Italy," is scheduled to open at the RISD Museum on September 1, running through June 3, 2012.

In the mid-1700s, British artists began to travel to Italy, drawing inspiration from its ancient sites and idyllic countryside. This new exhibition assembles Italian views by some of these early travelers, including Richard Wilson, Richard Cooper II, and John Warwick Smith.

Watercolor, a relatively new medium for landscape painting at the time, became essential to these artists recording their impressions of Italy for themselves and for collectors back home. Most adopted the idealizing and "classicizing" concept of nature that had been promoted by the previous generation of landscape and perspective painters working in Italy, including Claude

Lorrain and Antonio Canaletto.

Their works also demonstrate an interest in form, composition, and atmosphere, rather than the naturalistic color and layered washes more indicative of watercolors after 1800.

The Museum of Art Rhode Island School of Design, also known as the RISD Museum, was established in 1874. Its permanent collection of more than 86,000 objects includes paintings, sculpture, decorative arts, costume, furniture, and other works of art from every part of the world, including objects from ancient Egypt, Greece, and Rome, and art of all periods from Asia, Europe, and the Americas, up to the latest in contemporary art.

The Museum also offers a wide array of educational and public programs to more than 100,000 visitors annually.

DOES THE PRESIDENT OF THE UNITED STATES HAVE THE **AUTHORITY TO DECLARE WAR?**

Article I Section B of the United States Constitution says: "CONGRESS SHALL HAVE THE POWER ... TO DECLARE WAR."

Article II Section 2 says: "The President shall be Commander in Chief of the Army and Navy and of the Militia of the several states. The President's authority specified in the Constitution are to make treaties, appoint ambassadors, appoint judges and fill vacancies in the Senate with consent of the Senate."

Nowhere in the list of the President's authority is a word mentioned about the authority to make war.

The future for our area appears to be 150 or so larger parishes staffed by as many as 80 pastors. As a Catholic from East Boston, I could see there being only two to three parishes serving the entire community. The North End has one main church and three other worship sites. I see the status quo remaining so for the future. East Boston has numerous church buildings some of which are either in disrepair or underused. I could see some of the neighborhood church buildings getting secularized for non-religious use while others would stay open as a worship site.

Across the Archdiocese this process will be put into action whenever Cardinal O'Malley begins this rumored process of shrinking property for financial reasons.

My old parish, St. Philip's in Lower Roxbury was suppressed back in the '70s when it was merged into the nearby St. Francis de Sales Parish. The building was eventually sold to the city and used as a warehouse until a fire in 1981 destroyed the building. Many see that process picking up steam again as the Catholic population of legacy Catholics continues to needing to become mega churches.

existing nine or so parishes still in vigil since the reconfiguration began in 2004 is anyone's guess. Some could re-open as worship sites for these new proposed mega parishes and others might be relegated to profane use and sold off to the highest bidder.

The bottom line for the Archdiocese is to have a church structure in place to meet the future needs of Catholics in the Archdiocese of Boston. There will never be complete agreement that this new process is workable or fair to the Catholic laity that actually still go to church. Will this new structure reform bring Catholics back to church or continue to chase them away is still up for heated debate. However, what is clear is that the Church is moving to address dwindling numbers of Catholics still going to Mass and the shrinking number of priests available to serve them.

Recipes from the Homeland

QUICK VEAL OR CHICKEN SPECIAL

- 1 pound cubed Veal stew meat or chicken breast
- 1 large ripe tomato
- 1 medium chopped onion
- 2 cloves chopped garlic 2 small sprigs Bay Leaf

(optional)

- 1 fresh Mint leaf (optional) 1 or 2 *julienne potatoes
- 3/4 cup frozen or canned green peas

(optional)

2 tablespoons red wine

1 or 2 *julienne carrots

- 1 Chicken bouillon cube
- 3 tablespoon olive oil
- 1 can sliced mushrooms or mushrooms of choice

Heat oil in skillet and add cut up veal or chicken breast. Stir and simmer to brown lightly. Remove only meat from skillet and set aside. Add cut up onion and garlic to oil in skillet and simmer until onion is opaque. Add cut up tomato. Stir and simmer over medium heat. Cover and continue to simmer for two or three minutes before adding one cup of water and a chicken bouillon to skillet. Stir, cover and continue to simmer mixture slowly for another two minutes. Then add veal or chicken breast to tomato mixture and bring to a slow boil. Add bay leaf and mint (optional) to skillet and stir. Continue to simmer at low heat for ten

Meanwhile, remove skin from carrots and potatoes and *cut into thin long strips (julienne). Set aside in water in separate bowls.

When meat has cooked about ten minutes in skillet, add carrots first. Cover and cook for about five minutes. Then add potato and mushroom slices. Stir and cover. Continue to simmer until potatoes and carrots are tender to your liking. Add wine, cover and bring to a slow boil and then remove from burner.

Serves two.

NOTE: It was meals like this that I remember Mama surprising us with at various times. I often wondered - Now where did she find this recipe? She loved creating meals that might be different. It was a great lesson for me that encouraged me to create meals with meats and vegetables that my family enjoyed.



Nation - 2 Trucks: "Minnie" and "Cheese Force One," Kick*ss Cupcakes, The Froyo Truck, Clover Fast Food, Bon Me and Pennypackers.

Additionally, there will be a searchable, user-friendly application available on www.cityofboston.gov/ foodtrucks and www.bostonfood.org starting next week that will tell the public which trucks are at which locations/schedule.

As part of the Mayor's Healthy Food Initiative, food trucks applying to participate in the program must include at least one healthy menu option that does not include fried foods, transfats, or high fructose corn syrup. The healthy menu option also has to include at least three of the following: fruits, vegetables, whole grains, low-fat dairy, reduced fat or lean meats that are grilled, broiled or baked. Additionally, participating trucks were asked to provide a statement on their commitment to environmental sustainability and community engagement, and to consider joining the Mayor's "Rethink Your Drink" Campaign.

Boston's Food Truck program is the result of a collaborative effort between the Mayor's Office, the Boston Transportation Department, the Boston Redevelopment Authority, the Public Works Department, and the Parks and Recreation Department. The program is the result of a City Council ordinance that was passed on April 6.



Pope Benedict XVI recently made known his view in a speech that pre-dated "The World Day of the Sick". He was quite adamant by saying, inter alias, that it is imperative to invest more energies "into health facilities that are helpful, and supportive, to the sufferers, above all the very poor and the needy". He further added that "a society that is unable to accept those who suffer - with obvious reference to the encyclical SPE SALVI- is a cruel and inhuman society." If every man is our brother, particularly the weak one, those who suffer and the ones who need care, ought to be paramount in our attention, so that none of them feels forgotten or neglected. He also stated that "the measure of the human care is essentially determined in relation to the suffering, and to the one who suffers, no matter what we think, be the single individual or the society. He then expressed the hope that the authorities make sure that major investments be focused on the health facilities that mostly care for the very poor, sick and needy.

His speech was delivered while the argument over euthanasia was raging; it (euthanasia) was a topic of a debate on television, in a spot presented by the radicals. These are trying any kind of stratagem in favor of legalization of euthanasia, as presented on the Bishops' daily by Assuntina Morresi, an associate professor of physical Chemistry at the University of Perugia, and also as a member of the National Committee on Bioethics.

"They were friends and that was what made government possible," said Roberts, adding that the topic seems particularly appropriate this week when the two parties are divided over dealing with the national debt ceiling.

First Lady Michelle Obama and three former first ladies Nancy Reagan, Secretary of State Hillary Rodham Clinton, Rosalynn Carter, former President Bill Clinton, former President George W. Bush were among the dignitaries present at the funeral.

A second funeral was held Thursday in Grand Rapids, Michigan, where Gerald Ford is buried at his presidential museum. Speakers at the event discussed politics, the White House and Ford's impact on substance and alcohol abuse treatment.

Ford's funeral was similar to the final tributes for her husband. The ceremony was held at St. Margaret's Episcopal Church in Palm Desert, a private but televised event. Following the funeral, members of the public were invited to file past her casket and sign a guest book until midnight.

Ford's body was interred on Thursday at the presidential museum along with her husband on the day that would have been Gerald Ford's 98^{th} birthday.
