# 118 Years of Continuous Publication

One hundred and eighteen the GAZZETTA had to under- ation changed as they years ago, an Italian immigrant who arrived in Boston when he was only 16 years old saw the realization of his fondest dreams, to establish an Italian language newspaper that would be the genuine voice of the increasing flow of Italians to the United States. The boy was James V. Donnaruma, the newspaper was LA GAZZETTA DEL MASSACHUSETTS which is now published in English as the POST-GAZETTE.

He remained at the helm of this well-known publication until his demise in 1953 at which time his son, Caesar, took over the reins of running the now famous national weekly newspaper located in the North End of Boston. Caesar was loyally assisted by an ingenious wife, Phyllis, who assumed the role of publisher in 1971, as one the nations first Italo-American women publishers. Upon Phyllis' death in October 1990, their daughter, Pamela, continued the tradition as the third generation publisher of the POST-GAZETTE.

The GAZZETTA, as it was properly called, was very short in financial means but had a large vision, to give its readers a better and wider understanding between two countries. The so-called Italian Colony, or "La Colonia," had to face a complexity of problems and

stand the slow and hard transition of men who, in most cases, had been engaged in agriculture in the home country. Here, they were to work in construction, factories and restaurants, eventually emerging as small storekeepers and finally the professionals, heads of business enterprises and eventually to become industrial leaders, heads of state, people to be respected by others.

If America was to some a bitter disappointment, to more it remained a great adventure and excitement. There were new ways to be learned as well as new institutions. There were speculators and exploiters to be fought, a "padrone" system needed to be destroyed. There were churches to be built and above all, immigrants took advantage of America's free education while learning the process of citizenship. We devoted pages and pages to that very mission!

The GAZZETTA became, in a way, a sort of guide, so to speak, the go-between that brought American political life to the Italian immigrant. Many times our people were sent unknowingly to work in places subject to a strike and were therefore exposed to physical violence on the part of strikers ... in time, the situlearned more about the new land of opportunity.

The Italian immigrant was a hard worker, a thrifty man, a family man. He had pride. As a family their goal was to build a future in America. The GAZZETTA stressed these virtues. We began to publish an all-English section which became a real forum, discussing many problems, criticizing discriminating laws while advocating Americanization and responding to community needs such as the Red Cross appeals.

A typical Horatio Alger story could be repeated by thousands of immigrants and their American-born children who became an integral part of this great country, fighting in its wars and facing every national crisis. It would be impossible, space wise, to enumerate the many initiatives taken by our publication from its inception as "LA GAZZETTA" to its presentday format as the "POST-GAZETTE" in its 118 years of uninterrupted publication. We never missed an issue, even when the going was very hard.

The moral reward, over the years of hard work, came in many ways when American presidents, senators,

C.E.O. nineteen was Rutherford B. Hayes Attended Harvard College in his earlier days; Then to Ohio to practice the law, Business was so bad he wondered what for. In the great Civil War, held a General's commission, Then into politics with the Army's permission Became a staunch Republican, wasn't easy in those days, Then awarded the Presidency through some questionable ways.

He took the oath of office in a private hall, Canceled the parade and even the ball: He bravely faced his political nagging, Even did what he could to stop carpet bagging. The wisdom of his policy was by word of mouth, To end all the violence and bring peace to the South; Then to a hot issue, a political bomb, Just how to cope with civil service reform.

Workers now slipped into emotional depression, Which was brought about because of economic recession; Financiers and bankers did not worry or fret, As long as payments were made against the public debt.

In some respects he was quite a charmer, He showed little concern for the poor country farmer; With the railroad strike on and states bursting their bubble, He sent Federal troops to the scenes of the trouble.

After four difficult years, his position was firm, He declared that a President should serve only one term; At the time he left office his work was assessed, And they say that the public was favorably impressed.

Lucy Ware Webb became Rutherford's mate, Like her husband she was also from the Buckeye State; A sweet-tempered girl just loaded with knowledge, She dated Hayes while attending Wesleyan College.

With respect to competition, there just was no other, She had already been chosen by Rutherford's mother; Became the first First Lady with college degrees, Gave birth to eight children but had only two knees.

With strong temperance convictions she banned liquor and wine, Nicknamed "Lemonade Lucy" and to her that was fine; For lasting contributions her was one of the best, She started the annual Easter egg rolling contest.

#### The Failure of Detroit and Why It Won't Happen Here

A story is told that one day in the 1950s the Mayor of Detroit, the Governor of Michigan, and heads of the "big three" automobile manufacturing companies, and the President of the United Automobile Workers union sat around a table in Detroit — rather like the "board room" scene in the 1972 motion picture, "The Godfather" — and decidedhow everything would run in the "Motor City." The story is apocryphal, but more about it

So what about the Detroit bankruptcy? Many conservative and Republican friends are indulging in schadenfreude over the failure of the experiment in liberalism that has been Detroit under the seven mayors, all Democrats, who have governed since 1962. Personally, I think it is in extremely poor taste to rejoice over the prospect that workers may lose their pensions, creditors will go unpaid, and basic public safety services are largely suspended in a city of a 700,000 souls. Furthermore, the facts do not support that narrative.

Boston, at 625,000 is, in population, nearly the same size as Detroit. We've had

Ah, but the difference is Detroit was dependent on one industry and when it declined, so did the city. But if that were the explanation, what about Pittsburgh. Like Boston and Detroit the city government is of the "strong mayor" type, and since 1934 those mayors have been Democrats. At 300,000 residents it's smaller, but, like Detroit, it was, for many years dependent largely on one industry, steel. When steel production declined, so did the city. However, Pittsburgh is recovering, due to private industry and government investment in the core city.

Three things differentiate Boston from Detroit.

1. Race. Whites were leaving Detroit for the suburbs starting with the post-World War II suburban boom. After the Black riots in the summer of 1967 White-flight accelerated. After 1967 much

of the White population of Michigan was afraid to cross Eight Mile Road, the division between Detroit and the northern, White suburbs. By the 1980 U.S. Census, the population of Detroit was just 34 percent White. If White Michiganders had any interest in returning to Detroit, Mayor Coleman Young's response to the census numbers made it clear they were not wanted. He declared White-flight a good thing, saying something to the effect that the rest should leave too, because Detroit is Black city. Whites heeded the Mayor's advice. Detroit is now 11 percent White.

2. Sprawl. Boston has nearly the same population as Detroit, but Detroit is halfagain as large, in terms of square miles, 143 square miles compared to 90. Even when Detroit, in 1950, had a population of 1.8 million, many of the residents lived in houses set on large lots



# Trayvon's Death Brings Up Race Elephant in the Room

"There are very few African-American men in this country who haven't had the experience of being followed when they were shopping in a department store. Trayvon Martin could have been me 35 years ago."

- President Barack Obama

When Barack Obama was elected president in 2008. liberals hailed the victory that we were now living in a post-racial America. However, since his election, he has become a lightning rod for racial division. Everything he does or says seems to be viewed through the prism of race. Here we had a president who was biracial, a president raised by his white maternal grandparents and we saw him attending a church whose pastor's views certainly weren't close to post-racial anything.

I grew up in the '50s and '60s in lower Roxbury, a racially-mixed neighborhood consisting of Italian and Irish Americans and a growing African-American community. I was the first "Irish Giarratani" in my family. My brother met his wife in Roxbury and they married in 1968 which was not a time when biracial marriages were common place. On my mother's Irish side, I had an uncle who married a Latina from Puerto Rico and I had four Puerto Rican-Irish cousins growing up. My family background was for me the real expression of what it meant to be an American.

Lots of people in the African American community were upset with the verdict on George Zimmerman. They saw it as unjust because he killed an innocent 17-yearold young man. Did he target Martin because he was black or wearing a hoodie? Did he go out looking for a black boy to shoot?

What is racial profiling, is it by itself a hate crime? If racial profiling leads to the death of another human being, is that a punishable crime? Was Zimmerman a racist with a gun on that fateful evening? Or was he just a crime watch member looking out for the safety of his community? If Trayvon had been white, would Zimmerman have acted any differently? Was justice not served by the not guilty verdict rendered by the jury of six women?

Depending on the race of the person you ask, you are likely to get polar opposite answers. Many in the Black community say reaction in the African-Americans is based on 400 years of racism in this country. If you ask a white person, many say the

April 6 - The opening ceremonies of the 1896 Summer Olympics, the first modern Olympic Games, are held in Athens.

May 26 - Eleven years after its foundation, a group of 12 purely industrial stocks were chosen to form the Dow Jones Industrial Average. The index was composed entirely of industrial shares for the first time.

May 27 - St. Louis-East St. Louis Tornado: The costliest and third deadliest tornado in U.S. history levels a mile wide swath of downtown St. Louis, Missouri, incurring \$2.9 billion (1997 USD) in normalized damages, killing more than 255 and injuring over 1,000 people.

June 4 - The Ford Quadricycle, the first Ford vehicle ever developed, is completed, eventually leading Henry Ford to build the empire that



# Saint Peter Chrysologus

Saint Peter was born at Imola, Italy in 406, he was baptized, educated and ordained a deacon by Cornelius, Bishop of Imola. After serving as a deacon in Imola, Saint Peter was given the name Chrysologus, meaning 'golden worded' in Greek, as a result of his exceptional oratorical ability. In 433, Pope Sixtus III consecrated him bishop of Ravenna. As bishop, Peter practiced many corporal and spiritual works of mercy, and shepherded his flock with utmost diligence and care.

The traditional account, as recorded in the Roman Breviary, is that Pope Sixtus III had a vision of St. Peter and St. Apollinaris, the first bishops of Rome and Ravenna respectively, who showed Sixtus a young man and said he was the next Bishop of Ravenna. When the group from Ravenna arrived in Rome including Cornelius



Sixtus recognized Peter as the young man in his vision and consecrated him as a bishop.

Known as "The Doctor of Homilies," Peter was known for his short but inspired talks; he kept his sermons short for fear of boring his audience. After hearing his first homily as bishop, and his archdeacon Peter, Empress Galla Placidia is

said to have given him the surname Chrysologus, by which he is known. Galla Placidia was to become the patroness of many of Peter's projects. Peter worked to rid his city of the last vestiges of paganism and spoke against the Arian and Monophysite teachings, condemning them as heresies.

Peter explained to his flock topics such as the Apostles' Creed, John the Baptist, the Blessed Virgin Mary and the mystery of the Incarnation, in simple and clear language. Peter advocated daily reception of Holy Communion. He urged his listeners to have confidence in the forgiveness offered through Christ.

He died at Imola, Italy in 450 during the Pontificate of Pope Leo the Great. Saint Peter Chrysologus was declared a Doctor of the Church in 1729 by Pope Benedict XIII largely as a result of his simple, practical, and clear sermons. In the eighth century Felix of Ravenna preserved 176 of his homilies which have come down to us, nearly all dealing with Gospel subjects. His feast day is celebrated on July 30th.





# Recipes from the Homeland

#### VEGETABLE MEDLEY

2 medium potatoes

- 1/2 pounds fresh, frozen or canned string or cut beans 1 large garlic clove
- 1 medium zucchini sliced
- (1/2-inch pieces) not peeled
- 1 medium yellow squash sliced (1/2-inch pieces) not
- 2 large ripe tomatoes or a four-ounce portion crushed tomatoes
- 1/3 cup olive oil
- 1 chopped medium onion
- 1 tablespoon capers

3/4 tablespoon basil

In a saucepan, sauté onion and capers in oil until opaque. Add chopped ripened tomatoes or four ounces of crushed tomato. If you prefer a heavier sauce, use a four-ounce can tomato sauce instead. Add fresh or dried basil. Stir, cover and simmer slowly. Meanwhile, peel and cube potatoes. Wash and set aside. If using fresh string beans, cut ends off, wash and set aside. Add potatoes and beans to saucepan. Stir, cover, and simmer slowly for ten minutes. Add sliced zucchini and yellow squash (optional). Salt to taste. Add water if more liquid is desired and bring to a boil. Cover and simmer slowly until all vegetables are tender. Serve with garlic bread.

Serves two.

NOTE: For those who enjoy rice or pasta, prepare your preferred rice or macaroni according to directions on the package. Serve a portion topped with the vegetable medley. Sprinkle with your grated cheese of choice.

that you'd expect to see in Chrysler, Ford and General the suburbs. It was ever thus. I recall, in the 1980s, reading a book about the history of Detroit that mentioned that, even before the city boomed with the automobile industry, earlier, nineteenth century visitors commented that everything was so spread out in Detroit, compared to other towns.

3. Big, big, big. Even if the story that begins this essay isn't the literal truth, it explains much of the problem of Detroit. One big industry dominated. The Chairmen of

Motors, along with the President of union, and a strong Mayor decided everything. That means that when mistakes were made they were colossal, and difficult to remedy. From the 1970s on there was talk of, but no significant action on, diversifying the economy. As educated people left the city the remaining population elected worse and worse Mayors.

Put those three factors together and it was just a matter of time before Detroit failed.



A Nostalgic Remembrance



Saturday the 27th is the anniversary of the end of the Korean War. August 7th is Purple Heart Day and on August 14th, Japan surrendered to end WWII. I met a cousin the other day and over coffee, we talked about the family. The men in our family have been involved in all the wars since the Spanish American in 1898. That's just two years after the first relative arrived in America. Both sides of the family have been flag wavers ever since that point in time. If this sounds corny, then let it be so, but being an American to all sides of my family has been extremely important if for no more of a reason than personal satisfaction. I mention all this be-cause we are still hyphenated ... Italian-American. It makes me think we are in limbo somewhere not quite in Heaven according to what the nuns told us when I was a kid.

When people ask me what I am, I often say, "Writer, musician, actor and educator." The next question is usually, "No, where are you from?" My answer is always, "Boston." And then I'm asked, "No, what I meant is, where are your people from?" Again, I reply, "Boston." Of course, when they ask what country the family originated in, I have to play into their hands and say, "Italy." Before I walk away, the comment is usually, "Oh, you're Italian-American," with a verbal hyphen in between.

If we have to be hyphenated, then let me quote the words of an attorney named Angelo Bianchi, Esq. A while back he wrote a narrative called, "I Am An Italian-American."

It begins with, "I am an Italian-American. My roots are deep in an ancient soil, drenched by the Mediterranean sun and watered by pure streams from snow capped mountains.

I am enriched by thousands of years of culture.

My hands are those of the mason, the artist, the man of the soil.

Rome, the poetry of Virgil, the creations of Dante and the philosophy of Benedetto Croce. I am an Italian-American and from my ancient world, I first spanned the seas of the new world. I am Cristoforo Colombo. I am Giovanni Caboto, known in

American history as John Cabot, discoverer of the mainland of North America.

I am Amerigo Vespucci, who lent his name to the new world, America. First to sail on the Great Lakes in 1697, founder of the territory that became the State of Illinois, colonizer of Louisiana and Arkansas, I am Enrico Tonti.

I am Filippo Mazzei, friend of Thomas Jefferson and my thesis on the equality of man was written into the Bill of Rights. I am William Paca signer of the Declaration of Independence. I am an Italian-American. I financed the Northwest Expedition of George Rogers Clark and accompanied him through the lands that would become Ohio, Indiana, Illinois, Wisconsin and Michigan, I am Colonel Francesco Vigo.

I mapped the Pacific from Mexico to Alaska and to the Philippines, I am Alessandro Malaspina.

I am Giacomo Beltrami, discoverer of the source of the Mississippi River in 1823. I created the Dome of the United States Capitol. They called me the Michelangelo of America ... I am Constantino Brumidi.

In 1904, I founded in San Francisco the Bank of Italy, now known as the Bank of America, one of the largest financial institutions in the world and am the originator of strip mall banking, I am Amadeo Peter Giannini. I am Enrico Fermi, father of nuclear science in America. I am the first enlisted man to win the Medal of Honor in World War II, I am John Basilone of New Jersey.

I am an Italian-American. I represent the millions who served in America's military services and the tens of thousands whose names are enshrined in military cemeteries from Guadalcanal to the Rhine just from World War II alone.

I am the steel maker in Pittsburgh, the grower in the Imperial Valley of California, the fashion designer in Manhattan, the movie maker Hollywood the home My thoughts have been maker and the breadwinner recorded in the annals of in 10,000 communities all over the United States.

I am an American without stint or reservation, loving this land as only one who understands history, its agonies and its triumphs can love it and serve it. I will not be told that my contribution is any less nor my role not

In other words, my grandfather was Italian, my father was Italian American, I am American Italian and my sons are American. It has taken several generations to remove the hyphen, but as far as I'm concerned, it's

Today's immigrants are from other parts of the world, Africa, Asia, the Middle East and Latin America. Many look down on these folks due to the physical differences between them and our folks of European origins. My comment is, "Give them a chance before we stereotype them into negative categories. If they mean well and want the American dream, let's help them out. If they are looking for trouble, then let's make that dream become a nightmare. We've worked too hard to let things fall apart. We learned from the people who preceded us and laid down the ground rules for what became America. We have a lot to be proud of with just two major blemishes on our record, slavery and the disposition of the Native American." When I mention these things, some of those who are gun shy agree with me, others don't. Let's see what the future brings without the hyphen. GOD BLESS AMERICA





The MASSACHUSETTS PORT AUTHORITY (Authority) is soliciting professional consulting services for MPA CONTRACT NO. A302-D6, FY14-16 ARCHITECTURAL/ENGINEERING SERVICES. The Authority is seeking a qualified multidiscipline consulting firm or team, with an emphasis on architectural design and proven experience to provide professional services including planning, design, and construction related services including resident inspection, on an on-call, as needed basis. These services are expected to be provided at Logan Airport and other Massport facilities. The projects may range from small and simple to relatively large and complex. The Consultant must be able to work closely with the Authority and other interested parties in order to provide such services in a timely and effective manner.

# HOOPS and HOCKEY in the HUB

A SCHOOL THAT BELIEVES IN CONTRACTS — In a somewhat refreshing take on contracts in the athletic world, there still is at least one place where those who give their word by signing a contract are expected to keep it - or experience significant financial penalties.

That place would be Kent State University in Ohio which has just successfully sued its former men's basketball coach Geno Ford for breach of contract. The amount awarded to Kent State by the court was \$1.2 million.

Ford had amassed a fine 68-37 record and won two Mid-American Conference titles in three years at KSU. Back in 2010 the coach had renegotiated his contract, increasing his salary to \$300,000 per year, making him the highest paid coach in the conference.

Ah, but KSU had inserted into the contract a "liquidated damages clause" which stated that if the coach left on his own before March 31, 2015 Kent would get the balance of his contract all in one payment. If Kent fired him, the coach would get the balance.

Fast forward to March 2011 and coach Ford had an offer he felt he could not refuse. Come coach at Bradley University for \$700,000 a year. And off he went. But Kent State then filed a lawsuit against him for the remaining four years of his salary (\$1.2 million). And just last week the institution won a legal victory.

Ohio Attorney General Michael DeWine was quoted in press reports as stating: "When coaches and high profile employees leave public universities in breach of their contracts, the State of Ohio has an obligation to seek the compensation to which it is entitled."

Coach Ford should have known better. Jim Christian, his immediate predecessor, left Kent State to coach at Texas Christian and wound up paying KSU \$350,000.

And the legal actions aren't over. Kent is also suing Bradley concerning the matter. That lawsuit is scheduled to go to a jury trial on October 7.

To all colleges and pro franchises: We hope you're taking notes. Now you know what to insert into the next contracts that you offer. You also need the willpower to back up that written language with court filings, if needed.

**JUST TO COOL US OFF** — Both the preseason and regular season schedules for the Bruins were announced during the recent heat wave. The B's will have two preseason home games at the Garden, hosting Detroit on September 19th and Washington on September 23rd.

The Bruins will open the regular season with a three-game home stand, meeting Tampa Bay on October 3rd, Detroit on October 5th and Columbus (without former Bruin Nathan Horton who has had shoulder surgery) on October 10th.

November 5th brings Tyler Seguin back, as Dallas visits, while the rematch between the Bruins and the Stanley Cup champion Chicago Blackhawks at the Garden won't take place until March 27th. The B's will play a road game in Chicago on January 19th.

**IN MEMORIAM** — Remembering the victims of the worst plane crash in Boston history which occurred 40 years ago (July 31, 1973) at Logan International Airport. The crash happened when a Delta Airlines DC-9 hit the seawall at the airport while coming in for a landing in the fog. All 89 people on board Flight 723 were killed, including one person who died several months later in a hospital.

Also remembering Harvard University baseball coach Joe Walsh who died one year ago (July 31, 2012) at his home in New Hampshire. The annual New England College All-Star Game is now named in his honor.
