Mississippi Removes Stars and Bars from State Flag

Stirpe Nostra

APHRODITE



Aphrodite Pudica (Roman copy of 2nd-century AD), National Archaeological Museum, Athens

Aphrodite is most popularly known as the Greek goddess of Love. According to ancient tales, she was the daughter of Zeus and the goddess Dione. Legends tell us that Aphrodite first appeared to the mortal world as a goddess who was born out of the ocean foam and first stepped ashore on the island of Cyprus during Phoenician times. Initially, she was worshipped as the goddess of love but in later years, her influence was extended to maritime traffic, tranquil seas, and prosperous voyages. Those mortals who were not seafaring people knew her as the goddess of spring, gardens, and groves.

Notwithstanding all of the above, in the world of mythology Aphrodite showed her full power as the goddess of love and beauty. She was above all other goddesses in loveliness, grace, magic charms, and

captivating beauty; irresistible to the wisest mortal and able to subdue any god. Even the legends surrounding the Trojan War place Aphrodite in the events that lead to the hostilities. Eris, the goddess of discord threw a golden apple among the assembled goddesses. The apple was inscribed "For the fairest." An ensuing quarrel between Aphrodite and the other goddesses was finally referred to Paris, a shepherd on Mt. Ida, whose judgment was to be final. Each of the contestants offered gifts which were intended to influence Paris' decision. One goddess offered a kingdom, while another offered intellectual superiority, etc. The prize was finally assigned to Aphrodite who promised Paris the fairest woman in the land for his wife. Due to Aphrodite's delay in paying her debt, plus the coincidence of Paris' voyage to Greece, advantage was taken of an opportunity to abduct the fair Helen, wife of Menelaus, a Spartan king. The Trojan War, as you know, was fought in order to secure the release of Helen and to return her to Menelaus.

Mythology places Aphrodite as the wife of Hephaestus, smith of the gods, but there are also stories of notorious escapades with other gods. One such escapade with a member of Trojan royalty produced Aeneas, who later became known as the ancestor of the Roman race.

Aphrodite became a favorite subject with the ancient artists, but was represented in whatever mode suited their individual interest at that particular time. Early works showed this goddess clothed or draped, while in later years, she was generally shown undraped, rising from the sea, or leaving her bath. Speaking of baths, excuse me while I try to find some soap.

Case numbers:

FOURTH OF JULY PUBLIC SAFETY REMINDERS:

The Mayor reminded everyone that COVID-19 presents a safety issue during Fourth of July celebrations. While this is traditionally a weekend to gather in large groups, that is not something that can be done this year. **The City's Independence Day celebrations are going to be online.** Everyone's Fourth of July plans need to be limited to small groups, wearing face coverings and keeping six feet of distance.

The Mayor pointed to what is happening in other parts of the country, with major surges of cases; hospital capacities being pushed to the limit; and economies getting shut down again. He urges every resident and business to continue to take COVID-19 seriously.

The City and the Boston Public Health Commission have continued to make health the top priority, by basing decisions on science; monitoring the data and inequities across demographics and neighborhoods; and bringing health and financial resources to where they are needed.

Chief of Health and Human Services Marty Martinez gave the following updates:

Boston is continuing to see a solid 14-day decrease in cases and a 7-day decrease as well. While the decrease is flattening, we are seeing very low case numbers continue, which is a good sign.

In the last 18 days, the City has only had **1 day with over**

30 cases. Our work is paying off to prevent new infections.

We also had one of our lowest positive case rates this past week at 1.9% positive for the entire week, with a cumulative rate of 17.7% for COVID testing in general. While we have increased the number of people we have been testing over the past few weeks, we continue to see a decline in the positive test rate.

Our hospital ICU usage was at **78%** of normal capacity, which is down from a high of **136%** at its peak in April.

We continue to look at the inequitable impacts COVID has had on our Black and Brown communities. This is why we are increasing testing in key zip codes, and investing in resources to connect people to care and support at our community health centers.

He urged everyone to stay cautious and diligent while the City continues down the path of recovery.

Equity and housing security: Housing security is a pressing issue, and is part of the City's conversation on equity.

The Mayor referenced a report released this weekend about the threat of widespread evictions, when federal unemployment relief runs out and the state's eviction moratorium ends. The City was able to provide data for this report, because we have been tracking these needs and working to meet them — by creating an Office of Housing Stability; investing in affordable housing; and advocating for greater tenant protections. The FY21 budget approved last week expands this work with \$16 mil**lion** of new investment.

The City also filed several bills in the current legislative session to protect tenants and increase housing stability. These include:

A bill that guarantees tenants of a building the **right to buy** that building with a nonprofit partner if it goes on the market.

A bill **protecting elderly tenants** from eviction and displacement.

A bill to guarantee tenants facing eviction the **right to legal representation**.

The Mayor also supports a bill filed by **Senator Sal DiDomenico** to pilot a **Right to Counsel** for tenants impacted by COVID-19.

During the public health crisis, the City has made **\$8 million** available for rental relief for residents who are not eligible for unemployment insurance or federal relief. As of last week, the City has distributed over **\$1 million** of those funds to cover rent for hundreds of households, and will continue to distribute funds as needed.

The Mayor is asking the State to **extend the eviction moratorium** for as long as it takes to protect housing stability in the City of Boston and Commonwealth and with whatever supports are necessary to protect landlords from foreclosures and other harms. He expressed support for the bill filed by Reps. Kevin Honan and Mike Connolly.

Housing insecurity is an issue of racial equity as well as general economic disruption. City data shows that communities of color are more vulnerable to eviction and burdensome rents. That is due in large part to a history of being excluded from housing opportunities that took place all across our country. That's why the City has to take a deep look inside our systems to root out

COVID-19 Testing Available in the North End

NEW Health, a federally qualified health center and an affiliate of Massachusetts General Hospital and Boston Medical Center, opened a COVID-19 testing site in the North End neighborhood of Boston. This is NEW Health's second testing site, in addition to the site in the Bunker Hill Housing Development in Charlestown.

Located right outside the Nazzaro Community Center at 30 North Bennet Street.

NEW Health welcomed Rep. Aaron Michlewitz onsite and recognize his efforts in helping to establish the new site.

The North End testing site is open Tuesdays and Thursdays, 9:00 a.m. to 12:00 p.m., rain or shine. The launch of the new site follows the opening of the Charlestown location in May and allows for greater availability and convenience to all area residents, particularly as the neighborhood reopens and the public returns to the local streets, restaurants, and shops. Testing is available for all North End residents and NEW Health patients at this location in addition to the Charlestown site.

Patients can access the site within the parking lot of the Nazzaro Center by entering from North Bennet Street (there will be no access from the Prince Street side). **Appointments are**

required to reduce crowds and wait time and can be scheduled by calling 617-643-8000. Testing is available without a referral and even to residents who are not exhibiting symptoms. Proof of residency is required. A telehealth visit is conducted prior to the onsite testing visit, both of which are covered by all major health insurance providers; if patients have no insurance or insurance does not cover, the tests will still be provided for free.

"I want to make sure our most vulnerable residents are kept safe during this pandemic," said NEW Health CEO James Luisi. "We're opening this site to encourage residents of the North End to come get tested. Our general mission is to improve the quality of health and life for the residents of Boston's North End, Waterfront, and Charlestown communities, and this critically-needed testing site reflects that."

In conjunction with the crucial testing for the community, NEW Health is also focused on supporting those facing food insecurity. Patients being tested who indicate they are unable to purchase necessary groceries also receive supermarket gift certificates. NEW Health recently planted its annual rooftop garden at its Charlestown facility. Herbs and vegetables

from the garden are used by the health center's nutritionist to teach patients how to cook healthy meals on a budget. This season launched an instructional video series documenting the garden from initial plant to last harvest.

Both NEW Health locations on Hanover Street in Boston's North End and at 15 Tufts Street in Charlestown are also open and accepting new patients for services in departments including Adult Primary Care, Pediatrics and Adolescent Primary Care, Behavioral Health, Dental Care, Vision, Podiatry, Obstetrics and Gynecology (OB/GYN), Radiology, and Lab. Staff continue to follow strict guidelines and cleaning protocols to guarantee a safe environment for patients to receive care. In addition to a universal mask policy, NEW Health has implemented a prescreening process for patients and upon arrival, a staff member supplies a new mask and hand sanitizer, and screens for COVID-19 symptoms once again. All waiting areas have been reorganized to allow for 6 feet of distancing between

City of Boston to Remove The Emancipation Group Statue Following Vote by Boston Art Commission

The Boston Art Commission Called for a Process To Re-Contextualize the Statue in a New Setting

Mayor Martin J. Walsh and the Mayor's Office of Arts and Culture, together with the Boston Art Commission (BAC), announced the Boston Art Commission has voted to remove the bronze figurative elements of The Emancipation Group statue from its location in Park Square. The statue, which is a copy of a statue in Washington D.C. created by Thomas Ball, has been criticized since its installation in 1879 for its depiction of an enslaved man.

"As we continue our work to make Boston a more equitable and just city, it's important that we look at the stories being told by the public art in all of our neighborhoods,"

said Mayor Walsh. "After engaging in a public process, it's clear that residents and visitors to Boston have been uncomfortable with this statue, and its reductive representation of the Black man's role in the abolitionist movement. I fully support the Boston Art Commission's decision for removal and thank them for their work."

The Emancipation Group was a gift to the City by Moses Kimball, a local politician. The statue depicts Abraham Lincoln, whose right hand rests on the Emancipation Proclamation. His left is raised in a gesture of benediction above the crouched figure of Archer Alexander, a Black man who assisted the Union Army, escaped slavery, and was recaptured under the Fugitive Slave Act. There is an inscription on the front of the piece that reads, "A race set free and the country at peace / Lincoln / Rests from his labors.

For generations, Bostonians have called for its removal due to its racist depiction of a Black person. Many also feel it implies that one person ended slavery and misrepresents the complexity of United States history. A recent petition by local artist Tory Bullock calling for the statue's removal garnered over 12,000 signatures. The City of Boston encouraged the public to share their input on *The Emancipation Group* through an online survey, which received 645 responses. The Boston Art Commission held two special meetings to hear public testimony, and also welcomed written testimony via email.

"Public art is storytelling at the street level. As such, the imagery should strike the heart and engage the mind," said Ekua Holmes, Vice-Chair of the Boston Art Commission. What I heard today is that it hurts to look at this piece, and in the Boston landscape we should not have works that bring shame to any groups of people, not only in Boston but across the entire United States."

The commissioners unanimously voted to remove the bronze figurative elements of *The Emancipation Group* pending:

- Engagement of an art conservator to document, recommend how the bronze statue is removed, and supervise its removal and placement into temporary storage;
- Commissioning of detailed documentation of the artwork into Boston Art Commission archives, which may include photography of the statue in situ, drawings, and a 3D scan, as well

L'Anno Bello: A Year in Italian Folklore

Pep and Pride on the Fourth of July

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



No other holiday smells tastes or feels like summer more than the Fourth of July. It is the scent of fired-up grills emanating from every American backyard, the light swirl of smoke rising up in the hazy heat. It is the taste of sweet buttered corn crunching between your teeth. The Fourth of July encompasses the sounds of families laughing as they share food and memories outside, and of fireworks exploding across a silky night sky. To this day, I still feel a mysterious shiver when I hear the faint sound of fireworks bursting from some far-off festival during a starlit evening. These distant fireworks instill in me the feeling of the unknown, the sensation that little feasts are sweeping the country before the big celebration of Independence Day. Because of these exciting and myriad feelings, the Fourth of July remains one of my favorite holidays, the quintessential celebration of summer. It is a commemoration of family and food, patriotism and heritage, history and diversity, all converging in a brilliant summer day.

Had Massachusetts representative John Adams been correct, we would have been honoring our country's Independence Day on the second of July. That was the day in 1776 when, during the height of the Revolutionary War, the convention of delegates from the Thirteen Colonies, known

as the Second Continental Congress, approved a resolution that declared independence from Great Britain. Adams predicted that this day would forevermore be marked with parades, bonfires and games. In reality, Adams's speculation on the nature of Independence Day celebrations proved accurate, only the date shifted to the fourth, when the Congress finally approved this declaration after much revision. Therefore, the Fourth of July commemorates a tremendous event - a bold statement of independence, a desire to free oneself from oppression that would inspire revolutions the world over. As a patriotic holiday, the Fourth of July is also a perfect time to honor America's diversity, and during this holiday I often reflect on what it means to be Italian-American. Italians have been involved in America's quest for liberty and equality since the country's early days. The Tuscan physician Filippo Mazzei inspired the Declaration of Independence's statement that everyone has fundamental equality. Giuseppe Garibaldi, the hero of Italian independence, was recruited to fight in the Civil War and though he did not because of his commitment to Italy's freedom, his name inspired a Union Army regiment comprised of soldiers from both Europe and America. An Italian immigrant, Constantino Brumidi, painted the U.S. Capitol dome. We should take this holiday as a chance to feel proud to be an American but also proud of our ethnic heritage, which contributes to I must take the time to wish everyone ... Last week, the Mayor announced a new **Equity Cabinet** for the City of Boston. The purpose is to elevate and accelerate the work the City is doing to dismantle systemic racism and create fair opportunities for all Bostonians.

The Mayor announced **Dr. Karilyn Crockett** as Boston's first-ever **Chief of Equity**.

The Mayor described Karilyn as a brilliant innovator and passionate change maker, and someone who lifts up community voices and brings their power and perspective to the halls of government, business, and academia.

Karilyn has already had an immense impact in Boston:

She served for four years as the City's Director of Economic Policy, Research, and Small Business Development.

In that role, she helped create the first citywide Small Business Plan and Economic Equity & Inclusion Agenda.


She also strengthened the City's Resident Jobs Policy, which leverages our city's growth to create more opportunities for women and people of color.

Karilyn is a proud product of the Black community in Boston. She grew up in Dorchester and attended Boston Public Schools for most of her K-12 education. She went on to Yale University, where she earned 3 degrees, including a Ph.D. in American Studies. After college, she founded MYTOWN: a trail-blazing organization that hires high school students to research local histories and create walking tours.

Karilyn is also a leading scholar of equity and urban planning in Boston. She published a groundbreaking book called *People Before Highways*, which has changed our understanding of urban renewal, putting the community at the center of the story. For the last 2 years, she has been a lecturer in Public Policy and Urban Planning at M.I.T.

She understands the roots of racial inequity and the tools we need to break it down, and is passionate about our community's ability to lead this work.

The Mayor then invited Dr. Crockett to reflect on her role and her focus moving forward.



CHAPTER 24 Smells, Sounds, and Sights of the Seasons

Life in the North End has always been a highly sensory experience. The seasons of the year separated one from the other by distinct smells, sounds and sights unique to each.

Autumn in the North End was a special time, the experience of a very old culture preparing for winter, making its way in a new world. There was the distinct, acrid smell of discarded crushed grapes, rising from bushel baskets piled high on every corner. The discarded grapes waiting for trash pickup, the by-product of the many regional wines being prepared from recipes centuries old, in cellars scattered throughout the North End. Although Grandpa Bernardo passed away several years ago, Grandma deeply sentimental, could never part with the three enormous wine barrels used to make his version of a Southern Italian wine. Grandpa had asthma and no sense of smell. He was unable to taste the wine to determine if it was ready to be bottled. Mom and Auntie Stella became his wine tasters. The story goes, Grandpa would send them down into the cellar to test the wine by siphoning off a bit of wine from each of the three barrels. The fresh wine was both



delicious and strong. On one occasion, the two young girls siphoned and re-siphoned the wine, swallowing more than usual, wanting to make certain it was ready to serve, becoming somewhat inebriated. They surfaced from the cellar holding a half empty bottle of wine, declaring, "It's ready!" Grandpa caught sight of his daughters, who obviously had one too many, and said to Grandma, "E' questo che insegni alle tue figlie? (Is this what you teach your daughters)?" Grandma, never to be put down, shot back, "Sono anche le tue figlie (They are also your daughters)." Grabbing the bottle out of Auntie Stella's hands, she told the two girls to go to bed, which they did, giggling all the way to their room. Just before closing the door, Auntie Stella turned and said, "Papa, you make delicious wine." With that, he tossed a dish towel at her, while yelling, "Va' a letto!" (Go to bed!) After closing the door behind them, the two girls could be heard giggling until they fell asleep.

Autumn was also the time when the red and green peppers, bought at Haymarket from street produce stalls, were being preserved in jars filled with vinegar and spiced with garlic cloves. For reasons of space, the filled jars were stored under beds throughout the North End like buried treasure. Their contents would be used to spice up a salad or add a delicious flavor to fried pork chops prepared for dinner on the chilly evenings that lay ahead. Tomato sauce was set aside in sealed jars that lined shelves bowed from the weight of previous seasons. Resourceful North Enders were preparing for winter. The sight of children playing in the streets after school, the sound of church bells filling the brisk air beckoning the faithful to morning Mass and later to Mass at day's end, contributed to an atmosphere distinctly Italian. It was a time in which the North End felt more like an Italian village than a neighborhood in a big American city.

as the history of the piece and the process that the Boston Art Commission took in order to make this decision;

- Creation of a public event that will acknowledge the statue's history and inform the public;
- Initiation of a process to determine how to re-contextualize the existing statue in a new publicly accessible setting; and
- Addition of temporary signage to the site to interpret the statue prior to its removal and permanent signage after the removal.

The date for the removal of the statue has not yet been determined. The Boston Art Commission will continue this conversation at its July 14, 2020 BAC meeting.

"We need to engage in public dialogue and examine the inequities that exist in our public realm. Who is represented in our artwork, which artists, and whose histories?" said Kara Elliott-Ortega, Chief of Arts and Culture for the City of Boston. "I appreciate the immense contributions from the public and their thoughts for the future of *The Emancipation Group*, and I look forward to using this process as a model for assessing other pieces in our collection."

In 2017, the BAC established

a collection policy to ensure that only artworks of the highest quality and enduring value are accepted into and kept in the City's holdings. With the creation of that policy, the BAC also established a deaccession process for the formal removal of an artwork from the City's collection after cautious and careful deliberation. The report An Opportunity for Change by local art historian Ewa Matyczyk, commissioned by the BAC, recommends the removal and relocation of the statue, with options including a long-term loan with a museum, or placing it somewhere where it can be in conversation with other representations from the historical era.

In 2019, the Mayor's Office of Arts and Culture began an effort to catalog the City's art collection and create a searchable online database with educational content. As part of this process, the City sought public input in assessing the historical and cultural significance of Boston's monuments and memorials.



Saint Augustine Zhao Rong And His 119 Companions

Christianity arrived in China by way of Syria in the 600s. Depending on China's relations with the outside world, Christianity over the centuries was free to grow or was conversely forced underground to operate secretly.

During the Tang dynasty (618 - 907) the Christian community flourished for two centuries. In the 13th century, thanks to the understanding of the Chinese people and culture shown by missionaries like Giovanni da Montecorvino, it became possible to begin the first Catholic mission in the Middle Kingdom.

Augustine Zhao Rong was a Chinese Soldier, who accompanied Bishop John Gabriel Taurin Dufresse, a Paris Foreign Mission Society member, to his martyrdom in Beijing. Augustine was baptized and not long after was ordained as a diocesan Priest. He was martyred in Beijing in 1815. Emperor Kia-Kin (1796 - 1821) published numerous and severe decrees against Christians. Two edicts of 1811 were issued by the Emperor.

The two edicts were directed against those Chinese who were studying to receive Sacred Orders, and against priests who were propagating the Christian religion. A decree of 1813 exonerated voluntary apostates from every chastisement, that is, Christians who spontaneously declared that they would abandon their faith, but all others were to be dealt with harshly. Augustine was martyred in 1815 during the Boxer Rebellion in which anti-colonial peasant rebels slaughtered 30,000 Chinese converts to Christianity along with missionaries and other foreigners.

Augustine Zhao Rong and his 119 point companions known also as The Martyred Saints of China, were Canonized by Pope John Paul II on October 1, 2000. They consisted of 87 Chinese Catholics, and 33 Western Missionaries from the mid-17th century to 1930. The Church celebrates their Feast Day on July 9th.

A Nostalgic Remembrance



Yesterday was our 43rd anniversary. Loretta and I were married at St. Leonard's in the North End on July 2nd, 1977. We met about a year and a half earlier at Boston University, both of us working on our doctorates. We didn't hit it off at first, but once we started dating, things changed.

I had picked Loretta up in the North End one stormy winter's night at the beginning of 1977. We were supposed to tie up with Dean Saluti and head out to see a movie all three of us wanted to watch. As I drove along Storrow Drive, traffic slowed to a crawl and finally stopped due to the roadway icing up. (You know what Boston's driving can be like when it snows) By the time we arrived at Dean's apartment, it was too late to head in town as the picture we wanted to see had already started. So, we ordered a pizza from a nearby bakery, and then told Dean we were getting married. As we were stuck in traffic, I proposed, Loretta accepted, and Dean was the first to know.

When Loretta told her parents, there was a bit of anxiety that developed. First of all, I was more than 12 years older than their daughter. Second, I was a musician and entertainer (by night); representing a lifestyle they had never experienced nor understood. My folks had taken a liking to Loretta when they first met her and they were happy with our decision to settle down. I knew what my folks were like regarding the young ladies I had brought home in the past. They were courteous, polite, and accommodating, but through their politeness, I could tell whether they approved or not. In Loretta's case, they approved.

A summer wedding was planned. Loretta chose St. Leonard's on Hanover Street in the North End as the church she wanted to celebrate her nuptials in. The priest we wanted to marry us would be on vacation on that coming July 2nd, and we headed to the Paulist Center in downtown and spoke with the late Fr. Simon Iocca, who agreed to handle the ceremony for us. Uncle Nick set up the reception with John Polcari, whose restaurant was one of the most famous in Boston at that time. John and Uncle Nick were good friends and the restaurant's function room was selected, a menu was chosen and a guest list was put together.

As the time approached, Loretta picked her maid of honor and attendants. I asked Sal Meli to stand up for me and Dean, and five other close friends to be my groomsmen. My former business agent was now in the photography business and he got the OK to film the wedding. My band was hired to play the reception minus the bass player (me). I even made a promise not to sit in, and I didn't.

Everything was set in stone, and I asked Loretta what her preferences were, a honeymoon cruise or a house in the suburbs. She chose the house. We headed to see a friend of mine who was in the real estate business, and when we saw a picture of the house that we still live in, it was a done deal. After a bit of negotiating, the house was ours. It was April of 77, and Loretta decided to move in. Both of our father's helped us redecorate and as the summer approached most everything was complete.

I had a speakerphone installed in the kitchen, and on a given Saturday when all four of us were working on the house, the phone rang. I put the speaker on as I had paint on my hands and didn't want to touch anything. The voice was that of pianist Eddie Jackson, whom I had worked with the summer before when he was part of a Motown group that was traveling through Boston minus a bass guitarist. Eddie yelled, "Hey baby, what's happening. We're going on the road in July and will be traveling for two months and need you on bass. Are you down with that?" Loretta and her father looked shocked. My father, being a musician and understanding the lingo, turned away and just smirked. I looked at the faces of my future wife and her father and said, "Yo, bro, it's over. I'm getting hitched in July, and ain't goin' nowhere." My future wife and her father sighed with relief. Dad tried to keep a straight face and said nothing. (A year or two later, Eddie Jackson would get off the road, buy a home in New Hampshire, and settle down. We would do a lot of duo work together after that ... piano and bass ... just the two of us playing cocktail jazz.)

Well, June rolled around and Loretta and her entourage celebrated with a bridal shower. Sal Meli booked in Polcari's for a bachelor party for me and we awaited July. On the night before the Saturday wedding, Dad and Mom had an open house for the wedding party after our dress rehearsal. Uncle Nick was the bartender and

I invited Fr. Simon to join us. After a couple of drinks and a bite to eat, Fr. Simon asked if anyone of my guests wanted to go to confession seeing we were having a wedding Mass. I told him that about half of the people present weren't Catholic, but I would make the announcement anyway

One of the groomsmen wanted to cleanse his soul and agreed to be the first to confess his sins. Fr. Simon asked which room he could use for a confessional, and I chose my bedroom. When I began working on a doctorate at B.U., I moved back to my folks' house to cut down on the cost of things, and Fr. Simon and my friend headed up to my bedroom. They were back down in a few minutes both laughing. When I asked what they were laughing about, Fr. Simon announced, "This is a first for me, conducting a confessional activity with the sinner sitting on a chair with a beer in his hand, me sitting on a bed with a scotch in my hand, and an open copy of Playboy on one of the pillows. This is a first, but all is forgiven."

We were married the next day at St. Leonard's, and then made our way to Polcari's for the reception. All went well until the next morning when I received a call from my parents. Ralph Manfredonia, one of Dad's closest friends dropped dead of a heart attack. I had planned to take Loretta away for a few days and then return to finish redecorating our new home. But we knew that we had to attend a wake and a funeral.

Later that year, Uncle Nick retired after 25 years running the Musicians' Union and headed to Florida with Aunt Dorothy to live out their remaining years. We would head to Delray Beach to see them that winter, but that's another story. So, to my darling wife, "Happy 43rd Anniversary. Te amo."

Italian food has always been one of the world's most beloved gastronomies. Italians pride themselves on their culinary creations, noting the use of fresh seasonal ingredients as a significant factor in their delicious results. In Italy, cooking is tradition-



ally done with what is in season, and eating seasonally is the Italian way of life. For example, asparagi verdi (green asparagus) is harvested in the south of Italy from February through May and in the North, generally from April into mid-June. Only at the height of their flavor would you find these delicious stalks featured on the menus in Italy's restaurants.

My family followed the same customs of the old country, and always made meals from ingredients that were fresh, available, and in season. Though late in the year, when I spotted bunches of asparagus at a nearby farm, I immediately thought of a recipe I wanted to share. Prosciutto Asparagi e Mozzarella con Penne (Asparagus, Prosciutto and Mozzarella with Penne) is one I've made often, and it is absolutely scrumptious. Fresh asparagus with garlic, olive oil and crushed red pepper, chunks of mozzarella cheese, pieces of prosciutto, and penne pasta when combined, results in an amazingly delectable dish. Just the perfect spring or summertime meal; hearty, yet not heavy or laden with sauces, and incredibly delicious. I assure you, Prosciutto Asparagi e Mozzarella con Penne will delight everyone at your dinner table!

ASPARAGUS, PROSCIUTTO and MOZZARELLA with PENNE

Prosciutto Asparagi e Mozzarella con Penne

2 pounds asparagus, trimmed and cut into 2-2 1/2 inch pieces, separating the stalks from the top pieces

1/4 - 1/2 cup light olive oil

cut into 1-inch cubes

6 - 7 garlic cloves, pressed 1 ¾ pounds fresh mozzarella,

1 ½ pounds penne pasta 2 - 3 cups reserved asparagus/pasta water ½ to ¾ pound prosciutto, sliced into 3-inch pieces crushed red pepper, to taste

Fill a large stockpot with water, add some salt, and let come to a boil. Take the asparagus stalk pieces, cook for 4 - 5 minutes, and set aside. In the same pot of water, add the top pieces, cook for 2 minutes and remove. To this same boiling water, add the penne pasta, cook to al dente, remove and set aside. Reserve 3 to 4 cups of the asparagus/pasta water and rinse pan for later use.

In a large saucepan, add the olive oil and warm on medium heat, add the pressed garlic and cook for about a 1 to 1 ½ minutes. Reduce temperature and add the asparagus, toss in the garlic/oil and cook on low, turning frequently, for about 4 minutes making sure not to soften the top pieces too much. Add the pasta and mozzarella, then slowly add about a cup of the pasta water at a time, while gently tossing everything together. The entire amount of water will not be needed, just enough so the mixture is not dry, not too much, or it will make the pasta soggy. The water, oil and cheese become the "sauce". Turn off the heat, add the prosciutto and gently blend. Let stand for about 5 minutes to allow the mozzarella to soften and all of the flavors to meld together. Toss, plate and serve, adding extra crushed red pepper, if desired.



Poland's antiquated military responds to attack

There is some dispute, but most historians agree that WWII officially started on September 1, 1939, when the German battleship Schleswig-Holstein attacked a Polish fort on Westerplatte Peninsula in the dark early hours of the morning (planned as a surprise attack). The fort was easy access for Germany, being just over the boarder and the million and a half German troops launched its first attack in Adolf Hitler's attempt to regain territory lost after the Treaty of Versailles.

At 1 million the Polish army was outnumbered, and negotiations with Great Britain France, and Russia to form an alliance of protection against the Third Reich that summer failed to end in an agreement, and Germany soon seized control of the airfields, bases, and rolled its tanks into the cities of Krakow and Warsaw, overtaking the army, bombing passenger trains, and firing on civilians.

Always the propagandist (and surrounded by brilliant spinners of the worst, or best, sort) Hitler painted the scene as an act of self-defense. To substantiate his claims, Hitler commandeered violent attacks on Poland's German population and framing the Polish government, broadcasting anti-Nazi rhetoric on a German controlled radio station in Poland (painting them as instigators), and dressed Dachau camp prisoners in Polish army uniforms before executing them, disguising them as casualties of the

"The Polish State has refused the peaceful settlement of relations which I desired, and has appealed to arms," Hitler said. "In order to put an end to this

the country was ripped between the two invading nations. Within days, the Polish army, its leaders, and the citizens who were lucky enough to getaway, fled

Hitler framing the attack as an act of retribution

lunacy, I have no other choice than to meet force with force from now on."

Hitler was counting on Britain and France ignoring this act, much like they had been ignoring his various violations of treaties in the previous three years. But the two countries had agreed, nonetheless, to fight on Poland's behalf, fearing that if Germany's power grew too large, they were open to attack as well. There was evidence for this concern, as Hitler had remilitarized the Rhineland in 1936 and, leading up to this attack had annexed both Austria and Czechoslovakia. In addition, when Poland refused to make a pact with the three nations offering help in the summer of 1939, Russia, instead made a secret pact with Germany involving Poland as a mutual take away.

Hitler was taken aback when both England and France issued ultimatums mandating the withdrawal of troops from Poland or face a declaration

the country leaving Germany in full control. By the end of the month, Hitler declared

Germany wasted no time in rounding up the countries weak, its Jews, and members of the resistance. Many were executed and others sent to camps. Half of the Jews killed in the Holocaust were captured in Poland.

Though tens of thousands were killed in this initial battle, this was merely the start of the war, the turning point of the 20th century. In the meantime, the rest of the world was closely watching in terror.

Eddie Kasko Dead at 88



Red Sox Hall of Famer Eddie Kasko recently passed away at the age of 88. Kasko spent 29 seasons with the Sox as a player, minor and major league manager, scout, and front-office executive.

He was inducted into the Red Sox Hall of Fame in 2010.

Kasko was named Red Sox manager in 1970, following popular manager Dick Williams who led the Red Sox to the 1967 World Series during "The Impossible Dream Season," when the Red Sox, who finished a half-game ahead of the NY Yankees, moved out of last place to roar back in '67 to win the AL pennant and I believe that Dick Williams was the midwife who delivered Red Sox Nation alive and kicking.

Kasko managed the Sox for four seasons 1970-73. I also remember the first time I heard of him was in the 1961 World Series when he played for the Cincinnati Reds against the Mantle-Maris NY Yankees that year. Kasko was a great defensive player at both third base and shortstop.

KEN BUCHANAN

Former World Lightweight Champion Still Slugging at 75



Happy Birthday Champ!

Popular former World Lightweight Champion Ken Buchanan celebrated his 75th birthday on June 28th while in the hospital recovering from an illness. He is expected to be back on his feet soon.

Born in Edinburgh, Scotland, Ken was an outstanding amateur before turning professional in 1965. Over the next five years he ran his record to 36 and 1 with his only loss being a disputed decision to Miguel Velazguez for the European crown.



Ken Buchanan defeating Ishamel Laguna

In his 38th fight Buchanan challenged Ishamel Laguna for the World Lightweight Championship. Laguna was from Panama but the fight was held in Puerto Rico on a very hot day. Many thought the heat would work in Laguna's favor, but the Scot proved durable and smart and won the decision and the title over fifteen rounds.

In between a couple of non-title fights, Ken defended the title against Ruben Navarro, winning a fifteen round decision by a clear margin. After that, he gave Laguna another shot at the crown and, though cut, won a tough fight by unanimous decision at Madison Square Garden. On the undercard of that fight another Panamanian fighter by the name of Roberto Duran made his American debut with an impressive one round knock out of Benny Huertas.

At this point in his career he was riding high. He was immensely popular with fans in the United States and a hero in his native Scotland. In 1970, he was named Fighter of the Year by the Boxing Writers Association of America.

After the Laguna win, Buchanan had two non-title fights and then signed to fight Roberto Duran. The fight took place on June 26, 1972, with Duran winning the title in a controversial bout. While ahead on points going into the 13th round, Roberto was becoming frustrated by Ken's durability and tenaciousness. Buchanan was landing a flurry of punches as the round was nearing its finish, and after the bell rang Durn landed a vicious blow below the belt that incapacitated Buchanan.



Buchanan vs. Duran

Referee Johnny LoBianco called the fight off and ruled Duran the winner by TKO and new champion. He did this while admitting the fight ending blow was landed after the bell had rung, a clear foul and one that should have led to Duran being disqualified.

Ken ratted off 13 straight wins after that, but was never given a return match with Duran, even though there was a signed contract for the match, Duran refused to honor it.

In 1975, Buchanan challenged Guts Ishimatsu for the WBC World Lightweight Champion but lost a 15 round decision in Tokyo. After that loss the former champ would fight just ten more times, winning the European Lightweight Title along the way. Eventually, the fire in the belly left him and he retired in 1982.

In retirement the Champ went into the hotel business. He is happily retired today and living in Edinburgh where he is still wildly popular.



HOOPS and HOCKEY in the HUB

appointment for the Boston Celtics, then the 1998 Draft was

just the opposite.

It was a surprise but in a positive way. Coming off the first season with head coach Rick Pitino at the helm at 36-46 and out of the playoffs, the Celtics were looking forward to that summer's annual selection rite once more. It was held far from the Hub — at General Motors Place in Vancouver, British Columbia on Canada's West Coast.

Back in Boston, some 3,000 miles away, the Celtics coaching staff and front office executives were in action — and they couldn't believe what they were seeing. As the early stages of the draft progressed, one standout player remained unselected — Paul Pierce from the University of Kansas.

It was June 24, 1998 — six months from Christmas Eve. But the Basketball Santa had arrived at the Celtics doorstep. Pierce was still available when the Celtics selected him with their first round pick (10th overall). The young man who had been born in Oakland, California — and had lived in Inglewood while loving the Lakers — was now a member of the Boston Celtics.


It was a wonderful way to start Pitino's second year. His first had started with an upset victory over the defending NBA Champion Chicago Bulls at the Garden. His second effectively began with the selection of Pierce. While people have tended to forget about the big win over the Bulls, they will never forget Paul Pierce.

The 6-7 forward, who left Kansas after his junior year, would play for the Celtics for 15 seasons. Along with teammates Kevin Garnett and Ray Allen, he would lead the Celtics to two NBA Finals and an NBA championship in 2008 — a year when he was selected as the MVP of the Finals. He also became a member of another Big Three — joining Larry Bird and John Havlicek as the only players to score more than 20,000 career points for the C's.

It might seem a bit odd but the selection of Pierce marked the high water mark of Pitino's four and a half year span with the Celtics. Pitino had power — absolute power — when he was in charge of the Celtics, not only as head coach but as president of the team as well. But Pierce had another kind of power — staying power — the type of power that would culminate in the retirement of his number 34 jersey during a Garden ceremony on February 11, 2018.

Pitino's second season (1998-1999) would be delayed by a lockout, resulting in only 50 games being played. It was another year of discouragement as the Celtics finished with a 19-31 record and failed to make the playoffs once again. There were flashes of positives, of course. Pierce became a starter right away and combined with teammate Antoine Walker to create an exciting tandem on the court.

The next year (1999-2000)

proved to be another one of disappointment. The C's went 35-47 and once again failed to make the playoffs. A trio of late winter setbacks highlighted the frustration as all three were lost when opposing teams made last minute buzzer beater baskets.

The last of the three provoked Pitino's best remembered comment during his time in Boston: "We've played hard the whole year. Larry Bird is not walking through that door. Kevin McHale is not walking through that door. Robert Parish is not walking through that door. People don't realize that and as soon as they realize those three guys are not walking through that door the better this town will be."

It was Pitino's defining moment in the Hub, a time when all the frustrations became distilled into one brief (but everlasting) summation of his era. All the pressures and emotions of his tenure here were brought forth, put on display and enunciated in a singular statement that remains a point of fascination to this day. Look on the internet and there it is — just as it was broadcast across the country on the night it was delivered during a post-game press conference.

About nine months later — on January 8, 2001 — with the C's sporting an underwhelming 12-22 record, Pitino called it quits, throwing in the towel on a tenure that saw him compile a 102-146 record in Boston. However, even the act of walking away proved to be financially lucrative. The Celtics paid him \$1 million in the days following his departure.

Assistant coach Jim O'Brien was elevated to the top spot on the bench. Although the Celtics finished poorly again, they improved under his guidance, making it to the 2002 Eastern Conference Finals.

As for Pitino, he didn't skip a beat. Come the fall of 2001, he became the head coach at the University of Louisville, a position he would hold until 2017. He was let go as a series of scandals involving the basketball program came to light. In 2018 the NCAA vacated Louisville's 2013 Division 1 National Championship.

Pitino moved on to coach a proteam in Greece for two seasons. He recently became the head coach of Iona College, a small school north of New York City. Iona plays its home games in a gym that seats just under 2,600. That means the 67-year-old coach probably will finish his career in an environment that is worlds away from the atmosphere of big-time college hoops and the NBA.
