With the fiery images still fresh in our minds of the deadly gasoline tanker explosion in Saugus, now is the time for all Boston residents and businesses to get on the record regarding the travel of these dangerous trucks through our neighborhood streets.

The State Transportation Authority, MassDOT, has initiated a public comment and hearing process regarding the proposed ban of passthrough hazardous material (hazmat) trucks from downtown Boston. This is especially important for the residential and business community of the North End/ Waterfront area, which is currently a designated passthrough route for hazmat trucks. Pass-through hazmat trucks are not doing

Enough Talk, Mr. President: Try Something Different by Herman Cain

Immediately following the debt ceiling debacle, the White House announced that the president will take a three-day bus tour through the Midwest to hear people's concerns about the economy and talk about measures to boost economic growth and job creation.

Is President Obama that out of touch?

Our national debt has now surpassed the Gross Domestic Product (GDP), because the national debt has grown faster than the anemic GDP growth rate. The unemployment rate was just reported for the month of July at 9 percent, which is the 30th consecutive month exceeding the promised-to-notexceed 8 percent rate. The agonizing debt ceiling deal did not prevent the S&P rating agency from downgrading our nation's credit rating. Businesses are going bust, and some families are broke.

This is beyond concern. These are crises screaming for solutions.

After the president's tour, we will get another speech. He will once again promise his laser-like focus on economic growth and job creation. We have heard this

speech many times before only to get the same results. More talk, talk, talk.

I have been traveling the country and listening to people for the last year, and I can tell you their concerns and fears. Namely, the economy is stuck in neutral and the president's policies of spend, spend, spend are not working. Since the president has not put forth any new ideas to boost economic growth and job creation, people also know that nothing is going to change simply because he is going to do another tour and give some more speeches.

Mr. President, speeches do not fuel the economic engine of this economy, which is the business sector. And speeches are not going to reduce the latest unemployment rate of 9.1 percent, nor will they ease the pain of the nearly 15 million people who can't find jobs because your administration wants to raise taxes and continue your regulatory onslaught on American businesses.

Mr. President, your failure to listen to the right people is not only weakening our economy, it's personal. I am out of patience paying rent and buying tires for friends and family because this economy is underperforming when it does not have to do so. This economy has plenty of pentup economic growth if taxes and regulations would just get out of the way and the uncertainty that's holding this economy down is removed. You have the power to do that. We don't.

A few weeks ago I shared in these commentaries my Economic Vision for America, parts 1, 2 and 3, if I were president. You do not have enough time left in your presidency to implement all of it, but you could get some of it passed by Congress to at least have an economic legacy of having tried to do the right thing.

The stock market will survive last week's big decline. It's resilient, and millions of people are not going to go without food and shelter because of the decline. The downgrading of the nation's debt rating by one of the major rating agencies is not good, but we can survive.

But people cannot survive without a job. Businesses

Stirpe Nostra

VESPASIAN THE RESTORER

Titus Flavius Sabinus Vespasianus, better known as Vespasian, was born in the Sabine country on November 17, 9 A.D. He married Flavia Domitilla and they had two sons that were named Titus and Domitian, who in turn served as emperors. Vespasian saw duty in a military capacity in the Roman provinces of Europe, Asia and Africa. He was very poor while serving as a military commander and at one time was suspected of acquiring money by dishonorable means; however, he had a great military reputation and was well liked by the soldiers. During the reign of Claudius, Vespasian was placed in command of a Roman legion that went through Germany and Britain, fought thirty battles, and reduced those two powerful nations to subjection.

While on a tour of Greece as one of Nero's companions, Vespasian often of- raded around Rome after his

fended that emperor by walking out while he was singing, or if he stayed through to the bitter end, would fall asleep. Nero sent Vespasian to conduct the war against Palestine in 66 A.D. and he remained there until after the death of Nero and Galba. Vespasian was proclaimed emperor at Alexandria on July 1, 69 A.D. after the war between Otho Vitellius and was quickly recognized by all of the eastern part of the empire. Vespasian became the first Flavian line of emperors (three in number) and he was followed by his sons Titus and Domitian.

He arrived in Rome late in December of 69 A.D., leaving his son Titus to continue the war in Palestine, and on December 22, his forces dragged Vitellius through the street before killing him with repeated blows. The head of Vitellius was pabody was thrown into the Tiber.

Vespasian worked with great industry to restore order in the city and throughout the empire. He disbanded some of the rebellious soldiers that had been loyal to Vitellius, and maintained a strong discipline among his own troops. He worked in complete harmony with the senate and the public administrators. His simple and economic life style was in complete contrast to that of his predecessors and he set a personal example that did more to reform the morals of Rome than all of the laws that have ever been passed. His mode of life was closer to that of a private citizen than one who possessed supreme power. He was easy to approach and to speak with, and made himself and his time available to all persons.

Personnel is Policy

During the administration of Ronald Reagan in the 1980s, an often heard conservative aphorism was personnel is policy, meaning that a conservative man or woman in the executive office wasn't sufficient to effect conservative policies. He or she had to appoint conservatives, otherwise the liberal establishment and bureaucracy would continue to churn out ruinous liberal policies.

To most of us it seems fairly self-evident: when the people elect a Republican they expect Republican policies to follow, and, surely, a Republican appointee is more likely to promote Republican policies than is a Democratic appointee. But, as the saying (often attributed to George Orwell) goes, There are some ideas so wrong that only a very intelligent person could believe in them. Well, there is no doubt former Massachusetts governor and presidential hopeful Mitt Romney is a very intelligent man who has fallen for some very wrong ideas. "He never asked me if I was a Democrat or a Republican and never asked most of the Cabinet members who came with me," said Romney cabinet member, Barbara Berke, in a July 2, 2007 New Republic article. We know the result. Romney, who now styles himself a conservative, gave us four years of typical Massachusetts liberalism from the corner office.

Out of all of Romney's policies in Massachusetts, the one that most haunts him as national candidate is his signature health care reform. Conservatives have dubbed it Romney-Care and have derided it as the gateway drug to Obama-Care. Last week, a group of extremely concerned citizens from a variety of walks of life filed the necessary paperwork with the Attorney General's office to give the voters of Massachusetts the chance to repeal the most onerous portion of the state's universal health care law, the individual mandate.

The ballot question, the creation of Massachusetts Citizens for Life (MCFL), is simple and compelling. It says: Individual Health Coverage will be stricken in its entirety so that no individual shall be required to purchase health insurance or be subjected to any penalty or sanction for declining to do so.

MCFL has launched a website, www.repeal-romneycare.com, to keep the public informed about their progress and to give groups the resources they need to help with this very important effort.

"We at Massachusetts Citizens for Life have worked very hard over the past two years to prevent and then defeat Obama-Care," said MCFL spokeswoman, Anne Fox. She continued, "Once Obama-Care is overturned, the rest of the country will be fine, but we in Massachusetts will still have to live under its prototype. Repealing the individual mandate is a start toward better health care in Massachusetts.'

Meanwhile, Mitt Romney is stuck defending an indefensible public policy. He can't repudiate it without further, and perhaps for his political life, fatally, cementing his disreputation as a flip-flopper. Poor Mitt Romney. Many a Republican has faltered because he failed to learn the lesson that personnel is policy. Romney may be the first to falter because he failed to understand that *policy* is policy.

The Art Connection has brought 27 original and unique art pieces to the Elder



Plan to Honor First Italian Police Officer **ANDREW B. CUNEO**

Mayor Menino and Police Commissioner Davis

Patrolman Andrew Cuneo was 44 years of age when he was appointed to the Boston Police Department on May 9, 1906, serving in Division 3, 6 and Division 1. Officer Cuneo was born in Genoa, Italy and was working in the North End of Boston in familiar territory. The morning of August 13, 1921 was a typical day of Duty for Officer Cuneo, but little did he know it would be his last.

Ex-Boston Police Officer

Philip F. Whelan, 39, was upset with the city, state and government and was a very bitter man. Earlier in the day he entered the pawn shop of Max Bloom which Street in the North End of Boston. Whelan asked the owner, Max Bloom, for a 38. caliber revolver that was in the display case, Bloom handed an H&R 38 caliber revolver to Whelan who then removed bullets from his pocket and loaded the weapon. Whelan then told Max Bloom that he would return later that night to pay for the gun. Mr. Bloom requested payment and Whelan had no intention of paying for the pistol. Max Bloom then told Whelan "I'll call the police" and Whelan exited the pawn shop with the pistol at his side. Max Bloom followed Whelan out of his store as Whelan started to walk towards Scolley Square, Bloom velled out "the man is carrying a gun." As Whelan walked down Hanover Street with the pis-



was located at 331 Hanover tol out he caused panic among the shoppers as they ran into shops and hid behind parked motor vehicles to get out of Whelan's way.

Mr. Tony Silver, who lived at 295 Hanover Street, ran to Division 1 located on Hanover Street at 12:00 pm and informed Duty Supervisor Sergeant Corcoran of what was happening. Officer Cuneo, who was in the guardroom at the time, overheard Mr. Silver's plea for help and told Sergeant Corcoran he would investigate the incident. Sergeant Corcoran rang the bell in the Station to summon more officers to assist Officer Officer Cuneo. Cuneo crossed the street in front of the station and heard loud talking coming from a store a few doors down. Officer Cuneo observed a man running towards him attempt-

ing to avoid someone. Whelan upon seeing Officer Cuneo raised his weapon towards Officer Cuneo, Officer Cuneo grabbed Whelan in a struggle for control of the weapon and they fell to the ground. Whelan was fighting to get away from Officer Cuneo who was attempting to get control of the revolver. At this time Sergeant Corcoran and Officers McGowan and Mayer observed from the Station what was going on and they raced to assist Officer Cuneo, Whelan saw the Officers approaching and managed to get control of the pistol and fired two shots into Officer Cuneo. Officer Cuneo fell to the Street mortally wounded. Whelan then turned the weapon towards Sergeant Corcoran, Officer McGowan and Mayer and fired two more shots; the bullets missed their intended targets.

Shoppers screamed and ran for cover as Whelan ran with the gun in his hand. Officer Dever, who heard the sound of gun fire, ran to the scene and observed Whelan running down the street attempting to get away. When Whelan saw Officer Dever he turned and fired one shot at him missing him. Officer Dever drew his Service revolver and fired four shots at Whelan. One of the bullets grazed his scalp the other three shots missed their intended mark. Officer Stengel came running to the scene from

THE BUDGET FINALLY PASSED

Congress passed a deal that would lift the debt ceiling in exchange for up to \$2.4 trillion in spending cuts. Activists on both sides didn't like the deal and it's not tied to the balanced budget amendment. "This is a bad deal for the economy, a bad deal for the middle-class and a bad deal for tackling our real long-term budget problems," said Justin Robin, executive director of a Tea Party group. Congress and the White House struggled for weeks to reach a deal that would avoid an August 2nd default. The House passed a deal on Monday and the Senate voted on Tuesday. President Obama will get a hike in exchange for \$917 billion in spending cuts over the next 10 years. The \$917 billion will include \$741 billion in discretionary cuts, a \$20 billion in entitlement boosts and \$156 billion in debt service cuts. Under the budget office's baseline estimate spending will rise 4.8% a year in fiscal 2011-21 and discretionary spending will rise an average of 1.6% and consumer spending will rise 4.8% a year. Total outlays will rise with the entitle-Social Security, Medicare, veterans program

and military pay would be The report was the latest exempt. to show the economy is

Consumers closed their wallets in June as income barely budged. The Commerce Department reported that consumer spending fell 2% in June, July versus May, the first drop in two years, often being up 1% the month before. Income rose 1% in time with forecasts. The weak job market continued to weigh on income spending but government support for the consumer, also waning. Consumers are struggling as they pay more to fill up their gas tanks but new tax relief and other taxes go up as tax payments were up an average of \$66 billion versus December, as states hike taxes to balance budgets and personal taxes remain \$200 billion below their level in 2007 when the recession began. The decline in factory orders unexpected rise in layoffs, cast doubts on the recovery. The U.S service sector grew at the slowest pace in 17 months in July and showed sign that the world's biggest economy is sputtering. "The economy slowed more than expected in July," said Mark Vitner, senior economist at Wells Fargo. Wall Street had envisioned a rise to \$51.7.

to show the economy is slowing at the start of the 3rd quarter, and risk of a recession has increased. Mark Vitner, economist at Wells Fargo, says the economy will pick up in the 4th quarter as gasoline prices ease and disruptions from Japan's quake fade. IBM's new orders slowed last month to a 23 month low of \$51.7 and the job gauge sank 1.6 points to a 23 month low of 51.7. Export orders fell 8 points. The job report showed evidence that the recovery has slowed. Friday's jobs report rose by 82,000 last month, well below the pace expected to cut the employment rate which is still holding a 9.2%. The Federal Reserve isn't expected to initiate a 3rd round of easing which would boost the price of oil and commodities contributing to the economic slowdown. Another round of easing will do more harm than good. Lately the dollar has stabilized and energy prices have stabilized and fell quite a bit. That will reduce inflation and support better consumer spending. Businesses are already cash rich, with unemployment may stay around 9% up to election time next year.



"While There is Tea There is Hope"

There's still a store at the corner but back in 1773 it was the Salutation Tavern which probably explains all the war paint.

However, as I looked at the message on the t-shirt, I thought of the current political atmosphere and the Tea Party movement today across America and up on Capitol Hill where some 78 Tea Party Republicans elected last year are standing up to the principle of smaller government, spending cuts and fewer taxes.

Today, the liberals in government, the liberal news media and especially MSNBC, have tried to frame the clash between left and right as a battle between responsible liberals and the radical "burn and slash" right wing. To tell you the truth, at least these conservatives hold to their principles. Liberals love calling themselves "centrists" but these folks are principleless. They pretend to be moderates when they are not. The political center of the Republicans is slight to the right of the political spectrum, but the center for Democrats is actually nowhere near the center. These folks are the real extremists. It is their way or the highway.

The recent battle over raising the debt ceiling exposed who the Democratic leadership really is. None of them really hang out in the center and nor are they moderates on social policy. Did you watch President Obama looking foolish trying to hang on to reality? While the leadership in the House and Senate, Democrat and Republican alike were trying to lead, the president looked like a bystander pretending to be doing something. "While there is tea, there is hope." I truly think this quote is more relevant than ever before. Sometimes thinking from the past is the only way to see the future. When Paul Revere was watching that steeple for a light or two, he thought he was risking death for the cause of liberty. Sacrifices made for the greater cause of all. Today Americans are dying in Afghanistan and Iraq under great risks to life and limb. These young men and women in our armed forces put their lives on the line every day for that "tea" which makes us a free society.

I salute those trying to make government a source of pride both here and around the world. I salute those who believe we shouldn't be spending what we don't have. Each generation is a gift from the previous generation. It doesn't belong to us. Our job is to pass it on to the next generation in better shape than found.

As long as people believe in liberty and don't raise the white flag of surrender, we can survive. After all, despite what the liberals say, if we hold to our principles, we will never lose. While there is a tea mentality, there will always be hope. If we give up, we will forever be thirsty for our cup of freedom.



Saint Lawrence of Rome

Saint Lawrence was born in Osca Hispania, now modern day Spain, in the third century A.D. Lawrence was one of the seven deacons appointed by Pope Sixtus II who served in the Church of Rome by being placed in charge of the distribution of Church revenues to the poor. Lawrence, like Pope Sixtus II and many other members of the Roman clergy, was one of the victims of the persecutions of the Emperor Valerian. At the beginning of the month of August, 258, the Emperor issued an edict, commanding that all bishops, priests and deacons should immediately be put to death. The imperial command was immediately carried out in Rome. On August 6, Pope Sixtus II was apprehended in one of the catacombs and executed.



After the death of Sixtus, prefect demanded that Lawrence turn over the riches of the Church. Saint Ambrose writes that Lawrence asked for three days to gather together the property[1]. Lawrence worked swiftly to distribute as much Church property to the poor as possible so as to prevent it from being seized by the prefect. On the third day, Lawrence

appeared before the prefect at the head of a small delegation when ordered to give up the treasures of the Church. He presented the poor, the crippled, the blind and the suffering and said that these were the true treasures of the Church. This act of defiance led directly to his martyrdom.

Saint Lawrence is often represented with the gridiron on which tradition relates he was roasted to death. He was martyred on August 10, 258 in Rome. Saint Lawrence was sentenced at San Lorenzo in Miranda, martyred at San Lorenzo in Panisperna and buried in the Via Tiburtina in the Catacomb of Cyriaca. Tradition holds that Lawrence was burned or "grilled" to death, hence his association with the gridiron. Tradition also relates that Lawrence, while he was burning on the gridiron, asked his torturers to "turn me over ... I'm done on this side." Pope Damasus built a basilica in Rome which he dedicated to St. Lawrence; this is the church now known as that of San Lorenzo in Damaso. The church of San Lorenzo in Lucina, also dedicated to this saint, still exists. The feast day of St. Lawrence is celebrated on August 10th; he is the Patron of the Poor.

students recently learned that the BPS is considering relocating BLA to Hyde Park High School, thereby freeing up BLA's building at 205 Townsend Street for the Boston Arts Academy. While on its face this may sound like "opportunity," it surely is not. Hyde Park High School cannot accommodate the current enrollment of 1,750 BLA students, nor can it offer students the amenities they currently enjoy, such as the outdoor classroom and easy access to cultural centers and athletic facilities. 



Vegetable Medley

2 medium potatoes 1/2 pound fresh, frozen or

- canned string or cut beans
- 1 large garlic clove 1 medium zucchini sliced
- (1/2-inch pieces) not peeled
- 1 medium yellow squash sliced (1/2-inch pieces) not
- 2 large ripe tomatoes or a four-ounce portion crushed tomatoes
- 1/3 cup olive oil
- 1 chopped medium onion 1 tablespoon capers
- 3/4 tablespoon basil
- Salt

In a saucepan, sauté onion and capers in oil until opaque. Add chopped ripened tomatoes or four ounces of crushed tomatoes. If you prefer a heavier sauce, use a four-ounce can tomato sauce instead. Add fresh or dried basil. Stir, cover and simmer slowly. Meanwhile, peel and cube potatoes. Wash and set aside. If using fresh string beans, cut ends off, wash and set aside. Add potatoes and beans to saucepan. Stir, cover and simmer slowly for ten minutes. Add sliced zucchini and yellow squash (optional). Salt to taste. Add water if more liquid is desired and bring to a boil. Cover and simmer slowly until all vegetables are tender. Serve with garlic bread.

Serves two.

NOTE: For those who enjoy rice or pasta, prepare your preferred rice or macaroni according to directions on the package. Serve a portion topped with the vegetable medley. Sprinkle with your grated cheese of choice.

The proposed ban of passthrough hazmat trucks by the City of Boston is based on a comprehensive public safety study recently completed by the highly regarded Battelle Memorial Institute. The data and analysis decisively concludes that hazmat trucks traveling through downtown Boston, including the North End/Waterfront, present a public safety risk more than twice that of using the highways around Boston.



Nanna & Babbononno

A Nostalgic Remembrance



Norwich, New York, a city that is between Syracuse and Albany and reachable via state roads 12 or 23. Well, back in the day, Dad played for the Chet Nelson Orchestra during the summer, and from the end of June to the Labor Day weekend, they worked the county fairs throughout the northeast. This week, the 9th through the 14th, is the time slot for this year's Norwich Chenango County Fair.

Dad loved to play the county fairs during the summer months. They were fun, profitable and you got to see a good portion of rural America that, otherwise, was left to the locals. Of course, Mom and I went with him when we could. At times, Nanna and Babbononno came along. This was my parents attempt to get them away from the city during part of the summer. If it wasn't for my father insisting they come along, they would never have had a vacation. Beginning around 1955, things changed a little. Dad bought the cottage on Lake Maranacook in Winthrop, Maine and the family headed there in August, minus Dad when it was time to play at a county fair somewhere. But this was the early 1950s, and Mom, Dad, Nanna, Babbononno and I piled into Dad's 1949 Chevy and headed for New York state.

For these outside fair grounds, Dad played tuba, not bass. This meant that there was more room in the car for everyone's stuff: the tuba (or maybe his Sousaphone), suitcases with clothes, a portable charcoal burner, a Coleman gas stove, a Coca Cola ice chest filled with everything Italian that had to be refrigerated, a garment bag with Dad's band uniforms, jugs of homemade wine that Babbononno insisted upon and a couple of cardboard boxes with things my family might need in the wilderness of rural New York.

fairgrounds, Dad had a Babbononno had stashed meeting to attend, and when everything Italian that he he returned to us, he said that we were staying at the home of a man named Will Northrup. It seemed that the Northrups, a retired couple, had a large home and rented out rooms to help make ends meet. Will Northrup was wheelchair bound, but he and Babbononno hit it off Boston usually had the con-

You've never heard of immediately due to Babbononno's homemade wine, if you get my drift.

Most of the rural fairs were held at designated fair grounds, with buildings that could house prize animals that were put on display by local farmers, or 4H Club members showing the produce grown in the area, advertising the latest in farm implements and machinery and selling just about anything that was homemade or grown. Each of these fair grounds had a race track with a grandstand on the outside of the center of the track and a stage on the inside of the track. During the day, people in the grandstand were treated to horse pulling contests, sulky races, dare devil car drivers, a couple of the entertainers that appeared on the night time venue and a few selections from Chet Nelson's band with Dad on tuba. All of the entertainment was conducted between the races, rain or shine.

After Dad got settled into his routine, he invited Mr. and Mrs. Northrup to be his guests at the fair. They hadn't been to it in years, as Will Northrup had been in a wheelchair for quite a while. Dad made all the arrangements, and they had one heck of an afternoon for themselves. After that point in time, Mrs. Northrup insisted on making breakfast for us. None of us were used to country style breakfasts which, to these New York folks, consisted of oatmeal, fried eggs, buckwheat pan cakes, home cured bacon, American style sausages, homemade white bread with fresh churned butter and black coffee with fresh cow's milk on the side. This was the type of meal that, once eaten, you might get hungry four or five days later.

Lunch and dinner were usually eaten at the many food areas at the fairgrounds. Most of it was wholesome. Most of it was good tasting. All of it was American. Thank God Dad brought the When we arrived at the Coca-Cola ice chest where assumed we wouldn't find in rural America.

I even worked during many of the county fairs. For the shows held at night on the stage across from the grandstand, they needed many scenery changes. A scenery man from South

tract, and he was the man I worked for. He was an Irishman named Louie who chewed cigars, day and night. He taught me how to be a stage hand and paid me \$35.00 for the week to assist him; not bad for a young kid in the early '50s.

Dad's business partner in the music business was the trumpet player for the band, Barney Mould. One day, it rained so hard that all of the afternoon entertainment was cancelled and we all sat at tables in a large staff tent that was located on the grass behind the stage. Barney, a tall heavy set red head, and Dad complained to each other about eating nothing but American food. Nanna, Babbononno and Mom agreed. Barney told Dad that he had heard of a Kosher delicatessen on the outskirts of Syracuse. That's all Dad had to hear. We made a dash for his car, piled in and headed for an establishment called "Benny Ginsberg's Kosher Deli." Don't ask me how, but we found it and ran inside dodging the rain drops. The smell reminded me of the delis in Chelsea when I was a kid. The only smell that was better to my nostrils was an Italian grocery store, but I didn't want to offend anyone so I kept my mouth shut.

We looked around for several minutes until Dad appeared with Mr. Ginsberg, the owner. Dad told him that Barney was a Cantor at a temple in Boston, and if he gave us good prices, maybe Barney would sing a couple of religious songs for him. Barney obliged and the bill was cut in half. That afternoon, we pigged out on pastrami, Jewish hard salami, corned beef, homemade coleslaw, half sour pickles and tomatoes and a few other Jewish delicacies. Babononno told everyone that the food wasn't Italian, but it was just as good. We took what we didn't eat and put it in Dad's Coke chest for a future lunch.

Babbononno hit it off with the leader of a dog act that was one of the features of the fair that year. His name was Johnnie Laddie and he was from Foggia where Babbononno was born. At night, after the show, they talked about the Old Country in their own dialect, drank Babbononno's wine and patted the dogs. We became friendly with a twoman pantomime act called the Bryants. They both had numbers tattooed on their left arms. They were survivors of a Nazi concentration camp and had put their act together years earlier to entertain the other inmates.

This was how I spent part of my youth during the summers of the late '40s through the mid '50s, and I wouldn't swap those memories for all the millions I never made.

Cross Street and fired five shots at Whelan. One of the five shots struck Whelan in the leg causing him to fall to the pavement. Whelan then attempted to reload his pistol, but Sergeant Corcoran, Officer Hafner, Dever, Stengel and Kavainugh were able to hold him down and arrest him, not without a violent struggle.

Officers McGowan, Mayer and Curry rushed Officer Cuneo to the Haymarket Relief Hospital where Doctor Breslin pronounced Officer Andrew B. Cuneo dead upon arrival. Whelan was charged with the murder of Officer Cuneo and arraigned in the Municipal Court before Judge Dowd. Officer Cuneo was married and the father of nine children. Patrolman Andrew B. Cuneo was buried in St. Michaels Cemetery, Roslindale, MA. Officer Andrew B. Cuneo's name is on the National Law Enforcement Memorial in Washington, DC, Panel 7, East 6, along with the Massachusetts State Law Enforcement Memorial in Boston and at the Boston Police Memorial located at Boston Police headquarters.



SECRET RESTAURANTS OPERATE IN ITALY. A reservation can be made, as in a traditional restaurant, just to be in a home atmosphere! People enjoy eating in someone else's house, but after the coffee ending the meal, they get the bill. There are some advantages too: new friendships are made, but this "private eating luxury" occurs only a few evenings a month. Of course, there are no signs outside the building and no advertising. The location can be found on the internet or through friends. Once a place is located, people make a reservation through email, Facebook or a phone call. And the arrangement is complete! New and old customers are welcomed in these private homes or large apartments, which organize banquets on certain established dates for paying guests! The homes, centrally located, are beautiful and with a unique atmosphere. The bill is paid in cash. Nobody asks about the price of the full meal it would look far too cheap! The only expression generally used on the bill is "donation"! The guests are asked to follow an "ad hoc" protocol: to arrive on time, avoid finding excuses alleging "food allergies" at the last minute but always required to call in ahead of time.

These restaurants, tested first in America and in Northern Europe, are now booming in Italy. They have become popular, mostly due to the small number of guests at a seating. It seems that the routine style of eating out, to some people, is becoming quite annoying.

A new organization, HOMEFOOD.IT, operates from Piemonte to the Sicily regions, strongly competing with the traditional restaurants. Some hosts prepare elaborate meals for their guests, but the menu is standard for the date. Some of these eating places have created a private club with "private customers" who pay an association fee of 35 euro and are screened when they enter the home/restaurant. The "Cesarine" (female cooks), as opposed to the "Cesarini" (male cooks), are code-name nouns. In Milan, for example, a very active "secret" restaurant is the home of Oliviero Leti, a stage designer by profession, who has a living place with ten rooms, all furnished as a theatre set, who organizes brunches as well as dinners on Sundays, but by request only! In the City of Amsterdam, a place known as "Dine with the Dutch" offers a tasty dinner, complete with an antipasto all the way to sweets, for 50 euro (\$70) to tourists as well as to local residents. In Washington, D.C. the evenings become "party" time. The American organization "Hush," born in the mind of a member of the World Bank, has a list of 300 emails. The dinners cost \$50-\$75 and are held in private homes in Georgetown. The cook, after a few days, is happy over the great success of his place. In London there is a place, "The English Can Cook," managed by a photographer. Again, reservation to this place come via emails, but the number of 8-10 people is actually for only 5 people. If you travel through Europe you will find on the internet places in Denmark, ("Meet the Danes"), in Paris, France ("Hidden Kitchen"), in Berlin ("The Shy Chef"), in Lisbon ("Hush, Hush Garden") and in Barcelona ("KoKum"). Who is the Best Twin of All Time?

Minnesota Twins have been around since the 1962 expansion and have had some great players over the years; folks like Bert Blyleven who finally got into the Hall of Fame last year, Jim Kaat, a great starter in the Sixties, Kirby Puckett who was an All Star in 10 of 12 seasons and whose career ended when his sight disappeared and today's Joe Mauer who has led the majors in batting average three times and who won the NL MVP in 2009. He carries a .324 career average.

In my eyes the two top players in franchise history are Harmon Killerbrew and Rod Carew. Carew was an All-Star in each of his 12 seasons in Minnesota and had a .334 career average with the Twins. He led the AL in batting average a whooping seven times and most hits three times.

However, I believe it is Harmon Killerbrew, who started with the old Washington Senators before they moved to Minnesota and changed the team's name in 1962, who is the franchise's best all time player. 
