Despite a few disappointments here and there, the US Olympic Team has been, as expected, tremendously successful in Rio thus far. As of Wednesday afternoon, the US leads the medal count with 27 — ten ahead of closest competitor China, and almost double 3rd place Japan, which has won mostly bronze hardware. The US also leads in gold medals, with the powerful Swim Team contributing seven of the total ten so far. In fact, the Swim Team has won 18 of the 27 US medals collected to date. (Michael Phelps has a couple of those seven golds, and it has been reported that his career total of 21 gold medals exceeds the Summer Olympics gold medal total of 175 of the countries competing in Rio!) Meanwhile, the "Final Five" Women's Gymnastics Team (so named because it is coordinator Márta Károlyi's last Olympics and also because the teams will be reduced to four gymnasts in the next Summer Olympics) has won the Team gold and is poised to rack up a few Individual golds this week. GO USA!



Stirpe Nostra

THE ROMAN THEATERS

The Roman Theater, adapted from the Greek design, was partly hollowed out of the ground and partly built up of masonry. Both Greek and Roman theaters were built in the half round, or semicircular in plan. Some of the very early Greek theaters utilized built-up bleachers for the spectators. Many people were injured when one of these bleachers collapsed, consequently all future theaters were hollowed out of the hillside whenever possible. All were open to the air with no roofs and intended for daytime use. The stone seats were neatly arranged in tiers with aisles and cross aisles.

The stage and backgrounds were permanently constructed. The Greeks called the background, the skene, the Romans called it the scena, and here in the U.S.A. we call it the scene. The Greeks called the part of the stage in front of the curtain, the proskenion, the Romans called it the proscena, and here in the U.S.A. we call it the proscenium.

The section directly in front of the stage was called the orchestra and reserved for senators and other dignitaries. The general spectator section was called the auditorium. The Romans built long corridors under the auditorium to be used as a shelter in case of sudden show-

ers. The Greeks had no shelters and this is probably the reason why they became such good runners.

There were two Roman theaters that are worthy of mention at this time. The first is the Theater of Marcellus, the only ancient theater in Rome. It is said to have been started by Julius Caesar, but completed by Augustus in 13 A.D., and named in honor of his nephew. The theater could accommodate 12,000 spectators. It is now in a ruinous condition, but at one time its beauty and proportions were a source of inspiration to artists.

The second is the Theater of Pompey, completed about 52 B.C. We remember Pompey as being a great Roman general, statesman, and member of the First Triumvirate. Parts of the foundations are all that remain of the theater. It was used for over 600 years, and the outer walls remained unbroken up to the 16th century. It occupied an area of about three acres and had a seating capacity of 25,000. A theatrical performance often lasted all day long. At one performance, 500 lions were presented. At other times, they featured elephants, crocodiles, and hippopotami.

To compliment the theater, Pompey built a great porticus

(covered walkway supported by beautiful columns). It consisted of several parallel colonnades with flower gardens, tree-lined walks, fountains, pictures, and statues of marble and bronze. The area was open on all sides to the public, and at once became a favorite spot for Roman idlers. In addition to these buildings, Pompey also built a building for the Roman Senate to use while awaiting the rebuilding of their own Curia, which was destroyed by fire. This new building was called "Pompey's Senate-House."

And now the bitter irony of fate. Pompey's buildings were built solid enough to last for 20 centuries, completed at the expense and for the enhancement of one man. Just four years later his army was defeated by Caesar, and Pompey died almost alone on a desolate Egyptian seacoast. Four years after Pompey's death, Caesar himself lay dead in Pompey's Senate-House, murdered by those 23 Roman citizens ... "Et tu Brute."

Save the North End Nursing Home

Dear Editor,

I find the open letter from the president of Spaulding (Mr. David Storto) to be disconcerting.

He claims that this facility, along with the West Roxbury facility, is no longer structurally capable of providing the quality of care that Spaulding prides themselves in to future patients and residents of these communities.

He illustrates this with the alleged lack of ADA-accessible bathrooms and claiming that mechanical problems with the HVAC system and elevators are just simply not feasible to repair and maintain.

The lack of treatment and administrative space was also factored into the decision to close the North End facility.

Mr. Storto claims that Partners had considered many facility options over the years which included renovating the North End building, but unfortunately it was just not a viable alternative.

The Spaulding North End facility was named among the best nursing homes in Massachusetts in 2010 by U.S. News & World Report. They also received a "5-star rating" from the Centers for Medicare (CMS) and a "100% deficiency-free survey in 2011" by Massachusetts Department of Public Health (DPH). They boast about this on their website. Could these accreditations have taken place in a facility which Partners claims to be obsolete?

Mr. Storto's open letter states that the safety of their patients and their families is Partners' highest priority. Has safety not been a priority while they have operated under these deteriorating conditions for years? What were the many facility options? Who was engaged or part of the discussions and resolution process over the years? What options were not viable?

I fully understand the goal of provider consolidation, and realize that this is the way that healthcare providers are going to have to compensate for "federal patient protection and the affordable care act," which is looking for \$500 billion in savings over the next decade to help pay for extending coverage to 32 million uninsured Americans.

Healthcare providers have to increase revenue to absorb this cost over the next decade, and consolidating and monopolizing is the recipe. The bottom line is they are just too powerful to stop and this exploitation of consumers is what we have to look forward to.

Let's face it, this is a business that every consumer loathes. At no time in our lives do we like to be at the mercy of others, but unfortunately everyone gets a turn. Just remember that!!!!!!!!

Partners may be a monopoly, but someday those decisionmakers will need the very same care that is being removed from our community.

Unfortunately things do not resonate until they happen to you.

L'Anno Bello: A Year in Italian Folklore

Enjoying Italy's Premiere Summer Holiday

There is no use hiding it anymore: autumn is coming. The signs of the changing season pulsate all around me. The evenings fall earlier, a dusky blue mantel of sky covering the Earth, and the air feels crisper as well. The earliest crop of apples has arrived at markets, and I cannot wait to enjoy this succulent fruit in cakes, breads, crisps and as a simple snack. Even Halloween decorations, smiling pumpkins and arched black cats, begin to wink from store shelves amidst all the notebooks and pencils of back-to-school sales. Although autumn is my favorite season, I am determined to hold on to the rest of the summer for as long as I can, until the school bell rings in September. After all, the days are still warm and the sun still bakes the Earth. Indeed, in Italy, summer vacation remains in full swing. The biggest summer holiday in Italy occurs on August 15th, though Italians extend the celebrations for several weeks before or after. For this feast, named Ferragosto, Italians leave the cities en masse to spend time at the beach or mountains. Caught between the heat and idleness of summer and the rhythmic nature of fall, Ferragosto provides Italy with one last joyous blast of the vacation season.

Visiting Italy during August can sometimes resemble walking through the quiet remains of an ancient civilization. Tourists abound, of course, but many Italians have already escaped the scorching heat of cities and towns once August begins, embarking on their Ferragosto vacations until the holiday culminates on August 15th. I

remember the slightly eerie sensation of walking through Rome one August eleven years ago, and noticing the boardedup restaurants and theaters and shops. Meanwhile, the Italian coastline brims with colorful beach umbrellas and chic sunbathers, the sands chockablock with impromptu volleyball games and radios blaring the latest hits. Italians even exchange holiday greeting cards emblazoned with pictures of beach picnics and grinning suns. In small Italian villages, such as my father's home outside of Sulmona in Abruzzo, people celebrate Ferragosto with shady al fresco dinners, featuring the seasonal produce of zucchinis, tomatoes, peppers and herbs. This holiday has been important to Italians since ancient times. It hearkens back to the year 18 B.C., when the Emperor Augustus established the Feriae Augustae - Festivals of Augustus - in honor of his reign. Some historians suspect that Augustus' festivals replaced older holidays like the Vinalia rustica, which marked the grape harvest. For all of its modern trappings, therefore, Ferragosto remains a seasonal celebration honoring the freshair pleasures of summer and the harvest. August 15th holds another

August 15th holds another great significance in Italian culture: it is the feast day of the Assumption, or *L'Assunzione*. This religious holiday observes the Virgin Mary's physical and spiritual Ascent into Heaven. Italian villages and towns combine Ferragosto and *L'Assunzione* festivities by holding parades and processions where the statue of the Blessed Virgin

Mary is held aloft. In the medieval city of Siena, the famous Palio, or Renaissance horse race, occurs around this time. Around Europe, in fact, the Feast of the Assumption also serves as an important seasonal marker, heralding the start of the harvest. Armenian farmers bring freshly harvested grapes to church on the Sunday closest to the Assumption so that the priest may bless the fruit. In Poland, where the Virgin Mary of the Assumption is also known as the Blessed Mother of the Herbs, people gather herbs and have them blessed in church and later display those herbs around their homes for protection. I honor the harvest qualities of the Assumption by baking cheesy biscuits studded with chives; both the wheat and the herbs symbolize the bounty of Mother Earth. The pungent aroma and simple texture of these small breads remind me that August means far more than the end of summer; rather, it is a time to be thankful for the gifts of nature and to appreciate the cyclical changing of the seasons much as our ancestors did.

Therefore, August in Italy teaches us to live in the moment. Though we may be worried about the stress of the upcoming cold-weather months, the holiday of Ferragosto encourages us to seize the last few weeks of summer with fanfare and fun, enjoying the cool waters of the ocean or a picnic under the stars, surrounded by family and friends. Meanwhile, the Feast of the Assumption emphasizes the bountiful harvest that characterizes the late summer and fall, as well as the beauty of the changing seasons. So let us allow the lessons of these two holidays to permeate our lives, and carry the pleasures of August with us always.

P.S. Happy Birthday to my father Rocco Di Censo, who was born the day after Ferragosto. Daddy, I love you always!







Saint Felix of Cantalice

Felix da Cantalice was born on May 18, 1515, to poor peasant farmers in Cantalice, Italy, in the central Italian region of Lazio. Felix was the third of four sons born to Santi and Santa Porri. At about the age of ten, Felix was hired out first as a shepherd and later as a farm hand to a family at Citta Ducale. Until the age of twenty-eight he worked as a farm laborer and shepherd and developed the habit of praying while he worked. Toward the end of autumn 1543, Felix entered the newly founded Capuchin friars as a lay brother at the Citta Ducale friary in the municipality of Anticoli Corrado.

In 1547, he was sent to Rome where he was appointed quaestor (Alms Collector) of the Capuchin Friary of St. Bonaventure. His duty was to go about the region collecting alms to support the friars and their works of charity. Brother Felix spent the next 40 years begging alms to help in the friars' work of aiding the sick and the poor.

Brother Felix became a familiar sight, wandering barefoot through the streets of Rome, a



sack slung over his shoulder, knocking on doors to seek donations. He received permission from his superiors to help the needy, especially widows with many children. It is said that his begging sack was as bottomless as his heart. Brother Felix blessed all benefactors and all those he met with a humble "Deo Gratias!" (thanks be to God!), causing many to refer to him as "Brother Deo Gratias."

Felix was so successful in his work that during the famine of 1580, the political leader of

Rome asked the Capuchins if they would 'lend' Felix to them so he could collect food and provisions for the entire city. The Capuchins agreed and Felix embraced his new task.

He preached in the street, rebuked corrupt politicians and officials, and exhorted wastrels to stop leading dissolute lives. He also composed simple teaching canticles, and arranged for children to gather in groups singing to them as a way to teach them the catechism.

St. Philip Neri had a deep affection for Brother Felix whom he once proclaimed the greatest saint then living in the Church. When St. Charles Borromeo sought St. Philip's aid in drawing up the constitutions of his Oblates, St. Philip took him to St. Felix as the most competent adviser in such matters. Through it all, Felix kept his wonderful humility and simplicity. Acclaimed a Saint by the people of Rome immediately after his death, which occurred on May 18, 1587, Brother Felix was beatified by Pope Urban VIII in 1625, and canonized by Pope Clement XI in 1712. His Feast Day is celebrated on May 18th.





Adding some of their own flair to the festive procession were the Greater Boston Firefighters Pipe and Drum Corps. The Grand Procession ended with the traditional "Tug of War" (the back half won again) and the "Dance of 20 Men" to cheers from the grateful crowd.

Saint Agrippina Di Mineo was a beautiful blond princess who was unmercifully tortured to death by the Emperor Valerian in 256 AD. After her death, her body was taken from Rome to Mineo, Sicily, by three holy women; Bassa, Paula and Agatonica. The commoners were amazed by the lightweight fragranced body protected by angels and shielded by clouds. In the North End, it's 20 men that coordinate in a complex rhythm to keep the extremely heavy statue in the air. 

Lawrence Mayor to Present Key to the City to Renowned Artist and Lawrence Native,

Giovanni DeCunto



On Friday, September 2, 2016, Lawrence Mayor Dan Rivera will recognize renowned artist Giovanni DeCunto with a key to the City of Lawrence. The ceremony will take place on the first evening of the Feast of the Three Saints, Friday, September 2nd, at 8:15 pm at the main bandstand on Union and Common Streets.

Now considered one of the greatest Expressionist artists in the world, DeCunto grew up on Chestnut Street in Lawrence, and was the product of a very difficult home life in that Italian

neighborhood. More interested in art and sketching than school work, he attended 12 different schools in Lawrence over eight years.

Although very ill, Giovanni's father paid for art lessons for his son. He was so talented that the Mass College of Art offered him a scholarship. But Giovanni's mother would not permit him to attend art school so he ran away from home and lived for a time in an abandoned building in Lawrence. DeCunto attended night school to get his GED and finally did attend Mass College

of Art on a scholarship. He later received a scholarship to Boston University.

Giovanni went on to The University of Padua to further his artistic skills. It was in Padua that DeCunto began to paint with his hands rather than brushes, creating his own unique signature style. Soon in demand, Giovanni DeCunto's paintings were not only commissioned by MIT, the Fogg Museum, and the Smithsonian Institute, but he was also commissioned by Barbara Bush to paint the portrait of George Bush for the Bush Library.

Now the foremost Expressionist artist in the country, DeCunto has been commissioned to paint portraits of many famous celebrities, professional athletes, and politicians. His works are exhibited in major museums throughout the world, and he has recently opened a new gallery on Lewis Wharf in Boston. Although he has achieved worldwide fame, Giovanni has not forgotten his Lawrence roots. He is a spokesman for Lawrence-based New Balance, and his intent is to give back to the city that did not abandon him. DeCunto plans to present a painting to the City of Lawrence as a token of his appreciation later this

Over the years, only four individuals have received a key to the City of Lawrence, making this a significant honor bestowed on natives of Lawrence. Past recipients include Conductor Leonard Bernstein, rock musician Sully Urna of Godsmack, longtime local radio personality, Bruce Arnold, and former Lawrence DPW director, Ray DiFiore.





In his stage play on which the opera is based, Beaumarchais broached the topic of the class struggle between the Count and his servant on the eve of the French Revolution. However, only the brilliance with which Mozart captured the character of each and every figure made the work a classic: "Each one changes, is changed, ground, threshed, torn apart and sewn back together again, until he finally stands before himself as himself and, astonished and rejoicing, finds himself again as a completely new person," says Sven-Eric Bechtolf, who has set his production in the 1930s, thus bringing the plot closer to our own time





Recipes from the Homeland

Broiled or Baked HADDOCK ALLA SICILIANA Broiled Haddock Sicilian Style

- 1 pound haddock fillet
- 1 medium onion
- 1 large chopped garlic clove or
- garlic powder 2 fresh tomatoes
- 1 tablespoon oregano flakes
- 1 or 2 tablespoons grated Romano cheese (optional)
- 2 tablespoons olive, canola, or vegetable oil
- Salt and pepper

Spread some oil on bottom of a broiling tray or baking pan. Place haddock fillet skin down on tray or baking pan. Cut tomatoes into 1/4-inch slices and place over haddock fillet. Cut onion in 1/4-inch slices and layer over tomato. Sprinkle oregano, salt and pepper to taste over onion. Spread chopped garlic, or garlic powder, over contents. (Optional) sprinkle grated cheese over contents. Next, sprinkle oil of choice over all. Cover and place at least two inches below broiling coils. Broil for about fifteen minutes. Remove from broiler. If dry, add a small amount of water. Cover and return to broil for about ten minutes. Remove from oven. Baste haddock with the liquids that accumulate in the broiling tray or baking pan. Return uncovered and brown onions and tomato. Check frequently to prevent burning or drying out.

*Cooking time for the haddock fillet depends on the thickness

NOTE: When Mama prepared this meal, I remember enjoying the fragrances of garlic, tomato, oregano and broiling fish that spread throughout the kitchen. Mama liked adding some Romano grated cheese occasionally over the contents. She referred to this meal as "Haddock alla Pizzaiola."

As the haddock cooked, I checked to be sure that we had plenty of bread available at home. I enjoyed dunking my bread in the juices while eating the broiled fish, and I still do.

A Nostalgic Remembrance



Last week, I left off meeting the owner of a hotel in Cassino. His place had the only swimming pool in the town and we were invited to spend the next day as his guests. I kind of knew why we were invited. The owner had lived in the States for many years and welcomed us so that he would have people to speak English with. Sal, Jose, Franny and I accepted the offer, and the next day we showed up at the hotel with bathing suits and towels. The owner, whose name I seem to have forgotten, treated us like foreign dignitaries. He had a cabana and lounge chairs set up for us and a table on wheels with all kinds of munchies for us to pick on. I whispered to Sal that it was a good thing we had brought along a bottle of Crown Royal that I had picked up in Naples for just this type of an occasion. We gave it to the hotel owner as a gift. When he opened the box and saw the velvet bag the bottle was housed in, he smiled from ear to ear, stating, "I used to drink this in Chicago, but can only get it when I go to Naples or Rome." We spent a wonderful afternoon discussing the hotel owner's life in the United States which ended with his deportation, which we didn't discuss.

For a fee, locals could spend a day at the hotel's pool and there were a few young locals enjoying the experience as well. About an hour into our stay, one of the locals hopped over to where the owner was sitting and complained that one of the pool patrons had just punched him in the nose. His face was red and his nose was bleeding. The owner accompanied the injured young man to where a few other locals were sitting. When confronted, another young man admitted that he had hit the injured man. When asked why, he accused the man with the still bleeding nose of trying to pick up his wife using suggestive language in the process. When confronted by the hotel owner, the victim admitted his guilt, adding in the excuse that he thought she was a single girl on the make. The next thing I saw made me laugh. The hotel owner grabbed the still bleeding young man by the ear and formed me that the best choice dragged him away from the pool. He asked an attendant to gather up the man's belongings and then threw them and the

still bleeding young man off of his property, telling him that if he ever returned, other parts of his body would be bleeding worse than his nose. The owner smiled back at my crowd and said in English, "That's the way we did things back in Chicago!"

Toward the end of the week, it was time to head out again. I had made the only reservation of the entire trip for hotel rooms in Rome. I anticipated that Rome, like most big cities, would be crowded during tourist season and hotel reservations would save us from having to hunt for a place to stay. Once there, my rationale would prove to be correct. Rome was packed with tourists from all over the world.

Well, it was soon time to leave

Cassino. A dinner was planned for Sal, Jose, Franny and me just so we wouldn't be hungry on our way north. A shopping bag filled with supplementary food was added, just in case. We said goodbye to Franny's family. Her Uncle Emilio and I hugged and he cried due to our departure. Even Cesare the pig left his place in front of the barn to join us in our goodbyes. And, soon, we were on the road to Rome. I headed back out to the coastal highway and then north toward the Eternal City. Following Jose's map of Rome, I found the main train station and the Piazza Indipendenzia, which is where it was located. Angling out of the piazza was Via Nazionale which headed to the geographical center of Rome. Following the map to a side street, I found the hotel we were to stay at. When we stopped at the hotel, I discovered something I didn't know. Each floor of the building was a different hotel, and each catered to people from different countries. The Hotel Cristina catered to Italians and was on the 3rd floor of the building. The rest of the floors were for tourists from other European countries, and just riding up and down on the elevators was quite an international experience.

Jose stayed with the car as we checked in as there was no parking in front of the hotel and no garage nearby. (Welcome to the big city.) The concierge inwould be to give my car back to the rental agency and give them a date when I wanted one back to leave town. He also informed

us that Roman public transportation could take us anywhere we wanted to go. It all sounded like a plan and I left my compatriots to sign in and do whatever while I returned the car to the Maggiore Rental Agency which was located at the main train station that I mentioned earlier.

I found my way back to the Piazza Indipendenzia and located the Maggiore Agency.

I returned the car with the stipulation that, three weeks from that date, they would have a four-door FIAT waiting for us. Just as I was finishing the paperwork, I heard someone yell, "Hey, Johnny Christy, is that you?" (That was, and is, my stage name.) I turned to see an old friend from Hollywood, Bill Levett. Bill was a character actor I had known at Paramount Studios. I had not seen him since running into him and his wife in Caracas, Venezuela, two years earlier. His wife, Ruki, was doing a commercial being filmed on the French Riviera, and they were renting a car to head there.

After the pleasantries, I explained my rationale regarding turning in the car. Just as I finished, Bill gave me food for thought. A stuntman friend of his owned a full sized American car that he would rent out and chauffeur when he wasn't working as an actor. Bill explained that there was almost no work during the summer, and if I was interested, he would call his friend to give me a price on taking us around. I told him I was interested and we headed to a pay phone. The next thing I knew, I had a Chevy four-door and a chauffeur at my disposal. The price was right and split three ways, wouldn't be much of a burden to Sal, Jose or myself.

When I was back at the hotel, I saw that it was 6:00 o'clock Rome time, meaning that it was 12:00 noon in Boston. I decided to call home and let the folks know that we had arrived in Rome without any issues. Mom and Babbononno were there having lunch when I called. I assured my mother that things were great and that there were no problems. Then, Babbononno got on the line to tell me where to go in Rome. I told him what little I had seen up to that point, but he had to play tour guide. The only problem was that Babbononno had left Italy in 1896, and it was 1972 in Rome. When I described what we saw as we entered the Eternal City, he velled back, "Stupid, you're in Spain, not Italy. You made a mistake. You went the wrong way." (Stupido, andatu a Spagna, no Italia. Tu fattu un spaglio. Tu fattu il modo spagliato.)

Rome had changed a bit since Babbononno's day there, but that's a story for next week.

The Case of Barney and Betty Hill



Barney and Betty Hill, a New Hampshire couple who would start the mid-20th century flying saucer craze.

On the night of September 19, 1961, Betty and Barney Hill of Portsmouth, New Hampshire, were allegedly abducted by a UFO they encountered near Lancaster. Their story would become the most famous case of alien abduction and the original source of fascination for UFO enthusiasts. Barney died less than a decade after the encounter, but Betty kept the story and her passion for extraterrestrial life alive for more than forty years afterwards. Ironically, it is Betty's near fanaticism on the subject that hurt her credibility.

By now, the story is well known. The Hills were returning from a vacation in Montreal when, in the night sky, Betty observed a white star-like object moving in an upward direction. Pulling over near Twin Mountain, Barney got his own good look and, at first, took the object to be an airplane, a notion he soon dispelled when the object began descending toward him. The Hills ran back to their car and began driving toward Franconia Notch. However, the craft soon hovered above their vehicle, forcing Barney to stop and step out of the car. Here is where their story becomes a true test for even the most open-minded of researchers. Barney later recalled that at this point, he observed humanoids in black caps coming toward them in an apparent attempt to abduct them. The couple drove away in what they described as semi-consciousness and by the time they were fully awake, they realized they had travelled nearly 35 miles south.

What exactly happened to the Hills has brought many speculations with no hope for a resolution in sight. What is

certain is that the rest of Betty's life would be devoted to UFO

Within days after the encounter, she contacted the U.S. Air Force and NICAP and not long after had an interview with New England astronomer Walter N. Webb.

Perhaps not surprisingly, Betty began experiencing many dreams about the abduction which revealed further details of their abductors. Barney was beginning to forget the encounter, and maybe even dismissing it as the result of a long drive, but agreed to undergo hypnosis to put Betty's mind to rest.

In 1963, the couple began their hypnosis session with Boston psychiatrist Benjamin Simon. Hypnosis drew out further details from both Barney and Betty but, in the end, Simon concluded that while he could not account for every detail the Hills described, the incident was simply a psychological aberration.

Even after Barnev's death in 1969, Betty stood by her story even as Simon started what would become a long line of navsavers.

If the Hills had indeed experienced a delusion, there are many ways to account for it. A few years prior to their alleged encounter, Betty's sister had told her of her own encounter with a UFO, maybe planting a seed of interest. It's important to remember too that pop culture in the early '60s had found a new fascination with alien visitors. And here is one of the most popular theories. As Martin Kottmeyer wrote in 1990, two weeks prior to Barney's recollection of the incident, an episode of TV's The Outer Limits



aired featuring extra-terrestrials closely resembling Barney's description of the aliens he saw.

"Wraparound eyes are an extreme rarity in science fiction films," Kottmeyer said. "I know of only one instance. They appeared on the alien of an episode of an old TV series, The Outer Limits, entitled "The Bellero Shield." A person familiar with Barney's sketch in The Interrupted Journey and the sketch done in collaboration with the artist David Baker will find a "frisson" of "déjà vu" creeping up his spine when seeing this episode. The resemblance is much abetted by an absence of ears, hair, and nose on both aliens. Could it be by chance? Consider this: Barney first described and drew the wraparound eyes during the hypnosis session dated February 22, 1964. The Bellero Shield was first broadcast on February 10, 1964. Only 12 days separate the two instances. If the identification is admitted, the commonness of wraparound eves in the abduction literature falls to cultural forces."

Meanwhile, novelist and New Hampshire resident Jim MacDonald wrote that what the Hills experienced was no more than the result of sleep deprivation. There is a third explanation, covered this time by Robert Sheaffer.

"I was present at the National UFO Conference in New York City in 1980, at which Betty presented some of the UFO photos she had taken," Sheaffer recalled. "She showed what must have been well over two hundred slides, mostly of blips, blurs, and blobs against a dark background. These were supposed to be UFOs coming in close, chasing her car, landing, etc.... After her talk had exceeded about twice its allotted time, Betty was literally jeered off the stage by what had been at first a very sympathetic audience. This incident, witnessed by many of UFOlogy's leaders and top activists, removed any lingering doubts about Betty's credibility - she had none. In 1995, Betty Hill wrote a self-published book, A Common Sense Approach to UFOs. It is filled with obviously delusional stories, such as seeing entire squadrons of UFOs in flight and a truck levitating above the freeway."

One may disagree with Sheaffer's take on both Betty Hill and her work, but one cannot easily discount the implication of his accusation which, given human nature, may be the most plausible. All too often we will believe whatever it takes to bring us fame and fortune. For Betty Hill it was a life as a pillar of UFO-ology.




The Nose of the Great John L.



A RAY OF HOPE OR A HOPE-FUL RAY? — Of all the news we've read concerning the offseason maneuvers by the Celtics, one of the most compelling to surface in recent days is the supposed interest that former C's star Ray Allen has expressed in returning to Boston.

The Boston Globe reported that Allen, who is now 41 and has not played since the conclusion of the 2013-2014 season, is "seriously considering a comeback."

Allen indicated that he had already spoken to representatives of the Celtics and the Milwaukee Bucks, two of his former teams. Allen played for the Celtics during the highly successful Doc Rivers era, when the Celtics won the 2008 NBA Championship and came within about six minutes of winning the 2010 title.

He averaged 16.5 points per game and 3.4 rebounds per game in the five seasons he played in the Hub (2007-2012). He then played two additional seasons with the Miami Heat.

While in Boston, he was best known for his shot from the corner, a trademark swish for three points. A graduate of UConn, he was always in tiptop shape and often used topics from college courses in discussions. We vividly remember one time during an interview session when he used scenes from ancient Greek classics as examples.

Being around Allen, one always had a feeling that his life could definitely be expanded after his playing days concluded. Even his nickname gave it away. In another era, Larry Bird's name in the locker room was Birdie. In the time of the new Big Three, Allen's teammates referred to him as Senator.

Our view on this possible comeback is that Allen should not attempt it. Yes, if he really wants to return to the NBA he probably can. Of the 30 NBA teams, some franchise would probably sign him up.

Even so, Allen has apparently set his sights on good teams where he has previously played.

But it's more than that. A team signing Allen would be getting a 41-year-old Ray Allen, not a younger man. That franchise would also be getting a player who has not faced NBA quality competition in a little over two years. That's another big question mark.

Then there's the issue of ego. Would Allen want to come back as a starter? How would he feel if he came back in a reserve role, only playing 15-16 minutes a game — or perhaps less than that?

In addition, there's the legacy issue. Allen left Boston as a star, a popular player with fans and media members alike, widely respected for his quality of play and personality. He was a classic representative of a classic franchise.

That's why we think it would be a mistake for him to return. It runs the risk of tarnishing a very positive legacy. Ray went out a winner in Boston. A return would probably mean an eventual exit below that standard.

As we all know, some fans and media members are fickle. We'd hate to see Allen being booed during a game or being the subject of negative articles and comments in print, broadcast and online media.

There's also the distinct possibility that he would play a secondary role, being relegated to a few minutes per contest or, perish the thought, being left on the bench for several games at a stretch.

We hope that Allen would decide not to return as a player and run the risk of tarnishing his memory and legacy. There are many other roles in basketball where he could experience success — being a coach or front office executive among them.

And, of course, there are many other roles in life outside of basketball, Senator Allen being a possibility among them. Let's hope Ray Allen keeps the positive memories of his basketball legacies untarnished as he moves on to another productive chapter in his life.

IN MEMORIAM — Remembering Bobby Thomson, who may well have hit baseball's most famous home run, on the sixth anniversary of his passing (August 16, 2010).

In the bottom of the ninth inning in the third game of a three-game playoff for the 1951 National League pennant, Thomson belted a three-run homer off Ralph Branca to give the New York Giants a stunning 5-4 victory over the Brooklyn Dodgers at the Polo Grounds.

The "shot heard 'round the world" capped an amazing stretch drive by the Giants, who trailed the first place Dodgers in the National League standings by 13½ games in mid-August.

While the moment is enduring, the actual excitement was tempered soon thereafter. The Giants advanced to the World Series to face the New York Yankees. The Yankees won the Series in six games for their third straight championship and 14th overall title. It was the last World Series for Joe DiMaggio and the first for rookies Mickey Mantle and Willie Mays.

A punch thrown at the noggin that did not land with accuracy on the jaw would very likely result in a broken or damaged hand, severe pain, and the inability to use the damaged fist for the remainder of the fight.

The way the old-timers dealt with this was by spending a

> lot of time grappling with one another and digging in blows to the body. Many of these bouts lasted for hours because a fighter would not take a chance on throwing a head shot until he felt he had his opponent worn down enough to line up a very accurate punch to the jaw. Also, the left jab, which lands with frequency upon the nose, was pretty much non-existent in those days.

> For all of their brawls, it is likely (I would say pretty definite judging by the photos), that neither man was hit on the nose very often. It is even more likely that neither of them ever

suffered a broken nose.

The advent of the gloved fist changed the sport of boxing dramatically and made it much more dangerous. I think Sul-
