# Hollywood Stars Ditching Hollywood for Austin

It appears Hollywood stars are saying good-bye to Hollywood and moving to live in Austin. Actors and actresses are headed to the southwest as fast as they can.

The Texas capital is in the midst of an economic boom only accelerated by the pandemic. Home prices are now rising down there. Tesla CEO Elon Musk is predicting Austin will become a modern-day BOOMTOWN and I'm not talking Rex Trailer either.

Musk himself is opening a Tesla factory just outside city limits.

Actor Matthew McConaughey who is considered by many to be Austin's unofficial brand ambassador said he saw this all coming saying, "I'm excited for the growth. We're not going back. We don't have a landmark like Niagara Falls of Disney World or the Eiffel Tower. They're coming for the vibe — we've got the people."

McConaughey said their challenge will be to preserve Austin's "soul" despite the influx from Hollywood. "What we have to watch in Austin is the preservation of our DNA."

#### Retired Ice Official Blasts Biden Over Border

A retired ICE official has announced he has left the agency out of frustration over Biden's border policies actually endangering our national security. Thomas Feeley, former ICE director in New York said the southern border is "wide open" and the crisis has grown "so bad" that illegals are being processed over the phone after being released into the U.S.

Feeley actually mentioned one incident where ICE wanted him to release a convicted arsonist because he hadn't been arrested in the last 10 years. He replied to higher ups that the reason he hasn't been arrested for so long was because he had been in prison for 12 years. He was basically told to cut him loose and they didn't care about his prison time.

Feeley apparently got fed up with fighting and arguing all the time over releasing bad people to the streets, so he decided it was time to move on after a 25-year career. Like Kenny Rogers, he had a choice, hold 'em or fold 'em and he decided it was time to hit the saddle.

#### Nicaraguan Police Raid Newspaper Office

Nicaraguan police have raided the offices of *La Prensa*, the opposition newspaper in that Central American dictatorship. The National Police said the raid was related to an investigation of wrong-doing on the part of the newspaper company. The paper actually was able to live stream the video of the raid in real time. The paper has been quite critical of the country's long-serving Sandinista president Danny Ortega.

#### Is COVID 99 Percent Survivable?

A "viral post" claiming COVID is 99 percent survivable for most age groups is "likely true," notes Robert Soave at Reason, yet social media flagged it as "misinformation" and PolitiFact rated it "false." In fact, "expert consensus" places "the death rate at below 1 percent" for most people. The post erred in comparing the vaccine's efficacy rate, 94 percent, to the COVID survivability rate; vaccines don't compete with natural immunity but "render COVID-19 even more mild and even more survivable."

Yet PolitiFact rated as false the very idea that COVID has a low infection fatality rate for most people." People can and should "improve their odds" by getting vaccinated - but "we don't need to live in fear."

# Bodies Fall from the Sky, but at Least there are No Mean Tweets

Twenty years, a trillion dollars, thousands dead, tens of thousands injured — and nothing accomplished. We leave Afghanistan the same as it was when we entered.

This past Monday President Biden addressed the nation to say he took responsibility for the debacle in Afghanistan, and then went on to blame everyone except himself.

He spent much of the time addressing a "straw man" argument, saying that those who say we should not be leaving are wrong. Who says we shouldn't be leaving Afghanistan? There are a few who say that our small presence there was preventing the situation from becoming even worse, that there had not been a U.S. death in combat there in a year-and-a-half, and that leaving will strengthen terrorists everywhere, who will be emboldened to conduct another 9/11-type attack. They may have some good points. However, Americans' shock over the images coming out of Afghanistan is not because the decision to leave is considered wrong. The majority of Americans of every political view agree that it is past time to leave. The shock is how badly Biden handled the withdraw. For many months, going back into the last Administration, we've known we were leaving soon. Biden had months to plan the action. What we saw on television last weekend suggests that no planning went into this operation.

This is a disaster of Biden's making. The Taliban will use this to recruit more soldiers to fight Americans everywhere in the world. Our allies such as Hong Kong and Taiwan will question our resolve to stand by our friends. The people of Afghanistan will suffer. Afghan translators and others who

helped us will die. Afghan women and girls will be treated as property, not persons.


Now, Biden needs to find some competent advisors to successfully finish the job of getting our people out. Let's see if he can do it. In that Monday speech Biden warned the Taliban, saying that "if they attack our personnel or disrupt our operation, the U.S. presence will be swift and the response will be swift and forceful." He further elaborated that the U.S. response could be up to, and including, refusal to use the Taliban's preferred pronouns, but he did take off the table more extreme actions such as tweeting mean words.

Speaking of tweets. Former President Trump is still banned from Twitter, while the spokesman for the Taliban in Afghanistan continues to use that platform to boast of their victory and recruit new soldiers.

**Ancient Roman ruins on Palatine Hill** 

Fundatories in Latin, fondatore in Italian, and founders in English. For hundreds of years, Rome was the undisputed mistress of the world. Whatever her greatness might have been, in architecture, painting, or religion, that greatness has left its mark here. The history of no other city in the world can compare with that of Eternal Rome.

The city state was an independent self-governing city and included the area around it that came under its protection and control. It was much like any large city in the U.S. including its suburbs. From a few hills covered with sheep droppings, Rome grew into a little town, then a walled city, and then into a city-state. In time Rome grew into the greatest governing empire the world had known and for centuries was not matched or exceeded until the time of the British Empire. The city was actually founded on those land rises that eventually became known as the "Seven Hills of Rome" named Capitoline, Aventine, Palatine, Esquiline, Quirinal, Viminal, and Coelian. These hills were occupied by vagrant tribes long before Romulus appeared on the scene. The tribes were savage hunters who wandered through the dense forests. From these tribes came "Vates," a soothsayer or prophet, and from the name Vates came "Vaticanus," for the name of the Hill that was made a kind of sacred spot a thousand years before St. Peter was born.

About the time of Vates, there also was a leader of an agricultural tribe who was known as Latinus and his people were called Latins. Their god was Saturn, the good sower.

There were also the Sabines, people of the lance (quiris), and from this name came "Ouirites" and eventually Quirinus the lance-bearer was the name given to their god Janus, and the name Quirinal was given to one of the Hills that they occupied.

Contemporary with all of this was the development of the Etruscan Race. They were savage in their religion and morals, but refined in their artistic tastes as the most-civilized of modern nations. They were tomb-builders and they built their tombs underground as chambers carved out of the tufa rock many, many years before the early Christians thought about the catacombs. The Etruscans cremated their dead, but buried images of them, so there is plenty of sculptural evidence of their culture. They also built walls, aqueducts and temples, and they made use of the principles of arched construction. The Etruscans are credited with the construction of the "Cloaca Maxima," a great arched drain under the area that was later selected for the Forum Romanum. This drain still carries storm water to the Tiber.

The Hills of Rome were occupied by tribes long before the time of Romulus, as noted above. Also, there were nine Romes before the Wall of Romulus was built, halfway up the Palatine Hill. The Etruscans were eventually conquered by people known as Romans, and it is with the construction of this Wall of Romulus, 27 centuries ago, that historical Rome began.

Why me?

**VESTED INTEREST**, with two school-aged children and nephews within the Revere School System, I, like many parents, experience first-hand how decisions that are made impact our children and the quality of education they are

I grew up in this city. I was a part of the first class to walk through the doors of the new Garfield Magnet School. It was a wonderful experience for me. I played on the Garfield Gators basketball team, mentored second-graders and made lasting friendships. As a kid,

school work was school work, you did what you had to do to get it done - looking forward to those subjects that caught your interest and getting through the classes that you weren't too keen on, but also, and arguably more important, it was a time filled with smiles and laughter. In retrospect, school was a happy time in my life and it is this experience and more that I want for my children, and for all children.

I am a 1996 graduate of Revere High School and former Patriot, having played basketball, field hockey, powderpuff and track and field. My involvement in extra-curricular activities ran the gamut from year-book committee to the Revere Interact Club, a junior rotary club under the Kiwanis. Like many of my former classmates, also now parents, there were countless formative experiences packed into those four years. I went on to study criminal justice at Northeastern until confronted with a reality check; I couldn't afford Northeastern, not even with having worked three jobs. I was fortunate enough that my experience at Northeastern had opened the door for me to land a job with the Board of Bar Overseers and later as an investigator with the Office of Bar Counsel, the state's licensing, ethics and disciplinary board for attorneys.

I worked during the day as I pursued an education. I took classes at Bunker Hill Community College and ultimately earned a bachelor's degree from UMASS Boston, graduating summa cum laude and was a recipient of the Distinction in Criminal Justice Award. I continued to work full-time and enrolled in the evening program at New England School of Law, where I earned the Black Judges Conference Award, a distinction in academic achievement. I passed the bar in 2008.

Today, I am a practicing civil litigation attorney. I have effectively represented clients before the Massachusetts Superior, Appellate and Federal courts, including Higher Education Law, Title VII of the Civil Rights Acts of 1964, Negligence,



Premises Liability, Personal Injury and Wrongful Death. I also conduct independent workplace investigations.

It is based on my personal experience and with my children in mind, that I wish to serve on the school committee. We should be doing more for our children by way of providing a variety of pathways and opportunities for success, and that is not going to look the same for each child. Not every child is going to gravitate towards academics. Some students will, however, prove talented in a skilled trade, technical or

in the vocational arena, all of which are areas that children should be exposed to and experience at some level early on in their educational career. This is an area for which I hold the utmost of importance and will strongly advocate, as a member of the school committee.

I am not a politician. I did not set out to become one. I am a parent and I see an area where I believe I can be effective in the positive shaping of our educational district. The Revere educational system provided me with a solid educational framework, combined with core values of respect, responsibility, kindness, and empathy that were instilled not only at home, but also by dedicated teachers with whom my path crossed. My experience is a testament to what our educational district is capable of. We have somehow veered from the days when families were establishing themselves in our city solely because their children would receive a supreme quality education, now with more parents opting to send their children to private schools. Our children are growing up in a world much more advanced, with resources literally at their fingertips and information being thrown at them hard and fast. It can be overwhelming for any one of us, but every decision that is made should be a decision that is reflective of that which is best for all of our children and that notion, that alone is my agenda.

I am a lifelong learner and truth seeker. I will listen. I will thoroughly educate myself on the topics at hand. I will review issues with a critical, open mind, one that is impervious to outside influences. I will do my job. ### L'Anno Bello: A Year in Italian Folklore

Keeping in Tune with the Seasonal Dance

The photos begin to inundate social media around this time of year: coffee shops advertising their wares with well-lit shots of cardboard cups stacked high with a frothy cloud of whipped cream and sprinkled with the reddish glitter of cinnamon, surrounded by the seasonal trappings of orange gourds. After all, the end of August means a plethora of announcements concerning the release dates of pumpkin spice lattes, the ne plus ultra of spicy fall drinks for java lovers. Pumpkin season is still fairly far-off, but these ads serve as yet another reminder that autumn, my favorite season, was quickly approaching. Indeed, I have lately been paying attention to the signs of the changing season all around me, from the prevalence of apples in the supermarket to the ever-so-slight hues of red and orange appearing on some leaves. When the days get too humid and sticky - which I am fine with at the beginning of summer but find unbearable when crafting lesson plans or setting up my classroom for the next school year — I think of the harvest decorations I continually see in stores, and shiver with excitement over the crisp days of fall. Observing the signs of the changing seasons not only helps me live in the moment by concentrating on the natural phenomena currently unfolding around me, but it links me in a powerful way to the actions and lives of my ancestors.

Tracking the seasons has been a passion of mine long before I started this column. While clearing out a drawer in my old room, my mother found an old notebook of mine in which I had been charting the natural signs of the changing seasons. For the shift

of a daisy, called a margherita in Italian, which would bloom in late September. I mentioned a gnarled tree whose leaves always turned a kaleidoscope of yellow and red a month early and floated to the ground well before the calendar turned to autumn. Baking an apple dessert, cool mornings, the color of the early twilight — all of these observations made it into that little notebook. Doing so helped me become a better observer of nature and of the excitement of life around me, and I hope to resume this sort of project again soon. Noticing and recording the shifting tide of the seasons actually has a scientific name. It is known as phenology, and naturalists often encourage people to sketch or write down their observations and then submit them in order to help scientists track climate data. Therefore, this hobby is both romantic and functional!

This pastime is apparently quite timeless as well. Our ancestors have been discerning the seasonal changes since time immemorial — not because they were eager for pumpkin spice lattes or photographing falling leaves, but rather because they operated in a primarily agricultural society where determining the right time to plant or harvest crops was invaluable to the survival of the community. In Italy, August functions as the month of the grain and hay harvest, and tightly rolled bundles of hay baking under the sun serve as one of the surest signs that autumn will soon descend upon the lovely Italian countryside. Italian farmers also examine their grapes during this month, ensuring they are getting the right amount of sunshine, water and shade to make them from summer to autumn, I wrote perfect for the vendemmia, or about witnessing my uncle and harvest, in September. After all, grandmother planting the bulbs grapes stand as an important

cultural symbol in Italy, for the grapes gathered in September will be processed into wine in November, ready to serve as the steadfast staple of Italian hospitality during the holidays and beyond. Finally, Italian farmers of yore frequently used saints' days as milestones for seasonal changes, a trait which is reflected in the proverbs still ubiquitous in Italian society to this day. August 24th is St. Bartholomew's Day, and the Italians repeat a proverb which declares: "A San Bartolomeo montagna mia bella ti abbandono." Translated, this dictum says that one should abandon the beautiful mountains after the Feast of St. Bartholomew, perhaps a reference to the cooler weather and the end of the vacation period. When we notice even the simplest transitions from one season to another, therefore, we are actually repeating the actions our forebears performed in order to carve out a living from the Earth.

As the bright days of summer give way to the cool nights of fall, I encourage everyone to keep track of the unfolding seasonal changes. These transitions do not have to be major, as even the tiniest details like a sip of apple cider or a yellow school bus can signal the start of an exciting new season. Let us become seasonal detectives, paying close attention to the evidence of nature's eternal cycle. By doing this, we become closely attuned to Mother Earth which has nourished us and our ancestors for so long, and we learn to live in the moment by understanding the natural beauty of the here and now. If we welcome every season with optimism and a healthy dose of respect, then the bounty of the Earth will love us in kind, no matter which latte we drink!

### Saint Maximilian Kolbe

Kolbe was born on January 8, 1894, in Zdunska Wola, Kingdom of Poland (then part of the Russian Empire).

He was the second son of Julius Kolbe and Maria Dabrowska. His father was an ethnic German, and his mother was Polish; he had four brothers. In 1914, his father was captured by the Russians and hanged for his part in fighting for an independent Poland.

When he was about ten years old, the Virgin appeared to him and offered him two symbolic crowns: the white crown of chastity and the red crown of martyrdom, Kolbe chose both. He entered the Franciscan Order at the age of sixteen.

In 1918, he was ordained a priest and continued his work of promoting Mary throughout Poland. Over the next several years, Kolbe took on publishing. He founded a monthly periodical titled, Rycerz Niepokalanej.

In 1936, Kolbe's poor health forced him to return home to Poland, and once the invasion by Germany began, he became

irreconcilable enemies in the depth of every soul: good and evil, sin and love. And what use are the victories on the battlefield if we are ourselves are defeated in our innermost personal selves? -St. Maximilian Kolbe

There are two

one of the only brothers to remain in the monastery. He opened a temporary hospital to aid those in need. When his town was captured, Kolbe was sent to prison but released three months later.

Kolbe refused to sign a document that would recognize him as a German citizen as a result of his German ancestry. He continued to work in his monastery, providing shelter

2,000 Jews from German persecution. After receiving permission to continue his religious publishing, Kolbe's monastery acted as a publishing house again and issued many anti-Nazi publications.

On February 17, 1941, the monastery was shut down: Kolbe was arrested by the German Gestapo and taken to the Pawiak prison. Three months later, he was transferred to Auschwitz.

for refugees — including hiding

Never abandoning his priesthood, Kolbe was a victim to severe violence and harassment. Toward the end of his second month in Auschwitz, men were chosen to face death by starvation to warn against escapes. Kolbe was not chosen, but volunteered to take the place of a man with a family.

It is said during the last days of his life Kolbe led prayers to Our Lady with the prisoners and remained calm. He was the last of the group to remain alive, after two weeks of dehydration and starvation. The guards gave him a lethal injection of carbolic acid. The stories tell that he raised his left arm and calmly awaited death.

St. Maximilian Kolbe died on August 14. 1941. He was Canonized by Pope John Paul II on October 10, 1982. The Feast Day of Saint Maximilian Kolbe is August 14<sup>th</sup>.



# Nanna & Babbononno

A Nostalgic Remembrance



Last Sunday, August the 15<sup>th</sup>, was an important date for me ... on that date in 1952; I became an usher at the Seville Theater. Wow, that was 69 years ago and I was 13 years old going into the 9th grade at the Barnes Junior High School in East Boston.

Two older neighborhood chums, Fred Cataldo and Joe Marotta, were working at both the Seville and Central Theaters, and I began hanging out with them during the day when they were doing maintenance at the Seville. One of the other ushers was leaving after enlisting in the Marines and it left a vacancy at the Seville. So, on Friday the 15th, I was fitted for an usher's uniform and assigned to begin my employment on that night.

James F. Ray was the manager and James Wall was his assistant. Mr. Wall handled the ushers and gave me the instructions as to what he expected from his ushers. He was ex-military and sounded like a drill sergeant in his approach, but I was eager and hoped for the best.

A few years earlier, I had told Babbononno I wanted to shine shoes in Central Square to make spending money. He, being the consummate furniture maker, made his only grandson a shoeshine box. There was a problem. Dad refused to let me shine shoes or sell newspapers on the streets of East Boston. Seeing I did not receive an allowance, I wanted to do something to make money. Dad had no problem with washing and waxing cars, so, I bought all of the necessities and washed and waxed cars to make money.

About a year after becoming an usher at the Seville, I sold my supplies and book of customers to one of my workers who was eager to take over. Between school, playing baseball, studying music with Babbononno and working at the theater, something had to go, and it was the washing of cars.

At the Seville, I was low man (kid) on the totem pole and the schedule they gave me proved it. I was assigned to the days and time slots that none of the other ushers wanted. Another thing, I had lied about my age. You had to be 16 years old to work there and you needed working papers issued by the state to make it legal. I was only 13. Each time Mr. Wall asked me if I had obtained the necessary documents, I gave him an excuse as to why I didn't. It got

to the point where I received an ultimatum from Wall, "Get the working papers or be gone." Just as the time ran out, Mr. Wall disappeared. I don't know if he was fired, retired or assigned to another theater. I heard all kinds of stories, but no one really knew. No one took Wall's spot and Mr. Ray, the manager, was the only person everyone employed at the theater had to answer to. Occasionally, he would ask me about my working papers and I would come up with an excuse each time. When I finally turned 16 three years later and obtained them, he seemed satisfied. What I would find out years later, Mr. Ray knew how old I was all along and just let it slide.

Not long after Mr. Wall left, the two neighborhood friends that got me the job were assigned permanently to the Central Theater, and Mr. Ray hired an older teenager to be the head usher. For about 2½ years, I took his abuse and dealt with the schedule I was given each week, again given the days and hours that no one else wanted. I tried complaining to Dad and Babbononno, but there reactions were, "Deal with it or quit." So, I dealt with it.

Not long after I turned 16 and had obtained my working papers, things changed. One evening, the stage manager, Dave Turner, told me and one of the candy girls that Mr. Ray wanted to speak to us in the office immediately. After we entered the office, Mr. Ray closed the door, glared at the two of us an announced that he had discovered that there was a conspiracy going on. The head usher, the ushers and all the candy girls were stealing money from the candy concession as well as some of the candy and selling it on the side. As Mr. Ray continued, the candy girl and I glanced at each other wondering what was in store for us. The boss immediately clarified things, "After my investigations, I discovered that you two were not involved. I fired all of the ushers and candy girls, so you two are now in charge" Pointing at us he continued, "Theresa, you are now the head candy girl. John, you are now the head usher. He opened the office door, and with a wave of the hand, shooed us out saving, "Now go hire some new candy girls and ushers." As we exited the office, Dave Turner, the stage

manager, was collecting tickets at the front door. He looked at us and smiled. I guess he and Mr. Ray had discussed the situation ahead of time, and he knew what the outcome would be.

I hired a half dozen or so young men and trained them to be ushers. Mr. Ray had me, and the new crew fitted for new uniforms, and we were back in business. After working out a few bugs, things went rather well. On Friday afternoons, Mr. Ray would drive me throughout the streets of East Boston with window cards to distribute. If a storeowner agreed to display a Seville window card with events listed for the forthcoming week, they would receive two theater passes. I always had a couple of extra passes for my personal use and would give them to friends. Two teen friends, who hung out at Orient Heights Square, were often the recipients of the passes ... singer Bobby Vincent and future baseball great Tony Conigliaro.

One evening, while I was sitting at the front door after the box office had closed, Dad walked in. He wasn't working that night and decided to take a walk. Just as he entered, Mr. Ray came out of the office. I was about to introduce him to my father, when they both smiled at each other with Mr. Ray saying, "Johnny Christie," and Dad saying, "Jimmy Ray." What I didn't know until then, was that Mr. Ray in his younger days, frequented the clubs Dad played in and they had become good friends.

Years later, I would find out that the new head candy girl and I would be the surrogate children of Mr. Ray. He was never married, a Boston Yankee by ethnicity and never showed his emotions outwardly. But, as I said, we were the kids he never had, and he loved us.

Both Dad and Babbononno both asked me a question as I was graduating college and still working at the Seville. They wanted to know what I learned through my years at the theater. I explained how I learned responsibility, developed management skills as head usher and commitment as an employee. They both said that, if that was the case, then it was worth it. I had the skills I would need to succeed for the rest of my life. I think they were right.

A typical breakfast or la colazione in Italy is much lighter and sweeter than the eggs and toast combinations accustomed to in this country. Many Italians start their day by visiting a local café or pasticceria where they tend to pick up the daily newspaper, order their favorite coffee and then choose a sweet pastry from the selection offered. You can enjoy a cappuccino and cornetto in Northern Italy or a granita and brioche in Sicily. However, if you really want to try something unique and absolutely scrumptious, I recommend visiting a coffee bar or pasticceria in Florence for a budino di riso, or rice pudding tart!

The budino di riso are traditional Tuscan pastries made with a sweet short crust shell and filled with a creamy custardy rice pudding mixture. It's highly unlikely you'll find them locally, so you may want to try and make them homemade. It requires making the pastry, rice, and custard, which can easily be prepared in one day, or the pastry and rice, can always be made the day ahead. With their buttery sweet crust, and creamy citrus vanilla rice pudding filling, Rice Pudding Tarts or Budino di Riso make delicious breakfast treats that are sure to be loved by adults and children alike!

#### RICE PUDDING TARTS Budino di Riso



#### SHORT CRUST

2 cups '00 or all-purpose flour 11 tablespoons cold butter, cut into small pieces

1 egg, room temperature

2 egg yolks, room temperature ½ cup and 1 tablespoon confectioners' sugar Zest of ½ organic orange

To make crust: place flour and butter in food processor, pulse until well combined/crumbly. Place mixture on a flour board and make a well in center. Add orange zest, confectioners' sugar, and eggs. Combine with hands until a soft dough forms. Wrap in plastic and refrigerate while making fillings.

 $2 \frac{1}{2}$  to  $2 \frac{3}{4}$  cups whole milk 1/4 cup granulated sugar Zest of 1 organic orange

Zest of 1 organic lemon 1 cup Arborio rice 1½ tablespoons butter

To make rice: add the milk, granulated sugar, and zest of orange and lemon to a medium saucepan. Heat over medium heat and as soon as the milk is hot, not boiling, add the rice. Lower the heat and cook the rice slowly for about 25 to 35 minutes, stirring occasionally to prevent it from sticking. Once the milk is absorbed (sometimes a bit extra is needed) and the rice is cooked well, remove the pan from the heat, add butter, stir together and set aside to cool.

1 ½ cups whole milk 3/4 cup granulated sugar Peel from 1/2 organic lemon ½ tablespoon pure vanilla

2 tablespoons cornstarch 1 ½ tablespoons 00' flour

1 egg 1 egg yolk

To make custard: place milk and peel of lemon in a medium saucepan, simmer until almost boiling. At the same time, in a medium bowl, beat together the eggs, sugar and vanilla. Sift in the cornstarch and flour. Remove pan of milk from stove, discard lemon peel and while whisking, add a little bit of the egg mixture to the milk. Place pan back on stove and over low to medium heat, continue to add the egg mixture, whisking while adding. Continue whisking for about 10 to 15 minutes or until custard thickens. Remove from heat, place custard in a heatproof bowl, cover with plastic wrap and allow to cool.

\* Additional confectioners' sugar for sifting

#### **ASSEMBLE**

Preheat oven to 350°. Remove dough from refrigerator and let sit 10 minutes before rolling. Grease and flour one 12 and one 6 cup muffin pan (can even use 18 tart shell molds). Place dough on a floured board and roll out to about an 1/8-inch thickness. Using a glass or round biscuit cutter, cut 18 circles from this dough. Place each circle of dough inside of a prepared muffin cup and with your hands press dough to evenly cover the inside of each cup.

Take the prepared custard and add it to the rice mixture, blend together well. Add by tablespoons at a time, evenly filling all the dough lined muffin cups. Bake for about 30 minutes or until light to golden brown or when the crust is cooked. Do not overcook or the rice will be dry. Cool to room temperature, generously sift with icing sugar and serve. Refrigerate leftovers.



late 1970s, standing 6-foot-8 and with a 100 mph fastball and that long stride of his toward home plate; he made most batters feel like he was right on top of them.

Pittsburgh Pirates slugger Dave Parker told Sports Illustrated back in 1978, "When (Richard) pushes off the mound, he looked like he was 10 feet away from you instead of 60. It causes you to learn a little bit and makes you think you have to swing the bat quicker."

Richard spent a short time in the minors and became a full-time Astros starting pitcher in 1975. Over the next four seasons, he won 74 games and led in strikeouts twice, 303 in 1978 and 313 in 1979. He had the lowest ERA in the NL in 1979 with a 2.71 ERA. He was also wild, lots wild. In 1976, he walked an incredible 151

He started off 1980 pitching pretty well but in mid-June he began feeling fatigue in his throwing arm but was still able to start that year's All-Star Game on July  $8^{th}$ .

In his next start, he seemed lethargic, felt sick to his stomach and had trouble reading signs from his catcher. After 3 1/3 innings, he left the game. At the time, he was 10-4 with a 1.90 ERA. Richards was then placed on the DL. On July 30th, while playing catch at the Astrodome, he felt a series of symptoms that added up to a stroke.

Richards actually recalled how weird he was feeling, lost his equilibrium and crashed into the Astro Turf. He was rushed to the hospital emergency room and underwent emergency surgery to remove a clot from the junction of two arteries in his neck.





Yes, indeed, Joe Thornton has come and gone a long way from that first sun-splashed day in September some 24 years ago when the members of the Boston media gathered at Ristuccia Arena in Wilmington and surrounded the number 1 pick in the 1997 NHL draft.

Picky they were, those writers and broadcasters, as they focused on whether the 18-year-old they had encircled was the pre-ordained savior of a franchise that had not won a Stanley Cup since the spring of 1972.

Looking on was a man whose name was synonymous with the Bruins, one who had worn the spoked B proudly across his chest for his entire professional life to that point — all-star defenseman Ray Bourque.

Eventually, over time both would depart. With his career running down, Bourque would ask to be traded, a request that was accommodated, allowing him to join the Colorado Avalanche and win his first and only Stanley Cup in 2001, his last season on the ice. There it was, his name etched onto the surface of the Cup for all time.

His triumphant return to the Hub with the Cup that spring and the ensuing lunchtime rally at Boston's City Hall Plaza was spectacular, with the assembled multitudes roaring in appreciation as Ray held high hockey's holiest hardware and exclaimed, "Everyone loves Raymond and Raymond loves you."

As far as the Bruins were concerned, it had been another underwhelming year, the B's having wrapped up their 2000-2001 regular season back on April 7<sup>th</sup> on Causeway Street with a 4-2 victory over the New York Islanders. It was a win that enabled them to conclude with a 36-30-8-8 regular season mark, good enough for 88 points, a fourth-place finish in the Northeast Division, but without a berth in the playoffs for the second year in a row.

For the fans present at City Hall Plaza, the proceedings in the Heart of the Hub that day in 2001 harkened back to an earlier time — to 1972 when the Cup was indeed theirs — a feeling that would not be fully experienced again for another decade — in 2011 when the Bruins defeated Vancouver for the title.

In contrast to Bourque, Joe Thornton would remain a hardworking member of the Bruins for only seven plus seasons — until November 30, 2005, when he would be traded away to the San Jose Sharks. It would be there — some 3,000 miles from the Hub — that he would hit his stride and remain a mainstay.

Even on the day he was traded, a little over three months after signing a new three-year \$20 million contract back in August, he was showing his potential — leading the team in scoring with 33 points through 24 games.

When he returned to the Garden with the Sharks a few weeks later on January  $10^{\rm th}$ , those stats earned through November  $30^{\rm th}$  still placed him atop all Bruins scorers, an unbelievable reality at the time. Consider: the leading scorer for the 2005-2006 Bruins at that point in the season was actually playing against the Bruins. He didn't play long, however. He left after three shifts, having been assessed a game misconduct in the first period of a contest the Sharks won, 6-2.

To this day, he remains the only player in NHL history to win the Art Ross Trophy (leading point producer in regular season) and the Hart Memorial Trophy (regular season MVP) while playing for two different teams in the same year.

Thornton would remain with San Jose for nearly 15 seasons, a period when he grew to become one of the league's best centers. The scoring and the accolades were great. But one aspect remained among the missing — his name on the Stanley Cup.

And thus, in the twilight of his career, after a season with the Toronto Maple Leafs, that Joe Thornton, as Bourque before him, made an assessment and reached a conclusion. If he was to have a reasonable opportunity to win a Cup, he would have to go to another franchise.

And thus Thornton, a veteran of 23 seasons in the National Hockey League, signed on for a  $24^{\rm th}$  — this time with the Florida Panthers. It wasn't about the money — a one-year deal worth \$750,000. It was about putting himself into position to possibly win a Cup.

"It means everything to me," said Thornton in an interview published on the Panthers website. It is purely hockey. Everything is ultimately about winning the Stanley Cup. The Panthers are right there in my opinion."

And so, like Bourque before him, Thornton will be moving on. Unlike Bourque, he did not have to request to be traded since he was free agent. The 6-3, 235-pound player, who still has an imposing presence on the ice, will be moving to the Sunshine State, no longer the 18-year-old rookie who needed to learn the ropes, but now the 42-year-old senior veteran whose grizzled appearance denotes: wisdom, authority, and leadership.

As such, he actually studied the playoff picture as it unfolded this past spring. "I saw their (the Panthers) team on paper," he noted. "I watched their team." The time spent transformed those viewing hours into a deeper relationship.

"I love their team," he continued. "I love what they are building. I am excited to be part of it. The Panthers are right there in my opinion. It doesn't matter about the past," he said in a nod to the fact that Florida lost to eventual Cup champion Tampa Bay in the first round of the playoffs last spring. "They had a great season," he said in reference to the 37 victories compiled by the Panthers—third highest (with Pittsburgh) in the entire NHL.

"This is a new year. Obviously, they lost to the eventual champions. For me, it will be just work, work, work, and hopefully at the end you will see some rewards."
