## 102<sup>nd</sup> Fisherman's Feast

The 102<sup>nd</sup> Annual Fisherman's Feast took place August 16-19, 2012 in the North End of Boston. The Madonna del Soccorso di Sciacca Society sponsors this annual event, that was founded in 1910. The basis of the feast is of religious nature — a Catholic tribute to the Virgin Mary with its roots originating in the ancient town of Sciacca in Sicily.

The Feast began on Thursday evening with a procession to the waterfront where a blessing of the waters takes place. The most poignant moment is the traditional Flight of the Angel. A young girl is

lowered from a window or rooftop via pullev down to the Madonna Statue, and offers her a bouquet of flowers.

At the end of the Fisherman's Feast, the statue of Madonna del Soccorso (Our Lady of Help) is carried through the streets and brought to Sacred Heart Church, her home during the year. A statue of Saint Rosalia is carried to the front door, and they meet. Members of the Society then lead the crowd in shouting "Viva Madonna del Soccorso" and "Viva Saint Rosalia." Saint Rosalia is credited with helping to end a plague of cholera that struck Palermo in the 16th Century.

## Menino Opposed to Phased-In Casino Idea

Mayor Thomas M. Menino has reportedly objected to any plans by Suffolk Downs owners to develop its proposed \$1 billion casino resort in phases, with slots and table games coming first ton and Worcester region. and the rest of the casino coming later. "I will not support a phased-in casino," said Mayor Menino in a recent Boston Globe interview. According to the mayor, "The product that is right for us in Boston is a full resort destination that provides complete economic development for the area."

The mayor's Host Community Advisory Committee urged the track to submit plans "that complete the project in a single phase." The letter was signed by the committee's chairman Brian Leary. Suffolk Downs, once Robert Kraft's Foxboro casino idea went crashing down after local community opposition, has been seen as the favorite to win the sole casino license created by state law for the Greater Bos-

Over two months both Suffolk Downs with its casino partner Caesars Entertainment unveiled plans for a gleaming crystal gambling casino resort with hotels, restaurants, entertainment venues and a spa. Back in July, Caesars chief executive Gary Loveman said he saw a casino in a two-stage development process. Slots and tables the first year and everything else in the second phase in an additional year. Reportedly, Suffolk Downs in all talks with city officials have pushed the two phased plan while the mayor continues to oppose a phased-in casino. As the mayor has stated, "It would be a renovation of old Suffolk Downs ... What about the hotel? ... We can have slot machines anyplace ... It has to support economic development that is right for our city."

Chip Tuttle, Suffolk Downs' chief operating officer has responded in a statement saying, "We take this letter (from the city's Host Community Committee) and the issues raised very seriously and will address them immediately ... and look forward to responding in a substantive way that reflects our long standing commitment to create a world-class resort befitting the tourism hub of the region, creating thousands of jobs for local residents and significant opportunities for local businesses.

# Stirpe Nostra

#### **FRUMENTUM**

Frumentum is the Latin word for corn, and from the days of antiquity one of the duties of the Roman Government was to maintain it in good supply. Even during times of scarcity it was expected that the administrators would buy the corn from other countries and sell it to the people at a moderate and stable price. Permitting the supply of corn to dwindle or the price to rise was considered to be an act of total irresponsibility and a neglect of one of the gov-ernment's most important duties.

Economic conditions, of course, were not "totus consolatio" or always in a consoled state of affairs. During periods when the indigent or extremely poor population increased they could not afford to buy corn even at moderate prices, so the demand was to be fed at the expense of the State. On very few occasions, wealthy persons in search of popularity made donations of corn to the people. State subsidies to supply corn and wheat below their market values started about 123 B.C. Strangely enough, these

subsidies were not restricted to the poor; every citizen had a right to them, but distribution was made through fathers of families. Each recipient was required to apply for the subsidy in person, and this in itself deterred most of the rich. In time this system taught the poor to become paupers of the State and such a vast idle population soon emptied the treasury. This situation could never happen in the U.S.A. because we would just print more money ... How simple can you get.

The amount of the food subsidies fluctuated until about the time of Julius Caesar when corn was then distributed to the people free. The cost for this caper came to approximately twenty percent of the total revenues of the State. Caesar affected some economies by requiring proof of citizenship. This reduced the number of eligible persons by about fifty percent. Having gone this far he then enacted laws which set a ceiling on the number of recipients and permitted new additions only by lottery as the old timers died off.

History implies that in time the free corn was supplied only to the utterly destitute. These persons were first issued tickets called "tesserae Nummariae" which entitled the holder to receive the corn without payment.

When a tessera was issued it became the property of that person for life. He could keep it, sell it, or even will it to one of his heirs. Any Roman citizen, except a senator, was eligible to hold a tessera, provided that he could show a need.

Eventually, instead of distributing the corn every month, a wheaten bread was made by the State and given to the people. The bread was baked by "pistores" (millers or bakers), delivered to special elevated depots which were approached by "gradus" (steps) and ... you guessed it ... the bread was called "panis gradilis." After 2,000 years we removed the steps, installed escalators, and changed the name to "panis gratuitus."

#### Republican Party, Again, Drives Voters to the Democratic Party on Election Day

Looking at this fall's elections, not many men and women have stepped up to give the voters of the North End and East Boston — prime readership of this Post-Gazette column — a choice. The Democratic Party has someone running for each of the eleven offices to be filled. However, out of the ten where there could be a primary contest, Democratic voters will determine the outcome of but four. The other six have only one name per office on the ballot — so Democratic primary voters have no choice.

Here's how it breaks down. Democrats Terrence W. Kennedy and Francis Xavier Flaherty, Jr., are vying for Executive Councillor. No Republican is running.

For positions in the Suffolk County Courts, Democrats Michael Joseph Donovan and Michael L. Dash are vying for Clerk of Court (Civil Business). Democrats Maura A. Hennigan and Robert J. Dello Russo, Sr., are running for Clerk of Court (Criminal Business). Democrats Patricia Patty Campatelli and Salvatore LaMattina are facing off for Register of Probate. None of these Democrats will face a Republican on the November ballot. For Clerk of Supreme Court and Register of Deeds there isn't even a contest for the Democratic nomination, so voters are quite irrelevant to the process.

For Representative in the General Court the Democrat faces no contest in either the primary or the general election. So out of eight county or state offices to be filled, four will be decided in the Democratic primary, three are already decided before anyone votes (because only one person is running). That leaves just one race that will be decided by the voters in the November election, which is for Senator in the General Court where Republican Thomas Dooley is challenging Democrat Anthony Petruccelli.

Looking to national races, voters in the North End will have the choice of Democrat Stephen Lynch or whichever of the two Republicans, Joe Selvaggi or Matias Temperly, wins in the Republican primary for Representative in Congress. In East Boston the Democratic candidate for Congressman will have no Republican opposition.

The race for United States Senator will pit Democrat Elizabeth Warren against incumbent Republican Scott Brown. For President we all know that Republican Mitt Romney is challenging Democrat Barack Obama.

My question to the Republicans is: Why would I want to register in your party? Say I am a Republican-leaning voter. If I live in the North End there is but one contested Republican primary election to vote in, out of ten possible. And even then, it's just to pick which Republican will lose to the Democrat in November. If I live in East Boston your primary is utterly pointless to me as a voter as you have no contests to settle that day. Far smarter for me to be an unenrolled voter and vote in the Democratic primary which will decide who will be Executive Councillor, Clerk of Court (Civil Business), Clerk of Court (Criminal Business) and Register of Probate, four offices for which there will not even be token Republican opposition in November.

Having voted in the Democratic primary (in order to have my vote matter) I then go into the voting booth in November to see, below the top couple of races, no Republicans running or some Republican whom I never heard of because, having no primary opponent, he wasn't newsworthy. On top of that, he's running against a Democrat who was on my September ballot, possibly even a Democrat I voted for in the primary as the "lesser-of-two-evils." The harm from not having primary contests in the Republican Party doesn't stop there. Parties and candidates can spend huge amounts of money trying to identify voters who may lean their way, here in Massachusetts the Commonwealth does part of that for you. For free! If this independent but Republican-leaning voter had pulled a Republican ballot in September that is information you can get free or at slight cost from the city's Election Department. With that information you would know that I am a strong candidate for your get-out-the-vote effort in November. But, because you didn't have primary contests to interest me, I voted in the more important Democratic primary. I'm still far more likely to vote Republican in November. That is if I remember to vote. But you have no way of knowing that. I might have even been a good target for your fund raising efforts, but for all you know, I'm a Democrat, since you forced me into that party's primary.

In sum, what is the point of a political party that doesn't run people for political office?





The Siege of Khe Sanh began in the early morning hours of January 21, 1968, when 20,000 North Vietnamese troops closed in on an American base manned by 6,000 Marine troops in a hilly, desolate part of the

Seventy-seven days later, when the horrific and unrelenting bombardment finally ended, 703 American and South Vietnamese troops had been killed, 2,642 wounded, and seven were missing. North Vietnam casualties were estimated between 10,000 and 15,000.

One of the survivors of the Siege of Khe Sanh was Ken Rodgers, who grew up in Casa Grande, Arizona, and who joined the United States Marine Corps right after his freshman year of college. He was one of the Marines of Bravo Company, First Battalion, 26th Regiment, who fought at Khe Sanh. He was barely 21 years old.

Since then, he and the other Marines of Bravo Company who survived Khe Sanh have gathered regularly to commemorate and pay homage to the battle and to their fallen comrades. At the 2009 Khe Sanh Veterans' reunion in Denver, Colorado, Ken and his wife Betty decided the in-

#### Remembering PFC VINCENT ANTONIO MOTTOLA

Our minds have a way of bringing us back in time. When I stand at my cousin Vinnie's grave on the Vietnam Memorial lawn at Oak Grove cemetery in Medford, MA, I am a young woman again of 21. A flag is presented, Taps are played, gun salutes go off. It all comes back to me.

PFC Vincent Antonio Mottola of Medford, MA was 18 years old when he was killed at Khe Sanh on February 23, 1968, leaving behind his mother, father, two brothers

and many cousins, aunts and uncles who loved him. As one of the men from Bravo described Vinnie, he was funny, irreverent (definitely), and carried his own weight.

Almost 44 years later, my nephew Jimmy was watching a documentary about the siege at Khe Sanh. It sparked a desire to find out more about Vinnie. He had never known Vinnie. My nephew was born three years after Vinnie died. This is how my nephew Jimmy found out about "Bravo!

Common Men, Uncommon Valor." This past January I was in contact with Ken Rodgers, Bill Jayne and others who remembered Vinnie. Bill Jayne remembered the day Vinnie was killed. To be able to speak to other Marines who knew Vinnie after 44 years was surreal. They were able to answer our questions about how he was killed. The muses online gave me the opportunity to get to know these fine men and learn about the siege at Khe Sanh from the Marine point of

Come the end of August, I hope to join these gallant Marines in D.C. for the Khe Sanh Veterans reunion, listen to their stories and see a preview of the documentary.

We would like to hear from anyone else who might remember Vinnie. At the end of the Vietnam War over 58,000 Americans had lost their lives, approximately 1,290 from Massachusetts.

The Massachusetts Vietnam Veterans Memorial was dedicated in June 2002, it is located on Skyline Drive at Green Hill Park in Worcester. The 4-acre location includes a pond, walking paths and the Memorial. A place to provide a dignified, quiet, natural location for reflection and learning. The Memorial is designed in three sections called places. These consist of the PLACE OF FLAGS, PLACE OF WORDS and PLACE OF NAMES. The PLACE OF WORDS shows text from letters written home by some of the Soldiers, Sailors, Airmen and Marines who died in Vietnam. The PLACE OF NAMES proclaims in stone the name of each and every Massachusetts resident who died in combat or as a result of wounds received while in action in Vietnam.

## HISTORY OF St. Anthony of Padua

Doctor of the Church 1195 – 1231

Saint Anthony was canonized (declared a saint) less than one year after his death.


There is perhaps no more loved and admired saint in the Catholic Church than Saint Anthony of Padua, a Doctor of the Church. Though his work was in Italy, he was born in Portugal. He first joined the Augustinian Order and then left it and joined the Franciscan Order in 1221, when he was 26 years old. The reason he became a Franciscan was because of the death of the five Franciscan protomartyrs — St. Bernard, St. Peter, St. Otho, St. Accursius and St. Adjutus — who shed their blood for the Catholic Faith in the year 1220, in Morocco, in North Africa and whose headless and mutilated bodies had been brought to St. Anthony's monastery on their way back for burial. St. Anthony became a Franciscan in the hope of shedding his own blood and becoming a martyr. He lived only ten years after joining the Franciscan Order.

So simple and resounding was his teaching of the Catholic Faith, so that the most unlettered and innocent might understand it, that he was made a Doctor of the Church by Pope Pius XII in 1946. Saint Anthony was only 36 years old when he died. He is called the "Hammer of the Heretics" His great protection against their lies and deceits in the matter of Christian doctrine was to utter, simply and innocently, the Holy Name of Mary. When St. Anthony of Padua found he was preaching the true Gospel of the Catholic Church to heretics who would not listen to him, he then went out and preached it to the fishes. This was not, as liberals and naturalists are trying to say, for the instruction of the fishes, but rather for the glory of God, the delight of the angels, and the easing of his own heart. St. Anthony wanted to profess the Catholic Faith with his mind and his heart, at every moment.

He is typically depicted with a book and the Infant Child Jesus, who had miraculously appeared to him and is commonly referred to today as the "finder of lost articles." Upon exhumation, some 336 years after his death, his body was found to be corrupted, yet his tongue was totally incorrupt, so perfect were the teachings that had been formed upon it.

## ST. LUCY

### Patron of Blindness

Lucy's name means "light", with the same root as "lucid" which means "clear, radiant, understandable." Unfortunately for us, Lucy's history does not match her name. Shrouded in the darkness of time, all we really know for certain is that this brave woman who lived in Syracuse and lost her life in the persecution of Christians in the early fourth century. Her veneration spread to Rome so that by the sixth century the whole



Church recognized her courage in defense of the faith.

Because people wanted to shed light on Lucy's bravery, legends grew. The one that is passed down to us tells the story of a young Christian woman who had vowed her life to the service of Christ. Her mother tried to arrange a marriage for her with a pagan. Lucy apparently knew that her mother would not be convinced by a young girl's vow so she devised a plan to convince her mother that Christ was a much more powerful partner for life. Through prayers at the tomb of Saint Agatha, her mother's long illness was cured miraculously. The grateful mother was now ready to listen to Lucy's desire to give her money to the poor and commit her life to God.

Unfortunately, legend has it, the rejected bridegroom did not see the same light and he betrayed Lucy to the governor as a Christian. This governor tried to send her into prostitution but the guards who came to take her away found her stiff and heavy as a mountain. Finally she was killed. As much as the facts of Lucy's specific case are unknown, we know that many Christians suffered incredible torture and a painful death for their faith during Diocletian's reign. Lucy may not have been burned or had a sword thrust through her throat but many Christians did and we can be sure her faith withstood tests we can barely imagine.

Lucy's name is probably also connected to statues of Lucy holding a dish with two eyes on it. This refers to another legend in which Lucy's eyes were put out by Diocletian as part of his torture. The legend concludes with God restoring Lucy's eyes.

Lucy's name also played a large part in naming Lucy as a patron saint of the blind and those with eye-trouble.

Whatever the fact to the legends surrounding Lucy, the truth is that her courage to stand up and be counted a Christian in spite of torture and death is the light that should lead us on our own journeys through life.

In Her Footsteps:

Lucy is the patron saint of the blind. Braille is an important means of communication for those with visual impairment or blindness. Support the teaching of Braille in schools and learn about it yourself by calling your local chapter of the National Federation of the Blind.

Prayer:

Saint Lucy, you did not hide your light under a basket, but let it shine for the whole world, for all the centuries to see. We may not suffer torture in our lives the way you did, but we are still called to let the light of our Christianity illumine our daily lives. Please help us to have the courage to bring our Christianity into our work, our recreation, our relationships, our conversation — every corner of our day. Amen.

## A Yearly Encounter

Shiny silver stars remained scattered over the sidewalk in front of Sacred Heart Church this past Monday, a reminder of a very special event that took place the previous evening, the yearly encounter of the statues representing the societies of Madonna del Soccorso di Sciacca and Saint Rosalia, one of the many traditions that abound in the North End.

The encounter takes place on the last day of the Fishermen's Feast honoring Madonna del Soccorso, the statue of the Madonna, after being carried through the streets of the North End for hours by members of the society, makes its way to Sacred Heart Church where the figure of Saint Rosalia is enshrined. The doors of Sacred Heart are opened wide and the beautiful statue of Saint Rosalia is brought to the entrance of the church by members of her society, accompanied by the ringing of church bells and a blizzard of confetti and tiny silver

stars, enthusiastic shouts of Viva Madonna del Soccorso and Viva Santa Rosalia spontaneously erupt as members of the two societies pay tribute to each other and the traditions of their regions of Sicily.

The feast honoring Madonna del Soccorso began in 1910; it is a happy event commemorating a vision of the Blessed Virgin to the Augustinian monk Nicolo Bruno in 1300. According to tradition, Mary announced that she would assist and aid the people of Sciacca and that this message should be spread to its inhabitants. The annual feast has beknown as Fishermen's Feast.

Rosalia, according to tradition, was born in Palermo in the 12th Century to noble parents. She refused to marry a nobleman who asked for her hand in marriage because she had committed herself to Christ. Rosalia, to avoid marriage, fled to Monte Pellegrino where she lived in a cave for her remaining years.

On May 29, 1624, Vito Amedeo, excavating on Monte Pellegrino, found the remains of Rosalia; he also found her crucifix and rosary. In the same year, Palermo was being ravaged by plague, Rosalia's bones were placed in a silver urn, put atop a float decorated with roses, lilies candles; where she passed, the plague ended. Pilgrimages to Monte Pellegrino began and a church was built in the cave where her remains were found. Saint Rosalia is the Patron Saint of Palermo.



#### AGLIA, OLIO, POMODORO, E BASILICO CON LINGUINE

(Aglia e Olio alla Salemitana)

5 large vine-ripened tomatoes (well ripened) 10 cloves of garlic 1/2 cup olive oil

1/3 cup fresh basil leaves Grated cheese of choice I pound linguine Salt and pepper

Cut up tomatoes into a thick medium-sized bowl. Add peeled and cut-up garlic gloves.

Wash fresh basil leaves. Cut up and add to tomato and garlic.


With a wooden mallet, crush contents of bowl into a pesto sauce (thoroughly mashed). Add oil, salt and pepper to taste. Mix contents thoroughly. Cover and set aside.

Following directions on the package, cook one pound of linguine to your liking. (Reserve about one cup of water when draining the pasta.) After draining, place pasta in a serving bowl. If desired, add a small amount of the hot reserved water to the  $\mathbf{uncooked}$  tomato mixture. Then spread mixture over the linguine. Stir and serve in bowls topped with grated cheese of choice.

Serves four.

NOTE: As I read this recipe, I can literally smell and taste this uncooked tomato, garlic, basil, and oil pesto. It became a traditional summer meal when relatives gathered on a warm August afternoon. Papa always saved a few tomatoes from his garden in Wilmington for this purpose. Some of the children walked away from the table with teary eyes from the strong garlic flavor; but many grew to enjoy this special meal that originated in our parents' homeland of Salemi, Sicily.

## Nanna & Babbononno

As a third generation musician in my family, I became a professional about the same time I was turning eighteen. Babbononno had taught me how to read music when I was a child, using the Italian solfeggio method that he learned as a boy in Italy. Dad had taught me how to play bass violin when I was a young teen and I had taught myself how to play bass guitar not long afterward. I worked at it and I guess I became good enough to earn a week's pay playing part time, enough, at least, to pay my own way through college.

Street corner life was now behind me. The only time I would see my old pals was when they would go to see a movie locally and I was working the door collecting tickets at East Boston's Seville Theater. This was on nights when I wasn't playing music or studying for the next day's classes.

When the time came to turn professional, I needed a tuxedo. It was assumed that I would follow in Dad's and Uncle Nick's footsteps and play society music. Society music was the traditional non-stop dance music played for coming out parties in the spring, the wedding receptions that followed Easter, high school and college proms, hotel dances and functions of all types, live shows and if you knew Jewish music, the traditional weddings and Bar Mitzvahs of the day.

I really didn't want to play society music, but discovered it was more prestigious than working night clubs and lounges and the pay was a lot better. As I was paying my own way through college, I followed in Dad and Uncle Nick's footsteps and opted for society music.

As I already mentioned, I needed a tuxedo. A society musician was always on stage in a neatly pressed tuxedo and a starched white pleated shirt. When the time came to buy my first tuxedo, Babbononno and Dad brought me to Lebow Brothers, a clothing store on the second floor of a building on Washington Street in Boston. The establishment had been outfitting musicians with their needs for two generations and a hefty discount was given to people in the profession. Dad was friendly with the brothers that owned the establishment as he had

been doing business with them for years.

As they were measuring me for a fitting, they were under the watchful eye of Babbononno, who inspected the material of each garment that I tried on. When I finally decided on a particular tux, Dad nodded his approval due to the style and Babbononno did the same because of the quality of the material. The alterations were done while we waited and when I looked inside at the labels, there was one that read Lebow Brothers with my initials underneath and another label on the other side that was just a black square with a rabbit's head in the middle, the symbol for the Playboy Empire. I was thrilled with my new tux and added in a bow tie, cummerbund and a couple of pleated formal shirts. I was now ready to show myself off on my next job.

Let me backtrack a bit and mention that before trying to break into the society circuit, I had played locally with small groups at East Boston and North End bars and ca-This included Sal Bartolo's Ringside Café in East Boston, Carmen's Café which was located near the Union Oyster House and several other saloons that used trios or quartets that played the music of the day. These places didn't pay much and there were no guarantees. I remember one such joint which will remain nameless except to say that we musicians nicknamed it "Friday night at the fights." I wanted something better.

Babbononno and Dad were not thrilled with me playing in those places which they called "local dives." Nanna and my mother would pray that I never became involved in any of the fights they had heard about due to their eavesdropping.

To break away, I auditioned for the Ken Reeves Orchestra. Ken Reeves was a Boston Yankee who catered to his people with the music and entertainment they demanded. The Boston Brahmin were members of the prestigious private clubs in the city, they sponsored the coming out parties each spring where their daughters would be formally presented to society. They held many functions at Boston's most exclusive hotels and function facilities, events that were constantly written

up in society columns in most of our daily and weekly newspapers. Ken Reeves, being a member of their "tribe," booked in the lion's share of the work.

When I called and asked for an audition, I had a friend drop me off at their office which was on Boylston Street at that time. I arrived a bit early dressed in a suit and tie carrying a bass violin under my left arm. Dad was working and Babbononno supervised my preparations. When I entered the office, I was greeted by a man named Dave Kahn. He didn't look too happy to see me but left his desk, sat at a nearby piano and began to play. Both Dad and Babbononno had already primed me on the type of bass playing accompanied society music and I held my own accompanying Mr. Kahn.

After he had gone through the scores of a couple of Broadway musicals and then segued into the music of Cole Porter and George Gershwin, playing fox trots, standard waltzes and a couple of Viennese waltzes, he held up his fist indicating we were going to end our playing. I knew I had to hold my own but Mr. Kahn's lack of enthusiasm made me feel as if I hadn't made the grade. Once I had packed up my bass, he explained that I had done well but the office didn't need another bass player and he would call if he could do anything for me. In other words, "Here's your hat, what's your hurry." I took the hint, thanked him for the opportunity and left.

That evening at dinner, I explained the happenings of the day to all at the table, Mom, Dad, Nanna and Babbononno. All of them knowing how tough it was to be a musician. Babbononno and Dad told me not to despair as there were other band leaders who put out several bands on weekends and I might consider contacting some of them.

The next day, when I returned home from my classes at the college, a postcard was sitting on the kitchen table. It was addressed to me from Mr. Kahn and listed ten future weekend dates that he was booking me in to play. To be continued ...



MILLIONS FOR AN OLD FERRARI. An old 1957 Ferrari "Testarossa" has been sold in California recently for a record \$16.4 million. The sum paid by an unidentified collector was for the very first model of the mythical 'testarossa,' used as a prototype later for the production of a very popular and much loved car. The engine is a three-liter model (3,000 cc), with 12 cylinders, which deliver 300 hp and a manual 4-speed shift. The car was used for a period of eight years in Europe and in the United States for competition(s). The unknown buyer is a collector and a lover of Italian cars. CNN, a cable TV network, announced that the sale also mentioned a similar car model, sold at an auction in 2009 was also a Ferrari, which sold for 'only' \$12 million to another unknown collector. The latter sale took place at Maranello, a town in the Province of Modena, Italy, where the Ferrari was manufactured.

THE NEW ECONOMIC POLICY: CUTTING THE POLITICAL PORK! The new Italian Government, led by Premier Mario Monti, has embarked on a serious mission: to cut the fat wherever it is. #### Boston Marathon® Jimmy Fund Walk History

The idea for the Jimmy Fund Walk came about in the late 1980s when Mike Andrews, former Red Sox second baseman and chairman of the Jimmy Fund, and his wife, Marilyn, were taking a walk one day and mentioned how great it would be to host a walk as a benefit for the Jimmy Fund. They wanted it to be unique and Mike Andrews suggested it be held along the Boston Marathon® route. He spoke with Boston Athletic Association officials and walkers have been walking the Boston Marathon® route to raise money for Dana-Farber ever since. A fall date was selected because most of the area's larger fundraising walks are held in the spring. The first Jimmy Fund Walk was held in 1989 with approximately 600 walkers.


