### **Congress Closes U.S. Protections** on Meats from Other Countries

the U.S. House of Representatives? You may know that recently the majority voted 300-131 to toss out federal inspections of "out-of-country" poultry, beef, and pork. Are you aghast with disbelief as I am at the mere thought? Or are you angry upon learning that our meats will not receive rightful inspection after they have passed through the hands of other nations?

These food inspections include labeling of meats in countries where animals were born, raised, and slaughtered, reports the online newspaper Food Safety News in its June 11th edition. The first action on the bill - Country of Origin Labeling Amendments Act of 2015 or COOL - was voted on by the House on June 11th. COOL was enacted in 2013 to ensure that Americans know exactly where our meat originates.

A fight is sure to follow by House members such as Massachusetts Rep. Jim McGovern (D). "I think that's the wrong way to proceed," he said. The Consumer Federation of America survey shows that 90 percent of Americans want to know exactly where their meat is from. Labeling the packaging of meats addresses those concerns.

Wait. There's more bad news for food protection. On Thursday, July 23rd, the House vote was 275-150 to end any state "issuing mandatory labeling laws for foods that contain genetically modified organisms," or GMOs, reports The Hill in its online publica-

What is happening with the members of tion. Representatives favoring the bill clamor that laws labeling GMOs will spike food prices. Vermont Rep. Peter Welch (D) disagrees with the bill's intent: "What's the problem with letting consumers know what they are buying?" Indeed.

As I researched the necessary facts and details for my column, I recalled reading a book in the 1980s entitled The Jungle, which chronicled the horrors of the meatpacking industry in 1906. One of the best investigative journalists of his time, also referred to as a "muckraker," Upton Sinclair set out to write about the vagaries of immigrants laboring within the industry. But he tripped across various other atrocities as he walked through plants fraught with myriad unsafe conditions.

Sinclair wrote: "There would be meat stored in great piles in rooms; and the water from leaky roofs would drip over it, and thousands of rats would race about on it. It was too dark in these storage places to see well, but a man could run his hand over these piles of meat sweep off handfuls of the dried dung of rats. These rats were nuisances, and the packers would put poisoned bread out for them; they would die, and then rats, bread, and meat would go into the hoppers together."


Upon reading Sinclair's putrid depiction of the meatpacking industry, Americans grew

# Stirpe Nostra

#### THE APPLES OF THE HESPERIDES

The legend concerning the apples of the Hesperides starts with the marriage of Jupiter, chief of all Roman gods, to the goddess named Juno. The wedding was attended by all other deities, who brought beautiful gifts. The grandmother of the bride brought a wedding gift of golden apples growing on live branches. As soon as the ceremonies had ended, the branches were planted in the sacred garden of Juno. The Hesperides, three daughters of Atlas, and a goddess named Hesperis, were directed to cultivate and watch over the growing trees. The golden fruit soon became known as the apples of the Hesperides. The girls were negligent in their duties and frequently plucked off apples for themselves. Consequently, Juno sent a large serpent to guard the fruit. This monster had a hundred heads that slept at different intervals, so that it was ever watchful. The eleventh task required of Hercules was to bring back to the king, at the city of Tiryns, the apples of the Hesperides.

The journey to the sacred garden of Juno took Hercules into the Caucasus Mountains where he came upon Prometheus, still bound to the rock. We remember Prometheus as the Secondary Titan who stole fire from the gods and gave it to mankind. Later, he dis-

pleased Jupiter, so he was chained to this rock. Each day a giant eagle tore at his liver, which grew whole again each night. The best artistic representation of this legend has been portrayed on an eight-foothigh oil-on-canvas masterpiece by Peter Paul Rubens. It is entitled "Prometheus Bound," and is owned by the Philadelphia Museum of Art. Prometheus is also represented in a sculptured wall plaque that is now in the National Museum at Naples, Italy. Hercules shot and killed the eagle; then he freed Prometheus from his bonds. In gratitude, Prometheus advised Hercules not to enter the sacred garden of Juno, but to send Atlas, the father of the Hesperides, to fetch the

apples for him.

Continuing his outward journey, Hercules finally came to the sacred garden of Juno. It was located near the spot where Atlas was holding the sky on his shoulders. Remembering the advice of Prometheus, Hercules offered to relieve Atlas of the weight temporarily if he would gather the golden apples from the garden. Atlas agreed, fetched the apples, and returned shortly thereafter. Hercules soon discovered that Atlas did not intend to resume his great burden, but instead offered to deliver the apples himself. Having this great weight upon his back prevented Hercules from resorting to any kind of force against Atlas. Using caution and wit, Hercules pretended to agree to the proposal of Atlas, but begged him to hold the sky just long enough to permit a pad to be placed on his head. The gullible Atlas laid the apples on the ground and took back the sky. As soon as the weight was transferred, Hercules picked up the golden fruit and started his journey back

After receiving the apples, the king immediately returned them to the Hesperides because it was not considered proper that such sacred fruit remain in anyone else's keeping.

#### MASSFISCAL SAYS

Closing the Union Loophole is a Top Priority for Fairness Advocates as Court Begins Hearing Mass. Campaign Finance Law

On February 24th, two Mas- and Mike Kane to close the sachusetts companies, in coordination with the nationally recognized Goldwater Institute, filed a bold lawsuit seeking to close the "union loophole" in Massachusetts campaign finance law, and both plaintiffs in the lawsuit have connections to the Massachusetts Fiscal Alliance. 1A Auto Inc., a family-owned auto parts retailer in Pepperell, is run by Rick Green, who is also the chairman of Massachusetts Fiscal Alliance's board of directors. Mike Kane, whose Ashland business, 126 Self Storage Inc., is also part of the suit, serves on Massachusetts Fiscal Alliance's board as well.

Massachusetts' campaign contribution restrictions are tilted heavily in favor of unions and against businesses. Since 1908, businesses have faced a total contribution ban to state candidates. These special rules allow unions to contribute as much as \$15,000 to state candidates, while individuals are permitted to contribute up to \$1,000. After unions have donated \$15,000 to a campaign, their political actions committees (PACs) can continue to contribute up to the ordinary limits. Meanwhile, business PACs are banned from contributing.

Last week, hearings began at Suffolk Superior Court in the lawsuit filed by businesses owned by Rick Green

so-called union loophole in Massachusetts campaign finance law.

Massachusetts is one of only six states with campaign finance laws that favor unions.

Executive director of MassFiscal Paul D. Craney said, "Campaign finance law boils down to freedom of speech. It's just not fair to tell businesses they can't participate, while unions and special interest groups pour money into campaigns. We need to level the playing field in Massachusetts politics.

"Closing the union loophole must be the number one priority for advocates of fairness," concluded Craney.

According to an article in Boston Magazine, "It's impossible to overstate how much of a major role organized labor plays in Massachusetts politics ... Thousands of active union members are the foot soldiers in the always-evolving voter efforts. And outreach they crave their financial donations."

The Boston Magazine article cited as a recent example the 2013 mayoral race, when organized labor groups from around the country contributed heavily to the campaign of now mayor Boston Mayor Marty Walsh. Like in all elections, businesses were forbidden from participating financially.

### Saint John Eudes

John Eudes was born on November 14, 1601, on a farm near the village of Ri. in Normandy, France, the son of Isaac and Martha Eudes. He went to the Jesuit College at Caen when he was 14 and joined the Congregation of the Oratory of France in 1623. He studied in Paris and at Aubervilliers. Eudes was ordained on December 20, 1625, and worked as a volunteer, caring for the victims of the plagues that struck Normandy in 1625 and 1631. rediscovery of the Holy Spirit. He spent the next decade He giving Missions, building a reputation as an outstanding preacher and confessor and for his opposition to Jansenism. As a missionary, Father Eudes became famous and was considered the greatest preacher in France since St. Vincent Ferrer. He was called by Jean-Jacques Olier (French priest, founder of the Society of Saint Sulpice) "the prodigy of his age."

Father Eudes was a member of the French School of Spirituality. The French School was not a system or philosophy, but a highly Christocentric approach to spirituality, characterized by adoration, a personal rela-



resigned from the Oratorians in 1643 and founded the Congregation of Jesus and Mary (the Eudists) at Caen, composed of secular priests not bound by vows, but dedicated to upgrading the clergy by establishing effective seminaries and to preaching missions. His foundation was opposed by the Oratorians and he was unable to obtain Papal approval for it. In 1650, the Bishop of Coutances invited him to establish a seminary in that diocese. The same year, the sisters at his refuge in Caen left the Visitandines and were recognized by the Bishop of Bayeux as a new congregation under the name of Sisters of Our tionship with Jesus, and a Lady of Charity of the Refuge.

Father Eudes wrote a number of books remarkable for elevation of doctrine and simplicity of style, among them, The Wondrous Childhood of the Most Holy Mother of God.

Father Eudes founded seminaries at Lisieux in 1653 and Rouen in 1659 and was unsuccessful in another attempt to secure Papal approval of his congregation. In1666, the Refuge sisters received Pope Alexander III's approval as an institute to reclaim and care for penitent wayward women. Father Eudes continued giving missions and established new seminaries at Evreux in 1666 and Rennes in 1670. He shared with St. Mary Margaret Alacoque the honor of initiating devotion to the Sacred Heart of Jesus (he composed the Mass for the Sacred Heart in 1668) and the Holy Heart of Mary, popularizing the devotions with his books The Devotion to the Adorable Heart of Jesus (1670) and The Admirable Heart of the Most Holy Mother of God, which he finished a month before his death at Caen on August 19, 1680. Saint John Eudes was beatified April 25, 1909, and canonized in 1925. His feast day is August 19th.

outraged and demanded wholesale changes. Laws to inspect meats and the safety of its workers were soon enacted. Sinclair is credited with changing the industry.

Do Americans truly have a say about our collective safety of foods? Do we even possess influence over the people we elect to wisely repthe U.S. Congress? I like to

think so, because part of me is an eternal optimist.

Yet with the passage of the bizarre legislative bills that strip our safety as to where our steaks and chicken come from, I am growing skeptical of the misguided motives of federal-level public servants. Do they know they're in Congress to serve us? Maybe we should remind resent us in both houses of them that their responsibilities are to the citizens first.

Ferragosto: When All of Italy is on Vacation

There is no use hiding it anymore: autumn is coming. The signs of the changing season pulsate all around me. The evenings fall earlier, a dusky blue mantel of sky covering the Earth, and the air feels crisper as well. The earliest crop of apples has arrived at markets, and I cannot wait to enjoy this succulent fruit in cakes, breads, crisps and as a simple snack. Even Halloween decorations, smiling pumpkins and arched black cats, begin to wink from store shelves amidst all the notebooks and pencils of back-to-school sales. Although autumn is my favorite season, I am determined to hold on to the rest of the summer for as long as I can, until the school bell rings in September. After all, the days are still warm and the sun still bakes the Earth. Indeed, in Italy, summer vacation remains in full swing. The biggest summer holiday in Italy occurs on August 15th, though Italians extend the celebrations for several weeks before or after. For this feast, named Ferragosto, Italians leave the cities en masse to spend time at the beach or mountains. Caught between the heat and idleness of summer and the rhythmic nature of fall, Ferragosto provides Italy with one last joyous blast of the vacation season.

Visiting Italy during August can sometimes resemble walking through the quiet remains of an ancient civilization. Tourists abound, of course, but many Italians had already escaped the scorching heat of cities festivities by holding parades and towns once August be- and processions where the gan, embarking on their statue of the Blessed Virgin Ferragosto vacations until Mary is held aloft. In the the holiday culminates on medieval city of Siena, the August 15th. I remember the famous Palio, or Renais-

slightly eerie sensation of walking through Rome one August ten years ago, and noticing the boarded-up restaurants and theaters and shops. Meanwhile, the Italian coastline brims with colorful beach umbrellas and chic sunbathers, the sands chockablock with impromptu volleyball games and radios blaring the latest hits. Italians even exchange holiday greeting cards emblazoned with pictures of beach picnics and grinning suns. In small Italian villages, such as my father's home outside of Sulmona in Abruzzo, people celebrate Ferragosto with shady al fresco dinners, featuring the seasonal produce of zucchinis, tomatoes, peppers and herbs. This holiday has been important to Italians since ancient times. It hearkens back to the year 18 B.C., when the Emperor Augustus established the Feriae Augustae — Festivals of Augustus — in honor of his reign. Some historians suspect that Augustus's festivals replaced older holidays like the Vinalia rustica, which marked the grape harvest. For all of its modern trappings, therefore, Ferragosto remains a seasonal celebration honoring the fresh-air pleasures of summer and the harvest.

August 15th holds another great significance in Italian culture: it is the feast day of the Assumption, or L'Assunzione. This religious holiday observes the Virgin Mary's physical and spiritual Ascent into Heaven. Italian villages and towns combine Ferragosto and L'Assunzione

sance horse race, occurs around this time. Around Europe, in fact, the Feast of the Assumption also serves as an important seasonal marker, heralding the start of the harvest. Armenian farmers bring freshlyharvested grapes to church on the Sunday closest to the Assumption so that the priest may bless the fruit. In Poland, where the Virgin Mary of the Assumption is also known as the Blessed Mother of the Herbs, people gather herbs and have them blessed in church and later display those herbs around their homes for protection. I honor the harvest qualities of the Assumption by baking cheesy biscuits studded with chives; both the wheat and the herbs symbolize the bounty of Mother Earth. The pungent aroma and simple texture of these small breads remind me that August means far more than the end of summer; rather, it is a time to be thankful for the gifts of nature and to appreciate the cyclical changing of the seasons much as our ancestors

Therefore, August in Italy teaches us to live in the moment. Though we may be worried about the stress of the upcoming cold-weather months, the holiday of Ferragosto encourages us to seize the last few weeks of summer with fanfare and fun, enjoying the cool waters of the ocean or a picnic under the stars, surrounded by family and friends. Meanwhile, the Feast of the Assumption emphasizes the bountiful harvest that characterizes the late summer and fall, as well as the beauty of the changing seasons. So let us allow the lessons of these two holidays to permeate our lives, and carry the pleasures of August with us always.

P.S. Happy Birthday to my father Rocco Di Censo, who was born the day after Ferragosto. Daddy, I love you always!

Mirror, Mirror on the Wall, Who's the Fairest of Them All?

Lowering the price of the mirror came from the French. When they learned how the Venetian glassblowers were making the mirror, they began mass producing them, inevitably lowering the prices in Western Europe.

Today, the modern process for making a mirror is called "silvering," ory spraying a thin layer of silver or aluminum onto the backside of a sheet of glass. However, most mirrors today are made by heating aluminum in a vacuum and bonding it to the cool glass. Mirrors are an important part of our everyday life, including LCD projection, car headlights and beauty of course!



# THOUGHTS BY DAN ABOUT THIS & THAT

#### **CHIANG KAI-SHEK**

(October 31, 1887, Fenghua, Zhejiang-April 5, 1975, Taipei, Taiwan):

#### An Interesting Failure

Chiang Kai-shek was a political figure plagued by misfortune which continued after his death. Living exiled in Taiwan at the time of his death, he watched his anti-Communist ideals fall apart as Mao Tse-tung took over the country. He is now spoken of very little outside of Taiwan, especially in the States where his reign was overshadowed here by our own quarrel with Japan during WWII.

But Chiang Kai-shek was a man with a great love for his country and rose to power with many great things in mind for the future of China. In Taiwan, where he escaped as a refuge during his twilight years, he maintains a strong fan base (albeit still as a controversial figure). Understanding Chiang Kai-shek is paramount to understanding the development of China.

Chiang began his political career at the military academy in Paoting before being sent to Tokyo's Military State College in 1907. In the ensuing years, China went through the Wuchang Uprising of 1911 which would end the Qing Dynasty (and by extension the long history of imperial rule), and halted the influx of developments of the West after the Boxer Rebellion, which ultimately lead to the creation of the Republic of China. Chiang then returned to China to fight with the rebel army and gained the support of Sun Yat Sen by 1923 after helping Sun regain control of Guangzhou.

After the death of Sun Yat Sen in 1925, Chiang began taking steps to nationalize the country and establish a system of democracy. He began to lead China's nationalist troops toward a new unified country, and by 1928 was leader of the newly formed Republic of China, (something he played a part in forming) and, with his


It is at this point that Chiang Kai-shek's legacy begins to darken. Indeed, trouble was brewing in China, this time from an outside enemy. The Second Sino-Japanese War began making some rumblings almost immediately after Chiang became leader. As late as 1936, Chiang tried to ignore the growth of Japan's empire, preferring to focus, as the leader of the Nationalist Party, on curbing the growth of Communism within his own borders.

Ironically, the growth of Communism in China, which plagued it well into the late 20th century, is often linked directly to Chiang Kai-shek. He became so committed to the Nationalist Party and fought so hard to suppress the Communist Party that it became easier for the party to gain sympathizers in China who had become fed up with Chiang Kai-shek's pushiness. Be that as it may, Chiang's reluctance to engage in warfare with Japan was the first time he lost support from his own former allegiants.

By 1937, however, the threat from Japan demanded attention and an allout war broke out between the two countries. Even then, Chiang did not fully take his attention off of the Communist Party in China, having failed to reach a compromise with them (not entirely his fault as later decades proved how aggressive the Communist Party

was). Even while Japan took over Nanjing and Hankou, Chiang deployed his best soldiers to block Communist advancements in the northwest.

It's important to note that after WWII, Chiang Kai-shek became well regarded in the West. Ironically enough, one of the criticisms he did receive from Allied forces was that he didn't do enough to kill the growth of Communism. It's easy to make such an accusation during the start of the Cold War, but harder to understand the position Chiang was in, fighting two threats at the same time, one from inside his country and one outside.

Unfortunately for Chiang, the Communist Party of China was only picking up steam after the war and, though Chiang was elected the first president of the Republic after a new constitution was drafted, he saw the fall of the Nationalist Party as the Communists were gaining support both nationally and internationally from neighboring Russia. Amid accusations of corruption and inflated spending, Chiang resigned as president in 1949. At this point, his Vice President Li Tsungjen took over, but Chiang began pulling the strings for him, unwilling to give up power completely. This created strife between the former allies that resulted in Tsung-jen being exiled. In the meantime, negotiations between the Nationals and the Communists became





This past weekend, thousands gathered to celebrate the 95th annual Madonna Della Cava Feast, which took place on Hanover and Battery Streets in Boston's North End. The image of Maria SS Della Cava, Principal Patron of Pietraperzia, Sicily, was rediscovered miraculously in the year 1223 by a mute from Trapani who was directed by Our Lady to proceed to the outskirts of the town where the portrait of Our Lady would be found. In the process, his speech and hearing were restored. The first words spoken by the mute were, "VIA MARIA SS DELLA CAVA."

The feast began on Friday evening with the exposition of the image of the Madonna, followed by a blessing and short procession. A variety of entertainment was provided over the weekend, with special guests Vinyl Groove on Friday and Natural Wonder on Saturday. The feast concluded on Sunday with a Mass at St. Stephen's Church followed by a procession of the faithful, members of the Madonna Della Cava Society, and two marching bands — St. Alfio's and the Northeast Italian Band.



Ready for this? A second-grader at an Indiana public school was "banished" by his teacher after telling his classmates that he didn't believe in God. The seven-year-old was forced to sit by himself during lunch for three days and not speak to other students because, the teacher said, his views on religion had "offended them." His parents have filed a lawsuit.

It has been said that a boy is the only thing God can use to make a man.

Mother Superior Frances Fitzgerald says, "God doesn't expect us to solve all the world's problems — he only expects us not to create them."

Wow! A New York City high school student has complained she was awarded a diploma despite failing grades so the school could bolster its graduation rate. Melissa Majia says she was given a passing grade in her government class even though she hadn't done the work. Her teacher admitted being "under tremendous pressure" to meet academic goals, and said it was in "the school's best interest to pass her."

Get off her back! Hillary Clinton's use of a private email server while Secretary of State continues to cause trouble for the Democratic presidential candidate, as the FBI began investigating whether confidential government information had been "compromised." The Washington Post reported that the FBI's investigation comes after the intelligence community's inspector general requested that the Justice Department examine Clinton's private server. Clinton herself has not been accused of any wrongdoing and is not the target of the investigation, officials said. The FBI has contacted a Denver-based technology company that helped manage the server, which was installed in Clinton's Chappaqua, New York home in 2008. A spokesman said Clinton had never sent or received emails "that were marked classified at the time," though some of that material has since been retroactively deemed classified.

News from Basel, Switzerland. A retired and healthy British nurse ended her life at a Swiss assisted suicide clinic because she wanted to avoid becoming a "hobbling old lady," it was revealed. Gill Pharaoh, 75, had no apparent health problems, but said her decades-long career as a palliative care nurse for the elderly had shown her the stark realities of growing old. "I do not think old age is fun," Pharaoh told the Sunday Times before she died, adding that she had watched a friend suffer for years after a stroke and that she did not want to be a burden on her family. Assisted suicide is illegal in Britain, but a bill that would give terminally ill patients the right to die will be debated next month in the House of Commons.

Achtung! The German government is using the military to cope with a record influx of asylum seekers — prompting accusations that it is breaching Germany's strict post WWII constitution. Despite a ban on using the army for anything other than defense and national emergencies, soldiers have been deployed to erect temporary camps after refugee reception centers became overwhelmed and some migrant hostels were attacked by right-wing groups. Defense Minister Ursula von der Leven said the armed forces were simply trying "to help wherever we can." More than 300,000 people have applied for asylum in Germany so far this year, compared with just 26,000 for the U.K. in all of 2014.

Huh? A Texan's attempt to shoot a trespassing armadillo backfired when the bullet ricocheted off the animal's hard shell and struck him in the jaw. The man spied the armadillo on his property in Marietta, Texas, and "took his .38 revolver and shot three times." said Cass County Sheriff Larry Rowe. The shooter was airlifted to a local hospital, where his jaw was wired shut.

And Francesco Vigo (1747-1836) is believed to be the first Italian to become an American citizen. Vigo served as a colonel, spy, and financier during the American Revolution. He died a pauper, but in 1876 the U.S, government gave his heirs about \$50,000 to repay them for Vigo's financial support of the Revolutionary War.

Billy Martin, born Alfred Manuel Pesano, became the first Italian-American manager to win a World Series when he led the New York Yankees to victory in 1977. And Buttercup Dickerson, born Lewis Pessano in Tyaskin, Maryland, in 1858, was the first Italian-American player in the major leagues. He died on July 23, 1920.

### Recipes from the Homeland

#### VINE-RIPENED TOMATO SALAD

- 3 vine-ripened tomatoes
- 1 large cucumber
- 1 large onion 1 tablespoon dried oregano
- 1 tablespoon fresh basil
- leaves chopped (optional)

1 tablespoon fresh mint leaves chopped (optional) 3 tablespoons virgin olive oil Salt and black pepper to taste

Wash tomatoes thoroughly. Cut each tomato lengthwise into quarters. Cut each quarter into one-inch portions. Place in serving bowl. Then remove outer skin from cucumber and slice thinly as for salad. Add to tomatoes. Remove skin from onion. Wash and cut in half, lengthwise. Slice halves into 1/3" long slices. Add to tomatoes and cucumber slices. Cut in some fresh basil leaves and/or fresh mint leaves, sprinkle oregano and virgin olive oil over contents in the bowl. Add salt and pepper to taste. Mix thoroughly before

The combination of vine-ripened tomatoes plus the above mentioned herbs mixed with virgin olive oil enhances the flavor of this salad, though regular olive oil, canola or vegetable oil can be used.

NOTE: When I prepare this vine-ripened tomato salad today, I often think about growing up in Boston's North End. Fresh vine-ripened tomatoes were only available for sale during mid-summer. However, from springtime to fall, during those Depression days, we experienced the sight and fragrances of "container gardens" resting on our fire escapes and roof areas. My friends and I saw tomatoes grow from the small yellow blossoms that appeared on the tomato plants in

Some North Enders rented gardening lots in Revere or Woburn to grow their tomatoes, vegetables and herbs. I waited patiently for tomatoes and cucumbers to be harvested from my parent's garden lot in Silver Lake, Wilmington, MA.

Mama served us the fresh tomato salad for lunch many times together with our fresh bread, some cheese and roasted black olives. We also enjoyed the salad with suppers of baked poultry

Though he persisted with futile attempts to take back mainland China, the final blow to his legacy came in 1971 when the United Nations officially recognized the Communist Party as the only

ended with his death in 1975, were a sad affair indeed.

Even in Taiwan where he unleashed his brutal rule, Chiang maintains a number of followers, though he remains a highly divisive figure. However, few will argue that Mao Tse-tung was the step that China wanted, no matter how large his support base. Under him, China became something of a horror show, something it took the help of Henry Kissinger to overturn. Since then, China has climbed back to the sort of ideal Chiang wanted. But for a while, as Mao Tse-tung caused the death of thousands of Chinese citizens, Chiang Kai-shek could take some comfort, despite his failures, in being able to say "I told you so," a reoccurring theme with the figures I research for this series.

### Nanna & Babbononno

A Nostalgic Remembrance



Friday the 13th ... Babbononno claimed that he wasn't superstitious about bad luck. He didn't believe in it, but on the other hand, he didn't take any chances. Nanna believed in some of the old wives' tales from the Old Country, but she was Americanized more than Babbononno. If something went wrong, instead of blaming it on bad luck, she would say a couple of Hail Mary's and let it go at that. This month, the 13th is on a Thursday, so we're safe.

Babbononno, if he spilled salt, or even when he didn't spill any, would take the salt shaker and sprinkle some salt over a shoulder. If a black cat crossed in front of him or was near him, he would make the Sign of the Cross, mumble something under his breath and head on his way.

As a child, I once asked my grandfather why he believed in bad luck. He insisted that he didn't but would add, "Io non voglio tentare destino." (I don't want to tempt fate.) I can remember when my cousins Paula and Ellie and I were young children, and a Friday the 13th was arriving, Babbononno would tell stories about things that happened that no one could explain. One of the stories went like this, " I had a paesano who owned a fishing boat and often asked me and a couple of other paesani to go out with him just to enjoy the day. On the day I could make it, none of the other friends were able to go, so I decided I would go alone. It was a long time ago when mv children were very young, maybe 1920. Well, the day before the one when I was not working, I called Paesano Angelo, the owner of the fishing boat and told him I could make it. He was happy that I could go along and gave me directions to the fish pier and to where the boat was docked.

Babbononno and Angelo, the fisherman, talked over things, and early on that Friday morning, before the sun came up, my grandfather arrived at Boston's fish pier and boarded Angelo's boat for a day of fishing. Nanna, not knowing what was in store, packed a picnic basked for Babbononno with sandwiches, pieces of cheese, fruit and a bottle of wine. Once on board, Angelo, the fisherman, instructed my grandfather on the do's and don'ts of a working boat and, after the instruction period,

they headed out of Boston Harbor.

The boat was part of a flotilla of fishing boats that were so common in Boston 90 years ago and Babbononno just observed the happenings of the morning in amazement. They headed out past the inner then the outer harbors of the city, until they were out to sea and lost sight of land.

Once they were at a particular location where Angelo assumed there would be fish, the crew went into action plying their trade on a cloudy morning. Babbononno watched again in amazement as each crew member followed silent instructions and worked collectively to catch fish as they probably had done so many times in the past.

As the morning wore on, the skies didn't clear. As a matter of fact, it became foggy and soon you couldn't see more than a foot or two in front of yourself. Angelo told Babbononno not to worry, as they had a compass, plenty of gasoline and a fog horn to warn off boats that might come too close in the fog. Under his breath, my grandfather mumbled something about Friday the 13th and bad luck especially on his day off, but didn't say anything to Angelo.

The spot that was picked to stop and fish didn't pan out as there weren't any fish caught, so the decision was made to try another location. When they tried to start the boat, it wouldn't kick over. They checked the engine and that seemed ok, but the gas tanks were empty. Angelo, swearing in Italian, couldn't understand what happened as he had filled them early that morning. To complicate matters, a look at the compass showed that it was just spinning around, not allowing them to find a direction. To try to attract attention, Angelo had one of his crew begin to sound the fog horn at particular intervals. This continued for quite a while and, as time passed, my grandfather developed a slow panic but tried not to show it.

After what seemed like an eternity, they heard someone yelling, "Ahoy, ahoy." Angelo answered back and a voice in broken English yelled back, "This is the Ave Maria, a fishing boat out of Gloucester, do you need help?" Angelo yelled back that they did and kept sound-

ing the fog horn until the Ave Maria was visible. It was decided that the captain and crew, Portuguese fisherman from the port of Gloucester, would tow Angelo's boat back to Boston Harbor. Once the lines were attached, the tow began and Babbononno began to relax a bit but was still more than anxious about not being able to see anything in the dense fog.

The Ave Maria chugged along at a slow pace, just barely visible as it towed Angelo's boat. They passed the outer islands, the inner islands, and were soon in the calm waters of Boston Harbor. As they approached the fish pier, the fog began to clear just a little and the captain of the Ave Maria velled to Angelo, "Try to start your engine." Angelo tried, and his engine started. He checked his gas tanks and they were full. He couldn't understand it, nor could he understand how his compass was now working accurately. The crew threw off the lines and Angelo thanked the captain and men of the Ave Maria for getting them home safely and, as the thank you was being shouted, the Ave Maria headed back into the thick fog of the morning. Babbononno was relieved and celebrated by opening up the bottle of wine Nanna had packed in the picnic basket. He needed a drink.

Well, the day was shot for fishing and Angelo wanted to check his engine, gas tanks and compass before he did anything else. The boat zigzagged its way through the maze of Boston's fishing boats that had not sailed that morning and pulled into the dock where it was usually moored. The harbor master came out to greet the boat and ask Angelo why they were back before finishing a day's fishing. Angelo began trying to explain the happenings of the morning to the man and, when he reached the point where a boat came to their rescue. the harbor master just stood there with the look of shock on his face.

Angelo noticing the expression on the man's face asked him what was wrong. The harbor master began a slow explanation of why he was shocked. He spoke slowly and distinctly, stating that the Ave Maria was a well-known fishing boat from Gloucester but it had been sunk by a German submarine near George's Banks just after America had entered World War I about three years earlier.

This is how Babbononno ended the story and my cousins Paula, Ellie and I just sat there in silence fearing Friday the 13<sup>th</sup>. I don't believe in luck, but like Babbononno, I don't like to tempt fate. GOD BLESS AMERICA



### Hey, who's the Champ?


There Was a Time When Everyone Knew Who the Heavyweight Champion of the World Was

In recent years, boxing has deteriorated greatly. The skill level has dropped precipitously, commentators strive to discuss the sport in baseball-like terms by using crazy punch stat numbers, and there is an aura of professional wrestling when the fighters enter the ring that has had a demeaning effect on the sport. I could go on and on, but it is clear that boxing is very different from the sport, or as I prefer to call it, the art, it was a number of years ago.

One of the major changes has been in the loss of prestige the "Manly Art of Self Defense" has suffered. In the 1920's through the 1940's boxing, horseracing, and baseball were the most followed sports in the country. In the case of boxing, it was most likely the most followed in the world, and it could be argued that the Heavyweight Champion was the most famous person on the planet. As author Christopher Klein points out in his book Strong Boy, the Life and Times of John L. Sullivan, America's First Sports Hero, it was The Great John L. who elevated the role of boxing champion to celebrity. This was made possible by the creation of the intercontinental railway, which, for a word used at the time and the first time, enabled a not the worst of what was sports hero to travel at a relatively fast pace across the nation and be seen in person by millions of people. "I shook the hand that shook the world," were the words repeatedly spoken by those who met the Boston

Strong Boy. His fame took on mythical proportions, and that aura carried over to subsequent titleholders. James J. Corbett became known as the first scientific boxer and was noted for using brains over brawn when he won the title from Sullivan. In stopping Corbett, Bob Fitzsimmons added an anatomy lesson to the world of boxing with his paralyzing solar plexus punch that left Corbett helpless on the canvas.

And so it went on, with each new titleholder being recognized as a one-of-akind person. Each was known as the toughest man in the world, but also as a much larger-than-life figure that drew crowds wherever he went. Just getting a glimpse of the champion was enough to thrill people. Also, many of these champions fought either in other countries or defended their title against challengers from places outside of the United States, making them true worlds champions.

Fitzsimmons, a British citizen, was born in New Zealand, and Tommy Burns in Canada, making them the first two non-American title holders. Jack Johnson won the title from Burns in Australia and lost it to Jess Willard in Cuba. Jack Dempsey defended the title against Luis Firpo from Arand Georges gentina Carpentier from France. The list goes on throughout the years, further proving the legitimacy of being called World Champion.

The Heavyweight Championship has also been at the center of a number of social and political battles, as in when Jim Jeffries tried to win the crown from Jack Johnson. It was felt at the time that the white race had to be saved from being seen as inferior to the Negro, said. Joe Louis, a black man, transcended race when he represented America against Nazi Germany in his second fight with Max Schmeling, as did Ali in the first Ali / Frazier match, with all kinds of social overtones to it.

Starting in the nineteenth and lasting throughout most of the twentieth century the Heavyweight Championship held incredible significance. This is no longer true. If you were walking down any street in America during most of the twentieth century, and yelled out "Who's the Heavyweight Champ?" just about every man, woman, and child would respond immediately with the correct answer. That would not happen today. A whole generation, maybe two, exist that sees no prestige in

that honor, and it is no wonder seeing the proliferation of titles that now exist because of the various sanctioning organizations and the television networks that are complicit with them. I think the last undisputed and lineal Heavyweight Champion was Lennox Lewis, and he hasn't held the title since 2003. Since then, it has been mostly chaos. Walk down that same street today and ask who the Champ is, and you will get puzzled looks.

This is true not only of the heavyweight division, but of all the boxing weight classes. Tune into almost any televised fight nowadays and at least one, if not all the bouts, will be billed as for a world title. Boxers are becoming champions with less than a dozen fights under their belts. There is no longer a process where young fighters spend years learning the art of boxing, working their way up from preliminary fighter to a higher place on the undercard to semi-final status where they would hope to crack their way into contender status, a once great achievement unto itself.

The sport has been cheapened and demeaned by those who are profiting the most from it. In On the Waterfront, Terry Malloy, the character played by Marlon Brando, utters the famous lines "I coulda been somebody, I coulda had class, I coulda been a contender ..." Well, boxing no longer has class, and that is a shame for the fans, but mostly for those who work hard and step into the ring. They have lost the right to try to stand with the giants, to join the few immortals. They may be called champion, but they are in a crowded field holding a title that has no value or real meaning.

When I was a kid, I got to Jack Dempsey. Dempsey had lost the title many years before I was born and was, at the time of our meeting, an old man. But I still get excited when I think about shaking his hand and

#### HOOPS and HOCKEY in the HUB

A WHOLE NEW SEASON FOR JAROMIR JAGR — Down in the Sunshine State, where the climate never changes to hockey weather, the fortunes of the Florida Panthers may take an upswing to meet the higher temperatures.

If they do, that may be due in no small part to veteran NHL forward Jaromir Jagr, who will be starting his first full season in Sunrise, Florida, when training camp opens next month.

Jagr, who was sent by New Jersey to the Panthers for draft picks near the trade deadline back in February, left the northern climes as the third leading point producer on the Devils with 29.

Down in Florida he immediately resumed where he had left off in New Jersey in fact, he got better - coming away with 18 points in the 20 games he played with the Panthers. It's been said that a rising tide lifts all boats. That seems to be what occurred in Florida after Jagr joined the team. As one NHL writer has pointed out, the Panthers were 26-22-13 prior to Jagr coming on board. That projected to an 87-point team total in the standings over a full season.

With Jagr playing on Florida's top line alongside 19-year-old Aleksander Barkov and 21-year-old Jonathan Huberdeau, the Panthers went 12-7-2 down the stretch, projecting to a 101-point team total over the course of a full 82-game slate. With Jagr on their line, Barkov scored 7 goals and had 8 assists for 15 points while Huberdeau found the range for 6 tallies and 15 helpers for 21 points. Huberdeau concluded the season with 54 points — tops on the team.

Jagr himself wound up with 6 goals and 12 assists over the 20 games he played with Florida, and had 17-30-47 totals in the 77 games he played split between the Devils and the Panthers. In the closing days of the 2014-2015 regular season, he overtook Ron Francis and assumed fourth place on the all-time points list. He also passed Phil Esposito for fifth all-time in goals, Adam Oates for sixth all-time in assists and Alex Delvecchio for eleventh all-time in games played. Quite a productive 20game span, wouldn't you say?

When the regular season starts in October, Jagr will enter the campaign first among active NHL players in points (1,082), games played (1,550), assists (1,080), goals (722), plus/minus (plus 291) and power play goals (204). Among the all-time NHL leaders, he also ranks first in game winning goals (129) and fourth in points. In addition, he has scored 78 goals and amassed 121 assists for 202 points in the Stanley Cup Playoffs.

Those stats might even be more impressive if he hadn't spent three seasons (2008-2009 through 2010-2011) playing overseas in the Kontinental Hockey League. Oh, and by the way, he's also won an Olympic Gold Medal - with the Czech team in 1998. He also took home a bronze medal in 2006.

In an era where younger players seek long-term deals, Jagr is just grateful to get the opportunity to extend his career. Yes, he would have liked a two-or three-year deal. But he's realistic, not demanding. So, just a day after the conclusion of the regular season, the Ageless One signed a one-year contract with the Panthers, meaning he'll still be an active player in the NHL when he turns 44 on February 15<sup>th</sup>.

"We are extremely pleased to have resigned Jaromir," stated Panthers GM Dale Tallon in a press release. "He found instant chemistry with Barkov and Huberdeau. Jaromir's intense work ethic and positive attitude has had a tremendous impact on our locker room.'

Florida owner Vincent Viola added that "Jaromir is a true professional in every sense of the word and a worldclass player. This signing further shows our commitment to building a competitive and winning team in South Florida. In just 20 games, he became a fan favorite. We look forward to his continued contributions to our organization."

Florida is the eighth NHL team that Jagr has played for. Selected by the Penguins as their first choice (fifth overall) in the 1990 NHL Draft, he set right to work, winning the Cup with the Pens in both 1991 and 1992. Way back when Bruins Head Coach Rick Bowness got dismissed after losing to the Pens in the Wales Conference Finals in 1992. Jagr was on that Pens team that beat the B's. He's also played for Washington, the New York Rangers, Philadelphia, Dallas, the Bruins and New Jersey.

Over the course of his 21-year NHL career, he put together 15 consecutive 70-plus point seasons (from 1992 to 2008), a feat that stands as an NHL record. He also had 18 straight seasons with 50 or more points. He had 35 points in 48 games during the lockout season (2012-2013), but rebounded in 2013-2014 with 67 points — a year in which he turned 42 years old.

Jagr came to the Bruins late in the 2012-2013 season and played 33 games — 11 at the end of the regular season and 22 in the playoffs. Nevertheless, he made a big impression on the fans and media members. It was a sad day on Causeway Street when then GM Peter Chiarelli refused to sign him up for a full season.

Spanish explorer Ponce de Leon once searched all over Florida for the Fountain of Youth. Centuries later you can find an example in the Sunshine State. Just watch Jaromir Jagr in action.
