

### Glad Steve Bannon is Out of White House

### **Tomasone Honored**

at 15th Annual Community Fellowship Luncheon

The Boston Red Sox, in partnership with the Boston Area Church League, held their 15<sup>th</sup> annual Community Fellowship Luncheon on Friday, September 8<sup>th</sup>, at the Boston Back Bay Hilton Hotel. This year, local Robert "Ted" Tomasone was honored with the Ted Williams Home Run for Humanity Award.

Tomasone was born in Boston's North End, graduating from Boston English High School and going on to Northeastern University, the U.S. Army, and the Commonwealth of Massachusetts. Next month, Tomasone will have completed 53 years of service to the Commonwealth of Massachusetts Trial Court, where he currently serves as Clerk Magistrate of the Somerville District Court. But, more importantly, Tomasone has dedicated his life to serving the North End/Boston community and inner city youth. Over many years, he has raised over \$2 million dollars and sponsored community activities ranging from after school programs, exposing North End kids to music, theater, sports and museums, to hosting an annual Christmas luncheon for the elderly and shut-ins in the city, a much appreciated outing that includes money and gifts. One of Tomasone's many fundraising efforts is the annual

# Stirpe Nostra


#### THE VORACIOUS AND VICIOUS VITELLIUS

Two of Vitellius' most prominent characteristics were his love for luxury and his cruelty. Every meal became a feast for himself and every night he indulged in a drinking orgy. Most of the time he forced or tricked someone else into picking up the tab for his feasts, which were known to have run as high as \$20,000 dollars for one sitting.

An emetic is a medicine or substance that causes vomiting. It is common knowledge that these ancient Romans often took emetics to avoid the acid indigestion associated with overeating. Vitellius usually resorted to this practice in order to sustain his heavy eating habits. An example of the kind of meal that was set before this voracious man is indicated by the spread offered at his own brother's home to celebrate the arrival of Vitellius into Rome. There were two thousand of the choicest fishes and seven thousand birds. Other platters contained delicacies like livers of pike, peacock's brains, flamingo's tongues, and milt (reproductive glands) of lamprey eels (yech). Even when traveling, if he came upon anyone who just happened to be making a sacrifice of food to some god he would snatch it up and devour it on the spot.

Inflicting torture or death upon anyone for any reason was his other personal delight. Those who were selected for execution were invited to his court through every kind of deception and then seized.

Two sons who attempted to intercede to save the life of

their father were put to death with him. A Roman knight was ordered to be executed, and as he was being led away he called out to Vitellius saying, "You are my heir." After seeing his will, it was noted that a freedman was listed as a joint-heir along with the emperor; consequently, the freedman was also executed. Vitellius was even suspected of causing his ailing mother to starve to death because of an oracle that prophesied a long and secure rule if he survived his parent. Others say she was ailing and asked for poison, and that he quickly granted

During the eighth month of his reign, trouble started brewing in the provinces and some of the troops even swore allegiance to Vespasian. Offers to repent and even bribery failed to deter those who were determined to take control of the empire. When Vitellius received news that the enemy was drawing

near and his own forces had deserted him, he then gathered his most cherished possessions, his cook, his baker, and a girdle full of gold coins. He went first to his father's house, but after having second thoughts about remaining incognito, he then took refuge at the lodge of a friend. He tied a dog in front of the door and put a couch and mattress behind it. The invading forces quickly forced their way inside and dragged him from his hiding place. Vitellius attempted to escape capture by lying about his identity, but he was soon recognized. He then begged for his life to be spared and to be placed in confinement, alleging that he had important information that was vital to the safety of Vespasian. But the invaders, intent upon extracting their pound of flesh, bound his arms, tied a rope around his neck, and dragged him like a dog through the streets that were crowded with abusing and mocking citizens. They entered the Forum and this is where some people pelted him with dung while others hurled gross obscenities at him and still others taunted him about his bodily defects. He was tortured for a long time on the "Stairs of Mourning" and then killed by repeated blows. His head was paraded around Rome after his body was thrown into the Tiber River, and the spirit of the voracious and vicious Aulus Vitellius, the eighth emperor of the Roman Empire, was joined with those of his ancestors.

### Saint Catherine of Bologna

Catherine was born on September 8, 1414, in Bologna, Italy. She came from an aristocratic Bolognese family, her mother was Benvenuta Mammolini of Bologna and her father, Giovanni Vigri, an ambassador to Niccolò III d'Este, Marquis of Ferrara. She was sent to the court of the Duke of Ferrara as a lady-in-waiting for his daughter, Margherita d'Este, at the age of nine. During this time, she received an excellent training in reading, writing, music, singing, drawing and illuminating.

In 1426, however, after twelve years at court, she left and entered the convent of Corpus Domini at Ferrara. The convent, which had been established in 1406 as a lay community living a semi-religious life and



following the Augustinian rule, was considering changing to the Franciscan rule (something which eventually happened in stages in the early 1430s).

This fluid situation expe-

rienced by Catherine in her early years at Corpus Domini is reflected in her writings. In 1432, together with other young women of Ferrara, she founded a monastery of the Order of Poor Clares.

In1456, Catherine was asked by her superiors and the governors of Bologna to return to Bologna, requesting that she should become the founder and Abbess of a monastery of the Poor Clares that was to be established in association with the Church of Corpus Domini in Bologna.

Catherine passed away on March 9, 1463 at the age of 49. After her burial, it is said many graveside miracles occurred. Her incorrupt body was exhumed and relocated to the chapel of the Poor Clares in Bologna, to the church of Corpus Domini where it remains on display, dressed in her religious habit.

Saint Catherine was canonized on May 22, 1712, by Pope Clement XI. The Feast Day of Saint Catherine of Bologna is celebrated on March 9th.

Saint Catherine was a poet, author and painter; she is the Patron Saint of Artists and also against Temptations.

October is Italian Heritage & Culture Month. Each year, it is celebrated across the nation. It is an opportunity to learn more about our Italian heritage and culture and share with the rest of the American community.

In the paragraphs that follow, I have laid out the challenge we face. In regard to Italian Americans who are not part of the Italian American community, we must win over as many as possible. We cannot afford to say they are lost forever; never say die! Our future depends on expanding our community. And, always speak positively of your Italian heritage and what it means to you. Need help? ### WHAT CONSTITUTES ITALIAN AMERICAN IDENTITY?

There are approximately between 16 and 24 million Italian Americans living in the United States. However, this figure is an educated guess; there are a number of reasons for the lack of precision. One reason is what constitutes Italian identity. There are three basic groupings that lie within the population:

"Traditional" Italian Americans feel and act Italian, possess Italian values, and perform traditional practices. They identify with their Italian heritage by belonging to Italian American organizations, supporting our institutions, and keeping alive our Italian values and traditions.


"Cultural" Italian Americans do acknowledge some kind of identification with their Italian heritage. However, their way of life does not seem to reflect this acknowledgment.


"Non-Identification" applies to those individuals who have some Italian background, but for all intents and purposes do nothing to identify themselves as Italian Americans. They do not belong to Italian American organizations, support our institutions, or keep alive our traditions. Often, the only thing Italian about them is their Italian surname.

In order to preserve our Italian heritage in America, we need to pass it on to the next generation. It will not be easy, since so many Italian Americans fall into the non-identifying group! Some of them will be intrigued that you personally still appreciate your Italian heritage. Articulate the reasons and invite them to come to an Italian heritage event.

It is also important that we welcome the non-Italian spouse;



### L'Anno Bello: A Year in Italian Folklore

An Equinox and a Love for the Harvest

After a stifling hot start to the school year, which I spent teaching history to redfaced teenagers and cranking up the air conditioner in my home, I was relieved when one morning dawned overcast and cool. Finally, the smell of September — that wonderful month when the leaves begin to blush with shades of red and gold, and chilly nights creep in cat-like with their early darkness — permeated the air. Wherever I turn my head, it seems, signs of autumn wink at me playfully, announcing the presence of the season with a crisp and snappy flair. Juicy apples lent their tartness to an old-fashioned cake I baked for a family gathering not too long ago. Scarecrows smile from store shelves, their broad grins and crackly hair joyfully heralding the feasts to come. Leaves shine in the slick pavement after a rainfall. There is even a carton of iced pumpkin spice coffee sitting in my refrigerator, waiting for me to enjoy its creamy goodness. These hallmarks of fall intensify as we near the autumn equinox, which this year occurs today, Friday, September 22<sup>nd</sup>. This equinox embodies the rhythm that pulses throughout the fall, its measured dance of harvest and community and interplay between light and dark. Indeed, the autumn equinox is celebrated throughout the world, including Italy, as a seasonal marker and as a significant date in which people honor the generosity of the Earth.

The autumn equinox falls about halfway between the summer and winter solstices, and as such is used to indicate the passage of time. While

some people may mourn the end of the astronomical summer and its idyllic, carefree nature, it is important to look at the autumn equinox as an opportunity to begin anew. The return to work and school fills the air with a sense of purpose and organization, a feeling that will guide us as the cadence of autumn eventually dissipates into the jollity of the holidays. Since autumn brims with renewal, it is little wonder that many cultures begin their new year around the equinox. One such example is Rosh Hashanah, the Jewish New Year, which occurred on September 20th this year and is celebrated with meals of apples and honey to ensure the sweetness of the upcoming year. However, the equinox also signifies another important time change: while the day of the equinox consists of equal hours of day and night, after this date the darkness will overwhelm the light. The darkness beckons me indoors, to cozy evenings spent with my family and friends as our stories and laughter form a barrier against the dim night. I may even spend the early nights alone baking with the abundant produce of autumn, filling my kitchen with warm and spicy scents. The equinox affords us opportunities to reconnect with our families and our deepest selves, to devote time to projects and hobbies and take pleasures in the spirit of the season, which is at once both communal and introspective.

In addition to the turning of time, the autumn equinox is also a wonderful time to pay homage to the bounty of the Earth. In Europe, the last collection of harvest takes living off the land in a primarily agricultural society, may have waited until the Harvest Moon to finish harvesting their crops. The Harvest Moon, or the full moon closest to the equinox, illuminated the fields sufficiently so that farmers could work well into the night. This year, the Harvest Moon occurs on October  $5^{th}$  and, as usual, I will celebrate the occasion by baking my appropriately named Harvest Moon cookies, or almond cookies half-dipped in melted chocolate. As the harvest ended in Europe, many cultures would ritualistically cut the last sheaf of grain, a practice which stems from ancient times, when people believed that the goddess of the grain was embodied in the final remaining bundle. It was then time for cozy feasts known as "Harvest Home," which still exist to this day and can be seen in the harvest fairs that dot event calendars throughout the fall. For Harvest Home, the community gathers together at tables laden with the foods of autumn — apples, pumpkins, pears, carrots, nuts, ginger, spices — and celebrates the generosity of the land and the fruits of their labors. In Italy, these kinds of feasts often take the form of sagre. Derived from the Latin word "sacrum," which also lends itself to the English word "sacred," sagre are festivals devoted to a specific crop or product. Italians love their sagre, and the various regions of Italy have feasts that honor a local delicacy. Villages in Northern Italy, for example, may host sagre di mele — apple festivals — while Southern Italians often honor grapes in their sagre di uve. No matter what autumnal staple is being celebrated, these European feasts remind us that good food, a strong sense of community, and the love of family are sacred treasures indeed.

This equinox, let's bring back a sense of balance and purpose to our lives by enjoying the season. Rather than bemoan the darkness, we can welcome it by resolving to use nighttime as an opportunity to do something that makes us happy — whether it is spending extra time with our families and friends, or crafting some alone time in which we may develop our interests and hobbies. We can honor the bounty of the Earth by enjoying its fruits and truly relishing them, slowly biting into a tart and juicy apples and inhaling the spicy scent of a cinnamon-flecked cider. Moreover, we can spread the love of the Earth by donating our time or our food to those less fortunate. Let us carry the lessons of the equinox to our heart, and then the pleasures of fall will always have a home — a harvest home, if you will inside our souls.

They say some people are dangerous to know and in Elementary: The Fifth Season that truth never cut deeper. ### MERRILY WE ROLL ALONG

The Huntington Theatre

The Huntington Theatre Company plans to produce all fifteen of Stephen Sondheim's musicals. This year they have begun their season with *Merrily We Roll Along*, the Sondheim play with book by George Furth that had a very rocky beginning in 1981, closing on Broadway after just 16 performances. Sondheim and Furth revised the play in 1992, but not on Broadway. Twenty years after that, Maria Friedman, who played Mary in the 1992 production, directed a new production that became a hit in London's West End.

And now, thanks to Huntington's artistic director Peter DuBois, Boston audiences have a chance to see this wonderful production with Maria Freidman directing. For a play that had such a rough beginning, it has grown into a marvelous work.

The story is about three friends — Frank, Charley, and Mary — and is told in reverse. The play begins as their friendship is coming apart in 1976 and works its way back to when they first got together in 1957. It is a story of the challenges facing friends as they move ahead in life and begin to define their values, which can often turn out to be much different as they experience life. There is no doubt audience members will find much that is familiar in the play.

As the play opens, we learn of the tension between Frank and Charley whose friendship had led them to becoming a songwriting team and playwrights. Creatively they worked well together. The two had become quite successful, but each measures success in a different way and this has caused much tension between them.

Frank and Charley are played by Mark Umbers and Damian Humbley, respectively. They are reprising their roles from the West End production and are marvelous together. Mary is played by Eden Espinosa, who brings an honesty as well as tenderness to the role of Frank and Charley's novelist friend, who sees the destructive effect success is having on the friendship but is not able to do anything to stop it. She is also in love with Frank but never lets on to him.

In what is one of the musical highlights, Humbley as Charley is positively superb when he encap-

sulates all of his misgivings about what Frank is doing with the direction of their joint career. The number, *Franklin Shepard*, *Inc.*, takes place during an interview at *NBC* studios and is a high-octane piece that is a showstopper. The audience at the performance I attended loved it, as did I.

There is so much to love about this show. The score had to be structured in an unconventional manner, as the story is moving backwards in time. I would imagine Sondheim enjoyed playing with this music timeline. Music Director Matthew Stern is in top form. The choreography by Tim Jackson is a joy to watch. Watching the company moving about the stage during *The Blob* set in 1962 is

both very funny and brilliantly done.

Taking this ride back to where it all began is a fascinating journey. Along the way we go from the judgments we make of the characters having seen them after so much has occurred to learning how they got that way. It is so interesting to watch as it reminds us how fragile friendships can be and how what we value as individuals can create conflicts with those we love. It also reminds us of how hard it can be to frame our values when we are not sure of what it means to be successful.

Umbers, Humbley, and Espinosa are just fantastic. Add the remarkable Jennifer Ellis as Beth and Aimee Doherty as Gussie and you have a stage that is overflowing with talent giving us theatre that is a joy to watch.

Many years ago, a very successful man gave me a piece of advice. He told me not to chase success but to chase the idea. Success will follow. I believe by success, he meant happiness is seeing your idea blossom. I think Charley understands that. I think deep inside Frank does, too, but just can't allow himself to accept it. I also think Mary feels the pain for both of them.

I recommend this play as it is not only so well done, but it will also leave you reflecting on your own definition of success and the value of friendship. You could do worse than to ponder such things.

### THE ROYALE

Comes Out Swinging at the Merrimack Rep

The Royal, directed by Megan Sandberg-Zakian, is this year's season opener at the Merrimack Repertory Theatre in Lowell, MA. It is a fast-paced work that doesn't let up for a moment during its 80 minutes. Very loosely based on Jack Johnson's fight against Jim Jeffries, it is the story of Jay "The Sport" Jackson, who is the first back man to challenge for the Heavyweight Championship of the World.


Jay Jackson is played by Thomas Silcott, who brings us into the ring with and into the mind of the confident but conflicted challenger. Playwright Marco Ramirez has given him plenty to work with in this thought-provoking play, and Silcott is an amazing presence on the stage. The dialogue is crisp and sharp, just like an action-filled boxing contest. Ramirez not only gives us insight into what a fighter is thinking about while in the ring, but also deals with the wider implications of having a black man win the white-dominated championship in 1910.

and seems a bit uncomfortable with the social implications of the fight. Fish is excited to be a part of such a great event but is also naïve. He is the character who elicits sympathy from the audience. Both actors are strong and very competent in their roles.

Lighting and sound are used very effectively. A scene where Jackson is hitting the heavy bag while his shadow is cast against the side and back of the stage is very powerful. Mr. Ramirez has said that he sees boxing as a percussive sport and in-

This conflict is sharpened by a conversation Jackson has with his sister Nina, played by Ramona Lisa Alexander. Nina warns Jackson that his victory could result in violence against blacks across the nation, and she suggests subtly that it may be better for everyone if he lost. She feels that things are moving too fast and questions if Jackson is putting his personal gain ahead of his people. It is an intense back and forth that has the power of a hard-fought boxing match.

Mark W. Soucy plays the fast-talking white promoter Max, who also serves as reporter and commentator for the two boxing matches that take place in the play. His sharp dialog keeps the adrenaline flowing. As a ballyhooer, he puts Don King to shame. You can feel the excitement build listening to him. He's good.

George Bennett Watson as Wynton, Jackson's trainer, and Toran White as Fish, Jackson's opponent in the opening scene as well as his sparring partner for the big fight, are both excellent in their roles, which are a bit lower octane but no less important. Wynton has been around the game for some time

corporates a hip-hop rhythm into the play, which works very well.

The fight scenes are different in that instead of having the boxers throw staged punches at each other, they face the audience and punch towards them while also using the noise of stomping feet and claps to represent punches. It is a novel and very effective way to stage a fight, and the accompanying dialog along with superb lighting allows us to step into the minds of the fighters.


The Royale is a boxing play but it is also much more. In these heavily politicized times, I am always fearful that a playwright will, as they too often do, preach to the audience about how it should think. Mr. Ramirez instead chooses to leave us with questions. This is far more effective in helping bring us together to find common ground.

Whether or not you are a boxing fan, *The Royale* is a play that you should not miss.

### MEN ON BOATS a Sinking Ship

Men On Boats looked to be an interesting, thought-provoking, and even edgy play. Unfortunately, it was none of those things. The story, based on John Wesley Powel's 1869 expedition down the Colorado River to the Grand Canyon, has a cast made up of non-male actors in the roles of the explorers. It is an interest-ing concept and one I was looking forward to seeing played out.

When asked if she would call it a feminist play, author Jaclyn Backhaus is quoted in an interview saying, "I would like it to be one, if only to &!\$\$ off the six or seven old white men who walked out

during the first half of this past run." Well, as an old white man, all I can say to Ms. Backhaus is the only thing about this play that &!\$\$ed me off was the extraordinary tediousness of it. I would have been happy to have been off ended, challenged, or provoked by this production. I appreciate edgy work even if I don't agree with it. However, this was far from provocative. It was simply a dreadful waste of 100 minutes. If she wants to make people angry, and that is a very legitimate thing to do with theatre, she needs to do better than this. I would much rather be off ended than bored to death.

I have always admired the SpeakEasy Stage Company for its willingness to put on new and challenging works. And I have no doubt they will continue to do so. We are lucky to have such a company in Boston. I think it is important they do that, and I must say I have been influenced by many of the fine productions I have seen there. This just is not one of them.



The Lost Early Work of W.C. Fields

W.C. Fields is another comedian whose work we are fortunate to still have mostly intact. But Field's career was expansive and versatile. Over a decade before he even made a movie, he toured the world as a juggler and vaudeville stage remained his home until he starred in the 1915 short *Pool Sharks*.

Fields was on and off the screen throughout the 1920s, working with D.W. Griffith in Sally of the Sawdust. But sound provided his cinematic breakthrough. Fields is remembered today as a master of one-liners rivaled among his contemporaries only by Groucho Marx. Fields was a comedian like no other. While the zaniness of the Marx Brothers seemed to defy the Great Depression and Laurel and Hardy were tragiccomic victims making the most of the cynical world it created, Fields's characters couldn't give two cents for the world around them so long as there was booze and no children, "I like children ... fried," the comedian once mused.

Indeed, the '30s were Fields' golden years. His short subjects from early in the decade (*The Golf Specialist, The Dentist, The Fatal Glass of Beer,* and *The Pharmacist*) are near perfect comedies. And some of the



features (It's a Gift!, Man on the Flying Trapeze, The Big Broadcast of 1938, You Can't Cheat an Honest Man, My Little Chickadee, The Bank Dick, and Never Give A Sucker an Even Break) feature some of his best work.

Acknowledging the '30s as Fields' best decade, the loss of some of his early silent work seems less tragic. Undoubtedly, his best work has been preserved.

Still, one would like to take *That Royle Girl* (his second picture for D.W. Griffith) from 1925 off of its "Ten Most Wanted" lost films list. In the film, Fields is but a comic relief, the story belonging truly to Griffith at heart. A young girl from the slums (Carol Dempster) saves



a down-on-his-luck musician from being unjustly executed and melodrama ensues. Griffith was here working under strain, the bosses at Paramount keeping a tight watch on time and budget. By 1925, though, Griffith was hardly breaking ground in film as he had been a decade earlier and if there was a jewel in this film, it was Fields as the girl's gin-guzzling father.

The Potters from 1927, however, was a starring vehicle for Fields. The story concerns the Potter family and patriarch Pa Potter (Fields) who, always on the lookout for a fast buck, invests \$1,000 in a phony oil stock. Then, however, fortune seems to shine on the Potter family.

Though devoid of sound, *The* Potters in many ways resembles a classic Fields vehicle: an impoverished family and the mishaps of a scheming father. If only one of Fields's lost films could be unearthed, this would be the most valuable as in it one could trace the narrative roots of what is arguably his best sound picture, The Bank Dick. For now, The Bank Dick is the only visible legacy of *The Potters* and, for that matter, the best example of the legacy of W.C. Fields, the sourest comedian of the early talking pictures.

## Recipes from the Homeland

#### BAKED MANICOTTI

In Tomato Sauce with Meat

4 eggs 2 tablespoons olive or 2 cups flour vegetable oil 2 cups milk 1 small six-inch cast iron or Pinch of salt non-stick skillet

Practice is needed to be sure the same amount of mixture is poured into skillet for the same size manicotti.

Prehead oven to 400°F.

Break eggs into a bowl and beat eggs. Slowly add remaining ingredients one at a time in the bowl. Use an electric mixture on slow speed until it resembles a prepared pancake mix.

Rub inside of cast iron or non-stick skillet with some oil. Heat skillet over burner until it is hot. Remove from heat and with a small ladle, drop about two tablespoons of mixture at one end of skillet. Quickly tip skillet to allow batter to spread over the entire bottom. When firm but not browned (about five seconds), remove by lifting round edge with a fork or small spatula. Place in a dish to cool. There should be no need to turn the round over for further cooking. If you do, be sure not to brown the round crepe. Layer eight or ten prepared rounds one on top of the other. Continue making these until all mixture is used. Stir mixture occasionally.

FILLING:

2 pounds ricotta cheese
2 beaten eggs
2 pinch of salt

2 inch of black ground pepper
(optional)
3 tablespoons grated cheese of
choice (optional)

In a strainer, remove any excess water from ricotta cheese. Then place in a bowl. Add beaten eggs, salt, pepper and grated cheese of choice if desired. Blend but do not whip with electric mixer.

Taking one manicotti round at a time, place one to two tablespoon of filling in center. Then fold one end of round over the filling. Take opposite end of round and fold over to seal the filling in the stuffed Manicotti.

Using prepared tomato sauce, cover bottom of a manicotti baking tray with the sauce. Line bottom of baking tray with rows of stuffed Manicotti (seal side down). Spread tomato sauce over them and then sprinkle grating cheese of choice over sauce. A second layer of Manicotti can be placed over the first layer or, if preferred you can continue the process by using another baking tray.

Bake in preheated 400°F degree oven for twenty minutes. Check to see if ricotta mixture needs to bake longer before removing from oven. Ricotta is cooked when you pierce the Manicotti with a toothpick and it comes out clean.

Serves six.

Manicotti rounds can be frozen. Wrap cooled manicotti in wax paper in groups of eight or ten. Place in seal-locked plastic bags. Wrap each bag in aluminum foil before freezing. To defrost, remove from freezer and then from wrappings. Prepare a large serving tray with a clean towel. Cover with wax paper and allow defrosting on the towel before stuffing.

A Nostalgic Remembrance



I have always had a love affair with cars. Babbononno never drove. He was born just a few years before automobiles became the new toy to buy. As a result, he didn't understand what cars were all about and he hated every one that he came across. In turn, every car he came across hated him in return.

My father's generation was born somewhere between 1900 and 1920. By the time they were in their mid or late teens, cars were all the rage. It was a young man's duty to learn how to drive, obtain a Massachusetts driver's license, and hope that, someday, they could afford a car. My father was in this category with one exception — he needed a car. While in his late teens, Dad became a professional musician, playing bass violin, tuba and Sousaphone. It was difficult if you had to take the "T" to go to work carrying one or more of these instruments, so you bought a car.

I remember when I was a kid. Dad would reminisce about his Model T and his Model A Fords. When I came along, Dad owned a 1937 two-door Plymouth. He bought it used in 1938, when I was born. And Dad, being the utilitarian that he was, kept the car until 1949, when it was falling apart. He sold it to a teenager who told Dad that he was going to enter it in the demolition derbies that were often held at Norwood Arena, a long-gone racetrack located on Route 1, south of Boston.

A neighbor from across the street had just bought a new 1949 Chevy from Reese Chevrolet, an automobile dealership located in the Day Square area of East Boston.

The neighbor, a man named Tony Patti, bought the fastback Super Deluxe model, and Dad loved it. Even Babbononno liked the appearance of the sleek-looking car, which he called futuristic in appearance. Dad fell in love with Tony's new auto and had him bring us to Reese to look at their models. The "us" I refer to included Dad, Tony, Babbononno, me, and Dad's bass violin. If the bass violin didn't fit, Dad couldn't buy the car.

Dad wanted the same model that Tony our neighbor had bought, but there was a problem. When Dad tried to slide his bass violin into the sleek fastback model, it didn't fit. The way a bass player inserted his instrument into a car was as follows:

You opened the right door, turned the bass sideways, slid it onto the front seat with the bottom facing the steering wheel, lifted it and slid the back across the top of the seats so that the bottom faced the rear window and the top of the instrument faced the front window. This was back in the day before head rests, so the distance between the top of the seat and the inside roof was sufficient for the depth of the instrument. Unfortunately, the fastback model wouldn't allow Dad's bass to fit. The slant of the design cut down the headroom in the area of the rear seat and the bass just didn't fit.

Dad, unhappy, but undaunted, tried the bass in a two door sedan, a coupe with more headroom in the back than the fastback. The bass fit and Dad began bargaining with the salesman. This car was the Super Deluxe model with all the extras for 1949, a radio, a heater, a spotlight, full-sized hubcaps, a marbleized steering wheel, a red plastic hood ornament that lit up when the headlights were on, and whitewall tires. Like all Chevys before 1955, the car had a six cylinder engine with less than 100 horse power and, of course, a three-speed column shift standard transmission. (Automatic transmissions for Chevys were six years away.)

Even with the bass violin in the car, Babbononno was able to sit on the right front seat without a problem, so he was happy. Dad continued to bargain with the salesman and bought the car for \$1,200, cash. When we arrived back on Eutaw Street, Mom and Nanna came out of the house to look at Dad's new car. Dad brought the bass into the house and my mother and grandmother got in for the proverbial test drive. Mom, the first one to speak, said that the vehicle had a new car smell. Under her breath, Nanna said that the car didn't smell like an ashtray as did the '37 Plymouth, but I think I was the only one who heard her.

Dad would keep the all black car until late in 1954 and then trade it in for a Chevy four-door Bel Air model. (This was the car I would learn how to drive in and used to pass the state driver's test.) This powder blue and white car was kept for three years until Uncle Nick bought a '57 Pontiac four-door hardtop. Dad fell in love with Uncle Nick's new medium blue and white toy and bought the identical car. It was the high-end model and had an automatic transmission,

power steering, power brakes, whitewalls, full hub caps, and something new — a high fidelity AM radio. When I drove this car, my friends called it a "chick magnet."

This car was bad luck for Dad; it had an engine fire once and was stolen twice. He couldn't wait to get rid of it and went back to owning a Chevy. Dad, back then, was really a Chevy man. But, during the mid and late '50s, there was a phenomenon in East Boston regarding young men and their cars ... the cars had to be Oldsmobiles. There was an Oldsmobile agency at the traffic circle that separated East Boston and Revere, Bell Oldsmobile. As a result, everyone called the traffic circle, "Bell Circle."

Now, if you were a young East Bostonian who had a job, when you had enough for a down payment, you headed to Bell Oldsmobile and looked at the models you couldn't afford and bought one that fit into your budget. The epitome was an Olds model 98 hardtop or convertible, but they were close to \$5,000. Most of the guys who succumbed to the Oldsmobile fad bought either 88s or Super 88s, models with prices closer to what they could afford. I do remember a couple of the frequenters of the corner of Brooks and Bennington Streets who bought Oldsmobiles that they couldn't afford and had them repossessed. I don't know how long the Oldsmobile fad stayed with the guys from East Boston, but there were a lot of them on our streets well into the 1960s.

When I became a professional musician playing the bass violin, I had to do the same thing Dad did, take my bass with me when I was interested in buying a car. If the bass didn't fit, I didn't buy the car. Time to go ... don't forget, if you want to get in touch, email me at beagsley@rcn.com.

California, like Massachusetts, is trying to force presidential candidates to show their tax returns before being allowed on the ballot in either presidential primaries or the general election.


Last time I looked, the U.S. Constitution sets the eligibility to run for president. States have no business adding more rules to make ballot status.

### **George Chuvalo Turns 80**

### Why Did He Not Suffer from Brain Damage While Ali Did?

On September 12<sup>th</sup>, former heavyweight contender George Chuvalo celebrated his 80<sup>th</sup> birthday. Many people are commenting on how George has lived so long and is showing no signs of the effects of the punches he took over his long career. Many find it ironic that the "catcher" Chuvalo is clearheaded, while the great "boxer" Muhammad Ali had been showing symptoms of brain damage for decades before he passed away last year at the age of 74

Chuvalo and Ali fought twice. Their first meeting was in 1966, when Chuvalo took the fight on short notice after a planned bout between Ernie Terrell and Ali fell through. Chuvalo went the full fifteen rounds with the Champ and if the scoring was based solely on body punches, the Canadian would have won the title. Ali took the decision with his fast punching and movement. However, he did take enough of a beating to his body that he was urinating blood for days afterwards. Even though Chuvalo took a number of shots to the head, he and his wife were still able to go out dancing after the fight.

The two fought again in 1972, with Ali again winning a unani-

The numbers don't tell us a whole lot, so let's look at the fights. They both took on some of the best fighters in an era that was full of talent in the heavyweight division. They had a number of opponents in common, including Joe Frazier, George Foreman, Jerry Quarry, Floyd Patterson, Oscar Bonav-

mous decision. But, once again, George made him work for it. In a total of 22 rounds against Ali, Chuvalo was never close to being off his feet. Even though they were one-sided in the scoring, both fights were interesting and Ali knew he had been in

a fight.
So, to get back to the original question, why is it that George Chuvalo did not suffer the same fate as Muhammad Ali? Let's start by looking at the numbers. Ali had a total of 61 professional bouts in a career that spanned 21 years. Out of those 61 fights he won 56, lost 5, and was stopped only once. He was never counted out. He fought a total of 548 rounds.

Chuvalo had a total of 93 fights with 73 wins, 18 losses, and 2 draws in a career that lasted 22 years. He was stopped only twice and never counted out. Chuvalo was also never knocked off his feet. He fought a total of 501 rounds. Even though he fought a third more fights than Ali, he fought fewer rounds. There are two reasons for that. First, he stopped more opponents than Ali did, and second,

he fought fewer 15-round bouts.

ena, Buster Mathis, and Cleveland Williams. Ali fared better against this opposition than did Chuvalo, though Chuvalo did beat Quarry and Williams and lost very close decisions to Patterson and Bonavena.

Chuvalo is remembered as the tough guy who seemed to have an unlimited capacity for absorbing punishment. The only two men to stop him were Foreman and Frazier, two of histories heaviest hitters. Boxing fans remember both of those bouts well and will recall how Chuvalo took some terrible blows in both of them. It should also be remembered that neither fight lasted very long. Frazier stopped Chuvalo just 16 seconds into the 4th round. The Foreman bout ended less than two minutes into the 3<sup>rd</sup> round. Even though he absorbed some heavy punishment in those fights, we are looking at a total of roughly eight minutes of combat.

You might say George took a beating over a total of 27 rounds from Ali, but Ali never hit George solidly on the chin. Chuvalo kept his head down and didn't seem at all fazed about Ali's punches.

Okay, so that is just four of Chuvalo's fights. What about the other 89 bouts he was in? He must have surely taken plenty of punches in those fights.

Well, no. Out of those 93 contests, Chuvalo won 73 and 64 of those were by knockout. Also, the vast majority of those fights were against secondstring opponents whom George easily overpowered. Also, if you take the two Ali fights and the losses to Frazier and Foreman out of his 18 losses, you are down to 14 decisions George dropped and I can't think of one where he took a beating. His losses to Bonavena and Patterson were both close and disputed. The majority of his wins were pretty much walkovers. In contrast to popular belief, George Chuvalo did not take a ton of punishment over his career.

Contrast that with Ali. Take just his fight with Ernie Shavers. Muhammad probably took more punishment in that one fight than Chuvalo did in his entire career. While Ali won the 15-round decision, he took blows that I doubt any other human could have stood up to. He was repeatedly hit on the jaw and rocked by the very hard punching Shavers. Add to this fight the battering he took in the first and third Frazier fights, his three wars

with Ken Norton, his slugfest with Ron Lyle, and even his greatest victory over George Foreman, and you are looking at a man who received significant head trauma in the ring. Add to this his bout against Larry Holmes - a fight that never should have taken place, as Ali was already showing signs of dementia pugilistica by that time — and you have to come to the conclusion that over their careers it was Ali, not Chuvalo, who suffered the most punishment in the ring. Ali actually took many more head shots than Chuvalo did.

It really is ironic that George Chuvalo would have not only survived Ali, but also have come out of the game with his faculties intact while it can be argued Ali had the worst case of the effects from blows to the head than any of his predecessors. Yes, it may be ironic, but it is not surprising.

### HOOPS and HOCKEY in the HUB

Unlike the swallows that seem to regularly return to Mission San Juan Capistrano in California on St. Joseph's Day (March 19<sup>th</sup>) every year, the Bruins return to the Garden at a slightly different juncture every September. Some years it is shortly before the autumnal equinox while in some years it is a few days later.

Thus, it was on September 19<sup>th</sup> — three days before this year's equinox — that a training camp version of the Bruins made its way into the Garden for the annual curtain raiser on Causeway Street, a group of players that featured a number who will be sent to Providence before the regular season opener on October 5<sup>th</sup>.

For media members and Bruins staffers, it was a chance to catch up on summer activities. It almost seemed like the first day of school with questions such as "What did you do this summer?" and "Did you have a nice summer? Being the main conversation starters for the evening."

But, of course, there was a game to be played, against the Detroit Red Wings (another Original Six franchise) that attracted, according to an official announcement, over 16,000 fans to the arena. There was a good attendance, although it didn't appear that many turned out.

Very few of the Bruins veterans played in this contest, won by the B's 4-2, as head coach Bruce Cassidy used the game to evaluate younger players. It's a relatively short preseason this year, only six games, so every contest counts immensely in the fortnight of time before an Opening Night roster is announced.

"I mean, hopefully, I would like to have some very difficult decisions when training camp is over because players have pushed and played well," stated Cassidy following the game. It was his first postgame press conference as the official head coach of the B's after being elevated from the interim slot to the permanent position during the offseason.

"Hopefully you have a difficult time because guys have done what they've been asked to do," opined the coach. "You'd hate for it to be the other way. I think guys understand there is opportunity here and they've really pushed hard so far. I like these young guys. Many have played well in training camp, in the practices."

For those young players competing for roster spots, Cassidy offered some insights on the points he looks for. "Who is hard on the puck? Who is winning pucks? Who can keep their pace up? I think the young skilled guys are all capable of making plays. You can probably list seven or eight that have talent and could make NHL plays. That's what we are looking for — who can play against the men and compete and win the pucks."

And here's what may seems like a shocker. Remember in

the movie *Miracle* where coach Herb Brooks indicates that he wants a certain type of player for the 1980 U.S. Olympic hockey team, not necessarily ones that are the best? Well, it appears that Cassidy is going down that road.

"I don't think you can take the 12 best players necessarily (to make up four three-man lines). It's who fits, who plays better with who. You need different elements in your group. Having said that, some of the guys, we feel the younger guys that are competing for spots, have some similarities. They are guys that all make plays with good players."

That seems to narrow the field down a bit to which newer players can play best with the veterans (who enhances the line the most). It may not necessarily be in a scoring situation but who brings out the best in the other members of the line.

Take, for example Jake DeBrusk, who was the Providence Bruins' Rookie of the Year last season. He says he knows what the strong points of his game are. "I go to the hard areas and take a defenseman with me and get those pucks back and give it to those guys (veterans). They're pretty good with it. I thought we forced a lot of turnovers against Detroit. I thought we were all over the puck offensively."

For his part, Cassidy fells that DeBrusk "has fit in nicely. He's trying to attack the net. He's another guy who is hard on pucks. His pace is better than it was last year (in Providence). It goes to the hard decision part. He's really pushing it. He's playing on left wing on a line with David Krejci and David Pastrnak. He's giving it his all "

Of course, training camp is merely a start for any number of players. As Cassidy stated earlier, just because a player is sent down to Providence and doesn't start the season in Boston, that doesn't mean that he can be recalled at any time. He can. In fact, in any given season 5-10 players from Providence may play in Boston, some briefly, some for longer stretches while some may be called up and stay.

Another player who looked good in the Detroit game was backup goalie Anton Khudobin. He played in 16 games for the B's last season and dressed as the backup netminder for 38 contests. It's his second time around with the Bruins, having previously played 15 games on Causeway Street from 2011-2013.

He indicated that he engaged in an intense fitness schedule over the summer and is ready for duty. As a backup to starter Tuukka Rask, it's his position to lose. He'll probably start the season in the Hub and should stick if he performs in an acceptable manner. But a few less-than-positive outings may well result in another goalie taking his place. Only time will tell
