94th Annual Feast of the Three Saints

Lawrence, Massachusetts

The St. Alfio Society continued its Sicilian tradition honoring three brothers — St. Alfio, St. Filadelfo, and St. Cirino brothers who were martyred for their faith almost 1,800 years ago. The Feast is both a religious festival and a celebration of Italian culture. This annual tradition included a Torchlight Parade, Procession of the Saints, Italian food, amusements, games, a silent auction, a \$5k raffle, free musical entertainment, and free children's rides. And, of course, the popular Feast-favorite snack, crispellis!

The festivities began on Friday with the opening ceremony at Lawrence City Hall on Common Street and a procession to Corpus Christi Parish at Holy Rosary Church. Friday evening, the Main Bandstand entertainment featured local Italian crooner, Steven Savio, followed by the popular Italian tenor, Aaron Caruso.

Saturday events included the Three Saints Run for Veterans road race, the Lawrence YMCA Music Club, a Cannoli Eating Contest, a Taste of Italy with free wine tasting and food pairings, the music of Bustv Faro, the Torchlight Parade, fireworks, and a traditional musical salute entitled the Cantata. Entertainment included Doo Wop Deville,

vocalist Vanessa Salvucci, and New England's favorite, Beatlejuice.

Sunday began with a Solemn Mass in honor of the Three Saints continued by the Procession of the Saints' statues through the Feast neighborhood and finished with the "Moment of Glory" Benediction and Cantata with fireworks, confetti, and cheers of "Viva St. Alfio!" Musical entertainment included a Youth Battle of the Bands, Busty Faro, local favorite Ralph Boragine, R&B entertainment, and the legendary B-Street Bombers.

Stirpe Nostra

OTHO

Marcus Salvius Otho, the seventh emperor of Rome, was also the eighth Caesar. He was born on April 23, 32 A.D. During his early childhood, he was so wild and unruly that his father often had to discipline him by flogging. Later in his adult years, he pretended love for an older but influential woman in the court of Nero and used her to worm his way into the emperor's good graces. It is said that either because of similarities in character or immoral interests. Otho became a favorite of Nero and this contact helped him to keep informed on all of the imperial plans and secrets. Their closeness was such that Nero and Otho even shared the same mistress, who was named Poppaea Sabina. She had been separated from her husband and was living with the emperor. For some unexplained reason, she was turned over to Otho who seduced her, arranged a fake marriage, and shortly thereafter they fell deeply in love. Otho then refused to let Nero or his messengers near her, and even when the emperor stood at Otho's front door, demanding the return of his mistress, the door was slammed in his face. The crafty Nero then annulled the marriage, which he thought to be genuine, appointed Otho to the office of Governor of Lusitania (present Portugal), and recovered the mistress. Poppaea Sabina is the woman that was kicked to death by Nero at a later time because she complained about the emperor spending too much time at the chariot races.

Otho performed his appointed task with remarkable moderation and integrity for about ten years. During the final months of Nero's reign, Galba appeared

to be the people's choice as a successor, and Otho chose the opportunity for revenge by supporting the cause of Galba. Otho gave gifts of money to many soldiers, missed no opportunity to flatter or shower his attention on dignitaries, and when Galba ascended the throne, considered himself to be the prime candidate for adoption by the new emperor. Galba, however, selected a man named Piso. There were at least seventeen men named Piso who had attained varying degrees of fame during ancient times. This unfortunate heir to the Roman Empire was named Piso Liciuianus and he enjoyed his heirdom for only four years while Otho induced the Praetorian Guard to rise against Galba and assassinate him.

Shortly after Galba's death,

that emperor's administrators, and appropriated about two and one half million dollars for repairs or renovations of Nero's Golden House.

About the time that all of this was happening, the Roman legions that were in Germany swore their allegiance to Vitellius. As soon as this news reached Otho, he persuaded the Senate to send a delegation to inform Vitellius that an emperor had already been selected and to negotiate a peaceful settlement. It soon became clear that Vitellius would have no part of Otho, and marched his legions toward Rome. With characteristic rashness, Otho decided to engage the forces of Vitellius in a decisive battle as soon as possible and was victorious in three minor clashes. Finally, as peace talks were about to begin, Otho's defenders were treacherously attacked and defeated, and this is when he decided to take his own life in order to avoid further bloodshed.

After exchanging good-byes with relatives and burning personal papers, Otho put a dagger under his pillow and slept soundly that evening. At daybreak he stabbed himself under the left breast and was dead at the age of thirty-eight after only ninety-five days of reign. Otho was never considered to be a man of great courage. He was of average height, bowlegged, and slightly feminine in the care of

CIVICS EDUCATION BILL

The Teenage Republicans of Massachusetts, an organization of Republican students, has joined with the Massachusetts High School Democrats to strongly endorse the H.2016 civics education bill, introduced to the State House by Representative Linda Dean Campbell. The bill integrates student-led and project-based civics education into existing curricula. It seeks to correct the drastic deficiencies in civic education in Massachusetts schools and empower students to become involved in our democracy.

For years, there has been a painful lack of civics education in Massachusetts's public schools. There are few schools that offer any kind of government or citizenship classes, let alone have civics programs and activities. This has made for weaker public education, a weaker level of political involvement in younger people, and a weaker democracy.


Two months ago, the Massachusetts High School Democrats (MAHSD), an organization of hundreds of students from across the Commonwealth, publicly endorsed H.2016 in the Statehouse. Members of the organization testified in front of the State House Committee on Education and have been campaigning for the passage of the bill, discussing it with


lawmakers, and working to give the bill more media visibility. The Teenage Republicans of Massachusetts (MATARS), a similarly student-led organization, recently began their own effort in support of the bill.

Mike Brodo, Chairman of the Teenage Republicans of Massachusetts, attested that: "While I firmly believe that our generation has the capacity to become a leader of progress in the political world, students must be aided by civics education and engagement. Without an apt knowledge and understanding regarding how our political system works, it will be very difficult to make the changes needed for progress and cooperation in the years to come."

Michael Baick, Chairman of the Massachusetts High School Democrats, adds: "The joint support of the MAHSD and the MATARS highlights just how critical this legislation is for our democracy. The need for civics education and engagement transcends partisan squabbles."

Education reform is a bipartisan issue, and civics lies at the core of both education and democracy itself. Students from across the political spectrum agree that civics education needs a radical overhaul, and H.2016 is crucial to getting the

New Exhibit Honors Beloved Artist, FPAC Founder & Arts Advocate

Gallery at 249 A Street is set to premier Bejeweled, a new exhibit of works by Paola Savarino, to honor her memory and legacy not only as a creative force, but also as an accomplished advocate for affordable live/work space for artists in the City of Boston. Sponsored by the 249 A Street Artists Cooperative, Gallery East, and the South Boston Community Development Foundation, the exhibit runs through Saturdav, September 30th. Gallery hours are by appointment at 617-416-0718. The show reception takes place on Friday, September 8th, from 6:00 to 8:00 pm and is open to the public. Refreshments will be served. The exhibit and reception are FREE.

Bejeweled is co-curated by Duane Lucia and Tony Savarino, Paola's son, and features 25 paintings never before shown. They are works in acrylic, oil and mixed media, including glass beads and coins. The pieces portray highly textured, colorful and poetic images that dance on the canvas and energize the viewers' senses. "As a visual artist, much of Paola Savarino's experience translates into visual expressions," said Lucia. "Color, energy, symbols and surfaces are her means of exploring and understanding the world."

Early in Savarino's career, she illustrated Charles Bukowski's poem, "The Genius of the Crowd." In the 1980s, she became known for her large abstract canvases and, more recently, her encaustic mixed media Buddhas. She received numerous awards over the course of her career, including a Museum of Fine Arts Fifth Year Grant and an endowment from the WBZ-TV Fund for the Arts to create one of the first large arts projects — a billboard painting — in Fort Point. Her paintings are part of the permanent collection at The


Rose Art Museum at Brandeis University.

Born in Cleveland, Savarino moved to Boston in 1970 to attend the School of the Museum of Fine Arts, where she would later go on to teach painting. As Boston's Fort Point area - with its abandoned warehouses — became a destination for artists in the late 1970s, Savarino and others began working and living in the huge loft spaces despite

the buildings being commercially zoned. They feared being caught, every knock on the door inducing panic and a scramble to hide signs of residence. That was no way to live.

In 1980, Savarino helped found Fort Point Arts Community (FPAC), which set on a course to find, re-zone, purchase and renovate buildings in which artists could afford to work and reside legally. The organization's first success was the 249 A Street Artists Cooperative, where Savarino and her son took up residence along with 44 other artists. FPAC has since gone on to develop The Artist Building at 300 Summer Street and play an important role in establishing Midway Studios. Today, more than 300 artists live and work in Fort Point, and FPAC has become a model for artists' organizations nationwide.

Paola Savarino passed away on March 8, 2017. Her son, Tony, said, "Paola treated everything and everyone she came in contact with like a rare and precious jewel." It's clear that her spirit, talent and kindness live on with her family, friends and the Boston artist community.

L'Anno Bello: A Year in Italian Folklore

Treasures of the Vineyard: La Vendemmia in Italy

September is a glorious time of the year in Italy. The sun still bakes the landscape into splendid hues of amber and ochre. Local festivals called sagre celebrate the ongoing harvest, with town squares becoming veritable banquets of local specialties ranging from apples to truffles to figs. Of course, the country begins gearing up for the autumn as well, as the dusky nights become cooler and people adjust to the rigorous rhythms of the new season. However, one September event particularly captures the whole essence of Italy in the fall. It is called la vendemmia, or the grape harvest, and it sweeps the country through the autumnal months. La vendemmia is a sacred ritual in Italy, where the grape comprises a prized crop and its final product, wine, forms the crux of its national character. Throughout this harvest, Italian towns buzz with the energy of people collecting their grapes in giant wicker baskets or on the back of tractors, ready to be eaten as a fresh seasonal treat or distilled into the country's famous wines. Communal pleasures blend with hard work in order to create a beautiful dance of quaint customs, careful food preparation, and long-term planning for the cold months ahead. Observing Italian vendemmia customs reveals much about the power of the harvest as a way of respecting the Earth and the lure of traditions, even in modern Italy.

Indeed, the sight of vineyards perched on rolling hills, with dappled sunlight shining through the gemlike green leaves and violet grapes, has become an indelible symbol of Italy, often being the first image that enters people's minds when they think of the Italian countryside. Italian immigrants to the United States brought over their love for the all-important grape when they crossed the ocean, making it a staple of Italian-American culture. Grapes were my father's favorite fruit, and a bowl of translucent



and sweet pale green grapes, or velvety purple fruit, frequently sat on our kitchen table. Several relatives of mine grow grapes at home, the gnarled vines and wild leaves creeping over backyard trellises like a labyrinth.

Back in Italy, the same vineyards that adorn postcards and posters are humming with activity for the September vendemmia. Skilled farmers know the precise temperature and weather that make for the best picking conditions and will produce the optimal grapes and wine. Nowadays, many people adapt technological methods to la vendemmia, using the latest gadgets to test the acidity of the grapes. However, tradition still reigns supreme in many parts of Italy, where the whole village assembles to pick grapes, from the grandmothers in kerchiefs to the hip young people on break from college. One can sense the Bacchanalian revels of old in these communal gatherings.

La vendemmia is so vital in Italy precisely because much of these harvested grapes will be used in one of Italy's most iconic products, wine. Wine, or vino, holds a significant spot in Italian culture and society, finding a place on every dinner table as the foundation of Italian hospitality.

Wine is also imbued with a religious connotation, serving a prominent place in the Eucharistic ritual of bread and wine. It is not unusual for the basements in some of my family

member's homes to be stocked with bottles of wine, glowing an eerie shade of white and purple in the dim light, aged to perfection and ready to be brought out to greet the arrival of a guest. Actually, wine is such a touchstone of Italian society that numerous superstitions protect its reputation and warn of dire consequences to anyone who mistreats wine. A superstition that hearkens back to Roman times states that a person who spills wine must dab a little behind each ear to ward off any bad luck that comes from the waste of the precious drink. However, Italians do consider it good luck to spill wine on new clothes or a tablecloth. Perhaps this is a way for the wine to transfer its inherent positivity to the new garments. Miscellaneous wine superstitions further include never toasting with water, but rather always with wine; avoiding serving wine "backhanded," or with the back of the hand facing guests; and, for women, refraining from drinking the last drops of wine in a bottle at the risk of remaining unmarried (this superstition, of course, is from olden days when society dictated that women must get married). I do not drink wine myself, but I appreciate the wisdom and customs of my ancestors behind its making.

I believe that one of the most important lessons to be gleamed from la vendemmia is patience. Farmers must wait a long time for the grapes to be just right for picking; gathering the crop any sooner or later impacts that taste of the fruit and the eventual wine. Later, winemakers similarly ready themselves for the grapes to be distilled and the must to turn to wine. The traditional day in Italy for tasting new wine is actually St. Martin's Day, or la Festa di San Martino, which falls on November 11th two months after the bulk of the grape harvest has taken place. Afterwards, though, the wine becomes a crucial part of the Italian holiday season and beyond. As we enter the fall, with its new rhythms and its return to school and work, we can all learn lessons from la vendemmia. We can set many goals for professional and personal improvement, but we should realize that they will take patience, dedication, and hard work in order to manifest. Once they do, however, they will be as beautiful and well-earned as the finest Italian wine, which once started from the lowliest. barest vine. Just as Italians gather grapes this September, let us gather our own hopes, dreams, and challenges and work to make them come into fruition this autumn and all year long.



I kinda remember what it was like to be 19 years old in 1967. I graduated English High School the summer before and enlisted in the United States Air Force. I still remember being amazed that on Thanksgiving Day I was exercising with my U.S.A.F. flight group out on the field at Lackland AFB outside San Antonio, TX, and the temperature was a balmy 92

degrees. What kid from Boston thought it would ever be 92 degrees on Turkey Day when usually I was freezing while watching the English-Latin football game over at Harvard Stadium with usual temps around 35 degrees if we were lucky?

That year was packed with history, as 1968 would also be but 1968 is a topic for another commentary. The War in Vietnam was starting to go from bad to worse as the American body count in 'Nam escalated. I can still remember watching CBS News with Walter Cronkite and seeing that bloody war only get worse. I was actually really lucky never to have gone over to the battlefields, spending my time in the Air Force stateside.

A big song back then was "Turn, Turn, Turn" by The Byrds. Two weeks ago, I attended a funeral Mass for a good friend of mine at St. Mary's in Charlestown and one of the readings was a passage from the Bible that The Byrds turned into a hit record about a time for this and a time for that. To me, that was the only explanation that could show what 1967 meant to so many living through it.

The year brought lots of good things and bad, births and deaths, horrors and happiness. American cities were burned to the ground over that long hot summer of violence. Then there was Expo '67 up in Montreal. We can't forget that here in Boston we were burning up with Red Sox fever as our Impossible Dream took the lowly Red Sox into that year's World Series.

Finally, there was the birth of the City Paper in 1967, when publisher Paul Feeney helped create a newspaper of record out of a shopper's newspaper. Over these last 50 years, the Boston City Newspaper has grown into a must-read for many Boston neighborhoods that need information not likely to appear in our daily newspapers or on the TV news. Feeney is still at it and I have been by his side helping to turn out this little paper week after week, year after year, and decade after decade. Many others, too, along the way became part of a newspaper that would change the way we follow neighborhood news too little for the big papers to cover.

When I first met Feeney, he had a little storefront down across from a little coffee shop long since gone on Dorchester Avenue. The staff crammed into the closet-sized office and started some great Dorchester history and the paper expanded over the years to cover the news from more and more neighborhoods.

Back 50 years ago, Killer Kowalski was the man in the wrestling ring, you went out dancing every weekend at the original Boston

Tea Party club in the South End, and Kevin H. White took on Louise Day Hicks for mayor. Through it all, the Boston City Paper covered it all and continues to do so to this very day. America has gone from President Lyndon B. Johnson to President Donald J. Trump and the news media in Washington,

DC, continues to pump out fake news.

I was young and full of life, looking to the future with great hope despite bad things being witnessed. Today, except for being not so young, everything else stays the same.

Congrats to Paul Feeney and the Boston City, long may they both reign!



There's Good Rockin' in Ogunquit

HEARTBREAK HOTEL

Ogunquit Playhouse through September 30th

The early years of Elvis Presley are too often overlooked. Most Presley impersonators portray the Elvis of the Vegas stage, wearing capes and sequined jump suits. At this later point in his life, the drug use was really beginning to show, and the rock icon was becoming a tragic figure. The hard living would result in his untimely death at the age of 42. It is unfortunate this is the Elvis who is most often portrayed.

While the Las Vegas Elvis fits into the much too often tragic life of a great talent taken down by his own success, the more interesting story lies in his early years. This is where Floyd Mutrux, the creator of the Tony Award-winning Million Dollar Quartet, which played to sold out crowds at the Ogunquit Playhouse the past two seasons, has stepped in to tell the truly fascinating story of Presley's early life.

Heartbreak Hotel is a prequel to Million Dollar Quartet and focuses on the Sun Records years of the young truck driver who would skyrocket to fame overnight.

Heartbreak Hotel is now playing at the Ogunquit Playhouse where it had its world premiere on August 30th. It is an interesting production to watch, as it is still a work in progress. The music is positively outstanding, with all of the actors playing their own instruments.

Eddie Clendening, who originated the role of Presley in the Broadway production of *Million* Dollar Quartet, is not an Elvis impersonator. He brings much more to the stage than just an imitation of the rock icon. Clendening manages to capture



the persona of the young Elvis. Most impressively, he is able to rock out with the raw energy of Presley while always retaining that shyness that made him so charming. While ripping out on songs such as Good Rockin' Tonight with hips swiveling and lip twitching, we see that young boy who still seems just a bit uncomfortable in the spotlight even while he is thriving in it. Clendening really pulls this off and it is no easy task to do. This is as close as you will come to experiencing the young Elvis, a paradoxical figure who was shy and yet craved attention.

The story is not just about Elvis but also about the era. It was an amazing and transformational time in music and there are cameos from many of the other great performers of the time. These include Wanda Jackson (Brenna Bloom) and Sister Rosetta Tharpe played by Terita Redd, who deserves an "Amen!" for her amazing rock/ gospel singing.

Geno Henderson nearly steals the show playing numerous greats, including Chuck Berry and Nat King Cole. Mr. Henderson moves seamlessly through his parts.

The interplay between Colonel Tom Parker (Jerry Kernion) and Sam Phillips (Matt McKenzie) creates a tension, with Parker seeing Presley as a product and Phillips recognizing him as a great artist. It leaves us wondering just what would have happened if Presley had decided to remain with Phillips.

Yes, this play is a work in progress. The musical numbers, the sets, the lighting, are all outstanding. I don't think this time of Elvis Presley's life has ever been captured so well. Where this production is weak is in the book. The early life of this seemingly simple southern boy is a very complex story. It is a huge challenge to try to capture even a very condensed version of all that went on in those early years while still focusing on the music. What I saw on the stage in Ogunquit is a great start to what can be a wonderful and important story. It will be interesting to see how it all develops.

There are more than a couple of reasons to see Heartbreak Hotel. First, watching Eddie Clendening as the young Elvis is a true experience. He really gets it. Second, while this is a work that is still being developed, it is fascinating to be a part of the process as I am sure the writer and director are taking the pulse of the audiences. It might not be a bad idea for them to have suggestion boxes placed at the exits. I know I would have contributed a few.

Heartbreak Hotel takes us back to one of the most amazing eras in the history of American music. It is just astonishing when you realize how fast things changed. It was an exciting time that lives on in music through this day. It's rather ironic that Colonel Parker chose to take Elvis to Hollywood and Vegas, as he didn't believe Rock'n'Roll was going to last. Sam Phillips knew better.



Boston Native Keeps the Navy's Newest, Most Advanced **Helicopters Flying**

A 2012 Quincy High School graduate and Boston native is serving with a U.S. Navy helicopter squadron that flies the Navy's newest and most technologically-advanced helicopter.

Petty Officer 2nd Class David Hanna is an aviation electrician's mate with the "Grandmasters" of Helicopter Maritime Strike Squadron (HSM) 46, a Mayport, Florida based squadron that operates the Navy's next generation submarine hunter and Anti-Surface Warfare helicopter, the MH-60R Seahawk. Each helicopter is nearly 65 feet long, may weigh up to 23,500 lbs. (max gross) and can travel over 120 miles per hour for nearly 320 miles on a

As an aviation electrician's mate, Hanna is responsible for maintaining the helicopters and making sure they meet their

"I wanted the chance to do more with my life and get out of the city," said Hanna. "My older brother was Army and my younger sister was in the Marine Corps."

According to Navy officials, the MH-60R is the most capable multi-mission helicopter available in the world today. It is used for a variety of missions, including hunting and tracking enemy submarines, attacking enemy ships, search and rescue, drug interdiction, delivering supplies and supporting the Navy's special operations forces.

It is replacing the Navy's older helicopters because of its greater versatility and more advanced weapon systems.

Hanna said they are proud to be part of a war-fighting team that readily defends America at all times. In addition to his duties as an aviation electrician's mate, Hanna takes part in honoring those who have passed.

"I've served as part of a flag detail for more than 100 military funeral services," said Hanna.

Sailors' jobs are highly varied within the squadron. Approximately 297 Navy men and women are assigned and keep all parts of the squadron running smoothly. This includes everything from maintaining helicopter airframes and engines, to processing paperwork, handling weapons and flying the aircraft.

Serving in the Navy, Hanna is learning about being a more respectable leader, sailor and person through handling numerous responsibilities.

"Serving means paving a path for your family members," said Hanna. "The sense of pride you get is also important."

Recipes from the Homeland

NONNA MARY'S LIVER AND ONION

1 pound calf's liver1 large onion3 tablespoons olive, canola or

vegetable oil

3 tablespoons white or red wine ½ cup flour Salt and pepper

On a cutting board, cut up liver into one-inch portions and place in a bowl. Sprinkle flour over the liver and stir so that all portions of liver are coated with flour. Sprinkle liver with salt and pepper and set aside.

Remove outer skin from onion. Cut onion in half lengthwise.

Cut into ¼-inch strips lengthwise. Set aside in a separate bowl. Heat oil in skillet before placing liver into skillet. Stir to prevent sticking. Continue frying and stirring over medium heat until all portions of liver brown lightly. Add onion strips and stir thoroughly. Cover and fry over medium/low heat about five minutes. Check frequently to prevent sticking to skillet.

Meanwhile, in a cup, add three tablespoons of water to three tablespoons of wine of choice. When onion becomes opaque, add wine and water mixture to skillet. Stir thoroughly and cover. Allow contents to simmer slowly for a minute. Stir, cover and remove from burner.

NOTE: It always amazed me at how, in such a short time, my mother-in-law Mary prepared this Liver and Onions recipe. It's easy, she would say to me.

It took me a while to learn that liver does cook quickly in a hot skillet, then becomes brown over medium heat. Covering the liver portions with flour before adding to the skillet creates a delicious broth when the water and wine are added to the skillet.

Like my mother-in-law, I serve this with fresh Italian bread and a green salad.

The Stooges Completed ... Almost



In January 2013, fans of *The Three Stooges* had something to rejoice over. A print of their long-thought lost short *Hello Pop!* was found in a private collector's garage in Australia.

Most of the Stooges' shorts have survived to delight fans for decades and, though tantalizing to die-hard fans, *Hello Pop!* was a missing piece to overlook in their body of work. It was the third of five musical shorts they would make with boss Ted Healy before breaking out the following year with their own classic shorts. Their involvement is less than Stooge-heads would expect but, nonetheless, it was greeted with much fanfare.

In the film, Healy plays a producer whose attempts to start a production are thwarted by a stagehand, a pestering lady, and his sons, played by the Stooges themselves.

MGM decided to film in Technicolor and use the film as a vehicle for two musical numbers salvaged from older films. Like most shorts of its era, the prints were disposed of after the theatrical run, but a copy of *Hello Pop!* did survive in MGM's vault number 7 and became a casualty of the vault fire in 1967.

By 1967, *Hello Pop!* was but a forgotten entry in the Stooges's canon. After parting ways with Ted Healy, the trio made a total of 190 short films for

Columbia Pictures, surviving Curly's early retirement, Shemp's sudden death, and two painfully unfunny stand-ins for Curly after that.

But in 2013, Malcolm Smith, a seventy-eight year old Australian film collector, was cleaning out his shed when he came across a Stooges short.

"When I came across that one I thought, no, I'll put that aside. I suspected it could be a lost film," said Smith.

Smith then checked with a colleague, who confirmed the film to be the missing piece in the works of the Three Stooges. Smith bought the 35mm negative in the 1950s and it had remained in his shed for decades along with other treasures, such as a sound version of *Hollywood Party*, another rare MGM short.

Paul Brennan, then head of the Australian branch of

Warner Bros. Archives, shipped the film to the States observing, "Across America, there are probably five million hardcore *Three Stooges* fans. On NitrateVille or any of the websites that search for lost vintage material, there is euphoria that the sole missing Three Stooges film has been found."

Brennan theorized how the only known surviving copy ended up in Australia. "They'd ship prints out here and they never needed to come back. Often they were souvenired from the rubbish bin or the tip," he said.

The discovery of *Hello Pop!* leaves but one film featuring the Stooges still missing, the following year's *Jail Birds of Paradise* which, though also not featuring the Stooges prominently, does feature a sequence shot for MGM's unfinished musical extravaganza *March of Time*.

Saint Ludmila of Bohemia

Saint Ludmila was born in Melnik, Bohemia, about the year 860. She was the daughter of the Sorbian prince Slavibor. Saint Ludmila was the grandmother of Saint Wenceslaus, who is widely referred to as Good King Wenceslaus.

Ludmila married Duke Borivoy of Bohemia, whom she followed into Christianity. They built a church near Prague and tried unsuccessfully to establish Christianity within their realm. Upon the death of Borivoy, his sons Spytihinev and Wratislaw (who married Drahomira, a pretended Christian who actually favored paganism) succeeded him. Wratislaw and Drahomira had

twin sons, St. Wenceslaus and Ludmil Boleslaus the Cruel, the former of ly after h

whom lived with Ludmilla at Tetin. Wratislaw died in 916, leaving the eight-year-old Wenceslaus as his successor. Jealous of the influence that Ludmilla had over Wenceslaus, Drahomira is said to have persuaded two noblemen to murder her. She is said to have been strangled by them with her veil in the year 921.

Ludmila was canonized shortly after her death.

She was at first buried in the church of St. Michael at Tetin, but her remains were removed to the church of St. George at Prague before the year 1100, probably by St. Wenceslaus, her grandson. She is venerated as one of the patrons of Bohemia, and the feast of Saint Ludmila of Bohemia is celebrated on September 16th.

A Nostalgic Remembrance



I shouldn't do this, but now that I live in both the Boston area and southern Florida, I compare friends and acquaintances. What I mean is that, as I have gotten to know people in Florida, I measure them up and compare them with my friends back home. I know I shouldn't do this but I can't help it. Over the years, I have put together a little family of friends to take the place of the brothers and sisters I never had. In this column, you've read about Sal Meli, Dean Saluti, John Silva, the late Bill Hurley, Joe Carter, Ed Ligon, Mike Finer and Bill Strachman. This is my inner circle of friends younger adopted brothers, as it were. But in Florida, even though I have new friends, I silently make comparisons with the guys back home — and I shouldn't.

I think I have adopted people due to learning from Nanna and Babbononno and my folks a generation or two ago. Both of my grandparents had people they were close to that were called paesani, compari, or amici. Most were people from Avellino, Napoli or Foggia that were in America alone. These single folks seemed out of place whenever we had a holiday gathering at my grandparents, but they were made to feel at home and part of the family.

My folks did the same thing a generation later with some of the people Dad worked with. My father was with the Boston Schools during the day and a musician at night. As a result, there were friendships that developed from both professions. For the most part, their wives and Mom hit it off and their kids and I would play together like siblings or cousins would. Believe it or not, most of the friends for those three generations can be classified as normal — whatever normal

My friends in Florida are quite different. To begin with, there is an elderly couple next door. The man has a number tattooed on his arm due to the fact that, as a child, he was in a Nazi death camp. In 1945, the camp was taken over by invading American soldiers and my neighbor survived. His wife tells me that sometimes at night, he relives those days of his childhood and will wake up screaming. He has never left the past behind.

Stella, a dedicated wife, has never been able to help her husband overcome his early years.

Another couple that we are friendly with has a successful business. He was from Brooklyn and she from Brookline. They live in a fashionable neighborhood, have two new Mercedes Benz cars and all the trappings of good living, but they fight all the time. The woman looks for mistakes in the daily operation of their business and blames her husband, coming up with contrived flaws in his being that have caused the problems. The man is low-key and relaxed, and when he is verbally attacked by his wife, just backs off and takes the abuse. He's not confrontational, she is. Each time they call to go out to dinner, Loretta will ask, "Are they fighting, or is there a truce?" If there is a feud going on, we give them an excuse and choose not to be in their company. It can be nerve-wracking.

Most other couples we've met have been divorced once or twice and all have stories about their earlier lives. One couple is funny. He's Irish, she's Jewish, and both are from New York. My Irish friend was married to a Sicilian lady who passed away. (He's an Italian wannabe.) His Jewish wife is divorced, and together remind me of the comedy team of Jerry Stiller and Ann Meara from TV years ago. Not long ago, they told Loretta and me that they were heading back to New York for a christening and a bris. Rich, the husband, was going to attend his grandson's christening at their old parish church, and his wife Fran was going to attend the bris of her grandnephew. If you don't know what a bris is, I will tell you. As Christians and Catholics, we baptize infants as part of our cultures and traditions. Jewish customs dictate that a male infant has to be circumcised, and they celebrate the event with a ceremony and a party afterward. It sounds like a Christening, only with a sharp knife included.

There are several other stories I could relate, but to sum them all up, it seems that most of the people we've met have chosen southern Florida as a place to start life over. No one has Florida roots. All are from the northeast — New York, New Jersey or Massachusetts — and all have sad or angry stories

Another couple that is only in Florida in the winter is an Italian couple from New Jersey. As I got to know the man, I discovered that he lived in Italy as a child during WWII. Some of his stories can be shocking, especially when his town's people had to deal with the German soldiers who were stationed there. His wife, like many of us, is third generation.

And yet, another couple that we see, maybe, once a week for dinner divorced each other for 15 years and decided to remarry a couple of years ago. Lee is an actress and does mostly stage work during the winter season when there is work in southern Florida. Her husband, Tim, is a scenery designer and has won many awards for his imaginative designs. Both are originally from the midwest and have ancestries that go back to at least the Civil War. (They are probably the most normal of our friends.)

At times, when Loretta and I are heading back from an evening with one or more of these couples, we discuss how different our lives are from theirs. She will often make the sign of the cross and say, "Thank God we're so different." Back home in Boston, it's quite different. We have roots, as do all of our friends. Socially, we are part of an extended family, especially through the Italian-American organizations we belong to. Life is sweet, life is comfortable, and life is normal.

I would like to change the subject at this point. I have written a book that is coming out this fall. It is a series of 18 short stories about growing up in East Boston and attending English High School in the mid-1950s. If anyone is interested, I will be having a book signing at some point in the fall. I don't know where yet, but I will keep you informed as to location, dates and times. YOU and this column have been the inspiration for the book.

I have to thank Babbononno and my father for prodding me to write the stories I had heard as a child growing up in Eastie, going to high school in town, and meeting people from the rest of the world.

TONY SHUCCO

One of Boston's Greatest, He Should Never Be Forgotten

I remember getting to know Tony Shucco when I was a young amateur boxer training at the New Garden Gym in Boston. He would climb the stairs to the fourth floor of the legendary gym many a day to watch the fighters work out. He was usually quiet, but it was obvious he enjoyed being there. Boxing had been and still was his life.

It is sad that such a great fighter, a man who defeated five world champions — including two heavyweight champs — is not better remembered. Shucco was among the best boxers to fight out of Boston and deserves to be recognized for that.

Not long ago, I spoke with his daughter Angela and she allowed me to look at a box filled with letters, photographs, and news clippings of her father's career. She is very proud of her father and hopes more people will learn about his career.

Tony Shucco was born June 13, 1911, and grew up in Boston's North End where he lived most of his life. His original name was Anthony Sciucco, but he changed it to the more easily pronounced Shucco when he began boxing.

After an outstanding amateur career that consisted of nearly a hundred bouts and numerous championships, Shucco moved onto the professional stage with his first fight in 1928. He would remain undefeated for 18 fights before dropping a decision to the great Johnny Indrisano at the Boston Arena. At that time, Shucco was campaigning as a welterweight but would begin moving up through the weight classes. And like so many great boxers who start off at lower weights, he retained the speed

and skills that are rarely seen in the heavier fellows.

Shucco was a brilliant boxer who possessed one of the best left jabs in the business. And, though he rarely weighed over 180 pounds, he fought many of the leading heavyweights of his day. He defeated Natie Brown, Lee Ramage, Tuffy Griffiths, and two heavyweight champions, Jack Sharkey and James J. Braddock. He also scored wins over champions Maxie Rosenbloom, Bob Olin, and Lou Brouillard.

Tony Shucco was a solid top contender for years and it is unfortunate he never got a shot at a title. He certainly had the credentials for it, but back in those days there were so many outstanding fighters competing you really needed to be connected to get a shot.

In 1938, Shucco traveled to Europe where he had an English representative by the name of Tom Hurst. He was a making a name for himself across the Atlantic with fights in England, Ireland, and Germany. In letters he wrote home, he began signing his name "English" Tony Shucco. While there he became close friends with American Flyweight Champion Jackie Jurich, who was also represented by Hurst. The clouds of war were starting

to gather and it was difficult being separated from his wife Etta and young son Anthony, so Shucco returned home. He was immensely popular with the European fans and surely could have built a great reputation on the Continent had he continued fighting there.

When he returned to the States, he dropped a close decision to top-rated heavyweight Bob Pastor and then went on a winning streak. It is at this point in Shucco's career where he just couldn't catch a break. In 1940, Heavyweight Champion Joe Louis agreed to defend his title in Boston. The logical opponent for Joe would have been Tony Shucco, who was on a six-fight winning streak. He was back from Europe, in good shape,

and full of confidence. Unfortunately, the title shot was given to Al McCoy, who had lost three of his last six fights, including two consecutive losses leading up to the Louis fight. I am not sure why McCoy was chosen over Shucco, but it should have been Shucco in the ring on that December night.

I am not arguing Shucco would have beaten Louis, as there wasn't a man on the planet who could have taken him back then. But, I will make the case Shucco had the style to give the Brown Bomber some trouble. It is also highly possible Shucco could have lasted the distance. It is a shame he did not get the opportunity to fight for boxing's biggest prize against its greatest champion. I can guarantee you he would have been remembered for that and would have made Boston proud.

It is interesting to note that after the loss to Pastor, Shucco continued without a loss until he retired in 1942. In spite of this great record, he would never get that elusive shot at the title.

In 1944, Shucco embarked on a comeback. He had seven bouts, winning three and losing two with one ending in a draw. He retired for good in 1944.

When I got to know Shucco, he was showing the effects of the punches he took later in his career. I remember being told at the time that his managers, one of whom was a relative that I shall not name, kept him fighting to cash in on his reputation. At that point, Shucco's legs were not what they used to be and he was taking punches he easily would have avoided as a younger man. Once again, that dark side of boxing reared its ugly head.

I spent many an afternoon talking with Shucco in the New Garden Gym. He always

HOOPS and HOCKEY in the HUB

NEWLY ATTIRED — When the Boston Celtics open the regular season in October, they'll sport a new look — and it won't be just concerning the roster makeover that took place during the summer.

While much attention has been focused on the player personnel moves the Celtics have made, they'll also have a new look in attire as well, wearing freshly designed uniforms that are gradually being introduced.

The new designs have come about in the aftermath of the NBA's switchover to Nike as the official uniform provider. There will be new uniform designs for all 30 NBA teams. Each team will have four new designs. In addition, eight teams also will have "classic" uniforms to wear at various points throughout the season.

One of the major changes is that the Nike Swoosh Logo will appear on the uniforms of 29 teams. The logo of the previous provider (Adidas) did not appear on the uniforms. The uniforms for the Charlotte Hornets will be adorned with the Jordan "Jumpman" Logo, a nod to the former NBA superstar and his majority ownership of the team.

Another change is that many of the league's teams have sold space on the jerseys for sponsorship logos. The General Electric "GE" logo will appear on all Celtics uniforms this season.

In another change, the designation of "home" uniforms and "road" uniforms is being eliminated. Or is it? In an official press release, Nike noted that at the start of the season, each team will choose a uniform that will be worn at all its home games. Visiting teams will choose a uniform of contrasting color.

But as the season gets underway, there initially will be only two uniforms for each team. One is called the Association Edition and is essentially the home white uniform that NBA teams have worn over the decades. The second is called the Icon Edition and was, as the Nike release states "previously known as the road uniform." It is dominated by the team's primary color — that is green in the case of the Celtics.

The two additional uniforms that each team will eventually acquire include one that will be "inspired by the mindset of the NBA athlete" while the other will reflect "the communities that support their teams."

The "Classic Edition" celebrates some of the most iconic uniforms in league history and can be worn at each team's discretion. We think that both the Celtics and the New York Knicks will qualify since they are the only two original NBA teams still playing in their original franchise cities.

The new uniforms will be a blend of yarn and recycled polyester, with each uniform using material from 20 recycled plastic bottles. Nike says that

the new uniforms will wick away sweat 30 percent faster than the uniforms used last year.

Looking online at the two versions that have been released so far, I don't see that much of a difference between the new uniforms and those of recent years. Online preliminary sketches of the other two versions didn't seem to be that different, either (other than perhaps dark colors). It doesn't appear that radical design changes are in store. The materials used in making the uniforms may change somewhat, but the designs do not seem to be a radical departure from the past.

However, no sketches were available for the "Classic Edition." Those could truly be special. We will just have to wait and see what is unveiled when the time comes.

NOEL SIGNS WITH DALLAS

— Everett's Nerlens Noel will be a member of the Dallas Mavericks for the entire 2017-2018 season after signing a \$4.1-million contract in late August.

Noel had been traded to the Mavs by Philadelphia back in February at the trading deadline. After his arrival in Texas, he averaged 8.5 points, 6.8 rebounds and 1.1 blocked shots while playing center in 22 games.

Born in Malden to parents of Haitian heritage, Noel played two years at Everett High School before transferring to the Tilton School in Tilton, New Hampshire. A top college recruit, the 6-11 center played one year at Kentucky before leaving for the 2013 NBA Draft.

Although he suffered a torn ACL knee injury in February 2013 while at Kentucky, he was taken sixth by the New Orleans Pelicans, who promptly traded him to the Philadelphia

It can take a significant period of time to heal and rehab after ACL surgery. In Noel's case, it caused him to miss the entire 2013-2014 NBA season. Thus, the 2014-2015 campaign became his rookie season. He responded by playing in 75 games, averaging 9.9 points and 8.1 rebounds. In his second season (2015-2016), he upped his scoring average to 11.1 while his rebounding average remained the same at 8.1.

Last year, his knee flared up again at the start of the season. He only appeared in 29 games, mostly as a substitute, before being traded to Dallas on February $23^{\rm rd}$.

In his first game for the Mavs, he recorded nine points and 10 rebounds in a win over the Pelicans. A few days later, in his first start, he tied his career high in rebounding with 17 and added 15 points in a victory over Memphis.

The Celtics will play at Dallas on November $20^{\rm th}$. They will host the Mavs at the Garden on December $6^{\rm th}$ in what will be a homecoming for Noel.
