

THE HOSPITABALE AUGUSTUS

The villas of Augustus were not considered lavish but he did decorate with rare items such as the bones of huge sea monsters or wild beasts, and also the weapons of heroes. His furniture was plain, simple, and on a par with that of private citizens. Even his house clothes were common and made by the women in his family. He wore a form of elevator shoe to gain a bit of extra height and he always kept suitable clothing available to wear in public.

He gave many formal dinner parties and always observed protocol, along with the personality of his guests. On those occasions when he was late to dinner he permitted his guests to begin before he took his place. He also insisted that they complete their meal if he was required to leave early for any reason. His dinners usually consisted of three courses, but when he was in a lavish mood he served six. They were never extravagant but were always steeped in goodfellowship. He always tried to draw the silent guests into general conversation, and usually provided entertainment in the form of actors, musicians or storytellers.

He was a light and irregular eater and his tastes were plain. He often ate before and after a dinner party but not during it. He particularly liked coarse bread, small fishes, homemade cheese, and green figs. His favorite wines were vinum setinum, the finest wine in all of Italy made at Setia, near the Pontine Marshes and also Raetian wine from the Alpine country.

Although he was very fond of wine, he drank it very sparingly. He could never consume more than a pint otherwise he would "upchuck" it. He never drank before dinner but for an antipasto he would take a bit of bread soaked in cold water, a slice of cucumber, a leaf of lettuce or a piece of dried apple. His favorite after dinner sport was to auction off paintings of which only the back was shown and requiring all of the guests to take part in the bidding. He went all-out on holidays, especially the Saturnalia (comparable to our Christmas season) and gave gifts of clothing, gold, silver and rare coins. He observed a daily siesta after the noon meal but after dinner he retired to a couch

in his study to attend to the remains of the business of

Augustus was not without his share of superstitions. At one time he had a narrow escape from lightning during a journey, consequently he carried a sealskin on trips as a protection, and at any sign of a violent storm he sought refuge in underground vaulted rooms. During a battle he became ill and intended not to leave his tent, but a friend's dream and warning caused him to spend the night elsewhere. His camp was entered during the night by the enemy and his litter was stabbed through several times in the belief that he was still lying there. During the spring of that year, he had many fearful but unfulfilled dreams. The dreams during the balance of the year were less frequent but more reliable. He considered it to be a bad omen if his shoes were put on wrong in the morning but starting a journey in the drizzle of rain was a good omen. Lastly, he never took up any important business during midday.

ALL THE WAY WITH JFK

On January 12, 1961 when I was still 13 years old in Sister Mary's Honor 7th grade class at St. Rita's Grammar School, President-elect John Fitzgerald Kennedy delivered his famous "City on a Hill" speech in the State House chamber before a joint session of the Legislature. This past January 12, his greatnephew Joseph P. Kennedy III stood at the same dais and delivered his speech about the current atmosphere of politics in America. He recalled the message of Dr. King and his own grandfather Bobby Kennedy, both gunned down two months apart in 1968.

Kennedy, an assistant district attorney down on Cape Cod, urged all Americans to return to "service and sacrifice, integrity and dedication" and said these were the ideals "that ought to endure."

Back in 1960, I was inspired by Jack Kennedy and what he said. Still in 1968, I listened to and watched both Dr. King and Bobby Kennedy. I remembered November 22, 1963 five years later when both King and Bobby Kennedy were gunned down in senseless acts of violence. I remember turning 20 years old in May 1968 right in the middle of both their deaths. I still felt inspired but also jaded because good men were dying trying to do the right thing for all of us.

Back then, we weren't just Democrats, Republicans, liberals and conservatives but Americans with a common cause. We need to find that common cause again. America needs to work for its people again. Right now that isn't happening. We need to see that shining light high up on that hill again. Government needs to be that lighthouse rather than an iceberg ready to crash into us.

Finding Answers on Race at the Museum



A new exhibit on race and racism at the Museum of Science poses a question to all its visitors: "Are we so different?" It's a question that perhaps the youngest museum-goers — the hundreds of students that cross the museum floors each day can answer best: "No, we're not all that different," said Khorally Pierre, a sophomore at Community Charter School in Cambridge. Pierre and her classmates were among the first to see "RACE: Are We So Different?," a temporary exhibit opened on January 16. "Everyone should see it," said Pierre, "because there is still a lot of racism out there and we need to talk about it." That is precisely the museum's and the exhibit curators' intent.

discussion, directing many questions to visitors without forcing any pre-packaged answers. "We hope the exhibit will spark thoughtful dialogue," said Ioannis Miaoulis, President and Director of the Museum of Science. The challenge is to go beyond old social and cultural conventions to affirm that humankind cannot be divided and categorized by race or ethnicity. "If museum-goers take time to reflect on their beliefs, confront their fears, question preconceptions and challenge assumptions about race, then the exhibit will be a success here in Boston," added Paul Fontaine, the Museum's Vice-President of Education.

The exhibit focuses on

Developed by the American Anthropological Association and the Science Museum of Minnesota, "RACE: Are We So Different?" is geared to have its visitors challenge preconceptions



that find their way into our minds. The exhibit's handson approach makes it easy and fun to learn about how concepts of race and racism developed through history and how we still live in a race-obsessed society. Not many visitors seemed to know that 1691 was the year the term "white" was first legally used, or that 1790 was the year the Naturalization Act passed, declaring that only "free white persons" could become U.S. citizens.

A long time has passed since then, and many things have changed. Now visitors can debunk old racist theories through various educational tools. All throughout the exhibit hall there are videos of people from different ethnic backgrounds talking about race. Every few feet there are open binders, pencils and flash cards on which people can write their own experience with race. An art installation by Teja Arboleda shows faces of several different people with different skin color morph into one another. In the middle of it all, a tall vertical panel at the beginning of the exhibit reminds newcomers of one of the most important sentences in the U.S. Con-

stitution: "We hold these truths to be self-evident; that all men are created equal ..."

Those words, as well as the whole exhibit, hit the mark, according to Brence Pernell, a teacher at Community Charter School. "I'm impressed by the research that has been put into it and I appreciate the multi-faceted approach," he said. "It encourages dialogue and discussion, which need to continue." As South Carolina native, Pernell took his class of 10th graders on a field trip as part of their current studies on slavery. "This helps visualize certain things we are talking about right now in class and I'm very happy to see my students engage in lively discussions about the race."

Dating back to 2007, the exhibit has been moving around the country and is already booked for the next two years. Boston will host the exhibit until May 15, after which it will move to Washington D.C.'s Smithsonian National Museum of Natural History. The exhibit in Boston will also feature an exclusive addition: A series of musical installments put together by musician and sound artist Halsey Burgund, who has been collaborating with the Museum of Science for the past several years. "It's art that complements the science aspect of the exhibition," he said. "What I wanted to do was collect different voices from the Boston area to give the exhibit a local perspective." More than 250 voices of people living along Route 28 were collected and combined with music composed by Burgund and will be audible to the public starting February 3.

STOCKS CLOSE AT WEEK'S HIGHS

The market steadily higher with the NASDAQ and NYSE all up .7%, and volume rose across the board. A few more leaders broke out. Gold prices fell sharply on China's tightening. JP Morgan rose 51% as fourth quarter earnings rose 51%, beating views. Adjusted revenue Citigroup, Goldman Sacs and Bank of America are due out this week. Retail sales December were up! JP Morgan shares edged up to 1%, the highest since \$43 billion according to Janice Dinnon, CEO on a post earnings phone call. The bank, according to its CEO, they are settling most of their problems with Fannie Mae and Freddie Mac. Analysts are expressing both optimism and pessimism about 2011. Many analysts expect high tech companies to report a weak PC market, including mobile computing that benefits a wide swatch of technology providers. Revenue rose 8% over last year in the fourth quarter compared with the year's earlier quarter and following four straight quarters of dismal comparisons. Analysts expect first quarter sales to be up 12% above projections. At the end of the day they have a better outlook for growth and expect stronger growth in the second half of the year. Thomp-

son Reuters expects a 14% growth rate. IBM and Apple should give a good view on business and consumer IT buyers. The trend toward cloud computing should be at full force this year and expects strong demand for Smart Phones and we are dealing with a fragile economic growth in the tech world in 2011. The satellite industry is also playing a pivotal role in the shift to digital TV like in upgrades to provide expanded and groundbreaking services. Spending rose 11% in 2010. The economy is showing signs of acceleration and spending is beginning to improve, and showing signs of acceleration. Firms like Verizon, AT&T and Spring Nextel are launching G4 networks for faster and better services. Smart Phones account for about 15% of the global business and will grow to more than 30% in the next year. Acme Packet is building a signal between privately managed internet services that include voice and video conferences. Customers include cable and wireless network providers. To stay in the game players must lean heavily on research and development. The consumer opened their purse strings wide in 2010 and a strong demand for electronics has the industry tweaking its projections. The growth has opened the market to faster growth. The overall semiconductor industry is growing faster by branching into new specialties and adding market share. Sales climbed 15% in the fourth quarter. Can a will be changed after you die? FREDERICK N. PELLEGRINI, administrator, vs. LUCY B. BREITENBACH & others SUPREME JUDICIAL COURT OF MASSACHUSETTS 456 Mass 876; 2010 Mass. LEXIS 293 February 8, 2010, Argued May 25, 2010, Decided

The decedent executed a will that provided his friend and sister would each receive one-half of the income from his securities and bank accounts during their lifetimes. The will also provided that the residue would be shared jointly by two charities. The decedent was reluctant to disclose the extent of his assets to the attorney who drafted the will, who only knew that the decedent lived in subsidized housing and wanted to keep the legal costs associated with making the will as low as possible. At the time of his death, the value of the decedent's estate was about \$1.7 million. The administrator sought to reform the will, alleging that if it were not reformed the estate would have to pay taxes of about \$466,733 to the detriment of the charitable beneficiaries.

This is a case where the charities argued that the intention of the decedent was to provide for the charities after the death of the two individuals named in the

They argued that the will should be changed to carry out the charitable intentions of the decedent to minimize the tax obligation.

The Supreme Court decided not to reform the will. The Plaintiffs seek to change the will to create a charitable trust.

The court said full clear and decisive proof of mistake is required to justify reformation of a trust instrument.

In contrast to the above cited cases, there is no trust instrument in this case. The plaintiff asks us to reform a will to create a trust, namely a CRAT. We decline to do so.

The plaintiff has not cited (Flannery), in which we stated that courts have no power to reform wills. The plaintiff, therefore, makes no claim that this case might be an appropriate one in which to reconsider Flannery, although that is the essence of his claim. While there is an exception to the general rule permitting reformation in cases where there exists an ambiguity in a will the plaintiff concedes, as he must, that the will in this case is unambiguous. There is also no indication that there was any mistake on the part of decedent's counsel in the drafting of the will. To the contrary, counsel stated in his affidavit that he had followed his clients' request to the letter. This case holds that where there is no mistake or ambiguity, a will cannot be changed after death.





Welterweight Champion of the World Tony DeMarco Exhibit Unveiled







mum on Cinelli's release, January 4) that Governor Deval Patrick has of yet neither watched the taped Parole hearing or looked at Dominic Cinelli's criminal record. I agree with the editorial that both departments need to "be married to the judicial branch, which it serves."

Politics has seemingly caused a big scandal for probation and the release of a future murderer by the parole board. Issues dealing with both parole and probation need to placed in a politics-free zone. There was no excuse for the county district attorney's office to be overlooked when it came to a parole hearing.

The criminal justice system is apparently ill-served when former campaign workers decide who stays in prison and who is let out. Let the judiciary branch of state government be held responsible for the entire process from the courtroom to the parole board.

Do We Say Happy Anniversary?

January 4th marked the 16th anniversary of Whitey Bulger's fugitive status and the FBI re-affirms that the worldwide hunt for Bulger continues. The last confirmed sighting of Bulger, who turned 81 last September, was in London in 2002, according to the FBI.

Kevin Weeks, a former Bulger associate who's coming out with a book called "Where's Whitey" in June says, Bulger will never be caught and outside of the Boston area, nobody cares or even knows who Whitey Bulger is. As Weeks says, "No one is worried about an aging criminal from America."

VEAL CACCIATORE

Veal Stew Meat or Veal Shoulder Arm Chop

- 1 pound veal meat
- ½ cup chopped celery
- 2 cloves garlic (optional) 1 medium onion chopped
- 2 large carrots
- 2 large potatoes
- 1 sprig of bay leaf (optional)
- 1 chicken bouillon cube
- 1 cup water
- 1 full tablespoon capers (in vinegar and water)
- 1/4 cup olive oil,
- canola or vegetable oil 3 medium-size ripened
 - tomatoes chopped
- ½ pound fresh string beans, or 8 oz. can of cut beans, or frozen cut beans

Line a twelve-inch skillet with oil and heat over medium flame. Leave bone in if using shoulder chop but remove extra fat from veal shoulder chop. Place veal in heated skillet to sear and brown. Remove meat from skillet and set aside. Add celery, onions and capers to the skillet. Stir until onion is opaque. Do not brown onion. Add a little of the vinegar and water from the capers' bottle. Add bay leaf (optional) and simmer about two or three minutes before adding chopped tomato pieces. Stir occasionally and cover. Simmer slowly for about three minutes. Meanwhile, dissolve bouillon cube in warm water. Slowly stir in bouillon mixture into skillet. Add garlic and veal into skillet. Cover and cook about ten minutes over medium heat.

Peel and slice carrots into wedge about two inches long. Cut tips of string beans if using fresh beans and wash thoroughly. Peel potatoes and cut into two-inch wedges. Add carrots first to skillet. Cover and cook them about five minutes before adding string beans and potato pieces.

Add additional water if needed. Cook until potatoes and vegetables are tender. Season to taste. If bay leaf is used, remove before serving meal.

NOTE: I learned from my mother to vary the recipe by occasionally adding a can of mushrooms to the skillet. Another option is to add sliced green peppers or some green peas. In place of potatoes, I sometimes prepare some of my favorite rice and serve it plain or topped with a few tablespoons of sauce from the skillet.



A Nostalgic Remembrance

It was January, a cold snowy January in 1956. Dad had gotten a call from a friend in Augusta, Maine. It seems that there was a major snowstorm that hit Maine's capitol and our cottage was in the nearby town of Winthrop. Winthrop, Maine had, at one point, a Ford plant and a couple of factories, but by the mid 50s, they were ready to close. As a result, the only real economy the town has was during the summer when the seasonal residence were back. The town was situated on the south side of Lake Maranacook. The road we lived on, Memorial Drive, had mostly summer cottages on the lake side of the road and local residents on the other side. When Emil Andy called, it was to say that he swung by the lake to check on three places, ours, Mike Barca's place and Emil's brother-in-law's place. Mike was Dad's best friend from his days working for the Boston Schools. He and Mike were two of the four pioneers in the Department of Audio/ Visual Education. As two men with Italian last names, they gravitated toward each other at a point in time when they were in the minority. Mike had married a woman from Maine and they built a cottage on Lake Maranacook back in the 40s. Due to the friendship that developed between Mike and Dad, the families came to know each other and we were invited to their summer cottage several times, a main reason for us buying a summer cottage a few doors away, right on the lake. Next to Mike's place was Emil's brother-in-law's place. Lionel Lemeux was a writer for the Lewiston Sun, a local daily newspaper in that part of Maine. Emil and Lionel, or Lal, as everyone called him, headed to the lake to check out the cottages after a major January snowstorm.

Emil told Dad that when they got to our place, they couldn't find it. It was covered with snow drifts, and the snow from the roof in tion going which was part back of the cottage slanted of the acceptance of the right out toward the middle Christoforo family as part of of the frozen lake. As a result. Dad decided that we should head to Maine to see if there was any damage to the place. The same storm had hit Boston, but northern New England had gotten a real "Nor'Eastah," and they were snow bound. Emil also

clear and easy to travel on high. The door was frozen but we had to be cautious. He advised Dad to pull the antenna of the car all the way up and attach a red banner to the top. If we stopped at an intersection, the snow might be so high that the only way a driver in a vehicle coming from the right or left might know we were there behind a snow mound was to look for the flag. We packed our warmest clothes and Dad, Mom, Nanna, Babbononno and I climbed into Dad's 54 Chevy and headed north.

Of course, part of Babbononno's things included a gallon of Zi'Antonio's best homemade red wine. He had become friendly with one of the locals, a man called "Old Vic" by the locals. Vic Gordon was around Babbononno's age and the two had hit it off a couple of summers earlier. Vic had a thick Maine accent and Babbononno spoke fractured English. The wine would allow them to understand each other without a problem.

We headed north picking up the Maine Turnpike just outside of Portsmouth, New Hampshire and continued toward Augusta. A mile or so out before the Lewiston-Auburn sign was the sign for Winthrop and we headed on the local roads arriving at Mike Barca's cottage within a half hour of when we planned to be there. When we arrived, the house was filled with several families, Mike, his wife, Nara, her parents Ed and Ma Mascal, Emil Andy, his wife, Irene, their three children, Lionel Lemeux, his sons, and the Gordon family from across the street. They were all waiting for us. After coffee, tea and a couple of drinks, we headed to our place, called Frosty's Point. When Dad bought the place the original owner gave Dad a discount on the price if he would keep the same name it had had for a couple of generations. Seeing most of the summer homes had names, Dad kept the tradithe local summer scenery.

We bundled up again and walked to our place which was about 100 vards from Mike's cottage. Dad, Mike, Emil and I began shoveling a path from the road, and then the snow away from the front door. It took a long time said that the roads were as the snow was several feet

shut and Emil and Mom began cleaning snow away from a kitchen window that was just to the left of the door. The window wasn't locked and Mom climbed inside followed by her favorite son (me). With us pushing from the inside and Dad pulling from the outside, we finally opened the door. Mike had brought a wagon filled with dry firewood with him and he and Dad stuffed the pot belly stove with whatever would fit and then lit the fire. Emil had brought a ladder from Mike's place, set it up, climbed on the roof, cleared snow from around in the chimney and we closed up and headed back to Mike's place, planning to return within an hour or so when the cottage had warmed up.

We walked back to Mike's where Nara, her mother and Nanna had prepared dinner for everyone. Babbononno and Old Vic had put a good dent in the gallon of wine and were singing two different songs, Vic's in English and Babbononno's in Italian. When we returned to our place a couple of hours later, the heat from the stove had melted a lot of the snow from the sides and roof of the cottage, enough so that we could see the windows and the back porch. When we entered, the place was quite warm. Mom and Nanna made up the beds and we slept there over night.

One of the Gordon kids, Old Vic's granddaughter, knocked on the front door early the next morning and told us that Mike and Nara expected all of us for breakfast within the hour. We could smell the bacon cooking fifty yards from their front door. As we walked in, Nara yelled that we were having fried eggs with bacon and ham. She had also make buckwheat pancakes from scratch and drowned them in local maple syrup. If you add in the homemade bread, fresh from the dairy butter and a few other Maine delicacies, you had a lumberjack's breakfast. Nanna had two pots of coffee waiting, one American and one Italian. It was a feast.

We decided to wait for a while and then head back to Boston. Dad, Emil, Mom and I headed back to our cottage which now was completely visible due to the heat from the stove melting the snow. Mom packed up the bed linens and the rest of the clothes and things we had brought from Boston. We headed back to Mike and Nara's place for a thank you and to say goodbye, which took about a half hour. It was quite an experience for all of us and we talked about the folks all the way home, referring to them as if they were family. Maybe, in a sense, they were, back fiftyfive years ago.

job growth and the economy. Mayor Menino announced a \$100 million "stimulus" to green city buildings and other assets. The work could be financed through energy savings and would generate approximately 1,000 new jobs in construction and other sectors. The Mayor also pledged to ease the complex permitting process for small businesses by cutting red tape and reviewing permit requirements.

Education Reform

Highlighting education reform as one of the major successes of 2010, Mavor Menino pledged to continue aggressive transformation efforts so that educational opportunity is shared across the city. Having in the past year secured landmark education reform at the State House, the City began making use of the new authority to create in-district charters and put the best educators in struggling buildings.

The Mayor called for doubling the number of early education seats in the Circle of Promise and invited nonprofit institutions and private sector partners to help meet that challenge. He noted that full day kindergarten for four-year olds has been successful, and that increasing early education seats in the Circle of Promise would help young children who live there and create capacity across the city.

Access to Quality Healthcare

The Mayor announced **NeighborCare** a proposal to increase access to affordable, quality health care. The initiative is designed to

increase the use of community health centers by providing more hours and more services in the neighbor-

New Public Safety Tools

After a year marked by an increase in homicides, including several high-profile cases, Mayor Menino pledged resources to public safety, including a second police academy class in addition to the one already in the academy now and a new Anti-Gun Task Force with the Bureau of Alcohol Tobacco and Firearms (ATF).

Mayor Menino also called for better coordination of re-entry programs with the state prison system.

Budget Savings

Another item atop Mayor Menino's agenda for the New Year is reform to the design of municipal health care plans. Boston taxpayers currently cover approximately 82-percent of health care costs totaling nearly \$300 million. The State, on the other hand, pays only 67 percent of healthcare costs for new employees. Mayor Menino noted his proposal for a Boston Group Insurance Commission, which — following the state version — would produce savings of more than \$1 million a month and approximately \$17 million a year.

The event program included a moment of silence for the victims of the recent tragedy in Arizona, as well as performances by the Boston Arts Academy and Boston City Singers and an invocation by Fr. David I. Convertino of St. Anthony's Shrine and Ministry Center.

A rendere nota la decisione dei Vescovi e' stato il portavoce dell'episcopato italiano, Mons, Domenico Pompili, La Chiesa pur preferendo la sepoltura tradizionale non riprova la cremazione " se non quando e' voluta in disprezzo della fede, cioe' quando si intende, con questo gesto, affermare il nulla in cui verrebbe l'essere umano", ha spegato ilrappresentante della CEI.

Nella societa' italiana come altrove, I Vescovi guardano con preoccupazione ad una certa tendenza necrofila, o peggio, a fenomoni di satanismo collegato ai morti. Per questo, in futuro, si promuvera' una riflessione a tutto campo sul senso della vita e della morte, a fronte di una cultura che maschera, o esorcizza, la fine, ha assicurato Mons. Panpili. Si vuole cosi' risvegliare, ha spiegato Mons. Panpili, la memoria dei defunti.attraverso la preghiera, bandendo ogni forma di ricerca del macabro e del demonismo.

La memoria dei defunti e la familiarita' con il camposanto sara' un modo concreto per contrastare la prassi di disperdere le ceneri o conservarle al di fuori del cimitero o di una chiesa. Non esiste nella dichiarazione dei Vescovi una spiegazione di come si puo' disporre delle ceneri dei defunti. Questa materia, cosi' delicata, coinvolge le sensibilita' piu' profonde dei cristiani ed i principi basilari della fede, come la resurrezione dei corpi. La CEI (consiglio episcopale italiano) ha molto lavoro da fare, prima di ricevere l'imprimatur definitivo della Congregazione Vaticana per il Culto Divino. Il solo suggerimento e' quello che le ceneri dovrebbero essere depositate in luoghi consacrati.

In conclusione, diciamo che in tempi antichi la cremazione non era contemplata. Ma ora le nuove esigenze richiedono nuove alternative.

DID YOU KNOW THAT ...

The Italian Bishops, who number about 200, recently met in general assembly at Assisi where (they) approved, with a few amendments, the new funeral ritual which contemplates, in the Italian Ecclesiastic policy-making, precisely cremation, a practice already authorized by Canon Law in 1983. It will also introduce a liturgical ritual to anyone who will choose to be cremated. To make the Bishops' decision the public was the spokesperson of the Italian Bishops Congregation, Mons Domenico Pompili. The Church, which prefers the traditional burial, doesn't object to cremation, "unless," explains Pompili, "it is requested to disparage the Faith, i.e., when, by doing so, someone intends to affirm the insignificance of the human being."

In Italian society, as elsewhere, the Bishops look with pre-occupation to a particular neurologic tendency, or worse, to satanic phenomena performed on the dead. Monsignor Pompili has assured everyone that in the future, because of that, we shall better reflect entirely on the meaning of life and death, vis-à-vis a culture, which masks or exorcises the end. In this fashion we wish to re-awaken the memory of the dead people, explains Mons. Pompili, through prayer, banning any macabre orientation and demonism. The memory of the departed people and the familiarity with the cemetery will be a concrete way to approve the practice of dispersing the ashes or preserving them outside the cemetery or a Church. In the Bishops' deliberations there is no explanation on ways to dispose of the departed's ashes. The CEI (the Italian Bishops Congregation) has a lot to do before getting the final "Imprimatur" of the Vatican Congregation for the Devine Cult. The only suggestion may be that the ashes ought to be preserved in consecrated places. In conclusion, let's mention that in ancient times cremation was never contemplated. Now, however, new needs require new alternatives.

FALLON SEEKS OKAY FOR FAN PIER SITE

Joseph Fallon is moving on his proposed 15-story research lab at Fan Pier. On January 5, Fallon Co. sought approval from the city's Civic Design Commission for his building site next to the Moakley Federal Court House. He's still looking for tenants. Right now the tenant pool is either new companies coming into Boston or companies willing to pay big bucks in a newly built waterfront building.

Any developer needs a site that is signed, permitted and ready to start construction quickly or developers won't be taking any proposals seriously. Fallon has already built an office tower at One Marina Park Drive. In May, Louis Boston temporarily moved from the Back Bay to Fan Pier. Fan Pier spans nine blocks and 21 acres.

WHAT ABOUT THE FOREST HILLS **OVERPASS?**

the Casey Overpass at Forest Hills. Most folks just call it the Forest Hills Overpass. It has been scary looking for years now. 

Dave Sisler was Top Sox Rookie in '56



Dave Sisler, the 1956 Red Sox Rookie of the Year passed away recently from complications from prostate cancer. Sisler was the last surviving child of Baseball Hall of Famer George Sisler. He pitched for the Red Sox, Detroit Tigers, Washington Senators and Cincinnati Reds for whom his father also played. Sisler was a 6 foot-4 right-hander who went 9-8 in his rookie season and was rewarded as the winner of the Harry Agganis Award given to the team's top rookie that season.

His best season was with the Tigers as a relief pitcher when he went 7-5 in 41 games with a 2.48 ERA. Sisler's brother Dick played in the majors with the Philadelphia Phillies, St. Louis Cardinals and Cincinnati Reds. Another brother George Jr. played minor league ball before becoming a professional baseball executive. Their sister, Frances, represented the Sisler family in Seattle in 2004 when the Mariners' Ichiro Suzuki broke George Sisler's 84 year-old-record of 257 hits in a season.

No Tax Break, No Bullpen Changes

I read a news story the concerning day Fenway Park and the Boston Red Sox. I don't have the Boston Globe article in front of me but the jest of the story concerned changes out in right field to make pitchers in the bullpen safer. The Sox apparently were seeking permission to do so, and to also get a tax break at the same time. Well, the tax break didn't come their way, so the club put off those changes for now. I guess those safety concerns weren't that great after all. At least, not without a tax break or two.

Artie Wilson Ran Out of Luck in Majors

Artie Wilson was one of the great shortstops of the Negro baseball leagues passed away recently at 90 years of age. In 1948, he batted .402 for the Birmingham Black Barons in the Negro American League. He played five years for Birmingham and was so good at hitting to the opposite field, he was given the Wilson Shift treatment. They opened up left field for him despite missing part of his right thumb. He twice led his league in batting and became a mentor to a young future Hall of Famer Willie Mays. This lefty, known for his speed, was a great leadoff player and could hit well to the opposite field that all three outfielder usually gave him the shift treatment guarding center to right and not worrying about left field. His highest average of .402 was the last time any professional baseball player broke the .400 barrier.

In 1949, he was signed by the Cleveland Indians and sent to the San Diego Padres in the Triple A Pacific Coast League, where he led that league in batting with a .348 average. The following year, he hit .312. In 1951, he made it to the majors with the San Francisco Giants but only played in 22 games. He played a few more years in the minors before retiring.

A great ball player in the Negro Leagues, he had tough luck in the majors unlike Satchel Paige, Willie Mays, Jackie Robinson, Roy Campanella or Minnie Minoso. He could have been one of the greats had the color barrier not blocked his entry into the majors, apparently, passed his prime.

Uggla, Braves Reach 5 Year Extension

Slugging second baseman Dan Uggla has reached a preliminary agreement with the Atlanta Braves on a 5-year, \$62 million contract extension. Uggla was acquired from the Florida Marlins this past November. Uggla, 30, is a two time All-Star and hit .287 with 33 home runs and 105 RBIs last season.

Mariners Bring Back Miguel

The Seattle Mariners and

Miguel Olivo agreed on a 2year, \$7 million deal, bringing the catcher back to the club. In 2010, he hit a career high .269 with 14 homers and 58 RBIs.

Orioles Get New Closer

The Baltimore Orioles gave right-hander Kevin Gregg a \$10 million, two year contract. Last season, he went 2-6 with a 3.51 ERA and 37 saves with the Toronto Blue

HOOPS and HOCKEY in the HUB

It was a big day, it was, and in the end, the two large men who dominated it stood tall, not only in physical stature — as they always have — but in other dimensions such as leadership, inspiration and respect.

It was the Martin Luther King Day doubleheader at the Garden, one of two such days on the Causeway Street calendar (the other is the day after Thanksgiving) where Boston's two winter sports teams - the Bruins and Celtics — play games on the same day in the same facility.

Such an occasion can be a long day, to be sure, especially for the Garden staff that must work both games. Although the contests are spread out enough over time to allow for the physical changeover, there definitely can be some meetings in the media room between those who chronicle the efforts of the respective teams.

You see, it's not uncommon for a few of the hockey writers to be joined by some of their early arriving basketball counterparts in the same media area where both engage in their pre-game and post-game tasks, albeit much more frequently on separate days through the season.

This year the media room was in full swing when we arrived around noon—an hour before the B's game with Carolina and was still humming around midnight some 12 hours later as writers sought to put together their reports on the Celtics-Magic game.

This year there was a common thread, if you will, between the two contests, both highlighted by accomplishments of their tall players, both hailed for a job well done.

The B's went first, as they always do on these double duty days, with the Hurricanes arriving as the next to last team in the Southeast Division behind Florida. The Bruins were atop the Northeast Division, with only a scant two points separating them from their archrivals the Montreal Canadiens in the standings.

The B's would win big via a 7-0 whitewash of the Hurricanes, who seemed to offer nothing of the ferocity that their name would suggest. In fact, only about five minutes and two goals into the game Cam Ward — the Canes' goalie — was gone for the day, relegated to the bench in favor of Justin Peters. But those few minutes in the net proved historic for Ward, who a number of years ago played for Lowell in the AHL. They meant that he played his 310th game in goal for the Canes, putting him in first place for career games played between the pipes for Carolina.

Meanwhile, the goalie change didn't seem to bother the B's, who potted five more scores before Tim Thomas left the ice with the shutout. remarkable.

But it was defenseman Zdeno Chara who stole the show, scoring his first career hat trick in his 892nd career NHL game and only the fourth in history by a B's defenseman.

The hats rained down as the 6-9 Chara sported a wide grin and accepted the congratulations of his teammates. Later coach Claude Julien would commend Chara for his overall effort that day, not just for the goal. "He made some good plays coming out of our own end," noted the coach. "He kept his game simple and really looked good. I thought he was a real solid player for us."

For Chara, "it was a very humble feeling with a big thank you to the guys because they put me in good spots and positions to score."

Several hours later, in a different room down the same hallway, it was 6-11 forward Kevin Garnett's turn to accept accolades following his return from an injury. Away from the action for nine games, KG returned with a 19-point, eight rebound performance as the Celts put away Orlando 109-106.

Just his presence made a difference to the team. That's what most fans would focus on. But down on the floor, another characteristic rings real with the players and coach Doc Rivers.

The coach said there was better communication on defense "because someone's talking. And no one talks like Kevin. He's the best talker in the league when you're talking defense. It was clear the communication was different, particularly the last four possessions. You could hear it. He was calling their sets out. He's a defensive coach on the floor."

Captain Paul Pierce said that with Garnett back in the lineup "we looked like a totally different team just with Kevin on the court. You can't replace what he gives to our ball club. He doesn't always show up with his numbers but his presence and his feel for the game and everything he does for the team goes far beyond numbers. We looked like a team that was ready and energized. That's the culture he's brought here since "Day One" and it's infectious. He raises everyone's play when he's on the court."

Two tall players — Chara and Garnett — leading the way on the same day. It makes one think that if everyone stays healthy, the Bruins and Celtics could have long runs in their respective playoffs come spring. A warm thought as Bostonians struggle with the steep snowbanks of January.
