## DEPARTMENT OF GOVERNMENT EFFICIENCY (DOGE) Reveals Wasteful Spending

(U.S. Agency for International Development (USAID) is Largest Offender

As Elon Musk and newly confirmed Cabinet members with Republican Congressional leaders continue to audit federal government agencies, their efforts have been revealing billions of dollars in government spending and waste. Despite Democratic opposition, DOGE enjoys full support and backing of President Trump. U.S. Senator Joni Ernst, R-Iowa, the Senate DOGE Caucus Chairwoman, speaks with Musk a couple of times each week regarding spending cuts to projects and programs the U.S. Agency for International Development (USAID) has funded for over the years.

Senator Ernst cited various examples of "wasteful and dangerous" spending by USAID, until DOGE stepped in, including spending \$20 million dollars to create a *Sesame Street* in Iraq. Under the Biden administration, USAID awarded \$20 million to a nonprofit called Sesame Workshop to produce a show named "*Ahlan Simsim Iraq*" in an effort to "promote inclusion, mutual respect and understanding across ethnic, religious and sectarian groups." Another example of questionable spending of American tax dollars by USAID is the \$900,000 to a Gaza based terror charity called Bayader Association for Environment and Development, and a \$1.5 million program slated to "advance diversity, equity and inclusion in Serbia's workplaces and business communities."

The Federal Emergency Management Agency (FEMA), the government's leader in distributing disaster-relief funding, gave over \$59 million to house illegal immigrants in New York City hotels just last week, according to DOGE. The spending was exposed by Musk last week in a post on X, "sending this money violated the law and is in gross insubordination to President Trump's executive order," which had put FEMA under review to improve the agency's priorities. Of the \$59 million, \$19 million was for direct hotel costs, while the remaining balance funded food and security, a New York City Hall spokesperson confirmed to Fox News. Department of

## Natural Gas Home Heating Rates are through the Roof

Governor Healey Calls for Immediate Relief

Massachusetts Governor Maura Healey called on the Department of Public Utilities (DPU) to immediately act on lowering energy prices. Massachusetts residents are dealing with unexpected rate increases sending their natural gas heating bills through the roof as so many continue to struggle with everyday necessities and essentials. "People did not plan for these extraordinary utility rate increases, and they can only do so much to stretch a budget. The DPU must act immediately to provide rate relief to customers in this heating season," Healey wrote in a letter to DPU chair Jamie Van Nostrant. The Governor is requesting something be done to "help consumers reduce bills and avoid future large, unanticipated price spikes like this."

Healey expects the agency to stabilize electricity rates similar to their actions in 2023, in addition to identifying ways to reduce future price increases and make any rate changes more transparent and predictable. According to Healey, it's incumbent upon



the utility companies to do a better job educating and informing consumers about state programs available to help them keep the heat on. The Governor took the opportunity to remind consumers that during the cold weather the law protects them from having their heat turned off, regardless of how high their bills may be. "It is also imperative that energy consumers know their rights, including they that cannot have their utility service shut off during winter months. Staying warm is critical for everyone's health and safety," Healey said.

Governor Healey is not the only elected official to take aim at the rising utility rates. Many local lawmakers fired off letters demanding a probe into the aggressive rise in Bay State utility rates after receiving numerous complaints from their constituents. Eversource pointed to colder temperatures this winter for higher natural gas usage and increases in customer bills.

Eversource traditionally request increases twice per year, May and November, and were approved by the Department of Public Utilities this past November for a 20% to 30% increase to customers natural gas bills while National Grid was given approval for an 11% - 13% increase. Officials adjusted the rate on February 1st when the cost of gas purchased by Eversource increased significantly in January. "The dramatic increase in usage is coupled with recent rate adjustments that took effect on November 1st, which is also impacting customers' current bills," the company said in a statement.

## Massachusetts Public Schools and Universities Must Choose DEI or Federal Funding

The Trump administration has imposed a February 28th deadline on all Public Schools and Universities in Massachusetts and across America to cleanse their curriculum of any Diversity, Equity and Inclusion (DEI) policies or face the potential loss of federal funding. According to a letter sent to education officials in all fifty states, from Craig Trainor, the Department of Education's Acting Assistant Secretary for Civil Rights, the federal government will now define regulations as any policy, "motivated by racial considerations" and will be considered non-compliant with the law. "The law is clear: treating students differently on the basis of race to achieve nebulous goals such as diversity, racial balancing, social justice, or equity is illegal under controlling Supreme Court precedent. All students are entitled to a school environment free from discrimination. The Department is committed to ensuring those principles are a reality," the letter states.

Any school, at any level, accepting federal funds is required to "ensure that their policies and actions comply with existing civil rights law and to cease all efforts to go around existing laws in matters of admissions, hiring, promotion, compensation, financial aid, scholarships, prizes, administrative support, discipline, housing, graduation ceremonies, and all other aspects of student, academic, and campus life." Basically, Trainor said "educational institutions may neither separate or segregate students based on race, nor distribute benefits or burdens based on race."

All educational institutions receiving federal funding have until February 28th to become compliant. Those who do not meet the deadline, will be subject to the Department of Education's actions as they tory practices based on race, including against "white and Asian students" in recent years. "The Department will vigorously enforce the law on equal terms as to all preschool, elementary, secondary, and post-secondary educational institutions, as well as state educational agencies that receive financial assistance," Trainor wrote.

Massachusetts Attorney General Andrea Campbell recently joined a number of other state AG's in issuing DEI guidance of their own for companies doing business in their states. The Attorney Generals believe Federal law cannot prevent private entities from using diversity, equity, or inclusion goals in their hiring decisions or day to day practices. The question begs, will Campbell and her group band together and challenge the Trump administration on this mandate?



### **SENECA**



Manuel Domínguez Sánchez, The Suicide of Seneca (1871), Museo del Prado, Madrid, Spain

Lucius Annaeus Seneca was more commonly called Seneca the Philosopher. He was born in Spain about 3 B.C., brought to Rome at an early age, and educated by some of the most eminent philosophers of the time. His enthusiastic acceptance of their teachings and life-style caused him to emulate their way of life. He also became a brilliant lawyer. The Emperor Caligula soon became jealous, and a severe critic of Seneca, and consequently marked him for destruction. Seneca was subsequently spared because of ill health, and also because of

rumors that he would soon die a natural death. Seneca surprisingly rose to great prominence under the succeeding Emperor Claudius, but he also made enemies of some powerful officials. After being accused of intimacies with a relative of the former Emperor Tiberius, Seneca was banished to Corsica for about eight years. Through the intervention of Agrippina (wife of Claudius), he was returned to Rome to tutor her son Nero.

Nero became emperor after the death of Claudius, and it is reported that during his early years, the only decent part of his reign was brought about as a result of Seneca's guidance. This period was known as the "gold quinquennlum" (golden five years). It soon became evident that Nero could not be controlled. He turned against Seneca, and in time caused him to commit suicide.

We are told that Seneca was one of the most brilliant figures of his time, and equal to the greatest intellectuals of the Silver Age.

His prose works were numerous and important. These included many speeches which were written for Nero, several treatises, a biography of his father, a panegyric (praise) of the famous Messalina, and a number of books of letters.

The greatness of Seneca probably stems from his narratives on morality. Many of his letters were written as sermons, while others attacked the vices of that time. He was one of the foremost Stoic philosophers of Rome. Much of his literary work greatly influenced Italian and French classical drama during the Renaissance period of many countries.

## **BIRTHRIGHT CITIZENSHIP**, **THE 14TH AMENDMENT** U.S. Supreme Court Showdown Inevitable

The definition of birthright citizenship, by its very name, would seem fairly simplistic, the idea that all children born in the United States have the same rights, regardless of where their parents originate from. But that may not quite be the case. Democrats, Republicans, Liberals, Conservatives, Progressives or just about anyone with an opinion on this issue, should brace and prepare for an all-out battle on both sides.

President Trump's challenge to birthright citizenship will almost assuredly be decided by the U.S. Supreme Court and will undoubtedly follow passionate arguments from both sides.

The case most often cited is 127 years old, United States v. Wong Kim Ark (1898), ruling the protections and guarantees afforded by the 14th amendment belong to citizens alike, "so long as they are permitted by the United States to reside here." Note key word, "permitted," which may actually support Trump's assertation.

On January 20th, not long after he was sworn in for his second term, President Trump declared through executive order that babies born to illegal immigrant mothers and lacking a father who is a legal U.S. resident, will no longer automatically receive U.S. citizenship. Beginning February 19, 2025, hospitals were prohibited from issuing U.S. birth certificates for these newborns, numbering approximately 250,000 each year. Trump also targeted birth tourism, ending automatic citizenship for the approximate 30,000 babies born each year to women who have entered the U.S. legally on temporary visas and give birth here. Regardless of how the mother arrives in America, all claim citizenship for their newborns under the birthright clause of the 14th amendment.

The original intent of the clause was proposed to guarantee citizenship to children born to former slaves, but in 1866 Congress expanded it to children of any race or ethnicity born in the United States, however Congress never debated whether offspring of people in the country illegally were guaranteed citizenship. There were no immigration laws or illegals in 1866, and the U.S. did not impose numerical limits on immigration until 1921.

Immediately upon President Trump signing his executive order, twenty-two states filed lawsuits, along with San Francisco and a number of non-profits. Days later, federal judges blocked the implementation of the order, with Judge John C. Coughenour of the Western District of Washington state calling it "blatantly unconstitutional." There is absolutely no way to determine how the Supreme court will rule on this explosive topic. The only justice on record offering his view, is Samuel Alito, stating during his confirmation hearing in 2006 that birthright citizenship "may turn out to be a complicated question."

There has only been one Supreme Court ruling on this topic in the past 160 years, which referenced the 14th amendment protections extending to all people who "are permitted by the United States to reside here." Justic Horace Gray wrote in support of the decision by citing an earlier Supreme Court ruling, Yick Wo v. Hopkins (1886), stating the 14th amendment's equal protection clause applied to people of all races " who have the right to temporarily or permanently reside within the United States." Not people who are here illegally.

Illegal border crossings are down 90% since President Trump resumed office, but executive orders are temporary and can be nullified by the next President. Regardless of how the court rules, Congress has the power to act by imposing stricter limits on our borders and halt financial incentives to those entering the country illegally. If Congress closes our border, birthright citizenship will cease to be an issue.

Last month the CBO estimated almost \$2 trillion in overspending this year or about 6.2% of gross domestic product vs. just 3.8% on average over the past fifty years. Add that to the nation's \$36 trillion in IOU's and you're looking at America's debt to GDP ratio exceeding its World War II peak. Interest on debt alone now tops military spending.

U.S. Drowning in Debt,

While Democrats Fight Spending Cuts

Over the past decades, Washington bureaucrats and elected officials have done nothing to curtail aggressive spending that has steadily increased and instead has witnessed Democrats blocking any type of spending cuts or attempts to constrain the budget.

As President Trump begins his second term and Elon Musk overseeing DOGE, the entrenched DC elites better prepare to witness some serious cuts to the entire federal budget. No one will be safe or exempt. Their goal is to scale back on the number of federal

## Wu and Kraft at Odds on Housing Plan

Boston Mayor Michelle Wu took issue with her challenger Josh Kraft's proposed housing plan, claiming it is a "fake rent control" pitch and nothing more than a proposal to minimalize affordability requirements for new housing developments. Kraft's plan strongly critiqued Wu's policies, which he suggests have stymied housing production and increased affordability issues.

"The proposal is that this sort of fake rent control would be implemented. What we saw today has been a distraction because underneath all this, is to dismantle affordability requirements, and in fact take us back to a time when it was anything goes for developers making money at the expense of affordability," Wu said on GBH's Boston Public Radio.

Kraft's plan calls for the production of more than 26,000 housing units that have already been permitted by the city but are not yet built, which his campaign estimates would bring in approximately \$120 million dollars in new tax revenue. Kraft's proposal centers around an inclusionary housing development policy previously in place under former Mayor Marty Walsh, omitting the modifications put in place by Mayor Wu this past fall. Kraft's proposal would also kick start the city's inclusionary zoning policy for market rate housing developments with ten or more units, instead of at least seven, and require a smaller percentage of income restricted units at 13%. from the current 17-20%.

Wu also shot back at Kraft's claim that her policies stalled construction of approximately 26,000 housing units, instead referencing a \$110 million dollar housing accelerator fund she proposed and was passed by the City Council. The goal of the fund is to ignite the production of permitted units that have been delayed due to lack of financing. Wu believes her opponents proposed opt in rent control plan, incentivizing landlords to cap rent increases for a ten-year period in exchange for an annual property tax break, "is not going to capture or protect against the worst offenders," stated Wu.

"The groundswell of support from all corners of the city for Josh's candidacy is clearly concerning Mayor Wu, and today's comments are a weak attempt to change the conversation away from her failure to create housing and real pathways to affordable homeownership. We need a mayor focused on solutions." the Kraft campaign offered in a statement.

## L'Anno Bello: A Year in Italian Folklore A Celebration of Cinema

### Would St. Michael Actually Want a Statue in His Honor Outside the New Police Station?



## City Celebrating 10 Years of Annual Spring Neighborhood Cleanups

Mayor Michelle Wu and the Office of Civic Organizing (OCO) announced the 2025 Love Your Block spring cleanups will take place on Saturday, April 5th and Saturday, April 12th. This year marks the 10th anniversary of Love Your Block, a program that has mobilized thousands of residents in community-led cleanups to beautify Boston's neighborhoods. Originally launched as Boston Shines and rebranded in 2015, Love Your Block has become a key initiative for civic engagement in Boston. Over the past decade, the program has empowered residents to take ownership of their public spaces, fostering community pride and connection through hands-on neighborhood beautification projects. These projects include street cleanups, park revitalization, planting flowers, and mulching.

The Love Your Block registration is now open for volunteers to sign up as hosts at *civicorganizing@boston.gov* Alternatively, individuals who wish to join an existing neighborhood cleanup as a volunteer can pre-register at *civicorganizing@boston.gov* After registration closes on March 3, 2025, the Office of Civic Organizing (OCO) will provide registered volunteers with a list of cleanup sites in their neighborhood that are accepting participants.

"Love Your Block cleanups have been a fantastic way of bringing communities together across Boston and one I have personally enjoyed taking part in," said Mayor Michelle Wu. "For the past 10 years, this program has empowered residents to take pride in their communities by giving them the tools to keep their neighborhoods sparkling. Together we celebrate the start of spring and take ownership of keeping our public spaces beautiful."

Love Your Block is a national grant program that funds resident-led neighborhood revitalization projects. In 2015, a three year Love Your Block grant was awarded to the City of Boston, which integrated the program as a permanent effort in 2018. Established and supported by Bloomberg Philanthropies, Love Your Block is delivered by the Bloomberg Center for Public Innovation at Johns Hopkins improved nearly 4,000 public Downtown Boston Alliance spaces.

Cleanups will take place in every neighborhood of Boston over the course of two weekends. The 2025 dates are as follows:

Saturday, April 5th: Allston, Brighton, Charlestown, Chinatown, Dorchester, Downtown, Leather District, Mattapan, Mid-Dorchester, North End, Roslindale, South Boston, West End, West Roxbury and Wharf District.

**Saturday, April 12th:** Bay Village, Back Bay, Beacon Hill, East Boston, Fenway-Kenmore, Hyde Park, Jamaica Plain, Mission Hill, Roxbury, and South End.

"Love Your Block is a reflection of Boston's spirit, neighbors coming together not only to care for the places we call home but also to strengthen the bonds that connect us," said **Nathalia Benitez-Perez**, **Director of the Office of Civic Organizing.** "I am deeply grateful for the dedication of our volunteers who work closely with us to keep this tradition alive."

Love Your Block had record participation numbers last year, with more than 2,000 volunteers across 121 sites citywide. After last year's success, the Office of Civic Organizing is partnering again with Boston Public Library and Boston Centers for Youth & Families to serve as centralized locations where community members can conveniently pick up and return cleanup tools. All participating sites are listed on the Love Your Block page, along with tips on how to host your own Love Your Block cleanup site. Tool collection is scheduled from 9:00-10:00 a.m., with returns to the same location between 12:00-2:00 p.m.

On Friday, April 4, the Downtown Boston Alliance (DBA) will kick off this year's Love Your Block cleanups with its annual Friday beautification project, marking the official start of the citywide initiative. The DBA coordinates this cleanup, but people can sign up through the City as individual volunteers at *civicorganizing@ boston.gov.* 

"For ten years, the City of Boston's Love Your Block event has brought the community together to celebrate the emergence of spring and to take pride in our respective neighborhoods through an annual day of service. The

## U.S. Senate Confirms Tulsi Gabbard and Robert F. Kennedy, Jr.

Two more Trump administration nominees have been confirmed by the Senate. Former four term Democratic Congresswoman from Hawaii, Tulsi Gabbard was confirmed as the Director of National Intelligence while Robert F. Kennedy, Jr., was confirmed as Health and Human Services Secretary. Both of these nominees were met with criticism by Senate Democrats, but it was Kennedy's nomination that garnered the toughest fight, with even some Republicans hesitant to support his initiatives.

Gabbard passed the Senate 52-48, with Senator Mitch McConnell (R-Ky.) joining all 47 Democrats in opposition. President Trump congratulated Gabbard stating, "she will eliminate corruption, restore honesty, integrity and trust to the national security state. There's nobody like her for this job. This was a very easy one for me. She was recommended by some of the top people in that world."

Attorney General Pam Bondi administered the oath of office to Gabbard in the Oval Office. "Unfortunately, the American people have very little trust in the intelligence community, largely because they've seen the weaponization and politicization of an entity that is supposed to be purely focused on ensuring our national security. I look forward to being able to help fulfill that mandate the American people delivered to you very clearly in this election, to refocus our intelligence community by empowering the great patriots who have chosen to serve our country in this way and focus on ensuring the safety, security and freedom of the American people," Gabbard stated after the swearing in.

Robert F. Kennedy Jr., was also confirmed by the U.S. Senate last week and will serve as President Trump's Secretary of Health and Human Services (HHS), bringing a contentious confirmation battle over Kennedy's skepticism on vaccines to a victorious ending. Similar to Tulsi Gabbard's vote, Senators voted along party lines, with only Mitch McConnell (R-Ky.) joining the Democrats in their opposition to Kennedy.

The son of the late U.S. Attorney General and Senator from New York has consistently questioned the safety of vaccines for polio, measles and Hepatitis B, founding the non-profit Children's Health Defense, which has sued the government and pharmaceutical companies over vaccines. In his initial confirmation hearing, Kennedy stated he is pro-vaccine and drew attention to the rise of chronic disease and obesity over the years. "When my uncle was President, 3% of Americans were obese. Today, 74% of Americans are obese or overweight. Epidemics are not caused by genes. Something is poisoning the American people, and we know that the primary culprit is our changing food supply." From the oval Office swearing in, Trump congratulated Kennedy, saying "Bobby created a nationwide movement made up of millions and millions of mothers and fathers and young people and concerned citizens of every background to end this horrible chronic disease crisis that exists in America. He's absolutely committed to getting dangerous chemicals out of our environment, and out of our food supply, and getting the American people the facts and the answers we deserve after years in which our public health system has squandered the trust of our citizens." Kennedy offered his thanks to President Trump for having "kept his word in every promise he's made to me" since endorsing Trump for President. "For 20 years, I got down every morning on my knees and prayed God would put me in a position where I can end childhood chronic disease in this country. On August 23 of last year, God sent me President Trump." Kennedy chose Supreme Court Justice Neil Gorsuch to administer the oath of office to him at the White House, in front of his wife, actress Cheryl Hines and his children.

## Saint Owen of Rouen

St. Owen was bishop of Rouen, France in the 7th century. He was born in Sancy, near Soissons, about 600 AD to a wealthy Frankish family. While he was still a child, his family housed and entertained the exiled St. Columban, who greatly influenced his early education. In his youth Owen was sent to the court of St. Clotaire II where he became an outstanding student. He gained the favor of the King and his son, who appointed him chancellor.

Owen, the nobleman, at a corrupt court, began to see the size and shape of the struggle to keep the light of Christianity burning.

He became a monk and a monastery builder in 636. Owen, who in 634 founded the Abbey of Rabais, was ordained priest by Dieudonne, Bishop of Mâcon. Sometime later his virtues and great ability marked him out for the archepiscopal see of Rouen, left vacant by the death of



St. Romain. Elected in 639, he was consecrated at Rouen, May, 21, 640, with his friend St. Eloi. He was made bishop of Rouen in Normandy in 641, and built monastery after monastery, for he clearly saw that only through these centers of Catholic living and learning could Europe be saved from darkness. He kept up his court connections, advising the weak Merovingian kings.

As a layman, St. Owen, with his zeal, piety and learning, was considered equal to any of the bishops. He gained a reputation for assisting the poor

and homeless and ministered to widows and orphans throughout the kingdom.

He passed away on August 24, 684, and is buried near the main altar of St. Owen Church in Rouen. The feast day of Saint Owen of Rouen is August 24th.








Local author Kevin Devlin can trace his origins back to an area which many in the city are familiar; indeed, the neighborhoods in Dorchester were (and to an extent still are) often identified not only by their official names but rather by the parish in which the local church was situated. With Devin's early years, it was the Savin Hill section of Dorchester and its two popular parishes, St. William and the church of St. Margaret's in close proximity. Devin can boast as having connections to both Dorchester and South Boston since his childhood was spent in Savin Hill and then moving to South Boston once married.

Readers might have read the author's other works:

a trilogy about South Boston with its initial volume The Southie Pact published in 2017 and subsequent sequels Hope and Despair and Death and Redemption released in 2020, or his science fiction story (and perhaps more of an admonition) Freedom Park, published in 2023. However, A Collection of Stories is a relatively short book but rich in content. Certainly, as with many concise stores. the reader is treated to a pithy narrative but substantial in substance. The collection consists of nine stories - several only a few pages but others longer with more plot development and suspenseful elements; and notwithstanding that the storylines can be linked to universal themes that also transcends time regardless of where the particular location in the story happens to be. The selection "Dark Days in America" is a case in point. Its setting is provincial but the story's theme can occur anywhere — in fact, one realizes that as severe as the story's content is — with banal actions inflicted by malevolent forces — the chances of certain

vile situations, such as the indiscriminate crime of murder is now more commonplace than rare. It would be well to read this story from a relative perspective - that is with the angle of time and space; the reader might beg the question "What is the timeframe, and location of where the action in the story takes place? Certainly this is one of the most thought-provoking stories Devlin presents. In the first selection. "The Tree Man," Devlin presents a fable - perhaps akin to the many allegories which have existed since antiquity. This story, however constructs a scenario where a tree and human correspond. The conversation between both incite inquires, albeit rhetorical, of why human nature is *why* it is. Of course, it is because of human nature, (and that probably is the best answer) that while humanity progresses, it is also regressing. Perhaps as the story articulates, if one has faith, then this is a step in the right direction and improvement is possible. Yes, in "The Tree Man" a didactic emerges, and with this, perhaps a fresh outlook of approaching life's foibles is comprehended and can be finally amended. As the saying goes *food for thought!* 

Several of the book's succinct chronicles, namely "The Wedding Proposal," "The Southie Monolith," and "Our Christmas Tree Ritual" definitely transports the reader to a mindset where philosopher Aristotle's Rhetorical Appeals is almost tangible. The audience is treated to Devlin's use of pathos when evoking not only neighborhood events but other celebrated locations, such as Fenway Park where the author relates an almost O Henry type of tale of an engaging couple attending America's favorite pastime event. And in his "Christmas Tree Ritual," the author allows for the reader

a glimpse into a custom which occurred every Christmas season — a tradition what many can fondly remember now in memory as if it were yesterday — decorating the holiday tree with family and friends.

And, the literary genre of

fantasy is not lost in this eclectic compilation. "The Magical Golden Dust," offers the audience an excursion into a world where transformation is the operative word — a transforming however into a future world predicated on the actions of a young man deemed to be imbued with an almost prophetic power — all against the backdrop of ominous powers.



#### William Shakespeare

William Shakespeare was probably born on about April 23, 1564, the date that is traditionally given for his birth. He was John and Mary Shakespeare's oldest surviving child; their first two children, both girls, did not live beyond infancy. Growing up as the big brother of the family, William had three younger brothers, Gilbert, Richard, and Edmund, and two younger sisters: Anne, who died at seven, and Joan.



Their father, John Shakespeare, was a leathwho specialized in the soft white leather used for gloves and similar items. A prosperous businessman, he married Mary Arden, of the prominent Arden family. John rose through local offices in Stratford, becoming an alderman and eventually, when William was five, the town bailiff—much like a mayor. Not long after serving as town bailiff, however, John Shakespeare stepped back from public life; we don't know why.

Shakespeare, as the son of a leading Stratford citizen, almost certainly attended Stratford's grammar school. Like all such schools, its curriculum consisted of an intense emphasis on the Latin classics, including memorization, writing, and acting classic Latin plays. Shakespeare most likely attended until about age 15.

A few years after he left school, in late 1582, William Shakespeare married Anne Hathaway. She was already expecting their first-born child, Susanna, which was a fairly common situation at the time. When they married, Anne was 26 and William was 18. Anne grew up just outside Stratford in the village of Shottery. After marrying, she spent the rest of her life in Stratford.

In early 1585, the couple had twins, Judith and Hamnet, completing the family. In the years ahead, Anne and the children lived in Stratford while Shakespeare worked in London.

Shakespeare's only son, Hamnet, died in 1596 at the age of 11. His older daughter Susanna later married a well-to-do Stratford doctor, John Hall. Their daughter Elizabeth, Shakespeare's first grandchild, was born in 1608. In 1616, just months before his death, Shakespeare's daughter Judith married Thomas Quiney, a Stratford vintner. The family subsequently died out, leaving no direct descendants of Shakespeare.

For several years after the birth of Judith and Hamnet in 1585, nothing is known for certain of Shakespeare's activities: how he earned a living, when he moved from Stratford, or how he got his start in the theater

The first definite mention of Shakespeare is in 1592 as an established London actor and playwright, mocked by a contemporary as a "Shake-scene." The same writer alludes to one of Shakespeare's earliest history plays, *Henry VI, Part 3*, which must already have been performed. The next year, in 1593, Shakespeare published a long poem, *Venus and Adonis*. The first quarto editions of his early plays appeared in 1594.

For more than two decades, Shakespeare had multiple roles in the London theater as an actor, playwright, and, in time, a business partner in a major acting company, the Lord Chamberlain's Men (renamed the King's Men in 1603). Over the years, he became steadily more famous in the London theater world; his name, which was not even listed on the first quartos of his plays, became a regular feature — clearly a selling point — on later title pages.

Shakespeare prospered financially from his partnership in the Lord Chamberlain's Men (later the King's Men), as well as from his writing and acting. He invested much of his wealth in real-estate purchases in Stratford and bought the second-largest house in town, New Place, in 1597.

Among the last plays that Shakespeare worked on was *The Two Noble Kinsmen*, which he wrote with a frequent collaborator, John Fletcher. Shakespeare passed away most likely on April 23, 1616 at age 52. We do not know the cause of his death. His brotherin-law had died a week earlier, which could imply infectious

## Colorful Houseplants for Lower Light Locations

indirect light and can scorch in direct sunlight or pale when the light is insufficient. Like nerve plants, they prefer consistently moist soil and high humidity. Boost humidity by grouping houseplants together and placing them on gravel trays. The pebbles in the tray elevate the pots above the water kept in the saucer. As the water evaporates, the humidity level increases around the plant. Use rainwater or distilled water to avoid brown tips on prayer plants, dracaenas, and spider plants caused by fluoride and chlorine in tap water.

For those with a bit more light add a few spots of color with polka dot plant (*Hypoestes phyllostachya*). You may have grown this plant as an annual in your garden and containers, but it also performs well as an indoor plant. Regular trimming of the green with white or pink-dotted leaves keeps the plant full and compact.

Peperomias prefer bright indirect light, but some varieties will tolerate a bit less. Ripple Peperomia (*Peperomia caperata*) adds texture and a bit of color while watermelon peperomia (*Peperomia argyreia*) offers a nice contrast with its smooth leaves colored like watermelon rind.

Dracaena plants offer a wide variety of textures with narrow and broad leaves and various types and intensities of variegation. Dorado's leaves have thin yellow leaf edges, Lemon Lime's green leaves are highlighted with white stripes and chartreuse leaf margins, and Limelight with its wide neon bright chartreuse leaves are just a few of the many colorful dracaenas now available.

If the colorful leaves of any of these plants tend to pale or fade to green you may need to increase the amount of light the plants receive. Try moving them closer to an east- or westfacing window or supplement those lowlight situations with artificial lights.


Consider these plants a piece of living art or a way to refresh your indoor décor. Not only do they improve the view, but they also help boost your mood, reduce stress, and improve focus when observing and tending these and your other indoor plants.

The memorial bust of Shakespeare at Holy Trinity Church in Stratford is considered one of two authentic likenesses, because it was approved by people who knew him. The other such likeness is the engraving by Martin Droeshout in the 1623 First Folio edition of Shakespeare's plays, produced seven years after his death by his friends and colleagues from the King's Men.

#### John Lee Hooker -It Serve You Right To Suffer (Impulse!, 1966)

Released on Impulse! in early 1966, It Serve You Right To Suffer is a masterful blend of new compositions and re-workings of songs John Lee Hooker had previously recorded. Performed with a trio of pedigreed jazz musicians, the session imbues Hooker's typically raw and stripped-down arrangements with sophistication, swing, and an improvisational spirit. Featuring Panama Francis on drums, Milt Hinton on bass, and Barry Galbraith on second guitar, this collaboration delivers some of the finest John Lee Hooker material ever recorded with a full band. Verve's Acoustic Sounds Series features transfers from analog tapes and remastered 180gram vinyl in deluxe gatefold packaging.

#### Lightnin' Hopkins -Lightnin' Strikes (Verve Folkways, 1966)

Recorded in 1966 for the Verve Folkways label, Lightnin' Strikes may not have the notoriety as some of Lightnin' Hopkins' other albums, but this set backed by Jimmy Bond (bass), Earl Palmer (drums) and Don Crawford (harmonica) is classic Lightnin'. From the opener, "Mojo Hand" to the ballad, "Woke Up This Morning," Lightnin' Strikes showcases classic blues from one of the best there was. Verve's Acoustic Sounds Series features transfers from analog tapes and remastered 180-gram vinyl in deluxe gatefold packaging.

Pianist Sylvie Courvoisier and guitarist Mary Halvorson are revered among the most distinctive and innovative voices in modern creative music. 
#### **"BOSTON'S WARMING CLIMATE LEADS TO** MORE RATS, STUDY SAYS"



*A* Nostalgic Remembrance



President's Day was on the 17<sup>th</sup>, and this means that the public schools are on a week's vacation. Years ago, when I was a young teacher in Boston, I would plan to go on vacation during that period of time. There were several young single teachers that I had befriended and we all had the same idea ... as the Brits would say, "Go on holiday," so we all went on

a vacation during that week off. Many of the people I taught with liked to ski. I tried it once

and decided to stick to warm weather sports and hobbies. If none of my colleagues wanted to head to a warmer climate, I would call my old friend, Sal Meli. He lived in East Boston and worked at Polaroid enjoying a rather flexible schedule that allowed him to take winter vacations.

When I told him that I was thinking of heading to Puerto Rico during the winter recess, he told me to include him in the plans. One teacher that I had become friendly with at Hyde Park High School, Tom Aylward, decided to join us and I headed to Colpitt's Travel Agency in Boston. I knew the vice president as he was a friend of Uncle Nick's and had taken care of his and Aunt Dorothy's vacation needs for many years whenever they decided to travel.

I've forgotten the man's name, but when I gave him our time frame and budget, he planned a trip for us that included Puerto Rico and St. Thomas, all in one week. We were booked to fly to San Juan at night on the last Friday before the week's vacation would start. We were to stay at the Hotel Normandie, an older, but fashionable hotel that, today, is classified as the oldest hotel in Puerto Rico. After being there for a few days, we were booked to fly to Charlotte Amalie, the capital of St. Thomas and check into the Gramboco Inn, a local hotel that was frequented by naval officers stationed on the island. When I told Babbononno about my plans, he fantasized that he could come with us, but it was impossible. He was too old but was satisfied when I told him that I would bring him back a bottle of homemade Puerto

Being young and positive about everything, I had him drop us off at the Eastern Airlines terminal and head back home. There was a lounge at the terminal that was owned by a former state senator, Mike LoPresti. I had campaigned for him when he ran for office and had also known one of his sons, Vincent, when we both attended English High School. When Mike spotted me, he came over to say hello and I introduced him to Sal and my teacher friend Tom who had arrived just as I did.

Mike told us to check in and then head back to the lounge for a drink. At check in, we were told that the flight was going to be delayed for an hour due to the weather. Our teacher friend who couldn't come had more than one drink, and when he headed back to the parking lot, couldn't find his car as they were all covered with snow by then. He wandered around aimlessly and then began to yell for help. A state trooper heard him and located him. He brought him back to the barracks and sobered him up before letting him continue the search for his car. The rest of us didn't know this part of the story but would find out a week later when we returned home. When the plane was ready to take off about an hour or two later, Mike LoPresti wouldn't let us pay for anything. I thanked him and we headed to the gate to board the plane and head south.

I don't know about Tom or Sal, but I fell asleep. A stewardess (now called flight attendant) woke me up as we were ready to land and I could see that it was almost dawn. It must have been around 5:00 or 5:30 in the morning when we landed. Just as soon as we deplaned, I could feel the warm tropical climate surrounding me, a climate that I've grown to love over the years.

A Grey Line tour bus was waiting for us and brought us to the Hotel Normandie after we picked up our suitcases from the luggage area. The hotel was oval shaped with a large deck area in the middle and an Olympic-sized swimming pool in the center. The room we had booked was very large and had three good-sized beds which made us very happy. After check in, we changed into more casual clothing and headed to the hotel restaurant and breakfast. (Back then, we dressed in a suit and tie when we flew.) As we entered, I noticed a table with three or four very attractive ladies sitting around it. One of them waved

and as I approached, I discovered it was the flight attendant who serviced us on the flight from Boston. She and one of the other girls were from Puerto Rico and were destined to show us around San Juan. But that's another story.

We decided to head for the pool and enjoy the sun and water while we planned what we were going to do for the next few days. Sal had been to the island a couple times and knew where to go, so we left the planning up to him. Before we did anything else, I wanted to call home and let my folks know that I was safe. Back then, to save money, I would call home collect and ask for myself. Mom usually answered and would say to the operator that I wasn't home and I would leave a message giving a relative's name. This would let, especially Mom, know that I was safe. Her problem was that she would always respond with, "I'll tell John that you called, and don't forget to wear a sweater if it gets cold.'

Later in the day, Sal, Tom and I headed for Old San Juan, the colonial section of the city. We joined a tour and saw the historic sites that amazed me as many of them had been there since around 1500. A fort and several government buildings had been con- structed by the Spanish not long after Columbus landed on the island. Later, Sal brought us to a restaurant and we got a sample of local dishes. I loved the food and still do. Much of it is centered around roast pork marinated in garlic, olive oil and spices.

For the next few days, we headed to several beaches that were recommended to us, and at night, local clubs where the best in salsa music could be heard and danced to. We also spent time at several hotels, especially the ones that had casinos. Right after Cuba became off limits for American tourists, Puerto Rico passed gambling laws and several of the major hotels opened casinos to attract the tourists. It worked and the island became a destination for Americans who had gone to Havana in the past. I had only been inside a casino once (Havana, 1958) and must have maintained beginner's luck status. No matter what I tried, I won. I tried blackjack and won. I tried roulette and won. I tried baccarat and won. I made more money than what I had brought to spend on the entire trip. As a result, I was ready for some gift buying a few days later when we headed for St. Thomas. But that's a story for another day ... GOD BLESS AMERICA

This old family recipe is both easy to make and delightful to eat. *Buon Carnevale*!

#### MIGLIACCIO (Italian Semolina and Ricotta Cake)



500g (2 cups) ricotta 250g (1 ¾ cups) semolina 1 liter (4 ½ cups) milk 350g (1 ¾ cups) granulated sugar 6 whole eggs 2 packets vanillina (or 2 teaspoons vanilla extract) 50g (4 tablespoons) butter 1 pinch salt 1 organic orange (half peeled, half zested) 1 organic lemon (half peeled, half zested) Confectioners' sugar, for dusting

**Note:** To flavor, some also add Millifiore, Limoncello or Strega, raisins and/or chocolate chips

Preheat the oven to  $350^{\circ}$ F ( $175^{\circ}$ C). Grease a 32cm (12-inch) cake pan or two smaller pans. Line with parchment paper and set aside. In a large stockpot, combine the milk, salt, butter, orange peel, and lemon peel over medium-low heat and bring to a gentle boil.

Reduce the heat to low, remove the citrus peels, and slowly whisk in the semolina, stirring continuously to prevent lumps. Cook until smooth and creamy, then transfer to a bowl and allow to cool.

In a large mixing bowl, beat the eggs, then add the sugar, citrus zests and vanillina (or vanilla extract).

Gradually mix in the ricotta, a little at a time, until fully incorporated.

Once the semolina mixture has cooled, add it gradually, mixing well between additions until the batter is smooth and lump-free. Pour the batter into the prepared pan(s) and smooth the top with a spatula.

#### The Mystery of the Mysterious Stranger

In December of 1916, more than six years after the death of Mark Twain, his final novel was published. Whether it was published in full remains a matter of mystery but what is known is that it had appeared throughout his later years in fragments and different versions. In its final (if not "finished") form, The Mysterious Stranger is among Twain's most exasperating works, painfully reminiscent of Kipling's Puck of Pook's Hill and Lewis Carroll's Sylvie and Bruno. It is, however, a revealing look into the mind of a grieving genius who had endured the loss of his wife and daughter and its release makes a valuable addition to Twain's cannon.

Like the works by Kipling and Carroll it is an episodic telling of encounters with a supernatural being visiting our world, in this case Satan, though not Satan himself...but Satan's nephew who shares his name and arrives in 16th century Austria and tantalizes a group of young boys with shocking and often nihilistic teachings on the meaning of life.

Not surprisingly, it's an angry, unrelentingly cynical, work. Evidence of Twain's state of mind during composition could be seen in such short works as What Is Man?, here unleashed in a larger uninhibited platform.

Curiously, however, The Mysterious Stranger started out in far more colorful, teasingly naughty spirits. In its first incarnation, appearing in the fall of 1897, the work was known merely by its working title "The St. Petersburg Fragment" which evolved over the next few years into Chronicle

of Young Satan, the story at this point set in the 18th century. The most promising state of the work came in the fall of 1898 under the title Schoolhouse Hill and featured an encounter with Tom Sawyer and Huckleberry Finn.

After that, the work disappeared beneath the small and sporadic works released during Twain's last decade and the status of the novel was not known until after his death.

After more than five years sorting through Twain's manuscripts his biographer and estate executor, Albert Bigelow Paine, reintroduced the work in what he called its finished form, now titled The Mysterious Stranger, though elements in earlier versions were evident throughout. It was published with much fanfare as Twain's last novel.

Indeed, The Mysterious Stranger was accepted as such for almost fifty years. Then, in 1963, Twain scholar John S. Tuckey examined Twain's manuscripts and found that what was published as The Mysterious Stranger was really a hybrid of Twain's notes with a lot of cosmetic and outright

padding by Paine and associate Frederick Duneka. To be sure this has happened before. Jane Austen's unfinished Sanditon, for instance, has been published with a conclusion tagged on to the work Austen left behind and also in an edition dismantling what Austen had laid down and building up from scratch. In both cases, however, the editors came about the published work honestly.

Nonetheless, the work as it was released was an insight into Twain's bleak view of humanity and religion, though his Christian Science, one of his last works is a far better read. But perhaps Twain is not to blame for the punishing darkness of The Mysterious Stranger. As is evident from the fluidity of its earlier versions it suffers both from expansion into novel length and its presentation in a narrative structure. Ideally, The Mysterious Stranger would have come to us as an essay but could have also staved afloat as a short story. Paine and Duneka gave us a valuable glimpse into Twain's increasing animosity in his twilight years, but robbed it of its power through inflation.



It is good to be back. It has been quite a while since your faithful correspondent took to the keyboard — early November to be a bit more precise.

With a physical therapist by my side I recently was able to walk with just a hiking stick for a considerable distance for the first time in over three months — leaving the walker back in my room.

All of this will hopefully lead me to going back to the TD Garden to cover events and be with game night friends I have made over the past 30 years.

I should also say I have a renewed appreciation for those who work directly in health care — especially nurses. If anyone reading this works in hospital administration, I want it known that I support their wishes for future salary increments.

I want to thank the staff of the *Post-Gazette* for the get well wishes that were posted in this space during my absence. I also want to thank all those who signed the get-well card that I received from those who work on Celtics game nights. Both were much appreciated.

Throughout my career, I always have worked with words. I was a journalism professor at Suffolk University in Boston for 43 years. So, I reminded myself that there are two words in the English language that differ by only two letters — victim and victor. I refuse to play the victim (or "why me") card. I keep telling myself that I will meet this challenge with fervent dedication and emerge from this total experience a victor. I have set my mind to that and believe that I will achieve that outcome over a period of time.

I hope that this positive outlook will encourage others facing medical challenges to do the same.

**HONORING JEFF TWISS** — Jeff Twiss, now the Vice-President of Media Relations and Alumni Relations for the Boston Celtics, will always occupy a special place in my mind. He was the person to issue me my very first pass to a Boston Celtics game way back during the 1991-1992 season.

Jeff has been with the Celtics for over four decades. It seems like he has been with the Celtics forever. We thought he might have been on hand for an NBA milestone moment back on the Opening Night of the 1979-1980 season when Chris Ford scored the first three-point basket in NBA history. That game also marked Larry Bird's first game as a member of the Celtics.

But Jeff said that he had not — that he was still up in his home state of Vermont. A couple of years later, while earning a graduate degree at UMass-Amherst, he worked as an intern for the Celtics.

As one who assists media members in their duties in disseminating news about the Celtics, Jeff found himself making headlines earlier this month when he was named the 2025 recipient of the John W. Bunn Lifetime Achievement Award-the highest award that can be bestowed on a person below enshrinement — by the Basketball Hall of Fame in Springfield.

As Jeff told one of my Suffolk classes years ago, one of his assignments as an intern was to sometimes drive coach Red Auerbach to various destinations. Red had a driver's license but apparently did not want to drive in the Boston area. During the season he lived in the Prudential Center.

One of these excursions involved driving the famous coach to a preseason game in Providence in 1981, Red asked Jeff if he would like to work for the Celtics. Of course, Jeff said yes and Red's reply was "eight o'clock Monday morning." As they say the rest is history.

Jeff has been with the Celtics ever since in a number of capacities. In his present capacity as the Vice-President of Media Relations and Alumni Relations he is a perfect fit since he knows so many people across the generations. His lengthy career has encompassed 40 post season appearances, nine trips to the Eastern Conference Finals, seven appearances in the NBA Finals and four NBA Championships
